EDITOR'S CUT

As you may have noticed on the inside front cover, *The Florida Patriot* received the 2010 Graham T. Smallwood Award best news publication for the society with 500 or more members and also received a check of \$250. This is not a single person's award but, instead, OUR award - the result of many Florida compatri-



ots contributing their articles, photographs, and comments or suggestions that brought us to this recognition. It is my job to assemble your valuable input into its final format but that task is meaningless unless I have something to format. Blank pages won't get us any recognition. The following is not a complete list of compatriots who contributed to the 2010 issues of *The Florida Patriot* - in no particular order, Harold Crapo, Ben DuBose, Hall Riediger, Randy Moody, Kevin Yarnell, every chapter submitting their chapter news & photos, Gerry Meeks, and as proof-readers (yes, I **really** need them) Lindsey Brock, Ben & Gerry DuBose, & Phil Wright. Now the challenge before us is to repeat and build upon our accomplishments for 2011 and for 2012.

A great deal of the formatting done to create a 'look' to our magazine is subjective - what I think will be a good reading experience, easily impart important information, and doesn't become boring. Thus, each issue may differ in layout in some small ways: different heading fonts, placement of graphics, and similar changes.

At publication time for the Summer issue, the Florida Society had 1778 members with a list of 994 compatriots with e-mail addresses. These 994 had 76 (to date) 'bad' addresses which left the electronic delivery at just over 50%. As promised, we offered the ability to OPT OUT of such electonic delivery. Twenty-five compatriots or 2.5% chose to do so. This provided an opportunity to increase the page count (from 24 to 32 pages) while still reducing the cost of that issue. This issue will be seeing the same or better cost reductions compared to last year's printing/postage costs. Such cost reductions can be used to offset the increased costs in printing the BOM Proceedings for those BOM attendees needing to have a hard copy. Printing costs for the Proceedings are no longer done gratis as they had been done in the past.



Public Debates over the Constitution

The New York experience

The proposed Constitution was first printed in New York City on September 21, 1787 in the *Daily Advertiser*. Three days later, that paper published the first editorial on the Constitution, describing it as the best thing available, and that although it was not perfect, it was much better than expected. They were in full support of the document, as were most merchants and businessmen.

In the months that followed, a raging debate took place in the form of newspaper articles, letters to the editors, broadsides (posters), and handouts. Americans were free to say what they wanted – and they did!

On September 27th, the *New York Journal* printed the first of seven essays by 'Cato,' said to be written by Governor Clinton. Cato called on freemen to be prudent and cautious: "Do not, because you admit that something must be done, adopt anything."



Within a week, 'Caesar,' allegedly Alexander Hamilton, charged Cato with demagoguery. "Shall we now

wrangle and find fault with that excellent whole, because, perhaps, some of its parts might have been more perfect?" he wrote.



These debates raged on and were distributed or carried in other papers throughout the region, and to a lesser extent, the entire country. An avalanche of the finest and most prolific political writing in America's history followed. A total of eighty-five

papers were published between October 27, 1787 and May 28, 1788. They appeared in four New York papers and then in book form.

Pseudonyms were used mostly to protect the authors from attacks, but their writing styles gave them away. They included Noah Webster, John Jay, and John Adams among others.

The people of Brooklyn, Queens, and Staten Island were treated to their first taste of true freedom of the press. The entire question concerning the ratification of the Constitution was being placed before them, and it was up to them to make a decision – the most important decision they would ever make.

Book Nook




At this time of year, it's appropriate that we take a look at a book such as this. *Miracle At Philadelphia: The Story of the Constitutional Convention* is a work of historical non-fiction, written by Catherine Drinker Bowen and originally published in 1966. Bowen recounts the Philadelphia Convention, a meeting in 1787 that created the United States Constitution. Bowen draws much of her information from notes and journals of the Framers, especially James Madison. It contains vivid description of many founders including George Washington, Benjamin Franklin, James Madison, Alexander Hamilton, and Gouverneur Morris, important compromises such as the Great Compromise, and controversial issues such as slavery.

This book goes far to illustrating the sometimes great divides between the delegates when it came to crafting this document. The Play and movie 1776 did the same thing but with the usual artistic license that comes with those media. Here, we get the viewpoints of the delegates in their own language. Descriptions of the side

negotiations and the sometimes contentious debates leaves the reader with a better understanding of their times and, more importantly, how we can learn how they came together to compromise. That ability is sorely missing from today's political climate of extremes.

While most generally don't read a book's Forward, you should read this Forward written by Chief Justice Warren E Burger. He illuminates the atmospheres in several states that were crucial in getting ratification of this Constitution. "Reaching across two centuries, the author reveals the parochial views of those who were content with each state issuing its own currency and free to

exclude commerce from other states. Where would we be had not Chief Justice Marshall in 1824, using the Commerce Clause, made us a "common Market" even before such phrase had currency?"





Maine's Sons of the American Revolution

The Meaning of the Machias Naval Victory Lives Dn Tou

hy does an historical event that took place on June 12, 1775—the onset of America's Revolutionary Warhave such meaning for people today? As a photographer who loves the natural beauty of coastal Maine, and the history of our great country, that is the question I was thinking about as I traveled from New York City to Machias last summer to participate in Margaretta Days. I loved being at this event, which commemorated the 235th anniversary of the first naval battle of the American Revolution. Its meaning came alive as I thought about what Eli Siegel, the great American philosopher and founder of the education Aesthetic Realism said: "The aim of history is to make past feeling felt more, or, simply, the past felt more." I believe this is why people are so stirred seeing our relation to the past, to men and women who lived at a critical time in our nation's history.

Largely unknown today, this mighty occurrence was called the "Lexington of the Sea" by the eminent writer James Fenimore Cooper. Though few in number, the men and women of Washington County seized the British ship the Margaretta, anchored in Machiasport. It was a known fact that the British were planning to use the Margaretta to transport lumber to Boston in order to build forts to be used against Washington's army. Though threatened, Mainers put their lives on the line to protect the meaning of the Revolution, and refused to provide the British with one log of Maine's valuable resource. Their brave decision stands for what we, as individuals and a nation today so much hope for. In the periodical The Right of Aesthetic Realism to Be Known, Ellen Reiss wrote:

"What the American Revolution was concerned with is the same thing Americans are in tumult over now—as people across this nation are so worried about jobs and money....By April 1775 there came to be a fury in many persons in America that while they lived on the American earth, planted it, built on it—

the wealth...was being robbed from them by an English king. There was fury that George III saw the American land and the people who lived on it as a means to enrich England."

I believe this describes the underlying cause of the fierce resistance to British tyranny that was shown by ordinary citizens—women and men who felt there was something to oppose with relentless determination and something big and beautiful to be protected and fought for. This feeling was represented with depth and style in the Margaretta Days celebration!

While today America's wealth is not going to the British monarchy, there is tremendous hardship and distress in the lives of most Americans because our vast wealth is used to bail out corporations and enrich executives and shareholders, as the average American gets poorer, including in Washington County. At the event, a woman I spoke with told me: "Sometimes we don't notice it so much here because most of us are all in the same boat." I

admire her courage; meanwhile no person should ever be forced to worry about not having a good-paying job or not being able to afford the basic necessities. If America's economy were based on ethics, and people, including in our government were honestly answering the question Eli Siegel asked: "What does a person deserve by being a person?," our country would be so different!

As a photographer, I was stirred by the expressions on the faces of people. For instance, there was Chris Sprague, a direct decedent of Jeremiah O'Brien, who spoke with such pride as he told of the preparations prior to the attack on the Margaretta. There was Dona Emerson who described the dilemma of Hannah (Watts) Weston, a young woman of 17, trying to decide how she can aid the defense of her land. She bravely carried ammunition for miles through the woods to support the men fighting at the front. We learned about the Rev. James Lyon who was portrayed by Doug Guy. Rev. Lyon, through the immortal words of Thomas Paine, inspired courage and perseverance.

"THESE are the times that try men's souls. The summer soldier and the sunshine patriot will, in this crisis, shrink from the service of their country; but he that stands by it now, deserves the love and thanks of man and woman."

And, I was moved by Valdine Atwood who told the story of "The Battle of the Rim" where the Passamaquoddy Indians joined the colonists, and fought side by side with them. There were dance, prayer and song from the Passamaquoddy by Joan Dana, Blanche Sockabasin, and Morning Star Wolf. There were demonstrations of spinning, food preparation,

firearms handling, crafts, and more. All these activities represented the feelings of people and what people are now insisting on more then ever—that they be seen with the fullness and justice they deserve. Commenting on the battle of Lexington. Ellen Reiss wrote:

"As they (the colonists) came out that April day, with their flag and weapons to face the trained soldiers of England, they were saying, 'This land on which our lives take place is ours. It does not exist for some monarch and his henchman to make profit from, while tyrannizing over, sapping, and ruining our lives in order to do so ... For the 13 colonies to be independent was for the

people living in them to own the rocky Massachusetts earth and the lusher Virginia earth and the earth at New York harbor, where ships could come in."

I believe that in 1775, the people of Machias felt intensely: "This land is ours—and we'll protect it with our very lives!" We can use what took place then to be clearer and surer about what we hope for and deserve—an economy that is based on ethics, and which will enable every man, woman and child to have good lives. Report of Florida Contingent to the 121st Annual Congress

From the reception on Saturday evening to the final banquet Wedesday evening Compatriots of the North Carolina Society provided a welcoming atmosphere, cheerful assistance and efficient management of the registration, tours, and elections. They deserve our accolades. Attendance was good with Florida providing one of the larger delegations.

On Recognition Night, the National Society bestowed the prestigious Minuteman Award for service to the National Society to Florida's Lindsey Brock and five other Compatriots. The Florida Society, its chapters and members were recognized more than any other state society in the 50 or so performance categories.

The results of the national officer elections are:

Chaplain General - James Taylor of Texas Board of Directors to the SAR Foundation - David Sympson of Kentucky and Sam Powell of North Carolina

Vice President General for the South Atlantic District - Charles Newcomer of Georgia

Trustee and Alternate Trustee from Florida - Gerald Meeks and Phil Carr, respectively

Incoming President General Magerkurth appointed these five Compatriots to the "at large positions" on the 2011-2012 Executive Committee: John Dodd of California, Paul Wilke of Ohio, Bobby Towns of Georgia, David Appleby of Missouri and Sam Powell of North Carolina. The four top national officers are ex-officio members.

There was keen interest among the delegates on the issue of former Presidents General serving for life as trustees. On one side delegates argued that keeping the PGs as trustees was wise because of the experience and knowledge they had acquired during their service in national office. On the other side, a perceived conflict between the Society's 1906 Congressional Charter and the current Constitution and By-laws demanded that they be excluded from being trustees for life. Furthermore, current practice as allowed in current Bylaws was in conflict with the Constitution which requires a nomination process and annual elections by Congress.

After protracted and often confusing debate the issue was resolved by adopting the Florida Amendment to Bylaw 16 that called for an annual nomination processes for former Presidents General and annual elections. The former Presidents General, including Florida's Carl Hoffman and Roland Downing, were subsequently nominated and elected.

The other Florida amendment (BL #11), to place the CAAH under the responsibility of the Historian General was tabled for further study. Delegates felt possible future changes in the SAR's organizational structure made this amendment unnecessary or pre-mature.

Executive Director Joe Harris resigned his position effective July 13th. He and his wife will move to a new home in Utah later this fall where he plans to continue his active participation in SAR affairs as a member of the Utah Society. The new Executive Director, Don Shaw, was introduced to the Congress. Go to http://www.sar.org/News/NSSAR-Hires-New-Executive-Director for details.

During the five days of Congress, an anonymous donor pledged to match, dollar for dollar, all gifts to the Center up to a total of \$100,000. Response was immediate and impressive as almost \$200,000 was raised.

Next year's 122nd Annual Congress will be in Phoenix, Arizona. The host committee chaired by Mike Jones has promised more casual dress standards and no humid weather. Mark your calendars for July 6-11, 2012.

Liberty Medal Awards

National Congress 2011

he Liberty Medal, authorized in 1987, commemorates the restoration of the Statue of Liberty, reminds us of our liberty and is presented for recruiting new members to the SAR.

The medal, along with a certificate, is awarded by the National Society. Presentation will take place at the Annual Congress; however, if a recipient is not present, it will be mailed to him. It is awarded to:



- 1. Anyone who has received the Florence Kendall Award at or before the Tampa Congress of 1986.
- 2. Any SAR member who after March 31, 1986, signed as first-line sponsor, the membership application of ten new members. For the purposes of this award, the person's name signed as the first-line sponsor should be the person who recruited the new member, and it should not be the name of an officer of a state society or a chapter, or any other person, who did no more than receive the application in the course of his official duties then append his signature as first-line sponsor, and forward the application to the National Society for processing.

For each additional ten new members, in which a recipient of the Liberty Medal is a first-line sponsor, a bronze oak leaf cluster may be presented. A recipient of ten bronze oak leaf clusters may be presented a silver oak leaf cluster to wear in lieu of the bronze clusters. A recipient of ten silver oak leaf clusters may be presented a gold oak leaf cluster to wear in lieu of the silver clusters.

Oak leaf clusters are displayed on the ribbon of the medal. If more than one oak leaf cluster has been awarded they should be arranged, as nearly as possible, like the stars on the Betsy Ross flag, with gold or silver clusters, if any, occupying the upper and dexter places of honor (the right of the wearer).

A new member is defined as an individual who was not previously an SAR member, but whose membership application has been approved by the National Society.

Historical Persepective Anyone? And Anyone?

o you remember the old saw "If a tree falls in a forest and no one is around to hear it, does it make a sound?." Or how about this one "Those who cannot remember the past, are condemned to repeat it."

We in the SAR have begun a project to register and, thus, honor WW II veterans - see page 16 - and there was a suggestion at the recent Summer BOM that we in the Florida Society should start the same programs for the Korean, Viet Nam, and veterans of later conflicts. That is, capture or register those SAR members who served in those conflicts so that we will have the information if/when National initiates the same program.

This is a good thing to do and we should begin now. However, there is something about this that strikes at a missing aspect of this program. While it is worthwhile to get the names we need to capture their experiences and LISTEN to them. To often, we as a nation go about doing these worthwhile projects but then forget the root cause or reason for doing so. These veterans took part in and fashioned history by their actions and commitment. If we (collectively) don't understand what that commitment meant to them in the context of their lives, then we will never learn from that history. Sure, we'll talk about the 'The Greatest Generation' but then as soon as the book is set down, we stop thinking and placing that new knowledge into our current lives the lessons that greatest generation learned – the hard way. We ask for The Greatest Generation to tell us their stories. And by doing so, we therefore have an obligation and a duty to pay attention and LISTEN to those stories. To do otherwise does a disservice to those storytellers.


There are many sources out there for all of us to look at, read, and absorb. The active word is ABSORB – take in completely. The History Channel periodically has many programs that cover such topics. A recent example is *Let They Be Forgotten* detailing the battle for Iwo Jima through interviews with surviving Marines. One cannot help but be deeply affected when listening to their reliving the assault and subsequent carnage on the beachesand how they lived throught that time. While this is a single example, there are as many more of these that need to be spoken – and LISTENED to so that we remember the past.

So what do those to adages have to so with this column? If our veterans speak of their experiences but there's no one there to LISTEN, then we have wasted their lives.

And our future generations are doomed to repeat the same mistakes. Think about it. Absorb it. Then find a Vet and listen.

Truth:

Everyone must pay their dues. You reap the benefits of being an SAR member by having paid your dues.

Consequences:

What is the consequence of not paying one's dues to the SAR? You are no longer a recognized member of your local chapter, our Florida State Society, and the National Society. You may not get your local chapter's newsletter and won't know about the important activities that are taking place. The camaraderie that happens at the SAR events will happen without you. And just as importantly, the chapter, state, and national organizations will miss your contributions to fulfilling the goals of the society. Individually we can make things happen – one man can make a difference. But put us all together and we can make great things happen to improve our country's understanding of the sacrifices of the Patriots of the American Revolutionary through education, through outreach to our communities, and through working with our youth and veteran groups.

What happens when the chapter fails to submit their dues? The chapter is disbanded and they are members no longer. How might this circumstance happen? Chapters begin asking for next year's dues early in the fall so that they can prepare their annual report which must be submitted to the state by December and to National by January. This is a rough time of year to collect money from anyone with the holidays approaching and the economy in its bad shape. But it still must be done. The

sooner members pay their dues, the sooner the chapter can submit their annual report and be done with it – for another year. It's never a good idea to wait until the last reminder notice is sent out before sending in your dues. Try paying dues on a layaway plan – put \$5 or \$10 dollars in a piggy bank each week/payday until you have the total collected then send it in. Relatively painless isn't it?

So. Make it easy on yourself and on your chapter by sitting down right now and paying your dues and then stand up and pitch in to help your chapter accomplish all of our SAR Goals.

religion as well as military and economic purpose. Modern day visitors to Mission San Luis discover a re-created community where time stands still. There they meet the people of San Luis going about the tasks that sustained life centuries ago. They walk the plaza where the Apalachees played their traditional ball games. They visit the most important structure in the Apalachee village, the council house, and also stop at the home of the Spanish Deputy Governor. Visitors are welcomed at the church built under the supervision of Franciscans, and at the friary where they lived."

The cutoff date for submitting the World War II Corps survey form is 30 May 2011. If the survey form was received by 30 May 2011 a certificate was issued and given to a state representative at the 2011 National Congress for distribution by the state society. Survey forms will still be accepted after this date but, the certificates will not be ready for Congress.

NSSAR World War II Corps

uring Spring BOM meeting, Compatriot Richard E. Friberg, Miami Chapter, FLSSAR, took the floor to address the ongoing national effort to identify current members who are World War II veterans. Specifically, Compatriot Friberg indicated that he attended the Spring 2011 Leadership Meeting in Louisville. While there he went to a gathering chaired by Compatriot Daniel R. McMurray, NSSAR Adjutant, World War II Corps. A key point in Compatriot McMurray's presentation was a request for chapters and states to support the initiative of now past President General J. David Sympson in identifying and honoring our nation's veterans, especially World War II veterans who are members of the SAR. Since the Spring 2011 Leadership Meeting, Compatriot Friberg has spearheaded an effort to identify all current WWII veterans in the FLSSAR.

Following Compatriot Friberg's comments, past President General Sympson took the floor and amplified the importance of the SAR World War II Corps. He further suggested that the FLSSAR seek a volunteer to act as the Adjutant, Florida Company, SAR World War II Corps.

When that day's BOM session closed, I met with now past President General Sympson, now past FLSSAR President Meeks, and Compatriot Friberg to volunteer as the Adjutant, Florida Company, SAR World War II Corp. They agreed to this appointment, with the understanding that Compatriot Friberg would serve as the Company Commander and I would attend to the administrative duties as he directed. At the NSSAR 121st Congress in Winston-Salem, NC, over 500 Patriotic Certificates were distributed to the State Societies, with the Florida Society receiving a large number of these certificates.
