

IMPORTANT DATES IN U.S. HISTORY

For those of you knowledgable on the United States Constitution, these dates 12th June 15, 1804 are the Enactment Dates for Amendments 11 to 27. Now can you match up the Amendment text with the Amendment number & dates?

a. Establishes the direct election of United States Senators by popular vote

b. Fixes the dates of term commencements for Congress (January 3) and the President (January 20); known as the "lame duck amendment"

c. Prohibits the revocation of voting rights due to the non-payment of poll taxes

d. Establishes the official voting age to be 18 years old.

f. Defines citizenship, contains the Privileges or Immunities Clause, the Due Process 19th August 18, 1920 Clause, the Equal Protection Clause, and deals with post-Civil War issues 20th January 23, 1933

g. Prohibits the denial of suffrage based on race, color, or previous condition of servitude

h. Establishes women's suffrage

i. Repeals the Prohibition of alcohol

j. Revises presidential election procedures

j. Provides for representation of Washington, D.C. in the Electoral College

k. Abolishes slavery and involuntary servitude, except as punishment for a crime

I. Prevents laws affecting Congressional salary from taking effect until the beginning of the next session of Congress

m. Allows the federal government to collect income tax

n. Establishes Prohibition of alcohol (Repealed by later Amendment)

o. Limits the president to two terms, or a maximum of 10 years (i.e., if a Vice President serves not more than one half of a President's term, he or she can be elected to a further two terms)

p. Codifies the Tyler Precedent; defines the process of presidential succession


q. Immunity of states from suits from out-of-state citizens and foreigners not living within the state borders. Lays the foundation for sovereign immunity

The Creation of a Florida **Society Veterans Battalion**

"The summer soldier and the sunshine patriot will, in this crisis, shrink from the service of their country; but he that stands it now, deserves the love and thanks of man and woman."

FLSSAR President David Ramseur understands the significance of these words written by Thomas Paine during the winter of 1776. He understands also how important it is to not only remember those veterans of 236 years ago, but to remem-

ber each FLSSAR Veteran of today by recording his name and presenting him with a certificate of military service. Thus a Florida Society Veterans Battalion is established.

FLSSAR members who are veterans (or who wish to be evaluated to determine if they are veterans) are requested to complete a Veterans Battalion Survey. Then have it endorsed with a certification by their Chapter President, before sending it to the FLSSAR Veterans Battalion Adjutant for recording and processing.

During processing, a certificate will be created and returned by email to the chapter president for presentation to the FLSSAR veteran. Each certificate will be personalized and will reflect the period during which the SAR member

was on active duty. It will also indicate if the member is authorized to purchase and wear either the War Service Medal or the Military Service Medal. Further, each qualified veteran will be assigned to one of the following companies based upon his period of military service. These companies include: (1) World War II, (2) Korean War, (3) Vietnam War, (4) First Gulf War, (5) Iraq War, (6) Afghanistan War, (7) War on Terrorism or (8) Cold

War. Members who have been awarded a World War II Certificate Veterans Battalion of Patriotism will be added automatically to the WWII Company, FLSSAR Veterans Battalion.

Examples of a certificate for a Vietnam War Veteran and a certificate for a Cold War Veteran are available from Chuck Sweeney.

The Rhode Island Society of the Sons of the American Revolution is pleased to announce the publication of the Regimental Book First Rhode Island Regiment for 1781 &c by Bruce C. MacGunnigle with an introduction by Cherry Fletcher Bamberg, FASG.



The 1st Rhode Island Regiment was a Continental Army regiment from Rhode Island during the American Revolutionary War (1775 - 1783).Like most regiments of the Continental Army, the

unit went through several incarnations and name changes. It became well-known as the "Black Regiment" because, for a time, it had several companies of African American soldiers. It is regarded as the first African-American military regiment, albeit with the misconception that its ranks were exclusively African-American. JOHN TRUMBULL JR. (June 6, 1756 -November 10, 1843)

John Trumbull Jr., the painter, was the son of Connecticut's patriotic Magistrate Jonathan Trumbull, who you read about in the last issue of *The Florida Patriot.*

He was born in Lebanon, Connecticut, and as a youth he received a fine education which brought him to Harvard College where he studied art his longtime passion. Soon after leaving Harvard he painted his first picture -The Battle of Cannae (which took place during the Second Punic War in 216 BC). After rave reviews he resolved to devote the rest of his life to art.

But duty to his newly emerging nation called, and in the summer of 1775 he joined the First Connecticut Regiment, where he was assigned to draw the enemy's works at Roxbury. General Washington was so impressed with his work that he made the young painter his aide-de-camp and by the end of that summer he promoted him to Major of his Brigade. Promotions came fast, but seemingly not fast enough for this young artisan.

Because in 1780 he resigned over a disputed rank and left for London to



study under Benjamin West.

Shortly after his arrival he was arrested and charged with treason. West interceded directly to the king and Trumbull's life was spared with the condition he leave the country. After spending eight months in prison he moved to Amsterdam and he did not return to America until late 1782. His father urged him to consider law as a career, but the young man decided to return to England after the Revolutionary War and once again studied under West. At that time he decided to produce a series of historical paintings on the American Revolution. His first two, in By Ben DuBose

1786, were the Battle of Bunker Hill, and Death of Montgomery. These were followed by several portraits of the signers of the Declaration of Independence.



In 1792 he was commissioned to paint, Signers of the Declaration of Independence, which now hangs in the Rotunda of the capital. After that he traveled between America and Europe engaged in various commercial pursuits, as well as portraits.

This venerable artist, soldier, and patriot died in the city of New York at eighty-eight years of age.



The History Of Flag Day

The Fourth of July was traditionally celebrated as America's birthday, but the idea of an annual day specifically celebrating the Flag is believed to have first originated in 1885. BJ Cigrand, a schoolteacher, arranged for the pupils in the Fredonia, Wisconsin Public School, District 6, to observe June 14 (the 108th anniversary of the official adoption of The Stars and Stripes) as 'Flag Birthday'. In numerous magazines and newspaper articles and public addresses over the following years, Cigrand continued to enthusiastically advocate the observance of June 14 as 'Flag Birthday', or 'Flag Day'.

On June 14, 1889, George Balch, a kindergarten teacher in New York City, planned appropriate ceremonies for the children of his school, and his idea of observing Flag Day was later adopted by the State Board of Education of New York. On June 14, 1891, the Betsy Ross House in Philadelphia held a Flag Day celebration, and on June 14 of the following year, the New York Society of the Sons of the Revolution, celebrated Flag Day.

Following the suggestion of Colonel J Granville Leach (at the time historian of the Pennsylvania Society of the Sons of the Revolution), the Pennsylvania Society of Colonial Dames of America on April 25, 1893 adopted a resolution requesting the mayor of Philadelphia and all others in authority and all private citizens to display the Flag on June 14th. Leach went on to recommend that thereafter the day be known as 'Flag Day', and on that day, school children be assembled for appropriate exercises, with each child being given a small Flag.

Two weeks later on May 8th, the Board of Managers of the Pennsylvania Society of Sons of the Revolution unanimously endorsed the action of the Pennsylvania

Society of Colonial Dames. As a result of the resolution, Dr. Edward Brooks, then Superintendent of Public Schools of Philadelphia, directed that Flag Day exercises be held on June 14, 1893 in Independence Square. School children were assembled, each carrying a small Flag, and patriotic songs were sung and addresses delivered.

In 1894, the governor of New York directed that on June 14 the Flag be displayed on all public buildings. With BJ Cigrand and Leroy Van Horn as the moving spirits, the Illinois organization, known as the American Flag Day Association, was organized for the purpose of promoting the holding of Flag Day exercises. On June 14, 1894, under the auspices of this association, the first general public school children's celebration of Flag Day in Chicago was held in Douglas, Garfield, Humboldt, Lincoln, and Washington Parks, with more than 300,000 children participating.

Adults, too, participated in patriotic programs. Franklin K. Lane, Secretary of the Interior, delivered a 1914 Flag Day address in which he repeated words he said the flag had spoken to him that morning: "I am what you make me; nothing more. I swing before your eyes as a bright gleam of color, a symbol of yourself."

Inspired by these three decades of state and local celebrations, Flag Day - the anniversary of the Flag Resolution of 1777 was officially established by the Proclamation of President Woodrow Wilson on May 30, 1916. While Flag Day was celebrated in various communities for years after Wilson's proclamation, it was not until August 3, 1949, that President Truman signed an Act of Congress designating June 14th of each year as National Flag Day.

USS Barry



Commodore Barry was a fighter. His heroic reputation has been remembered throughout the 20th century in a line of four destroyers all named after one of our first and finest Navy Heroes. The Destroyer is an all-purpose fighting ship that probably best typifies what we expect from a modern naval warship. Barry has been in almost every significant Naval campaign of the 20th and 21st centuries.

DDG-52, an Arleigh Burke AEGIS class destroyer, commissioned in 1992 and today in service with DESRON TWO, home port in Norfolk VA. In her distinguished career, she is one of only 3 ships to win the Navy's prestigious Battenberg Cup 3 times. She also has 4 Battle E's, and in 2004 she won the Arleigh Burke Fleet Trophy from the Atlantic Fleet. In her most recent actions, she engaged the Libyan Coast Guard which was firing upon Merchant vessels; and, she launched 55 Tomahawk cruise missiles in support of UN operations.

DD-933, a Forrest Sherman destroyer commissioned in 1956 decommissioned in 1982 that today serves as the official naval platform for Naval District Washington DC, hosting many important ceremonies that preserve the traditions and honors of the U.S. Navy. During her active naval service with the Atlantic and Mediterranean fleets, she participated in amphibious operations in Beirut Lebanon in 1958, the Cuban Missile Crisis in 1962 as part of the Blockading Fleet, and earned two battle stars during Viet Nam service.

DD-248, a Clemson class 4-piper destroyer commissioned in 1920, served in the Atlantic, Med, and Pacific fleets before WWII. During the first years of the war, she served in convoy duty in the Atlantic and Caribbean as an ASW escort. Later, she underwent conversion in the Charleston Navy Yard, becoming a fast troop transport APD-29. She participated in the landings in Southern France. She was transferred to the Pacific Fleet in March 1945 and took up patrol duties off Okinawa. There she was attacked by two kamikazes, surviving the attack but with tremendous damage. She then served as a kamikaze decoy, when for the second

Winter BOM Minutes

LSSAR President David Ramseur opened the meeting at 3:02 pm Friday and a quorum was certified. He announced that the State Orations Contest winners would be announced at the evening banguet. He also stated that a special treat was in store for all at the banquet, by a presentation by Compatriot Dr. Donald Wyman, entitled "The Dark Side of Benjamin Franklin." President Ramseur said that he was much impressed by the several chapters' participation in Veteran Day activities during November and in Wreaths Across America campaign, honoring our veterans. He acknowledged that favorable results are still coming in for our Center for Advancing America's Heritage and is looking

forward to achieving the 40% statewide goal. Senior Vice President Phil Tarpley encouraged everyone to get involved and exercise their freedom to vote

in the primary and the national election, as so much is at stake. He also pointed out that Florida DAR processed and approved over 13,000 new member applications during 2011. What a great example they set for us to strive for.

North Central Regional VP Scott Bushnell reports that several Chapters had participated in the many Veterans Day events held in various locations throughout the region, e.g. the Wreaths Across America, parades, Massing of the Colors, visits to Veteran's Nursing Home in Land-O' Lakes, and a Veteran's Fair.

Northeastern, East Central and Southwest Regions also reported on their Chapters participating in many Veteran's Day activities, including Massing of the Colors, parades, ceremonies honoring veterans, and several Chapters' Color guards presenting the Colors at Veteran Day events.

FLSSAR Secretary Steve Williams reported that 229 new members were accepted during 2011. Also, that 189 members were dropped or resigned. He predicted that many of those dropped are merely late in submitting their dues, so this will improve our numbers statewide. He encouraged the Regional VP's to convey to their chapters the importance in getting their members involved, e.g. on a phone committee, appointing them to some other operating committee, running for office in their chapter, etc.

Treasurer Hall Riediger stated that our financial affairs are in good shape. He asked the Regional VP's to please notify their chapter treasurers and presidents to be sure to file their 990N postcard forms to the IRS on time. After some discussion, a motion was made and seconded to approve the 2012 FLSSAR budget. It passed. A motion was made, seconded and approved to accept the treasurer's report as presented.

Chaplain Randy Moody reported that there were 13 Compatriots "lost" in 2011.

Secretary Steve Williams received a much deserved round of applause for his out-

standing work in publishing The Florida Patriot magazine, which received National honors.

He has also made good progress in lowering the publishing and mailing

costs of the magazine by encouraging members to receive the magazine via email, thereby eliminating the need to mail them their copies.

FLSSAR Past President Lindsey Brock reported on the progress at the Center For Advancing America's Heritage building. He said the façade is nearly finished. Also, that donations from individuals and/or chapters were acceptable at any time.

Chairman Nelson Jantzen reminded all chapters that the 2011 reports for Chapter Challenge were due to him NLT the first week of March, 2012.

Past President Gerald Meeks had sent a recommendation to Charter & By-Laws Chairman Phil Tarpley, to allow the FLSSAR President to serve two terms in office, thereby allowing him to continue or complete the projects and/or agenda he hadn't had time to get done in his one-year term. Tarpley pointed out that that action would probably have an adverse effect on the officers behind the president. The By-Laws Committee will study this proposal.

President Ramseur spoke about an opportunity, a "Jacksonville Project," where the Revolutionary War, Battle of Thomas Creek occurred, which encompasses a 388 acre tract of land. He reiterated that Florida, at present, has but two Revolutionary War sites,

Pensacola and the Last Naval Battle. He further stated that large amounts of funds were available from state and national sources for this type of project. President Ramseur has a meeting with the Jacksonville City Council in February re this project. A motion was made, seconded and passed to donate \$100.00 to the Battle of Thomas Creek Foundation.

Motion was made and seconded to reimburse Brevard Chapter \$325.00, for the cost of replacement of the pole to hold the Florida State Historic Marker of the Last Naval Battle monument from Cape Canaveral to the Veterans Center in Merritt Island. Approved.

The BOM reconvened at 9:02am, Saturday the 14th. Compatriot Lindsey Brock informed everyone that at future FLSSAR BOM sessions, the Executive Committee meeting would no longer be held on the second floor of the hotel, but would be held in Salon 1, on the first floor. He announced that the Spring BOM session will be held May 3,4 and 6. Also, that there will be breakfasts on Friday and Saturday and lunch on Friday. He also reported that the National team processing membership applications are steadily reducing their processing time. At present, the applications are in and out in 9 to 10 weeks. They expect to have the turn around time down to six weeks by July, 2012.

Chairman Gerald Meeks, Nominating Committee, presented the FLSSAR slate of officers for the ensuing year. (copy given to Sec'y Steve W.) Motion was made, seconded and passed to receive the Nominating Committee's report, with appreciation given to this committee. Other nominations and voting will take place at the FLSSAR annual meeting.

President Ramseur reported that a good number of our chapters were experiencing increased interest in the several competitions, e.g. Elementary school poster contest, the Eagle Scout scholarships, Essay contest, JROTC scholarships, and the Orations contest. He pointed out that these programs bring an increased interest in the American Revolution among the young folks in our schools.

Randy Moody, chairman of the Orations contest reported that the winner and second place finisher of this contest were announced at the Friday night banquet. The young lady winner gave her excellent, winning speech to everyone's enjoyment.

JROTC Chairman Phil Tarpley stated that nominations from the Chapters for Outstanding JROTC cadet, with all of the required attachments should be submitted to FLSSAR NLT April 7, 2012. Tarpley then requested that the BOM reimburse a chapter for the 26 to 30 meals provided to the Wounded Warriors (Purple Heart recipients) that were honored at an awards dinner. After discussion as to its propriety, a motion was made, seconded and approved that the request be sent to the ETF Disbursement Committee.

It was noted that 17 of the 33 Florida chapters were actively participating in presenting the Flag Kits and the accompanying booklets.

Carl Hoffman spoke on a recent law passed by Congress giving the President the authority to give the U.S. military the right to arrest and detain any person suspected of being a terrorist. He read his Habeas Corpus Resolution. (copy given to Sec'y Steve W.), pointing out that this was in violation of the U.S. Constitution. Item was tabled until our annual BOM meeting.

Meeting adjourned at 10;26 am. Bill Fuller, Recording Sec'y

Wreaths Across America [™] has an expanded program to enable cemeteries all over the country to place wreaths on individual graves to emulate the Arlington Wreath Program. Wreaths may be sponsored through fundraising groups or on-line for placement on individual graves at participating locations. It is quick and easy to become a fundraising group.

Here are the steps:

- You must register with WAA office before you begin fundraising. When you call or e-mail you will then be assigned group ID # and cemetery ID #. It is important to use this information on all your order submittals. Fund Raising may be done all year.
- All Wreath Sponsorship Applications must be in the WAA office no later than the first Monday after Thanksgiving. There are no exceptions
- Please be aware that Wreaths Across America (WAA) is a trademarked name. All funds collected must be processed through the WAA Office. You may not raise funds using the WAA name unless it is through this program.
- WAA wreath sponsorships sell at \$15. Funds are collected by each participating group. A certain amount (\$5 of each \$15) will be refunded to the fundraising organization. If you are not interested in raising money for your group and want to do wreaths only, you can choose the '3 for' option. For every 2 \$15 sponsorships 3 wreaths will be sent to the participating location of choice. With this option, no funds will be returned to your fundraising group.
- Sponsored wreaths will go to the participating cemetery as designated by the fundraising organization. WAA cannot honor specific requests. Some location leaders do make special arrangements. If you do not have a location in mind, just ask that the Wreaths be placed in the general fund.
- If your fund raising group is not a 501-c-3 not for profit organization, then please contact the WAA office for further instructions.

IMPORTANT DATES IN HISTORY - ANSWERS

11th February 7, 1795 - Immunity of states from suits from out-of-state citizens

12th June 15, 1804 - Revises presidential election procedures

13th December 6, 1865 - Abolishes slavery and involuntary servitude, except as punishment for a crime

14th July 9, 1868- Defines citizenship, contains the Privileges or Immunities Clause, the Due Process Clause, the Equal Protection Clause, and deals with post-Civil War issues

15th February 3, 1870 - Prohibits the denial of suffrage based on race, color, or previous condition of servitude

16th February 3, 1913 - Allows the federal government to collect income tax

17th April 8, 1913 - Establishes the direct election of United States Senators by popular vote

18th January 16, 1919 - Establishes Prohibition of alcohol

19th August 18, 1920 - Establishes women's suffrage

20th January 23, 1933 - Fixes the dates of term commencements for Congress (January 3) and the President (January 20); known as the "lame duck amendment"

21st December 5, 1933 - Repeals the Prohibition of alcohol

22nd February 27, 1951 - Limits the president to two terms, or a maximum of 10 years

23rd March 29, 1961 - Provides for representation of Washington, D.C. in the Electoral College

year. Prior to moving to Florida Ben had a long history of His-

was involved in having: four colonial homes saved and preserved; worked on over a half-dozen projects involving the restoration of historic monuments; he was appointed as a Brooklyn Historian by three Mayors, was appointed to the Bi-Centennial Committee of the Ratification of the Constitutional by the Governor; in the 1980s he received a quarter million dollars, including an NEH grant, to revise the "Teaching of Local History" in Brooklyn. After three years this program went city-wide.

Application Routing

LOUISVILLE — Staff genealogist Denise Hall sent the following to an SAR member to answer his question about application routing.

Applications pass through myriad hands before they reach us here in the Genealogy Department. From the Chapter level, they are sent to the State (registrar and secretary, and in some states, treasurer), and from the State level they are mailed to SAR headquarters (Fourth Street location), where the mail is received, opened, sorted and distributed. Then they are sent to the accounting department to verify and enter the monies received. Then they are brought to our West Main Street location to the Registrar for entering into the application database (where ACN numbers are assigned), and then the registrar brings them upstairs to Genealogy, where our supervisor sorts through each application before deciding which holding drawer they are placed in - Supplemental, Regular New Member or Fast-Track New Member. Then the genealogists assigned to those categories pull from those drawers in the order the applications were received to review them. Note: Until that last step, the documentation is not separated from the applications. After approval, the applications, along with the documentation, go back downstairs to the Registrar for the registration process, wherein new member applications are assigned and marked with their new national numbers, certificates are issued, postcards and letters are generated, mailings are prepared, and the stapled-together documentation for each approved application (that have been marked by the Registrar with the new national numbers) is separated from the applications, and then the original applications, as well as the documentation, are brought back upstairs to Genealogy for filing in our vault.

Or An Important Tool help your chapter stay vital and alive!

The following is from your FLSSAR Membership Promotion & Retention Committee and the Endowment Trust Fund Disbursement Committee. This is our joint effort at asking all Florida Chapters to pay attention to the many avenues of recruitment. Recruitment is NOT a passive activity - we can't sit back and wait for prospective members to come knocking at our door and begging to be a member. Witness the report from a Regional Vice President at the 2012 FLSSAR Winter BOM meeting where no recruiting for years has left a chapter on the brink of dissolving.

This document has been reviewed, amended, and approved

by: David Ramseur, FLSSAR President; Phillip Tarpley, FLSSAR Senior Vice President; Steven Williams, FLSSAR Secretary; and Lindsey Brock, NSSAR Registrar General and Past FLSSAR President. We recommend that every Chapter in Florida endorse, approve, and place into action these recommendations. There is nothing more important than growing our Society and Chapters.

Recruitment is NOT a passive activity– we can't sit to come knocking at our door.

The Medal of Appreciation and certificate, if she refers two (2) new member applicants to our chapter, over time with the new members being approved and inducted into the chapter.

- The Martha Washington Medal and certificate, if she refers a total of four (4) new member applicants to our chapter, over time with the new members being approved and inducted into the chapter. This would be two more after receiving the Medal of Appreciation.
- The Daughters of Liberty Medal and certificate, if she refers six (6) new member applicants to our chapter, over time with the new members being approved and inducted into the chapter. This would be two more after receiving the Martha Washington Medal.

Then, after a total of six (6) new members, the DAR member will receive a Bronze Oak Leaf Cluster for every two (2) new members.

Another variation of the above is based on "Referrals" only. The "Referrals" do NOT have to become members for the medals to be awarded. The Medal of Appreciation is awarded after three (3) referrals, the Martha Washington Medal is awarded

after five (5) referrals, and the Daughters of Liberty Medal is awarded after ten (10) referrals. Those using this variation feel that only judging the merit of the DAR recruiting efforts on just those approved isn't the best incentive for the DAR Daughters. We need the DAR members beating the bushes to get crowds coming to work on applications. In some cases it has taken 2 years to get the application

ready for submission. There has to be a more immediate 'payback' for the Daughter to become actively involved.

The Chapter should strive to make these awards at a luncheon that is jointly held with DAR Chapter(s). If there is not a jointly held luncheon currently, may we suggest that you start one. Good choices might be the Flag Day Luncheon, the Constitution Day Luncheon, the George Washington Birthday Luncheon, or a joint Flag Retirement Ceremony.

Chapter Officers need to be aware how these medals are treated under the current FLSSAR Endowment Trust Fund Reimbursement Instructions and Guidelines. Per Item B: Authorized reimbursement to chapters: Item Number 4: Other Medals purchased from NSSAR and presented to persons other than SAR members in recognition of their support of the Sons of the American Revolution, persons whose achievements are noteworthy in their school, community or state, or those currently serving or who have served in the Armed Forces of the United States, and two meals per recipient. (Limit \$20.00 per meal.)

Put another way, the chapter in making these awards to DAR members, is eligible to be reimbursed up to 100% of the chapter's cost as outlined above. This is a win – win for everyone. The chapter gains new members and the DAR member is awarded for their efforts, all at little to no cost for the chapter.

To those that may say that these medals are of much to great importance to be given away so easily, I would ask the following: When was the last time a DAR member brought in

DAR Recognition Awards for New SAR members

With every chapter in Florida needing to add new members just to stay the same size from one year to the next, may we please suggest that all chapters look at the following as one avenue that may help add new SAR Members for our Florida Society.

"You should be aware that the National Society Sons of the American Revolution awards \$500.00 each year to the DAR state society that has the most approved SAR application referrals within that year. In order for the Florida DAR Society to have a chance at this award, any referral from a Florida Daughter that results in an SAR application should be accompanied by the DAR Referral Form (DAR500-on the Florida website). So send in those SAR applications, attach the DAR Form, and send to the State Registrar. The form can be found at either the Florida website via the forms link (DAR500), or by going to the National website, http://www.sar.org/NSSAR-Forms, then scroll down to open either the pdf or doc "DAR Finder Form" file." (Reprinted from the Florida Patriot, Fall 2011)

We suggest that every chapter adopt some form of the following and advertise it heavily with every DAR Chapter in your area.

back and wait for prospects

two, four, or six new members?

As Kevin Yarnell pointed out last year at this time, the historical record has been that of Dropping around 200 members each year and getting around 200 new members for a stagnant growth. It seems that we'll never break the 2000 member barrier. Not to steal anything from the Member Promotion and Retention Committee, but our state society should not accept as a tradition that of dropping 200 members each year. This year we have a chapter of 53 members (before November 1st) which dropped 31 members – 58% of their members. And we have a chapter of 22 members who retained every single member. The average number of Drops per chapter is 6 members for 33 chapters.

What are the causes of this consistent rate of Drops? Some chapters may have unique situations that cause members to Drop and would require the chapter leadership to vigorously explore ways of mitigating those causes. Is it:

- Dues are hard to come by during the holiday season (November to December)? Have you tried sending your dues notices out on September 1 to allow members to save up to pay?
- Is the member not active and therefore has no sense of 'ownership' in the chapter? Thus, it's easy for him to Drop – there's no vested interest in the chapter.
- Are the dropping members out of area/state members and only connected to the chapter because their father/ grandfather/mother got them into the SAR?"
- 4. Does your chapter recognize its workers by awarding Certificate and Medal Awards?
- 5. Do your luncheon or dinner meetings suggest wearing a class B uniform or Revolutionary War uniform so medals can be displayed?
- 6. Did you ever notice that the most successful chapters have the most expensive chapter dues (\$30 or more)?
- 7. Is your Chapter making awards? If a chapter makes awards, then gets publicity for the award, then more prospective members become aware of their chapter. The more members the chapter can attract, then the more dues they can collect and the more awards they can make. The chapter's life blood is its members, and getting more members. More awards equals more publicity equals more members, and more member's means the chapter has more workers to make more awards, and back thru the circle we go.

Now, do we propose giving away medals or do we just go along with stagnant growth? We refuse to discuss the worst possibility of ceasing to exist.

You can read about the medals we have listed in The SAR Handbook Volume 3.



Flagler Compatriot, World War 2 Vet, Honored

Twenty-one year old Walter W Moore, enlisted in the Army Air Corp in February 1943 and served until November, 1945. After getting his wings in May 1944, he was assigned to the 487th Bomb Group of the Mighty

Eighth Air Force in England. He flew 30 ½ missions over Nazi Germany. The target on his 31st. mission was an oil refinery at Ruhland, Germany. (Nine minutes from the Russian line). Thirty minutes off the target the number two engine of his B-17 was hit and set afire by flak (Anti-aircraft fire) near Pilsen, Czeckoslovia. After parachuting out of their plane, his crew was captured and transported by train across Germany to Stalag V-A in Ludwigshafen near the French boarder. Shortly thereafter, the bloom of allied artillery could be seen on the skyline. The camp had about 1000 prisoners consisting of Americans, English, Indians and Russians. The entire camp was put on a march to postpone their ultimate liberation. Weeks later, the prisoners still on the march, were liberated by General George Patton's Third Army.

Walter received the Air Medal with four oak leaf clusters, the ETO Ribbon (Eastern Theatre of Operations) with one campaign star, the Ex-POW Medal and the Victory Medal. He also is a member of the Caterpillar Club. (Members have parachuted out of a disabled plane). The Veteran's Administration has declared Walter to be totally and permanently disabled. He recalls that his biggest thrill was returning to America via the Statute of Liberty. "There were three fire boats streaming water toward our boat with bunches of pretty girls cheering us. There were about 3000 Ex-POWS on board but not one dry eye. We were so very proud of our country and of being Americans". In addition to the Wounded Warrior Coin and Certificate, Compatriot Moore received a special Certificate of Patriotism from the National Society of the S.A.R. for his WWII service.
