

Society President's Message

My fellow Compatriots, it is a distinct privilege and honor to serve the Florida Society as your President for the 2015-2016 term. As I related to those attending the Florida Society's May 2, 2015 Annual Meeting, the theme for my term as your President is, "Back to Basics."

The "Basics," that I am referring to, are Chapter development and support, including recruit-



Our Florida Society Chapters are the fundamental elements of the state society. Some chapters are physically too distant to allow their members to attend our Board of Management Meetings. Immediate Past President, Steven A. Williams initiated the concept of Regional Meetings, but as with most new initiatives, it takes time for the idea to germinate. I have asked Senior Vice President Ray Wess, to promote Regional Meetings to all of our Regional Vice Presidents. Florida Society leadership is available to meet with our compatriots on their "home turf," and hold topic specific training sessions similar to those that are available at our BOM meetings. While new member recruitment is essential for chapter growth, member retention is equally vital. During Past President Ted Duay, III's term, with the invaluable assistance of his wife Debbie, our society was introduced to new genealogical tools (including Debbie's compilation of an on-line Florida Patriot Database) and research methods for researching patriot ancestors. With over 65% of Florida's population having a Hispanic link, there are potentially innumerable individuals who may have a patriot ancestor with lineage to General Bernardo de Gálvez's Spanish troops who contributed to the American Revolution. The names of those Spanish patriots have been released by the Spanish government and are available for research. Membership retention is vital for chapter sustainability. A key tool for member retention is to determine why a compatriot becomes disenfranchised with the SAR. Are the meetings at the wrong time, day, too expensive because of location...or are the meetings, just boring. The Membership Promotion and Retention Committee will emphasize member retention with some new concepts this year.

The Florida Society has several youth and educationally related programs that are challenging and fun for compatriots and contest participants. The Rumbaugh Historical Oration contest, the Eagle Scout program, the JROTC programs and Americanism Elementary School Poster and Middle School Brochure programs are known to most compatriots, but some chapters do not participate in these. The Knight Essay Contest and the American History Teacher Award are programs that perhaps appear more challenging to some chapters. These two contests reach two distinctly different subsets. The Knight Essay contestant does not have to be affiliated with any peer or specific educational group. Whereas most of the SAR programs are directed towards our youth, the American History Teacher Award is specifically for the educator and provides unique educational opportunities for the recipient. The Good Citizenship Certificate program has been vastly underutilized by the majority of Florida Society chapters. The program recognizes students, recommended by the school administration, in the 5th and 6th grade for their good citizenship by awarding certificates, provided at no cost to the participating chapters. This program is an excellent entre into the local school system. All of these programs provide excellent opportunities for public exposure to the principals and ideals of our Society.

Patriotism and the recognition of our patriot ancestors are the foundations upon which our society was founded. Promotion of patriot-

FLSSAR Officers Election Process

Our state society has elections every year at our *Annual Meeting* held at the Spring BOM. A Nominating Committee of five is nominated by the President and/or members of the BOM and elected by the BOM for a term to end upon adjournment of the next Annual Meeting. The Nominating Committee members can not have served on a prior Nominating Committee of the FLSSAR during the proceeding two years. The Nominating Committee shall elect its own Chairman.

The committee is to canvas the FLSSAR to solicit suggestions of those who are qualified and willing to serve in office for one year. The President and Senior Vice President agree to physically reside in the State of Florida for no less than six months during the year of office.

All nominees are expected to be members in good standing. A form describing their experience serving their Chapter and FLSSAR; as well as, current employee or career which could help them in the job volunteering is submitted. The Recommendation for Nomination as FLSSAR Officer is available on our website.

The Nominating Committee shall announce the names of the persons chosen and given to the FLSSAR Secretary at least 60 days prior to the Annual Meeting. This list will be published in a manner to assure every FLSSAR member is given at least 30 days notice prior to the Annual Meeting. It should be noted; however, any member of the FLSSAR may nominate any qualified member from the floor at any BOM meeting a person for any elected office.

The FLSSAR officer positions to be elected are President, Senior Vice President, Regional Vice Presidents, Secretary, Treasurer, Recording Secretary, Registrar, Chancellor, Chaplain, Genealogist, Editor, Webmaster, Historian, Member-at-Large of the Executive Committee and Sergeant-at-Arms; as well as, National Trustees, Alternate National Trustees, and nominees for NSSAR VPG South Atlantic District (to be elected by Congress delegates). It would be helpful if current officers or members interested in serving in these positions let the Nominating Committee know their interest and willingness to continue serving or wish to be considered to serve in another position. Hopefully this process can work smoothly and to the benefit of all FLS-SAR membership.

Ladies Auxiliary GRAPEVINE

The Ladies Auxiliary met during the May Board of Management meeting in Orlando. 

The City Council of the City of Jacksonville, consisting of one of the first in the nation to include both the consolidation of the city and the county, set aside March 21, 2015 as The Battle of Thomas Creek Memorial Day by proclamation.

On March 21, 2015, the Jacksonville Chapter, Florida Society, hosted the dedication of a Historical Marker, commemorating the May 17, 1777 Revolutionary War Battle of Thomas Creek. The encounter was the first major engagement and the second of three failed attempts by American forces to invade British East Florida. It is considered the southernmost battle of the American Revolutionary War. President General Lindsey Brock brought greetings from the National Society. Representatives were present from the City of Jacksonville, National Park Service, National and Florida, Georgia, South Carolina, and North Carolina Societies SAR, DAR, CAR, Sons of the Revolution, and Washington-Rochambeau Revolutionary Route Association. 26 wreath presentations were made. National Color Guard Adjutant Mark Anthony commanded a Color Guard of 27 Compatriots.

Four Accounts of the Battle of Thomas Creek

On December 18, 1775, General George Washington wrote a letter to John Hancock, warning that the British were stockpiling weapons and gunpowder in St. Augustine, in order to reclaim the Southern Colonies.

In response, the Continental Congress "recommended" Georgia and the Carolinas to launch an expedition into East Florida to defeat the British Regulars, capture Fort St. Mark in St. Augustine, and neutralize the Loyalists and Indians.

In June 1776, the First Expedition began; some Continentals of Major General Charles Lee burned Loyalist plantation forts on the St. Marys River. Unfortunately, Lee was recalled to the North. He took his Virginia and North Carolina troops with him and ordered the South Carolinians to return to Charlestown. The Georgia Continentals reached the St. Johns River; fought some pro-British Indians at the Cow Ford (present day downtown Jacksonville); but did not even threaten St. Augustine.

Early in February 1777, the Georgia Council of Safety elected Button Gwinnett President and Commander of the Georgia Militia. He decided to begin a Second Expedition to capture St. Augustine, especially in retaliation for the extensive cattle raids by the Loyalist Florida Rangers.

General Lachlan McIntosh was ordered to proceed to Sunbury, and Colonel Thomas Sumter to Fort Howe to assist the Georgians.

Heading south from Savannah, General McIntosh and President Gwinnett, repeatedly fought over command; so much so that when the expedition reached Sunbury, orders were waiting for both men to return to Savannah.

Colonel Samuel Elbert (a man with limited military expertise) was placed in charge of the expedition. Arguments between McIntosh and Gwinnett resulted in a duel in which both men were wounded, and Button Gwinnett died three days later.

Four officers played major parts in the Battle of Thomas Creek:

For the Patriots- Colonels Samuel Elbert & John Baker, and for the British– Colonel Thomas Brown & Major Marc Prevost. These four officers will introduce themselves and give their account of the battle–

1—Elbert Bio- I am Colonel Samuel Elbert- I was born in South Carolina in 1740, the son of a Baptist minister, who died when I was fourteen. Apprenticed to a merchant in Savannah, I became a successful trader with the Indians. But I really wanted to become a military officer, so I traveled to London to learn the duties of military life. While in England, I obtained uniforms and equipment, and upon my return, organized a British Grenadier Company in Savannah. A year later, I joined the Sons of Liberty, and in 1775, became a member of the Council of Safety and lieutenant colonel in the Georgia Continental Line.

Samuel Elbert's Account- In order to get to Florida, I directed Colonel Baker and his Continental and Militia dragoons to proceed by land over the Kings Road, and my Continental infantry to sail in galleys through the Inland Passage.

The King's Road stretched 200 miles all the way from Savannah to St. Augustine, and was sixteen feet wide. The Inland Passage was a series of tidal rivers between the mainland and the six barrier islands from St. Catherine's south to Amelia.

I planned a rendezvous on May 12, near the mouth of the Nassau River at a place called Sawpit Bluff. Then together we would cross the St. Johns River and continue to St. Augustine.

On May 1st, we embarked about 400 Continentals on seven vessels at Sunbury carrying twenty canon.

The Inland Passage offered protection from harsh conditions of the open sea, but was very slow due to delays waiting for favorable tides and currents that the galleys could navigate. Finally, we arrived on the north end of Amelia Island on May 19. I dispatched Lieutenant Ward with about twenty men to round up the inhabitants and prevent them from relaying our position to Loyalists on the mainland.

Some of the Amelia Loyalists fired on Ward's party, killing him and seriously wounding two others. In retaliation, I ordered Lieutenant Winfree to burn every house and destroy all the stock.

Ironically, I later learned that when we arrived at Amelia Island, Lt. Colonel John Baker's troops had already been defeated at Thomas Creek two days earlier.

For six days, our galleys tried to get through the Amelia Narrows into the Nassau River, but with the heavy cannons on board we could not. Since so many men had been stricken by disease on the voyage, I decided to wait at Amelia Island to join up with Colonel Baker before continuing to St. Augustine.

Now let's hear from Lt. Colonel John Baker whom Elbert ordered to join the South Carolina militia at Fort Howe.

John Baker- bio I was born in 1722 in (Dorchester) Massachusetts. Along with other Congregationalist families, we first moved to Dorchester, South Carolina and then to Midway, Georgia in 1752. I was 54 years old when commissioned Captain in the St. John's Riflemen, a volunteer company of Militia. I was soon promoted to Colonel commanding a Battalion of Militia, but later that year, I transferred into the Continental Army, along with most of my men. There I was commissioned Lieutenant Colonel in command of the 1st Regiment Georgia Continental Light Horse, a position in which I served during the Second Florida Expedition.

John Baker's Account- Arriving at Fort Howe, I learned that Colonel Sumter had been ordered back to Charleston. Nevertheless, We - about 165 Continental and GA Militia along with extra horses and baggage - set out on the King's Road. This was a fine road, but we had to continuously watch for Indians, bandits and Loyalist Militia.

The rivers were so swollen by spring rains that we spent two days crossing the Altamaha. On May 4, Indians attacked our camp; two of my men were wounded and one Indian killed. We faced additional delays when crossing the swollen Satilla and St. Marys Rivers.

We finally arrived in British East Florida on May 10. Leaving the King's Road, we were forced to cross treacherous swamps, but two days later arrived at the rendezvous point, Sawpit Bluff, on the appointed date, May 12. I found that Colonel Elbert had not arrived, and from scouts, learned that his large flotilla was still north of the St. Marys River.

We erected a fortified camp, and I sent forty mounted men commanded by my brother, Major William Baker, to conduct re<u>con</u>naissance patrols south toward the St. Johns River. During the next three days, we learned that the British knew of our approach, and were planning to challenge our advance.

In fact, the Florida Rangers did attack on May 14, but were seen by my sentry who fired his musket and aroused our camp. The Rangers quickly retreated, but their Indians stole some of our horses, which we retrieved. In the skirmish that followed; two of my men were wounded, and one Creek was killed. I was unable to stop my men from scalping him.

Knowing that the British were aware of the size and location of my command, I decided not to wait any longer for Colonel Elbert. Traveling northward, we moved toward Thomas Creek where we could retreat if attacked by the superior force which I expected.

At about 10 o² clock in the morning of May 17, weabout 109 soldiers – were surprised by the British with a force of more than twice the size of ours.

There were Indians firing on our flank, and many Rangers in front of us. We had no alternative but to retreat, which unfortunately lead directly into the bayonets of the British Regulars. Thirty of my men simply deserted at first fire; and my remaining Georgians were quickly overwhelmed and began retreating into the nearby swamp.

Although some fought courageously, I was disgusted with the cowardly actions of most of my men.

During the fight, one stole my horse to make his escape. I shouted to the fleeing rider that unless he stopped, I would shoot him in the back. Fortunately, he stopped, and I narrowly escaped capture.

Our casualties were significant: three killed; nine seriously wounded; and thirty-one surrendered or captured. But at least one-half of my men deserted into the swamp; and only eighteen escaped with me to join Colonel Elbert at Amelia Island. Our horses saved us from total destruction.

And now, we will hear from the perspective of the British- First from Lieutenant Colonel Thomas BrownThomas Brown's bio - I was born in 1750 in Whitby on the English coast of the North Sea, the son of a wealthy merchant.

When twenty-four years old, my father outfitted a ship and recruited more than seventy indentured servants for my voyage to Georgia. Upon arrival, I established Brownsborough, which I named for my father, near Augusta. I strongly opposed the efforts of the Sons of Liberty to enforce the continental association against trade with Britain. In August, 1775, about 100 Liberty Boys came to my house and demanded that I sign an oath of loyalty or receive a thrashing.

Before it was over, I was scalped three times, stripped, tarred and feathered, and my legs were badly scalded where the hot tar collected in my boots. They took off my boots, put hot brands to my feet, and burned off two toes. They tagged me with the nickname of "Burnfoot Brown," but I vowed they would soon regret that day.

When recovered, I fled to British East Florida, and unveiled a plan to Governor Patrick Tonyn for the conquest of Georgia and the Carolinas. Commissioned as a lieutenant colonel in command of the Florida Rangers, we began a campaign of harassment and terror on the Georgia frontiers. Thomas Brown account- At Cow Ford, we learned that a group of rebels had crossed the St. Marys and Nassau Rivers. On May 14, I embarked about forty Rangers and fifteen Indians aboard a schooner, and sailed up the St. Johns River to Trout Creek, where we began searching for the rebels. Within three hours, we found them; but before we could attack, we were seen by one of their sentinels and with the surprise gone, I decided to retreat to the ship.

But I ordered the Indians, led by a warrior named Black Creek Factor, to steal as many of their horses as possible. The Indians did, but the rebels overtook them and retrieved their forty horses.

A brief skirmish occurred and one Creek was killed, whom the rebels scalped and mutilated. This drove the Indians into uncontrollable rage. I was amazed that the small group of Indians chased the sixty rebels for over an hour, who refused to stop and fight.

I felt that the Georgians would regret this action when we finally caught up with them. I embarked my troops on the schooner and returned to Cow Ford to tell Major Marc Prevost about the activities of the rebels.

Now let's hear from Major Marc Prevost who was in charge of the British Regulars whom Brown came to tell about the actions of the rebels encamped near Thomas Creek.

Marc Prevost – bio - I am Major Marc Prevost and was born in 1736 in Geneva, Switzerland. Originally an officer in the Dutch army, I joined the British Royal American Regiment and was sent to America to fight the French and Indians. I was wounded in the battle of Ticonderoga, and while convalescing in New York City, I met and later married a beautiful young American.

At the outbreak of the War of American Rebellion, I was on half-pay, living in New Jersey. Recalled to service in St. Augustine, I became second-in-command to my brother, Colonel Augustine Prevost. My two sons, who were aged 11 and 9, joined me in St. Augustine and served as ensigns with our British Regulars.

Marc Prevost's account- When Colonel Brown informed me of the location of the Georgians near the Nassau River, On May 16, we quickly set out on the Kings Road, We marched about 11 miles northward to Rolle's Saw Mill on Trout Creek, and encamped to await news of the rebels. During the night, one of the Rangers located their force near the south bank of Thomas Creek which he reported to Colonel Brown and me.

We coordinated a plan of attack; I ordered Colonel Brown to ride ahead and gain a position in front of the Georgians while my British Regulars advanced from the rear.

At about 10 o'clock in the morning of May 17, we surprised the rebels who were proceeding toward Thomas Creek. Brown positioned some Rangers and Indians on their flank, while his main body fired at a range of 50 yards into their oncoming mounted troops.

They had no alternative but to retreat into my Regulars who were advancing rapidly in three columns with fixed bayonets. Twenty or thirty of the rebels just simply fled; we quickly overwhelmed the remaining and most retreated into the swamp. According to my Major Patrick Murphy, about forty Georgians surrendered, and all but sixteen were killed and scalped by the Indians. Colonel Brown and I had great difficulty saving the remaining prisoners.

Colonel Elbert later wrote a letter protesting the treatment of the prisoners, concluding with "if the Savages can't be restrained, why are they employed?" Governor Tonyn responded that the Indians sought revenge for the earlier mutilation of the Creek brave.

We found a complete set of plans for the invasion of Florida in Colonel Baker's baggage, but it didn't matter since we learned that Colonel Elbert and his larger force could not navigate the Amelia Narrows.

In Summary –

On May 26, Colonel Samuel Elbert decided to return to Georgia and reached Cumberland Island with 300 men, including only 42 of Baker's dragoons. Elbert ordered the galleys to transport the wounded back to Savannah, where all returned by June 15. The second invasion of East Florida ended with the tragic loss of a large number of Elbert's men. At least forty were killed or captured at Thomas Creek, but many deserted or died from disease contracted in the heat and swampy conditions.

They never approached the citadel of St. Augustine and had no success in preventing the Florida Rangers and Indians from continuing to raid coastal Georgia plantations.

Some actions of these men after the Battle of Thomas Creek---

Samuel Elbert faced Prevost again at Brier Creek where after a courageous stand; he was captured and held prisoner in Savannah for two years. Exchanged and captured again at Charleston; Elbert served at Yorktown, and made general in the Continental Army. He later became Governor of GA; Elbert County is named in his honor.

John Baker resigned his commission as a result of the disaster at Thomas Creek; but later rejoined the militia and faced Brown & Prevost again during the fighting at Midway in Liberty County, where he was wounded. Baker County is named in his honor. He married Mary Lapina at Midway Church in 1784.

Thomas Brown- and his newly named King's Rangers helped defend the British held Savannah during the Franco-American Siege in the fall of 1779. He garrisoned Augusta for two battles with Col. Elijah Clarke, where he hung 13 Patriots which he held as prisoners. Brown was one of the last Loyalist to leave Savannah. He and many of his Rangers settled on an island in the Bahamas, where he was regarded as a hero.

Thomas Brown and Marc Prevost defeated Col. Elijah Clarke and General James Screven at the Battle of Alligator Bridge. Marc Prevost was briefly assigned as Royal Governor of Georgia, after the British captured Savannah in December 1778. Sent with troops to Jamaica to put down an uprising in 1781, he died of wounds suffered there. After his death, his American wife, Theodosia married an up- and coming New York lawyer- named Aaron Burr, but she died before Burr became Vice-President.

As you know, the Florida Expeditions were initiated and failed three times- in 1776, 77 & 78. The required number of troops and artillery under an experienced leader with a good plan who was dedicated to the task never materialized.

Sites Committee Report The Battle of Thomas Creek; Marker Dedication Program The Southernmost Battlefield of the American Revolutionary War May 17, 1777

On March 21, 2015 the National Society and the Florida Society of the Sons of the American Revolution along with the City of Jacksonville dedicated a Florida Historical Marker in Seaton Creek Historic Park Commemorating the 238th Anniversary of the Battle of Thomas Creek. President General Lindsey C. Brock, a member of the Jacksonville Chapter brought greetings to the nearly one hundred (100) SAR, DAR, C.A.R. and others who attended the dedication ceremony. Greetings and 34 wreath presentations were also brought by The City of Jacksonville, the National Park Service,

and several SAR State Presidents, representatives of the DAR and C.A.R. and Ralph Nelson from the National Washington-Rochambeau Revolutionary Route Association. Also, attending the ceremony, were Past President General Roland Downing and his lady Norma, and Dr. Sam Powell, President SAR Foundation.

There were twenty-seven 27 SAR Color guardsmen from NC, SC, GA and FL commanded by Mike Tomme, Past National Color Guard Commander and Treasurer General and Mark Anthony National Color Guard Adjunct and South Atlantic District Vice President General. The invocation and benediction was given by Jacksonville Chapter Chaplain Reverend Robert M. Hale and the Pledge of Allegiance was led by Eagle Scout William Merkert. Compatriot Bill Ramsaur, of the Marshes of Glynn Chapter of the Georgia Society gave a presentation on "Four accounts of the Battle of Thomas Creek". The presentation gave the viewpoints from two Patriot Colonels and two British Colonels.

Purchase of the historic park was unanimously approved by the Jacksonville City Council in September 2012 and finally purchased by the City in late 2013. David Ramseur thanked the former local Director of the Trust for Public Land, Susan Grandin for all the years she worked to make this acquisition possible. Ms. Grandin also got Mr. Ramseur involved in 2011 and encouraged him to contact the elected city officials to purchase the land. As he testified several times before the City Council, it would be a win-win for the city by only paying \$.2M of the \$7.1M cost for the 846 acres that would contain "The Southernmost Battlefield of the American Revolutionary War".

SAR President General Lindsey C. Brock Honored Guest and Speaker at Gainesville Meeting November 18, 2014

President General and Mrs. Brock were the honored guests for the Chapter's regular meeting on November 18, 2014 at The Best Western Gateway Grand in Gainesville, FL.

After dinner was served, President General Brock delivered an interesting history of "Spies in the Revolutionary War". He stated that spies have been around since time began until today.



During the Revolutionary War there were both English loyalists and American loyalists engaged in spy activity, primarily reporting troop movements. These situations often caused families to split over their beliefs. Ben Franklin was forced to send his son to jail.

The most recognized American spy was 21 year old Nathan Hale who answered the call when George Washington asked for volunteers. Captain Hale was captured and ordered to be hanged. Legend recalls his last words: "... I regret that I have but one life to give for my country....." Brock reported that there is no evidence that these were his words. However, he stated that English author Cato has been quoted : "...What a pity it is that we can die but once for our country...."

The use of indivisible ink was common; messages were left in a blind for retrieval by others. Benedict Arnold used cipher. George Washington is recognized as a skilled manager of intelligence.

At one time American had 763 spies assigned code numbers. There is information available about some of them. The Culpepper spy ring, managed by Ben Talmage, included 2 women and #352 has never been identified.

These remarks which enlightened the audience about spies in the Revolutionary War were warmly received. A Certificate of Appreciation and a lapel pin of the US/SAR flags were

presented to Compatriot President General Lindsey C. Brock.

SAR Library Points-of-Contact

My last update to you was on February 17th.

1. Big news that will help for inventory/catalog and security purposes! The finish line was crossed with the barcode scanning project!! Appreciation goes to awesome volunteers and all the staff that helped to get this project completed. Special thanks to Rae Ann Sauer who led the project.

2. In accordance with the earlier Library and Archives Committee decision, 636 microfilm that were not needed or did not fit the Library collection policy have been removed from the collection. 620 of these are "Soundex" microfilm. If an institution in your state desires these rolls, please let me know. The remaining 16 reels are: Ottawa City Directories (9 reels), originally donated by the Starved Rock Library System of Ottawa, Illinois; a "Lake City Graphic" reel donated by an individual from Minnesota; and, 6 Civil War related reels from an individual in Louisville. The Library POCs or Presidents of Illinois, Minnesota, and Kentucky may contact me to obtain these reels otherwise the reels will be properly disposed.

3. Four new user computers for the Library were purchased and are awaiting installation. This includes new monitors made possible by a donation from Compatriot PZ Horton of the Tennessee Society.

4. A new front window sign reflecting the Library's revised hours (as of January 1) was recently placed. The Library is open M-F from 9:30 AM to 4:30 PM and the third Saturday of each month. It is closed the preceding Monday when open on following Saturday.

5. At the Spring Leadership meeting, the Trustees agreed to remove the wooden staircase off the back of the building, and enclose the current open rear area of the Library by replacing the rear door (to wooden stairs) with wall/window and by completing/continuing the wall along the front, inside the Library. Continuing the wall will provide actual office space for the Library staff. Work on the "Rear Area Construction" project is to begin shortly and scheduled to be completed by Congress.

6. As I reported earlier, the file cabinets holding the old Patriot

Index cards located on the floor of the Library are to be moved to the basement area. This work should be accomplished before Congress.

7. My appreciation to Director of Merchandise Susan Griffin who initiated the idea that Merchandise would celebrate National Library Week (April 12-18, 2015) by offering a 10% discount on all items purchased April 3 - April 19 by members of the SAR Friends of the Library. Membership in the Friends is \$25 a year and the application may be found under "NSSAR Forms." Joining the FOL is one of the best ways to show your support for the Library.

8. The "Family Histories" project is nearing completion. This is a collection of almost 850 surname files and miscellaneous genealogical information donated by patrons/members over many years. Many include family association newsletters. All have been scanned and we continue the process of "cleaning-up" the scans. They are to be made available online through the Library website. This will be a great addition to the collection -- lots and lots of interesting and hard to obtain information!

9. The Library's space continues to be used for presentations offered to the general public. The latest one was "Avoiding Potholes on the Road to Genealogical Discoveries," presented recently by Elaine Kuhn.

10. Remember, individuals, chapters, or states can also simply donate to either the Library Special Purpose Operating Fund (SPOF) or the Library Endowment Fund; non-designated donations go to the Library SPOF. We have at least two state societies that have donated \$300 to the Library this year, primarily so that books may be added to the state's collection in the Library. It helps Library Director Michael Christian if you suggest books, etc., that would be suitable for your state's collection. Check the catalog online to make sure the Library doesn't already have the book in the collection.

Trevor had already demonstrated exceptional citizenship and leadership abilities through his ongoing active involvement in Scouting, school, church and community activities. He had earned over 100 merit badges during his Scouting journey but he was told he should work to get more awards. He took this as a challenge and went out to get as many awards as possible including his Hornaday and both the supernova awards plus a few others.

His efforts did not go unnoticed. He soon received a call from the Director of the National Eagle Scout Association notifying him he had received their top Eagle Scout scholarship of \$50,000. A senior at Palm Harbor University High, he is the son of very proud parents Richard and Pamela Case.

1st Battalion, 265th Air Defense Artillery Regiment (1-265th)

Florida Army National Guard

Captain Lee Diggs and Staff Sergeant Glenn Wade of our Flagler County, Florida National Guard unit were the speakers at our March 20, 2015, Flagler Chapter meeting. Captain Diggs covered the history of the 1st Battalion, 265th Regiment, and Florida National Guard. The unit evolved from 1940's WWII service as field artillery, to serve today as an air defense artillery regiment headquartered at the Flagler County Airport. Captain Diggs went on to explain the dual role of the National Guard system in the United States. The first role of the National Guard is to augment the Armed Forces of the United States when federalized by the President. As an example, Captain Diggs stated that sixty percent of the infantry soldiers in the United States are in the Army Reserve or National Guard! The second duty of the National Guard is to serve in times of a natural disaster, a civil disorder or other needs at the request of the Governor. One of the companies of the battalion recently deployed to Afghanistan.

SSG Wade presented an overview of the weapon systems used by the 1-265th in today's Florida National Guard. There are two primary weapon systems in use by the unit. The first system is the "20mm Phalanx CIWS (Close-in Weapons System)' commonly referred to as the "Anti-Everything Gun." This weapon fires over 4,000 rounds a minute and is radar controlled. This unit has anti-aircraft and missile defense capability. The second system used by the 1-265th is the "Stinger Missile" which can be fired, using a hand-held launch system, or from a vehicle mounted platform. SSG Wade stated that the "Stinger" system was being phased out of service prior to "9/11", however, the Department of Defense saw the need for a hand-held defense missile and the "Stinger" was retained as a proven weapons system. Both systems were demonstrated in videos shown to our group. Captain Diggs and Staff Sergeant Wade are exemplary examples of the professional and highly motivated members of our Florida National Guard. We can all take pride in Flagler County serving as the location for such a fine group of individuals. Moreover, we thank them for their service!

The NSSAR Veterans Recognition Committee has staff cognizance of the administration of the National SAR Veterans Corps. The most recent Veterans Corps brought online was the Military Service Veterans Corps. It was the initiative of President General Brock as detailed in the in the January 2015 issue of the NSSAR Veterans Bugle Newsletter. That issue as well as the other Veterans Bugle issues can be viewed at the website listed above.

The Military Service Veterans Corps (MSVC) recognizes any and all veterans who served honorably and are entitled to wear the SAR Military Service Medal. The associated certificate of patriotism for the MSVC states: "As a member of its Military Service Veterans Corps, Compatriot (your name) is honored with this Certificate of Patriotism for standing ready to defend the United States against all enemies, foreign or domestic. As a Veteran, he is authorized to wear the Military Service Medal in grateful recognition of his service to country so as to ensure America remains a nation of free men and women." If you request to join the MSVC don't check off any other Veterans Corps listed on the Veterans Multi-Corps Survey Form.

The clearest analogy we can draw between this new Veterans Corps and the WW II Veterans Corps; Korean Service Veterans Corps; Vietnam War Veterans Corps, and Persian Gulf War Corps is like the American Legion is to the Veterans of Foreign Wars. The Legion is open to all veterans while the VFW is restricted to those who have served overseas during specific periods of conflict. The NSSAR Veterans Multi-Corps Survey Form, found via the web link listed above, is the means whereby a Compatriot can join the MSVC or any of the other Veterans Corps which come under the purview of the NSSAR VRC.
