

Putting Meat on the Bones President George Washington and the Early Years of the New Republic

George Washington stood on the balcony of Federal Hall at 26 Wall Street in New York City in the late, cool morning of April 30, 1789 with his freshly powdered hair (he didn't wear a wig) clothed in a freshly tailored suit surrounded by the first members of Congress. He faced Chancellor Robert Livingston, the highest judge of New York. His right hand rested on a Bible borrowed from the York Rite Masonic Lodge in New York City as he repeated the required Constitutional oath "to execute" the office of President and to "defend" the Constitution. He then added, "So help me God."

Washington must have felt much as he did when the Continental Congress appointed him Commanding General of the United States back in 1775 when he had only an imaginary army. This time he had neither cabinet, budget, money, army, navy, nor even a judiciary system. But he did have a newly elected Congress which, by Confederation Congress law, was supposed to convene on March 1, 1789. The House of Representatives failed to have a quorum until April 1. The Senate followed suit on April 6. After the inauguration President and Congress had to build a ship of state. Their only guides were the freshly inscribed Constitution as well as their own experiences and learning.

Someone once wrote that the secret of American genius was in the skill to organize. It was that skill which created the Stamp Act Congress, the Committees of Correspondence, the Continental Congresses, the Confederation and the Constitutional Convention. So the first order of business was to put together a working Congress consisting of leadership and functioning committees. The House elected a Pennsylvanian as its first Speaker. Frederick Augustus Conrad Muhlenberg, a Lutheran pastor and poet, born in Pennsylvania but educated at the University of Halle, Germany. Muhlenberg held the position of Speaker until he declined re-election in 1796. William Linn, a Presbyterian minister and Princeton graduate, was appointed Chaplain of the House, at an annual salary of of about \$500 and Samuel Provoost, Episcopal Bishop served the Senate as Chaplain. Among the measures passed by the First Congress were laws setting oaths of office for members of Congress, executive officers, and Judges, as well as State legislators and officials. Laws were enacted providing funds for negotiating with Indian tribes, building light houses and for a post office department. One of the most significant moves was an act to incorporate the Northwest Ordinance of 1787 into Federal law.

The Constitution had created the Supreme Court and other "inferior courts," but the burden fell on Congress to actually create the Third Branch of Government—ironically, the 1st Branch birthed the 3D Branch! The Judiciary Act of 1789 did just that. It provided for a Supreme Court of six Justices (the number has changed from time to time, but by the end of the Civil War the present number of nine was, more or less, inscribed in stone) including the Chief Justice of the United States and District Courts with a single Judge spread out among the

Thirteen States. Congress positioned three appeals courts, labeled "Circuit Courts of Appeal," between the District Courts and the Supreme Court. Two Justices of the Supreme Court and a District Judge made up each Circuit Court. They were called Circuit Courts because the three members had to "ride circuit," like the Methodist circuit-riding ministers, from place to place.

All the members were to be appointed by the President with the approval of the Senate. The Act also created the office of Attorney General as the fourth Cabinet officer. Washington appointed Edmund Randolph, a distant cousin of Jefferson, as the first AG.

With Madison's advice, Washington appointed John Jay of New York, the third author of the Federalist Papers, to be our first Chief Justice. The position was not highly coveted. Jay resigned a few years later to accept a diplomatic post to London. There he negotiated the Jay Treaty in an attempt to settle matters with Great Britain. Jay was succeeded by Oliver Ellsworth, the author of the Judiciary Act. A few years later, Ellsworth resigned. It was not until President John Adams appointed John Marshall, another cousin of Jefferson, to be Chief Justice that the high court began to take on the strong trappings of our Third Branch.

The most important member of the House of Representatives was undoubtedly James Madison, Jr. of Virginia. Madison had run against James Monroe on a platform of enacting a Bill of Rights which he shepherded through Congress and submitted to the States for ratification. The first Ten Amendments to the Constitution stand as perhaps the greatest contribution of Madison. But the diminutive, brilliant Congressman did much, much more. Unlike other Southern leaders, he was educated at Princeton, completing a three-year course of study in two years, but remaining at Princeton to study Hebrew and Philosophy, primarily the works of Enlightenment thinkers, under the President, the Reverend John Witherspoon.

Washington drew heavily upon Madison's views for the creation of his Cabinet as well as for the first men to hold those positions. Thus Congress created the positions of Secretary of State, Secretary of the Treasury, and Secretary of War, in that order. Washington and Madison were in agreement that the first Secretary of the Treasury should be Washington's brilliant young aide-de-camp, Alexander Hamilton. Washington's choice as Secretary of War fell on the former book-seller, and chief of artillery, General Henry Knox. Madison lobbied for his friend Thomas Jefferson for Secretary of State. At first Washington was cool to the suggestion. Jefferson had not been in the Constitutional Convention, nor had worked for its approval by Virginia. He was out of the country as our envoy to France. It was also rumored that Jefferson rather enjoyed being in France and was not eager to return. Nevertheless, Washington offered him the position and Jefferson accepted.

Madison performed other important tasks for his President. When Washington needed an inaugural speech, he turned to Madison. In the speech, most of which was written by Madison, the President unpretentiously alluded to his lack of experience for civilian office, and implored the Almighty to bless their efforts. He asked Congress for only one thing—to create a Bill of Rights. James Madison then responded enthusiastically for Congress, in essence to his own speech! As noted above, he took charge and pushed the first Amendments through Congress. Ten of them survived and became our Bill of Rights.

Washington commissioned Alexander Hamilton with

what was perhaps the the biggest job of all—to nurture our young economy, to create a monetary system and to service our national debt, created by eight years of war. Hamilton responded with four reports to Congress. The most important papers were on manufactures, emphasizing the importance of tariffs to protect the products of our young factories and to provide the nation's primary source of revenue, and a controversial report on "The Public Credit." In the latter, Hamilton called for: (1) the assumption of State debts, (2) combining State and Confederation debts into a National Debt, (3) the exchange of Continental currency for new Federal bonds at face, rather than depreciated, values, (4) chartering a National Bank to service the debt and to issue bank notes in lieu of currency, and (5) creation of a mint to manufacture coins.

Jefferson and Madison objected to the creation of a bank, to the assumption of state debts and to funding the old Continental currency at face value. The most serious question was the bank which Jefferson called "unconstitutional" because the Constitution did not specifically authorize the creation of a bank within the powers of Congress in Article I, Section 8. When Washington asked Hamilton to respond to the issue, the Secretary of the Treasury wrote that the Constitution does allow for the establishment of the bank in the final power given to Congress in Section 8—"To make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers and all other Powers vested by this Constitution in the Government of the United States or in any Department or Officer thereof."

Washington accepted the explanation, but the report had to be approved by Congress before it could be implemented. Madison and Jefferson balked. They were also opposed to both the assumption of state debts and the redemption of Continental money at face value for two reasons. States which had smaller debts (they had borne a smaller role in the war) would be forced to bear a heavier burden than those with larger debts. And currency speculators, those who now held the notes, would reap an unfair profit. Only some sort of compromise with Hamilton would offer a solution.

It was this conflict between Jeffersonians and Hamiltonians which moved the government toward a two-party political system. Jefferson arranged a dinner for the three men and it was over this dinner that they worked out a compromise. Hamilton held one bargaining chip. The Constitution stipulated that a capital city would be platted at some location to be purchased by Congress, but no locale had yet been agreed upon. Northerners preferred to keep it in Philadelphia, but Jefferson wanted it located close to Washington's Mount Vernon. After a fine dinner prepared by Jefferson's chef and a few glasses of Madeira, the compromise was agreed upon. Jefferson and Madison accepted Hamilton's Report. The National Debt would be created and a National Bank would be chartered. And the capital city, to be named Washington, would be located in Maryland, at a 10-mile by 10-mile District of Columbia, upstream the Potomac from Mount Vernon.

Thus, Madison and Hamilton, the grand collaborators of The Federalist Papers which persuaded the State Conventions to ratify the Constitution of 1787, emerged by 1792 as the leaders of two opposing political factions with different views of the meaning of the Constitution. The Jeffersonian-Madisonian position came to be called "Strict Construction," i.e. if the Constitution doesn't specifically state it, you can't do it, while the Hamilton view was referred to as "Loose Construction," i.e. if the Constitution doesn't forbid it, you can do it. For better or worse, this was the beginning of our two-party system!! The Federalist Party v. The Jeffersonian Republican Party. The Federalist Party would be dead by 1820. The Jeffersonians would morph into the Democratic Party under Andrew Jackson and another opposition party, The Whigs, emerged under the leadership of Henry Clay. The issue of slavery split the Whig Party into Conscience Whig (Northerners) and Cotton Whigs

(Southerners). A few third parties, such as the Liberty Party, Free-Soil Party, the Know-Nothings, and the nativist American Party, sprang up to fill the vacuum. But it was not until 1854 when the organization of the Republican Party filled the void that the two-party system re-emerged.

NSSAR GERMANY SOCIETY!

The Germany Society, Sons of the American Revolution was establish to honor the men of German Regiments who fought under the French Expeditionary Forces of France commanded by Jean-Baptiste Donatien de Vimeur de Rochambeau in support of establishing Independence for America. Many of our members also have patriot ancestors of German heritage.

Following the American-French Alliance of 1778,

the French committed ground forces to the American cause, first appearing at the Battle of Saratoga and later at Yorktown. The French expeditionary force was under the command of Jean-Baptiste-Donatien de Vimeur, Comte de Rochambeau. His force consisted of seven regiments, one of which was the German Regiment Royal Deux-Ponts.



The Regiment Royal Deux-Ponts was formed in 1757 by Duke Christian IV of Pfalz- Zweibrucken. The Duke, indebted to Louis XV of France, pledged his army to the French. It served France throughout its existence, even though it came from a Germanic region.

In Europe, the "two bridges" area (Deux-Ponts/Zweibruken) shifted over time between the French and the Germans but the Regiment's loyalty never did. Its blue uniform coat with its yellow facing, by coincidence, happened to be the colors of George Washington's uniform during the American Revolution.

The Regiment deployed with Rochambeau's army, and although composed of big robust men, suffered the loss of nine men during the 72 day crossing to America with more than 450 sick at the time they disembarked.

The Regiment was commanded by Guillaume Christian, Compte Deux-Ponts, and was composed of 69 officers and 1031 men. Rochambeau had specifically requested the Regiment Royal Deux-Ponts because of its fierce fighting reputation. One of the regimental officers, Baron Ludwig von Closen was chosen as Rochambeau's aide-decamp.

Facing Hessian troops at Redoubt 9 at Yorktown, Germans fought Germans. The Regiment suffered its greatest losses at the (greater than any other unit in the battle), with 46 killed and 68 wounded. Many more died subsequentPAGE 8 THE FLORIDA PATRIOT



ly of their wounds.

In recognition of their valor, General Washington presented the Regiment Royal Deux-Ponts with a captured cannon and flags of General Lord Cornwallis. The regiment's commander, Guillaume Christian, sent the cannon, along with Rochambeau's dispatches and the captured British colors to the French King.

Following the war, King Louis XVI awarded Guillaume Christian the prestigious Order of Saint Louis and promoted him to Brigadier General. In 1788, at age 35, he was promoted to Major General.

In 1790, the French ceased recruiting Germans and the Regiment lost its designation of "Royal." It was then designated as the 99th French Infantry Regiment and served France through World War I and II, as well as in Lebanon in 1980 and Bosnia in 1990. Its 240 year history concluded in 1997 when, due to downsizing of the French military, the Regiment was disbanded and its storied colors retired.

In addition to honoring this great Patriot Regiment, the Germany Society was created to help promote and support the mission of National Society of the Sons of the American Revolution by spreading American patriotism and knowledge of the history of the American Revolution and the founding principles our democratic republic. The Germany Society also provide financial support to the NSSAR through our society contributions to various needs and projects.

The Germany Society is always looking for Compatriots to join the Germany Society and only requirement for membership is to be an active member in good standing in the National Society of the Sons of the American Revolution.

Medals & Awards Committee Report

As stated in the NSSAR Handbook (Volume 5), the awarding of medals and awards should always be given very careful and serious deliberation to determine that the proposed recipient is qualified, deserving, and the occasion for presentation is appropriate. The presentation of medals and awards should not be treated

lightly by the National Society, district, state society or a chapter, and should always be given judicious thought to assure that the presentation is in keeping with NSSAR principles. It is essential that the integrity of NSSAR medals and awards be maintained.

As for the Florida Society, any nomination for a certificate and any supporting data to be used in making an award of a certificate must be submitted to the FLSSAR Medal & Awards Committee 60 days before any Board of Management Meeting so that the committee can evaluate the request, secure the certificate and/or medal from National if it is not already in FLSSAR inventory and have it prepared for signatures at the upcoming Board of Management Meeting. Most certificates issued by the Florida Society require the signature of the Society President and Society Secretary.

A member may be awarded several National Society medals more than once: Meritorious Service Medal, Roger Sherman Medal, Heroism Medal, Bronze Good Citizenship Medal, Liberty Medal, C.A.R.-SAR Medals of Appreciation, Samuel Adams Congress Planning Medal, Service to Veterans Medal, and the Florence Kendall Award.

Each medal previously listed has its own criteria. Please refer to the specific medal in the Handbook for the number of oak leaf clusters and/or multiple awards permitted. Also, any multiple awards of state society medals should use the oak leaf cluster system. For more specific information on each award medals available, refer to the NSSAR Handbook (Volume 5).

When various committees of the FLSSAR plan to give out certificates, medals, patches etc. for such programs such as the Knight Essay Contest, the Rumbaugh Oration Contest, JROTC, CAR, Eagle Scout, the committee chair is responsible to notify the Medal and Awards Committee of the number of awards that they are planning to award for the upcoming year by October so that the appropriate items can be ordered from the NSSAR. Although such awards may not need to be approved by the Medal and Awards Committee, proper planning is required in order to keep cost down and to not have to expedite such awards based on last minute planning. Note that typically, if the FLSSAR orders such items in the Fall of each year, there is a sale of them that help the Florida Society save some money so that we can better appropriate resources for other projects.

Committee Activity:

Veterans Recognition Committee continues to work with Chapters to expand the membership both the FLSSAR Veterans Battalion and NSSAR Veterans Corps with Compatriots who served honorably in the armed forces. Chapter Presidents are contacted quarterly and encouraged to promote Veterans Battalion program.

Committee chairman reviews Veterans Battalion requests within 24 hours of receipt of the required VB application and DD-214. Chapters are mailed a VB acceptance letter and Certificate within 48 hours for Compatriot presentation.

Chapter Presidents are requested to personally present the Veterans Battalion Certificate along with the authorized Military Service or War Service medal to approved Compatriots at a chapter meeting. The chapter is encouraged, but not required, to purchase the medal for each compatriot directly from SAR.org.

Chapter Presidents are reminded that the SAR War Service Medal is only authorized for Compatriot veterans with proof of war service directly in a DOD designated "combat area" noted on the DD-214. Non-combat related military service qualifies for the SAR Military Service Medal. The medals have equal rank.

The committee continues to work with Chapter Presidents and the NSSAR Veterans Corps committee to help FLSSAR Veteran Battalion members apply for the NSSAR Veterans Corp recognition.

Veterans Battalion Roster is updated on the FLSSAR web site quarterly listing Veterans Battalion members by Region & Chapter.



Rick Haven (1946 - 2020)

It is with deep regret that the FLSSAR and the Palm Coast SAR Chapter inform you of the passing of Rickard Lee Haven. As many recall, he supplied many members of the Florida Society with tailored Colonial Period uniforms and had represented the FLSSAR at various DAR Forum and at the NSSAR Congresses. He lived in Crescent City, Florida and was also active member of the Free and Accepted Masons in Florida and Virginia. upon which he was a past Worshiper Master. He died on February 10, 2020 following a brief illness.

Richard was born in Jacksonville and had been a winter resident of Crescent City and became a full time resident 25 years ago, coming from Williamsburg, Virginia. He excelled as a tailor and pattern designer for making 18th century clothing. He was the owner of Just Two Tailors and Tailor's Guide, supplying clothing and patterns for many Reenactors and Fife & Drum Corps across the United States and beyond. He even had his clothes appear in a few period movies. He was



renowned in his craft and was considered to be preeminent as a clothing designer and tailor. He had also operated a third business with his good friend Johnathan, *Two* Old Men, doing minor renovations and home repairs. He was active in the Sons and Daughters of the American Revolution and was a member and a past Worshipful Master of Lake Lodge #72, Free and Accepted Masons. He had shared his great knowledge of American History as a substitute teacher in Poultney, Vermont, Palatka High School, Crescent City High School, and at many reenactments and rendezvous over the years. For a time, he had also published a weekly paper on political current events, American Patriot News Local. He will be sorely missed by many of his patrons and friends.

He was preceded in death by his parents, Robert F. Haven and Catherine E. Martin. Surviving are his partner and companion, Evelyn Roberts; five children, Tracy Ann (Nick) Hinson, Robert (Jennifer) Haven, Paula (Philip) Morse, Thomas Haven, and Amy (John) Currin; seven brothers and sisters, Jeff Haven, Brian Haven, Patrick Haven, John Martin, Cheri Haven, Michele Nieberding, and Kim Blasingame; 17 grandchildren; 10 great grandchildren; and numerous nieces and nephews.

Election of 1800.... Contentious as 2020!

The more things change, the more they seem to stay the same... especially when we compare and contrast past presidential elections with the seemingly unprecedented drama unfolding in 2020 election.

On February 17, 1801, <u>Thomas Jefferson</u> is elected the third president of the United States. While the election constituted the first peaceful transfer of power from one political party to another in the United States, it was filled with deep divisions between parties, crude and unseemly conduct by presidential candidates, in fighting between political parties, acrimony, divisions in the populace, and even duels to the death between candidates.

By 1800, when Jefferson decided to run for president, he possessed impressive political credentials and was well-suited to the presidency. In addition to drafting the <u>Declaration of Independence</u>, Jefferson had served in two Continental Congresses, as minister to France, as Secretary of State under <u>George Washington</u> and as Vice President under <u>John Adams</u>.


However, vicious partisan warfare characterized the campaign of 1800 between Democratic-Republicans Jefferson and Aaron Burr and Federalists John Adams, Charles C. Pinckney and John Jay. The election highlighted the ongoing battle between the Democratic-Republican supporters of the French, who were embroiled in their own bloody revolution, and the Pro-British Federalists who wanted to implement English-style policies in American government.

The Federalists abhorred the French revolutionaries' overzealous use of the guillotine and as a result were less forgiving in their foreign policy toward the French. Federalists advocated a strong centralized government, a standing military and financial support of emerging industries.

In contrast, Jefferson's Republicans preferred limited government, unadulterated states' rights and a primarily agrarian economy. They feared that Federalists would abandon revolutionary ideals on which the United States was founded and revert to the English Monarchical style political process.

As Washington's Secretary of State, Jefferson opposed Secretary of the Treasury Alexander Hamilton's proposal to increase military expenditures and plan to launch a National Bank. He resigned when Washington supported the leading Federalist's plan for a national bank.

After a bloodless but ugly political campaign in which candidates and influential supporters on both sides used the press, often anonymously, as a forum to fire slanderous volleys at each other, the then-laborious and confusing process of voting began in April 1800.



Individual states scheduled elections at different times and although Jefferson and Burr ran on the same ticket, as president and vice president respectively, the <u>Constitution</u> still demanded votes for each individual to be counted separately. As a result, by the end of January 1801, Jefferson and Burr emerged tied at 73 electoral votes apiece. Adams came in third at 65 votes.

This unintended result sent the final vote to the <u>House of Representatives</u>. Sticklers in the Federalist-controlled House of Representatives insisted on following the Constitution's flawed rules and refused to elect Jefferson and Burr together on the same ticket.

The highly influential Federalist <u>Alexander Hamilton</u>, who mistrusted Jefferson but truly hated Burr more, persuaded the House to vote against Burr, whom he called "The most unfit man for the office of president". This accusation and many others led Burr to challenge Hamilton to a duel in 1804 that resulted in Hamilton's death.

Two weeks before the scheduled inauguration, Jefferson emerged victorious however, and Burr was confirmed as his vice president.

A contingent of sword-bearing soldiers escorted the new president to his inauguration on March 4, 1801, illustrating the contentious nature of the election and the victors' fear of reprisals.

In his inaugural address, Jefferson sought to heal political differences by graciously declaring, "We are all Republicans, we are all Federalists". As president, Jefferson made some concessions to his opponents, including taking Hamilton's advice to strengthen the American Navy.

In 1801, Jefferson sent naval squadrons and Marines to suppress Barbary piracy against American shipping. He

reduced the national debt by one-third, acquired the Louisiana Territory, and his sponsorship of the <u>Lewis and Clark</u> expedition opened the west to exploration and settlement.

Jefferson's first term ended in relative stability and prosperity, and in 1804 he was overwhelmingly elected to a second term. The flawed voting system that was so problematic in the election of 1800, it was later improved by the 12th Amendment, which was ratified in 1804.

New World War 1 Corps

With the increase in approved Memorial applications it has become evident that we have Memorial compatriots who were veterans of World War I. PG Manning has given approval to the Veterans Recognition Committee to add a World War I Corps to the NSSAR Combined Corps. The addition of the WWI Corps will allow us to properly recognize the Memorial compatriot veterans for their service.

A Memorial Compatriot is eligible for placement in the WWI Corps if he was awarded the WWI Victory Medal or if there is other documentation indicating that he served in France during WWI. Otherwise, the compatriot will be placed in the Military Service Corps. The application procedure for the WWI Corps Certificate of Patriotism is the same as the other six Corps.

The current VRC multi-service form will be modified to show the WWI Corps as a selection. Until that form is completed please submit the current VRC multi-service survey form on the VRC website at www.sar.org and note that it is a WWI Memorial veteran. The multi-survey form and additional supporting documents confirming the veterans WWI service should be submitted in the pdf file format to VetCorps@sar.org.

RVP Meetings Summary Comments Thru Feb 16, 2020

See additional attached document which includes greater details:

Lack of SAR Color Guard point opportunities.

Recommendation: Encourage the VPG to designate at least one color guard event, not normally identified as a National Color Guard event, in each of his states as a District Color Guard Event.

FLSSAR chapters have suspended black powder firing because the NSSAR has not provided information on insurance for color guard members.

Recommendation: Encourage the NSSAR to develop a recommendation on dealing black powder firing, including the availability of insurance options for color guard members.

There are concerns by registrars regarding issues which delay the transmission of completed applications to the NSSAR, and the return of accepted applications to chapters for new member inductions.

Recommendation: Ask the FLSSAR state registrar to assemble a small group of registrars from around the FLSSAR. Task the group with the development of report concisely stating concerns and providing a proposed solution to each. The report should be completed in time for the FLSSAR Spring BOM so it may be considered and necessary resolutions/recommendations considered for transmission to appropriate NSSAR officers and staff.

Numerous comments have been received regarding the FLS-SAR website. These include difficulty in its use, navigation problems in searching for items, downtime, its "out of date appearance" and other issues.

Recommendation: Task the FLSSAR Technology Committee to consider the anecdotal concerns and develop a methodology to identify issues, their extent, and propose corrective recommendations as necessary.

2023 Congress – members are expressing interest in the progress of the committee work, as well as steps being taken to ensure a successful event. Their specific concern is an apparent lack of information being disseminated.

Recommendation: The 2023 Committee should develop a periodic digital newsletter to be sent to all FLSSAR members, via email, noting topics of interest and progress of the committee.

Trust funds – the two trust funds, to which BOM members elect trustees, have not provided recent reports regarding their financial status and IRS submissions.

Recommendation: Ask the trustees to provide a brief report on the financial status of each fund, to include its IRS status, at the upcoming May BOM.



Panama City Chapter

Louis William Glayre and his wife, Carol Richard Glayre are the new 2020 members of the FLSSAR Panama City Chapter. In 2018, the Glayre Family moved from rural area near Enterprise, Alabama to 413 Hickory Bluff Circle, Southport, Florida, only to have their home severely damage by Category 5 Hurricane Michael. Louis William Glayre, with native American bloodline and a descendant of an American Revolutionary Patriot, served in World War II as a code breaker. Louis utilizes a wheel chair with a neck-back brace, his spine formerly broken in two places. 



South Atlantic District Report

Herein is the winter 2020 report that was given by FLSSAR President Lee Popham, Sr. at the South Atlantic District meeting that was held in Duluth, GA on January 24, 2020.

During the month of December, some family matters prevented me from performing many of my duties as Florida Society President. I owe many thanks to all of our Florida SAR Compatriots for their continued support – and particularly Senior Vice President David Bussone, and immediate Past President & Trustee Pat Niemann! A job like this simply cannot be accomplished without the volunteer help and support of our membership.

The Florida SAR is experimenting with seven Regional Meetings during the winter 2020 season, replacing the State BOM that is normally held during the first week of February. So far, three of the Regional Meetings have been held, and the combined attendance at those meetings has already exceeded the attendance at the 2019 and 2018 Winter BOMs in Orlando – and at significantly lesser travel time and expenses for the attendees.

An Educational Outreach initiative that started in the Tampa Bay area has now spread throughout the State of Florida, and a new Education Outreach Committee was formed at our Fall 2019 BOM. Members and volunteers are now working hand-in-hand with Florida State Education officials to help re-vamp the education curriculum of our public schools, with a greater emphasis on Civics and American History. Textbooks are also being reviewed for historical content.

Membership: As of 12/31/19, we have 2,503 members by FLSSAR count.

Junior Member James Popham Receives Bravery and SAR Heroism Awards

James Popham, son of Florida SAR President Lee Popham, recently received an award for Bravery from the South Miami Police Chief at the 18 February meeting of the South Miami Commission. He was also recognized with the SAR Heroism award at the 22 February Annual President's Day Luncheon of the Miami Chapter SAR. James is a Junior Member of the Miami Chapter SAR, and the Registrar of the Tequesta Society C.A.R. in Miami-Dade County.



Here is the text of the Award Presentation ceremony at the City of South Miami Commission Meeting:

In early December, 15-year-old James Popham was the victim of a horrific attack that took place inside his home.

After being brutally stabbed 16 times, James convinced his attacker to stop. He then mustered the strength to try to exit the front door, only to be met again by the attacker who actually blocked the door so James could not get help.

With a massive loss of blood James collapsed in front of the door. But he did not give up; instead, he began to instruct the attacker on how to save his life.

Step by step James told the attacker to get towels and apply direct pressure to the gaping wounds. James also continued his plea for the attacker to call 911.

After nearly 20 minutes, James finally convinced the attacker to dial 911. With the phone laid on James' shoulder,

James calmly instructed first responders how to reach him. Moments later. South Miami Police Officer Joshua Hickey arrived and immediately administered lifesaving aid and Officer Pierre arrested the attacker. After days in the ICU and an extended hospital stay, James continues physical therapy today. Extraordinary,

right? But, this is just the beginning of what we learned about James and the remarkable young man he is.

You see, just days after the attack, Chief Landa and [Officer Rodney Napier] visited James at Nicolas Children's Hospital, only to be introduced to an extraordinary young man.

We were hoping to surprise James with a visit from a professional athlete or a music celebrity. But, when we asked James who his favorite celerity

was, he answered Lee Iacocca. Not a celebrity, not a rock star, but a business icon.

That's when we learned we were in the presence of an extraordinary young man. Today, James attends a magnet program for gifted students. James is a member of Boy Scout Troop 941 and part of the prestigious "Order of the Arrow Honor Society". Among many other projects, James antici-

pates completing his Eagle Scout Project this year. Despite the challenges of the attack, James perseveres.

General Omar Bradley best defined bravery when he said: "Bravery is the capacity to perform properly even when scared to death." James, you exemplify what bravery really is. Chief Landa will now present you with the prestigious South Miami Police Bravery Award.
