







The 245th Anniversary of the Revolutionary War Battle of Thomas Creek

The 245th Anniversary on Saturday 26 March 2022, was another wonderful National Color Guard commemorative event honoring those Patriots who fought and died in this battle. The battle was against a large British Force comprised of Regulars, Loyalists and Creek Indians. This was the second of three failed attempts ordered by General George Washington to make N.E. Florida from the Apalachicola River to St. Augustine our 14th Colony. The battle is considered, "The Southernmost Battle of the American Revolution".

Our program began with a welcome from David Ramseur, followed by the Invocation given by Reverend Bob Hale. The presentation of colors was commanded by National Commander Lou Raborg assisted by Vice Commander Brooks Lyles, FLSSAR Commander Steven Fields and Vice Commander Scott Breckenridge. Eagle Scout Ryan Vogel led the," Pledge of Allegiance "followed by Patriotic Chorus Group "Let Freedom Sing". They inspired us with their wonderful singing of, "The Star Spangled Banner" and later in the program "You're a Grand Old Flag". Following the singing, National Color Guard Commander Lou Raborg presented David Ramseur with the National Von Steuben Color Guard Medal and Certificate for Sustained Achievement in the NSSAR Color Guard.

Greetings were brought from the City of Jacksonville by Mr. Harrison Conyers, Supervisor of Military & Veteran Affairs and from the NSSAR, Vice President General Pat. Niemann (Col. Ret.). Greetings were also from the Florida Society SAR, Bernard Wolff President, and from the Georgia Society Dennis Jane. We were honored to have greetings given from the Florida Society DAR, Vice Regent Cindy Addison and from the N.E. Florida Regents Council DAR President Linda Brenner and from the Florida State Society, C.A.R President Sydney Rigaud. We were again inspired with our speaker Dr. Roger Smith, of Colonial Research Inc. of St. Augustine. Wreaths were presented by 37 organizations from the SAR, DAR and C.A.R and other patriotic societies. A black powder salute was given honoring our fallen heroes at this battle followed by Taps by Scout Eric Links. We are looking forward to next year's 246th Anniversary Ceremony on Saturday 25th March 2023.

The 14th Colony (not Vermont) and the Battle of Thomas Creek (The Southernmost Battle Field of the American Revolution)- as coined by the late Congressman Charlie Bennett

(Primary source: Dr. Roger Brown's (The 14th Colony) & (Bill Ramsaur)

When one thinks of the original 13 colonies, we think of the Betsy Ross flag, songs and tributes. Actually Great Britain had 33 colonies, stretching from Nova Scotia to Granada in the southernmost waters of the Caribbean.

With the Treaty of Paris of 1763 and due to British troops in 1762 capturing Havana, Cuba; Spain willing gave all of Florida to the British in exchange for the profitable sugar producing colony. At that time sugar (by products of rum and molasses), was as valuable as we now consider oil.

Great Britain then divided Florida into two colonies East and West Florida. East Florida was the peninsular west to the Apalachicola River with St. Augustine the capital. West Florida was from the panhandle from Apalachicola River including the bottom halves of Ala., Miss, & Lou. West to the Mississippi River with Pensacola the capital. So therefore, Florida was actually two more of the 33 British Colonies.

Twenty years after the Treaty of Paris in 1783 Great Britain again returned Florida to Spain later becoming part of the US in 1821.

With the colonies declaring independence from Great Britain in 1776 the sugar producing islands no longer received goods from the southern colonies such as food, flax, cotton, barrel staves and naval stores. Therefore, they became dependent on goods being received from Florida producers. Great Britain saw St. Augustine as a very valuable city especially with the fortress Castillo de San Marco.

St. Augustine and NE Florida had by 1776 a large number of British Loyalists subjects that had left the Carolina's and Georgia and migrated to NE Florida and especially to St. Augustine. St. Augustine also housed a large number of British troops supplied with large amount of ammunition for attacking the Southern Colonies.

The Southern Colonies were vital to the British for squashing the rebellion against King George and still had a number of loyal subjects that could feed and supply the West Indies with goods.

General Washington saw that by seizing St. Augustine it would greatly contribute to the safety of those southern colonies. General Washington also wrote to the southern colonies of SC, NC and GA to take action an attack NE Florida and capture the military supplies at St. Augustine. He wanted at least five attacks but only three were pursued.

General Charles Lee 2nd in command under Washington's orders gathered an army of 2,500; however, Lee had little enthusiasm for the battle which never occurred due to the thought of moving an army through alligator and mosquito infested swamps in East Florida marshes did not appeal to him. It was said the army could mount five battles northward to one southward into the Florida Swamps during the Revolutionary War.

The first invasion into Florida was in June 1776, where some Georgia Continentals burned several Loyalists Plantation Forts along the St. Mary's River and then proceeded to what is downtown Jacksonville (Cow Ford) fighting British Loyalist Indians. Then due to infighting within the military who would be in command a quarrel resulted in a duel between General McIntosh and President Gwinnett with both being wounded in the duel with Button Gwinnett dying three days later.

The 2nd invasion (Thomas Creek) began May 1, 1777 with Col. Elijah Elbert and about 400 Continentals on seven galleys armed with twenty cannon departed from Sunbury via inland water. However, this was a bad decision due to unfavorable tides causing the galleys to be unnavigable toward the rendezvous point to meet with Lt. Col John Bakers mounted 165 militia who set out on the Kings Road.

Also, at Sunbury on May 1st, Lt. Col. Baker with 165 mounted militia traveled on the Kings Road which was a fine road except they had to watch for Indians, bandits and Loyalist Militia. On May4th they were attacked by Indians after crossing into swamps then arriving at the rendezvous point with Col. Elbert's Continentals at Sawpitt Bluff on the appointed day May 12th. Col Baker learned meanwhile from his scouts that Col Elbert's troops were being delayed and while at Sawpitt Bluff his militia was attacked by Indians who stole 40 horses and wounded two of his men. They retrieved their horses but his men killed one Indian and scalped

him.

Col. Baker moved his remaining 109 militia to a safer location (at Seaton Creek Preserve where we hold our Thomas Creek Ceremony) thinking his militia would be safe there from the British. But on the morning of May 17 there was a surprise attack by 400 British Loyalists, Black creek Indians and British Regulars surrounded them with no escape outlet except through a swamp.

The Patriot forces were decimated with 3 killed, 9 seriously wounded, 31 captured with half of them slaughter by the Indians in revenge for the scalped Indian, before the British Officers could stop them with the remaining escaping on horse-back through the swamps. Col. Baker said some of his militia fought courageously; however, most were cowards due to being vastly out numbered and surrounded.

Col. Baker on horseback narrowly escaped to join Col. Elbert at Amelia Island where he was still delayed in fighting loyalist forces. After conferring with Col. Elbert the invasion was cancelled and all returned back to GA.

The 3rd invasion took place June 30, 1778 led by Col. Elijah Clark is known as the Battle of Alligator Creek Bridge. Col. Clark led his 300 mounted Georgia Militia against British Major Prevost who were defending an area north of the Thomas Creek Battle site. Col. Clark was badly wounded in a skirmish and the assault was withdrawn.

Flagler Chapter

In honor of General George Washington's 290th birthday on February, 22nd, 2022, the Flagler Chapter completed the 8th Annual five-mile Thomas Creek Battlefield Hike. The purported Thomas Creek Battlefield is located within the Seaton Creek Historic Preserve, north of Jackson-ville, south of the Georgia state line, and near Nassau Sound and the Atlantic Ocean. The Battle of Thomas Creek oc-

curred on May 17, 1777 and was a major defeat for the Patriots. The Patriot forces consisted of approximately 170 mounted soldiers from GA, SC, & NC comprising the 1st Regiment Georgia Continental Light Horse commanded



by LTC John Baker and they were ambushed by 300 regular British Army soldiers from St. Augustine, 75 East Florida Ranger irregulars (loyalists) and many warriors from local tribes. The mission of the Continental Army Patriots was to proceed south from GA into Florida and destroy the British Army and British Government headquarters at St. Augustine, as well as, capture the vast quantity of stored war supplies and munitions. The British Army mission was to destroy the invading Patriot force whereas the local warrior tribesmen were seeking revenge, horses, supplies and scalps. Along the trail, the intrepid Flagler Compatriot hikers (Left to Right: David Kelsey, John Feind, President Charles Hayes, and Randall Morris) paused at a probable Patriot encampment area on several acres of high ground surrounded by swamp, dense brush, and giant Swamp Chestnut Oaks. The giant oak (on left) was dedicated to LTC John Baker, Commander of the Patriot forces. Compatriot John Feind, a recent new member, became the 10th Flagler Chapter Compatriot to complete this hike and was loaned the coveted "Hail Columbia" SAR medal for the courage and good works he has displayed and accomplished as a Flagler Chapter member. The medal and ribbon must be passed on to a nonmember lineal descendant.



On Four Chaplains Day during February 2022, the Flagler Chapter SAR presented the Chapter colors as part of the ceremonial salute. The memorial event was attended by approximately 80, with live music and a choir to accompany singing religious and patriotic songs. Many local government officials both county and city, multiple veterans organizations, along with various churches came together to memorialize the Four Chaplains who perished when the SS Dorchester a U.S. Troop Ship, was sunk off Greenland by a German U-Boat on 3 Feb 1943. The Four Chaplains gave up their life-jackets so others could survive and assisted the young troops as best they could as the ship sank. The Flagler Chapter had five Compatriots who participated: President Charlie Hayes, Don Gingles presented the colors, Jeff Schaller, David Kelsey, and David Hammond. Deputy Dawson's action demonstrated his dedication to serve and protect the citizens of Flagler County. The Flagler Chapter was pleased to present Deputy Dawson with the first award of the SAR Life Saving Medal and Certificate in Flagler County. American History Teacher

The Lake-Sumter Chapter is very proud that our winner and the Florida winner, Karen Flores, was second in the national competition for the middle school level. Karen has worked with us for several years. I first met here at a Lake County history fair about 4 years ago where she had several students win awards. Karen and Ron Toops started an essay contest for middle schoolers several years ago. National does not have an essay contest for middle school. Karen teaches at Eustis Middle School. She has been there 17 years and expects to be there many more years. We surely hope she stays.

Habitat for Humanity

This is a very easy program for a chapter. Basically, call up your local Habitat office and let them know you would like to donate flags to the new homes they dedicate. My chapter, Lake-Sumter, has been participating for 3 years. Dedications here are usually on a weekday morning and include folks who help build the house and dignitaries. Ours usually last about 45 minutes. We present a \$20 flag kit from Lowes and a letter with information about our chapter.

So far this year only two other chapters, Jacksonville and Clearwater, have donated flags – and let me know about it. This is a good community outreach.

And keep in mind that the Endowment Trust Fund will reimburse your chapter for 75% of the cost of the flag.

Endowment Trust Fund Disbursement Committee

The Endowment Trust Fund has over \$600,000 and been earning very well. The trustees can dedicate 3 – 5 % of it to distribute to our chapters for outreach programs – like our youth contests. This year that is \$26,435 – 4%. It is very disappointing to report that for this program year – Nov. 1 to Oct. 31 – we have received only 17 requests from 8 chapters for \$4,667. Why leave it unspent? I feel this is really valuable to small chapters that aren't likely to have a lot of funds for these outreach programs. The ETF basically pays 100% of the cost of medals and 75% of the cost of scholarships and awardee meals to non-SAR recipients. What better deal could you get? Each chapter can submit 5 requests for currently up to \$1,750 for the year. The ETF program year ends Oct. 31 with Nov. 15 the deadline to submit your requests. I surely hope there has been unreported activity and you will keep us busy this fall.

Below are the changes we are making for the coming year. Some primary things are raising the submission limit from \$350 to \$500 (totalling \$2,500 for the year) and greatly increasing

scholarship limits.

Endowment Trust Fund Awards Proposal for 2023

B5 application limit raised from \$350 to \$500 (concern is the space on the form for a submission)

C1 addition for the state winners of the Enhanced JROTC, Eagle Scout and Essay contests, as well as entrants in the Rumbaugh competition, chapters will be reimbursed 75% of the expense for travel (\$,50/mile) to Orlando and a hotel room

C2 youth scholarship money from \$50/25/15 to \$500/250/150

History teacher from \$100 to \$500

C3 meals raised from \$40 per award to \$100 – limited to 3 meals, recipient and parents

C4 meals raised from \$40 per award to \$100 – limited to 3 meals, recipient, significant other and superior officer

C5 meals raised from \$20 per award to \$100 – limited to 2 meals, recipient and significant other

C6 Habitat for Humanity flags raised from \$300/yr to \$500/yr

C8 addition and veterans museums

C12 History Fair support raised from \$100 to \$200 Genealogical workshops raised from \$200 to \$400

C13 Engraving of medals raised from \$10 to \$20 per medal

C15 Liberty Tree support raised from \$150 to \$500 per year

C16 Resident veteran reimbursement raised from \$100 to \$500

C17 Boy scout council support raised from \$100 to \$500

C18 JROTC unit support raised from \$100 for all units to \$100 per unit

C19 promotional documents raised from \$50 to \$100

These will be added to the submission form after Dec. 1. New submissions may start Jan. 1.

Rumbaugh Oration Contest

We expect to hold our state competition at the May BOM. The national deadline for submitting state winners is May 15 only 1 week after our live competition at the BOM. The format to remain the same – states submit a video of their winner, national chooses the best 6 who then compete live at Congress. Two years ago our winner, Kelsey Lopp from the Ocala chapter was the national winner – what an honor! The national chairman, Jack Bredenfoerder, has been a great help getting our entries in at the last minute. Now with COVID out of our way I really hope more chapters will participate.

I want to remind everyone that the Endowment Trust Fund reimburses 100% for the winner's medal and 75% of the limits on their scholarship and meals.
