They will be judged at Spring Leadership and the winner announced at Congress.

try is selected as the most representative of patriotism. The money given to NSSAR by Mrs. Bond is to be invested in such a manner as to yield at least \$1,000 annually in earnings, said Effective: February 6, 2022 - 20 - earnings up to \$1,000 to be presented to the winner. If the earnings in any year are less than \$1,000, the award shall be given in increments of \$100 (i.e., \$900). Any excess earnings shall be added to the principal. An SAR certificate, appropriately embossed, shall accompany the award. Incidental administrative expenses, i.e., the cost of the certificate, may be deducted from earnings prior to any excess reverting to principal. Should the name of this award ever be changed by NSSAR, the original \$20,000 donation shall revert to the Bond Memorial Trust as of the date of any such name change. Entries are to be no greater than 8½" x 11" in size, unmatted and unframed, and may be in color or black-and-white. Only one entry per compatriot will be accepted. Entries are to be sent to NSSAR Headquarters for judging during the Spring Leadership Meeting. All photos to be considered must be received by the Executive Director no later than February 15 of each calendar year. Judges shall be the SAR Magazine Editor, Historian General and the Chairman (Chairmen) of the Historic Sites and Celebrations Committee(s). If the latter is unavailable or if that committee is ever absorbed by some other entity, the other two shall select the individual(s) to serve as the third judge with preference being given to the chair of a committee devoted to patriotism. Judges will reach their decision in whatever manner they deem appropriate, so long as only one picture is selected as the winner. Announcement of the winner and presentation of the check and certificate will occur at Recognition Night during the Annual Congress each year. The SAR Magazine Editor is requested to run a reproduction of the winning photo each year in the issue of the SAR Magazine in which Congress events are reported. All entries become the property of the National Society Sons of the American Revolution and will not be returned. The award was first presented in 1998.

USS Stark Memorial Reports

With the beginning of a new year, the Veterans Committee would like to remind all chapters and state societies to submit a report for the <u>USS Stark Memorial Award</u>. If you have not already started working on your USS Stark Memorial report, now would be a good time to start.

The deadline to submit is 1 February, 2024. The purpose of this report is to recognize SAR chapters and societies for their support of and service to the Veteran community. Among the many activities that can be reported are the following:

- Participation in ceremonies for Memorial Day, Veterans Day, Independence Day, Patriots Day,
- Attendance at the funeral of a Veteran,
- Volunteering at a VA hospital,
- Non-monetary donations made to organizations whose primary clients are Veterans,
- Participation in the SAR Wounded Warrior program,
- Visits to Veterans that are home bound or in the hospital, and
- Placing flags or wreaths on the graves of Veterans.

Awards will recognize the most active chapters and most active state societies. An award certificate will go to the most active chapters based on membership size: 10 to 49, 50 to 99, 100 to 199, and 200 or more, using a weighted equation on a per member basis. Award certificates for state societies will be based on membership size: 10 to 199, 200 to 499, 500 to 999, and 1,000 or more members, using a weighted equation on a per member basis. Therefore, all chapters and state societies have a competitive opportunity regardless of the size of their membership.

The USS Stark Memorial reports are about more than just an award. When societies and chapters submit the report, they are providing information on their service to Veterans activities. The Veterans Committee uses this information to determine where the strengths and gaps are in the SAR's Veterans programs so we can better serve the Veteran community in the future.

The report form is available on the National SAR website. After logging in, click on <MEMBERS> then <FORMS AND MANUALS>. Please ensure the report you submit is Form: USSStark-2022-A. This form must be the one submitted. The USS Stark Activities Tracker is also available on the NSSAR website. This Excel spreadsheet is a useful tool to help track and tally qualifying activities throughout the year. Usage of the USS Stark Tracker will greatly simplify the reporting process.

It is recommended that chapters submit their USS Stark Memorial Award reports to their respective State Society Veterans Committee Chairman by January 15. The State-Society Chairman will then consolidate all chapter reports to compile a society report, using the same scoring sheet, and submit a report to the SAR Veterans Committee Chairman or NSSAR Headquarters.

In addition to the USS Stark Memorial Award,

the <u>State Veterans Service Award Certificate</u> will be also be presented at the National Congress in Orlando to any state society that meets the following criteria:

- 1) Submit a USS Stark Memorial score sheet for the state society, and
- 2) Submit USS Stark Memorial Award score sheets meeting the applicable criteria in the following:
- a. For societies with no chapters, submit the society score sheet only, with a minimum of 50 points on the state society score sheet submitted, or
- b. For societies with one or more chapters, at least 50 percent of its chapters must submit a USS Stark Memorial Award score sheet, with a minimum of 50 points on each score sheet submitted.

For the State Veterans Service Award only those score sheets for the state society and its chapters sent by the reporting deadline (Feb. 1) will be considered. No extra paperwork or reporting is required. Any society meeting the criteria will automatically have its name sent to the President General, who will award a certificate.

If you have any questions related to the USS Stark Memorial Award Report or the State Veterans Service Award, please let me know at your earliest convenience. There is a training video with the associated Power-Point presentation available on the Veterans Committee webpage to assist you in filling out the USS Stark Memorial Report The video and presentation file can be accessed at https://www.sar.org/committees/veterans-committee/. The links to the files are at the bottom of the webpage.

Chapter Challenge Contest

The Florida Society Chapter Challenge Contest is designed to recognize chapters for various activities that meet the goals of the SAR. Chapters are judged against each other based on size (small-red, medium-white, large-

blue). The top three winners in each category are recognized at the FLSSAR Annual Meeting. The contest period is the calendar year, January 1st to December 31st.

Scoring for the contest is done using the NSSAR Americanism Award / President General's Activity Streamer Combined Score Sheet, available on the NSSAR website (https://www.sar.org/committees/americanism-committee/). Chapters are encouraged to fill out the Scoresheet and submit it to the National competition. In addition, it should be sent to the State Secretary for inclusion in the FLSSAR submission and for the Chapter Challenge Contest. It is important to note that I need your submissions no later than February 1st, so that I can meet my deadline to National.

Endowment Trust Fund Distribution Update for Fourth Quarter 2023

The Endowment Trust Fund program year – November 1 to October 31 – certainly ended in a rush. We received 46 of our 58 requests in October! The 53 requests came from 22 chapters. Surely wish it was every chapter. The requests listed \$25.688.58 for their activities of which the ETF reimbursed \$18,901.70. Our highest reimbursement to date. \$3,000+ was still "left on the table". At the beginning of each year the trust fund trustees make 3-5% of the \$600.000+ trust fund available for reimbursing chapters for their outreach activities. Basically that's 100% for medals and 75% for everything else. For example, you run the essay contest and present the essay medal to the winner at your chapter meeting, a \$400 scholarship and treat the student and parents to a meal (we'll say \$20 each) at the presentation. You would get \$45 for the medal, \$300 for the scholarship and \$45 for the meals. You spent \$505 and the ETF would reimburse you \$390. So your "cost" for this great outreach program for your chapter was actually only \$115 – what a bargain. And hopefully you have inspired a better citizen and possible future SAR member. That's a deal! No matter what size your chapter is, you can participate. It certainly is not difficult and we are always available to help. But please, don't wait until the last minute! We will start receiving requests after January 1.

News from the FSCAR Chairman

My name is Arran Corbett. I am 15 years old and a sophomore at Leon HS. I am currently serving as the Florida Society Children of the American Revolution chairman of C.A.R./SAR/S.R. Relations. I am so glad to have joined the Tallahassee Chapter SAR as a junior member. I am the fourth generation in my family to belong to the SAR!

As state chairman, I want to share with you information on The Next Step Initiative. It involves working with C.A.R. parent organizations to transition our members to DAR, SAR and S.R. At SAR National Congress they said that they really want a relationship with the C.A.R. and are eager to help with transitioning boys into the SAR. The President General and other leaders told the SAR members to support the C.A.R. President General. They praised our Next Step Initiative and recommended that SAR members across the country get a copy of it. The SAR waives the application fee for C.A.R. members in good standing. Most chapters pay the dues for junior members. Otherwise, it's only \$5 annually until age 18. Junior members can log in to the national SAR website with their member number and get items including insignia. When attending SAR events representing the SAR, dual members can wear it.

Chaplain General Elam had been admitted to the hospital and appeared to be improving, however on Tuesday, December 19, 2023, he died in the hospital. I spoke with Dwight's wife today and thus far no cause of death is known for certain.

The Florida Society SAR hereby reports with deep regrets the passing of Dwight D. Elam who served as our Florida Society

Chaplain for many years and with his chapter, the Caloosa Chapter in Fort Myers, FL. Below is what was stated in his obituary. Dwight Donald Elam, 72, of Lexington, KY, and Fort Myers, FL, passed away on December 19, 2023. He was born September 12, 1951, to James and JoAnn (Stokley) Elam in Lexington, KY.

While Dwight and Becky have called Fort Myers their home for over twenty years, their journey with the Lord has taken them on many adventures.

Dwight was proud of being a Timothy of Broadway Christian Church, where he had many great Biblical mentors. Dwight and Becky met

through a Christian Church rally and went to Bryan Station High School, graduating in 1969. They married on June 12, 1970, and Dwight graduated from Milligan College (TN) in 1973 with degrees in Education and



Ministry. While at Milligan, they welcomed their first child, Christina Kelly.


Dwight is preceded in passing by many friends and family, including parents JoAnn and James Elam, his son-in-law, and co-worker Ed Cerwinsky.

Frederick Pfeiffer (1925 – 2013)

Upon reviewing the records of a past Central Florida SAR Chapter member that has moved out of the Orlando area awhile back, we came across records that showed he had passed away & hereby announce the passing of Fritz Pfeiffer.



The Hon. Frederick Thompson Pfeiffer, (Fritz Pfeiffer) entered the life eter-

nal on April 30th 2013. He was a man of faith who loved his Lord, his family, the law, and being a judge. He was born on July 26th 1925 in Cleveland Ohio, and later moved to Arlington, Virginia where he graduated from Washington-Lee High School in June, 1943. He was selected for the V-12 Navy program at the University of North Carolina at Chapel Hill where he joined the Phi Delta Theta Fraternity. In 1945 he was commissioned an Ensign and sent to serve in Saipan. After being released to the inactive Naval Reserve in 1946, he returned to the University of North Carolina where, as a Phi Delt, he met his future wife, Betty (Elizabeth Huntington Phillips) who lived next door in the Tri Delt House at UNC. After receiving a degree in history in 1947, he entered the George Washington University School of Law and married Betty in 1948. Upon graduation from law school in 1950, he passed the Washington, DC Bar Exam.

He and Betty moved immediately to Betty's hometown of Orlando, Florida where he first worked for his father-in-law's company building houses and later as a claims adjuster for State Farm Insurance Company. Always intending to get back to his love of the law, at age 45, he studied for and passed the Florida Bar in about 1970. In 1972, he was elected to the Orange County Circuit Court serving later as Chief Judge of the Circuit, and ultimately as a retired Senior Judge until January 2009. Fritz's faith was central in his life. He was actively involved at his church, Emmanuel Episcopal Church, Orlando, where he served 4 times on the Vestry, and as Junior Warden, and treasurer. He was also a lay reader, and Lay Eucharistic Minister, taking communion to the homebound. He was appointed treasurer for the Diocese of Central Florida from 1970-1982 and served on its Executive Committee, the Standing Committee and as chairman of the Finance Committee. Fritz was involved in the Central Florida Community where he was a member of Kiwanis and coached little league baseball for 11 years. He was a board member of the Central Florida History Center, The Friends of the Library, and the

Holocaust Resource Center. In 2002, he was voted Judge of the Year by the Central Florida Chapter of the American Board of Trial Advocates and, in 2005, he was honored by having the Central Jury Room in the Orange County Courthouse named for him. In 2010, he moved to Pine Knoll Retirement Center in Southern Pines, NC with his wife Betty, who died in 2011.


Compatriot Scott, with his love for Myra always in his heart, has moved to be closer to family. We wish him the best for continuing to live a great life.

From the By-Laws Committee

The following proposed by-laws changes are currently under consideration. Recommended changes are underlined.

1. Appointment to State Positions of At-Large Members

Article III Officers, Section 3 Additional Offices

Current Wording: "The FLSSAR at any Annual Meeting, or at the BOM at any regular of (sic) special meeting, may create additional offices as in their judgment may be required, and may designate the person or persons to occupy the same until the next Annual Meeting of the FLSSAR."

Recommended Wording: "The FLSSAR at any Annual Meeting, or at the BOM at any regular <u>or</u> special meeting, may create additional offices as in their judgment may be required, and may designate the person or persons to occupy the same until the next Annual Meeting of the FLSSAR. <u>No person who is a member-at-large only (i.e. not a member of a FLSSAR chapter) shall be appointed to any FLSSAR office or committee."</u>

Summary of changes: Correct a typographical error--"of" to "or", and include a statement to clarify that a member who could otherwise be a member of a state chapter but does not elect to do so, shall not be appointed to a state-level office or committee.

2. Annual Elections

Article III Officers, Section 2 Nomination and Election of Officers, C. Election

Current Wording: "Elections will be held at the Annual Meeting. Election for an office for which only one person has been nominated shall be by voice vote upon a motion to elect by acclamation.

Recommended Wording: "Elections will be held at the Annual Meeting by those physically in attendance. Election for an office for which only one person has been nominated shall be by voice vote upon a motion to elect by acclamation."

Summary of change: Clarify that voting for elected offices shall be allowed only by those members physically in attendance at the Annual Meeting.

3. Qualifications of Nominees

Article III Officers, Section 2 Nomination and Election of Officers, B. Qualifications of Nominees:

Current Wording, Article III, Section 2, paragraph B: "The Nominating Committee, or FLSSAR member who makes a nomination for an elective office of the FLSSAR, shall have ascertained before making a nomination that the person to be nominated is a member in god standing and has stated in writing that he is willing to serve in that office. Furthermore, each nominee, for the office of President and Senior Vice President, shall indicate their willingness and advise the Nominating Committee of any hindrance that might prevent them from attending all BOM meetings during the term of their elected office and to physically reside in the State of Florida for no less than six months during each year the office is held. In order to be eligible for the office of President or Senior Vice President, the compatriot must have completed at least one term or year in an elective office of the FLSSAR or as Florida's National Trustee prior to assuming the office of President or Senior Vice President."

Suggested Wording:

"B. Qualifications of Nominees

(1) The Nominating Committee, or FLSSAR member who makes a nomination for an elective office of the FLSSAR, shall have ascertained before making a nomination that the person to be nominated is a member in good standing and has stated in writing that he is willing to serve in that office. Furthermore, each nominee, for the office of President and Senior Vice President, shall indicate their willingness and advise the Nominating Committee of any hindrance that might prevent them from attending all BOM meetings during the term of their elected office and to physically reside in the State of Florida for no less than six months during each year the office is held. In order to be eligible for the office of President or Senior Vice President, the compatriot must have completed at least one term or year in an elective office of the FLSSAR or as Florida's National Trustee prior to assuming the office of President or Senior Vice President.

(2) Nominations not part of the committee slate must be made in person from the floor at the appropriate point in the meeting. The proposed candidate need not be present. If a proposed candidate is not in attendance, the nominator must present a signed statement from the nominee acknowledging that he agrees to serve if elected.

(3) The nominating committee shall put forward no more than one name per elected office.

Summary of changes: Adds numbered paragraphs to the section. Clarifies that nominations for officers in lieu of slated positions shall only be made from the floor, that the nominated person does not have to be present, and that the nominating member has the responsibility to provide a signed document from the nominated person that he agrees to serve if elected. Adds a requirement that the nominating committee shall nominate only a single name for each elected office; no multiple nominations are allowed.

4. Schedule of BOM and Annual Meetings

Article III Officers, Section 6 Holding Multiple Offices

Current Wording: "Any member except the President may be elected to, and concurrently hold, more than one, but not more than two, of the offices listed in Section 1 of this ARTICLE."

Suggested Wording: "Any member except the President may be elected to, and concurrently hold, more than one, but not more than two, of the offices listed in Section 1 of this ARTICLE. The currently elected President will not hold or chair any FLSSAR committee other than the Executive Committee."

Summary of change: Clarifies that the newly elected President cannot be part of any FLSSAR committee other than the Executive Committee, as prescribed by the By-Laws.

5. Number of Members Needed for New Chapter

Article VII Chapters, 3. FORMATION

Current Wording to Article VII, paragraph 3. FORMATION: A minimum of ten members resident in the territory encompassed thereby shall be necessary for the formation and issuance of a charter to a local Chapter. An application for the formation of a new Chapter shall be submitted to the BOM; if the application is approved the BOM shall direct the preparation of a charter and shall arrange for it to be presented with a proper ceremony.

Recommended Wording: "A minimum of 15 members resident in the territory encompassed thereby shall be necessary for the formation and issuance of a charter to a local Chapter, with at least 10 being primary members of the new chapter and located in the area where the new chapter intends to hold meetings. An application for the formation of a new Chapter shall be submitted to the New Chapter Development Committee for additional coordination before being forwarded to the BOM; if the application is approved the BOM shall direct the preparation of a charter and shall arrange for it to be presented with a proper ceremony.

Discussion: At May 2022 BOM, the topic of number of members required for a new chapter was raised. A vote was taken to change the By-Laws to state that the number of members must be a minimum of 15.

This change was worked in cooperation with New Chapter Development Committee. The members of this committee proposed additional criteria before a new chapter can be included into the FLSSAR. Recommend these additional criteria be added to their New Chapter Development Committee Charter.

6. Correct a Typographical Error

Articles VIII Miscellaneous

Current wording: ARTICLES VIII

Recommended change: Delete "s" from Articles, to ARTICLE VIII.

7. Notification to BOM for Amendments

ARTICLE VIII Miscellaneous, Section 3 Amendments, (2)

Current Wording: "(2) The text of any proposed amendment(s) must be provided to the members of the Board of Management (BOM) at least thirty (30) days prior to the Annual or

Special Meeting. The proposed amendment(s) will then be voted on by ballot at the Annual Meeting."

Recommended Change: (2) The text of any proposed amendment(s) must be provided to the members of the Board of Management (BOM) at least thirty (30) days prior to the Annual or Special Meeting. This notification may be accomplished by direct mail, email, publication in the FLSSAR Newsletter, or any combination of these methods of communication to meet the thirty day requirement to ensure all members are notified in ample time. The proposed amendment(s) will then be voted on by ballot at the Annual Meeting."

Caloosa Chapter



Nathaniel J. Othon (in uniform, above) is a member of Boy Scout Troop 351 in Punta Gorda, and is also one of our Compatriots, having joined the Caloosa Chapter of the FLSSAR in June of 2018 as a Junior Member. He has previously achieved the rank of Life Scout, has already earned all the Merit Badges required to obtain the rank of Eagle Scout, and has been working on his "Eagle Project" (the final requisite for the prestigious rank) for about two years. Not being one to avoid difficult tasks, Nathaniel had approached Military Heritage Museum Executive Director Gary Butler to inquire if there were any projects that could benefit the Museum. According to Butler, from a variety of alternatives, Othon picked the most difficult -- placement of a section of the actual iconic Berlin Wall consisting of three 500-pound slabs and associated landscaping and signage for permanent display at the museum campus.

On November 9, 2023, thirty-four years to the day after the Wall ceased to be used to prevent border crossings and began to be demolished, Compatriot Othon presented his finished project to the Museum. Nathaniel explained that unlike the vertical sections of the Wall often seen with much graffiti, his concrete sections now standing outside the Museum showcase panels taken from the East German side, placed horizontally. These stark reminders of the efforts made to prevent residents of East Berlin from escaping to the West are graffiti free due to the fact that they were heavily guarded by East German and Russian soldiers.

It took two years for Nathaniel to see to the move of the heavy concrete slabs from St. Petersburg, where a collector had stored them, to obtain all required permits and build the pad where the exhibit would be located, as well as construct the frame that would hold the panels in place and install the associated exterior landscaping. All in all, approximately \$30,000 in donations of goods and services were used to complete the Project. These donations included the use of a crane and other construction equipment from Florida Premier Contractors, Nova Industrial Arts, Suffolk Construction and Keesling Construction. Support also came from

Sunseeker Resort.

Compatriot Othon explained that the reason he selected this Project was his grandfather, John Carey, who was serving in the US Army in Germany at the time the Wall went up after WWII. Said Nathaniel: "It's important for all generations to remember the Berlin Wall. The Wall coming down sent the Soviets, our large rivals, a message that the people of East Germany didn't need to be oppressed or starved anymore. So, the Wall falling was the end of that suffering. For a lot of people, it is symbolic of that period of history that ended the Cold War." For more information on the Museum, and Nathaniel's Project, see: https://militaryheritagemuseum.org.

coastal area of Lee County. Organizing President was Sidney Scott King, Jr., who had become an SAR member in 1952. A Charter Night Banquet was held on February 22, 1973, and the rest, as they say, is history.

Fifty years later, on Saturday evening, November 4, 2023, Caloosa Chapter President Thompson gaveled the 50th Anniversary Gala banquet to order, and Chaplain Dwight D. Elam gave the invocation. In short order, the Light Horse Harry Lee Camp #15 Color Guard, Mike Buff commanding, posted the Colors, Secretary Rick Parfitt led us in the Pledge of Allegiance, Bill Osborn presented the American's Creed, and Dr. Ron Pecck led us all in the SAR Pledge.

A reverential silence was maintained as Mike Buff and President Thompson took turns remembering our Prisoners of War and Missing in Action, and each item on the "Missing Man Table" was explained. Following formal introductions and greetings, Betsea Kinne and Tony Parker of Hearts and Homes for Veterans, Inc. were recognized and spoke of their continuing mission to assist homeless veterans. Their success stories were moving, and they received sustained applause for the success they have had in helping our veterans get off the street, and into a career which can support them and their families. Both Betsea and Tony expressed their sincere gratitude for our Chapter's recognition and appreciation of the services that are provided by Hearts and Homes, and the monetary assistance being provided them with the gift of proceeds from the silent auction and raffle. 'Nary a dry eye in the room after that!

Things did not stop moving by any means, and next came a variety of awards, including the newly created DAR Bronze Hannah White Arnett Medal, which was presented to eleven SAR Recipients.

Everyone stood during the formal proposal of toasts to the Commander in Chief, and then Chiefs of the various Service Branches, which were all made with wine, save for the toast "To our Fallen Comrades" who were toasted with water only. The meal itself was as good as the program, and after dinner we were all treated to a vignette presented by Cara and Bill Elder, in their first-person interpretation of what it was like during the Winter Encampments of 1775-1778 for Martha and George Washington.

The silent auction was much fun for all, and especially exciting for those who had made the "winning" bids. They were the ones with the broad smiles on their faces as they retrieved the items they had successfully bid on.

The only sad time of the night was when the Motion to Adjourn was made and passed, benediction was offered by Chaplain Elam, and the SAR Recessional was led by Dr Ron Peck. It was then we knew we had to leave the building and say good night to our friends and compatriots.

The DAR/SAR/S.R. Committee was formed to promote the relationship between the National Society Sons of the American Revolution (NSSAR), the General Society Sons of the American Revolution (S.R.) and the DAR. Specifically, the goal is to (i) promote a congenial and harmonious working relationship for the betterment of our shared objectives, and (ii) render support and assistance in the area of community-centered events and mutual membership growth, and (iii) foster shared goals of historic preservation, education, and patriotism. In this regard, the Hannah White Arnett Medal was created,

These individuals were selected for the award for all the activities they have participated in with many chapters in the Regents' Council.


Jacksonville National Cemetery that connects with to the Lem Turner Road (US#1).

AMERICAN REVOLUTIONARY WAR BATTLE OF Alligator Creek Bridge

The 3rd Florida invasion took place on June 30th, 1778, led by Col. Elijah Clark. It is known as the Battle of Alligator Creek Bridge. Col. Clark led his mounted Georgia Militia against British Major Prevost's forces who were defending Alligator Creek Bridge.

As with the prior two expeditions, there was a serious leadership disagreement between the two leaders: Governor Houstoun and General William Howe. Even though there were 2,600 Continental and militia forces under the two leaders, they did not agree on how to proceed with the invasion into Florida.

General Howe (with one half of the forces) opted to stay and occupy Fort Tonyn located about 14 miles north of the Alligator Creek Battle site on the St. Mary's River, even though it had been burned by British Loyalists.

Governor Houstoun opted to attack the 500 British Regulars, 200 South Carolina Royalists and Seminoles at Alligator Creek Bridge. As Houstoun's forces under General Screven chased the Loyalist forces back to the bridge, the British Regulars thought Screven's forces were also Loyalist forces retreating from the burned Fort Tonyn.

Col. Elijah Clarke led his mounted militia against the British bridge entrenchments during the skirmish and Clarke was wounded. General Screven's main reserve force, seeing that Clarke was injured and being barely able to escape capture, ordered a retreat. This was the third failed expedition. It was primarily due to a lack of coordination that had also doomed the two previous assaults on the Florida-Georgia borderlands.

The third invasion into Florida swamp land was a disaster. Although American battle casualties were only 13, over 500 Patriots died of disease before they could be withdrawn from East Florida.

FROM INTERSTATE 4 WEST - (from Tampa): From I-4, take exit #67 (SR 536/Epcot). At the bottom of the ramp, turn right and

continue on SR536 approximately 2 miles to SR535. Turn right at this traffic light and go almost 2 miles and turn right onto Kyngs Heath Rd at traffic light. The hotel is on the corner of SR535 & Kyngs Heath Rd.
