

#### THE BATTLE OF BLUE LICKS

(From a speech given at the Commemoration of the Battle of Blue Licks, August 15, 2009)

It is great to be in my home state, The Commonwealth of Kentucky. First allow me, as Historian General, to bring you greetings from President General Ed Butler of the National Society, Sons of the American Revolution who could not be with us today.

When I was a youngster growing up in Berea, KY I recall that we had many towns and streets that ended in Lick or Licks – Red Lick, Paint Lick, Salt Lick, and of course Blue Licks. Before I began my remarks relating to the Battle of Blue Licks I would like to take this opportunity to congratulate Compatriot Neal Hammon of the Kentucky Society for his significant contribution to the history of the American Revolution era as recorded in his recently published book, entitled Daniel Boone and the Defeat at Blue Licks. For his writings and research in publishing the book Compatriot Hammon was awarded the prestigious Minnesota Society Stephen Taylor Award at the 2009 National Congress of the Sons of the American Revolution which was held last month in Atlanta, Georgia.

Many historians consider the Battle of Blue Licks as one of the last land battles of the American Revolutionary War. The Battle of Blue Licks occurred ten months after Cornwallis's surrender at Yorktown, which had effectively ended the war in the east. But, on a hill next to the Licking River in what is now Robertson County, a force of about 50 British rangers and 300 American Indians ambushed 182 Kentucky militiamen. It was the worst defeat for the Kentuckians during the American Revolutionary War.

The Commanders that served in this battle with the Kentucky militia were, John Todd, Stephen Trigg, Daniel Boone and Robert Patterson. On the British side the Commanders were: William Caldwell, Alexander Mckee and Simon Girty.

The Kentuckians casualties and losses were: 72 killed, 11 captured and on the British side 7 were killed and 10 wounded.

As we remember those brave men who fought and died for our country during the Battle of Blue Licks, let us never forget that we currently have many brave men and womem fighting for this great country we call the United States of American in many parts of the world, particuliary in Afghanistan and Iraq.

Now back to Battle the Battle of Blue Licks.

The Kentuckians reached the Licking River on the morning of August 19, near a spring and salt lick known as the Lower Blue Licks. On the other side of the river, a few Indian scouts could be seen. Behind the Indians was a hill around which the river made a loop. Colonel Todd called a council and asked Daniel Boone, the most experienced woodsman, for his opinion. Boone, who had been growing increasingly suspicious about the overly obvious trail the Indians had been leaving, advised his fellow officers that the Indians were trying to draw them into an ambush.

Major McGary ignored the remarks of Boone. He was eager to prove that he was not a coward as Boone's earlier remarks had suggested, urged an immediate attack. He mounted his horse and rode across the ford in the river, shouting, "Them that ain't cowards, follow me." Men began to follow, as did the officers, who hoped to at least make an orderly attack. "We are all slaughtered men," said Boone as he crossed the river.

On the other side of the river, most of the men dismounted and formed into a battle line of three or four divisions. They advanced up the hill, Todd and McGary in the center, Trigg on the right, Boone on the left. As Boone had suspected, Caldwell's force was waiting on the other side of the hill, concealed in ravines. As the Kentuckians reached the summit, the Indians opened fire with devastating effect. After only five minutes, the center and right of the Kentucky line gave way; only Boone's men on the left managed to push forward. Todd and Trigg, easy targets on horseback, were quickly shot down.

The Kentuckians began to flee wildly back down the hill, fighting hand-to-hand with the Indians who had flanked them. McGary rode up to Boone's company and told him that everyone was retreating and that Boone was now surrounded. Boone gathered his men for a withdrawal. He grabbed a riderless horse and ordered his son, Israel Boone, to mount and make an escape. Israel refused to leave his father, however, and was shot through the neck as Daniel searched for another horse. Boone saw that his son's wound was mortal, mounted the horse, and fled. According to legend, Boone hid his son's body before leaving, but in reality there was no time.

#### Aftermath

Although he had not taken part in the battle, George Rogers Clark, as senior militia officer, was widely condemned in Kentucky for the Blue Licks disaster. In response to the criticism, Clark launched a retaliatory raid into the Ohio Country. In November 1782, he led more than 1,000 men, including Benjamin Logan and Daniel Boone, on an expedition that destroyed five Shawnee villages on the Great Miami River, the last major offensive of the war. No battles were fought in that engagement because the Shawnees declined to engage the Kentuckians, instead pulling back to their villages on the Mad River.

Those villages were subsequently destroyed by Benjamin Logan in 1786 at the outset of the Northwest Indian War. On that expedition, Hugh McGary confronted the Shawnee chief Moluntha, asking him if he had been at Blue Licks. Chief Moluntha had not taken part in the Battle of Blue Licks—relatively few Shawnees had—but he evidently misunderstood McGary's question and nodded his head in agreement. McGary then killed the Shawnee leader with a tomahawk. Logan relieved McGary of command and later had him court-martialed. Remember to only nod your head when you are certain of the question being asked.

Thank you for providing me the opportunity to talk about The Battle of Blue Licks. You have been a very attentive audience. Now, let's enjoy the rest of today's activities.


# "OFFICIAL HANDBOOK OF THE NATIONAL SOCIETY OF THE SONS OF THE AMERICAN REVOLUTION"

# THE CENTER FOR ADVANCING AMERICA'S HERITAGE ADVANCE: CAMPAIGN FOR NEW GENERATIONS FACT SHEET

The Sons of the American Revolution is an historical, educational and patriotic organization formed in 1889 to preserve the stories of our patriot ancestors' struggle against tyranny and the principles upon which our country was founded. The SAR has over 28,000 members today, all of whom trace their ancestry to the Revolutionary War era. The SAR's national headquarters are in Louisville, KY.

The SAR seeks to help fill the ever-increasing gap in history and civics education within our school systems through its newly formed *The Center for Advancing America's Heritage*. Since the 1960's the American education system

has consistently reduced the amount of time spent on social studies and history in the classroom. This trend affects our ability to teach our children the stories of our past to better understand the issues of today. The Center will provide educational programs to school children from local and surrounding school systems through permanent and traveling exhibits and in outreach education programs distributed to SAR Chapters across the country.

The Center will provide expanded space for permanent and traveling exhibits, speakers, workshops, summer camps and school programs, plus improved conditions for its internationally acclaimed genealogical library as well as more efficient space for administrative and programming offices.

To further its goal of expanded services, The SAR has purchased an historic 1840's era building on Louisville's West Main Street, a Cultural District known for its second largest collection of iron-front façade buildings in the country (second only to SoHo in New York). Plans to renovate and furnish the 40,000 square foot historic site include an open gallery atrium and inviting reception area. The SAR National Headquarters will be located on the second floor. The Genealogical Library will be a significant part of the west wing and a rooftop garden will overlook the majestic Ohio River.

Along with the general public and school groups, key users are expected to be scholars, historians, authors, teachers, students, families and individuals who are interested in researching and learning more about our country's beginnings and the principles upon which it was founded.

To fund The Center's renovation, SAR members, private foundations, corporations, businesses, local, state and federal grants, community leadership and the publicat-large will all be invited to participate in ADVANCE: Campaign for New Generations.

To help fund The Center's operations while making The Center as accessible and affordable for the public as possible, a market based general admission fee will be considered. Additional fees for traveling exhibits and special programming may be assessed. The genealogical library is free to SAR members and some affinity organizations with a nominal research fee for others. In addition, income will be derived from The Center's full range of activities including a café, gift shop, rental fees and fees for special programs. An endowment fund will be established and ongoing fundraising will be conducted.

Based upon traffic generated along Louisville's historic West Main Street and the activity generated at other attractions located along that corridor, it is projected that The Center could attract as many as 100,000 visitors in its first full year.

There are no other cultural attractions like The Center for Advancing America's Heritage near Louisville, KY. The location for The Center is easily accessible by three major interstates, 71, 65 and 64, and sits within a day's drive of more than half the population of the United States. This new Center will add another jewel to Louisville's tourism crown and strengthen the economic development of the downtown cultural district.

The Center's construction schedule is dependent on available and pledged funds. The projected schedule has the building ready for occupation as early as the first of 2011. The hours of operation are still to be determined, but will certainly be compatible with other activity and traffic along the West Main Street corridor


