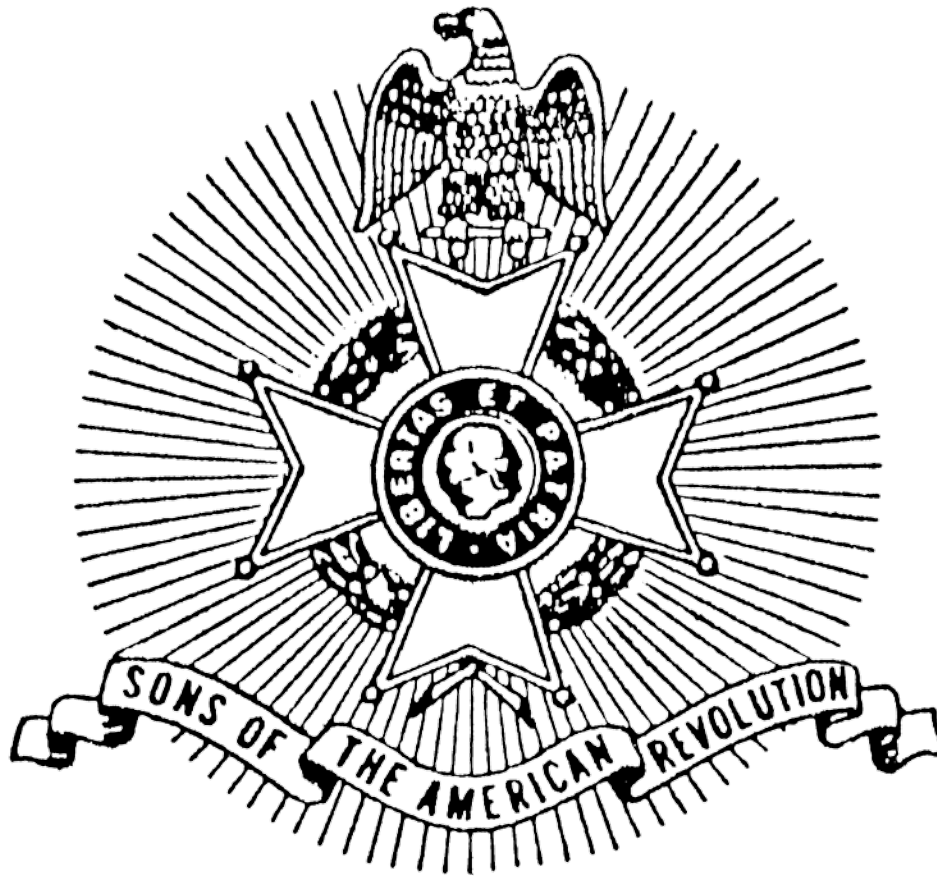

The objects of this Society are declared to be patriotic, historical and educational; to unite and promote fellowship among the descendants of those who sacrificed to achieve the independence of the American people, to inspire them and the community-at-large with a more profound reverence for the principles of the government founded by our forefathers; to foster true patriotism; to maintain and extend the institutions of American freedom.

Introduction

The document includes the charters for all active FLSSAR committees as of May 2021. A charter, as outlined in the Society By-Laws "...states the name, duties, structure, powers, method of appointment, and term of office of its members". Committees fall into one of three categories: Statutory, Standing, and Special.

Statutory committees are permanent, prescribed and delineated in the By-Laws, and provide the fundamental functions of executive decision, finances and audit, the nomination of officers, and presentation of medals and awards, including the Patriot Medal.

Standing committees are the most numerous and provide for all outreach to youth, our patriotic and nationalism awards programs, liaison with other Societies, and internal functions. They are of proven worth and may be changed or eliminated only by the Board of Management which may also create new Standing Committees.

Special, or *ad hoc*, committees may be created by Presidential fiat or by the Board of Management. Some Special Committees may be short lived, existing only to complete a specific and well defined objective. These may have a charter or other written description. Others may be ongoing with charters and if proven successful, may be empowered by the Board of Management and transformed into Standing Committees.

Statutory Committees

Explanation

As established by the By-Laws, there are six statutory committees.

- Executive
- Finance
- Financial Review
- Medals and Awards
- Nominating
- Patriot Medal

A Statutory Committee has the following Characteristics:

1. Statutory Committees are established by, and their charters set forth in, the By-Laws.
2. Statutory Committees perform functions and have powers as stated in the By-Laws.
3. Statutory Committees remains in existence permanently, from year to year.
4. Members of Statutory Committees are appointed by the officer identified in their By-Law and are concurrent with that of the appointing officer unless otherwise stated in the ByLaws.

Changes to Statutory Committees are made by amending the By-Laws.

By-Laws may be amended by following the process as outlined in the Amendments Section of the current version of the By-Laws of the Florida Society.

Purpose:

To act on any matter between regular meetings of the Board of Management the Chairman deems of such importance and urgency that action must be taken before the next regular Board of Management meeting. To act on matters provided in the By-Laws. To offer advice to the President and National Trustee regarding issues the Committee feels FLSSAR should support at the Trustee's Meeting

Authority:

Florida Society By-Laws, Article V, Section 1

Members:

Chairman: FLSSAR President
Vice Chairman: FLSSAR Senior Vice President
Immediate past: FLSSAR President
Secretary: FLSSAR Secretary
Fiscal Advisor: FLSSAR Treasurer
Member-at-Large Compatriot

Functions:

Three members shall constitute a quorum. The Executive committee shall have the power to conduct its business by mail, e-mail or by electronic means or telephone in lieu of convening in formal session; provided, however, that each member of the Committee shall confirm by email or hardcopy letter to the Secretary, each vote he has given by telephone. A report shall be made by the Chairman and/or Secretary at each meeting of the BOM detailing all actions taken by the Executive Committee since its last report to the BOM. During intervals between meetings of the BOM, the members of the Committee shall have the duty to meet on call of the Chairman and to act for the Board of Management ad interim on any matter that the Chairman deems to be of such urgency and importance that the action must be taken before the next regularly-scheduled meeting of the BOM. The committee shall also serve as a council to advise the President on planning and operational matters about which he deems the counsel of the Committee to be needed or helpful. The Committee shall also serve as a council to advise the President and the National Trustee on national NSSAR issues that FLSSAR members have interest in to present to the National Trustee Meetings.

Purpose:	To exercise management over all FLSSAR finances except the Endowment Trust Fund and Operating Budget Trust Fund.
Authority:	Florida Society By-Laws, Article V, Section 5.
Members:	A Chairman who shall be the Treasurer of the Florida Society and two other members, who shall be appointed by the President, Florida Society for terms concurrent with that of the appointing officer.
Functions:	To exercise management supervision over all FLSSAR finances except those of the Endowment Trust Fund and those of the Operating Budget Trust Fund.

Financial Review

Status

Statutory

Purpose:

To conduct, or cause to be conducted, an annual internal peer review of the financial books and records of the FLSSAR for the preceding fiscal year.

Authority:

Florida Society By-Laws, Article V, Section 2

Members:

The President shall appoint a Financial Review Committee of not less than three nor more than five Members of the FLSSAR.

Functions:

The Financial Review Committee is responsible for conducting an annual internal review of the books and financial records of our Society. The Treasurer provides the committee with sufficient and appropriate materials to review the activities, transactions, and financial assets of the FLSSAR. After reviewing the data, materials and records provided, the Committee determines if those records and processes accurately reflect the financial position of the FLSSAR.

The report of such review shall be presented to the Board of Management for approval prior to the Annual Meeting of the FLSSAR.

The word "audit" is a reserved term and does not pertain to this charter.

Medals and Awards

Status	Statutory
Purpose:	Implement, administer and keep records for the Medals and Awards program. (except Patriot Medal)
Authority:	Florida Society By-Laws, Article V, Section 4.
Members:	A Chairman and four Members who shall be appointed by the President, Florida Society and whose terms shall be concurrent with that of the appointing officer.
Functions:	<p>To designate the person(s), groups, or organizations to whom medals (other than the Patriot Medal), plaques, prizes, decorations, trophies, certificates, gifts, honoraria, or other awards, except as provided for in these By-Laws, are to be given by and in the name of the Florida Society.</p> <p>To arrange for medals, plaques, and the like to be suitably engraved; for certificates and the like to be suitably inscribed, signed and framed for hanging; and for the items which are to be awarded to be on hand at or before the scheduled time of the presentation ceremony.</p> <p>To designate the person who will present the medal or award to the recipient.</p> <p>To furnish the Secretary, at the time of the Annual Meeting, a list of all medals and awards that have been given out by this committee during the year of its tenure, so that the names of all holders thereof may be permanently recorded in the annals of the Florida Society</p> <p>To provide advice and guidance to the chapters regarding medals and awards proposed to be given by the chapters. Nominations of persons to be considered by this Committee for awards may be made to the Committee by any member of the FLSSAR; such a nomination should include a statement detailing the qualifications of the nominee for such consideration, and should be sent to the Chairman of the Committee</p>

Status	Statutory
Purpose:	To nominate at least one candidate, qualified and willing to serve, for each office that is to be filled by election by the FLSSAR at its next Annual Meeting.
Authority:	Florida Society By-Laws, Article III, Section 2. (a) (1)
Members:	Five members who shall not have served on a Nominating Committee during the preceding two years shall be elected by the Board of Management at its first regular BOM meeting following the annual meeting from a slate of nominees who shall have been nominated by the President and/or the Board of Management. The five elected shall serve until the adjournment of the next Annual Meeting and shall elect from their number a Chairman. (Article III, Section 2 a. (1) (a)).
Functions:	To solicit candidates who are qualified and are willing to serve, at least one candidate for each office, to be filled by election at the next Annual Meeting. The Chairman, or other committee member designated by him, shall announce at least 60 days prior to the Annual Meeting, the names of the persons chosen by the Committee to be the nominees for the respective offices, and shall thereupon deliver a copy of the committee report to the Secretary who shall publish it in such a manner and at such time as to assure that every member of the FLSSAR is given at least thirty days advance information as to the names of persons whom the Committee will nominate for the respective offices for the following year. At the next Annual Meeting of the FLSSAR the Chairman, or other committee member designated by him, shall place in nomination the names of the respective candidates proposed by the Committee to be officers of the FLSSAR for the following year, and he shall thereupon deliver a copy of the committee report to the Recording Secretary. Patriot Medal

Statutory

Purpose:

To designate members of the FLSSAR to whom the Patriot Medal will be awarded. To present the Patriot Medals at the final session of the Annual Meeting by the Chairman of the Committee or his designee.

Authority:

Florida Society By-Laws, Article V, Section 3.

Members:

The President of the FLSSAR shall appoint, and name the Chairman of, the Patriot Medal Committee, to consist of five members of the FLSSAR, each of whom has previously been awarded the Patriot Medal by the FLSSAR. The terms of the Chairman and Members shall be concurrent with that of the appointing Officer.

Functions:

Consideration of Nominations: Nominations of persons to be considered by the Committee for the Patriot Medal may be made by any member of the FLSSAR. Such nomination should include a statement detailing the qualifications of the nominee, and must be sent to the Chairman of the Committee at or before January 31st of each year.

Presentation of the Patriot Medal: The Committee shall assure that the Patriot Medal, properly engraved, and a framed Certificate attesting to the Award, are on hand at the scheduled time of the Presentation Ceremony. The Chairman of the Committee, or his designee, shall present the Award at the Final Session of the Annual Meeting of the Florida Society, and, he shall furnish annually to the Secretary of the Florida Society a list of persons to whom the Patriot Medal has been awarded so that the annals of the Society may record the names of all holders of the Patriot Medal as being life Members of the Board of Management (By-Laws Article II. Section 1. a.).

Standing Committees

Explanation

A Standing Committee has the following characteristics: (By-Laws Article V. Section. 6. b.)

1. Standing Committees are established and empowered by action of the Board of Management.
2. Standing Committee Charters may be amended or revoked by action of the Board of Management.
3. Standing Committees perform functions. They remain in existence as long as their Charters remain in effect.
4. Standing Committee Charters designate the class of business for which the Standing Committees have cognizance; and they grant authority to conduct business.
5. Members of Standing Committees are appointed by the officer identified in their Charter. Members of Standing Committees serve for a term as stated in their Charter.

Changes to Standing Committees may be made in the following manner:

- 1) Suggested changes are submitted to the subject committee for recommendations and a position on the change(s).
- 2) The subject committee shall submit the proposed change(s) to the next Board of Management where the change(s) shall be subject to a decision by a simple majority vote.

The subject committee charter will be changed, if appropriate, or, if necessary, a new charter will be written for dissemination to the membership in the next issue of the Florida Patriot or will be posted on the FLSSAR web site.

Americanism Youth Contests

Status	Standing
Purpose:	To administer the NSSAR Americanism Youth Contests (The Elementary Poster and Middle School Brochure Contest) for the Florida Society. The aim of this contest is to stimulate interest in American History in support of the established school curriculum
Authority:	Florida Society By-Laws, Article V, Section 6. b
Members:	A Chairman and six Members, with the goal of having one member to represent each of the seven Vice Presidential Regions, appointed by the President Florida Society, and whose terms are concurrent with that of the appointing officer.
Functions:	<p>To administer the contests for the Florida Society in accordance with the National Society Guidelines.</p> <p>To provide chapters with current guidance to conduct local contests.</p> <p>To encourage chapters to conduct contests to select a winning contestant for the State contest at the annual meeting.</p> <p>To maintain a close relations with chapter contest chairmen and provide assistance when needed.</p> <p>To ensure adequate space and time is reserved at the annual meeting for judging of the contests. A minimum of three judges should be adequately trained and not biased on the criteria in evaluating the students' contest entries.</p> <p>To ensure that the FLSSAR contest winners are delivered in sufficient time to Congress for judging.</p> <p>To report the winning entries to the FLSSAR Treasurer and Ladies Auxiliary Treasurer for the checks to be delivered and presented to the winning chapters at the annual meeting if possible.</p> <p>To report all contest costs to the FLSSAR Treasurer and file a report for the next Board of Management meeting.</p>

To update and maintain the Governing Documents of the Florida Society.

Authority:

Florida Society By-Laws, Article V, Section 6. b.

Members:

A Chairman, usually the Senior Vice President, and additional Members, normally four, as the President, Florida Society may appoint and whose terms shall be concurrent with that of the appointing officer.

Functions:

To maintain a current Master Copy of the Articles of Incorporation and the Bylaws of the Florida Society.

To receive, review, and/or make recommendations for proposed amendments to the Articles of Incorporation of the FLSSAR consistent with Article IX of that document.

To receive, review, and/or make recommendations for proposed amendments to the Bylaws of the FLSSAR consistent with Article VIII, Section 3 of that document.

To publish approved changes to the documents over which this committee has cognizance, ensuring one document doesn't conflict with the approved changes of another.

To promulgate Bylaw changes as approved by the Florida Society at an Annual or Special Meeting, in coordination with the State Recording Secretary and State Secretary through errata sheets, page changes, articles in the Florida Patriot, email and the Florida Society website.

To print revised editions, as required, of the documents over which this committee has cognizance, in coordination with the State Secretary. To make limited distribution of hardcopy documents over which this committee has cognizance to appropriate State Officers and Committee Members. To assign to the State Secretary the bulk of document printing for distribution to all State Officers, Committee Chairmen, and Chapter Presidents. In lieu of printing, revised editions of the documents over which this committee has cognizance can be made available through electronic means such as email or the posting to the Florida Society website.

Purpose:

To administer and coordinate the Florida Society support for Children of the American Revolution (CAR). To also serve as the SAR Junior Members Aide and Page Committee

Authority:

Florida Society By-Laws, Article V, Section 6. b

Members:

A Chairman and such additional Members as may be appointed by the Florida Society President, and whose terms shall be concurrent with that of the appointing officer

Functions:

Establish and maintain liaison between the FLSSAR and the N.S.C.A.R. and F.S.C.A.R. The local FLSSAR Chapters should coordinate joint functions and activities between the local societies, the N.S.C.A.R. and F.S.C.A.R.

FLSSAR Chapters should assist in the chartering of new F.S.C.A.R. Societies if requested to do so.

Support the local C.A.R. Societies and F.S.C.A.R with Senior Leaders from the local FLSSAR Chapters and also provide monetary support to the local C.A.R. Societies in their area.

At the Fall Board of Management Meeting, it shall be the duty of the current Committee Chair to request a budget amount for the Annual Grant for the coming year. This should be done before budget for the coming year is presented by the FLSSAR Treasurer. The Treasurer needs to be informed of your requested amount before he prepares the new budget.

The FLSSAR Annual Grant is presented to the President of the F.S.C.A.R., by the incumbent FLSSAR President or his representative, at the F.S.C.A.R. annual meeting which is normally in March.

Encourage male members of the F.S.C.A.R. to become members of the SAR when they attain eligible age.

Members of the FLSSAR can obtain a current listing of all F.S.C.A.R. officers, both members and seniors at the local society, state and national level by visiting the F.S.C.A.R. or N.S.C.A.R. web site or by requesting a listing from any member of this committee.

Utilize the F.S.C.A.R. members (Aides & Pages) and SAR Junior members (Aides) to perform the duties of escorting the various youth winners and their family members to the dais to receive their respective awards at our annual Youth Awards Luncheon

Insure that the participants, Aides, Pages and Junior members are aware that FLSSAR will pay for their meal at our annual Youth Luncheon.

Insure that the participant's names are listed or announced at the annual Youth Awards Luncheon and that an appropriate N.S.C.A.R. certificate or medal is presented to all participants.

No report is required to carry out the duties of this committee other than the reports for our BOM meetings and our annual meeting.

- Authority:** Florida Society By-Laws, Article V, Section 6. b.
- Members:** A Chairman and at least five other Members to be appointed by the President, Florida Society, and terms shall be concurrent with that of the appointing officer.
- Functions:**
- To publicize the NSSAR Eagle Scout Scholarship and Awards Program, to request assistance and cooperation from the Scout Executives of the Florida BSA Councils, to assist Chapter Eagle Scout Committee Chairmen understand the Program and to tell them how to obtain the necessary forms and names of eligible Eagle Scouts.
 - To request that Chapters inform the State Eagle Scout Committee Chairman of their Chapter winner by January 2 annually and to select the FLSSAR Eagle Scout Scholarship nominee by February 1 annually.
 - To forward the papers of the FLSSAR first place winner to the NSSAR Eagle Scout Chairman by February 22 annually.
 - To arrange for the FLSSAR winner to attend the Annual/Spring BOM, expenses paid, to receive his awards.
 - To publicize the Robert E. Burt Boy Scout Volunteer Award for FLSSAR scouters of the Sons of the American Revolution. The award and forms are available on the NSSAR Eagle Scout Committee web site.

- For an Eagle Scout Court of Honor Ceremony, we suggest the Chapter present at the Ceremony the following: Eagle Scout Printed Certificate (ES-0412), Eagle Scout Partners for Good Citizen Patch (ES-GCP), a Certificate Presentation Folder to present the Certificate in. Also have plenty of the FREE Eagle Scout Pamphlets (ES-F) to hand out.
- For the Chapter Eagle Scout Scholarship Winner, we suggest the Chapter present at the Chapters Eagle Scout Award Ceremony the following: Eagle Scout Scholarship Medal (ES-M), Eagle Scout Engraved Certificate (ES-0411), Eagle Scout Scholarship Competition Patch, and a Certificate Presentation Folder to present the Certificate in. The Eagle Scout Scholarship Competition Patch is available to each Eagle Scout who completes the requirements listed in the Eagle Scout Scholarship Program

In an effort to maintain the high standard of conduct expected and deserved by our Forefathers, our Members, and the American public Florida Society SAR operates under the Code of Business Ethics and Conduct outlined below.

Authority:

Florida Society By-Laws, Article V, Section 6. b.

Members:

A Chairman appointed and additional Members, not less than 5, who shall be appointed by the President, Florida Society and whose terms shall be concurrent with the appointing officer.

Functions:

Ensure adherence by all Florida members to the policies as set forth below.

Upon receiving a complaint perform due diligence in investigating said complaint and forward the committee recommendation to the Florida Executive Committee for any action deemed necessary.

Compliance Requirements All members, employees, and volunteers are required to comply with applicable federal, state, and local laws and regulations and with National Society SAR and Florida Society SAR bylaws and policies.

Prohibited Actions

No member, employee, or volunteer shall engage in the following actions:

Authorize the use of or use for the benefit or advantage of any person, the name, emblem, endorsement, services or property of Florida Society SAR, except in conformance with Florida Society SAR policy.

Accept or seek on behalf of any other person, any financial advantage or gain of other than nominal value offered as a result of the member's, employee's, or volunteer's affiliation with Florida Society SAR.

Publicly use any Florida Society SAR affiliation in connection with promotion of partisan politics, religious matters or positions on any issue not in conformity with the official position of Florida Society SAR.

Disclose any confidential Florida Society SAR information that is available solely as a result of the member's, employee's or volunteer's affiliation with Florida Society SAR to any person not authorized to receive information, or use to the disadvantage of Florida Society SAR any such confidential information, without the express authorization of Florida Society SAR.

Knowingly take any action or make any statement intended to influence the conduct of Florida Society SAR in such a way as to confer any financial benefit on any person, corporation or entity in which the individual has a significant interest or affiliation.

Operate or act in a manner that creates a conflict or appears to create a conflict with the interests of Florida Society SAR and any organization in which the individual has a personal, business or financial interest.

Retaliate against any member, employee or volunteer who seeks advice from, raises a concern with or makes a complaint about fraud, waste, abuse, policy violations, discrimination, illegal conduct, unethical conduct, unsafe conduct or any other misconduct by the organization, its members, employees or volunteers.

Operate or act in any manner that is contrary to the best interest of National and Florida Society SAR.

Conduct in disseminating via multi-party e-mail, mail, social media or other means, disparaging, maligning, false, or harassing comments or statements concerning compatriots.

Issuance of circulars, communications or pronouncements regarding the Florida Society SAR purporting to represent official policies of the Florida Society SAR via e-mail, mail, social media or other means, without the approval of the Trustees, Executive Committee or the Executive Director.

Misappropriate or convert to personal use the personal or intellectual property of the Florida Society SAR without the approval of the Trustees, or if that authority is delegated, without the approval of the Executive Committee or the Executive Director.

Reporting Responsibility

Each member, employee, volunteer and other stakeholder of Florida Society SAR has an obligation to report in accordance with this Code of Business Ethics and suspected violations of this Policy.

**Handling of
Reported
Violations**

Violations of this Policy shall be referred to the Ethics Committee for investigation. The investigation may be instituted by a written complaint or by information brought to the attention of the Chairman or a member of the committee. The committee shall investigate the alleged violation. At the conclusion of the investigation the committee may hold hearings and take testimony as provided in Robert's Rules of Order.

At the conclusion of the hearing and investigation the committee may take such action as it deems necessary, or it may recommend disciplinary action to the President and the Executive Committee. In the event of a recommendation for disciplinary action by the President and the Executive Committee, the Executive Committee shall review the findings of the Ethics Committee and take appropriate action or no action as the case requires.

The alleged violator may appeal the action taken by the Executive Committee by filing notice within thirty (30) days demanding a hearing on the alleged violations before the Executive Committee at a date time and place which shall be set by the Executive Committee. The alleged violator shall have a further right to appeal any action taken by the Executive Committee to the Board of Managers at its next regular meeting. Executive Committee action other than expulsion shall be confirmed by a majority vote of the members of the Board of Managers present. If the action being sought against the alleged violator is expulsion from Florida Society SAR, a two-thirds (2/3) vote of the members of the Board of Managers present and voting shall be necessary to expel. Such alleged violator shall have a further right to appeal any action taken by the Board of Managers to the immediately following Annual Meeting. Board of Managers action other than expulsion shall be confirmed by a majority vote of the delegates at said Annual Meeting present and voting. If the action being sought against the alleged violator is expulsion from Florida Society SAR, a two-thirds vote of the delegates at said Annual Meeting present and voting shall be necessary to expel.

 - Assure that facility restaurant will serve breakfast at suitable time. Starting not later than 7:00 am.

It shall also be the duty of the Committee to put forward specific tasks for the teachers to accomplish in order to better teach Early American History to their students.

The Committee shall select the winning candidate from those candidates sent forward from the Chapters and, with the approval of the BOM, pass this application on to the NSSAR Committee Chairman.

The Committee shall use the state winner's documents and handouts as promotion material for the following year's award program (provided the Committee has written permission from the previous year's winner).

A suitable Award is to be presented to the FLSSAR winner at the FLSSAR Annual Meeting.

The winner of the FLSSAR Award is to be photographed and his/her application is to be made available to all Chapters for promotion purposes.

FLSSAR Award:

The Committee recommends that FLSSAR give the state winner a cash award, plus an appropriate engraved Plaque and Certificate.

At the Fall Board of Management Meeting, it shall be the duty of the current Committee Chair to request a budget amount for the Annual Grant for the coming year. This should be done before budget for the coming year is presented by the FLSSAR Treasurer. The Treasurer needs to be informed of your requested amount before he prepares the new budget.

Chapter duties:

The Chapters shall provide the FLSSAR Committee with appropriate candidates and the supporting documents needed to be considered for this award.

Each Chapter is responsible for providing all teachers with the appropriate deadlines and Rules applicable to the Contest for the ensuing year.

When possible, each member of the various Chapter History Teacher Award Committees shall attend classes at the high school level to show the previous year's program for all to see and learn from.

The Chapter Committee shall provide candidates with the appropriate application blanks and give council to those who wish to enter this award contest.

Chapters shall provide the local winning entry with a significant Award and present this Award at one of their member meetings.

Publicity photos and write-ups are to be given to the local media for publication and copies of these are to be sent

Special or Ad Hoc Committees

Special Committees may be transformed into Standing Committees by the Board of Management.

Status Ad-Hoc

Purpose: Establish a monument in recognition of the first amphibious landing of the American Revolution.

Authority: Florida Society By-Laws, Article V, Section 6. c

Members: This committee will be established with the following members and they shall serve until the BOM after the dedication of the monument or on a 2/3 vote of the BOM. Additional members may be added to the committee by the incumbent President and confirmation of a majority of Excom. Those members shall serve under the same terms as the initial appointees. Steve DePaul, Jon Hunt, Dick Young, Steve Fields, Matt Matthews, Chris Washler.

Functions: This committee will be funded with an initial \$5,000 from the general fund.
