Society President's Message

Compatriots,

This year we will strive to rekindle our efforts with the Florida Department of Education and the Governor's office. As you may recall, we had developed a meaningful association with these entities which allowed us to be involved in the selection of textbooks concerning the American Revolution. Additionally, we were poised to assist in the development of curricula for the schools that involved classes that contained teaching of the Colonial Period. However, our participation became disrupted earlier in the year because of the health situation. We will endeavor to reconstitute our successes.

We are accumulating information to make application to the NSSAR Historic Sites Committee to have the Battle of Alligator Bridge recognized as an NSSAR Historic Site. That would give us four sites in the State with one more to assess, potentially. Even though we are called the 14th and 15th colonies, we had an important part to play in the American Revolution as Dr. Roger Smith so aptly writes.

This year will pass quickly – too quickly. But one major project that will continue is the planning for the 133rd Congress in Orlando, FL in 2023. As the FLSSAR Host Planning Chairman, there will be continuity between my two roles until the termination of a successful event. Much has been done and there is still more to do. Society Secretary's Report

FLSSAR membership total (as of 8/1/2021) is 2,315, including Youth and Dual members.

In mid-September, I will be sending all information necessary to complete the annual reports to the chapter Presidents and Secretary. The packages include member rosters, payment forms, and instructions. The chapter annual reports need to be submitted to me by December 15th, so that I can meet my deadline to National. If you do not receive your package by Oct 1st, please let me know. If someone other than the chapter President or Secretary is completing your annual report, please ensure that they get the package I send.

Regarding Youth members:

The Youth Registrant program existed from 2001 until it was terminated in 2011. Under the program a person under age 18 could file an application which, if approved, would allow that person to convert upon request to standard membership without any further documentation. When the program was terminated, all existing Youth Registrants could either convert to Junior Membership or, after they reached their 18th birthday and before age 29, could still apply for Regular Membership. I would encourage those chapters with Youth members to contact their sponsor and see if they would like to convert the Youth member to Junior (if under 18) or Regular status. There is no fee; just payment of the annual NSSAR and FLSSAR dues, and no application is needed. If, however, they turn 29, they get dropped, and application for Regular status would require the standard application process. If you have any questions, or need assistance, please contact me.

Regarding the Chapter Challenge Contest:

The Florida Society Chapter Challenge Contest is designed to recognize chapters for various activities that meet the goals of the SAR. Chapters are judged against each other based on size (small-red, medium-white, large-blue). The top three winners in each category are recognized at the FLSSAR Annual Meeting. The contest period is the calendar year, January 1st to December 31st.

Scoring for the contest is done using the NSSAR Americanism Award / President General's Activity Streamer Combined Score Sheet, available on the NSSAR website (https://www.sar.org/committees/americanism-committee/). Chapters are encouraged to fill out the Scoresheet and submit it to the National competition. In addition, it should be sent to the State Secretary for inclusion in the FLSSAR submission and for the Chapter Challenge Contest. It is important to note that I need your submissions no later than February 1st, so that I can meet my deadline to National.

Washington's "Badge of Military Merit"

Following victory of the Continental Army over the British at Yorktown, Washington established his headquarter at Newburgh where he could observe the English army in New York.

Continuing his tireless efforts to improve the condition of his troops and insure a high state of morale, Washington decided to create an honor to recognize enlisted men who had performed bravely on the field of battle. He called this award, the Badge of Military Merit.

Washington designed the distinctive badge in the form of a purple cloth heart with the word Merit inscribed in the center. The merit badge was conceived as a military order for soldiers who exhibited, "not only instances of unusual gallantry in battle, but also extraordinary fidelity and essential service in any way."

General Washington announced the Badge of Military Merit in his general orders to the Continental Army on August 7, 1782 his headquarters in Newburgh. Washington statement regarding the Badge of Military Merit (see picture):"The General ever desirous to cherish virtuous ambition in his soldiers, as well as to foster and encourage every species of Military merit, directs that whenever any singularly meritorious action is performed, the author of it shall be permitted to wear on his facings over the left breast, the figure of a heart in purple cloth, or silk, edged with narrow lace or binding.


Not only instances of unusual gallantry in battle, but also of extraordinary fidelity and essential service in any way shall meet with a due reward.

Before this favor can be conferred on any man, the particular fact, or facts, on which it is to be grounded must be set forth to the Commander in chief accompanied with certificates from the Commanding officers of the regiment and brigade to which the Candidate for reward belonged, or other incontestable proofs, and upon granting it, the name and regiment of the person with the action so certified are to be enrolled in the book of merit which will be kept at the orderly office.

Men who have merited this last distinction to be suffered to pass all guards and sentinels which officers are permitted to do. The road to glory in a patriot army and a free country is thus open to all. This order is also to have retrospect to the earliest stages of the war, and to be considered as a permanent one."

-G. Washington, Commander-in-Chief Continental Army-

Historians tend to agree that only three soldiers actually received the medal. Two men selected by a board of officers to receive this award were Sergeant Elijah Churchill of the 2nd Continental Light Dragoons and Sergeant William Brown, a member of the 5th Connecticut Regiment, Continental Line.



Washington Presenting First Military Badges of Merit to Churchill & Brown



Brown had won praise for his bravery in the storming of Stony Point in 1779 and for gallantry in the trenches at Yorktown. Churchill distinguished himself during attacks against two forts on Long Island.

On 3 May 1783, these men traveled from the Continental encampment at New Windsor and to Washington's headquarters at the Hasbrouck House in Newburgh. There, before an honor Guard Mount of the 1st New York Regiment, Commander -in-Chief Washington awarded Sergeant Churchill and Sergeant Brown the first Badges of Military Merit. (see pictures)

Surviving records for the period confirm the presentation of only one other Badge of Military Merit to Sergeant Daniel Bissell of the 2nd Connecticut Regiment on June 10 1783.

Following the Revolutionary War, the Badge of Military Merit fell into disuse although never officially abolished.

In 1932, the United States War Department authorized the new Purple Heart Medal for soldiers wounded in battle or previously awarded either a Wound Chevron or the Army War Ribbon. It was also mandated that the Purple Heart Medal would be considered the official "successor decoration" to the Badge of Military Merit.

The original Military Badge of Merit, the pomp, and ceremony, however, symbolized much more than recognition of brave men. The badge represented the climax of the molding of a citizen army of volunteers and militia into a force that had fought on equal terms with one of the world's best armies, and in doing so, had played a vital role securing freedom and independence for their fellow citizens.

Both the Badge of Military Merit and the Purple Heart have become symbols of pride in our Country and Military and Patriots from all walks-of-life as a tribute to all those who served and sacrificed at the Altar of Freedom!

From the New Chapter Development Committee

Although the FLSSAR By-law states a chapter can be started with 10 members in a local area, it is suggested and encouraged by the FLSSAR that the potential new chapter begin with at least 15 local members (existing or new) who agree to be active. The more people that join the new chapter at the start, the more the said chapter can make a difference in their region by having members that can serve on the various outreach committees such as JROTC awards presentations, Knight Essay Contest, and Rumbaugh Oration Contest, Americanism Poster Contest, HFH Flag Presentations, Veterans Recognition Awards, Color Guard, and much more. Members will also need to agree to serve as Chapter officers.

The increase number of local members help make it possible for more people to assist with the various activities of the chapter without having a small number having to do all the work. Additional members also help when securing reservations at local restaurants that the new chapter may want to start meeting.

All new members usually have submitted their paperwork for SAR membership ahead of time so that everyone is a member of the NSSAR and FLSSAR at the time that the chapter is chartered. The harder job is getting volunteers who are willing to take on the role of officers and committee chairmen in a new chapter. If this sounds interesting to you and you are aware of an area in the State of Florida in which a new chapter could be established, the FLS-SAR would like to hear from you. NSSAR Newsletter Competitions

The winners of the 2021 competitions were announced and awarded at the July 2022 Congress.

As always, the committee is looking for more members in the committee for judging the many contest newsletter issues. If you have experience in publishing or judging newsletters, please consider joining the committee by contacting the chairman.

To all Chapter Newsletter editors and State Society editors, now is the time to start thinking about entering the SAR competitions for these four 2021 year competitions:

• The two Carl F. Bessent Awards are presented to SAR chapter editors for the best multiple sheet and single sheet periodicals

The Jennings H. Flathers Award is presented to the state-level society with fewer than five hundred members. State membership levels at the end of the preceding year -2020 in this case – will determine which of the contests should be entered.

The Paul M. Niebell, Sr. Award is presented to the state-level society with over five hundred members judged having the best periodical or newsletter with ten or fewer pages. State membership levels at the end of the preceding year -2020 in this case - will determine which of the contests should be entered.

• The Grahame T. Smallwood, Jr. Award is presented to the state-level society with over five hundred members judged having the best periodical or newsletter with more than ten pages. The guidelines for judging newsletters can be found at the <u>sar.org</u> website via this link accessed by logging into the SAR site - - <u>and</u> accessing the committee's web page. Please read these guidelines to understand what and how your publication will be judged.

Every editor at a state-level society or chapter considers his newsletter to be excellent and deserving of recognition. Editors are to be commended for their efforts expended on their newsletters. However, there are only a few awards available and the competition is fierce, with little room for error. There is also some subjectivity incorporated into the judging process in order to provide flexibility in determining the best newsletters. These guidelines should help editors determine if they are meeting the requirements necessary to be competitive. **If so,** then the editors can submit their publications for judging. **If not**, then the editors should work towards meeting the requirements before submitting.

Remember, good communication is the goal, not awards or accolades.

To be eligible for competition, submission should be the **single issue** as determined by the editor/chapter to be the best published issue per calendar year (January to December 2021) to be submitted to the Newsletters and Publications Committee chairman. Submissions are preferred by email attachment (PDF/WORD files) or by the issue's URL if located on a web site. Submissions should be of acceptable quality. See Handbook for ideas for what a good newsletter can be. <u>The submission must be received by December 15</u>. When submitting your single issue for a State entry, please **state which contest you are entering**: Flathers, Niebell, or Smallwood. Sending all newsletter issues to the committee chair does <u>NOT</u> enter the publication into any contest. If you cannot submit by December 15th, contact the committee chairman for an extension. The extension will not be longer than 2 weeks. Late submissions without an approved extension will not be judged.

To repeat some language from the Newsletters and Periodicals Handbook: "There is a distinct obligation on the part of a local chapter's leadership to inform the membership as a whole of a chapter's activities, goals, and achievements. We all know that many of our supportive members find it difficult or impossible, for any number of reasons, to attend chapter meetings. Without written communication received on a regular basis, these men would receive nothing, and may feel no obligation to continue membership in the organization and be one of those individuals who drops membership when the dues notices are sent. No news is not good news. No news is just that: nothing."



250th Anniversary of the American Revolution Recognition Program National Society. Sons of the American Revolution



The recognition program is designed to encourage and recognize those compatriots, chapters and societies that participate in local, state, national and international events which publically educate, and recognize, honor, and celebrate the events and heroes of the period surrounding the American Revolution. Participation involves the planning and execution of these events, as well as attendance. The medal covers the celebration of any event's 250th anniversary where said event related directly to acts of resistance to British attempts to coerce the residents in America: from the first Parliamentary Acts protested after the conclusion of the French and Indian Wars, through the armed struggle of the American War for Independence, to the ratification of the Treaty of Paris by the Continental Congress. This therefore will cover any public celebrations in the period from 2014 to 2033. Form may be submitted to cover multiple years and following the first submission be submitted in multiple years, only covering activities since the previous submission. Scorekeeping is the responsibility of each compatriot and awarding authority. You will receive an email authorizing the purchase from merchandising. The guidelines and points are describe below:

> Awards are based on activity and the awarding of points for each type of activity:

a. Directing, chairing or co-chairing an event or sub-committee for the duration of the event. (20 points)
b. Participation in the planning, financing, promotion or conduct of an event other than directing, chairing, or co-chairing an event. Those that do direct, chair or co-chair and event and also serve as a regular member of a committee or sub-committee in a non-leadership role, may also earn points. (10 points)

c. Attending an Event (3 points)

d. Attending an event in Colonial Attire (5 points)

SAR Members may be awarded the Medals for achieving the following levels:

a. Bronze Medal: 25 promotion points as certified by his chapter, state, district or national society.

b. Silver Medal: Compatriots who earn 60 promotion points as certified by his chapter, state, district or national society.

c. Gold Medal: Compatriots who earn 150 promotion points as certified by his chapter, state, district or national society.

> Non-SAR members may also be awarded these medals:

a. The chapter may present bronze awards to its Partners in Patriotism, and may recommend its Partners to the state or national society for higher recognition.

b. The state and district may present silver awards to its Partners in Patriotism, and may recommend its Partners to the national society for higher recognition.

c. The district or national society may present gold awards to its Partners in Patriotism.

> Coin Award, May be awarded to SAR and Non-SAR individuals participating in programs but taking no actual leadership role.

Streamer. Awarded to SAR and non-SAR organizations. The certificate will describe the program for which the award is being made. Streamers come in three levels based on maximum participation in any one event during the year. Stars will be awarded if re-earned in subsequent years. The Bronze Streamer for an average of 10% participation, the Silver Streamer for an average of 25% participation, or a Gold Streamer for an average of 50% participation.

"Sons of Liberty-1775" by James N. Muir depicts a typical Colonial Militia citizen-soldier on that date, the original "Patriots' Day" of 19 April 1775. The sculpture is historically authentic in every regard as to arms, accoutrements, clothing and hair style. He is carrying a captured 42-inch barrel "Short Land" Model 1740 British Musket adopted in 1765 to replace the earlier 46-inch first model "Long Land" or "Brown Bess" (which is depicted in the maquettes of "Sons of Liberty-1775). Powder and ball were carried either in a powder horn and pouch or preferably, as depicted, in the more military cartridge box in the form of pre-made paper or linen cartridges. A vent pick and frizzen brush hang handily from his vest.
