From the Medals & Awards Committee

When considering awarding a member a medal or any awards, the chapter should determine that the proposed recipient is qualified, deserving, and the occasion for presentation is appropriate per the guidelines stated in Volume 5 of the NSSAR Handbook. The presentation of medals and awards should not be treated lightly by the National Society, district, state society or a chapter, and should always be given judicious thought to assure that the presentation is in keeping with NSSAR principles. It is essential that the integrity of NSSAR medals and awards be maintained.

As for the Florida Society, any nomination for a certificate and any supporting data to be used in making an award of a certificate must be submitted to the FLS-SAR Medal & Awards Committee 60 days before any Board of Management Meeting so that the committee can evaluate the request, secure the certificate and/or medal from National if it is not already in FLSSAR inventory and have it prepared for signatures at the upcoming Board of Management Meeting. Most certificates issued by the Florida Society require the signature of the Society President and Society Secretary.

When various committees of the FLSSAR plan to give out certificates, medals, patches etc. for such programs such as the Knight Essay Contest, the Rumbaugh Oration Contest, JROTC, CAR, Eagle Scout, the committee chair is responsible to notify the Medal and Awards Committee of the number of awards that they are planning to award for the upcoming year by October so that the appropriate items can be ordered from the NSSAR. Although such awards may not need to be approved by the Medal and Awards Committee, proper planning is required in order to keep cost down and to not have to expedite such awards based on last minute planning. Note that typically, if the FLSSAR orders such items in the fall of each year, there is a sale of them that help the Florida Society save some money so that we can better appropriate resources for other projects.

The Many Faces of Benjamin Franklin

"Either write something worth reading or do something worth writing" is a very well known, though unfortunately overused, quote by Benjamin Franklin. However, in all that Franklin did, his life was certainly worth writing. His achievements spanned many fields, from his advances in science to his success as a politician and diplomat and a published author. He was at the core of founding the United States, as he helped draft the Declaration of Independence, negotiated the Treaty of Paris (which thusly ended the Revolutionary War), and in the later years, was a very important delegate to the convention that created the Constitution. Though he had only two years of formal education, Franklin made his way to being one of the most influential and important thinkers in American history.

Born into a family of "modest means", Franklin only had two years of formal education, but still was an avid reader and educated himself in the arts of writing. He was an apprentice to his older brother at a printing press, and very quickly took to writing for a newspaper published by his brother. When he was just 17, he quit his apprenticeship to work as a printer in Philadelphia and then London, and then back to Philadelphia to begin his own printing business (Benjamin Franklin). In the 1730s, Franklin published Poor Richard's Almanack, and was elected the official printer of Pennsylvania (A&E Television Networks, 2014). Through his popularity as a printer, Franklin became more involved in civic affairs, and established a lending library, the city's first fire company, a police patrol, and the American Philosophical Society; as well as, the Pennsylvania militia, and was key in the creation of the Academy of Philadelphia. He was the first postmaster general of the United States and held the position from 1775 to 1776, resulting in his face being on the first U.S. postage stamps (Benjamin Franklin).

Benjamin Franklin, the scientist and inventor, was all the more influential to the United States and the world as a whole. In the 1740s, Franklin sought entrepreneurship by inventing the Franklin stove (A&E Television Network, 2014), which was a "wood burning stove that could be built into fireplaces to maximize heat while minimizing smoke and drafts". The stove was designed ingeniously and Franklin explained in his promotional pamphlets the complexity and the science of how warm air expands to take up more space than cold, how it is tighter, and how heat radiates whereas smoke is carried only by air (Isaacson, 2004). He became a soldier in the Pennsylvania militia at the age of 42, but then decided to pursue his interests in science, which lead to his more notable scientific experiments with electricity (A&E Television Networks, 2014).

In one of his first experiments, Franklin debunked previous notions that electricity only involved two types of fluids, vitreous and resinous, which could be independently created. Franklin discovered that the generation of a positive charge was accompanied by the generation of an equal negative charge, that was thusly called the conservation of charge, and the singlefluid theory of electricity. Harvard professor, I. Bernard Cohen, proclaimed that, "Franklin's law of conservation of charge must be considered to be one of the same fundamental importance to physical science as Newton's law of conservation of momentum", which was quite the compliment in the scientific realm (Isaacson, 2004). Then, much later in his scientific career, Franklin proved that lightning is electricity using his famous kits experiment (Benjamin Franklin), which was extremely controversial at the time, garnering several reviews suggesting that his claims about the experiment were a "hoax", and many religious groups, and the ABBE Nollet suggested his experiments and development of a lightning rod was "an offense to God" (Isaacson, 2004). Through the criticism and praise alike, Franklin gained much popularity and was suddenly a famous man, his inventions and theories spreading through every corner of the world, his name now a household one.

Franklin's political career is marked by several of the most influential events in the formation of the United States, specifically the documents that bind it. In 1754, Franklin proposed a plan for uniting the colonies under a national congress, which laid the framework for the Articles of Confederation, which was the first constitution of the United States when ratified in 1781. In 1776, he was a core member of the five-member committee that helped draft the Declaration of Independence, which was instrumental to the freedom of the American colonies from British rule. Congress sent Franklin, on the same year, to France in hopes of gaining them as an ally (Benjamin Franklin).

Franklin wrote to France during this time, and France feared that the Americans would take their independence from Britain without helping the French also, to which Franklin replied with, "No peace is take place between us and England, till you have concluded yours" (Franklin & Sparks, 1856). In May 1782, Franklin wrote to John Adams about the independence of the United States and France saying, "The ministry have in contemplation the independence to America, on condition of Britain being put again into the state she was left in by peace of 1763, which I suppose means being put again in the possession of the islands which France has taken from her", which he then remarks that this is "a proposition of selling to us a thing, that was already our own, and making France pay the price they are pleased to ask for it" (Franklin & Sparks, 1856). France's help was instrumental in the success of the Revolutionary War, and thus, in 1783, Franklin helped negotiate and draft the Treaty of Paris, which concluded the 13-year war with Britain (Benjamin Franklin).

Following almost a decade of being in France, Franklin returned to the United States in 1785, which lead to his pertinent involvement in the drafting of the United States Constitution (A&E Television Networks, 2014). Franklin told his colleagues in the Constitutional Convention that the success of any government rested "on the general Opinion of the Goodness of that Government as well as of the Wisdom and Integrity of its Governors". With this thought in mind, the Congress realized that the public reception of the new Constitution being drafted both at home and abroad likewise would depend on the reputations of the people writing it, Franklin's reputation was highly positive, "the whole world thought better of him and Washington than of any other Americans" (Morgan, 2003). As a Pennsylvanian delegate, Franklin debated a great deal with his colleagues at the many meetings of the Constitutional Convention, and in the end urged his fellows to support the controversial United States Constitution, which was thusly ratified in 1788, and Washington was inaugurated as president in 1789 (Benjamin Franklin).

One year following these events, in 1790, Franklin passed away at the age of 84. Franklin left money in his will to be used in Boston and Philadelphia to establish a trade school, a science museum and fund scholarships. The legacy of Franklin is made obvious by the successes of the United States that he was so instrumental in creating. His many other talents as an author, printer, scientist, and inventor are also still very important to this day, as many technologies were influenced by his thinking that are important to our daily lives.

Robert H. Brotherton (1947-2021)

It is with deep regret that the Clearwater and Saint Petersburg SAR Chapters announce the passing of Robert H. Brotherton" since he was a member of both chapters. He served as guest com-

mentator on the Family Tree Nuts YouTube episode "How to join the Sons of the American Revolution".

Robert Harding Brotherton, 74, husband of Janice Lynn Brotherton, entered into rest on Thursday, February 18, 2021. Funeral services will be held on March 6, 2021 at 2:00 PM at Moss Feaster in Dunedin, FL. Burial will take place in Berry Highland Memorial Cemetery in Knoxville, Tennessee.



Robert Harding Brotherton was born to his father, Robert Graham Brotherton (1923-2013) and his mother, Marjorie Helen Harding (1924-1988), in Knoxville, Tennessee. He graduated from Donelson High School in Nashville, Tennessee, in 1964.Robert married Bettejane Childress (1948-1975) on July 29, 1967 in Detroit, Michigan. Robert served in the United States Airforce as a launch crew member of a Titan II Intercontinental Missile Launch Crew beginning in 1966 and completed in 1970 in Wichita, Kansas, with an Honorable Discharge. Robert graduated with a Degree in Civil Engineering from the University of Tennessee (Knoxville) in 1973, utilizing the GI Bill benefits, assisted by the work efforts of his wife Bettejane, and his part-time work as an alarm installer. His wife Bettejane, died in a car accident in 1975, leaving him with two young children, James Harding Brotherton and Joseph Noah Brotherton, to raise.

In 1997, Robert married Janice Lynn Alban from Baltimore, MD. She served as a wonderful mother to these two boys and together they had a son Jeffrey Graham Brotherton and daughter Amy Beth Brotherton Caldarera.

Robert became licensed as a Professional Engineer in 1979 in Tennessee. His career preceded by working as an engineer with the Robert S. Miller Company in Nashville, TN, for one year and Envirodyne Engineers in Knoxville, TN, for nine years, where he participated in the planning, design, and construction of the City of Knoxville's Kuwahee Wastewater Treatment Plant (He co-authored a textbook on the design of pumping systems [Sanks] while working with Envirodyne). He served as the County Engineer for Knox County, TN, for three years, followed by 18 years of service to the City of Dunedin, FL as the City Engineer and Director of Public Works and Utilities, where he managed 175 staff and served, periodically, as City Manager, in his absence. Notable projects that he managed for Dunedin included the design and construction of the new Dunedin Wastewater Treatment Plant, Reverse Osmosis Water Treatment Plant, Reclaimed Water distribution system, Library, Senior Center, Stadium for the Toronto Bluejays spring training, flood control projects, and the redevelopment of downtown Dunedin. He is also known as the father of the Cooperative Funding Program for all Water Management Districts in the State of Florida.

Upon retirement at age 57, Robert began Brotherton Engineering, Inc., and served as the contracted City Engineer for several cities in Pinellas County, FL, between 2003 and 2019.

His career included many accomplishments and awards. Some of the most notable recognitions: "Engineer of the Year 2000" for the West Coast of Florida, "Walter Clausen Award" for making the greatest contribution to vocational education in the State of Florida in 1998, Co-Founder and Chairman of the Board for eight years for the first "Public Works Academy" in the United States, and Chairman of the Government Engineers - Florida Engineering Society in 1998. He was a Fellow of the Florida Engineering Society and National Society of Professional Engineers. He was awarded the Technical Achievement Award – Florida Engineering Society 1997 and the Daughters of the American Revolution (DAR) National Conservation Award in 1994.

He served as President of the St. Petersburg Chapter of the Sons of the American Revolution (SAR) in 2021. He also served as first Vice President of the Sons of the American Revolution (SAR), Clearwater chapter.



His personal life included serv-

ing as a Deacon and Trustee in several Baptist Churches. He recently started a church in Indian Rocks Beach called Grace Connection. He served as the Youth Pastor in two churches, served on the music worship team for several churches, sang with the Gospel Echos Quartet in the Tampa Bay Area for many years, maintained an extensive orchid collection, served as an assistant to the Genealogist in the Clearwater Chapter of the Sons of the American Revolution, served as his Family Historian (A comprehensive family tree, with over 12,000 family members, is located under the name "Brotherton Family Tree" on Ancestry.com.), co-authored a book on his Harding family tree that included biographies of over 500 living cousins, and served on the Pinellas County Republican Executive Committee. Robert was a licensed pilot and a certified scuba diver.

His life was dedicated to Christ, his family, and the communities that he served. Robert was preceded in death by his parents, Robert Graham Brotherton and Marjorie Helen Harding; and his first wife, Bettejane Childress.

Survivors include his wife, Janice Brotherton of Dunedin, FL; children, James Brotherton of Baltimore, MD, Joseph Brotherton of Washington, DC, Jeffrey Brotherton (Karen) of North Augusta, SC and Amy Caldarera (Jason) of Kennesaw, GA; grandchildren, Nicolas, Zoey, Nolan, Levi, Holden, Braxton and Ella.

Many species of birds were identified by sight and sound and his presence added measurably to this hike. The Battle of Thomas Creek occurred on May 17, 1777 and was a major defeat for the Patriots. The Patriot forces consisted of approximately 170 mounted soldiers from GA, SC, & NC comprising the 1st Regiment Georgia Continental Light Horse commanded by LTC John Baker and they were ambushed by 300 regular British Army soldiers from St. Augustine, 75 East Florida Ranger irregulars (loyalists) and many warriors from local tribes. The mission of the Continental Army Patriots was to proceed south from GA into Florida and destroy the British Army and British Government headquarters at St. Augustine, as well as, capture the vast quantity of stored war supplies and munitions. The British Army mission was to destroy the invading Patriot force whereas the local warrior tribesmen were seeking revenge, horses, supplies and scalps. On April 28, 2019 Trooper Vaughn responded to a request from Sheriff Mike Prendergast, Citrus County Sheriff's Office regarding an active pursuit where the suspect had attempted to run over multiple Citrus County deputies. FH Trooper Vaughn was fearless in his pursuit, despite gunshots being aimed at the troopers, the vehicle was stopped resulting in the apprehension of the suspect. Citrus County Sheriff, Mike Prendergast also took part in the paise of Vaughn. This was a very upbeat occasion for our Chapter meeting and SAR recognition event held at the Citrus Hills Golf and Country Club.

Charles W. Riegle, Sr. (1936-2021)

Charles William Riegle, Sr., 85, of Sarasota, and long-time member of Laurel Oak Country Club, passed away

at sunrise on January 17, 2021. He died as he wished: peacefully at home, with his loving wife and children by his side.

Born in Buffalo, New York, on June 25, 1935, to Dorothy McMurray Riegle and Warren Coleman Riegle, Charles is survived by Aušra, his wife of 53 years; sons Charles W. Riegle, Jr. (Chuck), of Charlottesville, Virginia, and Christopher V. Riegle of Marblehead, Massachusetts;



daughter Kristina A. Riegle of Rochester Hills, Michigan; their spouses Cynthia, Helen, and David; grandchildren Phoebe, Coleman, Evan, Oliver, and Genevieve, who knew him as "Poppy"; sister Patricia Morehead and brother-in-law Dr. William E. Morehead, of Memphis; and beloved nieces, neph-

ews, grandnieces, and grandnephews, who knew him as "Uncle Charlie." He is already dearly missed, but his family and friends have many, many wonderful memories.

In 1942, Charles' family moved from Bath, New York, to Memphis, Tennessee, where he completed his schooling. He served his church as head boy in the St. John's Episcopal boys choir and his country through the



Boy Scouts, the ROTC, the Army Reserve, and the Air Force Reserve medical corps. In 1967, Charles married the love of his life, Aušra Vedeckas, in New York City. Following a move from Memphis to Westport, Connecticut, the couple settled in Riverside, Connecticut, where they lived for 31 years and raised their children. In 2004, they made Sarasota their permanent home and joined Laurel Oak Country Club.

The son of an enterprising mother and a China Marine, Charles was outgoing and driven. He put himself through Southwestern at Memphis (now, Rhodes College), graduating with a Bachelor's in Psychology in 1957. He worked as a pharmaceutical sales rep and trainer before moving to a career in advertising. In 1972, he co-founded Rolf Werner Rosenthal, Inc., an advertising agency, in New York. After growing the business into a market leader, he and his partners sold it to Ogilvy & Mather in 1983. He conducted business as he did his life: honorably and with aplomb. He was proud to have made many clients his lifelong friends.

Charles volunteered time and talent to the Greenwich Symphony Orchestra, the Boys & Girls Club of Greenwich, Innis Arden Golf Club, and Christ Church Greenwich. He was an active member of the Sons of the American Revolution (SAR), a group dedicated to promoting patriotism and preserving American history. He held officer and committee positions across chapters in Connecticut, Massachusetts, and Florida, adding countless members to their rolls. In 2019, he capped off years of genealogical research by publishing The Riegle Family in America.

While work, service, and patriotism were important to him, Charles was first and foremost a family man. He and Aušra were always together: on the golf course, at the opera, entertaining friends, and traveling the world. They made epic summer road trips to escape the Florida heat. He spared no love for his children, whom he mentored by example.

A private funeral service was held on January 22nd at the Church of the Redeemer in Sarasota, where Charles was a member. Burial will follow at a later date. In 1972, he became the Head Professional at Lemon Tree Golf Course in Belleville, Michigan. By 1977 he was a Partner at Forest Lakes Country Club, Sarasota, Florida, where he worked as Director of Golf and General Manager of the club. He was co-founder of the Florida Golf Course Owners and Management Assoc. After the sale of the club, he continued his love of teaching as an instructor at the IMG Ledbetter Golf Academy in Bradenton, Florida and Longboat Key Club, Sarasota.

In semi-retirement. Doug remained active leading bible studies, and serving as a Deacon. Trustee and member of the choir at First Baptist Church, Sarasota. He also attained a 32-degree Scottish Rite of Freemasonry. Doug was President of the Saramana Chapter of the Sons of the American Revolution and Rotary member. Completed forms have been submitted to the Chairman of the Nominating Committee at <u>rmcguire@slvx.com</u>. In addition to the initial organizing meeting of the committee held at the May 2020 BOM, the Committee conducted a candidate's forum at the October 2, 2020 BOM, then held ZOOM meetings on January 8, 2021 and on February 13, 2021. The Committee has reviewed all applications received and determined that, in each case, the candidate is qualified for the position sought. At the February 13th meeting, the list of candidates was reviewed a final time and the slate was approved. The slate of nominees includes at least one candidate for each position to be filled by the election to be held May 1, 2021 during the Annual Meeting. In several instances there were more than a single nominee for the position. The Committee voted to include all qualified candidates on the slate. In advance of the election, the nomination or re-nomination forms of all candidates will be available for review in the "Members Only" section of the FLSSAR website.

The substantive work of the Nominating Committee set forth in the FLSSAR Bylaws has now been completed. Individual circumstances may result in withdrawal from consideration by particular candidates prior to the election. Henceforth, no additional candidates will be considered by the Committee. At the Annual Meeting, the Chairman will place the names on the attached list in nomination and will deliver a final report of the Committee to the Recording Secretary.

Notice of Liberty Tree Dedication

The dedication ceremony will be held on Sunday, April 18th beginning at 2:00 p.m. at the 2021 Heritage Festival celebrating Highland County's 100th Anniversary at the Edna Pearce Lockett Estate, sponsored by the Heritage Association of Highlands County and the Highlands Chapter, Sons of the American Revolution.

The Estate was a working cattle ranch from 1874 to 1991 and has been closed to the public until now. Fort Basinger was built on the property in 1837 during second Seminole War by Colonel Zachary Taylor. John Mizell Pearce was a soldier at that fort and returned there to establish the ranch, having been deeded 157 acres, including the site of the old fort. The original steamboat landing is at the estate. Mr. Pearce operated a ferry across the river as there was no bridge. The Estate is a place of magical beauty – a time warp of Old Florida. The house is one of the oldest houses in Highlands County.

Following the Massing of Colors by the Florida Sons of Liberty Brigade augmented by units of the Boy Scouts and the DAR, there will be a singing of the National Anthem, the Pledge of Allegiance, a reading of the American's Creed and the Preamble to the Constitution. The story and symbolism of the Liberty Tree will be told, and the Liberty Tree Poem will be recited. Proclamations from the City of Sebring and Highlands County will be presented. The program will close with a Benediction from the Florida Society SAR Chaplain.

There is no dress code but the SAR members of the color guard will conform with policies in both the FLSSAR and NSSAR Color Guard Manuals. Other participants and guests are encouraged, in the spirit of the event, to wear vintage attire or patriotic colors. For SAR Compatriots, this is considered a "National Event". It combines the previously established "Massing of Colors" event with the "Liberty Tree" event – recently added by the NSSAR Historic Sites and Celebrations Committee to the listing of National Events. Accordingly, SAR color guard members participating in this event may earn 20 Points (if using the points system) plus mileage points for qualification for the Silver Color Guard Medal.

Lawrence Gene "Larry" Fehrenbaker, Sr. MD "My First Florida Society SAR President"

To help handle the pain of loss of a significant other, one learns to vocalize or write a personal, precious memory, which provides the ultimate tribute, which only that individual can share. It helps give the grieving individual a 'since of closure' and provides an opportunity of opening a forum for others to do the same. No big words or catchy phrases needed, just a heartfelt small story will do. Therefore, I share my personal, precious memory of my First Florida Society SAR President, Lawrence G. Fehrenbacker Sr.

After joining the Sons of the American Revolution in November 2012, I, the 2015 – FLSSAR Panama City Chapter Vice President, nominated by the FLSSAR to become the Northwest Regional Vice President.

In June 2015, Lawrence G. Fehernbaker became the FLSSAR President and in the Summer Issue of the Florida Patriot, I found and read his Society President's Message, "Back to Basics". Immediately, he was addressing Chapter Development and Support, including recruitment and retention. It felt like the message was addressed to me, because the Panama City Chapter was so informal and not practicing the guidelines provided by the FLSSAR. Later, I received an email that Lawrence with his wife Jeanne would be visiting the FL Northwest Regional Chapters later in that summer. Oh Oh With the sense of urgency and within a month, I visited all six chapters within the Florida Northwest Region and learned how they were all different, but yet the same. I stand and turn toward the membership focusing on all the faces. I did not say a thing; I stood in awe, as I received such an abnormous applause. As I turned to sit back down, I looked at Lawrence's beaming proud face.

I was at home at the right place and led by a great mentor, Lawrence G. Fehrenbacker, Sr.

A blessing, a gift, or skill, it does not matter. To be able to understand and emphasis with others and to provide consultation and direction to success for those who feel slightly ill-at-ease is an attribute any leader or mentor would desire.
