

Compatriots,

We have to make a major change with the Rumbaugh Oration contest. In the past we held a live state contest at the May BOM. Last year the deadlines were close. This year national has moved their deadline up to May 19 and our BOM is 19-20. For the national competition it will once again be done from video submissions. From the ByLaw Committee - Proposed By-Law Amendments

Authority to Hold Meetings by EXCOM Members

Authority to hold EXCOM meetings by members other than the president will clarified.

Article V, Committees, Section 1, Executive Committee, second paragraph, recommended change to the first sentence: "Three members shall constitute a quorum, which may or may not include the President."

Removal of FLSSAR Officers

Article III Officers: Add a new Section 9, Removal of Officers, with the following wording. "In accordance with the Articles of Incorporation, Article VI. - Officers and Management, paragraph (C), states that "the Board of Management shall have control over all officers and committees, and for good cause may declare any office vacant." This declaration of vacancy shall include authority to remove FLSSAR elected officers for good cause.

In accordance with Article I, Section V, Special Meeting, paragraph a., the President shall call for a Special Meeting of the BOM to consider the removal any FLSSAR elected officer below the President.

For good cause, it shall be the responsibility of Senior Vice President to hold a special BOM meeting in accordance with Article I, Section V, to vote on the President's removal.

A vote of two thirds of the BOM membership will be required for removal."

Appointment to State Positions of At-Large Members

Article III, Officers, Section 3, Additional Offices, recommended change: Add sentence that states, "No person who is a memberat-large (not a member of a chapter) shall be appointed to any FLSSAR office or committee."

BOM Meetings

The ability to change the agenda of the BOM at the time of the meeting will be addressed.

Article II, The Board of Management, Section 3 Meetings, recommended change to first paragraph, as follows: "The currently elected President of the FLSSAR shall normally preside over the BOM meetings, but alternate officers are authorized to preside at these meetings if the President is unable to fulfill these duties for any reason."

Annual Elections

Article III, Officers, Section 2 Nomination and Election of Officers, paragraph C. current wording states: "Elections will be held at the Annual Meeting."

Recommended change: "Elections will be held at the Annual Meeting by those in attendance. Electronic voting and proxies are not authorized."

Appointment of State Elected Officer Positions

Current wording: "If any elected officer shall be unable to serve his full term because of a death, resignation, or disability or other cause, there shall be an appointment by the President for the unexpired portion of the term, subject to confirmation by the Executive Committee (by phone conversation, e-mail or letter, with formal confirmation at the next scheduled BOM per Article II - Section 2.F."

Recommended change: "....subject to confirmation by the majority of the Executive Committee members..."

Public Statements Regarding FLSSAR Business Matters

The process to make or release public statements regarding FLSSAR business matters will be clarified to ensure statements are

fully sanctioned

Article VIII Miscellaneous, Section 2, Authority to Speak for the FLSSAR, recommended change:

Add sentence, as follows: "Members of any FLSSAR authorized committee shall obtain approval from their respective committee chairman before releasing any report to the general membership of the FLSSAR. Due to possible legal repercussions, all reports, findings, or other written documents generated as a result of any FLSSAR committee which may adversely reflect on the organization or an officer of the FLSSAR shall be reviewed by the EXCOM for approval prior to release."

Electioneering

By-Laws do not address electioneering. Suggested change to Article III, Section 2, Nomination and Election of Officers, paragraph A. Nominations, (2) Nominations from the Floor, to the following: Add sentence, which states: "Nominations via electronic media, mass mailings, etc. in advance of the Annual meeting to the FLSSAR membership for alternate names or an alternate slate of FLSSAR officers shall not be allowed."

Schedule of BOM and Annual Meetings

Article II, Section 3, Meetings, currently states, "One meeting will occur on the day before the date fixed for the opening of the Annual Meeting of the State Society, to be known as the Spring Meeting."

Recommended change to the following: "One meeting will occur on the day before, or on the date fixed..." This will allow for flexibility in scheduling the BOM and annual meeting.

Chair Positions

Article III, Section 6, Holding Multiple Offices, currently states, " Any member except the President may be elected to, and concurrently hold, more than one, but not more than two, of the offices listed in Section 1 of this Article."

Recommended change: Add an additional sentence that states, "The currently elected President will not hold or chair any committee other than the Executive Committee."

FLSSAR Contracts

The current By-Laws require the Treasurer to hold all contracts. Over the years, the practice has evolved that the Secretary now holds contracts.

Article IV, Duties of Officers, Section 4, Secretary, paragraph g., as written, states, "Sign documents for official certification; sign checks as authorized; arrange for bonding of officers as directed by the BOM; and maintain the archives of original records of the FLSSAR; including all corporate resolutions...."

Recommended wording: "including all corporate contracts and resolutions..."

FLSSAR Assets

The By-Laws will be updated to address who will hold FLSSAR assets.

Section 12, Sergeant-at-Arms, current wording includes the following clause, "custody of the paraphernalia belonging to the FLS-SAR..."

Recommended change to include the words "other assets" after "paraphernalia."

Number of Members Needed for New Chapter

At May BOM, the topic of number of members required for a new chapter was raised. The By-Laws will state that the number of members must be a minimum of 15.

Article I, The Society, Section 2, Chapters and Regions, recommended new paragraph, as follows:

New FLSSAR state chapters may be authorized, provided a minimum of 15 existing FLSSAR members in good standing located in the area where the new chapter intends to hold meetings agree to support and participate in the new chapter. Petitions for a new chapter will include a statement that coordination with existing chapters within the region, as defined by boundary of the applicable Regional VP, has been conducted to ensure conflicts will not exist regarding community related activities, such as JROTC, etc. (updated revision)

Transfer of Members

The By-Laws will formalize the process for transferring membership from one chapter to another so that each chapter and the FLS-SAR are aware of the changes.

Article I, The Society, Section 3, Members, new paragraph c. as follows:

"c. Members may request to transfer from one FLSSAR chapter to another by submitting a written request to the current chapter Secretary. The member's current chapter Secretary will coordinate the transfer with the Secretary of the new chapter. The new chapter Secretary will ensure the transfer is noted by the FLSSAR state secretary." (updated revision)

NEW: Reference to Committees:

Current By-Laws has an error. Currently, Article V, Committees, Section 6, Other Committees, (a) 1, states "Statutory Committees are established by, and its mission statement is set forth in, the By-laws (see Article VIII - Section 3 below). However, Article VIII, Section 3 addresses Amendments.

Recommended change to (a) 1: "Statutory Committees are established by, and their mission statements are set forth in, the By-Laws (See Sections 1-5 above)." (new change)

NEW: Financial Review Committee

Article V, Section 2, Financial Review Committee wording does not mention any chairman for this committee. All other statutory committees mention a Chair, appointed by the President.

To avoid confusion, and ensure the President does not chair this committee, the following wording is submitted. Recommended change: "The President shall appoint, and name the Chairman of, a Financial Review Committee...."

Article V (Committees), Section 6 (Other Committees)

By-Laws Article V, Section 6, presently reads as follows:

Other committees, not listed in these bylaws, may become necessary or useful; or the need to modify the duties of, or eliminate, an existing committee may arise. In such case, the desired change shall be proposed for consideration by the President, the BOM, or any member of the FLSSAR, as appropriate. A proposal for a new Statutory or Standing committee or for the modification of an existing Statutory or Standing committee shall include a proposed draft of a new or revised mission statement that states the name, duties, structure, powers, method of appointment, and term of office of its members, and shall propose whether it shall be given the status statutory or standing.

Committees are described as follows:

A Statutory Committee has the following characteristics:

Statutory Committees are established by, and its mission statement is set forth in, the By-laws (see Article VIII – Section 3 below).

Statutory Committees perform functions and have powers as stated in the By-laws.

Statutory Committees remain in existence permanently, from year to year.

Members of Statutory Committees are appointed by the officer identified in their Bylaws and their terms are concurrent with that of the appointing officer unless otherwise stated in the Bylaws.

A Standing Committee has the following characteristics:

Standing Committees are established, chartered, and empowered by action of the Board of Management.

Standing Committee mission statements may be amended or revoked by action of the Board of Management.

Standing Committees perform functions. They remain in existence as long as their mission statements remain in effect.

Standing Committee mission statements designate the class of business for which the Standing Committees' mission statements have cognizance, and they grant authority to conduct business.

Members of Standing Committees are appointed by the officer identified in their mission statements. Members of Standing Committees serve for a term as stated in their mission statements.

A Special (sometimes called Ad Hoc committee) has the following characteristics:

A Special or Ad Hoc Committee is established, structured, chartered, and empowered by action of the President or of the Board of Management.

A Special or Ad Hoc Committee performs the task or tasks specified in that action.

A Special or Ad Hoc Committee remains in existence, and its members continue to serve, until the tasks shall have been completed, a report submitted and accepted, and the committee is discharge.

Changes may be made to Special or Ad Hoc Committee assignments by the empowering authority. Special or Ad Hoc Committees may be transformed into Standing Committees by the Board of Management.

Proposed Amended Article V, Section 6, revised as follows:

Other committees, not listed in these bylaws, may become necessary or useful; or the need to modify the duties of, or eliminate, an existing committee may arise. In such case, the desired change shall be proposed for consideration by the President, the BOM, or any member of the FLSSAR, as appropriate. A proposal for a new Statutory or Standing committee or for the modification of an existing Statutory or Standing committee shall include a proposed draft of a new or revised mission statement charter that states the name, duties, structure, powers, method of appointment, and term of office of its members, and shall propose whether it shall be given the status statutory or standing.

Committees are described as follows:

A Special or Ad Hoc Committee is established, structured, chartered, and empowered by action of the President or of the Board of Management.

A Special or Ad Hoc Committee performs the task or tasks specified in that action.

A Special or Ad Hoc Committee remains in existence, and its members continue to serve, until the tasks shall have been completed, a report submitted and accepted, and the committee is discharge.

Changes may be made to Special or Ad Hoc Committee assignments by the empowering authority. Special or Ad Hoc Committees may be transformed into Standing Committees by the Board of Management.

These documents have been known for years as "charters", and even though this was changed in 2021, members continue to refer to them as "charters".

Endowment Trust Fund Distribution Committee

This program year (November 1 to October 31 started off slow but really picked up at the end. We ended with 52 requests from 21 chapters for a total of \$11,383.83 sent back to chapters for their outreach programs. That compares to \$10,003 from last year but far from the \$26,000 that was available. We have this wonderful endowment fund, such a valuable resource for outreach yet chapters don't take advantage. The ETF pays for medals and awards to non-SAR members – potential SAR members. That's especially true for our youth programs. These young folks are our future. I'm glad we had 21 chapters participate but what about the other 11? Especially if you are a small chapter with not a lot in your treasury this is most valuable to you. You are reimbursed 100% for medals you present and 75% for associated expenses like meals for those awardees and their families.

At the last BOM we greatly increased the awards. You now can submit 5 requests at \$500 each for a total of \$2,500. Why pass that opportunity up? The new form and amounts will be on the state website and you can start making your requests January 1. We will be so glad to see them!

I would like to thank my committee – they approve all the requests – Jim Gaskins, Lee Matson, Jeff Sizemore, Ben Tidwell and Ray Wess for helping with this effort.

The Battle of Eutaw Springs

The *Battle of Eutaw Springs* was the last major engagement of the war in the Carolinas. Both sides claimed victory.

After a month-long siege and a fierce battle at the British controlled village of Ninety-Six, Major General Nathanael Greene, commander of the Southern forces in the Continental Army, became aware that British reinforcements were headed his way.

Greene retreated for several days towards Charlotte, North Carolina. Finally, after his pursuit by the British was abandoned, Greene moved his forces to a campsite on the High Hills of the Santee.

Here Greene allowed his exhausted troops to rest and awaited reinforcements. On 23 August, Greene moved his forces to cross the Wateree River, then the Congaree River, to Fort Motte and on to Burdell's Plantation in the vicinity of today's Vance, South Carolina.

Meanwhile, on 13 August, British Colonel Stewart led his force of 2000 to 2300 men from Orangeburg, South Carolina to Thompson's Plantation south of the Congaree River. He then fell back to Eutaw Springs on 27 August. On 08 September 1781, Greene's army of 2400 men began marching the 7 miles towards Eutaw Springs. Greene had infantry, cavalry, Continental troops, and militia as well as two 3-pound grasshopper guns and two 6-pound cannons. 200 of his men were left behind to guard the baggage train. Stewart also had infantry and cavalry, comprised of both British regulars and American loyalist contingents at his disposal as well as two 6 pound, one 4 pound and one 3-pound cannons as well as a swivel gun. His total troops on hand were between 1800 and 2000.

Around 8:00 AM Captain John Coffin and a detachment of South Carolina Loyalist cavalry were out foraging for supplies for Stewarts army. They encountered a mounted American scouting party under the command of Major John Armstrong. Coffin pursued Armstrong, who led him into an ambush. Coffin escaped but 4 or 5 of his men were killed and 40 captured, Armstrong's men then came across the foragers and captured 400 more British troops.

On an intensely hot morning Greene's forces advanced towards Eutaw Springs. At their approach, the surprised British left their uneaten breakfast and quickly threw lines of battle across the road in a heavily wooded area. A large brick home with a high walled garden and cleared fields stood behind them.

The waters and wood of Eutaw Springs were on the north. At first the center of the American line caved in. While opposing flanks were fighting their own battles, Greene restored the center with North Carolina continentals. The British line began to give, but Stewart quickly pulled up his left flank reserves.

The Americans were forced to retreat under thunderous fire. Greene then countered with Maryland, Virginia and Delaware Continentals and South Carolina cavalry, with devastating effect. The British fled in every direction and the Americans took over their camp. Colonel Stewart gathered

some of his men and took refuge in the brick home. From this vantage they "picked off" many American officers and men.

Feeling the battle was won, the tired, thirsty, hungry and ill clad Americans began plundering the British stores of food, liquors and equipment. Thoroughly enjoying themselves they ignored



their leaders' warnings and commands. The British, recognizing the disorder, were able to gather and mount an attack on the Americans.

The stunned Americans fought bravely but were put to flight from the British camp. After more than 4 hours of vicious battle, both armies had had enough. Casualties were extremely high. Greene collected his wounded and returned to Burdell's Plantation. Stewart remained in Eutaw Springs for the night.

09 September brought rain, which prevented a continuation of the battle. Stewart buried his dead, destroyed supplies and retreated towards Charleston. He left behind many dead unburied and 70 of his most seriously wounded. Greene pursued Stewart until 11 September, when he drew within range of British support from the garrison at Charleston.

Stewart's letter to his commander stated that he was attacked by the rebel Greene and all the forces he could muster, totally defeated him and took two 6 pounders. Greene's letter to Washington stated that he engaged in one of the most obstinate fights ever. "Victory was ours, and had it not been for one of those little incidents which frequently happen in the progress of war, we should have taken the whole British Army."

This last major battle in South Carolina completely broke the British hold in the south and denied needed aid to the British forces in the north. The British attempt to pacify the south with Loyalist support, had failed.

Despite winning a tactical victory, the British had lost the strategic battle. They were forced to abandon most of their conquests in the south, leading up to the surrender of Cornwallis at Yorktown.

Rest of the Story...My Patriot Ancestor, James Lanman, fought at the Battle of Eutaw Springs as a colonial regular where he was wounded.
