Battle of Thomas Creek Update

The 247th Anniversary of the Revolutionary War Battle of Thomas Creek (The Southmost Battle of the American Revolutionist War) was held on March 23, 2024. This ceremony is normally held at the battle location of Seaton Creek Historic Park in Jacksonville. However, due to a forecast of heavy rains at the park the location was changed to a large airport hotel meeting room.

Even though we thought the turnout would be low due to bad weather, we again had over 100 in attendance. For this National Color Guard Event, we were honored to have our National Color Guard Commander Scott Collins, who organized a large color guard of SAR compatriots and C.A.R members in presenting the colors. Greetings were given by the City of Jacksonville, NSSAR from VPG James Wyrosdick, Florida State President, Steve Fields and Georgia State President Ed. Rigel, Jr.. Greetings were given by FSSDAR Vice Regent Kim Zeman, N.E. Regents Council, President Betty Reed and by FSSC.A.R. State President Sydney Wagnstrom. Compatriot Dr. Roger Smith again gave us an enthusiastic presentation on why General George Washington wanted to make N.E. Florida our 14th Colony. All the attendees enjoyed the ceremony honoring our Patriots who fought and died in this second of three failed attempts ordered by General George Washington to make N.E. Florida our 14th Colony.

We are looking forward to next years Thomas Creek Ceremony to be held at Seaton Creek Historic Preservation Park on Saturday 29 March 2025 as we march towards our Nations 250^{th} Anniversary.

Proposed Changes to the Standing Rules and Procedures.

The FLSSAR Executive Committee plans to present the following proposed changes to the Standing Rules and Procedures at the Fall 2024 BOM meeting.

Section 100 (Members)

Section 100, Regular Members, presently reads as follows:

A Regular Member is age 18 or older who pays annual dues. Only regular members may vote and hold office in the SAR and receive the Patriot Magazine for free.

Proposed Amended Section 100, Regular Members, revised as follows:

A Regular Member is age 18 or older who pays annual dues. **All members, except Juniors, may vote at the Annual Meeting** and hold office in the SAR-and receive the Patriot Magazine for free.

Justification:

The original text implies that Life, Active Duty, and Dual members cannot vote, and that is not the case. All members can vote only at the Annual Meeting. BOM meeting voting is restricted to BOM Members. The Patriot Magazine is no longer provided for free, except in electronic format.

Section 100, Dual Members, presently reads as follows:

A member in good standing may transfer to any other state society, subject to the acceptance of that body.

Transfer forms are available from state societies, National Headquarters, or the NSSAR web site. The Transfer form is sent to National Headquarters for registration once it is signed by the secretary of the state society of current affiliation and the secretary of the state society to which transfer is desired.

Proposed Amended Section 100, Dual Members, revised as follows:

Move to Section 100, Regular Members.

Justification:

This does not only apply to Dual members.

Section 100, Dual Members, presently reads as follows:

A member whose primary membership is in one state, and his current dues have been paid, and wishes to apply for dual membership in the Florida Society shall complete the upper half of form and send to the Treasurer of the Chapter with whom he will affiliate in Florida with a check for State dues, and the prevailing Chapter dues. The chapter secretary sends the form and two checks to the FLSSAR Secretary. Refer to the <u>NSSAR website</u> for current forms and fee schedules.

Proposed Amended Section 100, Dual Members, revised as follows:

A member whose primary membership is in one state, and his current dues have been paid, and wishes to apply for dual membership in the Florida Society shall complete the upper half of form and send to the Treasurer of the Chapter with whom he will affiliate in Florida with a check payment for State dues, and the prevailing Chapter dues. The chapter secretary sends the form and two checks payment for State dues to the FLSSAR Secretary. Refer to the NSSAR website for current forms and fee schedules.

Justification:

The method of payment need not be specified.

Section 105 (Regional Vice President)

Section 105, A.7, presently reads as follows:

Submit Quarterly reports to the BOM describing RVP visitations and service to Chapters – as well as information about chapter activities.

Proposed Amended Section 105, A.7, revised as follows:

Prior to each BOM Meeting, submit Quarterly reports to the BOM describing RVP visitations and service to Chapters – as well as information about chapter activities.

Justification:

BOM Meetings are no longer held quarterly.

Section 105, B.7, presently reads as follows:

Upon election to office at the Annual Meeting of the State Society, the State Secretary will provide each RVP with...

7. A supply of up-to-date FLSSAR letterhead and envelopes or templates.

Proposed Amended Section 105, B.7, revised as follows:

Remove from Section 105 (RVP), B.7 and from Section 106 (Secretary), j.7

Justification:

We no longer send letters.

Section 107 (Treasurer)

Section 107, 7, presently reads (in part) as follows:

7. Maintain a record of the name, location, and custodian of, and custody receipts for, items of furniture, office equipment, flags, amplifying and/or recording equipment, and other such property items owned by the FLSSAR including inventory of library books and documents.

Proposed Amended Section 107, 7, revised as follows:

Remove this item.

Justification:

This is a duty of the Sergeant-at-Arms, not the Treasurer.

Section 110 (Registrar)

Section 110, 1, presently reads (in part) as follows:

The Secretary shall keep a Register of the names and dates of election, transfer, resignation and death of all active members.

Proposed Amended Section 110, 1, revised as follows:

Move this sentence to Section 106 (Secretary).

Justification:

This is a duty of the Secretary, not the Registrar.

Section 122 (Vice President General South Atlantic District)

Section 122, presently reads (in part) as follows:

Once each four year period, the FLSSAR shall nominate a qualified member of the FLSSAR to the Annual South Atlantic District Meeting to be the nominee to the NSSAR for Vice President General of the South Atlantic District.

Proposed Amended Section 122, revised as follows:

Once each four year period, the FLSSAR Board of Managers shall nominate a qualified member of the FLSSAR to the Annual South Atlantic District Meeting to be the nominee to the NSSAR for Vice President General of the South Atlantic District. The nominee will be selected at the BOM meeting just prior to the Annual South Atlantic District Meeting.

Justification:

We've been doing this at our Annual Meeting. But usually the Annual South Atlantic District Meeting occurs before our Annual Meeting.

Section 123 (Fund Management)

Section 123, Endowment Trust Fund, presently reads (in part) as follows:

Tax deductible contributions may be sent to the FLSSAR Treasurer by individuals, chapters, etc. for transmittal to the Board of Trustees of the Florida Society Endowment Trust Fund. \$1.00 is contributed from the State dues each year for this fund, paid after the Annual Report is submitted to National.

Proposed Amended Section 123, Endowment Trust Fund, revised as follows:

Tax deductible contributions may be sent to the FLSSAR Treasurer by individuals, chapters, etc. for transmittal to the Board of Trustees of the Florida Society Endowment Trust Fund. \$1.00 is contributed from the State dues each year for this fund, paid after the Annual Report is submitted to National.

Justification:

The Board of Managers voted to discontinue this practice at the Fall 2023 BOM Meeting.

Section 500 (Rules of Protocol)

Section 500, Requests for Visits By the President General, presently reads as follows:

Please refer to NSSAR Official Handbook Volume II: History, Organization and Protocol and follow the section "Requests for visits by the President General."

Proposed Amended Section 500, Requests for Visits By the President General, revised as follows:

Please refer to NSSAR Official Handbook Volume **on Protocol** H: History, Organization and Protocol and follow the section "Requests for visits by the President General."

Justification:

This section is now in Volume IV. It could change at any Congress, so just leave it out.

Section 500, Wearing Medals, presently reads as follows:

The NSSAR Color Guard in July 2011 voted to allow the State Color Guard Commander to have the authority to allow or disallow the wearing of medals by Color Guard members in his Brigade. The Color Guard Commander in charge makes the final decision on the permission to wear medals on the Color Guard uniform during SAR internal events such as chapter, state and national meetings where the general public is not present. Therefore the Color Guard Commander makes that decision for all state meetings where the general public is not present. His decision for the color guard will also be in effect for other compatriots in uniform at all state meetings. Color Guard Commander Phillip H. Tarpley in August 2011 with the members support ruled FLSSAR Color Guardsmen could wear their medals (no miniature's) if desired under guidelines set forth by NSSAR policy. The members are to follow NSSAR protocol for placement of medals.

Proposed Amended Section 500, Wearing Medals, revised as follows:

1. Rename heading to "Color Guard Wearing Medals"

Justification:

This section only refers to the wearing of medals by color guard members.

2.

The NSSAR Color Guard in July 2011 voted to allow the State Color Guard Commander to have the authority to allow or disallow the wearing of medals by Color Guard members in his Brigade. The Color Guard Commander in charge makes the final decision on the permission to wear medals on the Color Guard uniform during SAR internal events such as chapter, state and national meetings where the general public is not present. Therefore the Color Guard Commander makes that decision for all state meetings where the general public is not present. His decision for the color guard will also be in effect for other compatriots in uniform at all state meetings. Color Guard Commander Phillip H. Tarpley in August 2011 with the members support ruled FLSSAR Color Guardsmen could wear their medals (no miniature's) if desired under guidelines set forth by NSSAR policy. The members are to follow NSSAR protocol for placement of medals.

Justification:

While that may have been the policy at that time, it is no longer the case. As it notes, this is a decision for each Color Guard Commander, so it should not be specified here.

Section 502 (Registration and Hospitality Room)

Section 502, A.1, Regular or Special BOM Weekend, presently reads as follows:

The registration desk personnel have the responsibility of providing the BOM Proceedings (Blue Book), meal tickets, table signup sheets, meeting schedule, and any other informational items.

Proposed Amended Section 502, A.1, Regular or Special BOM Weekend, revised as follows:

The registration desk personnel have the responsibility of providing the BOM Proceedings (Blue Book), meal tickets, table signup sheets, meeting schedule, and any other informational items.

Justification:

This is no longer the "Blue Book".



Caloosa Chapter



The May 15th Caloosa Chapter Meeting was another "hit" in this year's series and focused on the success that the JROTC Programs have had in the Lee County Schools. Our Caloosa Chapter SAR Compatriot, Major General James L. Dozier USA (Ret.), and Col. Rodney "Scott" Robinson USA (Ret.), were on hand at our May 15th meeting to proudly accept our Chapter's \$2,000 cash donation to the JROTC Support Fund which General Dozier established, and which is named after him.

Those in attendance were treated to a powerpoint presentation made by Col. Scott Robinson, currently the Director of Army Instruction, Lee County,



Florida, schools.

According to Col. Robinson, JROTC offers a nationally accredited curriculum, which teaches leadership, team-building, decision-making, learning styles, emotional control, conflict resolution, financial awareness, first aid, US History, community service, personal wellness and much more. What was especially interesting was the 5-year plan that Col, Robinson explained every cadet formulates going into high school. The fact that it is a 5-year plan means that it includes the cadet's plan for what he or she will be doing the year following graduation from high school. A plan that is carefully monitored and discussed with the cadets year to year, until graduation.

All of the Lee County High Schools offer JROTC programs, and while the curriculum is standardized, each program has unique extracurricular offerings like academic and leadership bowl, robotics, drones and aviation/flying clubs and marksmanship. JROTC cadets regularly compete in state and national contests like Robotics, Raider Challenge, Cyber Patriot Games, etc. Cadets also have the opportunity to attend STEM camp at FGCU and Adventure Camp at Camp Tanah Keeta. Instructors also take cadets to visit Fort Myers Technical College, the University of Tampa, FIU, and USF.

Some of the basic statistics that Col. Robinson shared with us were truly amazing. For example, we were told that nearly 8,000 high school students are currently enrolled in the JROTC programs in Lee County! Last school year, the cadets contributed a total of 50,000 + hours of Community Service, and over \$7 million in scholarships were achieved by the 2024 JROTC graduates. Even better, Lee County JROTC cadets had a 98.9% high school graduation rate, with 53% choosing to go on to attend college, and 19% selecting vocational technical schools. In addition, many enlist in the military.

He concluded his presentation by asking for our support in the form of cash donations to provide for more programs and scholarships.

The Joseph S. Rumbaugh Historical Oration Contest is open to all students attending 9th through 12th grades in public, parochial or private schools, or home-school students studying at the same grade levels. Jones is a senior in high school, will be graduating in a few days, and will be attending New College of Florida this coming Fall. He plans to concentrate his studies in English Literature with the hopes of becoming a Professor in the future.

The grandson of our Compatriot, Tom Gillaspie, and a young patriot in his own right, Jones learned that the rules of the contest required him to write an original oration of not less than 5 minutes, or more than 6 minutes. The oration must be delivered from memory, and without the use of notes or any kind of props. The subject of the oration must deal with an event, a personality, or a document pertaining to the Revolutionary War with a mention of our nation's 250th anniversary celebration. The contest rules further state that: "It is essential that each oration show the relationship it bears to America today. Evidence of historical research and creative presentation are also important. The oration will be judged based upon its composition, delivery, significance, historical accuracy, and relevance to our 250th anniversary." He chose "Courage at Lexington and Concord" as the topic of his oration, did his research, and obviously "rang the bell" in winning First Place at the Florida State SAR level.


Announcement of the Sgt. Mose Adams Memorial Middle School Brochure Contest Winner 2024

Eliza Hamilton: The Strong Woman Behind

"Behind every strong man, there is an even stronger woman." When examining history, it is important to keep this saying in mind, as the prominent role women often play in the lives and destinies of the men they support is frequently overlooked. However, when we delve into the stories of these powerful women who were once underrated, we can see how influential their stories really are. Eliza Schuyler Hamilton is one of these women; she played a crucial and influential role in the American Revolution. While the historical narrative often focuses on the work her husband, Alexander Hamilton, did for the United States financial system, Eliza's impact was deep and profound, extending far beyond that of the battle and into the very substance of the young United States. Her life, achievements, and how she conducted her day-to-day life embodies a character and patriotism that can be used as a timeless example of a true American woman.

Throughout her life, Eliza was known for her inherent good nature and her strong Christian faith. She and Alexander met in February 1780, and they were married on December 14 of that same year. She had eight children of her own and adopted the orphaned daughter of a friend for ten years ("Elizabeth..."). Reports on Eliza's family life show that she was highly dedicated to the upbringing of her children. She ensured they all had a religious upbringing, and an associate of Alexander's even said that she "has as much merit as your treasurer as you have as treasurer of the wealth of the United States." Eliza often helped her husband in his work, too, "counsel [ing] him in his affairs and [keeping] his papers in order for him" (Turner).

However, this strong love for her family did not prevent hardships from finding their way into Eliza's life. She suffered tremendous losses over the span of three years, from losing first her younger sister Peggy to illness in 1801, her son Philip and her husband in duels, and finally, her father in 1804. After these deaths, the burden of Alexander's debts fell to her. She initially lost the Grange-their home in Upper Manhattan-to creditors. Still, she was able to pull together enough money to repurchase it, which demonstrated the very resourcefulness that got her family through such hard times. Her son James remarked that she was "a skillful house-wife, expert at making sweetmeats and pastry; she made the undergarments for her children, was a great economist and most excellent manager" (Long). Although she accumulated some inheritance money after her father's passing, she lived in "relative poverty" during her time as a widow (Turner).

Even though Eliza "had to use both strength and ingenuity to keep her remaining family afloat" after her losses, she didn't wallow in her sorrow. Instead, she threw herself publicly into charity work ("Elizabeth..."). Much of her charity work was inspired by her strong Christian faith, which was always a vital part of her life. She, along with two other women, founded the first private orphanage in New York. Eliza served as the second directress until 1821 and then as the first directress until 1848. She raised funds, collected and donated goods, and supervised the education and care of at least 765 children (Long). Regarding her charity work, she remarked, "My Maker has pointed out this duty to me, and has given me the skill and inclination to perform it" (Long). Anyone else might have been broken by the repetitive tragedy Eliza faced, but her ability to step out and pour herself so freely into her altruistic work shows true

selflessness and an ability to put others' needs above her own.

Eliza also went on a very lengthy campaign to ensure Alexander got the recognition she was sure he deserved. She spent nearly fifty years after his death defending his name and making sense of all his papers (Presnell). She wanted to highlight his Federalist legacy further and spent numerous hours collecting his writings for publication. Eliza also sent questionnaires to many of Alexander's former colleagues to validate details in his letters (Long). Without all of Elzia's work, Alexander's impressive legacy --and the extremely popular musical about it-- would be impossible to even fathom.

Several other significant historical figures noticed her impact. In 1842, President Polk remarked "at a dinner for about 40 guests... that "Mrs. General Hamilton, upon whom I waited at table, is a very remarkable person. She retains her intellect and memory perfectly, and my conversation with her was highly interesting" (Long). Because of Alexander's relationship with George Washington, Eliza and Martha Washington were also very close, and because of this, she became a very well-known faith in both New York and Philadelphia (Turner).

Despite her many hardships and dealing with devastating losses, Eliza Hamilton lived a life reminiscent of the very values our great country was founded on. Her dedication to her family and country, selflessness, faith, and perseverance embody the very definition of what it means to be an American and show that while Alexander was a very strong man, Eliza was the even stronger woman behind him.

Compatriots with the 2024-2025 school year starting to get underway, it would be a great time to engage with your local school systems to get involved with the many Youth Award Programs that we offer through the SAR. While I understand from some of our experiences some of the local school systems have been reluctant to get involved with our different programs. I would suggest that there are a couple of other avenues that we could explore to get the word out about our Youth Awards Programs and give the students an oppor-

tunity to participate. If your chapters are involved with your local DAR Chapters, Scouting Programs or other civic organizations, they offer us a great opportunity to introduce our Youth Awards Programs to both parents and students. I would also recommend looking into the local Home School Programs that are being offered within many of our communities. Most of the entries in all of our Youth Awards Programs this past year came from students that were being home schooled. In fact most of our State winners this year were home schooled students.

The 2025 Knight Essay Contest is currently underway with a deadline date of 31 December 2024 for the Chapter winners to be submitted to the FLSSAR State Chairman. Chapters need to establish their own particular deadline in order to complete the Chapter portion of this contest and then submit their winning essay to the State Committee Chairman prior to the 31 December deadline. All essays need to submitted through the closet FLSSAR Chapter to their location (Chapter locations and points of contact can be found on the FLSSAR website at flssar.org)

To participate students must submit an original 800 to 1,200 word essay based on an event, person, philosophy or idea associated with the American Revolution, Declaration of Independence, or the framing of the United States Constitution. The essays will be judged based upon its historical accuracy, clarity, organization, grammar, spelling and documentation.

The Chapter's winning essay must be submitted in five parts in the formats indicated as follows: 1. the Application (PDF); 2. the Bibliography (Word); 3. The Biography (Word); 4. The Essay (Word); 5. The Title Page (Word). This will allow the judges to finalize their evaluations of the essay; make any minor corrections as necessary; and submit our State winner to the national NSSAR committee by their February 2025 deadline. FLSSAR prizes for the 2025 contest are \$1,000/\$500/\$250. The NSSAR prizes presented at NSSAR Congress this year are 1st - \$6,000; 2nd - \$3,000; 3rd - \$2,000; 4th - \$500; and 5th - \$500. The Battle and Siege of Pensacola in the American Revolutionary War

Pensacola is nicknamed "The City of Five Flags" because multiple nations have at one time governed it, including Spain, France, Great Britain, the U.S.A., and the Confederate States of America. It is known as being the home of the excellent Navy's Blue Angels Flight Demonstration Team and certainly for more than hurricanes and the 1978 location where infamous serial killer Ted Bundy was arrested. Pensacola has a valuable and rich history, including a significant contribution to America's independence in the Revolutionary War.


The above oil painting by Augusto Ferrer-Dalmau depicts General Bernardo de Galvez at the Battle of Pensacola. This 1781 Battle was a major part of Spain's aggressive military campaign to seize Pensacola and the nearby Gulf Coast area from Great Britain, during the American Revolutionary War. The battle secured the southern route for supplies and closed off the possibility of any British offensive through the western frontier of the United States via the Mississippi River. General Galvez and a Spanish naval force of more than 40 ships and initially 3,500 men landed at Santa Rosa Island (near Pensacola in present day Florida) and began a two-month siege of British occupying forces.

The Longest Siege of the American Revolution - Some historians call the Battle of Pensacola the "Longest Battle" and others call it the "Longest Siege" of the American Revolution. Wesley Odom's book title calls it "The Longest Siege of the American Revolution: Pensacola." Also, author Joshua Provan calls it the "longest siege of the American War for Independence." The Battle of Pensacola was fought between the British and Spanish forces in 1781 and was indeed a significant "siege" and "battle" for America's independence.

A siege is a military tactical operation in which forces surround a town, building, or group of troops, cutting off essential supplies, with the aim of forcing a surrender.



General Campbell's British troops at Fort George in Pensacola could not be re-supplied, were surrounded, and surrendered.



A battle is a prolonged military combat engagement that is well defined in force commitment, weapons, area, and duration.

Over 7,000 Spanish troops and a fleet of 40 ships attacked British forces in Pensacola and the surrounding Bay, prepared trenches and batteries, and engaged them over a 61-day period.

It was the final "Battle" for the British in their conflict against Spanish forces for control of the provincial colony of West Florida. The Pensacola Siege lasted 9 weeks from March 9 to May 10, 1781 or 63 days, including official surrender and control by the Spanish. Other American Revolution "Sieges" include the Fort Ticonderoga Siege of 5 days, the Fort Henry Siege of 6 days, the Yorktown Siege of 3 weeks, and the Charleston Siege of 45 days.


In 1779 after Spain (and France) entered the Revolution on the side of the American Colonists, British General John Campbell raised the white flag of surrender on May 8th, 1781, since he was no longer capable of defending Fort George from Spanish artillery. A grenade from a Spanish howitzer exploded the powder magazine at the Queen's Redoubt, completely destroying the structure. Pensacola officially came under control of the Spanish on May 10th, 1781.

NOTE: A Redoubt is a small, usually temporary, enclosed defensive stronghold or weapons storage area and is usually found outside a larger Fort or military base.

British West Florida - The British divided the Gulf Coast Northwest area into two new colonies in 1763 separated by the Apalachicola River. British West Florida was a region on the northern coast of the Gulf of Mexico that included the part of formerly Spanish Florida, which lay west of the Apalachicola River near Tallahassee, as well as parts of formerly French Louisiana. Its government was based in Pensacola. The British West Florida colony included about two thirds of what is now the Florida Panhandle, as well as parts of the modern-day U.S. states of Louisiana, Mississippi, and Alabama.

British East Florida - The second colony was British East Florida, starting eastward from Tallahassee, and it was given to Spain in the final peace treaty with Britain in exchange for the Bahamas, leaving Spain in control of all of the Floridas. Both West and East Florida remained loyal to the British crown during the American Revolution, and served as havens for Tories fleeing

from the Thirteen Colonies.

Spain and America Shared A Common Enemy - Though Spain never signed an official agreement to fight alongside the United States, the two had a common enemy... Britain, long a Spanish rival... and a common friend, France, with whom both would form their own alliance.

Spain declared war on Britain in 1779, but not solely out of altruism to the American cause. Spain's goals were related to self-interest and strategic in nature. Spanish King Carlos III wanted to recover key positions in the Mediterranean lost to Britain earlier in the century, including Gibraltar, on the Spanish coast, and the island of Minorca. Preserving Spanish access to the Gulf of Mexico and Central America was also vital for Spain. Pensacola was a strategic location and chokepoint.

American Volunteers Joined with Spanish Troops to Fight the British - Don Bernardo de Galvez gathered a force of Spanish Army regulars, local militia, free Black soldiers, and a few American volunteers to first hit the British Fort at Baton Rouge (Louisiana) in September 1779. Galvez then led multinational troops from New Orleans taking back Forts from Great Britain along the Gulf Coast, including Natchez and Mobile. With help from the Spanish Navy from Cuba, Galvez engaged the British in Mobile (Alabama) in 1780. Then on March 18, 1781 as Commanding General of Spain's Army and Naval Forces at the young age of 35, Galvez led the Naval charge into Pensacola Bay to begin the Siege of Pensacola with the Spanish regulars and militia and 25 American volunteers. As a result, the Territory of British West Florida was ceded to Spain in 1783.

Galvez Received Many Accolades at a Young Age - At age 29 in 1776, Galvez was promoted to Colonel in the Spanish Army. King Carlos III of Spain appointed him Colonial Governor of Spanish Louisiana and gave him the title of Count of Galvez on January 1, 1777 at the age of 30. At age 33 in 1779, he was selected for Brigadier General and Field Marshall for Spanish Troops. Then he was promoted to Lieutenant General for all Spanish Army and Navy Forces and Governor of Cuba in 1783 at age 37. Galvez died in 1786 at the age of 40 from Typhus in Mexico City. There is a Galvez Street in New Orleans named for him, a large inscribed Statute of him on horseback in Pensacola, FL with several S.A.R., D.A.R., and Heritage Foundation plaques, and a Mobile, Alabama statute of him in Spanish Plaza.

Pensacola is regarded as his greatest victory by defeating the British. And it earned him a Royal Patent adding the words "Yo Solo" (I Alone) to his Coat of Arms. General Galvez was named a "Great Floridian" in 2012 and in 2015, Congress posthumously awarded him "Honorary Citizen of the U.S.A."

Spain Gives East and West Florida to the United States - After lengthy negotiations, the Treaty of Adams-Onis was signed on February 22, 1819, whereby Spain gave East and West Florida to the United States. Luis de Onis was the Spanish Minister to the U.S. and John Quincy Adams was U.S. Secretary of State. Spain received no compensation and the U.S. agreed to assume liability for \$5 million in damages done by American citizens who rebelled against Spain. The Adams-Onis Treaty of 1819 was also called the

NOTE: While under British control as colonies of the Kingdom of Great Britain until the Peace Treaty of 1783, East Florida and West Florida remained loyal to the British Crown during the American Revolution, so they did not join the revolutionaries in their fight for independence.

Transcontinental Treaty and it was ratified in 1821.



FROM INTERSTATE 4 WEST - (from Tampa): From I-4, take exit #67 (SR 536/Epcot). At the bottom of the ramp, turn right and

continue on SR536 approximately 2 miles to SR535. Turn right at this traffic light and go almost 2 miles and turn right onto Kyngs Heath Rd at traffic light. The hotel is on the corner of SR535 & Kyngs Heath Rd.

FROM INTERSTATE 4 EAST - (from Daytona Beach and downtown Orlando): From I-4, take exit #68 (SR535). Turn left from the ramp traffic light & head to Kissimmee. Upon going about 3.5 miles, turn right onto Kyngs Heath Rd at traffic light. The hotel is on the right.

FROM THE FLORIDA TURNPIKE, NORTH OR SOUTH: From the Florida Turnpike, take exit #249 (Osceola Parkway Exit), Head west upon getting on Osceola Parkway. Upon going across the Shingle Creek bridge after the toll booth, the next exit is SR535. Turn left onto SR535, and go to the next traffic light (Kyngs Heath Rd) and turn right. The hotel is on the right.

FROM MELBOURNE ON US192: From I-95, head west on US192 and go roughly 54 miles. Then turn right at the SR535 traffic light. At the next traffic light on SR535, turn left onto Kyngs Heath Rd. The hotel is on the right.
