The first portion of my year as President has certainly been interesting. In July, Congress was cancelled for the second time in the history of the SAR. Fall Leadership, scheduled for September 23-27 was also cancelled. But the work of the SAR continued, albeit in different formats.

I was fortunate last year to become a member of the NSSAR's Council of State Presidents. This summer PG Manning appointed me to three national committees: the Education Committee, the Strategic Planning Committee, and the Officer Training Committee.

In lieu of the cancelled Fall Leadership meeting, NSSAR committees have been meeting via videoconferences. On Friday September 11, the SAR Strategic Planning Committee met using GoToMeeting. (FLSSAR 2019-2020 President Lee Popham chairs this important national committee.) On Tuesday September 8, the SAR Education met via Zoom. The Council of State Presidents met on Saturday September 22, also via Zoom. (The Council includes the SVP, President, and immediate past President from every Society. It was a large group on the call, but it was orderly and well run.)

One of the very few "in person" events available this summer was an outdoor meeting of the St. Augustine Chapter. Aside from their regular business, they celebrated Chancellor (and former PG) Carl Hoffman's 70<sup>th</sup> year as an SAR member. SEVENTY YEARS. The SAR doesn't make a pin to commemorate membership of that length, so the chapter had one made.

The FLSSAR Executive Committee held several meetings, including on July 21<sup>st</sup> and July 9<sup>th</sup>.

On July 4<sup>th</sup>, The Villages Chapter held an outdoor meeting to celebrate the birth of our country. I read the Declaration of Independence to those gathered. Surprisingly, two fellow SAR members told me that was the first time they had heard or read the Declaration. I intend to make the reading a tradition at our chapter.

On June 28<sup>th</sup>, VPG Greenly held a South Atlantic District call for state presidents from North Carolina, South Carolina, Georgia and Florida.

Saturday June 20<sup>th</sup> was the commemoration of the Battle of Ramsour's Mill. I participated virtually since the on-site commemoration was cancelled. Quite a bit of effort has gone into the Handbook and it will continue to be a resource for the planning efforts by the state committee as we move forward. Expect several iterations of the resource from time to time. Fundraising continues to be of primary importance in the early stages so that we may fulfill our financial obligations to the Congress. We have made available (so far) Congress Medals (see insert 1) that you can purchase for \$40.00 per set (standard size and miniature). Shipping is in addition. There is also a chance to win a Charleville musket for \$20.00 per ticket or six for \$100.00. The musket is a firing reproduction of the finest manufacture and comes with a bayonet. No more than 300 tickets will be sold and when that occurs, there will be a drawing to present the musket to the fortunate ticket holder.

The Ladies Auxiliary also has certain financial responsibilities at the Congress which are outlined in the Handout. They have designed an attractive throw that they sell for \$70.00 (see insert 2). It is a popular item as they have sold out the first run and are now selling those from a second production. They are large enough to use as a comforter for cool nights or lay across a sofa or bed and display an SAR Minuteman logo.

I shall be in the Orlando area later to scout out a site for the Host Reception and potential tour destinations. Delores and I will also investigate venues for the Ladies Tea and possible locales for the First Lady's Luncheon. Shortly, we should be viewing a website that is specifically designed and earmarked for planning and managing the committee effort to effect a wonderful experience for the Society. Coordination efforts are underway.

We have not yet collected the 2023 Congress Member Assessment for 2019 from all chapters. They will be sent a reminder before the BOM.

**The Public Service and Heroism Committee (PS&H)** recognizes and honors citizens and individuals in our public service sectors of Law Enforcement, Fire Safety, and Emergency Medical Services for their contributions to the community and for heroic acts with Commendation and Heroism Medal; states, chapters, and commendation recipients are recognized in a booklet published and distributed at the National Congress each July.

The State-level PS&H Committee exists to publicize the committee's function to the states, local chapters and to encourage their participation. Awards presented are reported to the National-level PS&H Committee and the State-level society by filing out an on-line form.

**All commendations should be reported prior to June 1**, to ensure inclusion in the PS&H Committee Commendation Booklet for distribution at the July NSSAR Congress. The fillable online Public Service and Heroism Report Form, PDF forms may be found on the NSSAR website.

**The Law Enforcement Commendation Certificate and Medal** is presented to those who have served with distinction and devotion in the field of law enforcement. The medal is intended to recognize exceptional service or accomplishment in the field of law enforcement. Eligibility is not limited to peace officers but extend to the entire range of persons, who make and enforce the law. This includes peace officers, attorneys, judges, prosecutors and legislators, who have performed an exceptional act or service beyond that normally expected. The recipients are usually recommended by their superiors or peers for their accomplishments. The award may be presented posthumously. The medal may be presented to an individual only once; no oak leaf clusters of ribbon attachments are permitted.

**The Fire Safety Commendation Certificate and Medal** is presented to an individual for accomplishments and/or outstanding contributions in an area of fire safety and service. The award is not limited to firefighters, It may be presented to recognize a variety of fire safety and services that have evolved into a highly technical and skilled profession with constant study, development and involvement by numerous dedicated citizens with a single goal, which is to protecting human life and property by preventing injuries or casualties due to fire and chemicals. The medal maybe presented posthumously. The medal maybe presented to an individual only once. Oak leaf clusters or other ribbon attachment are not authorized.

**The Emergency Medical Services Commendation Certificate and Medal** is presented to an individual for accomplishments and/or outstanding contributions in the area of emergency medical services. The award is

intended for paramedics, certified emergency Medical technicians and others in the emergency medical field who have performed an act or service beyond which is normally expected. The medal may be presented posthumously. The medal may be presented to an individual only once, and no Oak Leaf clusters or ribbon attachments are permitted.

**A Heroism Commendation Certificate and Medal** recognizes outstanding bravery and self-sacrifice in the face of imminent danger – i.e., acts which involve great personal courage and risk to the recipient. The medal is intended primarily for acts by civilians, not in uniform, but does not exclude police, firemen, EMS or SAR members. It is not intended to recognize acts that would have been covered in the performance of one's normal duties nor by medals for valor by the armed forces. Animals are not eligible for recognition. The medal may also be presented posthumously. An individual may receive this medal multiple times. Presentation and wearing of Oak Leaf clusters shall follow NSSAR policy.

**The SAR Life Saving Medal** is presented to those individuals who have acted to save a human life without necessarily placing their own life or themselves in imminent danger. The medal is intended primarily for acts by civilians not in uniform, however, police officers, fire fighters, emergency medical personal, lifeguard, and SAR compatriots are not excluded from receiving this award. The medal is not intended to recognize acts that would otherwise qualify for military or another organization's valor and, in all cases, the fact that the actions of the rescuer actually saved the life of the victim must be validate by EMS or medical personal.

More detailed information on specific awards may be found in the NSSZR handbook, Vol. 5 along with the description of the qualifying service.

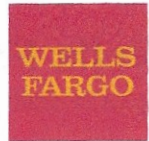
