Approval of Minutes of the Last Meeting

Florida Society Board of Management Meeting Minutes

Date: Saturday 05 Oct 2019, 2:30pm Location: Embassy Suites, Kissimmee, FL

Meeting called to order by President Lee Popham at 2:34pm. Opening ritual accomplished.

Included in these minutes are general topics of discussion and proposed Motions and the action(s) taken on those motions.

Lee Popham appointed Steve Williams as the 2019-2020 Compliance Officer.

Minutes of the previous meeting were approved as presented.

Executive Administrator Steve Williams reported:

- When the President sets the agenda for a BOM, it is the responsibility of the individual assigned to a particular session to coordinate with the Executive Administrator on the date, time, and content of the session, and this should be done as soon as possible.
- When submitting reports for the BOM Proceedings book, chapters should make their reports to their Regional Vice-President, and chapter color guards should make their reports to the FLSSAR Color Guard Commander.
- MOTION Upon the recommendation of the Nominating Committee, Bernard Wolff moved that we nominate Pat Niemann for 2020-2021 South Atlantic District Vice-President General. Dwight Elam seconded. <u>Passed</u>.
- MOTION Bernard Wolff moved that the BOM accept the attached charter dedicated to the formation of an ad-hoc committee titled the 2023 Congress Planning Committee whose duration will sunset at the adjournment of the 2023 NSSAR Congress. The purpose of said committee will be to coordinate the National Congress Planning committee to plan, fund, and implement the 2023 NSSAR Congress under the authority of Florida Society by-laws Article V, section 6.c. The FLSSAR President will appoint five members at the committee's formation and without future additions except to replace a Compatriot no longer able to fulfill his duties due to unforeseen circumstances. The appointed committee members are to plan, propose funding mechanisms, and oversee implementation of responsibilities of the Florida Society as host of the 2023 Congress of the National Society, Sons of the American Revolution. Ron Grove seconded. Passed.
- **MOTION** John Stewart moved that the proposed new special ad-hoc committee for Educational Outreach for the FLSSAR be approved, along with the attached draft charter. Steve Fields seconded. **Passed**.
- MOTION Ron Grove moved that we create a council of youth activities and that the purpose is to act as a forum for matters of mutual concern and interest to all youth programs, as well as a place where matters pertinent to all the program may be brought. The council will consist of a chairman and chairmen of all youth committees. Mike Tomme seconded. **Passed**.
- **MOTION** Upon recommendation of the Meeting Arrangements committee, the Executive Committee moved that the Fall 2020 BOM be held on Oct 2-4, 2020, and that the Spring 2021 BOM be held on 4/30-5/2/2021 at the Embassy Suites. no second required. **Passed**.
- **MOTION** David Bussone moved that Dick Young be appointed as the Endowment Trust Fund Trustee for the three year period 1/1/2020 to 12/31/2022. Mike Tomme seconded. **Passed**.
- MOTION The Battle of Thomas Creek Committee moved that changes to the Battle of Thomas Creek Committee charter, as published in the Fall 2019 Patriot magazine, be approved as published. no second required.

 Passed.
- **MOTION** The Nominating Committee moved that changes to the Nominating Committee charter, as published in the Fall 2019 Patriot magazine, be approved as published. no second required. **Passed**.
- MOTION David Bussone moved that to facilitate possible member purchase of specialty SAR license plates from the State of Florida, the President will create and charge an ad hoc committee with responsibility to research requirements, identify interested compatriots and, if feasible, support activities necessary to make available such license plates. (There is no financial cost to the FLSSAR for undertaking this activity.). Chuck Farmer seconded.
- Carl Hoffman moved to table the motion. Gary Miles seconded. Passed. The original motion is tabled.

 MOTION John Stewart moved to donate \$100 to the DAR exhibit tables at the 2019-2020 Central Florida Highland Games in Winter Springs FL on the Jan 18th 2020 weekend as they give us ample display room and introduce membership prospects to the SAR members attending. Bob McGuire seconded. Passed.
- MOTION Hall Riediger (for Steve Williams) moved that the FLSSAR waive state dues for active military members; for National Guard members on active duty at the time of the dues request, their dues are also waived. National Guard members not on active duty at time of dues request pay usual dues. Chuck Farmer seconded.

Steve Fields moved to postpone the motion. Pat Niemann seconded. <u>Passed</u>. The original motion is **postponed**.

MOTION – The Executive Committee moved that there be a chapter assessment of \$1 per member for the next 5 years, based on Jan 1 membership, to be allocated to the 2023 Congress Fund. no second required. Hall Riediger moved that the motion be amended to include "if necessary". Chuck Farmer seconded.

The original motion **Passed**.

MOTION – The Executive Committee moved that we allocate \$2,000 from the Meeks Fund to the 2023 Congress Fund annually for the next 5 years. no second required. **Passed**.

MOTION – The Executive Committee moved that we suspend the standing rule and allocate \$1 per member from the Endowment Trust Fund to the 2023 Congress Fund annually for the next 5 years. no second required. Passed.

Lee Popham stated that he was allocated reimbursement for travel expenses as Senior Vice-President and President, but has not used them, nor does he intend to use them, and would like to reallocate those funds to the 2023 Congress Fund.

MOTION – David Kelsey moved that the 2019 budget be amended to reallocate a portion of the President's expenses (\$3,333) a portion of the Senior Vice-President's expenses (\$833), and a portion of the Meeks Fund (\$1,667, representing the SVP expenses from 2018) to the 2023 Congress Fund. Passed.

MOTION – David Kelsey moved that the 2020 budget be amended to reallocate a portion of the President's expenses (\$1,667) to the 2023 Congress Fund. **Passed**.

MOTION – Carl Hoffman moved that the 2020 budget be approved as presented, and amended above. David Bussone seconded.

John Stewart moved that the motion be amended to include \$500 for the new Education Outreach Committee. David Kelsey seconded. **Passed**.

The original motion **Passed**.

MOTION – Jim Stone moved that the Florida Society endorse Compatriot Reverend Dwight Elam for the office of Chaplain General 2020-2021. Steve Fields seconded. **Passed**.

MOTION – Bernard Wolff moved that the Florida Society endorse Bruce Pickett for Secretary General 2020-2021 and John Dodd for Treasurer General 2020-2021. Pat Niemann seconded. **Passed**.

MOTION – The Endowment Trust Fund Distribution Committee moved that the Endowment Trust Fund Reimbursement Instructions and Guidelines sections C2, C3, and C9, as presented, be revised and the additions be effective November 1, 2019. no second required. **Passed**.

The meeting adjourned at 5:12pm.

National and State Officer Reports

President General (PG) Jack Manning convened the Leadership/Trustee Meeting at 9:45 a.m., February 29, 2020,

followed by opening ceremony and PG's recognition of veterans and first-time attendees.

Chancellor General Peter Davenport swore in those Trustees not sworn at the 2019 Fall Leadership Meeting Former President Generals were introduced and brought greetings.

The order of business was adjusted in order that presentations requiring a projector and screen could be given first. Following the presentations, the Trustees received reports from the General Officers.

Former PG Mike Tomme gave an update on the Member database and SAR website. The beta testing of the database was completed in November 2019. Chapter reports and Reconciliation Reports were made available to selected users consisting of State and National individuals. With a few more changes and modifications, the new SAR website using a WordPress platform should be fully functional by Summer 2020. PG Tomme reminded the trustees that when Chapter and State officers change, National needs to be notified so those officers can be given access to the new database. National will control State Secretary permission.

Compatriot Paul Callahan gave an update on the Richmond Congress, July 11-15, 2020. He stated that rooms at the host hotel are filled. If anybody needs a hotel room contact Paul via email <u>LTCMRSC@aol.com</u> with your arrival date, number of people and departure date. The host reception will be on July 11th and the Memorial Service on July 12th. Congress registration will open in mid-May.

Headquarters Maintenance Committee Chair Ken Goodson gave a presentation showing photos of the current condition of several areas of the West Main Street location and emphasizing the need for repairs. There

would later be a motion recommended by the ExCom that the Trustees approve six near-term maintenance related projects and one near-term appearance project. All these projects would have target completion during 2020 and are not to exceed \$30,000 (\$20,000 for the minor and \$10,000 for the major project). Responsibility for completion of these projects lies with the Executive Director, with assistance as needed from the Headquarters Building Maintenance Committee. This committee also presented a spreadsheet listing long term building maintenance projects requiring the establishment of a capital reserve fund setting aside \$25,000 per year if funds are available. This also was approved by the Trustees.

All present were reminded of the PG's Bermuda trip and encouraged to join the tour.

- Treasurer General (TG) Bruce Pickette reported that the preliminary audit report of the NSSAR and the Foundation was recently received. and that the Society was given a "clean" report in that the auditors gave an unqualified opinion that the financial statements fairly represented the financial position of the organization in accordance with accepted accounting principles. The recent SAR Logo Contest had resulted in hundreds of submissions and the responsible committee had narrowed the choices to ten (10) designs. Secretary General Davis Wright noted that the ExCom had referred the designs back to the committee for further work and that the final top selections will be presented to delegates at the Richmond Congress.
- SG Wright also announced that the Florida 2023 Congress Medal, the 2024 Pennsylvania Congress Medal, and the Arizona 125th Anniversary Medal were approved by the ExCom. The Gold Good Citizenship Medal was also approved for PG Manning.
- The Excom reviewed the SAR Ohanesian Family Award, approved by the Medals & Awards Committee, but referred it back to the Education Committee to further define sources of funding and derive funding agreements.
- SG Wright reported a Naming Rights Policy being derived between the NSSAR and the SAR Foundation had again been postponed until the next teleconference of the Excom, allowing for an Ad-Hoc Committee appointed by the Foundation to consider the policy.
- After a break for lunch, the Trustees were shown a video prepared by Solid Light, Inc., depicting a "walk-through" of the Museum as it is now conceived. The ExCom then recommended approval of Phase 2, Steps 3A and 3B of the SAR Education Center and Museum project. Step 3 had been divided into two parts with each part (3A and 3B) costing \$390,000. The Trustees approved the proposed contracts and expenditures subject to the availability of funds.
- The Trustees approved a recommendation for a proposal to be presented at Congress to increase application fees for selected application categories as current fees are not covering the cost of processing applications. The proposal is for application fees for (1) New Member Regular, (2) Junior Member, and (3) Memorial applications be increased from \$80 to \$100; for Supplemental applications be increased from \$60 to \$100; and for (1) New Member Regular Age 18 to Under 25 with Established Lineage, (2) New Member Regular Family Plan, (3) Junior Member Age Newborn to Under 18, and (4) Supplemental Family Plan applications be increased from \$30 to \$40. Presently, the cost of processing all categories of applications is \$104 per application. The Finance Committee had recommended a fee of \$115 for New, Junior, Memorial, and Supplemental but the ExCom reduced that recommendation to the \$100. The last fee increase was in 2012. This proposal only affects fees, not dues. Any fee increase would only be effective upon the approval and adjournment of the delegates to the 2020 Congress.
- The Excom recommended the Trustees decline to bring legal action against the shipping company insurance carrier for denial of the claim against the companies involved to recover the cost of the damage of \$3,000. The Excom believed the cost of the lawsuit would not be justified for the amount involved.
- The Trustees approved a motion recommended by the ExCom authorizing six maintenance projects and one appearance project for the Headquarters building during calendar year 2020. Available earnings from the Building and Outreach Fund are to be used not to exceed \$30,000. The Headquarters Building Maintenance Committee had also earlier presented a spreadsheet listing long term building maintenance projects requiring the establishment of a capital reserve fund. \$25,000 per year would be set aside if funds are available. This also was approved by the Trustees.
- On behalf of the Investment Committee, a motion to approve the percentages for the different classes of investments as recommended by Fifth Third Bank was approved.

Trustees were requested to complete the Conflict of Interest form and return them by the conclusion of the meeting. Respectfully submitted, COL Patrick J. Niemann, USA, ret., National Trustee, FLSSAR

- 1. The NSSAR headquarters will have a reopening on May 26th with regular hours of 8 a.m. 5 p.m. resuming on May 26th.
- 2. The genealogists working from home have completed 391 new member, 16 supplemental and 5 memorial applications.

- 3. PG Manning stated that the Congress in Richmond, Virginia is still scheduled to be held. However, the Richmond Mayor has the city in Phase 1 reopening until May 29th which means that groups of over 10 people cannot meet. Another Trustee Meeting will be held on May 30th anticipating the Richmond Mayor's decision regarding the opening of Richmond.
- 4. Paul Callahan mentioned that the ExCom has been discussing three options regarding the Congress. The options are no Congress; a virtual Congress doing only essential business such as voting; and live streaming from the Headquarters in Louisville. The ExCom is meeting weekly to discuss Congress options.
- 5. PG Manning stated that regardless if it is a regular Congress or a virtual Congress, all delegates, trustees, alternate trustees and VPGs need to be registered with the Executive Director Don Shaw no later than June 10, 2020.

- During the Presidency of Col Pat Niemann, a decision was made to replace the Winter BOM with regional meetings. Pat, and then Sr. VP, Lee Popham diligently participated in meetings around the state in an effort to engage our membership in open communication. As you normally do when one tries something new, we wondered if this regional approach would work.
- Member participation in this year's group of regional meetings answered the question. Your FLSSAR regional meetings drew more members than a typical BOM. And the discourse was enjoyable and productive. We will continue regional meetings during the upcoming FLSSAR 2020-2021 year. I look forward to seeing even greater participation by our members.
- Of the seven FLSSAR regions, six held meetings. I was able to participate in five of the six. During the meetings, some common themes developed. I categorized your comments and concerns and developed a summary for the Executive Committee. That report to the ExComm follows, including suggestions on how we might deal with each issue.

RVP Meetings Summary Comments

- 1) Lack of SAD Color Guard point opportunities.
- **Recommendation**: Encourage the VPG to designate at least one color guard event, not normally identified as a National Color Guard event, in each of his states as a District Color Guard Event.
- 2) FLSSAR chapters have suspended black powder firing because the NSSAR has not provided information on insurance for color guard members.
- **Recommendation**: Encourage the NSSAR to develop a recommendation that deals with black powder firing, including the availability of insurance options for color guard members.
- There are concerns by registrars regarding issues which delay the transmission of completed applications to the NSSAR, and the return of accepted applications to chapters for new member inductions.
- **Recommendation**: Ask the FLSSAR state registrar to assemble a small group of registrars from around the FLSSAR. Task the group with the development of report concisely stating concerns and providing a proposed solution to each. The report should be completed in time for the FLSSAR Spring (Fall) BOM so it may be considered and necessary resolutions/recommendations considered for transmission to appropriate NSSAR officers and staff.
- 4) Numerous comments have been received regarding the FLSSAR website. These include difficulty in its use, navigation problems in searching for items, downtime, its "out of date appearance" and other issues.
 - **Recommendation:** Task the FLSSAR Technology Committee to consider the anecdotal concerns and develop a methodology to identify issues, their extent, and propose corrective recommendations as necessary.
- 5) 2023 Congress members are expressing interest in the progress of the committee work, as well as steps being taken to ensure a successful event. Their specific concern is an apparent lack of information being disseminated.
- **Recommendation:** The 2023 Committee should develop a periodic digital newsletter to be sent to all FLSSAR members, via email, noting topics of interest and progress of the committee.

Trust funds – the two trust funds, to which BOM members elect trustees, have not provided recent reports regarding their financial status and IRS submissions.

Recommendation: Ask the trustees to provide a brief report on the financial status of each fund, to include its IRS status, at the upcoming May BOM.

Several of the recommendations already have had action taken which will deal with the concern. However, the arrival of CORVID-19 has delayed action on several others, particularly if the scope extends beyond the FLSSAR.

(Saturday March 28 – the Commemoration of the Battle of Thomas Creek was cancelled. I plan to attend in 2021.) (Saturday March 21- The Rumbaugh Oration Contest was to be held. It was cancelled) Subsequently we were able to view videos prepared by the 4 candidates. I was honored to participate a judge. The candidates were all exceptional.

- This represents my final report as your FLSSAR Member @ Large Officer. Over the past two and a half years, it has been my high honor and rare privilege to serve in this Office, and I trust my efforts have served to the benefit of our great state society.
- As I pass the gavel of this office responsibility to Compatriot and fellow Veteran Scott Bushnell, I wish him much success, and have every confidence that he will manage his new responsibility with enthusiasm and competence.
- Since the last Board of Management report, the Member @ Large Officer sent the 4th research email communications to Chapter Presidents seeking their feedback and input on pressing issues affecting their Chapters.
- While the overall response to my research emails has been generally disappointing with under 10 (25%), the responses have been interesting and enlightening. The following is the feedback on the research questions:
- 1. <u>Chapter Presidents</u> provided feedback on their most pressing chapter issues, suggestions to increase BOM attendance, and FLSSAR/NSSAR support.
 - I. The Pandemic has caused much disruption with the requirement to cancel important chapter meetings. There is concern that FLSSAR has provided little guidance or suggestions on ideas to maintain interest in the SAR mission when meetings cannot be held.
 - II. Most pressing chapter issue continue to be: meeting attendance program ideas, recruiting/retention suggestions, and minimal proactive *FLSSAR* ideas, direction, and chapter management support.
 - III. How to increase BOM Attendance: Better Pre-Event Promotion, Schedule Interesting Break Out Sessions, Guest Speakers, Less parliamentary proceedings/issues, more civic/community service discussions, and use of virtual services to make it easier for more compatriots to participate.
- IV. A major BOM attendance issue, however, was the overall expense averaging \$400+ including hotel/travel. Suggestions: Consider Virtual meetings, Regional BOMs, i.e. North, Central and South, that could allow more members to attend.
- 2. <u>Pensacola Chapter</u> proposed an idea for a statewide "Chapter Presidents Forum" via a closed Facebook page or similar social media platform for Chapter Presidents, RVPs and Officers to share ideas on new member recruitment, retention, meeting management ideas, BOM topics, involvement with other chapters and the DAR, and provide feedback to FLSSAR Officers.
- 3. FLSSAR & NSSAR support feedback:
 - a. Both the FLSSAR & NSSAR Websites are confusing, frequently not updated, and difficult to navigate.
 - b. FLSSAR needs to speed up the delivery of SAR RCs to the chapter in a timelier manner.
 - c. FLSSAR needs to communicate clearly what is being planned for the 2023 Congress, when the chapter fees need to paid etc.
- 4. <u>Chapter Presidents</u> were reminded of the FLSSAR Veterans Battalion and NSSAR Veterans Corp membership opportunity and easy application process to apply, with the turnaround time for review and acceptance for the FLSSAR VB (a) just 24 hours by the current FLSSAR VB Chairman.

- No proof submitted for one or more generations to connect lineage from one generation to the next.
- Incorrect check amount required for NSSAR and/or FLSSAR fees and dues.
- Lineage names do not match the submitted proof documents such as middle name or initial missing or given names shorted such as "Frank" instead of "Franklin."
- Word(s) miss spelled in all areas of application.
- Lineage section locations do not conform to required format which is "City/County/State" such as commas used instead of "/" or "/" not used even if city and/or county not known.
- Lineage section dates not properly formatted full known date should be 2-digit numeric day (i.e. 02), 3 character month (i.e. Sep) and 4 digit year (i.e. 2001). (i.e. 02 Sep 2001)
- Proof document missing, listed on application but not sent with the application.
- Unproven/unaccepted information used on application from a previous SAR, DAR and/or CAR application record copy.
- Service reference section left blank on application form.
- Chapter Name and State section left blank on application form.

- Lineage incorrect for one or more generations.
- One or more required application signatures are missing on the application.

Recommended Application Submission Improvement Areas:

- The SAR embraces and has approved four membership application forms: MS/Word version; PDF version; SARApAid by Cox Software; and My Applications, the online application system. Links to the current updated version of each of these four forms is available from the SAR website by clicking on https://sar.org/application. Revised versions of the four forms have been acceptable since they were first approved by the Trustees in March 2017 but outdated versions of these forms, in particular the MS Word, the PDF, and the SARApAid forms, continue to be received at Headquarters. Now, the Trustees have set an effective date after which outdated versions of the forms cannot be used. At the 2018 NSSAR Fall Leadership Meeting, the Trustees approved October 31, 2018, as the effective date for use of only the current versions of these application forms. The new application forms have several important changes: removal of the spaces for listing of the applicant's children, a revision to the applicant's signed certification, and addition of a space for signature of the Genealogist General. The current version date for each form type is:
 - MS Word version: "adopted Feb 2017 SAR Application Form 2017" found on the bottom of the application form.
 - o PDF version: "Rev. Mar 2017" found on the bottom of the application form.
 - SARApAid by Cox Software: "Appaid Ver. 5.03... Feb 21 2018" found on the bottom of the application form.
 - My Applications (the online application system): This format does not have a revision date, but any application printed after May 7, 2018 will automatically contain the required changes.

Only application forms with these, or more recent revision dates, will be accepted as of October 31, 2018. While leeway is certainly due those whose applications were in process at the time we reach the deadline, we need for this deadline to be respected and we request those who assist with application process – sponsors, genealogists, registrars, secretaries, and others – to assist our applicants in using the right application form and in avoiding the disappointment of having their form returned because of use of the wrong form. - There has been sufficient previous notification by GG and others which have been forwarded to all FLSSAR Chapter Registrars regarding the change in NSSAR policy regarding unproven information contained on submitted applications. Unproven information can no longer be submitted on applications. Likewise, any applicable information contained on document submitted with an application must be annotated on the application in the appropriate places when applicable. Failure to comply with these requirements will result in a pended application.
- NSSAR is identifying and will reject photocopied applications being received on SAR archival paper. A
 printer does a better job of injecting ink into paper if the copy prints from a computer command. If you
 take a printed application and simply photocopy it onto SAR watermarked paper it is insufficient for NSSAR
 requirements.
- Enclose 1 application copy on SAR watermarked archive paper and 1 application on plain paper for all applications submitted.
- Ensure all required signatures and dates are present as required for type of applications being submitted.
- Do not submit NSDAR web site printouts from the "Descendants Database Search" or NSDAR "Patriot Index" information. This information is not acceptable for either lineage or service and NSSAR does not want this unacceptable information included with any application.
- Ensure <u>ALL</u> applicable information contained on all submitted proof documents is recorded in the applicable sections of the application. Do not list references that are not being submitted and list all documents that have been submitted.
- Ensure all known spouse information is included when known for each generation even when the spouse is not in direct lineal descent. This will prevent applications from being pended when two persons of the same name are living in a given area and this information would assist in identification of the correct person used on the application.
- Only one set of proof documents are required to be submitted with each application. This also applies when submitting more than one application under the family plan criteria. One set of proofs only for the common documents used by all the applications in the group. His does not apply to multiple supplemental

- applications submitted at the same time. Supplemental applications are always considered separately and require complete sets of documentation.
- Use a red pencil to underline applicable data on all proof documents and DO NOT USE any type of highlighter.
- Copy of entire legible original census page must be submitted when using a census as a proof document. Ancestry.com census transcription pages cannot be used in lieu of the original census page but may be used in addition to the original page.
- Never use nick names on an application unless there is a required proof document has been submitted that validates the nickname.

New NSSAR Application/Genealogy Policy and Prep Manuals

New versions of these manuals are available for download from the NSSAR website.

- NSDAR/NSCAR Record Copy Acceptance Criteria Change 2011-06, Applications from other lineage organizations. SAR will now accept an official record or chapter copy of a DAR or C.A.R. application approved after 1 January 1985 as evidence of lineage and related fact except where DAR, C.A.R. or SAR has determined that the facts have been determined to be incorrect. In other words, center checks on applications approved after 1 January 1985 no longer prevent a DAR application from being accepted in lieu of other documents. Applications approved before this date are acceptable for corresponding facts marked as individually verified on DAR and C.A.R. applications. The subcommittee acknowledged that there were arguments on both sides of the issue and what it proposed was a middle ground that it deemed in the overall interest of the organization. No review process is perfect, but the overall DAR review process is an excellent one that includes a number of checks and balances. The old policy was clearly confusing to many applicants, chapter registrars, and state registrars, and the genealogy staff was spending a great deal of time requesting further information relating to DAR applications. Compatriot Peterman made a point in discussion I think all of us share; we do prefer copies of the documents themselves. Acceptance date for NSSAR record copies is 01 Jan 1074 and after.

Since the last BOM the Webmaster has completed 188 hours of support to the Society and various Chapters.

This support ranged from simple help getting Usernames and Passwords to work on the New National Logo Brand currently being considered at the National level.

Developed a new Help system and am working to make it available for all complicated Pages.

Placed Battle field (Florida) information on the Public Site.

Created a Committee membership lookup capability

Created a Medals lookup capability

Created a way for members to upload pictures, including their Info page Pictures

Created a listing on the Members Only site to show what I am working on, for whom, when requested/started and when completed

Encouraging Members to use the Help form (link on Listing Page) to request Webmaster support.

Financial Review

Pursuant to Florida Society SAR Governing Documents, Bylaws, Article V, Section 3, Financial Review Committee (revision date: May 20, 2017), the FLSSAR Executive Committee (EXCOM) under the leadership of FLSSAR President William Lee Popham, Sr. commissioned a Financial Review Committee led by the Honorable Bernard W. Wolff to conduct an analysis of the 2019-2020 financial activity of the Florida State organization. Each year an ad hoc committee is formed to review the record and ensure all financial activity corresponds to the expectations of the membership.

The Financial Review Committee, acting as an independent agency within the FLSSAR, received explicit instructions that informed our activity in several areas of interest:

• Review the Treasurer's Annual Report.

- 1. A simplified, end of the year assets accounting indicates a sum of \$113,668.22 (checking account balance plus surplus) which is under 10 times the annual expenditures of \$139,018 which appears to obviate against any potential tax liability.
- 2. The Meeks Fund is currently up to date with all outstanding contributions being deposited per the Treasurer's end of year report (January, 2020).

Review the previous audit report.

1. The Documents Committee should review the Financial Review Committee charter [revision 10/16/2016, recommended in the 2016 Financial Review] and delete references to an Audit Committee.

RESPONSE: This action appears not to be completed. References were noted to indicate the word "Audit" can still be found, including in the instructions found within this set of instructions. The term "Audit" also appears in copies of the October 2019 *Proceedings*. The Financial Review Committee Report is due in time for the Annual Meeting/Spring BOM. Therefore, there should be no reference to a report due for the Fall *Proceedings*. The alternative is to mention in the Fall *Proceedings* that the Financial Review Committee's Annual Report if due in the Spring.

2. Authorized check signers for the Society need to be updated after the 2020 elections and remove those individuals who are no longer authorized as signers by the Florida Society.

RESPONSE: The Committee finds that the previously authorized check signers for accounts held at Wells Fargo Bank will change with the election of a new Secretary. This change will require a timely response to affect a smooth transition for account management.

Review the people and procedural controls for access to the funds before deposit.

- 1. Three people have access to the accounts at Wells Fargo Bank: the Registrar deposits monies collected for application fees; the Secretary deposits reinstatement fees and annual dues; the Treasurer deposits registration fees and all other checks mailed to the FLSSAR.
- 2. The Registrar and Secretary both send scanned copies of their deposit slips to the Treasurer which are matched to the bank statement.
- 3. The Treasurer makes any, and all deposits to the Wells Fargo Money Market Account.

Review all financial assets, the people authorized to access them, and documentation of transactions.

- . Wells Fargo checking account: the three abovementioned personnel are authorized signers to the account: Registrar; Secretary; and Treasurer. The Treasurer has the only checkbook for the account.
- 2. Wells Fargo Money Market account: There is one Money Market Account at Wells Fargo valued at \$64,378.31 on December 31, 2019. There are two signers for the account. No activity was reported in the end of year statement from Wells Fargo other than addition of some account interest and two transfers to the Meeks Fund. No checks were written, according to the December 31, 2019 statement recapitulation.
- 3. The Secretary and Treasurer are the only authorized users of the two credit card accounts from Wells Fargo Bank.
- 4. Treasurer card: Any outstanding balance is paid when the current invoice is billed.
- 5. Secretary card: Any outstanding balance is paid when the current invoice is billed.
- A check balance of \$ 111,401.67 on the Wells Fargo Bank statement dated December 31, 2019 indicates a difference with the cash assets stated in the checkbook of the Society for the same date. The difference of

\$2,266.55 was due to outstanding checks that had not been cleared by the bank in order to balance the checkbook by the end of the year. The Registrar, Secretary, and the Treasurer are authorized depositors for the checking account with confirmation of deposits by the Treasurer. The Treasurer has the only checkbook and has signed all checks during fiscal year 2019. There are no other authorized check signers. There are no authorized co-signers. There are no other checking accounts.

Review the people and procedural controls for making payments for asset disposal.

- Monies are dispensed by the Treasurer when invoiced for budgeted committee or event related
 expenses; it is usually the committee chair or event leader who sends an invoice or asks for
 reimbursement. If a bill is sent directly to the Treasurer, even though in the Budget, the Treasurer
 forwards the invoice to the committee or event leadership for his approval prior to sending a check.
- 2. The Treasurer relies on good sense with some bills and determines a threshold amount that, if exceeded, encourages him to seek approval (usually via email for an expeditious outlay) from the EXCOM (\$200-\$300) or possibly the BOM (\$500+) to gain approval of the expenditure. A solicitation for an off-budget payment from the BOM would be accompanied by an expected amendment to the budget. However, at times it is possible that a small, off-budget request would be honored if it appertained to FLSSAR interests (e.g., color guard). It is a judgment call for the Treasurer. A complete list of all budget line items and receipts/expenditures is provided on a year-to-date basis at each BOM for transparency.

• Review the documentation filed to substantiate expenditures.

Ninety-three checks were written in 2019 (numbers 1856-1948). Since this volume of checks written exceeded 55 checks, a random number equaling one-tenth were randomly selected to review (n=10). This is the suggested number for analysis directed by the conventional worksheet. A random number was generated by a tool found in the Excel spreadsheet. No discrepancies were reported by the Committee.

• Write a Financial Review Summary letter to the president or chair (see Below).

2019 Summary Letter

On February 2, 2020 the Financial Review Committee of the FLSSAR spoke with the Treasurer to perform the annual non-certified review of the Society's financial books and reports for the fiscal year January 1, 2019 through December 31, 2019. In response to the Financial Review Committee's request, we received from the Treasurer sufficient financial records and specifically requested documents to perform the annual noncertified financial review for fiscal year 2019.

We concluded that the financial statement as prepared by the Treasurer fairly represents the monetary transactions of the Society for the fiscal year ending December 31, 2019.

The cash balance of \$113,668.22 from the Wells Fargo Bank checking account accurately represents the assets of the Society on deposit. The current value of the Wells Fargo Bank money market account reflects an accurate amount of \$64,378.31 as of December 31, 2019.

Both credit cards carry only current balances which are discharged at the next billing cycle. Suggestions for Improvement:

- 1. We suggest that a tickler file be established to assist as a reminder for the disbursement of funds to satisfy outstanding obligations.
- 2. A reconciliation of the checking account should be made every two months to keep account values and activity clearly in mind.
- 3. As in past recommendations, the word "audit" should be changed to "financial review" to accurately assess the function of the Committee, including the verbiage leading to and including the Summary Letter. In the case of the current Summary, the wording has been changed to indicate the change. This should be accomplished by tasking the Documents Committee to review the current Financial Review Committee charter (revision 10/16/2016).
- 4. A recommendation to add the Treasurer's name to the Secretary's credit card to allow more simple billing procedures and access to the account in case of emergencies.

Medals and Awards

As stated in the NSSAR Handbook (Volume 5), the awarding of medals and awards should always be given very careful and serious deliberation to determine that the proposed recipient is qualified, deserving, and the occasion for presentation is appropriate. The presentation of medals and awards should not be treated lightly by the National Society, district, state society or a chapter, and should always be given judicious

thought to assure that the presentation is in keeping with NSSAR principles. It is essential that the integrity of NSSAR medals and awards be maintained.

- As for the Florida Society, any nomination for a certificate and any supporting data to be used in making an award of a certificate must be submitted to the FLSSAR Medal & Awards Committee 60 days before any Board of Management Meeting so that the committee can evaluate the request, secure the certificate and/or medal from National if it is not already in FLSSAR inventory and have it prepared for signatures at the upcoming Board of Management Meeting. Most certificates issued by the Florida Society require the signature of the Society President and Society Secretary.
- A member may be awarded several National Society medals more than once: Meritorious Service Medal, Roger Sherman Medal, Heroism Medal, Bronze Good Citizenship Medal, Liberty Medal, C.A.R.-SAR Medals of Appreciation, Samuel Adams Congress Planning Medal, Service to Veterans Medal, and the Florence Kendall Award.
- Each medal previously listed has its own criteria. Please refer to the specific medal in the Handbook for the number of oak leaf clusters and/or multiple awards permitted. Also, any multiple awards of state society medals should use the oak leaf cluster system. For more specific information on each award medals available, refer to the NSSAR Handbook (Volume 5).
- When various committees of the FLSSAR plan to give out certificates, medals, patches etc. for such programs such as the Knight Essay Contest, the Rumbaugh Oration Contest, JROTC, CAR, Eagle Scout, the committee chair is responsible to notify the Medal and Awards Committee of the number of awards that they are planning to award for the upcoming year by October so that the appropriate items can be ordered from the NSSAR. Although such awards may not need to be approved by the Medal and Awards Committee, proper planning is required in order to keep cost down and to not have to expedite such awards based on last minute planning.

- A 133rd Congress Planning Handbook (Handbook) lists the different Task Forces needed to execute the FLSSAR plans to deliver the 2023 NSSAR Congress in Orlando, FL. It also indicates the job descriptions of the Congress Planning Committee and Task Force Commanders. The Handbook will be made available to the formal committee members, initially. It will also be sent to those who attended the formation meeting and signed the attendance sheet. Eventually, it will be uploaded to a 2023 Congress website (see below). Being mindful that we are still three years from this annual event, expect changes to the Handbook as we move forward. Each iteration will be dated to indicate new information. At a later date, an agenda will appear to give a day-by-day look at the program with dates and times.
- As many of you are aware, we have been engaged in fund-raising to handle the financial obligations of the FLSSAR concerning the Congress. Many of you have purchased a chance to win a Charleville Musket. In many cases, you have been able to choose your personal ticket number. There are still a few tickets left at \$20.00 apiece, or alternatively six for \$100.00. Once a total of 300 tickets are sold, we will hold the drawing and one lucky winner will have a new musket to maintain. This drawing should raise about \$5,000 net profit. After most of the tickets are sold, we plan to purchase another weapon and repeat the process.
- The NSSAR EXCOM approved a Congress Medal Set at our Leadership Conference in Louisville, Kentucky last February 2020. We are now in possession of 300 sets. Each set is comprised of a box, a standard-size medal and a miniature-size medal. They have a military style bayonet back. The medals have a navy-blue drape and a profile of Juan Ponce de Leon, in 3D, on the front while the NSSAR logo appears on the backside of a round medallion. The Congress Medal Set sells for \$40.00 plus shipping (to be determined), or they will be available at FLSSAR and NSSAR functions.
- The NSSAR Executive Director approved the minting of a Challenge Coin as the EXCOM already agreed to the design. It reflects the appearance of the medal used in the Congress decoration. It will take four to six weeks before they become available after the order is given for manufacturing them.
- The members of the Florida Planning Committee came to a consensus about publishing a FLSSAR Congress Planning Website. This resource will provide timely, pertinent information to inform the membership of our progress in planning for the 2023 event. It should be consulted regularly as additions, deletions, and other changes will appear as decided. Our web designer will provide several pages for our use and will include at least a Main Page, Handbook Page, Photo Album, and a Shopping Cart for the sale of previously mentioned goods. Others are likely to be added over time.
- The Ladies Auxiliary has been busy selling throws to raise money for their portion of the financial responsibility at this Congress. They have already sold out the first run of their delightful throws and will be ordering another batch, soon. They have a net profit of roughly \$3,000. The next run should earn a similar amount.
- There is a suggested number of 80 people who will be needed to staff all the responsibilities for a congress. This effort will take all of us working together to present to the general membership a most excellent event. If

we all do a little, much can be accomplished. Please volunteer at your earlies opportunity and contact any one of the Task Force Commanders that will appear in the Handbook.

Finance Committee

At the end of the BOM Proceedings Book, you should find the summary of cash receipts and cash disbursements for both the year ended December 31, 2019 and the five months ended May 31, 2020. These reports also show a new Congress Fund to separate the cash designated to cover the expenses of the 2023 Congress and related expenditures.

At May 31, the Florida SAR had \$172,439 in its two Wells Fargo bank accounts, of which \$11,162 is reserved for the 2023 Congress Fund.

Year Ended December 31, 2019

Dues were more than expected, but we were unable to identify those fees collected for the Patriot Magazine subscription, so we continued to print and mail copies. BOM registration fees were more than expected, as were the expenses. As you will recall, at the Fall BOM we revised the Budget to reallocate some of our budgeted expenses to fund the Congress Fund. The OBT annual contribution to Florida SAR was overlooked and I have been in touch with the Trustees. We spent about \$1,000 less on medals and awards than budgeted, but it looks like we will make that up, and more, in 2020 as we catch up on medals and resupply inventory. As noted in the Treasurers Report, I have not been able to get a quote on liability insurance. The Congress Committee spent \$825 to purchase the "Raffle Musket".

Five Months Ended May 31, 2020

The COVID-19 Virus and related restrictions will play havoc with our budget for 2020. BOM attendance is expected to be down, but costs are expected to increase to allow for members to attend virtually. The Commemorations of the Battle of Thomas Creek and Battle of Pensacola were both cancelled. Our Youth Program Committees were able to conduct all their contests and most of those checks have been written. Annual dues collections were less than expected. Dues have been paid to National. Again, we seem to be unable to separate Patriot Magazine subscriptions from Dues. I will work with Hall Riediger on that. I was late in getting the 2019 Congress Fund Assessment notice out, and as of May 31 I had not received payment from all chapters. The notice for the 2020 Congress Fund Assessment will go out by the end of June.

The Congress Committee spent \$4840 on medals for the 2023 Congress.


The original committee began as an ad hoc enterprise with approximately 30 volunteers and eventually became settled as a Standing Committee with a current membership of five members plus a chairman. Many of the original procedural goals have been realized while others require an on-going effort.

The following are a few observations that we feel may be of benefit to the FLSSAR as we look at the first phase of this roll-out: Phase two will appear later and will also address implementation of the updated STRATPLAN. This is a working document and is expected to be revised moving forward.

A defined Mission Statement, or vision of the SAR is paramount to this effort. Much of what is published and available to the public mentions some of the things we do as a group, but I really do not see a Specific Mission Statement, as such. The current Mission Statement that we find tells of what we do but does not relay an overarching vision of the organization. This should be remedied. The NSSAR website, under Mission & Goals is more descriptive than visionary in that it speaks of the Objects of the NSSAR. A visionary statement will raise questions for us about our raison d'être. For instance, are we in the business of insuring informed citizens, insuring a more perfect union, preserving an understanding of the sacrifices of our ancestors, among other considerations? I believe that we can, as a committee, generate a consensus of opinion about our vision of the future. When I was working with the J6 (Policy, Plans, and Procedures) for USSOUTHCOM, we formulated responses to interests held by the General, and others. Typically, the process started with a document prepared by an individual, or group. From that point, it was shopped to other departmental offices that had an interest in the project, and they "chopped" on the document with their relevant thoughts and ideas by adding commentary in highlighted colors. In this way, the budding document made the rounds and eventually ended up with common agreeme

Patriotic Activities

Functions:

- 1. Through the chapters, to encourage Americanism which is devotion and loyalty to the United States, its traditions, its customs and its institutions.
- 2. To encourage chapter participation in Allegiance Sunday programs which are held on the Sunday of the 4th of July, or the Sunday immediately prior to the 4th at which allegiance to the United States is reaffirmed.
- 3. To encourage participation by chapters at the naturalization of new citizens and develop programs which delineate the duties, rights and privileges of all citizens.
- 4. To develop programs of Patriotic Educational Significance for presentation before school, citizen, fraternal, and civic groups. Programs may be of historical documents, or biographical sketches of individuals or groups who had impact on the establishment and development of the United States.

- 5. To administer the Flag Program for the Florida Society to include competition for the rear Admiral William R. Furlong Award to the State Society with the best Flag Program, award and present the NSSAR Flag Certificate to individuals and activities in the name of the FLSSAR, encourage FLSSAR chapters to participate in Flag Day, June 14, ceremonies, and promote respect and honor to the Flag of the United States. Encourage chapters to present the NSSAR Flag Retirement Certificate (NEW) to individuals and activities in the name of the FLSSAR.
- Presentations of certificates can be simple or elaborate. Usually they take only a few minutes with a member introducing himself, talking briefly on the importance of or history of the American flag, explaining the award, and presenting it to the group. Certificates can be presented in an SAR folder, in a frame, or mounted to a plaque. If the certificate is mounted or framed, it is more likely to be put on display rather than stuffed in a drawer. Flag Certificates and the new Flag Retirement Certificates are available from the SAR store for only \$4.
- In July, 2019 the SAR National Society approved a new award: The U.S. Flag Retirement Award. *The award is presented to NSSAR state societies by the NSSAR National Society.*

The criteria of the award:

To qualify, one-half of its chapter (sic) and the state society must each present at least one U.S. Flag Retirement Certificate within a one-year period. Special recognition will be given if 100% of the chapters and the state each present at least one U.S. Flag Retirement Certificate within a one-year period. Qualification criteria for the award is to be reported, by the state society, to the chairman of the NSSAR Flag Committee and the National Society. The Flag Committee Chairman will evaluate the criteria and determine the award to be given.

The Award:

The first time a state society qualifies for the award, a streamer and a U.S. Flag Retirement Award Certificate will be awarded. Thereafter, each time the society qualifies for the award, a white star and a U.S. Flag Retirement Award Certificate will be awarded. If 100% of the chapters and the state each presents at least one certificate in a one-year period a Certificate of Excellence will be awarded, also.

Report Date:

The date that a state society must submit its report for the U.S. Flag Retirement Award is March 1 of each year.

- Allegiance Sunday is held on the Sunday closest to July 4th. Compatriots are encouraged to contact the head of their congregation or church to see what activities are planned to recognize Independence Day. These observances are opportunities to offer the services of the color guard or to have a member lead worshiper in the pledge of Allegiance. A Flag Certificate could also be presented if appropriate. This year several chapters took part in Allegiance Sunday activities. If yours did, please let the committee know so that we can include that information in our end-of-year report.
- For more details or information on any of these activities, please contact one of the committee members listed above.

Public Service and Heroism

- The Public Service and Heroism Committee (PS&H) recognizes and honors citizens and individuals in our public service sectors of Law Enforcement, Fire Safety, and Emergency Medical Services for their contributions to the community and for heroic acts with a commendation and medal. States, chapters and commendation recipients are recognized in a booklet published and distributed at the National Congress each July.
- The State-level PS&H Committee exists to publicize the committee's function to the states' local chapters and to encourage their participation. Awards presented are reported to the National-level PS&H Committee and the State-level society by filling out an on-line form.
- All Commendations should be reported prior to June 1, to ensure inclusion in the PS&H Committee

 Commendation booklet for distribution at the July NSSAR Congress. The fillable on-line Public Service

 & Heroism Report Form PDF forms may be found the NSSAR web site.
- The Law Enforcement Commendation and Medal is presented to those who have served with distinction and devotion in the field of law enforcement. The medal is intended to recognize exceptional service or accomplishment in the field of law enforcement. Eligibility is not limited to peace officers but extends to

the entire range of persons who make and enforce the law. This includes peace officers, attorneys, judges, prosecutors and legislators who have performed an exceptional act or service beyond that normally expected. The recipients are usually recommended by their superiors or peers for their accomplishments. The award may be presented posthumously. The medal may be presented to an individual only once. No Oak Leaf Clusters or ribbon attachments are permitted.

- The Fire Safety Commendation and Medal is presented to an individual for accomplishments and/or outstanding contributions in an area of fire safety and service. The award is not limited to firefighters. It may be presented to recognize a variety of fire safety and services that have evolved into a highly technical and skilled profession with constant study, development and involvement by numerous dedicated citizens with a single goal, which is protecting human life and property by preventing injuries or casualties due to fire and chemicals. The medal maybe presented posthumously. The medal may be presented to an individual only once. Oak leaf clusters or other ribbon attachments are not authorized.
- The Emergency Medical Services Commendation and Medal is presented to an individual for accomplishments and/or outstanding contributions in the area of emergency medical services. The award is intended for paramedics, certified Emergency Medical Technicians, and others in the emergency medical field who have performed an act or service beyond which is normally expected. The medal may be presented posthumously. The medal may be presented to an individual only once, and no Oak Leaf Clusters or ribbon attachments are permitted.
- A Heroism Commendation and Medal recognizes outstanding bravery and self-sacrifice in the face of imminent danger i.e., acts which involve great personal courage and risk to the recipient. It is intended primarily for acts by civilians, not in uniform, but does not exclude police, firemen, EMS and SAR members. It is not intended to recognize acts that would have been covered in the performance of one's normal duty, nor by medals for valor by the armed forces. Animals are not eligible for recognition. The medal may also be presented posthumously. An individual may receive this medal multiple times. Presentation and the wearing of Oak Leaf Clusters shall follow NSSAR policy.
- The SAR Life Saving Medal is presented to those individuals who have acted to save a human life without necessarily placing their own life or themselves in imminent danger. The medal is intended primarily for acts by civilians not in uniform, however, police officers, fire fighters, emergency medical personal, lifeguards, and SAR Compatriots are not excluded from receiving this award. The medal is not intended to recognize acts that would otherwise qualify for military or another organization's valor and, in all cases, the fact that the actions of the rescuer actually saved the life of the victim must be validated by EMS or medical personnel.

More detailed information on specific awards may be found in the NSSAR Handbook, Vol. 5, along with the description of the qualifying service.

Veterans Affairs

Functions:

The Veterans Affairs Committee has two major areas of responsibility.

- 1. The primary responsibility of the State Chairman and the Regional Vice-Chairmen is to encourage, advise, and motivate the various Chapters (primarily through the Chapter Veterans Affairs Chairman) to:
 - a. Recognize and present War Service Medals and Certificates to veterans within their respective Chapters who have served in the military during a war period.
 - b. Recognize and present Military Service Medals and Certificates to veterans within their respective Chapters who served in the military during peace time.
 - c. Recognize and present the SAR Purple Heart pin and Wounded Warrior Coin to veterans within the Chapter who received the Military Purple Heart during their military service.
 - d. Encourage gifting and visitation to veterans both within the Chapter as well as at local VA Hospitals, clinics, and nursing/private homes.
 - e. Participation in military funerals, parades and other veteran functions/activities. (SAR uniforms should be worn when receiving the colors at the funeral of a homeless veteran when no family members are present.)
 - f. Participate and conduct such other Veterans Affairs as directed by the President, Florida Society.
- 2. The State Chairman and the Regional Vice-Chairmen should encourage the Chapters to participate in the national USS Stark contest. The Veterans Affairs Committee responsibilities include:

- a. Process and consolidate all applications for the USS Stark Award for entrance into the National Contest.
- b. Summarize the forms for the State of Florida and submit the summary to the NSSAR USS Stark Chairman.
- c. Inform the FLSSAR President of the state winner of the contest at the Spring BOG for the presentation of the SAR Flag streamers. (The National winner is announced by the NSSAR.)
- Compatriots, with nearly ¾ of the year gone, now would be a good time to make sure that your records of this year's activities in support of our veterans are up to date. Not only does this ensure that your chapter and the state society accurately report their activities to national, it also helps to identify veterans or activities that we have not yet received the recognition or support that they deserve.
- This year the Florida Society has increased its support of the Missing in America Project (MiAP). This organization helps to locate and identify the unclaimed remains of veterans and their spouses. They then coordinate with the VA to ensure proper internment for them. At intervals, they organize ceremonies at national cemeteries where these veterans and spouses can be interred with the honor and respect that they are due.
- On September 26th of this year, six compatriots from three SAR chapters joined members of several DAR chapters, the Patriot Guard Riders, American Legion, VFW, other veteran and civic organizations gathered with the Missing in America Project at Sarasota National Cemetery for the internment of 17 veterans and spouses from the WWII, Korea, and Vietnam eras. Honors were rendered by a color guard from the Army, Navy, Marines and Air Force as well as a firing detachment and bugler. The SAR members participated as pallbearers during the ceremonies and in the procession to the columbarium.
- Another program that has seen increased participation is Honor Flight. The Honor Flight program provides trips for groups of older veterans who would not otherwise be able to travel to see the memorials in Washington, D.C. that have been erected in honor of their service. When a flight returns, the SAR joins with hundreds... sometimes thousands... of grateful Americans to welcome these veterans home once more. Events attended by SAR chapters in Florida include May 4th in Ft. Myers and June 11th in St. Petersburg. Coming up are flights into Ft. Myers on September 28th and November 2nd. These events are not just for the color guard. If you have the chance, please come out to help welcome our heroes' home.
- Lastly, Veteran's Corps Survey Forms and the appropriate supporting documentation should be forwarded to the state Veterans Recognition Committee Chairman, Don Lanman. Completed surveys that meet the criteria published by the state and national societies will be processed quickly and will generate a Certificate of Patriotism to present to our compatriot veterans. Please report presentation of these certificates (and the corresponding medals) to the committee at year's end.

3. Committee Activity:

- a. Veterans Recognition Committee continues to work with Chapters to expand the membership of the FLSSAR Veterans Battalion with Compatriots who served honorably in the armed forces. Chapter Presidents are contacted on a Quarterly basis and encouraged to promote Veterans Battalion recognition within each chapter.
- b. Veterans Battalion Roster has been updated on the FLSSAR web site listing of all Veterans Battalion members.
- c. The committee chairman is reviewing all Veterans Battalion requests within 24 hours of receipt of VB application form with DD-214, and mailing the VB letter and Certificate within 48 hours to the Chapter for presentation.
- d. Chapter Presidents are requested to personally present the Veterans Battalion Certificate along with the authorized Military Service or War Service medal to each approved Compatriot at a chapter meeting. The chapter is encouraged, but not required, to purchase the medal for each compatriot directly from SAR.org.

- e. Chapter Presidents are reminded that the *SAR War Service Medal* may only be authorized for Compatriot veterans with proof of war service directly within a DOD designated "combat area" as noted on their DD-214. Non-combat related military service qualifies for the *Military Service Medal*.
- f. The committee continues to work with Chapter Presidents and the NSSAR Veterans Corps committee to help FLSSAR Veteran Battalion members apply for the NSSAR Veterans Corp recognition.

Endowment Trust Fund Disbursements

To date I have received requests totally about \$8,500. There's still about \$16,000 available. The ETF year ends October 31 with the filing deadline being Nov. 15. Last year we had 66 requests for \$15,626. Please look through you activities and see what you have done that could help your treasury. Last year we made a few changes to the rules and this year I am going to request a few more. We want to do all we can to encourage outreach programs. Remember a keep to reimbursement is that these monies are only for non-SAR members. I will be having a meeting of all youth activity chairmen at 9 AM on Saturday at the BOM. Please encourage your chairman to attend.

Florida SAR Endowment and Operating Budget Trust Funds

Approved 2019 distributions from ETF amounted to \$14,207.83 and were disbursed in accordance with the policy established by the SAR Distribution Committee to 23 participating Chapters. Requests for this fiscal year are due to that committee by the end of October. It appears that there will be ample "unitrust income" available to meet all approved requests again this year.
