President Earl Mathews recessed the meeting at 12:01pm.

Board of Management Meeting

Meeting reconvened by **President Earl Mathews** at 1:24pm.

Ouorum requirement met.

Minutes of the previous meeting were approved as presented.

MOTION – David Bussone moved that the items listed in the Proceedings book be considered consent agenda. SECOND Steve Fields. PASSED

MOTION – The Finance Committee moved that unused President expenses be moved to the 2023 Congress fund. PASSED

MOTION - The Finance Committee moved that unused Secretary expenses be moved to the 2023 Congress fund. PASSED

MOTION – The Finance Committee moved that late reported SVP expenses for 2022 be moved to the 2023 budget. PASSED

MOTION – The Finance Committee moved that if there are unexpected Congress expenses, or budget overruns, that the Treasurer and Executive Committee members not on the Congress Planning committee be authorized to approve those expenditures.

PASSED

Compatriot Brad Marble presented a personal donation of \$2,000 to the Congress fund.

The Brevard Chapter presented its Tricorn Hat Resolution that was published in the Spring 2023 edition of The Florida Patriot magazine.

MOTION – Sam Ashdown moved that the resolution be adopted by the FLSSAR Board of Managers. **SECOND** Phil Markoe. After discussion, it was determined that this is not the proper procedure, and should be presented to the appropriate NSSAR committee for consideration. The motion **FAILED**.

MOTION – Steve Fields moved to recess until after the Annual Meeting. **SECOND** Dick Young. **PASSED President Earl Mathews** recessed the meeting at 2:32pm.

Annual Meeting

Date: Saturday, May 20, 2023

Location: Embassy Suites, Kissimmee, FL

Meeting called to order by **President Earl Mathews** at 2:50pm.

Quorum requirement met.

Proposed By-Laws Changes

The By-Laws Committee presented the following proposed by-laws changes, as published in the Winter 2023 Patriot Magazine and the Proceedings Book.

Authority to hold EXCOM meetings by members other than the president will be clarified.

Article V, Committees, Section 1, Executive Committee, second paragraph, recommended change to the first sentence: "Three members shall constitute a quorum, which may or may not include the President."

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. FAILED.

Removal of FLSSAR Officers

Article III Officers: Add a new Section 9, Removal of Officers, with the following wording. "In accordance with the Articles of Incorporation, Article VI. - Officers and Management, paragraph (C), states that "the Board of Management shall have control over all officers and committees, and for good cause may declare any office vacant." This declaration of vacancy shall include authority to remove FLSSAR elected officers for good cause.

In accordance with Article I, Section V, Special Meeting, paragraph a., the President shall call for a Special Meeting of the BOM to consider the removal any FLSSAR elected officer below the President.

For good cause, it shall be the responsibility of Senior Vice President to hold a special BOM meeting in accordance with Article I, Section V, to vote on the President's removal.

A vote of two thirds of the BOM membership will be required for removal."

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. FAILED.

Appointment to State Positions of At-Large Members

Article III, Officers, Section 3, Additional Offices, recommended change: Add sentence that states, "No person who is a member-at-large (i.e. not a member of a chapter) shall be appointed to any FLSSAR office or committee."

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. FAILED.

BOM Meetings

The ability to change the agenda of the BOM at the time of the meeting will be addressed.

Article II, The Board of Management, Section 3 Meetings, recommended change to first paragraph, as follows: "The currently elected President of the FLSSAR shall normally preside over the BOM meetings, but alternate officers are authorized to preside at these meetings if the President is unable to fulfill these duties for any reason."

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. FAILED.

Annual Elections

Article III, Officers, Section 2 Nomination and Election of Officers, paragraph C. current wording states: "Elections will be held at the Annual Meeting."

Recommended change: "Elections will be held at the Annual Meeting by those in attendance. Electronic voting and proxies are not authorized."

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. FAILED.

Appointment of State Elected Officer Positions

Current wording: "If any elected officer shall be unable to serve his full term because of a death, resignation, or disability or other cause, there shall be an appointment by the President for the unexpired portion of the term, subject to confirmation by the Executive Committee (by phone conversation, e-mail or letter, with formal confirmation at the next scheduled BOM per Article II - Section 2.F." Recommended change: "....subject to confirmation by the majority of the Executive Committee members..."

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. FAILED.

Public Statements Regarding FLSSAR Business Matters

The process to make or release public statements regarding FLSSAR business matters will be clarified to ensure statements are fully sanctioned

Article VIII Miscellaneous, Section 2, Authority to Speak for the FLSSAR, recommended change:

Add sentence, as follows: "Members of any FLSSAR authorized committee shall obtain approval from their respective committee chairman before releasing any report to the general membership of the FLSSAR. Due to possible legal repercussions, all reports, findings, or other written documents generated as a result of any FLSSAR committee which may adversely reflect on the organization or an officer of the FLSSAR shall be reviewed by the EXCOM for approval prior to release."

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. PASSED.

Electioneering

By-Laws do not address electioneering. Suggested change to Article III, Section 2, Nomination and Election of Officers, paragraph A. Nominations, (2) Nominations from the Floor, to the following: Add sentence, which states: "Nominations via electronic media, mass mailings, etc. in advance of the Annual meeting to the FLSSAR membership for alternate names or an alternate slate of FLS-SAR officers shall not be allowed."

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. FAILED.

Schedule of BOM and Annual Meetings

Article II, Section 3, Meetings, currently states, "One meeting will occur on the day before the date fixed for the opening of the Annual Meeting of the State Society, to be known as the Spring Meeting."

Recommended change to the following: "One meeting will occur on the day before, or on the date fixed..." This will allow for flexibility in scheduling the BOM and annual meeting.

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. **PASSED.**

Chair Positions

Article III, Section 6, Holding Multiple Offices, currently states, "Any member except the President may be elected to, and concurrently hold, more than one, but not more than two, of the offices listed in Section 1 of this Article."

Recommended change: Add an additional sentence that states, "The currently elected President will not hold or chair any committee other than the Executive Committee."

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. FAILED.

FLSSAR Contracts

The current By-Laws require the Treasurer to hold all contracts. Over the years, the practice has evolved that the Secretary now holds contracts.

Article IV, Duties of Officers, Section 4, Secretary, paragraph g., as written, states, "Sign documents for official certification; sign checks as authorized; arrange for bonding of officers as directed by the BOM; and maintain the archives of original records of the FLSSAR; including all corporate resolutions...."

Recommended wording: "including all corporate contracts and resolutions..."

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. PASSED.

FLSSAR Assets

The By-Laws will be updated to address who will hold FLSSAR assets.

Section 12, Sergeant-at-Arms, current wording includes the following clause, "custody of the paraphernalia belonging to the FLS-SAR..."

Recommended change to include the words "other assets" after "paraphernalia."

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented.

Scott Breckenridge moved to amend the wording to "and other assets". SECOND Doug Gibbens. PASSED.

Scott Breckenridge moved to amend the wording to "and other physical assets". SECOND Doug Gibbens. PASSED.

The motion **PASSED** as amended.

Number of Members Needed for New Chapter

At May BOM, the topic of number of members required for a new chapter was raised. The By-Laws will state that the number of members must be a minimum of 15.

Article I, The Society, Section 2, Chapters and Regions, recommended new paragraph, as follows:

New FLSSAR state chapters may be authorized, provided a minimum of 15 existing FLSSAR members in good standing located in the area where the new chapter intends to hold meetings agree to support and participate in the new chapter. Petitions for a new chapter will include a statement that coordination with existing chapters within the region, as defined by boundary of the applicable Regional VP, has been conducted to ensure conflicts will not exist regarding community related activities, such as JROTC, etc. (updated revision)

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. FAILED (21 nay to 20 aye).

Transfer of Members

The By-Laws will formalize the process for transferring membership from one chapter to another so that each chapter and the FLS-SAR are aware of the changes.

Article I, The Society, Section 3, Members, new paragraph c. as follows:

"c. Members may request to transfer from one FLSSAR chapter to another by submitting a written request to the current chapter Secretary. The member's current chapter Secretary will coordinate the transfer with the Secretary of the new chapter. The new chapter Secretary will ensure the transfer is noted by the FLSSAR state secretary." (updated revision)

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. PASSED.

NEW: Reference to Committees:

Current By-Laws has an error. Currently, Article V, Committees, Section 6, Other Committees, (a) 1, states "Statutory Committees are established by, and its mission statement is set forth in, the By-laws (see Article VIII - Section 3 below). However, Article VIII, Section 3 addresses Amendments.

Recommended change to (a) 1: "Statutory Committees are established by, and their mission statements are set forth in, the By-Laws (See Sections 1-5 above)." (new change)

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. PASSED.

NEW: Financial Review Committee

Article V, Section 2, Financial Review Committee wording does not mention any chairman for this committee. All other statutory committees mention a Chair, appointed by the President.

To avoid confusion, and ensure the President does not chair this committee, the following wording is submitted. Recommended change: "The President shall appoint, and name the Chairman of, a Financial Review Committee...."

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. PASSED.

Article V. Section 6

Replace all references to "mission statement" with "charter".

MOTION – The By-Laws Committee moved that the proposed change be adopted as presented. PASSED.

President Matt Mathews had to leave the meeting due to health issues. SVP Steve Fields took over as Chair of the meeting.

Election of Officers

The Nominating Committee presented its slate of officers for 2023-2024, as published in the Proceedings Book.

Chairman Dwight Elam announced that the Nominee for Recording Secretary, Len Crame, had to withdraw due to health issues.

Nominations were requested from the floor and Doug Gibbens volunteered.

Congratulations you Florida Sons of the American Revolution. Due to your hard work and dedication, our Society is the talk of the SAR. The 133rd Congress of the Sons of the American Revolution was held in Orlando this year – as you may have heard. From day one of that event all the way to this afternoons commemoration of the Battle of Kings Mountain, SAR members from around the country have come up to me to congratulate Florida for having "the best Congress ever". This has come from attendees, general officers, and regular members who have seen and heard what we were able to accomplish. To all of you Florida Sons, I salute you, your dedication to our patriotic, historic, and educational goals, your spirit of service, and the outstandingly positive and comradely spirit through these challenging past few years. Congress was a huge challenge. Without the support of hundreds of our members, we could not have accomplished this daunting enterprise let alone this triumph. Be proud of your efforts. You have shown the SAR-atlarge that the Florida Society and its members are true descendants of our patriot ancestors. Thank you all.

So, to the real report –

June saw many chapters and color guard units participate in Flag Day activities. I was able to attend the Sara De Soto Regents Council combined DAR/CAR/SAR luncheon and celebration. I was proud to participate in the posting of the colors by the Saramana Chapter and their Camp Nathaniel Green Color Guard.

In July, Patriot Sunday meant compatriots of all faiths attending religious services on the Sabbath closest to Independence Day. Many wore colonial attire or participated in observances to celebrate the founding of our nation - recognizing that our patriot ancestors were men and women of faith. If you've never had the opportunity, I encourage you to coordinate with your own place of worship and encourage them to renew this hundreds of years old tradition.

Independence Day was celebrated across the state with many chapters submitting letters to the editors of their local papers reminding readers of just how daunting the struggle for freedom was. SAR members across the state were instrumental in obtaining proclamations from local, county and even state governments celebrating this momentous event in America's history. Parades were held, solemn ceremonies seen at cemeteries were held, BBQ gatherings were hosted, and of course there were the fireworks. I hope that your 4th was as joyful and inspiring as mine.

Just days later the Florida Society hosted the 133rd Congress of the Sons of the American Revolution. Hundreds of compatriots and spouses descended on Orlando and were greeted with all the cheer and hospitality that could be hoped for. Special appreciation goes out to the dozens and dozens of volunteers that made this event a real success. The 2023 Congress planning Committee and their team of volunteer leaders created a team that worked hard, stayed positive, and accomplished every task put to them.

In July I also had the opportunity to sit down with the Excom of the Lakeland Chapter along with many of their committee chairs and learned how they are working to overcome the challenges that many chapters are facing – slower growth than recent years, difficulties in engaging with the public schools in a meaningful way, and how to get more engagement with their communities. They have a plan, great leaders, and the drive to do great things. I encourage all of your chapters to develop plans in these and other areas to focus your precious resources, time, and treasure to grow your chapters and be more impactful in your communities.

The Excom has had numerous email discussions and a few votes on administrative matters over the summer months. Our final zoom meeting will be the Sunday prior to this coming Board of Management meeting. A report on these activities and the results of that meeting will be given at the BoM.

As usual, September saw the SAR supporting DAR sponsored celebrations of Constitution Week across the state. The Sons of Liberty Brigade Color Guard (the FLSSAR state color guard) posted the colors for the Florida State DAR Fall Forum. Over a dozen marched, while many more attended the multi-day event. SAR compatriots volunteered at an information table to educate people on the SAR as well as gather information on prospective members. The leads generated at that event have been disseminated to chapters closest to where the prospect lives. With follow up, these prospects can become part of our next generation of compatriots, program chairmen, and even chapter or state leaders. Don't let these leads go cold. Former President Matt Mathews now heads the Membership Promotion and Retention Committee. If you need help generating leads, developing them into real prospects, or finding help with membership in general, he can connect you with the resources and assistance to accomplish these things. He is also a great resource in reconnecting with members that have dropped in recent years to encourage them to return and support the SAR mission. Show them what we have and are going to accomplish and that enthusiasm gets people to want to be part of something positive I our communities and our nation.

Supporting and recognizing the service and sacrifice of our veterans is a big part of how the SAR engages with the community. FLSSAR leadership got notice late on a Saturday in September that a recently identified WWII soldier was being returned from his anonymous grave in Europe to the South Florida National Cemetery. By the start time of the morning ceremony the following Tuesday, a dozen SAR compatriots and guardsmen from four chapters along with three members of the Ladies Auxiliary were in attendance. The ceremony for PFC Roy Searle, who died in the hectic fighting during the Battle of the Bulge, was held with full military honors and the solemnity appropriate for a fallen soldier. The Florida Society has now coordinated with the agencies that are involved with the return of recently identified soldier remains from all American conflict eras. When notice comes down, chapter presidents, color guard commanders, and veterans committee chairmen will all receive the information. It is my desire that this information be disseminated to all their chapter compatriots and the ladies of our local DAR chapters so that when the opportunity arises in their area, they too can support these solemn occasions as they can. If they don't hear about these events, how can they support them? First Lady Jill and I made a nearly eight hour round trip to honor PFC Searle's sacrifice. It was worth every minute.

It was built by students from The Villages Charter High School's Youth Construction Academy. In speaking with one of the students, we learned that a company came in and poured the foundation, but the students did all the rest. The dedication ceremony was quite moving. SAR was there to present a US flag, pole, and mounting bracket to the Duket family.

At our May 13 meeting, Mr. John Stewart portrayed our third US President Thomas Jefferson. He told how a Virginia lad, who lost his father at age 14, came to write the Declaration of Independence and went on to become President. He also commented on our US Constitution and some of the thinking behind it. In addition to the excellent program, we took in five new members. In mid-May, for the third year in a row, The Villages SAR presented Citizenship awards to students in the 5th, 8th, and 12th grades at The Villages Charter Schools. Each winner received a certificate and a check. It is fun to be at the award ceremonies and get to meet the award winners, which are chosen by their teachers and counselors. It is also an opportunity to get the word out about SAR. On Sunday, May 28, a contingent of The Villages SAR members and spouses was joined by a few Wings of Gold (a Naval Aviation group in the Villages) members and their families to place Memorial Day flags in section 402 of the Florida National Cemetery in Bushnell.

On Saturday, June 10, our guest speaker was Betsy Ross, as portrayed by DAR member Tracy Suarez. Ms. Suarez is a member of the Ponce de Leon Chapter of DAR in Winter Haven. Ross, a young widow, attended Christ Church in Philadelphia along with the George and Martha Washington, and sat in the pew next to theirs. Washington wanted one flag to unite the colonies. Up until then, every colony and every militia group had their own flag! The design Washington proposed had six-pointed stars, but Betsy insisted on a five-pointed star which is easier to cut out using four folds of a cloth square and making just one cut. The timing of this program was excellent since Flag Day is June 14.

The Villages SAR had an excellent meeting today on July 8, 2023, with 66 people in attendance. Perhaps the most exciting part was awarding the SAR Life Saving Medal to Villages Charter School student, 14 year old Annabelle Miller. Annabelle saved another girl's life on the evening of June 3 while standing in line at the concession stand of a drive-in movie! The girl fell face down on the

pavement, hitting her head, and was bleeding. Annabelle rushed to her side, and without concern for the blood, turned her over, and began CPR compressions until she began breathing again. Annabelle was a true hero that day and we wanted to recognize her heroism. We also took in one new member today, Mr. Danny Felt.

The main program was from seven members of Project Appleseed, who told the events of April 19, 1775, that led to the start of the bloody eight-year American Revolutionary War. British troops learned that day that the American militia groups may have been simple farmers but they knew how to fight! The Appleseed Project strives to promote teaching of American History and marksmanship.

Chapter Past President Dr. Donald Wyman gave the program at our August 12 meeting about the CIA Museum. Our attendance to hear the program was 56. The CIA Museum is in the heart of the Langley, Virginia CIA Headquarters Building, which is not open to the public. Don retired from the CIA after a 22 year career there, and his program resulted from two private tours he was given. His most recent tour was in September 2022 on the 75th Anniversary of the agency, at which Don was an honored guest. Don's program had to be approved by the CIA Director and the Office of Security.

The CIA was established on September 18, 1947 by President Harry Truman, but prior to that on June 13, 1942, President Roosevelt formed the OSS (Office of Strategic Services). The purpose of both agencies was to gather information internationally to help protect the US. Don had a lot of interesting stories about the activities of these agencies during WW2 and the "Cold War".

After his presentation, President Jerry Byers awarded Don with the Chapter Distinguished Service Medal in recognition of all that he continues to do for The Villages SAR.

We also took in two new members: James Barr and Bruce Smith.

The Villages Chapter of SAR held its September 9, 2023 meeting with 60 people in attendance. We took in three new members plus one member who transferred in from another chapter.

Our speaker was retired Navy Captain Don Fraser. Don was a Naval flight officer, Purple Heart recipient, with three Meritorious Service Medals, the Legion of Merit, the Bronze Star for combat, and various campaign ribbons, and was an instructor in the Naval Academy. He spoke about various aspects of the Army Air Force during World War II and some of its better known heroes. The Boeing B-17 bomber, known as the "Flying Fortress", dropped more bombs than any other US aircraft during the Second World War. Many of these aircraft flew out of bases in East Anglia, Great Britain. More than 300,000 Americans settled into that area during the war. The B-17 Flying Fortress was a four-engine, heavy bomber developed in the 1930s for the United States Army Air Corps (USAAC). It was a fast aircraft that flew as high as six miles above the earth – quite remarkable for a bomber of its era. Some of the famous aviators of that war include "Lucky" Luckadoo (at age 101, he is the last living pilot of the Flying Fortress), "Rosie" Rosenthal, who flew 52 missions at a time when you could leave the service after 25, Chuck Yeager, and screen actors Clark Gable and Jimmy Stewart (who was a Brigadier General when the war ended).

We announced with sadness the death of member Greg Young, who passed away on August 26, and we circulated a sympathy card for signatures. We also asked prayers for one of our youngest members, 5 year old Ryland Kautz, who is being treated for stage four brain stem cancer.

Our program in October will be Ms. Judy Goby-Oxtoby, who will present the history of the Tomb of the Unknown Soldier. Ms. Goby-Oxtoby is the Honorary Chapter Regent of the Big Cypress DAR chapter in Naples, Florida.

- On September 20, 2023, the Fort Lauderdale Chapter purchased 10 wreaths for \$170 that will be used as part of the Wreaths Across America Program celebrated in Broward County on December 16, 2023, at the Forest Lawn North Memorial Gardens in Pompano Beach, Florida.
- For 2023 as of August 31, 2023, the Chapter awarded 59 medals and/or certificates to participants in the various youth programs it supports. The breakdown: eight (8) Sea Cadets were awarded the Bronze Good Citizens Medal; thirty-two (32) JROTC Cadets were awarded the Bronze Medal; and nineteen (19) certificates were presented to 2023 approved Eagle Scouts residing in Broward County.

• A word about **BOM members**:

Not everyone that attends a Board of Management Meeting is entitled to vote. I've reprinted the relevant section from the FLSSAR By-Laws here.

Section 1 Membership

The membership of the BOM shall include only persons who are members in good standing of the FLSSAR, and who are listed in at least one of the following categories:

- a. persons who are lifetime members of the BOM by virtue of being a past President of the FLSSAR, a recipient of the Patriot Medal, or an incumbent or past elected officer of the NSSAR;
- b. persons who are members of the BOM by virtue of being, and while being, an elected officer of the FLSSAR; appointed incumbent FLSSAR Committee Chairman; an incumbent National Trustee from Florida; an incumbent Chapter President; and the most recent Past President of a chapter, i.e., the person who preceded an incumbent Chapter President in office; if a chapter has no most recent Past President it shall name another of its members to serve on the BOM;
- c. persons who have been appointed by chapters having more than forty members on the basis of one additional member of the BOM for each forty chapter members or fraction thereof more than the first forty, the term of office of such additional members of the BOM to be coterminous with that of the Chapter President incumbent at the time of their appointment to the BOM.

A member of the BOM who is unable to attend a meeting may name, in writing, another member of the FLSSAR to attend and act in his stead; provided, however, that no person may have more than one vote. Members of the FLSSAR who are not members of the BOM may attend and participate in debate but may not vote.

Recommended Application Submission Improvement Areas:

- Ensure all required signatures and dates are present as required for type of applications being submitted.
- Do not submit NSDAR web site printouts from the "Descendants Database Search" or NSDAR "Patriot Index" information. This information is not acceptable for either lineage or service and NSSAR does not want this unacceptable information included with any application.
- Ensure <u>ALL</u> applicable information contained on all submitted proof documents is recorded in the applicable sections of the application. Do not list references that are not being submitted and list all documents that have been submitted.
- Ensure all known spouse information is included when known for each generation even when the spouse is not in direct lineal descent. This will prevent applications from being pended when two persons of the same name are living in a given area and this information would assist in identification of the correct person used on the application.
- Only one set of proof documents are required to be submitted with each application. This also applies when submitting more than one application under the family plan criteria. One set of proofs only for the common documents used by all the applications in the group. His does not apply to multiple supplemental applications submitted at the same time. Supplemental applications are always considered separately and require complete sets of documentation.
- Use a red pencil to underline applicable data on all proof documents and DO NOT USE any type of highlighter.
- Copy of entire legible original census page must be submitted when using a census as a proof document. Ancestry.com
 census transcription pages cannot be used in lieu of the original census page but, it may be used in addition to the original
 page.

Finance Committee

W. Richard "Dick" Young, Chairman

Attached to the Proceedings Book are summaries of cash receipts and cash disbursements for the nine months ended September 30, compared to budget and including the proposed budget for 2024. (see Appendix F)

2023 Cash Receipts and Disbursements

Operations - There are no great surprises in the summaries of cash receipts and disbursements for the first nine months of 2023.

- Dues collections were on budget.
- The contribution from the Operating Budget Trust Fund has still not been transferred.
- BOM registrations and receipts were above expectations in May, but that also means related disbursements will also exceed budget.
- Registrar receipts are up, new member applications seem to be running ahead of budget.
- There have been no significant contributions, other than Congress related contributions.
- The amount of National Dues passed to Louisville was slightly more than budget.
- As approved by the BOM in May, the SVP Expenses budget for the last eight months of 2022 was carried over to 2023 and funded to then SVP Steve Fields
- Once again the approved budgets for the Educational Outreach Committee, Historical Sites Committee, New Chapter Development Committee and History Fair Committee have not been used.
- There was SAR involvement in the Galvez Day/Battle of Pensacola Commemoration in May; however, no request for reimbursement has been submitted.
- The Brevard Chapter has made a request for reimbursement for the Commemoration of the Last Naval Battle in March, which has not yet been funded.
- I have not yet found Liability insurance coverage that is reasonably priced; however, I may have finally been pointed toward a contact that may be helpful. I hope to have more to report by BOM weekend.
- Our Oration contest winner was not selected as a National finalist, so we were able to save the budgeted amount for travel expenses.
- The approved budget is a deficit budget; however, I expect the Society will finish with a budget excess due to saving from
 not funding a liability policy, savings on the Oration Contest expenses and saving on other committee budgets not utilized.

<u>Congress</u> – The BOM approved Congress budget anticipated raising \$90,000 and spending \$80,000 leaving a \$10,000 cushion. Due to your generosity, a small grant from the George Washington Endowment Fund, the diligence of the Congress Committee and the many volunteers who helped put it together and the advice from National Congress Planning Committee Chair, Paul Callanan, we were able to raise over \$95,000 while spending only \$60,000 leaving \$35,000 in the Congress Fund.

Proposed 2024 Budget

There is little change from budgets of prior years other than estimating the effect of the National dues increase on collections and the annual payment to National. The proposed budget is again a proposed deficit.

- The budget again includes \$2500 for liability insurance, though I hope to do better as discussed above.
- The Oration Contest budget was increased to allow for travel expenses to Pennsylvania, based on the assumption we have at least one contestant and they are included in the National finals.
- The budget includes our third and last \$1,000 contribution the BOM committed to the Florida Veterans Foundation. However, I believe we should continue to support this organization.
- Medals and Awards are difficult to budget as we always do what we need to do to recognize our most active compatriots each year.
- Several committees see a small increase in budget as their costs continue to increase more due to inflation than excess spending.
- The aforementioned committees that did not utilize their 2023 budget were again budgeted for 2024.

The Strategic Planning Committee's 2023 Report included recommendations to add stipends for more Executive Committee members, increase the expense allowance for the President and SVP, hire a contract webmaster and more. For the last few years, others have asked to increase the budgets for the Youth programs which have been the same for at least the last 10 years. None of this is possible at this time. As noted above, we are already budgeting a small deficit.

MOTION - Dick Young moved to open two accounts for Certificates of Deposit at Wells Fargo Bank, as follows:

- \$50,000 in the Wells Fargo special 11 month CD.
- \$25,000 in the Wells Fargo special 3 month CD.

SECOND Jeff Brunelle. PASSED

MOTION - The Finance Committee moved to reverse the allocation of \$4,000 to the Congress Fund back to the original allocation of \$2,000 each to the Meeks and ETF funds. **NO SECOND REQUIRED**.

Ray Wess moved to amend the motion to have all \$4,000 allocated to the Meeks fund. **SECOND** Jeff Brunelle. **PASSED.** The original motion **PASSED** as amended.

MOTION - The Finance Committee moved to have the 2024 budget approved as presented. NO SECOND REQUIRED. PASSED

MOTION - Scott Breckenridge moved to allocate the proceeds from sales of excess congress bags to a new Color Guard Fund. **SECOND** Harry Rinker. **PASSED**

The NSSAR Official Handbook Vol 5: Individual Medals, Awards and Certificates was revised and updated effective April 24, 2023. The Medals Order of Precedence for wearing of the medals was completely revised. The Medals and Awards Committee would like to remind our compatriots to review the handbook to ensure that you are in compliance with the new guidelines. Additional several new medals were added to the handbook which will allow us to recognize our members for their contributions in the education of our young generations about our American History and the American Revolution.

- 1. **Henry Knox Achievement Medal**: This medal can be awarded by either the State (Silver) or the Chapter (Bronze). This medal may be presented to a Compatriot or non-SAR member to recognize outstanding contribution, achievement, accomplishment, deed, performance, or effort that advances the mission, governance, programs, or activities of that State Society or Chapter.
- 2. **Outstanding Young Member Medal:** This medal can be awarded by either the State (Silver) or the Chapter (Bronze). This medal is awarded to a member of the SAR who is 40 years old or younger. The recipient shall have exhibited continued exemplary service to the Society at the State or Chapter level, especially focused on leadership and service to youth and younger members.

- 3. **Youth Education Medal:** This medal can only be awarded at the State level and recognizes sustained education of our youth by members of the SAR. The Compatriot presenting should develop and submit Presenter Sheets to the National Education Committee. Please refer to the NSSAR Handbook Vol V dated April 24, 2023 for further guidance on the requirements for this award.
- 4. **Youth Color Guard Medal:** This medal is earned for participation in SAR Color Guard events (National, District, State or Chapter) by any youth in colonial uniform or attire.

Recommendation for all State level medals and awards should be sent to the Chairman, Medals and Awards Committee as early as possible so we can ensure approval and availability of the requested medals prior to the Spring BOM/Annual meeting in May 2024.


During this meeting, two very important topics will be presented and discussed:

I. THE AMERICA 250 NSSAR 5-YEAR OPERATIONAL PLAN

The NSSAR Executive Committee APPROVED the 5-Year Operational Plan through 2026 at the 3 March 2022 meeting during the 2022 Spring Leadership conference in Louisville KY.

SPECIFIC ACTIVITIES AND RECOMMENDATIONS:

I. FIVE-YEAR UPDATE – OPERATIONAL PLAN THROUGH 2026



Goal #1 of the five-year operational plan through 2026 is to OPEN THE **SAR EDUCATION CENTER AND MUSEUM** during the 250th Anniversary of the American Revolution. A video presentation of the SAR Education Center and Museum will be viewed during the meeting.

STRATEGIC PLANNING PROPOSAL:

The ETF Disbursement Committee and the ETF Trustees should consider recommending reimbursements to all Florida SAR Chapters that contribute to the Education Center and Museum, on a pro-rata basis, up to the undistributed amount available on November 15 of each year, after taking all prior Chapter reimbursements into account.

For the past several years, the Endowment Trust Fund has provided for distributions to Chapters in the range of \$25,000 to \$31,000, with less than half of that amount actually being disbursed to the Chapters. For 2023, the maximum allowable reimbursements to all Chapters is \$27,327.43; yet only \$3,564.04 has been requested and reimbursed as of 31 August. Total reimbursements in prior years have ranged from \$8,000 to \$13,000.

The income from the Endowment Trust Fund (ETF) is intended to be used to support Chapter philanthropic activities, and the Education Center and Museum will be our gift to America on the 250th anniversary of the American Revolution. This action will allow the collective Chapters of the Florida SAR to make a significant Pledge in the \$100,000 range, payable over the next several years.

II. ONLINE DUES BILLING & COLLECTIONS; AUTOMATIC DUES RENEWALS

One of the stated Goals and Objectives of the 5-year Operational Plan is the streamlining of the Dues Billing and Collection process, and the reduction of Membership Non-Renewals that may be caused by a lack of organized follow-up, or the inability to make Online payments for annual Dues, Fees, Events, and Donations.

FLSSAR and a few Chapters have elected to serve as Beta Testers for **CLUB EXPRESS**. a potential Statewide canned software system that will allow Online Dues Billing & Collection on a statewide basis. Once fully-implemented on a Voluntary basis, this system could very well be extended to the NSSAR, for a Nationwide Dues Billing & Collection system.

- a. National Dues Billing and Collection from HQ Online Payment Capability Automatic annual dues renewals online payments to Society and Chapter of their portions of dues collected.- elimination of manual reconciliation process.
- **b.** Other non-profits of similar size and structure have reduced their membership retention "Drops" from 16% per year to 6%-8% by moving to a national billing process.

If you believe your Chapter can benefit from Online Payments and an automatic Dues Billing & Collection process, please be sure to attend this Strategic Planning Committee meeting! – It's open to everyone! It will also be live online during the Strategic Planning Committee meeting.

Several other recommendations have been made to the FLSSAR Executive Committee, which are under consideration. We will summarize any approved recommendations during the online meeting.

Your Committee Chair attended the Florida Society Children of the American Revolution Summer Packet Meeting on June 9-10 in Clearwater. As part of the meeting, I had the opportunity to meet with all the members and senior members present, in small groups, to present our various youth programs.

C.A.R. Next Step: The Next Step Program is being initiated by Senior State President Dr. Holly Hamilton. The purpose of the Program is to encourage the members of the C.A.R. to take the Next Step and join the SAR or DAR as soon as permitted. For the SAR, that is anytime as there is no minimum age limit to submit a new member application. You are asked to identify the young men in the local C.A.R. society, invite them to your SAR Chapter meetings and encourage them to become Junior Members of the SAR. All they need is a record copy of their C.A.R. application, a letter of good standing from National Society C.A.R. and a competed SAR Junior Member application. They even get a significant discount on application fees.

Youth Color Guard Medal: Earlier this year, National SAR approved a Youth Color Guard Medal. The details are included as Appendix C to the BOM Proceeding Book. Briefly, any individual under the age of 18, male or female, who participates in three SAR Color Guard events in three different years, in uniform or colonial attire qualify for this new color guard medal. The committee began meeting in August, and is working on developing a plan of action for not only supporting and promoting the current battlefield celebrations, but also promoting those that are just being established.

Dates for the Established Battlefield Celebrations in 2024 are: Last Naval Battle – 16 March 2024 (VMC Merritt Island) Thomas Creek – 23 March 2024 (Seaton Creek Historic Park Preserve) Battle of Pensacola – 8 May 2024 (Pensacola)

America 250 Celebrations

The Historic Sites and Celebrations Committee is taking an active role in helping the state Society and local Chapters establish and promote programs that celebrate and promote the 250th Anniversary of the founding of our country. To this end, the Committee will be hosting a meeting on Saturday of the Fall BOM to provide specific updates about the America 250 program, a brief training presentation, and most importantly – answer questions from compatriots on how chapters can best contribute to the America 250 Program. In addition, the Committee will be providing training and various other materials to chapters throughout the year to aid in their planning and implementation efforts.

America 250 - Florida/Legislative Update: Per the Legislative Affairs office for Florida Secretary of State Byrd, for the state of Florida to establish an America 250 Commission, it would require a legislative act. While no legislation was introduced in the 2023 session, discussions are already underway for legislation to be drafted as soon as legislators return to Tallahassee to begin committee work in September. The FLSSAR has been in contact with State Legislators and is seeking to take an active role in the ensuring that Florida joins the 38 other states who have already established an America 250 Commission. Hopefully by the time of the Fall BOM, I will have more substantial information that I can share regarding activity in the Florida Legislature.

Thomas Creek Revolutionary War Battle Ceremony Report – David Ramseur

The 247th Anniversary Ceremony of the Revolutionary War Battle of Thomas Creek Revolutionary will be on Saturday 23rd March 2024 (not 30th March 2024 the last Saturday as Easter is the 31st). Since 2015 when we supported the City of Jacksonville and especially the Trust for Public Land and we were able to preserve 846 acres that included our Thomas Creek Battlefield site. As information, the \$7.1 million cost of the Seaton Creek Historic Preserve land was acquired by the City of Jacksonville (with unanimous approval of the City Council) in 2014. Funding for the purchase came primarily from off-shore oil company leases plus environmental funding with only minor cost to our taxpayers.

We are looking forward to next year's 247th Anniversary Thomas Creek National Color Guard ceremony, especially with our support from our various SAR, DAR and C.A.R. chapters from Florida as well as others from inside and beyond our South Atlantic District. At this 247th Anniversary of this battle we are honoring our patriot ancestors who fought in this battle. As in the previous years, we are expecting another good turnout from our SAR Compatriots, DAR Daughters and C.A.R. Children plus other heritage organizations and guests as they join with us in honoring those patriots who fought in this battle for our Independence and that we will soon be celebrating our Country's 250th Anniversary.

Funding for the purchase came primarily from off-shore oil company leases plus environmental funding with only minor cost to our taxpayers

We are looking forward to next years 247th Anniversary Thomas Creek National Color Guard ceremony, especailly with our support from our various SAR, DAR and C.A.R. chapters from Florida as well as others from inside and beyond our South Atlantic District. At this 247th Anniversary of this battle we are honoring our patriot ancestors who fought in this battle As in the previous years, we are expecting another good turnout from our SAR Compatriots, DAR Daughters and C.A.R. Children plus other heritage organizations and guests as they join with us in honoring those patriots who fought in this battle for our Independence and that we will soon be celebrating our Country's 250th Anniversary.








Puerto Rico - Our American Cousin

With the new school year for 2023-2024 getting underway, it would be a great time to engage with your local school systems to get involved with the many Youth Award Programs that we offer through the SAR. While I understand from our experiences last year some of the local school systems were reluctant to get involved with our different programs. I would suggest that there are a couple of other avenues that we could explore to get the word out about our Youth Awards Programs and give the students an opportunity to participate. If your chapters are involved with your local DAR Chapters, Scouting Programs or other civic organizations, they offer us a great opportunity to introduce our Youth Awards Programs to both parents and students. I would also recommend looking into the local Home School Programs that are being offered within many of our communities. Most of the entries in all of our Youth Awards Programs this past year came from students that were being home schooled. In fact most of our State winners this year were home schooled students with our Poster Contest winner placing fourth at NSSAR this year.

The 2024 Knight Essay Contest is currently underway with a deadline date of 31 December 2023 for the Chapter winners to be submitted to the FLSSAR State Chairman. Students must submit an original 800 to 1,200 word essay based on an event, person, philosophy or idea associated with the American Revolution, Declaration of Independence, or the framing of the United States Constitution. The essays will be judged based upon its historical accuracy, clarity, organization, grammar, spelling and documentation.

The Chapter's winning essay must be submitted in five parts in the formats indicated as follows: 1. the Application (PDF); 2. the Bibliography (Word); 3. The Biography (Word); 4. The Essay (Word); 5. The Title Page (Word). This will allow the judges to finalize their evaluations of the essay; make any minor corrections as necessary; and submit our State winner to the national NSSAR committee by their February 2024 deadline. FLSSAR prizes for the 2024 contest are \$1,000/\$500/\$250. The NSSAR prizes presented at 133rd NSSAR Congress this year were 1st - \$6,000; 2nd - \$3,000; 3rd - \$2,000; 4th - \$500; and 5th - \$500. See SAR.ORG for complete details.

Goals for 2023-2024

1.JROTC Enhanced Program Award.

Continue working with the Chapter Society JROTC Points of Contact to achieve better results and max participation. If the chapter supports several JROTC units, it should run a local contest to select the best cadet, since only one cadet per chapter may advance to the state competition. The deadline for the JROTC Enhanced Program Award entries must be submitted by 10 Apr 2024. Send completed packets to LTC (Ret) Hans Hunt via email to: airbornerangermp@gmail.com

As you know FL State Society placed first in the JROTC Enhanced contest for 2023. The winner received her award at the Youth Awards Luncheon at the Orlando Congress.

State Award for the JROTC Enhanced Program will be \$1,000 for 1st place, \$500 for 2nd place, and \$250 for 3rd place. The state winner will also receive the State Outstanding Cadet Award (Silver Medallion on neck ribbon and certificate). State winners along with their parents will be invited to attend the Spring FL State BOM for their award. Meals are covered for their attendance. The state winner will go on to compete at the SAR National level. Where the 1st place national winner will receive \$5000 (plus \$1500 travel expense), 2nd place \$2000, 3rd place \$1000, 4th place \$250 and 5th place \$250.

The following criteria applies to a cadet nominated by his/her JROTC Unit for the Outstanding Cadet in the Enhanced Program:

- --3rdyear of a 4-year Program or 2nd year of a 3-year Program (cadet must be a junior);
- -- Top 10% of JROTC Class
- --Top 25% of his/her Student Body Class (verified by the Principal). (Each year we receive entries not in top 25%)

A completed Nomination Form and Recommendations (Endorsements) from the **Senior Military Instructor (SMI)** and the school **Principal** are also required. The Principal's Endorsement must also verify the **Class Standing** and **GPA** of the cadet. A transcript may be provided, but **GPA verification by the principal in his/her recommendation is still required.**

There is a special **Chapter Outstanding Cadet Medal Package** (bronze medallion with neck ribbon and certificate) for the Enhanced Program Winner, available at the NSSAR Store. The OC Medal Package (bronze medal on neck ribbon, ribbon with gold frame and a bronze star, certificate) costs \$45.00. Chapters are encouraged to present the Chapter OC Medal at their regular chapter meeting and then, present it again, at the JROTC Unit's Awards Ceremony or Awards Banquet.

Strongly encourage chapters to offer a monetary award to their winner, and they may also present a Certificate of Appreciation to each cadet nominated for the chapter contest. The Chapter winner of the SAR Enhanced Medal can wear their medallion with neck ribbon at graduation (as long as the Principal approves, which most do). This is an incentive for qualified cadets to know and be encouraged to participate.

- * If the SMI (Senior Military Instructor) has not already been contacted, now is the time for the Chapter Representative (President, Vice President, JROTC Chair) to affect liaison with the SMI at each JROTC Unit supported by the Chapter and reiterate the requirements for the Enhanced Program (sometimes referred to as the JROTC Outstanding Cadet Essay Contest).
- * Topic for the 500-700-word original Essay remains as in previous years "How JROTC has prepared me to be a better citizen of the United States of America." Essay should be doubled spaced (a line between each typed line) using Times New Roman or Calibri font size 11 or 12 and the Cadet's name, rank and Units name and school should be on the first page. The cadet's name should appear on each page of the Essay. A word count must be displayed.
- *The Nominating Form clearly states that additional pages may be attached, as required.

^{*}Lessons Learned from the last couple of years:

- -- SMI should complete Nomination Form with input from cadet list sponsor, chapter/state society. If extra space/pages are needed to answer a section, then please provide it.
- -- All lines of Nomination Form should have an entry SEP!
- -- Be specific, list what the cadet has done (general comments do not assist your cadet) -- List the facts and accomplishments instead of flowery adjectives.
- -- List the facts and accomplishments instead of flowery adjectives.
- List awards example: Varsity Letter Football, All District Tennis, All State Chorus, VFW Medal, Employment, After School programs and Weekend Activity, etc.
- -- Section 1 asks for ranks held by the cadet;

Section 2 asks for positions held, if the cadet is a member of a competition team, this is where it should be listed.

- -- Section 3 asks for school related Academic activities, **not** athletics. Community activities should be placed here if the activity is a service-learning project. [SEP]
- -- Section 4 is for athletics and other activities outside of school.
- -- Strong Endorsements (Recommendations) by Principal and SMI are critical. Try not to repeat the same information about the cadet.
- -- Essays are not proctored, there is no excuse for spelling or grammar errors (please proof) and **must** include a Word Count. The essay should be written in "first person."
- -- Only complete OC Packages will be forwarded to the Judges.
- 2.State Chapters must **make contact with their respective JROTC programs** within their chapter boundaries at the beginning of the school year and maintain contact with them throughout the year providing support to the JROTC/ROTC units where possible. Joint JROTC ventures with SAR chapters is highly encouraged. These joint events can be SAR Chapter meetings, Wreaths Across America, Veterans Day Programs, Attendance at JROTC meets/competitions, attendance at JROTC Change of Command Ceremonies, etc.
- 3. **The National SAR JROTC award**: is to be presented to the Outstanding Cadet in their next to last year of JROTC (a third year Cadet [11th grade] in a four-year program). For a two-year JROTC program, a Second Year Cadet may be selected. Ensure Cadet is a Junior. Whenever possible, presentation will be made by a member of the SAR at the JROTC units Spring Awards Program. The Bronze ROTC Medal with Bar and Certificate is reserved for JROTC Cadets.
- 4.The National SAR <u>ROTC</u> award: The SAR awards the ROTC Medal to foster the principle of the "Citizen Soldier", exemplified by the Minutemen of the Revolutionary War days. This award is presented by a Chapter, a State Society, or the National Society to ROTC cadets who are selected for having a high degree of merit with respect to leadership qualities, military bearing and general excellence. It is the goal of the state for each chapter to reach out to all Universities/Colleges with a ROTC programs within their footprint and present the SAR Silver Medal with Bar and Certificate at the respective awards ceremonies. Make immediate contact with the Professor of Military Science if you haven't already done so, and let them know that this award is available to them for their selected cadet.
- 5.**Recognize JROTC Instructors**. The JROTC Instructors are strong supporters of their communities and participate in multiple events. Strongly encourage chapters to recognize the Senior Military Instructor (Officer) and or the Military Instructor (NCO) at their schools. These SAR awards are available for you to utilize at your discretion:

a. SAR Certificate

b. **SAR JROTC Pin** - The sales generated from these lapel pins is being used to increase the JROTC operating fund, from which we draw each year to cover the costs of the awards, so the more we are able to raise, the more we can increase the annual awards. The pin is 3/4 inch in diameter and costs \$25.



c. The Outstanding Citizenship Award Lapel Pin is a portrait of a Minuteman with the Sons of the American Revolution encircling the upper half and Outstanding Citizenship Award encircling the lower half. A certificate is included with each pin if requested. The cost is \$10 for the pin.



d. Bronze Citizenship Medal with Certificate



6. Donor Recognition

3. USS Stark Memorial Award

FLSSAR President Steve Fields has emphasized to the Veterans Committee that encouraging chapters to compete and complete the USS Stark Award is one of this committee's primary responsibility, immediately after recognizing our Veteran members. The USS Stark Memorial Award recognizes outstanding chapters and state societies within the SAR for their support of Veterans. The criteria established for the Stark Report determines the winners of the awards presented at the national and state levels. All chapters, please be aware that there are forms for tracking and reporting USS Stark information available on the national website. The tracker is a great aid in maintaining a working list of service to veteran activities and participants throughout the year. It will make reporting at the end of the year a much easier prospect. Florida is one of the SAR's largest member states and has a huge proportion of veteran residents and members. Even if we do not report everything, each chapter is responsible for reporting activities supporting veterans every year through the USS Stark Reporting Form. Take a few moments now to start collecting your chapter's efforts. The committee looks forward to recognizing every chapter that supports veterans — whether in the SAR or our communities at-large. Also, chapters should survey their new members to ascertain if they are veterans. If so, it is strongly recommended that the chapter gather the information necessary for recognition of their military service. Submitting this information to the state and national societies will allow the awarding of a Certificate of Patriotism (provided at no cost to the chapter by the NSSAR).

- 4. **The Veterans Affairs Committee** continues to encourage Chapters to expand the membership both the *FLSSAR Veterans Battalion* and *NSSAR Veterans Corps* with Compatriots who served honorably in the armed forces. Chapter Presidents encouraged to promote Veterans Battalion program and are contacted quarterly to ID new candidates.
 - a. Committee member Lanman reviews all Veterans Battalion requests within 24 hours of receipt of both the required FLSSAR VB application form and DD-214. Chapters are mailed a VB acceptance letter and Certificate within 48 hours for Compatriot presentation.
 - b. Chapter Presidents are requested to personally present the Veterans Battalion Certificate along with the authorized Military Service or War Service medal to approved Compatriots at a chapter meeting. The chapter is encouraged, but not required, to purchase the medals for each compatriot directly from SAR.org.
 - c. Chapter Presidents are reminded that the *SAR War Service Medal* is only authorized for Compatriot veterans with proof of war service in a DOD designated "*Combat Theatre*" as noted on their DD-214. Non-combat related military service qualifies for the *SAR Military Service Medal*. Both medals carry an equal SAR rank.
 - d. The committee continues to support Chapter Presidents and the NSSAR Veterans Corps committee to help *FLSSAR* Veteran Battalion members apply for the *NSSAR Veterans Corp* recognition.
 - e. Veterans Battalion Roster is updated quarterly on the *FLSSAR* web site listing all Veterans Battalion members by Region & Chapter.

Summary: The Youth Color Guard Medal is earned for participation in SAR Color Guard events (National, District, State or Chapter) by any youth in colonial uniform or attire.

Description: The medal is silver in color with a blue outer ring. It features on the obverse a color guardsman and drummer. It bears the inscription "SAR Youth" on the top perimeter and "Color Guard" on the bottom perimeter. The reverse features a wreath on the outer perimeter and blank spaces for name and date of presentation. It is suspended from a chest ribbon with equal stripes of red, white, and blue centered on a blue and buff ribbon. It is available in miniature and comes with a certificate, which should be engrossed and presented with the medal.

Qualifications: This medal may be presented to any individual who, while under the age of 18 years old, participates in a minimum of three events per year for a minimum of three years. The years do not need to be continuous. Any SAR event that includes a Color Guard at National, District, State or Chapter may be counted towards the award. The youth must be in uniform or colonial dress and participate as a member of the color guard.

Special Application Required: Youth who believe they qualify for the Youth Color Guard Medal must complete the appropriate form setting forth their qualifications. This form is available on the SAR website and must be submitted to the Chapter or State Color Guard Commander for review and approval.

Restriction on Events: Double-counting events is not permitted. Any events used to qualify for the Youth Color Guard Medal may not be used simultaneously to qualify for any other Color Guard Medal (Molly Pitcher, Von Steuben, Silver, or Bronze). Additional qualifying events over and above those used to qualify for the Youth Color Guard must be used to earn the other Color Guard Medals.

Special Look Back Period: An individual may count events from 2018 forward so long as that individual was a youth (under 18 years old) when the individual completed the required service. Events may not be double counted; if an individual counted events attended as a youth toward any other Color Guard Medal (Molly Pitcher, Von Steuben, Silver, or Bronze), then those same events may not be used to qualify for the Youth Color Guard Medal.

Subsequent Presentation NOT Authorized: A youth may receive this medal only once. Oak leaf clusters or other ribbon attachments are not authorized.
