President Gaskins called for a vote to support all unopposed candidates. Motion carried unanimously.

President Gaskins called for a vote for the two candidates for Treasurer General. The vote was a tie.

A motion was properly made and seconded to endorse the qualifications of both candidates for Treasurer General. Motion passed. No action was taken on the or support indicated for either candidate for Genealogist General.

South Atlantic District Vice President General

Earl Matthews was nominated to be the FLSSAR candidate for SAD Vie President General. There was unanimous approval.

Reports of National and State Officers

William Allen Greenly, Treasurer General, brought greetings from President General Daryl Addington and the 37,000 members worldwide of SAR. TG Greenly discussed the financial situation of national and the steps being taken to improve that position.

State Officer Reports:

All reports that are in the book are accepted as written except as noted below.

<u>Regional Vice Presidents</u> – no report from any RVPs except the Northeast & Southwest Region Vice President <u>Chancellor</u> – no report

Committee Reports

All reports that are in the book are accepted as written except as noted below.

<u>Finance Committee</u> – Walter Arnold, FLSSAR Treasurer, reported that we are solvent and updated the balances in our respective accounts. He then presented the 2025 Budget. **Motion** – The Finance Committee moved to accept the 2025 budge. No second is needed. It was moved to amend the 2025 budget by adding \$1,000 in prize money for the Youth Video Contest. The motion was seconded and passed unanimously. The Finance Committee then moved to accept the 2025 budget as amended. No second was necessary. The 2025 budget was approved.

<u>Meeting Arrangements – BOM – Motion – The Committee moved that the Fall 2025 and Spring 2026 BOM meetings be held at the current location, which is the Embassy Suites, Lake Buena Vista on October 17-18, 2025 and May 15-16, 2026.</u> No econd was needed. Motion **passed**.

<u>Strategic Planning</u> – Wm. Lee Popham announced that the Strategic Planning Committee was moving forward with Club Express as our vendor for dues billing.

<u>Trust Fund Trustees</u> – An election was held for an open trustee seat on the Trust Funds. Jeff Brunelle was nominated and unanimously elected.

<u>Club Express</u> – Earl "Matt" Matthews gave a report on the Club Express System and the chapters that are using the system for 2025 dues collections.

<u>Congress Surplus Allocation</u> – The committee reported that was \$30, 646 left in the 2023 Congress Fund. The committee moved the allocation of the remaining monies, to be used for the following items: the NSSAR Education Center and Museum, the FLSSAR Bahama Amphibious Assault Memorial, the FLSSAR Education Outreach Committee, and the balance to be transferred to the FLSSAR Operating Budget Trust Fund for the future benefit of the Florida Society. No second was required. The motion passed. It was then properly moved and seconded that the Congress Surplus Allocation be thanked for their service and disbanded. The motion passed.

1st Amphibious Assault Committee – The committee gave a report on the progress of this project. Approximately one-half of the expected cost of the project has been donated either in cash or services in kind. Fundraising is ongoing with an expected completion date of March of 2026.

It was properly moved and seconded to amend the charter of this committee to include the following under Functions: The Committee shall be empowered to execute such plans and others that may be developed with the approval of EXCOM. The Committee may develop and execute fundraising activities as approved by EXCOM. Funds raised for the establishment of the memorial from all sources shall be transmitted to the FLSSAR Treasurer to maintain until EXCOM approved disbursement is requested by the Committee. The motion passed.

It was properly moved and seconded to appoint a Youth Video Contest Committee consisting of Steve Hohman, Chairman, Doug Gibbens, Kevin Shurte, and Phil Markoe. The motion passed.

The EXCOM proposed a total of 12 changes to the Standing Rules. The Sections of the Standing Rues affected were Sections 100 (Members), Section 105 (Regional Vice President), Section 107 (Treasurer), Section 110 (Registrar), Section 123 (Fund management), Section 500 (Rules of Protocol), and Section 502 (Registration and Hospitality Room). Ten of the changes were passed, 1 change was withdrawn, and 1 change was postponed until the next Board of Managers meeting in May 2025.

Proceeds will be used to help finance the <u>Chapter's new major 250th Commemoration Time Capsule Project</u>, which is well underway with our President leading a <u>cooperative group of SAR, DAR, and City of Pensacola participants for the project</u>. There are 5 SAR, 5 DAR, and 5 City committee members, with 7 sub-committees of members, with a Timeline of activities, action dates, and Point Persons from SAR and DAR jointly assigned to each activity and task. The CAR will also participate in our 250th project.

The Chapter has <u>7 external history and mission-related speakers scheduled</u> for the first months of 2025, with other possibilities. One speaker represented the founding Maine family for Wreaths Across America in March. Our Chapter presented him with a check from our President to purchase 30 wreaths for WAA. Another Speaker in February was from the DAR and she presented a fine program about <u>propaganda during WW II</u>. This <u>DAR Regent was awarded our Chapter's Bronze 250th Commemoration Medal</u> for her fine work in helping our President with the 250th Time Capsule project. Phil Bloyd, Executive Director of NSSSAR Foundation, will speak at our April Meeting and present GWEF Fellows Certificates and Pins to our <u>7 new George Washington Fellows</u>, with others possibly being awarded. This large number of <u>7 new Fellows in 1 year has never been accomplished by any previous Pensacola Chapter.</u> C.A.R. children will present a brief message at our June meeting, with an SAR Representative from Mobile, AL presenting a program then. The University of West Florida's AFROTC detachment Commander will present a Nov. program. Col. Findley presented a program on "Spies and Espionage During the American Revolutionary War" to the DAR Chapter and others, and had three articles published in the Florida Patriot magazine.

One of the President's goals was to strengthen associations and support for veterans to help them. <u>Associations have been established with 5 veterans groups</u>, to help, honor, and recognize veterans, including the FL Veterans Foundation, the FL Veterans' Hall of Fame Society, the Patriot Guard, Honor Flight, and United Way Veterans. Six meetings have already been held in four months to recognize, honor, and help veterans, with several more to follow. Our 8 Executive Committee members were awarded certificates and medals from the FL VA, Veterans Foundation (FVF), for their service to veterans. Active participation with the <u>United Way Veterans'</u> Committee recognizes and helps needy veterans. Visits with veterans at a Nursing Home, 2 Rehab Centers (Milton, FL and

Pensacola, FL), and other places were made. Two Chapter members are members of the <u>Patriot Guard Honor Team</u> to escort remains of veterans from funeral homes to cemeteries and participate actively and often in funerals and interments. <u>Eulogies</u> were given at two veterans' funerals by our President. He attended <u>10 funeral services and participated in Honor Guard Escort and as <u>Honorary Pallbearer</u> for the heroes for interment through Mid-April. Scheduled for the remainder of April are 5 funerals for veterans in our area, and we hope to participate.</u>

The chapter has grown to 59 members, adding one new member in April which is the largest that we have been. Through the first 3 months of 2025, our Chapter has already sponsored 68 wreaths for the Wreaths Across America December 2025 event at Barrancas National Cemetery. This is the most wreaths the chapter has sponsored for any 3-months since we started participating in WAA. Without any doubt, we shall sponsor at least 100 wreaths by December. We have had several entries for the Elementary Poster contest and the Middle School Brochure Contests. We anticipate that the Winners for both will be sent on to the state competition. This spring, we plan to give out about Mod Good Citizenship Certificates to students in Escambia and Santa Rosa County Schools, as well as JROTC medals were presented to cadets at all participating high schools in both counties. The Silver ROTC Medal was presented to an outstanding cadet at the University of West Florida and another Silver ROTC Medal will be presented in April to an AFROTC cadet from a separate Cadet Wing at another nearby university. This is the first time an ROTC medal was presented to two universities and two cadet Wings by our Chapter. And our Chapter was represented at an ROTC award ceremony at still another Florida university. Also, our President representing SAR presented the keynote address for the annual ROTC Military Ball at University of West Florida. Our Chapter presented its first ever Civil Air Patrol Cadet Medal and Certificate in March to an outstanding cadet and also recognized its Commander with a veteran's award medal, representing our SAR Chapter & FVF. Findley will present incarcerated Prison P

Our Chapter will purchase a <u>Bronze Marker for a huge Heritage Oak Liberty Tree</u> that was planted years ago in our Plaza Ferdinand Park. Sadly, Hurricane Sally destroyed the Liberty Tree Marker with its Liberty Tree History, so our Chapter will replace it and have a special <u>historic Re-Dedication Ceremony</u> to honor this great Liberty Tree and our SAR Chapter.

Our <u>"250 by the 250th" Flag Recognition</u> program is going strong. We have recognized **178** businesses and individuals that have been nominated and presented with certificates. We shall surpass our goal of 250 with only 72 more to go over the remaining about 1.5 years!

On May 9, the Pensacola Chapter will once again host the Battle of Pensacola Commemoration. This year's events are the keystone events for the City of Pensacola's Galvez Days with plans to begin on Wednesday May 8th. On May 9, the SAR Color Guard, accompanied by ladies from the DAR, will open the Friday events with a color guard procession down Palafox Street to the Galvez Monument and then on to the Basilica of St. Michael for the Galvez Commemoration. After the morning's ceremonies, there will be a lunch at the Pensacola Yacht Club and an evening social. The SAR and DAR will jointly sponsor a wreath laying ceremony with the Battle of Pensacola history and readings at the Minuteman Monument in Veterans Memorial Park at 3 pm. We are expecting a Color Guard contingent of about 20 members from Alabama, Florida, Georgia, and Tennessee.

Our chapter submitted our <u>USS Stark Memorial</u> entry in January, but already our report has been expanded for 2025 to include many more documented veterans' activities. The appointment of an Awards Chairman to focus on this report and other awards is helping. <u>Chapter member participation</u> is a goal and we have three previously inactive members who are starting to become more involved.

Withlacoochee Chapter

The Withlacoochee Chapter has had a very active winter and continues to grow. We have added several new members, some of whom are also attending this BOM.

At the end of January 2025, we acquired a two-year lease of a replica of George Washington's War Tent from Jim Griffith of the Alabama Society. This tent was constructed by Compatriot Nathan Taylor, who is also a new member of the Withlacoochee Chapter, in cooperation with the Museum of the American Revolution in Philadelphia, Pennsylvania. This tent was set up the week after it was acquired at a Liberty Tree dedication with the St. Augustine Chapter, on the grounds of the Oldest House Museum. The tent drew people who happened to walk by into the event and was a great addition to the tree's dedication. Two weeks later, it was set up in Brooksville, Florida, at the Heritage Days Festival, where it also was a great draw for people. The local JROTC program sent 18 volunteers to help set up the tent and was given some detailed lessons about our country's founding history. In the two public deployments of the tent, it has already proven to be a great recruiting and outreach tool.

Because we cannot be content with just having a prized replica of the tent General Washington led from, the Withlacoochee Chapter created a mobile museum of the American Revolution. To date, a large group of Compatriots have built a replica of some of the furniture in the original tent, created five uniformed mannequins, and dispersed various artefacts that would generally be found in a Patriot Chest. The tent is also outlined by 15 flags of the American Revolution, which act as decoration, as an educational opportunity, and to secure the guy ropes supporting it.

To raise funds for the chapter's various programs, the chapter has also secured a kettle-corn machine and will deploy concessions with the War Tent when possible. Concessions will consist of kettle corn, iced tea, and lemonade, which should draw more people towards the tent, provide volunteer opportunities for JROTC and CAR members (we are also tying this to a scholarship program based on volunteer hours), and raise funds for the chapter based on the high profit margins of the products chosen. The goal is to build a fully uniformed Color Guard with uniforms matching the spec set by General Washington for his Commander-in-Chief Guard and an outfitted Honor Guard.

Once we have the entire program ready, the Chapter can bring the tent to most locations and SAR-related events in the Southeast US, and can work with chapters to split the proceeds, provided the chapter can supply labor. Stay tuned.

The chapter has also brought the Children of the American Revolution to the Brooksville area by bringing back the Drummer Boy Chapter of the CAR.

Finally, we are working on an Associate program to tap into our community's patriotic spirit to enjoy social events related to the American Revolution. Quarterly events will be sponsored by local community businesses and feature any combination of a guest speaker, grilled meats, and spirits. Final details for a fall launch will be completed this summer. This program aims to generate additional donations to the SAR's various programs, increase awareness of what the SAR does, and educate the community about the events that led to our country's founding. Once we have associates in the door, we can work to see if they qualify for membership in the SAR. The program is also designed to fill a void in the social aspect of the Society.

St. Michael's Academy Fernandina Beach, Florida, Lindisfarne Hall Fernandina Beach, Florida, St. John's Academy Fleeming Island, Florida, Trinity Christian Academy Jacksonville, Fl., Fleeming Island Home School Group, and St. John's Academy Orange park, Florida. Both St. John's schools are Hillsdale College Member Schools. We at the Jacksonville Chapter feel that young students are the future of America, and this is one of our most important activities that will allow our members to work toward our SAR Mission Goals achievement. • A word about **voting**:

Voting meetings will be on Saturday afternoon. Those two voting meetings are the "Board of Management (BOM) Meeting", followed by the "Annual Meeting". These are the voting requirements for those two meetings:

1. Annual Meeting.

All FLSSAR members in good standing in attendance may vote at the Annual Meeting.

Of particular note for the Annual Meeting, business to be accomplished are proposed by-laws changes (as published in the Patriot magazine) and the election of officers for the next term.

2. BOM Meeting.

Only members of the Board of Management (BOM) in attendance may vote at the BOM Meeting. In accordance with the FLSSAR by-laws, the members of the BOM include:

- a. Persons who are lifetime members of the BOM by virtue of being a past President of the FLSSAR, a recipient of the Patriot Medal, or an incumbent or past elected officer of the NSSAR.
- b. Persons who are members of the BOM by virtue of being, and while being, an elected officer of the FLSSAR; appointed incumbent FLSSAR Committee Chairman; an incumbent National Trustee from Florida; an incumbent Chapter President; and the most recent Past President of a chapter, i.e., the person who preceded an incumbent Chapter President in office; if a chapter has no recent Past President it shall name another of its members to serve on the BOM;
- c. Persons who have been appointed by chapters having more than forty members on the basis of one additional member of the BOM for each forty chapter members or fraction thereof more than the first forty, the term of office of such additional members of the BOM to be coterminous with that of the Chapter President incumbent at the time of their appointment to the BOM.

I already know everyone who is in categories a. and b, assuming that I have been kept informed of the current chapter officers. For category c., the chapter must provide names to me, in writing, prior to the BOM. In addition, the by-laws provide for:

A member of the BOM who is unable to attend a meeting may name, in writing, another member of the FLSSAR to attend and act in his stead; provided, however, that no person may have more than one vote. Members of the FLSSAR who are not members of the BOM may attend and participate in debate but may not vote. Visiting dignitaries, especially those from other State Societies or from the National Society, may attend and may be invited to address the meeting but may not participate in debate or vote.

On the first page of the Statement of Activities (aka P/L) you will see we had 75 New Member Applications. The three (3) average (January - March) was 42. It is not clear how many New Member Applications would have been processed in March that were pushed to April with the discount of \$50.00 off National Fees. It is also unclear as to the possible effect on the May New Member Applications. Great job was done by Ray Lanz, again!

Total "Paid" Regular Members for FLSSAR are at 2,189 as of YTD April.

There continues to be unsupported detail from Club Express that now total \$8,696. E-mails have been sent to Club Express for the YTD March and part of April, but we still are waiting for a final resolution **before booking the revenue.**

On the expense side of this report eight (8) expense items. The largest was \$1,550.47 for the 1st issue of the Florida Patriot Magazine. We still have three (3) more issues to go this year at about \$1,500 each issue. Total "Receipts" collected from Members

for a hard copy of the Florida Patriot Magazine was \$1,440 for all four (4) issues. I would suggest that this is an item for discussion at our Fall BOM.

On the Statement of Financial Position (aka Balance Sheet) a few items of noteworthy. First funds collected and in the bank for the First Amphibious Monument is now at \$28,225. This number has changed since the close of April and continues to grow/change daily with what now is a "national" (multiple states) awareness of the First Amphibious Monument. I would look to Robbie Robinson for the most current number just before the BOM. Robbie has done a fantastic job with follow-up and coordinating the collection of funds for this program. Thank you Robbie!!

Net Cash (after restricted funds) is \$70,677.

Recommended Application Submission Improvement Areas:

- 1. Tombstone Submissions (TS):
 - a. Make certain you provide a copy of the citation page that provides location information. (i.e., Find-A-Grave (FAG) printout of Page 1 of Memorial Information) NSSAR will not accept the information unless a citation is submitted.
 - b. Make certain that the gravestone resembles period stone for the date of death, NSSAR will not accept non period TS information.
 - c. Make certain the copy of TS image provided is legible enough for the most casual reviewer, if not NSSAR will not accept it.
- 2. Court Record Submissions: (i.e., Orphan Court (OC), Deeds, Wills, Estate Records, etc.)
 - a. Make certain you provide a copy of the citation page that provides the court location and record book name/page or file name/#.
 - b. Make certain copies include the origination/recorded date information the court is included, do not chop the info off. NSSAR will not accept it without this information.
 - c. Make certain copies include the entire contents of the entry being used.
 - d. Make certain copy image provided is legible enough for the most casual reviewer, if not NSSAR will not accept it.
- 3. Census Record Submissions:

- a. Whenever possible submit the first census that a child would appear with their parents is used. This helps prevent errors in lineage determination.
- b. When census is the only source used to prove a generation connection. Make certain an exhaustive search is made to identify if more than one person of a like name and close age is not found to prevent NSSAR non acceptance.
- c. Whenever possible provide additional vital records to help validate the census information.
- d. Make certain copy image provided is legible enough for the most casual reviewer, if not NSSAR will not accept it. Make certain a full-page copy of census is provided, an enlarged snip-it may also be provided if desired.

4. Vital Record Submissions:

- a. Make certain copy image provided is legible enough for the most casual reviewer, if not NSSAR will not accept it.
- b. Make certain if the information came out of a published book to include the title/copyright page, and if it is from an accepted database include the source citation page.
- c. When conflicts are found between documents, they must be adequately identified and resolved to meet NSSAR expectations.

5. New NSSAR Patriot Submissions:

- a. Acceptable evidence must be submitted to prove where and when the patriot died.
- b. If the patriot did not die where the service was performed, then acceptable proof must be provided that proves he was the one that was living in the service location when it was performed.
- c. Make certain that an exhaustive search is made to identify if more than one person of a like name could have performed the service. All possible like possibilities found must be proven ineligible.

Executive Committee

The Executive Committee has met the following times since the last BOM.

 - o Appointment of Executive Administrator for 2025-2026.
 - Approved signing of the LOI for the First Amphibious Assualt Memorial, and release of the funds for the \$15,000 invoice to Premier Precast.

Business for this BOM meeting:

- 1. The Executive Committee has appointed Matt Mathews as Executive Administrator for 2025-2026.
- 2. The Executive Committee proposes the following procedure for handling contested officer elections:

The proper form for a nomination is "I nominate Compatriot XYZ." Any speech or additional comments included with a nomination shall be ruled out of order; the President may rule that additional statements constitute the supporting speech.

Nominees for the office of President shall be permitted one speech not to exceed five (5) minutes, first by the nominee from the Nominating Committee followed by nominees from the floor, in alphabetical order. One supporting speech not to exceed three (3) minutes shall be allowed for each nominee in the reverse order. No other speeches permitted.

Nominees for all offices other than President shall be permitted one speech not to exceed three (3) minutes, first by the nominee from the Nominating Committee followed by nominees from the floor, in alphabetical order. One supporting speech not to exceed two (2) minutes shall be allowed for each nominee in the reverse order. No other speeches permitted.

Voting shall be conducted in accordance with the By-Laws of the Society.

3. The Executive Committee presents the following proposed change to the Standing Rules, postponed from the Fall 2024 BOM meeting.

Section 123 (Fund Management)

Section 123, Endowment Trust Fund, presently reads (in part) as follows:

Tax deductible contributions may be sent to the FLSSAR Treasurer by individuals, chapters, etc. for transmittal to the Board of Trustees of the Florida Society Endowment Trust Fund. \$1.00 is contributed from the State dues each year for this fund, paid after the Annual Report is submitted to National.

Proposed Amended Section 123, Endowment Trust Fund, revised as follows:

Tax deductible contributions may be sent to the FLSSAR Treasurer by individuals, chapters, etc. for transmittal to the Board of Trustees of the Florida Society Endowment Trust Fund. \$1.00 is contributed from the State dues each year for this fund, paid after the Annual Report is submitted to National.

Justification:

The Board of Managers voted to discontinue this practice at the Fall 2023 BOM Meeting. that motion was:

"Motion – The finance committee moved to revert to the pre-congress practice of putting \$2,000 each year into the "Meeks" fund and the Endowment Trust Fund (ETF). Since the motion came from the finance committee, it required no 2nd. Ray Wess moved to amend the motion by stating that the entire \$4,000 should go into the "Meeks" fund with nothing to the ETF. Dick Young 2nd the motion to amend. The motion to amend was **passed**. Then the vote on the original motion as amended was **passed**. "

in addition, this doesn't really belong in the Standing Rules. It should just be a line item on the budget, to be considered annually, instead of automatically recurring.

4. The Executive Committee presents the following new proposed change to the Standing Rules.

Section 502 (Registration and Hospitality Room)

Section 502, Overview, presently reads as follows:

The Regional Vice Presidents are assigned as of 2012 on a rotating basis the responsibility to oversee the chapters of his region in a joint effort to function as a welcoming committee. The first duty is check in the registered members, all guests, and un-registered members who may attend. The registration spreadsheet must be e-mailed by the FLSSAR Meeting Arrangements – BOM Committee on Wednesday night to the RVP, Secretary, and Treasurer. Hard copies of the spreadsheets are to be provided to the RVP on Friday morning including all checks received to date. The registration table, therefore, will have the final registration spreadsheet(s) list(s) of those registered, their guests, meals selected and if money is owed, collect and record same on the spreadsheet including check numbers or note cash payment. When all registered members, special guests, etc., of the BOM are accounted for, the attendance spreadsheet(s) and all funds must be delivered in person to the State Treasurer.

Proposed Amended Section 502, Overview, revised as follows:

The Regional Vice Presidents are assigned on a rotating basis the responsibility to oversee the chapters of his region in a joint effort to function as a welcoming committee. The first duty is check in the registered members, all guests, and un-registered members who may attend. The Executive Administrator will provide the registration spreadsheet, and any registration forms and checks received to date, and the Proceedings books to the registration table before it opens. The registration table, therefore, will have the final registration spreadsheet(s) list(s) of those registered, their guests, meals selected and if money is owed, collect and record same on the spreadsheet including check numbers or note cash payment. When all registered members, special guests, etc., of the BOM are accounted for, the attendance spreadsheet(s) and all funds must be delivered in person to the State Treasurer.

Justification:

The history of when the rotation was started is not necessary, and the additional changes bring the overview up to date with current procedures for the BOM check-in process.

Section 502, A - Regular or Special BOM Weekend, presently reads as follows:

A. Regular or Special BOM Weekend

- 1. The registration desk personnel have the responsibility of providing the BOM Proceedings (Blue Book), meal tickets, table signup sheets, meeting schedule, and any other informational items.
- 2. The opening hour for the Friday check-in is 10:30AM unless otherwise scheduled.

- 3. Be it understood that some hotels only permit foodstuffs to be provided by the hotel. Therefore, any reference to FLSSAR chapters bringing food to the BOM events is understood to be meant for those hotels that allow such outside food to be provided. References to a Hospitality Room are applicable if the BOM event contract makes a provision for such a room. Typically, such contract provisions are done at an added expense. It is recommended that Donations will be required of those consuming the food to help offset the expense.
- 4. If permitted by the hotel, we recommend that the chapter members and member's wives assisting the RVP on Friday of a BOM should only have finger foods that each chapter in the region can donate. Recommended items include crackers, cheese, chips, pretzels, nuts, and cookies. We do not recommend purchasing packaged luncheon meat and cheese, etc., to set out for making sandwiches, if reimbursement from FLSSAR is expected. FLSSAR will not accept the invoice for such items. Members and chapters for the Hospitality room often donate sandwich platters. The chapters may also donate a mix of soft drinks, juice, and two to three cases of bottled water. If a sufficient amount is not donated the RVP may authorize purchase of same including regular and decaf coffee, etc., and be reimbursed by FLSSAR along with any non-food supplies invoiced. Liquor, beer and wine is not to be provided by FLSSAR but may be brought to the hospitality room by members for themselves or to share. The RVP should make sure the donation box with sign above it stating (food and drinks are not free) is on the food table where it is easily viewed.
- 5. The Hospitality room should close at 3 PM for the BOM meeting and open only after the evening banquet and close no later than 11 PM unless otherwise scheduled.
- 6. On Saturday morning, the RVP can decide if a need for regular and decaf coffee and juice should to be served as well as breakfast items such as Danish, donuts or bagels that are left over from Friday. If not, the none food supplies are packed in supplied FLSSAR containers and the RVP responsible for next BOM takes charge of the containers and provides personnel that will store the same in a proper and safe storage area. Food supplies including sodas are not to be stored because of the heat in Florida and time between meetings. Offer these items to the members from the chapters that donated them first.
- 7. RVP in charge of the current BOM should make sure all FLSSAR items are in containers and ready to be transferred to the next RVP and removed by Saturday morning.

Proposed Amended Section 502, A-Regular or Special BOM Weekend, revised as follows:

A. Regular or Annual BOM Weekend

- 1. The registration desk personnel have the responsibility of providing the BOM Proceedings, meal tickets (used for exceptions like vegetarian, no sugar, etc.), meeting schedule, and any other informational items.
- 2. The opening time for the Friday check-in will be determined by the Executive Administrator.
- 3. Be it understood that some hotels only permit foodstuffs to be provided by the hotel. Therefore, any reference to FLSSAR chapters bringing food to the BOM events is understood to be meant for those hotels that allow such outside food to be provided. References to a Hospitality Room are applicable if the BOM event contract makes a provision for such a room. Typically, such contract provisions are done at an added expense. It is acceptable that Donations will be requested of those consuming the food to help offset the expense.
- 4. If permitted by the hotel, we recommend that the chapter members and members' wives assisting the RVP on Friday of a BOM should only have finger foods that each chapter in the region can donate. Recommended items include crackers, cheese, chips, pretzels, nuts, and cookies. We do not recommend purchasing packaged luncheon meat and cheese, etc., to set out for making sandwiches. Members and chapters for the Hospitality room often donate sandwich platters. The chapters may also donate a mix of soft drinks, juice, and two to three cases of bottled water. If a sufficient amount is not donated the RVP may check with the FLSSAR Treasurer to confirm if funds are budgeted for the purchase of same including regular and decaf coffee, etc. Liquor, beer and wine is not to be provided by FLSSAR but may be brought to the hospitality room by members for themselves or to share. If donations are being requested, the RVP should put the donation box in a location easily viewed by those visiting the Hospitality Room.
- 5. Food safety must be observed when placing perishable items on food table. Arrange to have bowls or trays of ice for sitting containers of perishable items on. Do not put out all perishable items out at once. If available, use a refrigerator to store perishables and beverages. Most beverages can be placed in a container of ice instead of the refrigerator during the day. (The hosting Region would need to bring a cooler for this purpose.)
- 6. Hospitably room on Saturdays of Annual Meetings should ideally be open longer during the day as wives, members and guests may wish to visit and socialize while meetings are not scheduled. The Hospitality room should close for the BOM meeting and Annual Meeting (Spring only) and open only after the evening banquet and close no later than 11 PM unless otherwise scheduled. The Ladies Auxiliary may wish to request use of the Hospitality Suite for their meetings during the BOM or Annual meeting. To facilitate this, the host Region should contact the Ladies Auxiliary President and Secretary prior to the BOM weekend to let them know if a member or a member's wife will be available to keep the room open.
- 7. On Sunday morning, any unused non-food supplies and FLSSAR owned equipment (such as the coffee maker) should be packed in supplied FLSSAR containers and turned over to the FLSSAR Sgt-at-Arms for storage in the FLSSAR storage locker. Any perishable food supplies as well as soft drinks and water should be offered to the chapters that donated them or turned over to the RVP responsible for the next Hospitality Room to properly store until the next BOM. Perishable items (including soft drinks and water) may not be stored in the FLSSAR storage locker.

Justification:

This change combines Sections A and B into a single section covering both BOM weekends and Annual Meeting weekends. The change also reflects current standards and procedures. It further clarifies that the hospitality suite may be used by the Ladies Auxiliary for meetings if proper arrangements are made with the Host Region.

Section 502, B-BOM and Annual Meeting weekend, presently reads:

B.BOM and Annual Meeting weekend

- 1. Same requirements apply as stated in (A) above except as stated in (B) 2 and 3 below.
 - (a) If members are only registered to attend Saturday's BOM and Annual meeting events, the RVP is to provide early registration personnel at 8:30 AM and deliver the 2nd spreadsheet with those names and funds collected to Treasurer when completed.
- 2. On Saturday morning, sufficient regular and decaf coffee, juice and breakfast finger food such as Danish, donuts, croissants and mini bagels with cream cheese should be provided by 8:30 AM.
- 3. Food safety must be observed when placing perishable items on food table. Arrange to have bowls or trays of ice for sitting containers of perishable items on. Do not put out all perishable items out at once. If available, use a refrigerator to store perishables and beverages. Most beverages can be placed in a container of ice if supplied by the hotel instead of the refrigerator during the day.
- 4. Hospitably room on Saturdays of Annual Meetings should be open longer during the day as wives, members and guests may wish to visit and socialize while meetings are not scheduled. It should close at 4 PM and open only after the evening banquet and closed no later than 11 PM.
- 5. RVP in charge of the current BOM should make sure all SAR items are in containers and ready to be transferred to the next RVP and removed by Sunday morning.
- 6. When we hold meetings at a hotel that restricts FLSSAR from bringing in our own hospitality food and beverages, the Florida Society will purchase from the hotel hot and cold beverages as well as snack foods as needed. Donations will be required of those consuming the food to help offset the expense.

Proposed Amended Section 502, B-BOM and Annual Meeting weekend, revised as follows:

Financial Review Committee

The Financial Review Committee is responsible for conducting an annual internal review of the books and financial records of our Society. We are not responsible for conducting, or causing to be conducted, an audit.

The Treasurer provided the committee with sufficient and appropriate materials for us to review the activities, transactions, and assets of the FLSSAR. After reviewing the data, materials and records provided, the Committee is satisfied that these records accurately reflect the financial position of the FLSSAR. A budget and budget comparisons were also provided.

The Committee thanks our new Treasurer for his assistance during this review, and for the informative manner in which the material was presented. He has committed to providing more frequent financial updates during the fiscal year, including to the membership in The Florida Patriot.

Medals and Awards Committee

The NSSAR Official Handbook Vol 5: Individual Medals, Awards and Certificates was revised and updated effective 10 Oct 2024. The Medals and Awards Committee would like to remind our compatriots to review the handbook to ensure that they are in

compliance with the new guidelines. Serious consideration should be given to ensure a proposed recipient is fully qualified and deserving of the award for which they are being nominated to maintain the integrity of the NSSAR medals and awards.

The Committee would like to remind all Chapter Presidents and Secretaries that it is your responsibility to ensure that the State Membership database is kept current. In reviewing numerous medal nominations this year, the committee has found that the members medals and awards received at the chapter level have not been entered into the state database. This tends to create some concern especially when a compatriot is being nominated for some of the higher level state awards. Chapters need to submit a listing of all medals and awards presented to their Chapter members to the State Secretary so the database can be updated.

As a reminder to all Chapter Presidents, Secretaries and Treasurers, most all of the medals and awards presented to non-SAR members are eligible for reimbursement from the Florida Endowment Trust Fund (ETF) within the limits established by the ETF committee. Unfortunately it seems most chapters are not aware that this program is available. Chapters are allowed up to 5 applications a year for a maximum of \$500 per application for a maximum of \$2,500 per year. The medals are reimbursed at 100% while the other awards are reimbursed at 75% within the authorized limits. Many chapters miss out on this reimbursement policy because they fail to file for the reimbursement. The ETF Grand Application Form is located on the FLSSAR website and contains information about what reimbursements are available to the chapters.

Nominating Committee

Charter reads as follows:

- 1. To gather, sort, collate, and index official and other significant documents and artifacts of the Florida Society, and similar materials from individual chapters, compatriots, and related organizations, of significance to the Society.
- 2. To establish and maintain a secure and accessible repository of these documents and artifacts.
- 3. To publicize to the members of the Society the existence of the Archives as necessary.
- 4. To store, catalogue and preserve these materials; to maintain a master catalogue and index.
- 5. To keep its index, catalogue and the materials in its custody available for reference and study.

In reviewing the charter, it is time for a rewrite as it was based upon more of a paper system. In today's functioning operations, almost, if not all are digital. With the software capabilities, this is ideal to upload all of the documents into each of the chapter's area. The automatic back-up operations of the software makes it ideal for the chapters and the state to utilize as a means of storage.

During the period of being a Trustee, one of the requirements was to obtain a copy of the bylaws of each chapter. Not all of the chapters complied or even had bylaws to provide. With CE (Club express), the ability to post their bylaws in the designated area, would meet the requirement as stated above.

Recommend that the Executive Committee review and reestablish this committee's charter.

By-Laws Committee

Since May 2024, the FLSSAR ByLaws Committee received eight recommendations for updates to most current ByLaws. We reviewed and forwarded them to the FLSSAR Secretary, as well as the editor of the FLSSAR Patriot Magazine in accordance with Article VIII, Section 3 Amendments of the current ByLaws that discuss how changes and voting are conducted.

These recommended changes are being submitted for approval at the May 2025 Anual Meeting. See Appendix A for each of the eight recommended changes.

Education Outreach Committee

Kevin Shurte, Chairman

Since October 2024, the FLSSAR EOC has met monthly via Zoom, excluding the holiday recess in December. During this time, the committee has planned for and promoted NSSAR youth contests, apprised chapters of contest requirements, deadlines, and prize amounts, and promoted the State Youth Education Award and the new NSSAR Youth Protection Training Program.

Leading up to October 2024, the EOC registered and prepared for the 2024 Florida Council for the Social Studies (FCSS) Conference in Kissimmee. The committee designed registration sheets and flyers for distribution, as well as developing a website and QR code for harvesting patron contact information at the conference. Unfortunately, like the Fall BOM scheduled for the same weekend, the conference was cancelled, but the committee's efforts will pay dividends for the 2025 conference season.

At the rescheduled BOM in December, EOC members set up a mock booth like that displayed at educational conventions. Compatriot attendees were welcome to browse the display, review the contest materials, and test out the new promotional QR code. During the BOM, voting members unanimously agreed to increase the 2025 EOC operating budget to \$3000 to promote youth education

programs at upcoming conferences and conventions. Additionally, the EOC received a \$2000 one-time allocation from the Congress Surplus Fund Committee for the purchase of display materials including a 10'x10' SAR-branded pop-up canopy, a 6-foot SARbranded spandex table cover, and a 33"x81" retractable SAR recruiting banner. The EOC has purchased said items and has them stored in the FLSSAR climate-controlled storage unit in Kissimmee. These items are available for chapter use upon request (advance reservation and transportation to and from required).

In December, EOC members reserved exhibitor space for the 2025 FPEA Homeschool School Convention scheduled for May 22-24 at the Gaylord Palms Hotel and Convention Center in Kissimmee. Compatriots Dave Hitchcock, Michael Meyer, Phil Markoe, and Kevin Shurte are scheduled to volunteer at the event. In addition, the EOC has reserved funds to register for the 2025 FCSS Conference in Orlando (TBD) and the 2025 Florida Council of Independent Schools Conference (FCIS) being held in Jacksonville November 20-21, 2025. These events will promote FLSSAR youth education outreach to homeschools, public schools, and private schools throughout the state.

In February, FLSSAR EOC Chairman Kevin Shurte joined a Zoom meeting hosted by NSSAR EOC Chairman Roger Williams. During the meeting, state EOC chairmen from across the nation discussed methods of promoting youth education including accessing schools and various youth groups. Of particular interest was the discussion about the Patriot Chest Program and the Youth Education Award.

After the meeting, the FLSSAR EOC inquired with SAR employee Rae Ann Sauer about the status of the Patriot Chest Reimbursement Program. We learned that the Florida Society has never filed for reimbursement under this program and has a \$375.00 reimbursement available. Thus, the committee has begun actively seeking bargains for colonial-era replica items to include in a communal Patriot Chest that also would be available for loan to chapters. The first item purchased was a Denix replica of George Washington's pistol discovered at an Okeechobee pawn shop for \$33.00.

Since the February NSSAR meeting, state EOC compatriots have also begun promoting the state Youth Education Award Medal. Details about the award can be found on the national website under the America 250 tab at SAR Awards. Any compatriot who makes 15 youth presentations that promote the SAR mission to school-age children from preschool through twelfth grade qualifies for this state recognition. Two compatriots are scheduled to receive this award at the Spring BOM.

The EOC is looking forward to an active 2025, beginning with the upcoming Spring BOM and the FPEA Convention. In preparation, the EOC is designing and printing new bookmarks to promote brand recognition and our youth contests. The EOC has also scheduled an Education Outreach meeting at the Spring BOM on Friday, May 16 from 11:00 to noon to report its yearly activities, discuss upcoming events, and field questions and recommendations from our chapter members. All SAR members are encouraged to attend.

Finally, the EOC encourages all members to complete the newly-launched Youth Protection Training (YPT) found under the SAR University tab on the NSSAR website. The committee reminds chapters that all compatriots who work with youths, including color guard members, must have a current YPT certificate and recommends that everyone complete this new program.

At the 2024 Congress in Lancaster, PA, FLSSAR President Jim Gaskins was proud to learn that Florida was one of only six states that had participated in all seven of the Education Outreach Contests. Your Education Outreach Committee is equally proud to announce that this year the Florida Society has again participated in all contests, including the inaugural Youth Video Contest. Huzzahs to our members, our chapters, and our state!

Membership Promotion & Retention

• The National Membership in conjunction with National Communication and Education committee has established at the National website and series of video training of/for officers of the chapter via SAR University. This training has been published via email throughout the SAR.

Note: There is no means of recording who has taken the course or even making it mandatory at this time. At last review, there still are compatriots who have not even signed into National.

The below 2 statements of the charter are unreasonable to retain. The software of CE (Club Express) has the ability to send out notices to encourage reinstatement s of members for the whole state. This can be performed on a monthly, quarterly or annual basis. This timing has not been established, but has proved to be a very helpful tool for our society and national as well.

To encourage each chapter which had a member dropped for nonpayment of dues to seek his reinstatement. Poll chapters to find what methods they've used successfully and not-so-successful to develop a reinstatement protocol/checklist for chapters to use. To obtain State Society assistance in urging reinstatement.

The last paragraph needs to be removed, as this is a direct function of the registrar/genealogist. Membership committee members are probably not trained or informed of what national is proposing for genealogist or registrars. The state has 2 officer positions, Genealogist and a Registrar to help in these areas.

To encourage, support and advise chapter Registrar/Genealogists with genealogical problems regarding new and prospective members. This can be done in tandem with the Genealogy Committee. There is no reason to have a prospective member fail to become a member of NSSAR because there was no one to help the local Chapter find enough documentation to ensure his approval by the NSSAR genealogy staff.

SAR - CLUB EXPRESS CONTINUES TO GAIN ACCEPTANCE AND MOMENTUM !!!!

We wanted to get out a quick update about the CLUB EXPRESS National Dues Billing Task Force project rollout. For those who don't know, CLUB EXPRESS is the Society and Chapter membership dues management and communication system that will allow Societies and Chapters to receive online dues payments for FUTURE dues cycles.

During the 2025 Dues cycle, the Florida SAR suffered a 15+% membership loss, primarily from non-renewals of memberships as a result of non-payment of the 2025 Dues. When we analyzed these results, we learned that the Florida SAR Chapters that did NOT take advantage of the Club Express Online Dues Payment system experienced a 17.4% non-renewal rate; while the "Club Express" Chapters experienced only a 12.5% non-renewal rate.

The Florida SAR started this year with 2,088 Active members, after the dues reconciliation process was completed. As of May 1, 2025, our Active membership has increased to 2,365, for an increase of 277 members in only four months. It is significant to note that during the same four-month period, only 135 of those new members came from Approvals of New Membership Applications. The other increase of 142 members came from Reinstatements.

Why so many Reinstatements? Because 696 Reinstatement Requests were emailed to all 2023 and 2024 Florida Non-Renewals, and they were given the opportunity to Reinstate their membership by simply clicking a couple of online links, and paying their dues with their credit/debit card.

Several Florida SAR Chapters have already elected to join the Club Express system for the collection of dues, and for use as a Chapter communication system. Every Florida SAR Compatriot has the ability to receive another email from Club Express, inviting you to update your profile information and account.

<u>Please do not discard or disregard the Club Express email as spam!</u> If there is any question about whether an email received from Club Express (or any other entity) with respect to the SAR is legitimate, please don't hesitate to contact your chapter president or Florida SAR Secretary Scott Breckenridge.

You will still receive your dues notice from your Chapter, as you have in the past. You may continue to pay your dues as you wish to. Club Express will merely give you the option of paying your dues online, but only if you wish to do so.

ALL Florida SAR members whose Chapters have elected to join our Club Express automated dues invoice system will be receiving their 2026 dues invoices in September. You can then elect to pay your dues online, or you can continue to send your checks to your Chapter representative.

The Historic Sites and Celebrations Committee responsibilities include not only supporting the several battlefield celebrations already having national recognition, expanding recognition of historic sites in Florida, but also actively engaging in helping chapters and the State Society create and promote activities celebrating the 250th Anniversary Program.

This year, the Historic Sites and Celebrations committee has set three primary goals for the committee:

1) Reach the milestone of 100 America 250 Gold Medals for FLSSAR Compatriots

- 2) Build a 'History of the Revolution in Florida' product that tells the history of our 4 Revolutionary War battles.
- 3) Build greater support across the region and National Society for all of our battle commemorations. (This effort will include trying to get the battles featured on an episode of NSSAR's podcast, "Revolutionary War Rarities.")

Unfortunately, we have not reached our goal of 100 America 250 medals for FLSSAR Compatriots. At my last count, we were at 37 Gold Medals awarded to Florida Compatriots. I know we can do better! I know that your chapters are recognizing all of the events that took place during the Revolution, and I know that you are celebrating our 250th anniversary on a regular basis. Keep track of your attendance at those events and track your points!

Since the last BOM, we have definitely succeeded in building more support for our Revolutionary War battle commemorations in Florida. The Last Naval Battle event at the beginning of March was a huge success, and the Thomas Creek event at the end of March was one of the largest events they've ever had! As of this writing, the Battle of Pensacola event on May 9th hasn't happened yet, but it is shaping up to be another fantastic event drawing SAR compatriots from around the Southeastern U.S.!

In addition to our battle commemorations, the St. Augustine chapter held a Liberty Tree dedication in February that was a resounding success and brought together SAR, DAR, and like-minded historical organizations from around St. Augustine. The Daytona-Ormond Chapter worked with their local DAR Chapter to re-dedicate a plaque to the known Revolutionary War Soldiers who moved to the State of Florida. The Highlands Chapter celebrated Patriots Day by participating in the Heritage Festival at the Pearce Homestead. The Emerald Coast chapter is working on installing not one, but TWO America 250 benches at locations in Okaloosa County in the near future!

And finally, we are making progress on the fundraising for the First Amphibious Assault Memorial planned for Pompano Beach. For this National Color Guard Event, we were honored to have our National Color Guard Commander Scott Collins, who commanded a 32-man color guard. Greetings were given by the City of Jacksonville, NSSAR from VPG Scott Collins, Florida State President, James Gaskins. Greeting were given by FSSDAR Regent Elect Kim Zeman, N.E. Regents Council, by Marsha Byers, FSSC.A.R.by State President Caleb Golden. Compatriot Dr. Roger Smith again gave us an enthusiastic presentation on why General George Washington wanted to make N.E. Florida our 14th Colony.

At the ceremony people were encouraged to register for the Alligator Bridge ceremony on Saturday June 28th. This battle was the fourth attempt after the Thomas Creek Battle to make N.E. Florida the 14th Colony as ordered by General George Washington

We are looking forward to next year's Thomas Creek Ceremony to be held at the Seaton Creek Historic Preservation Park on Saturday March 28, 2026, as we march towards our Nations 250th Anniversary.

First Amphibious Assault Memorial

(First Amphibious Assault Memorial Committee) Steve DePaul, Chairman

The First Amphibious Assault Memorial Committee has conducted the following activities since the Fall BOM, as highlighted below:

- We have selected Steve Fields to be the deputy chairman, responsible for social media, and Robbie Robinson to be the committee secretary. The secretary will maintain all applicable documentation.
- Obtained approval from the FLSSAR EXCOM to submit a letter of intent (LOI) to the monument manufacturer, Premier Precast, to work with our engineer & architect, and provide structural submittals for final plans that will be submitted for permitting.
- We have established three fundraising campaigns to raise a total of \$122,700 by mid-December 2025. These funds are essential to ensure we meet the scheduled dedication ceremony for the monument in Pompano Beach on March 7, 2026, which will mark the 250th anniversary of the historic event.

The campaigns are as follows:

- Minuteman: For donations up to \$249.
- 250 for the 250th: For donations of \$250 or more.
- The Chapter Challenge: This program recognizes chapters that collectively contribute donations from their members.

So far, these initiatives have generated over \$15,000 for the "250" program, \$11,000 for the Chapter Challenge, and \$425 for the "Minuteman" program.

- We have solicited a request for funding from the NSSAR George Washington Endowment Fund, and we were granted \$14,500 for 2025. We anticipate a further request for funding for 2026.
- We have established a campaign to provide applicable information to other state SAR organizations; already we have received \$3000 in donations and pledges from two different states to date.
- We have received a total of \$53,975 in cash contributions and pledges from all sources to date. The funding still needed is \$68,700. As a result, we are currently at 67% of the total funding required to construct the monument.
- We have designed a commemorative coin that will be given to anyone who contributes \$250 or more to the monument project. These are a limited run, the first in an anticipated series of three. These coins are expected to arrive by 22 May 2025, after which we will begin delivery. The following coins will be available for sale at the next Congress and online.
- We established four large donor categories: platinum (\$20K or more), gold (\$10K or more), silver (\$5K or more), and bronze (\$2500 or more).
- We have received approval from the city of Pompano Beach to install plaques that will recognize our donors. These metal plaques will be prominently displayed next to the monument.
- We are collaborating with the City of Pompano Beach and local business leaders to raise funds. Additionally, we are partnering with the Pompano Beach Tourism Committee, hoteliers, and restaurants to provide accommodation and discounts for the event.
- -We have started developing a standalone website to raise awareness among the general public, states, and chapters that will provide information regarding the 1776 assault landing, event literature, dedication details, photographs, nearby hotels and restaurants, notable sites, the muster roll, and much more.
- The committee has also been communicating with two very senior US Marine Corps officers to help get the applicable information out to active duty and retired Marines. Information about the monument has been sent to the Commandant of the US Marine Corps and his staff.
- We have established a strong connection with a senior member of the Marine Corps League (MCL), who is distributing information about our monument to MCL members nationwide. We have also received one pledge of \$2,500 for the monument project from a CSSAR compatriot.
- Established a communications link with the Florida State representative who is a member of the state's 250th Anniversary commission.

- We have drawn up a set of PowerPoint slides to help educate other organizations about the monument and how to support our efforts to erect this historic monument, which is periodically updated.

During our Youth Awards Luncheon during the Spring BOM Jesse will receive her medal, certificate and a check for \$1,000. Jielianne will receive a certificate and a check for \$500; and Paige will receive a certificate and check for \$250.

We greatly appreciate all of the chapters that participated in the 2024-2025 Knight Essay Contest and would encourage your participation again next year with the 2025-2026 Contest. We would also like to encourage all of our Florida Chapters to get involved with our Youth Contest. It is a great way to get information out about our Society.

It is never too early to start soliciting Knight Essay entries for next year's contest. It is also important that you advertise your Chapter's deadline date for submitting essays to the Chapter as well as the FLSSAR deadline of 31 December for all chapter entries to be submitted to State. We had a number of inquiries come in late due to the confusion over the 15 February deadline posted on the National website which is the National deadline for receipt of all the State Essay entries.

For the Chapter's winning essay submission to State must be in five parts in the formats indicated as follows: 1. the Knight Essay Application (PDF) (which now must be signed and dated by the student); 2. the Bibliography (Word); 3. The Biography (Word) (Student's name must be on this document); 4. The Essay (Word); 5. The Title Page (Word). This will allow the judges to finalize their evaluations of the essay; make any minor corrections as necessary; and submit our State winner to the national NSSAR committee by their February 2026 deadline. FLSSAR prizes for the 2025-2026 contest are \$1,000/\$500/\$250. The NSSAR prizes presented at the NSSAR Congress this year were 1st - \$6,000; 2nd - \$3,000; 3rd - \$2,000; 4th - \$500; and 5th - \$500. See SAR.ORG for complete details.

The new school year for 2025-2026 will be upon us before we realize it. The September timeframe would be a great time to engage with your local school systems to get involved with the many Youth Award Programs that we offer through the SAR. While I understand from our experiences last year some of the local school systems were reluctant to get involved with our different programs. I would suggest that there are a couple of other avenues that we could explore to get the word out about our Youth Awards Programs and give the students an opportunity to participate. If your chapters are involved with your local DAR Chapters, CAR Societies, Scouting and JROTC Programs or other civic organizations, they offer us a great opportunity to introduce our Youth Awards Programs to both parents and students. I would also recommend looking into the local Home School Programs that are being offered within many of our communities.

Rumbaugh Orations Contest

(Joseph P. Rumbaugh Orations Contest Committee) Tom Bowen, Chairman

The Rumbaugh Oration Committee had two candidates this year. Our committee composed of Hamp Allen, Ben Tidwell, Kevin Yarnell and Thomas Bowen were pleased to see some serious interest in entering this very difficult contest. The entry forms and paperwork are lengthy and detailed and we appreciate the Jacksonville and Fort Lauderdale Chapters who got the job done in submitting the detailed and lengthy forms, paperwork and video of their candidate. The Oration must be five minutes and no more than six minutes and must be totally a memorized speech. No notes are permitted.

Our entries this year were Xander Fontaine, a high school senior from the Jacksonville Chapter and Chloe Cave a high school freshman from the Fort Lauderdale Chapter. The Florida Rumbaugh Committee conducted their judging of the videos on April 1, 2025 and Xander had the highest score. Xander is a senior student at the First Coast Christian School in Jacksonville, Fl. and has many honors in his high school career. He is already an experienced public speaker with multiple state championships in Speech and Biblical Recitation and has been on the Dean's list for 7 years. He is also a varsity footballer. His speech was titled "The Liberty Tree: Cornerstone of Social Justice".

He will not be able to give his speech at the BOM as he will be on a family cruise and the Chapter President Paul Tucker will accept the \$1000 check on Xander's behalf. There are typically only about 20 states that submit an Oration to National and 6 finalists are chosen based on their videos by the National Committee. We feel that Xander has an excellent chance of being one of the National finalists based on his confident and smooth delivery of his speech to our state committee.

ROTC / JROTC Committee

Dale Bottom - Chairman

At the behest of President Gaskins, the ROTC Committee established its 2024/2025 goals. They are as follows: Identify any chapters that have a school offering JROTC and ROTC in their area that are supporting them with medals or other activities. Encourage chapter leadership to consider including ROTC support for any Senior ROTC programs in their area.

- 1. Encourage chapter JROTC leadership to contact the Primary Military Officer in each high school, offering their support.
- 2. Encourage every chapter to support every JROTC program in their designated chapter area. If it is not possible to have a presenter available for a JROTC Awards Program, at a minimum, provide a Bronze Medal and Certificate to be presented by the school.
- 3. Create a database, as it were, of Florida JROTC high schools and ROTC colleges and universities by Chapter location.
- 4. Emphasize the Senior ROTC program in colleges and universities. The various services rely on these programs for officers.
- 5. Encourage chapters to promote the Enhanced JROTC program. Participation dropped off during COVID and is slow to come back. The goal was to have a minimum of 10 entries in the Enhanced program.

The Committee identified 343 Florida high schools offering JROTC programs of the Army, Navy, Air Force, Space Force and Coast Guard. There is at least one JROTC unit in each of the 32 Florida SAR Chapter service areas. The number ranges from 1 in the Okeechobee Chapter to 38 in the Central Florida Chapter. Chapters were encouraged to award each program with a Bronze JROTC Medal and Certificate and ideally have it presented to a cadet by a Chapter Representative at the School's award ceremony.

Thirteen Chapters support one or more Army, Navy, Marine Corps and Air Force ROTC programs at colleges and universities in their Chapter Area. It is difficult to determine the total number of colleges or universities served by the Chapters as some programs include cadets from nearby schools that do not have a ROTC detachment.

A complete list of all the JROTC and ROTC schools, by Chapter Service Area, was created. We were unable to identify all the Sea Cadet, Civil Air Patrol or Young Marine programs by chapter as we found no public record of such programs. However, several chapters reported their support for these units, and they are included in the information base we now have.

The Committee communicated with Chapter Leadership and ROTC Points of Contact regularly throughout the year, encouraging them to support JROTC and ROTC. A special emphasis was placed on the Enhanced Program as our goal was to have a minimum of 10 Chapter nominations for the 2024/2025 year. We fell short of that goal as we received only 5 entries. While the Committee is disappointed with these results, a contact protocol has been established that could make future years for the Enhanced Program more productive.

Ft Lauderdale Chapter – 30 Bronze Medals and Certificates. Bronze Outstanding Cadet Medal and Certificate and cash prize. Second and Third Place Enhanced contestants received Bronze Good Citizenship Medal and Certificates. 1 Bronze Good Citizenship Sea Cadet Medal.

Lake City Chapter- 4 Bronze Medals and Certificates.

Youth Video Contest Committee

The Public Service and Heroism Committee (PS&H) recognizes and honors citizens and individuals in our public service sectors of Law Enforcement, Fire Safety, and Emergency Medical Services for their contributions to the community and for heroic acts with a commendation and medal. States, chapters and commendation recipients are recognized in a booklet published and distributed at the National Congress each July.

The State-level PS&H Committee exists to publicize the committee's function to the states' local chapters and to encourage their participation. Awards presented are reported to the National-level PS&H Committee and the State-level society by filling out an online form. All Commendations should be reported prior to June 1, to ensure inclusion in the PS&H Committee Commendation booklet for distribution at the July NSSAR Congress. The fillable on-line PDF forms may be found here. Some browsers use a default application to read PDF files and you may need to specify that the file be "opened" with the Adobe Reader application.

Note: Be certain to use the most current version of Adobe Reader for this form, as some web browsers have proprietary PDF readers that do not work with this form. Save and rename the file identifying your Chapter and name on your computer. Do not fill out the blank form on the above links. After saving the blank reporting form to your computer, open from your computer and fill out the form completely. Use the second button-bar at the top, right-side of the form labeled "Click to Save and Email," to save the completed form

to your computer and simultaneously send the completed form to the PS&H Committee. If you do not receive a receipt confirmation of the completed form in 3-4 days, contact the chairman of the PS&H Committee. One should also send the completed reporting form to their State PS&H chairman

This program is an excellent way to recognize deserving individuals in our community and the public sector. We do suggest that those individuals, in the public sector of Law Enforcement, Fire Safety, and Emergency Medical Services, who are being considered for a Heroism Commendation, be previously recognized by their division head for their heroism. The final closure for the year 2024:

Processed 45 ETF's totaling \$15,645.26, approved and distributed to the chapters. Of the 45 processed, the requested amount was \$18, 419.06 the difference of \$2773.80 was lost to the chapters.

Last year as a comparison, 58 requests received and \$18,901.70 was disbursed. The interest appears to slowly decreasing.

The Endowment Trust Fund Disbursement Committee had several motions to present.

- 1. The committee moved to pay two (2) prior year ETF disbursements which were not paid although received prior to the cutoff date. The approximate amount is a total of \$500. Having come from a committee, no second was needed. Motion carried.
- 2. The committee moved that C.A.R. reimbursements percentage be increased from 75% to 100%. Having come from a committee, no second was needed. The motion carried.
- 3. The committee moved that scholarship money reimbursement limits for the Rumbaugh, Eagle Scout, JROTC, Knight Essay, Middle School Brochure Contest, the Americanism Poster Contest, and the Video Contest be increased to \$600 (1st), \$400 (2nd), \$200 (3rd). The American History Teacher contest be increased to \$700. Having come from a committee, no second was required. The motion carried.
- 4. Wm. Lee Popham moved and Steve Hohman seconded a motion that chapter payments for historical sites & celebrations benefit be eligible for ETF reimbursement, not to exceed 100% or \$500 per chapter. The motion carried.

(2) The text of any proposed amendment(s) must be provided to the members of the Board of Management (BOM) at least thirty (30) days prior to the Annual or Special Meeting. The proposed amendment(s) will then be voted on by ballot at the Annual Meeting.

Proposed Amended Article VIII, Section 3, A (2), revised as follows:

(2) The text of any proposed amendment(s) must be provided to the members of the Board of Management (BOM) at least thirty (30) days prior to the Annual or Special Meeting. The proposed amendment(s) will then be voted on at the Annual Meeting.

Justification: There is no need for a secret ballot for by-laws amendments. A voice vote is usually sufficient. If the vote is close, a hand count should suffice.

Appendix A - Proposed By-Laws Changes

Article I (The Society), Section 3 (Members)

By-Laws Article I, Section 3, first paragraph, presently reads as follows:

The FLSSAR is made up of members in good standing of the NSSAR, each of whom shall have been admitted to membership in the FLSSAR, and each of whom is a member in good standing of the FLSSAR. A Member in Good Standing is a person who has been admitted to membership in the NSSAR and the FLSSAR, who is not now in arrears in payment of his dues, and whose membership is not now suspended or terminated under the provisions of Section 3 of Bylaw 17 of the NSSAR.

Proposed Amended Article I, Section 3, first paragraph, revised as follows:

The FLSSAR is made up of members in good standing of the NSSAR, each of whom shall have been admitted to membership in the FLSSAR, and each of whom is a member in good standing of the FLSSAR. A Member in Good Standing is a person who has been admitted to membership in the NSSAR and the FLSSAR, who is not now in arrears in payment of his dues, and whose membership is not now suspended or terminated under the provisions of Section 3 of Bylaw 17 of the current NSSAR Bylaws.

Justification:

The NSSAR Bylaw referenced (17) is now currently Bylaw 33. It is very difficult to keep our bylaws in synch with changes to the NSSAR Bylaws. A general reference should suffice.

Article I (The Society), Section 3 (Members)

By-Laws Article I, Section 3.c, presently reads as follows:

c. Members may request to transfer from one FLSSAR chapter to another by submitting a written request to the current chapter Secretary. The member's current chapter Secretary will coordinate the transfer with the Secretary of the new chapter. The new chapter Secretary will ensure the transfer is noted by the FLSSAR state secretary.

Proposed Amended Article I, Section 3.c, revised as follows:

c. Members may request to transfer from one FLSSAR chapter to another by submitting a written request to the FLSSAR Secretary, who will coordinate the transfer with the current and new chapters.

Justification:

The intent of this by-law was to ensure that both the current and new chapters are aware of the transfer. Restricting coordination to the chapter secretaries can delay, or even prevent, a transfer from occurring. Allowing the FLSSAR Secretary to coordinate the transfer gives him the freedom to coordinate with the chapter President when the Secretary is unavailable or (in some cases) non-existent.

Article II (The Board of Management), Section 2 (Powers)

By-Laws Article II, Section 2f, presently reads as follows:

f. Fill vacancies which may occur in any office, to serve until the next Annual Meeting of the FLSSAR except as otherwise provided in ARTICLE IV, Section 2, of these bylaws;

Proposed Amended Article II, Section 2f, revised as follows:

f. Fill vacancies which may occur in any office, to serve until the next Annual Meeting of the FLSSAR except as otherwise provided in ARTICLE III, Section 8, of these bylaws;

Justification:

This is obviously pointing to the incorrect section.

Article III (Officers), Section 1 (Titles)

By-Laws Article III, Section 1, presently reads as follows:

The officers of the FLSSAR, who shall be members in good standing, who shall be elected at the Annual Meeting, and who shall serve upon their installation and until their successors assume office, shall be a President, Senior Vice-President, Regional Vice-President for each Region as from time to time may be established, Secretary, Treasurer, Recording Secretary, Registrar, Chancellor, Chaplain, Genealogist, Editor, Webmaster, Historian, Member-at-Large of the Executive Committee, and Sergeant-at-Arms. A Parliamentarian shall be appointed by the incumbent president.

Does this need to be mandatory? or just as needed?

Article I (The Society), Section 4 (Annual Meeting)

Article III (Officers), Section 2 (Nomination and Election of Officers)

By-Laws Article I, Section 4, presently reads as follows:

The FLSSAR shall hold an Annual Meeting each year on a date in the month of April or May to be designated by the President, and at a place to be selected by him. In no event shall the date of the Annual Meeting be later than fifteen days prior to the opening date of the Annual Congress of the NSSAR. A quorum of an Annual Meeting of the FLSSAR shall consist of twenty members in good standing. During the Annual Meeting, the President and/or the members of the BOM shall nominate, and the BOM shall elect, a Nominating Committee composed of five members who shall have not served on a prior Nominating Committee of the FLSSAR during the preceding two years and whose term of office shall continue until the adjournment of the next Annual Meeting of the FLSSAR. Electronic meetings according to requirements in the most recent edition of *Robert's Rules of Order* are permitted.

By-Laws Article III, Section 2.A(1)(a), presently reads as follows:

(a) Election of Members. During the Annual Meeting, the President and/or the members of the BOM shall nominate, and the BOM shall elect, a Nominating Committee composed of five members who shall have not served on a prior Nominating Committee of the FLSSAR during the preceding two years, and whose term of office shall continue until the adjournment of the next Annual Meeting of the FLSSAR. Prior to the call for nominations, the Secretary shall inform the BOM of the names of persons who served on a Nominating Committee during either of the prior two years. Each member of the BOM shall vote for five of the persons nominated, on ballot forms provided by the Secretary. In the case of a tie vote that would prevent the naming of five clear winners, a runoff election shall be held between those unsuccessful candidates who, had they received one more vote on the first ballot, would have been a clear winner. If the committee is elected by acclamation, voting will not be necessary. The members of the Nominating Committee shall elect their own chairman. The Senior Vice-President shall not serve as a member of the Nominating Committee.

Proposed Amended Article I, Section 4, revised as follows:

The FLSSAR shall hold an Annual Meeting each year on a date in the month of April or May to be designated by the President, and at a place to be selected by him. In no event shall the date of the Annual Meeting be later than fifteen days prior to the opening date of the Annual Congress of the NSSAR. A quorum of an Annual Meeting of the FLSSAR shall consist of twenty members in good standing.

During the Annual Meeting, the President-membership present and/or the members of the BOM shall nominate, and the BOM shall elect a Nominating Committee in accordance with Article III, Section 2 (Nomination and Election of Officers) of these by-laws. composed of five members who shall have not served on a prior Nominating Committee of the FLSSAR during the preceding two years and whose term of office shall continue until the adjournment of the next Annual Meeting of the FLSSAR. Electronic meetings according to requirements in the most recent edition of Robert's Rules of Order are permitted.

Proposed Amended Article III, Section 2.A(1)(a), revised as follows:

(a) Election of Members. During the Annual Meeting, after the election of officers, the President-Elect and/or the members of the BOM shall nominate, and the BOM membership present shall elect, a Nominating Committee composed of five members who shall have not served on a prior Nominating Committee of the FLSSAR during the preceding two years, and whose term of office shall continue until the adjournment of the next Annual Meeting of the FLSSAR. Prior to the call for nominations, the Secretary shall inform the BOM membership present of the names of persons who served on a Nominating Committee during either of the prior two years. If more than five persons are nominated, each member of the BOM shall vote for five of the persons nominated, on ballot forms provided by the Secretary. In the case of a tie vote that would prevent the naming of five clear winners, a runoff election shall be held between those unsuccessful candidates who, had they received one more vote on the first ballot, would have been a clear winner. If the committee is elected by acclamation, voting will not be necessary. The members of the Nominating Committee shall elect their own chairman. The Senior Vice-President shall not serve as a member of the Nominating Committee.

Justification:

Since the general membership elects the FLSSAR officers, they should also select the Nominating Committe. This process should only be documented in one place, to avoid any possible contradiction.

Article III (Officers), Sections 4 (National Trustee) and 5 (VPG)

By-Laws Article III, Section 4, presently reads as follows:

The BOM shall annually select individuals for nomination for National Trustee and Alternate National Trustee in accordance with the requirements of the bylaws of the NSSAR, and ARTICLE III, Section 2, or these bylaws.

By-Laws Article III, Section 5, presently reads (in part) as follows:

... in accordance with the bylaws of the NSSAR and Article III, Section 2, of these bylaws.

Proposed Amended Article III, Section 4, revised as follows:

The BOM shall annually select individuals for nomination for National Trustee and Alternate National Trustee in accordance with the requirements of the bylaws of the NSSAR, and ARTICLE III, Section 2, or these bylaws.

Proposed Amended Article III, Section 5, revised as follows:

... in accordance with the bylaws of the NSSAR and Article III, Section 2, of these bylaws.

Justification:

The reference by-law refers to offices that are to be filled by election by the FLSSAR. The positions referenced in Article III, Sections 4 and 5, are not elected by the FLSSAR.

Article V (Committees), Section 5 (Finance Committee)

By-Laws Article V, Section 5, presently reads as follows:

The Finance Committee shall consist of the Treasurer, who shall be the Chairman, and two other members who shall be appointed by the President, and whose term of office shall be coterminous with that of the President who appoints them. This standing committee shall exercise management supervision over all FLSSAR finances except those of the Endowment Trust Fund and the Operating Budget Trust Fund.

Proposed Amended Article V, Section 5, revised as follows:

The Finance Committee shall consist of the Treasurer, who shall be the Chairman, and two other members who shall be appointed by the President, and whose term of office shall be coterminous with that of the President who appoints them. This **standing statutory** committee shall exercise management supervision over all FLSSAR finances except those of the Endowment Trust Fund and the Operating Budget Trust Fund.

Justification:

By definition in Article V, Section 6, the Finance Committee is a Statutory committee, not a Standing committee.

Article VIII (Miscellaneous), Section 3 (Amendments)

By-Laws Article VIII, Section 3.A(2), presently reads as follows:

(2) The text of any proposed amendment(s) must be provided to the members of the Board of Management (BOM) at least thirty (30) days prior to the Annual or Special Meeting. The proposed amendment(s) will then be voted on by ballot at the Annual Meeting.

Proposed Amended Article VIII, Section 3.A(2), revised as follows:

(2) The text of any proposed amendment(s) must be provided to the members of the Board of Management (BOM) at least thirty (30) days prior to the Annual or Special Meeting. The proposed amendment(s) will then be voted on by ballot at the Annual Meeting.

Justification:

There is no need for a secret ballot for by-laws amendments. A voice vote is usually sufficient. If the vote is close, a hand count should suffice.
