


Approval of Minutes of the Last Meeting

Florida SAR Winter 2017 Board of Management (BOM) Minutes of 4 February 2017, as recorded and prepared by Recording Secretary Compatriot Charles T. Sweeney. The BOM was held at the Embassy Suites Orlando-Lake Buena Vista South, 4955 Kyngs Heath Road, Kissimmee, Florida 34746, with President Raymond Francis Wess presiding.

Executive Committee members present included President Raymond Francis Wess; Immediate Past President and Vice President General South Atlantic District Lawrence Gene Fehrenbaker, Sr., MD; Senior Vice President Robert James Folk, Sr.; Secretary Herman Hall Riediger; Treasurer Walter Richard Young; and Member-at-Large Ronald Eugene Toops. Also present was past FLSAR President and current Executive Administrator Steven Allen Williams.

General Officers of the SAR present included President General J. Michael Tomme, Sr.; President General Lindsey Cook Brock (2014-2015); President General Carl K. Hoffmann (1997-1998); Former Chaplain General and current SAR Parliamentarian Rev. Dr. Randy Dwight Moody.

Quorum Verified by Secretary Hall Riediger.

Approval of the Minutes for the Fall 2016 Board of Management (BOM) Meeting of 15 October 2016 were reviewed and passed subject to Rev. Dr. Randy Dwight Moody recommendation that the motions presented during the presentation of the Endowment Trust Fund Disbursement Committee Report include that which follows.

1. <u>Background</u>. Compatriot David Kelsey, an Operating Budget Trust Funds Trustee, Chairman, and Endowment Trust Fund Disbursement Officer, has serviced three 3-year terms with the Florida SAR Endowment and Operating Budget Trust Funds Committee. On 31 December 2016, his current term on the committee ends. Compatriot David Kelsey indicated a desire not to serve another term.

<u>Motion</u>. To fill the upcoming vacancy, President Wess proposed that the BOM nominate Compatriot John Stewart for a three-year term as Compatriot David Kelsey's replacement. Since there were no nominations offered from the floor, Rev Dr Randy Moody moved that the nominations be closed.

Motion Passed.

2. <u>Background</u>. One of President General J. Michael Tomme, Sr., initiatives included the challenge to each State Society to donate \$1,000 or more to the Council of Youth Awards during his term of office.

Motion. Past President Lindsey C. Brock offered the motion that the FLSAR Donate \$2,000. Rev Dr Randy Moody second the motion. During discussion of the motion, President Ray Wess clarified the funds source: \$1,280 would come from the FLSAR treasury, and \$720 would come from accumulated private donations.

Motion Passed.

Statutory Committee Reports were given. One significant point of concern was voiced; namely, Rev. Dr. Randy Dwight Moody questioned the true amount on page 31 of the proceedings under "Record Storage." After discussion between Treasurer Richard Young, and President Raymond Wess, and with input of previous treasurer Hall Riediger, guidance was given that the minutes reflect an administrative correction is authorized to rename "Record Storage" to "Record Stipend." The storage expense as previously programed (sic) at \$1,000 should be recorded on the appropriate line item on the Finance Report as "Record Storage."

Committee Chairmen Reports in the order listed on the Meeting Agenda followed. During this process, Rev. Dr. Randy Dwight Moody made the following motion.

Significant Point of Information. During a brief by Compatriot Don Lanman it was suggested that the Florida SAR would benefit from reviewing how we utilize the \$1,000 budged funds for the Support the Troops (ad hoc) committee, with a view toward redirecting these funds to other Veterans Programs that are partnered with members of the C.A.R

<u>Motion</u>. Rev. Dr. Randy Dwight Moody moved that the ad hoc Support the Troops Committee procedures be suspended while a special committee evaluate the feasibility of moving in a new direction in partnership with the C.A.R and that funds utilized in executing such study be made available to the special committee for their use accordingly. Motion was first and seconded by Compatriots Lee Popham and John Stewart.

Motion Passed.

<u>Guidance</u>. President Ray Wess appointed Compatriot Don Lanman to chair an ad hoc committee consistent with the motion stated immediately above. Further, President Wess tasked this ad hoc committee to report their finding at the May 2017 BOM.

<u>President Ray Wess Authorization</u>. In view of the upcoming National Society Leadership Conference on March 3rd through March 4th, 2017, the BOM was apprised that select issues will be presented to the Trustees concerning: (1) Matters pertaining to "good moral character and repute," (2) Matters pertaining to gender identity. The BOM authorized President Wess to present views and votes based upon his conscious.

Executive Committee Motion.

Background. In December 2016, an ad hoc Ethics Committee was created, with Charter. On 3 February 2017, the Executive Committee agreed to propose to the membership that the Ethics Committee (ad hoc) become a standing committee. **Motion**. The Florida SAR moves that the existing Ethics Committee (ad hoc) become a Standing Ethics Committee.

Motion Passed.

The Winter 2017 Board of Management meeting ended at 4:15 PM.

A motion was introduced to include a policy in the SAR Handbook regarding the character and background checks of new applicants. **Motion Passed**

A motion was introduced to purchase \$25,000 worth of carpeting for the first floor of the SAR Headquarters allowing for the greater availability of rentals. **Motion Passed**

Late reports are to be emailed to me on/before 5/25/2017.

I will cover a couple topics in this report.

- Contact Information. For those compatriots needing to get various contact information for state and chapter officers, please use the flssar.org website's Officers tab. The names USPS addresses, phone numbers, and email addresses (when provided) are there for all officers. Calling or emailing the state president, the state secretary or me for this information will take longer than for the compatriot to look it up for himself. It saves time for both parties. The email addresses for Florida's committee members are accessed by the hypertext link for their names. Again, using this facility saves time for all involved.
- **BOM Registration forms** are created in PDF format and are fill-able. This means that a registrant can SAVE the form to their computer, OPEN it with Adobe Reader and fill it out they do NOT need to print and handwrite anything. Once that is completed then they can email it to me. I receive forms that have been downloaded, then printed, hand filled, scanned into a JPG format then emailed. Too often this creates a mostly illegible form.
 - NOTE: You must use Adobe Reader for this and the latest version. Other PDF readers may not work. Adobe Reader is a FREE download.
- Youth Protection System. This requirement is a two facet program. The first being the requirement for members to take the BSA YPT course and report their certificate to me. As of this report, 16 FLSSAR compatriots have forwarded their Certificate number to me; 11 chapters. The second facet is to identify those compatriots who do presentations or living history/reenacting and get them to do their Presenter Information Sheets (PIS). See Addenda at back of Proceedings for an example of what must be in the PIS form. And what will take the longest to implement is establishing a centralized data base at National and digitizing/cataloging all the PIS and Presentations. NSSAR will have to establish the standards for the PIS and work with the History Committee to establish standards of historical accuracy for the presentations, then establish a standard for videotaping them. What this infers is that the National History Committee will have to 'vet' every presentation given by a compatriot. Also, part of this is the requirement that there be new presentations made.
 - Education Outreach Team Leaders track the number of <u>new</u> presentations and venues presented by their team members and report to the State Education Outreach Coordinator NLT than 30 April annually

- Education Outreach Coordinators track the number of <u>new</u> presentations and venues *presented by chapter*
- O States report the chapters who have met the required number of new presentations to National Education Committee POC NLT 31 May annually. Note the requirement in the graphic below. A small chapter is required to create 3 new programs each year, large chapter 7 new programs and have them vetted by National.

Like earlier, I appreciated all of the thorough feedback that I received at the various Florida Society chapters. At all of these personal visits, I found the participation in the surveys satisfactory. I had similar satisfactory results when I called, again personally, the responses of the various Chapter Presidents. One of the discouraging results, was that associated with the On-Line Surveys. Only about 1% of the membership participated in this approach. I do appreciate the effort of Scott Bushnell in creating these surveys. I have other comments, but I will leave that to those who want to ask me about them.

In my continuing efforts to understand some of the interests and concerns of our Florida Society Members, I have added to our knowledge during this period. They still in most cases, are satisfied with the benefits that they receive at the chapter level, including recording their patriot, observing historical presentations and socializing. The new results added family research - genealogy assistance as another benefit. Benefits from the FLSSAR and NSSAR were more vague. I must repeat, the chapter members and officers, and especially the chapter presidents are the customers of the Florida Society. If we take actions without their support, we are making a big mistake. I think of the recommendation: "Do No Harm!"

It was surprising that no members mentioned either the FLSSAR or the NSSAR magazines as benefits. They laughed frequently at the idea that being an officer or committee chair was a benefit, although a number of past FLSSAR officers did look at their service as an officer as a benefit ... maybe an honor would be a better word!

The next comments are related to the NSSAR efforts called OUTREACH. It is a great thought, which includes not only the personal Outreach to our chapter members, but the various members of our local communities. The ideas expressed by Randy Moody and Scott Bushnell about the various brochures and new member/officer "packages" are a great start for spreading and implementing Outreach to this audience.

The idea of a mentoring program for new members at the chapter level is another way to proceed with Outreach to these individuals. It takes the efforts of current members, setting down with new members and letting them know what the NSSAR is all about. The various brochures and new member packages are part of that effort. These "new member" packages need to identify the various NSSAR and FLSSAR Education and other programs and also describe briefly the content and purpose of the programs.

One of the opportunities, identified by a number of chapter members, is to clearly identify the contacts associated with the various programs. They indicated it was difficult to identify some of the program chairmen and to make contact for assistance. The were not mentioning the Reg. VPs!?

When it comes to Strategic Planning, the FLSSAR needs to first identify the current performance of the items of interest. Most to the performance elements reside, I believe around member and officer participation. This is participation as society officers and committee chairmen. It also includes the participation rate in the various programs. It is clear that the Boy Scout and the JROTC are our leading programs. Even knowing this, the participation by the number of chapters can be increased with Outreach. Outreach can also be implemented with the other selected programs.

- Dr. Smith received his Ph.D. in Early American History and Atlantic World Studies from the University of Florida in 2011. His work on the American Revolution in the South has received the Aschoff Fellowship Dissertation Award and the Jack and Celia Proctor Award in Southern History.
- Dr. Smith now represents Colonial Research Associates and speaks nationally on his Revolutionary War research. He has provided consultation for the AMC television series Turn, and worked on projects with the Florida Humanities Council, the University of West Florida, the University of Florida, and the City of St. Augustine. He is an SAR member in the Florida St Augustine Chapter.
- The topic: The 14th Colony: The American Revolution's Best Kept Secret - On December 18, 1775, General George Washington wrote a letter to John Hancock, warning the Continental Congress that the British were stockpiling weapons and gunpowder in St. Augustine, East Florida. In his letter, Washington was sounding an alarm, as he feared that the British were preparing to reclaim the southern colonies by invading Georgia and South Carolina with an army from East Florida a colony wholly loyal to King George III. And Washington was correct! The role played by British St. Augustine in the American War of Independence is Florida's most unique story in its 500-year history perhaps the most unique story of the American Revolution.

Recommended Application Submission Improvement Areas:

- NSSAR is identifying and will reject photocopied applications being received on SAR archival paper. A
 printer does a better job of injecting ink into paper if the copy prints from a computer command. If you
 take a printed application and simply photocopy it onto SAR watermarked paper it is insufficient for
 NSSAR requirements.
- Enclose 1 application copy on SAR watermarked archive paper and 1 application on plain paper for all applications submitted.
- Ensure all required signatures and dates are present as required for type of applications being submitted.
- Do not submit NSDAR web site printouts from the "Descendants Database Search" or NSDAR "Patriot Index" information. This information is not acceptable for either lineage or service and NSSAR does not want this unacceptable information included with any application.
- Ensure <u>ALL</u> applicable information contained on all submitted proof documents is recorded in the applicable sections of the application. Do not list references that are not being submitted and list all documents that have been submitted.
- Ensure all known spouse information is included when known for each generation even when the spouse is not in direct lineal descent. This will prevent applications from being pended when two person of the same name are living in a given area and this information would assist in identification of the correct person used on the application.
- Only one set of proof documents are required to be submitted with each application. This also applies when
 submitting more than one application under the family plan criteria. One set of proofs only for the common
 documents used by all the applications in the group. His does not apply to multiple supplemental
 applications submitted at the same time. Supplemental applications are always considered separately and
 require complete sets of documentation.
- Use a red pencil to underline applicable data on all proof documents and DO NOT USE any type of highlighter.
- Copy of entire legible original census page must be submitted when using a census as a proof document.
 Ancestry.com census transcription pages cannot be used in lieu of the original census page, but may be used in addition to the original page.
- Never use nick names on an application unless there is a required proof document has been submitted that validates the nickname.

SAR will now accept an official record or chapter copy of a DAR or C.A.R. application approved after 1 January 1985 as evidence of lineage and related fact except where DAR, C.A.R. or SAR has determined that the facts have been determined to be incorrect. In other words, center checks on applications approved after 1 January 1985 no longer prevent a DAR application from being accepted in lieu of other documents. Applications approved before this date are acceptable for corresponding facts marked as individually-verified on DAR and C.A.R. applications. The subcommittee acknowledged that there were arguments on both sides of the issue and what it proposed was a middle ground that it deemed in the overall interest of the organization. No review process is perfect, but the overall DAR review process is an excellent one that includes a number of checks and balances. The old policy was clearly confusing to many applicants, chapter registrars, and state registrars, and the genealogy staff was spending a great deal of time requesting further information relating to DAR applications. Compatriot Peterman made a point in discussion I think all of us share: we do prefer copies of the documents themselves.

 Random checks were selected to verify payment and receipt of the funds. No discrepancies were noted. Uncleared checks were researched by the Treasurer and resolution for all were accomplished.
- We concluded that the financial statement as prepared by the Treasurer fairly represents the monetary transactions of the Society for the fiscal year ending 12/31/2016.
- The cash balance of \$82, 904.45 shown on the bank statement dated 12/31/2016 from the Wells Fargo bank accurately represents the assets of the Society on deposit in the checking account at that institution. Additional account is a Wells Fargo Money Market Account: \$65,000+ as managed by FLSSAR Treasurer and monitored by the Finance Committee. There being no Petty Cash fund.

(1) The text of any proposed amendments shall be submitted to the Document Committee (by November 1st) in ample enough time for review so that a recommendation can be made (which shall make its recommendations) to the Board of Management (BOM) at a regular meeting thereof at least 45 days prior to the Annual Meeting.

B

(1) The text of any proposed amendment(s) (shall) should be submitted to the Documents Committee (at least 60 days) for review and recommendations prior to any Regular or Special Meeting of the Board of Management of the FLSSAR. Any voting member of the Board of Management may propose an amendment. (The 60 day time frame is to allow for an orderly review of any proposed change and time for the Documents Committee to formulate their recommendation to the Board of Management).

These recommended changes will still allow the Committee to review and submit any changes to the ExCom and BOM of the FLSSAR.

To ensure adequate space is reserved at the Winter Meeting to conduct the Rumbaugh Oration Contest that judges and timekeepers are designated and briefed, and that prize money and Awards are on hand. Additionally, travel expense reimbursement is granted to each Florida SAR Rumbaugh Oration contestant to the maximum amount of \$60.00 when proper and acceptable receipts are presented to the Florida SAR Treasurer within ten days of completion of the Contest. Ethics Committee Charter Name: Ethics Committee

Status: Standing

Purpose: In an effort to maintain the high standard of conduct expected and deserved by our Forefathers, our

Members, and the American public Florida Society SAR operates under the Code of Business

Ethics and Conduct outlined below.

Authority: Florida Society By-Laws, Article V, Section 6. c (1).

Members: A Chairman appointed and additional Members, not less than 5, who shall be appointed by the

President, Florida Society and whose terms shall be concurrent with the appointing officer.

Functions:

1. Ensure adherence by all Florida members to the policies as set forth below.

2. Upon receiving a complaint perform due diligence in investigating said complaint and forward the committee recommendation to the Florida Executive Committee for any action deemed necessary.

Policy statements

Compliance Requirements All members, employees, and volunteers are required to comply with applicable federal, state, and local laws and regulations and with National Society SAR and Florida Society SAR bylaws and policies.

Prohibited Actions

No member, employee, or volunteer shall engage in the following actions:

- Authorize the use of or use for the benefit or advantage of any person, the name, emblem, endorsement, services or property of Florida Society SAR, except in conformance with Florida Society SAR policy.
- Accept or seek on behalf of any other person, any financial advantage or gain of other than nominal value offered as a result of the member's, employee's, or volunteer's affiliation with Florida Society SAR.
- Publicly use any Florida Society SAR affiliation in connection with promotion of partisan politics, religious matters or positions on any issue not in conformity with the official position of Florida Society SAR.
- Disclose any confidential Florida Society SAR information that is available solely as a
 result of the member's, employee's or volunteer's affiliation with Florida Society SAR to
 any person not authorized to receive information, or use to the disadvantage of Florida
 Society SAR any such confidential information, without the express authorization of
 Florida Society SAR.
- · Knowingly take any action or make any statement intended to influence the conduct of Florida Society SAR in such a way as to confer any financial benefit on any person, corporation or entity in which the individual has a significant interest or affiliation.
- Operate or act in a manner that creates a conflict or appears to create a conflict with the interests of Florida Society SAR and any organization in which the individual has a personal, business or financial interest.
- Retaliate against any member, employee or volunteer who seeks advice from, raises a
 concern with or makes a complaint about fraud, waste, abuse, policy violations,
 discrimination, illegal conduct, unethical conduct, unsafe conduct or any other misconduct
 by the organization, its members, employees or volunteers.
- Operate or act in any manner that is contrary to the best interest of National and Florida Society SAR.
- Conduct in disseminating via multi-party e-mail, mail, social media or other means, disparaging, maligning, false, or harassing comments or statements concerning compatriots.
- Issuance of circulars, communications or pronouncements regarding the Florida Society SAR purporting to represent official policies of the Florida Society SAR via e-mail, mail, social media or other means, without the approval of the Trustees, Executive Committee or the Executive Director.
- Misappropriate or convert to personal use the personal or intellectual property of the Florida Society SAR without the approval of the Trustees, or if that authority is delegated, without the approval of the Executive Committee or the Executive Director.

Reporting Responsibility

Each member, employee, volunteer and other stakeholder of Florida Society SAR has an obligation to report in accordance with this Code of Business Ethics and suspected violations of this Policy.

Handling of Reported Violations

Violations of this Policy shall be referred to the Ethics Committee for investigation. The investigation may be instituted by a written complaint or by information brought to the attention of the Chairman or a member of the committee. The committee shall investigate the alleged violation. At the conclusion of the investigation, the committee may hold hearings and take testimony as provided in Robert's Rules of Order.

At the conclusion of the hearing and investigation, the committee may take such action as it deems necessary, or it may recommend disciplinary action to the President and the Executive Committee. In the event of a recommendation for disciplinary action by the President and the Executive Committee, the Executive Committee shall review the findings of the Ethics Committee and take appropriate action or no action as the case requires. The alleged violator may appeal the action taken by the Executive Committee by filing notice within thirty (30) days demanding a hearing on the alleged violations before the Executive Committee at a date, time and place which shall be set by the Executive Committee. The alleged violator shall have a further right to appeal any action taken by the Executive Committee to the Board of Management at its next regular meeting. Executive Committee action other than expulsion shall be confirmed by a majority vote of the members of the Board of Management present. If the action being sought against the alleged violator is expulsion from Florida Society SAR, a two-thirds (2/3) vote of the members of the Board of Management present and voting shall be necessary to expel. Such alleged violator shall have a further right to appeal any action taken by the Board of Management to the immediately following Annual Meeting. Board of Management action other than expulsion shall be confirmed by a majority vote of the delegates at said Annual Meeting present and voting. If the action being sought against the alleged violator is expulsion from Florida Society SAR, a two-thirds vote of the delegates at said Annual Meeting present and voting shall be necessary to expel.

As the year goes on the trend is that the chapters are on the greater part growing, please look over the comparison chart to see how your chapter is doing. We are already ahead of last year and on a path toward 2500 members, it should be very close this year. Florida Society shows 2279 members but that includes Dual and Youth members which are not counted by National, without the Dual and Youth we have 2200 members.

I have made a concerted effort to get all the new leads which we get from National to the Chapters, and I believe that this has been a contributing factor in the number of new members that we are processing.

You can see from the chart that many of the chapters are doing very well, but there are a couple of that because of their locations have a very small new member pool on which to draw are not growing a fast as their neighbors. Then there are those chapters that are struggling because a lack of participation by their members this is unfortunate, but unless they are able to find one or two members who are willing to put in the extra effort then they will continue to slowly fade away. I have seen this in my own chapter which faded to 44 members in 2010 but has now increased to the point that we are looking to break off a new Okeechobee Chapter and our registrars (Steve Laster, Chuck McKinley and John Sheppard) have also been assisting the reforming of the Treasure Coast Chapter.

It is not easy and many times it is downright depressing when the end of the year comes and you lose 10 members or maybe half your chapter for not paying dues.

Retention is another point, it is probably the most difficult part of running a chapter "RENEWALS" it requires a huge amount of energy, resources and perseverance to get a every member paid, and there is no easy way, it requires notification of your members, re-notification of your members, personal contact and just plain stubbornness (I will not let my members walk away without my talking to everyone finding our why they are not renewing)

Commemorative Historic Sites

The Charter of the Commemorative Historic Sites Committee includes development of the history and background of such sites and to document such sites. Annually the Florida Society holds celebrations to commemorate each of three Revolutionary War Battlefields in Florida. The Last Naval Battle celebration is held at Merritt

Island in March, and the Battle of Pensacola and the Battle of Thomas Creek are held during May in Pensacola and Jacksonville respectively.

The Merritt Island celebration, being a landside event for a maritime battle, has an advantage of a "mature" venue with easy access and great facilities. Numerous Patriotic and Civic Organizations participate in this event which is hosted by the Brevard Chapter which took place this year on March 11th. Once again, a successful ceremony which included the marching of the Sons of Liberty Brigade for a distance of perhaps fifty yards.

The Thomas Creek celebration is rather a different matter. The battlefield in May 1777 was in a remote and challenging terrain, and the battlefield today remains a rather primitive and challenging environment. Our Compatriots from the Flagler Chapter visited the site in March and filed the following report submitted by Compatriot David Kelsey.

On 3/9/17, the Flagler Chapter conducted their 3rd annual six mile hike to and from the Thomas Creek Battlefield area located inside the Seaton Creek Historic Preserve. Several improvements were noted: The level of the parking area has been slightly raised with the addition of gravel. The wire fencing has been replaced with attractive wood fencing. The barb wire has been removed. The hiker walk-thru from the parking lot into the Preserve remains and has been strengthened and upgraded (just wide enough to allow only hikers and horses to pass thru -- no cars, trucks, ATVs). The trailhead area has been expanded and graveled. The trails have been widened (~8-10 feet) and are being mowed.

The annual celebration is scheduled for May 13, 2017, a week before our BOM meeting, and we hope they have a successful event. A word of warning however – two Compatriots who participated in the hike described above acquired deer ticks associated with Lyme Disease and both underwent prophylaxis treatment. Neither has had any further trouble. However, Florida has many natural hazards that may be encountered. This is especially true when off the beaten path. One should not be surprised to encounter alligators, poisonous snakes, and any number of bitey-critters. Caution is advised.

When further information becomes available about the Battle of Pensacola celebration (Scheduled for May 6th) I will report this as well.

Poster Contest:

Accordingly, for FLSSAR 2016-17 the Poster Contest theme will be Captain John Barry the Patriot Revolutionary War Hero of "The Last Naval Battle". For the Poster Contest, I would suggest the Chapter winner deadline date of April 2017. For the FLSSAR contest the chapter winning posters (24 X 36 inches) will need to be brought to the annual FLSSAR meeting by Friday Morning May 19th for judging in Room Cypress 2, from 1:30 – 2:00 P.M. Make sure Chairman Ramseur receives an original plus two copies of the entry form for the winning chapter poster. Attach the original to the back of the poster and Mr. Ramseur will mail one copy to the National Chairman and the other copy to NSSAR HQ before June 1. - The Committee is pleased to report the program is progressing well not only in the State of Florida but awards of medals and certificates are being presented by the FLSSAR to cadets in Puerto Rico. Requests for similar awards and certificates have also been received from cadets in Germany and we have forwarded these to the Germany SAR where those requests for awards are being presented to cadets in Germany.
- The Enhanced JROTC Program winner for the FLSSAR outstanding cadet is Cadet Major Jovan Vasquez of Manatee High School in Bradenton. Cadet Vasquez was nominated by the Saramana Chapter. Cadet Captain Thais Martinez of Golden Gate High School in Naples was in second place. Cadet Martinez was nominated by the Naples Chapter. It was a very close and highly competitive contest reflecting the outstanding quality of the cadets entering the Enhanced Program contest.
- The Committee has concerns that many cadets in Florida are not entering the Enhanced Program contest. The contest winner in FLSSAR receives a \$1,350 award and then competes at the NSSA level for a \$4,000 first place award, \$1,500 second place and \$1,000 third place award. These are awards worth competing for. Winning at the state and national level is a \$5,350 award!
- The Committee also has a concern that many of the cadets fail to follow instructions. Granted these are cadets are only eleventh graders in high school, but they are also outstanding students with great grade point averages. Attention to detail is important. So the question arises, are the cadets being given all the rules and regulations? The Chapters are responsible to provide all the current rules and the instructions to all the cadets. In the past couple of years, NSSAR has permitted Chapters to send entries back to the cadets for correction of missing data eg., essays that the cadet failed to add their name, rank, unit name, and name of school at the top of the first page of the essay or some or all of that data. These are all part of the instructions and points are lost if the cadet omits them. A Chapter needs to insure that the cadet both understands and receives these instructions and all other requirements of the contest. There is not a problem if a Chapter reviews an entry and returns it to the cadet for correction but the FLSSAR State Committee should not evaluate Enhanced Program entries and return them to be corrected and resubmitted.
- Lastly, the Committee recommends that recognition be given to second place entries. In the contest this year, there was only one point between first and second place. Granted only the first place winner goes to NSSAR but some recognition should be awarded for the second place.

The Public Service and Heroism Committee (PS&H) recognizes and honors citizens and individuals in our public service sectors of Law Enforcement, Fire Safety, and Emergency Medical Services for their contributions to the community and for heroic acts with a commendation and medal. States, chapters and commendation recipients are recognized in a booklet published and distributed at the National Congress each July.

The State-level PS&H Committee exists to publicize the committee's function to the states' local chapters and to encourage their participation. Awards presented are reported to the National-level PS&H Committee and the State-level society by filling out an on-line form. **All Commendations should be reported prior to June 1**, to ensure inclusion in the PS&H Committee Commendation booklet for distribution at the July NSSAR Congress. The fillable on-line Public Service and Heroism Award PDF forms may be found here. Some browsers use a default application to read PDF files and you may need to specify that the file be "opened" with the Adobe Reader application.

Note: Be certain to use the most current version of Adobe Reader for this form, as some web browsers have proprietary PDF readers that do not work with this form. Save the blank PDF fillable form to a file on your computer. Do not fill out the blank form on the above links. After saving the blank reporting form to your computer, fill out the form

completely. Use the second button-bar at the top, right-side of the form labelled "Click to Save and Email," to save the completed form to your computer and simultaneously send the completed form to the PS&H Committee. If you do not receive a receipt confirmation of the completed form in 3-4 days, contact the chairman of the PS&H Committee. One should also send the completed reporting form to their State PS&H chairman

This program is an excellent way to recognize deserving individuals in our community and the public sector. We do suggest that those individuals, in the public sector of Law Enforcement, Fire Safety, and Emergency Medical Services, who are being considered for a Heroism Commendation, be previously recognized by their division head for their heroism. Department heads generally welcome the opportunity to recommend deserving individuals for recognition. The commendations may be presented at either chapter meetings, departmental meetings, or other suitable events. The presentation of NSSAR commendations is an excellent means by which our Society can receive recognition and broaden our exposure and recruitment of potential new members. This program is also an excellent vehicle for publicity. The presentation of PS&H commendations at chapter and state meetings should be noted and reported by local media optimally; however, the recipient may elect not to have the commendation published for privacy concerns. Questions about the National SAR Public Service and Heroism Committee may be directed to a state's representative or the current chairman of the Public Service and Heroism Committee.

The Law Enforcement Commendation and Medal is presented to those who have served with distinction and devotion in the field of law enforcement. The medal is intended to recognize exceptional service or accomplishment in the field of law enforcement. Eligibility is not limited to peace officers but extends to the entire range of persons who make and enforce the law. This includes peace officers, attorneys, judges, prosecutors and legislators who have performed an exceptional act or service beyond that normally expected. The recipients are usually recommended by their superiors or peers for their accomplishments. The award may be presented posthumously. The medal may be presented to an individual only once. No Oak Leaf Clusters or ribbon attachments are permitted.

The Fire Safety Commendation and Medal is presented to an individual for accomplishments and/or outstanding contributions in an area of fire safety and service. The award is not limited to firefighters. It may be presented to recognize a variety of fire safety and services that have evolved into a highly technical and skilled profession with constant study, development and involvement by numerous dedicated citizens with a single goal, which is protecting human life and property by preventing injuries or casualties due to fire and chemicals. The medal maybe presented posthumously. The medal may be presented to an individual only once.

Oak leaf clusters or other ribbon attachments are not authorized.

The Emergency Medical Services Commendation and Medal is presented to an individual for accomplishments and/or outstanding contributions in the area of emergency medical services. The award is intended for paramedics, certified Emergency Medical Technicians, and others in the emergency medical field who have performed an act or service beyond which is normally expected. The medal may be presented posthumously. The medal may be presented to an individual only once, and no Oak Leaf Clusters or ribbon attachments are permitted.

A Heroism Commendation and Medal recognizes outstanding bravery and self-sacrifice in the face of imminent danger – i.e., acts which involve great personal courage and risk to the recipient. It is intended primarily for acts by civilians, not in uniform, but does not exclude police, firemen, EMS and SAR members. It is not intended to recognize acts that would have been covered in the performance of one's normal duty, nor by medals for valor by the armed forces. Animals are not eligible for recognition. The medal may also be presented posthumously. An individual may receive this medal multiple times. Presentation and the wearing of Oak Leaf Clusters shall follow NSSAR policy.

More detailed information on specific awards may be found in the NSSAR Handbook, Vol. 5, along with the description of the qualifying service.

Support the Troops (ad hoc)

Subject: Re-Review on the relevence of the FLSSAR Support the Troops Committee "Toiletries for Vets Program" President Wess,

- As directed, the following is a summary of my review of the original study and findings presented at the 2017 Winter BOM regarding the relevance and viability of the FLSSAR sponsored "Toiletries for Vets" program managed by the ad hoc Support the Troops Committee.
- The study reviewed the Support the Troops Committee program for the collection and mailing of personal hygiene products to active service military personnel, and explored the opportunity to sustain the program in partnership with local CAR chapters.
- As requested, this report will be submitted for inclusion in the BOM proceedings book and as the interim chair of the ad hoc Support the Troops Committee, I am prepared present the findings and proposed motion regarding the program and committee at the Spring BOM.

I. CAR Chapter Program Partnership Opportunity:

- 1. The CAR chapters interviewed are agreeable to working with SAR in supporting veteran's related projects.
- 2. CAR chapters feel that there is a greater need for personal hygiene products at local VA hospitals for patients' vs active military service members.
- 3. Palm Beach Chapter delivered a supply of personal Hygiene products, collected by SAR compatriots, to the Fifer George Weisenfels CAR Chapter who repackaged and delivered them to the West Palm Beach VA Hospital.

II. <u>Program relevance for active service military personnel:</u>

- 1. I personally interviewed serving members of the military, reserve/national guard units and veteran organizations including the American Legion, VFW, Purple Heart Society, and the Florida Veterans Foundation regarding their opinion on the relevance of the Toiletries for Vets program.
- 2. While all of the individuals and organizations interviewed praised the intent of the program itself, they all reported that in today's environment where military service personnel, even in forward deployments, have adequate supplies of personal hygiene and related products, that the SAR effort was no longer relevant.

III. <u>Conclusions & Recommendations</u>:

- 1. Based on the findings, there seemed to be a consensus that the program, while laudable, is no longer relevant for today's active service military members. Therefore, the Support the Troops committee recommends the following action:
 - i. *FLSSAR* discontinue the "Toiletries for Vets" program as presently constituted and reserve the existing budget for other veteran service related programs.
 - ii. Discharge the ad hoc *Support the Troops Committee* with the sincere thanks of *FLSSAR* and transfer the committee's activities and budget into the State Veterans Affairs Committee for review and management. [Committee discharged]
 - iii. Charge the *FLSSAR Veterans Affairs Committee* to identify opportunities and make recommendations for the use of the Support the Troops Committee budget.

IV. Proposed Motion Regarding disposition of the Committee and Veterans Program:

"Regarding the ad hoc FLSSAR Support the Troops Committee and its "Toiletries for Vets" service program, I move to discontinue the "Toiletries for Vets" program, discharge the Support the Troops Committee with the sincere thanks of the state society, and transfer that committee's responsibility, budget and management to the FLSSAR Veterans Affairs Committee."

- The USS Stark Contest for 2016 ended at year's end and the FLSSAR continues to show improvement with a total of 38,002 points earned in 2016 or 19.46 points per member versus 22,805 or 11.68 per member in 2015. There were six Chapters participating in 2016 versus five in 2015 and four then three in the most recent years.
 - A review of the points earned by category in 2016 versus 2015 shows a significant increase in hours served as volunteers in VA facilities a tenfold increase. Overall, FLSSAR continues to rank fourth in the nation behind Texas, Ohio, and Georgia. One way to look at it is that FLSSAR is in the top 8% of the NSSAR.
 - The 2017 contest is underway and will end on December 31, 2017. There have been numerous changes to the rules and the new USS Stark Award Scoring sheet is available on line. One of the biggest changes was in Section 11, where full credit is now being given for the donation of new items IF they are given within thirty days of purchase. Previously, a Chapter only received credit for one third of the purchase price.
 - The Chairman of the 2017 NSSAR Veterans Committee is Tony Vets. He and his Committee have been working on the changes in the contest rules. He is in Colfax, LA and his number is 318-627-2235.

Veteran's Recognition

We continued to expand the membership of the FLSSAR Veterans Battalion with now a total of 528, up from 514 members at the last report, who have served in the armed forces on active duty. A certificate of membership has been prepared and sent to the Chapter President for presentation to each new member. The roster of members has been updated 4 times since last October and a current roster dated 20 April 2017 is posted on the FLSSAR website.

Since the completion of the event last October, several RVP's and Chapters have requested that they be sent pins and other material for award to compatriots who were unable to attend the ceremony in Orlando. To date, we have forwarded nearly 100 of these items for local presentations. More are available upon request. Presentations are being made on a regular basis at Chapter meetings.

On December 16, 2016 the Jeff Miller and Richard Blumenthal Veterans Health Care and Benefits Improvement Act of 2016 (H.R. 6416) was enacted. According to a story in the May 2017 issue of the American Legion Magazine, Section 305 of this law states that any person entitled under Chapter 1223, Title 10, U.S. Code to "retired pay for non-regular service, shall be honored as a veteran but shall not be entitled to any benefit by reason of this honor." What does this mean? Now, honorary veteran status is allowed if a reserve-component member serves 20 good years, enough to retire. This has been a sore point for some of our Compatriots who served in the Reserve or Guard long enough to earn a retirement, but were not eligible for award of the Military Service Medal or membership in the FLSSAR Veterans Battalion. We will pursue a clarification of this new policy and report when there is definitive guidance.

On March 29, 2017 the President signed <u>The Vietnam War Veterans Recognition Act of 2017</u> designating every March 30th as *National Vietnam Veterans Day*.
