


# **Approval of Minutes of the Last Meeting**

President Robert J. Folk Sr. opened the meeting at 1:27 PM Saturday, 3 February 2018, and a quorum was certified by Secretary Hall Riediger. The Invocation was given by Chaplain Rev. Dwight D. Elam. President Folk Sr. led the Pledge of Allegiance, and Sr. Vice President Pat Niemann led the SAR Pledge. President Folk recognized Past President Generals Carl K. Hoffmann (1997-1998); Lindsey Cook Brock (2014-2015); J. Michael Tomme' Sr. (2016-2017); Immediate Past Vice President General South Atlantic District Lawrence G. Fehrenbaker, and the Past FLSSAR Presidents in attendance. Five first-time attendees were also recognized and welcomed.

Executive Committee members present included President Robert J. Folk, Sr.; Immediate Past President and Trustee Raymond Francis Wess; Senior Vice President Col. Patrick Jay Niemann; Secretary Herman Hall Riediger; Treasurer Walter Richard Young; and Member-at-Large Jeffery Sizemore. Also present was Past FLSSAR President and current Executive Administrator Steven Allen Williams. Parliamentarian Rev. Randy Moody was excused due to extensive damage to his church building arising from Hurricane Irma.

In a special presentation, Compatriot Jim Stone received the Pin and Certificate for his contribution to the George Washington Endowment Fund, recognizing him as a GWEF Fellow.

The Reading of the Minutes for the 4 November 2017 Board of Management (BOM) was waived with a Motion offered by PPG Carl K. Hoffmann. Carl Lambert seconded. The Motion was approved without objection.

Treasurer Dick Young gave a summary of the effort to raise matching "challenge match" funds for the Lanny Patton Challenge, whereby every three dollars contributed to the SAR Museum will be matched by a dollar from Compatriot Lanny Patton, up to \$100,000 – for a total of \$400,000 to be raised under this challenge. Young stated that the Challenge had been met, and the \$100,000 match was paid.

President Bob Folk summarized the actions and decisions of the Executive Committee meeting that took place on Friday, 2 February 2018:

A Gold Good Citizenship Award recommendation was rejected in a secret ballot by the members of the Executive Committee.

Discussions regarding a Florida Society Medal were tabled.

The FLSSAR Credit Card Authorization was increased to \$15,000 from \$10,000.

Strategic Planning – Special PowerPoint Presentation

Companion Charles Butler discussed the FLSSAR Officer Reimbursement Policy, and suggested changes. An open discussion followed.

Finance – Page 25 plus Pages 38-51

Compatriot Young declared that he is not recommending an increase in Dues.

Four amendments to the Budget were proposed:

Carry over a \$2,000 contribution to Fund for Florida's Future from 2017 that was not paid, and pay in 2018.

Ralph Nelson's collections from book sales in 2017 carry over as collections in 2018.

\$10,000 Surplus from 2017 earmarked to increase President's expense money from \$4,000 to \$5,000 per year for the next two years – calendar years 2018 and 2019. Also increase Sr. VP expense allowance to \$2,500 per year for two years also.

Balance of Surplus – approx. \$3,000 - to be added to the Gerald R. Meeks Funding for Florida's Future.

MOTION to approve changing the name of the Fund to the Gerald R. Meeks Fund for Florida's Future. PASSED.

MOTION to approve 2018 Budget as Amended. Each of the four proposed amendments PASSED.

# **National and State Officer Reports**

## **National Trustee**

Based on the Congressional Charter, NSSAR Constitution and NSSAR By-Laws, the property and affairs of the National Society are the responsibility of a Board of Trustees of at least 40 men, with one from each state society. Past PGs, current General Officers and current Executive Committee members may be elected/appointed as Trustees. Last May the FLSSAR membership voted to nominate me to serve as the Florida Trustee. I was elected to the position at the 2017 National Congress.

I attended the Leadership Conference and Trustee Meeting in Louisville on March 2-3. While there I took the opportunity to sit on the CAR Liaison and Insurance & Risk Management Committee meetings. There is more on the I&RM Committee Meeting in the Treasurer's Report. Items of interest that were discussed, or not discussed, at the Trustee Meeting are as follows:

- There was an update on the previously approved issuance of a Request for Proposal (RFP) to "fix" the existing NSSAR website. An RFP was issued to 15 parties, three of which responded. None of those three were thought to be acceptable. The Trustees approved the issuance of two more RFPs: one to build a new website and one to build a new member database.
- Former PG Lawrence proposed, and the Trustees accepted, changing the National History Teacher Award to \$15,000 per year, to be funded annually by former PG Lawrence.
- Former PG White proposed, and the Trustees accepted, the buildout of the remaining office space on the second floor of the Headquarters Building at a cost of approximately \$200,000.
- The Education Committee proposed, and the Trustees accepted, an American Founding Documents Educational Program & Curriculum and related workbook be funded, copyrighted and beta-tested at a number and variety of selected schools across the country at a cost of approximately \$7,000. The Committee has already put together a 24-hour program of instruction, focused on Middle School, that includes a Program overview, student & teacher workbooks, three quizzes and a final exam.
- The Genealogical Research System Project Committee reported that it continues to work on requirements for the GRS. They are not yet ready to issue an RFP.
- At the Fall Trustee meeting, it was agreed to extend the mandatory use of the on-line application form from January 1, 2018 to March 1, 2018. At this Winter Trustee meeting, it was agreed to again defer this mandatory use date to March, 2019.
- It was announced that as of December 31, 2017, the National Society had 36,961 members.
- In January 2018, PG Guzy, in an e-mail to the SAR Officers list, questioned the counting of the many donations made to the SAR Foundation to match the generous challenge of Compatriot Lanny Patton. Compatriot Patten has made his \$100,000 contribution to the SAR Foundation in support of the Solid Light (Museum) Project on the first floor of the Headquarters Building. This matter was not brought before the Trustees at this meeting.
- In the Winter 2018 issue of The SAR Magazine, the "President General's Message" (page 3) raised the question, "...how do we think we can manage an undertaking as large as a museum when we had been unable to build a great website?" This matter was not brought before the Trustees at this meeting.
- While in Louisville, I had the opportunity to meet and talk with Joe Hardesty, the newly appointed Library Director. Though several years later, Joe followed in my own somewhat dim footsteps by getting his undergraduate degree at Western Kentucky University followed by a graduate degree at the University of Kentucky. Joe is a compatriot with many years of experience and a passion for being a history and genealogy librarian. He will be a great asset to the SAR.

I plan to attend the next regularly scheduled National Trustees meeting in Houston on July 13.

## Meeting Attendance: 2016 - 2018

January 2018 meeting attendance was 35 including 21 members and 14 guests; February 2018 attendance was 23 including 16 members and 7 guests; March 2018 attendance was 23 including 19 members and 4 guests; April attendance was 28 including 19 members and 9 guests.

- June 3 Tom Wilcox, gave a presented The Battle of Brooklyn: The Lost Battle That Won the War
   October 7 Retired CIA official Donald Wyman gave a presentation concerning the CIA Museum.
  - November 4 Allan Lane gave a presentation concerning the fascinating end of the Civil War in native State of North Carolina, and how negotiations were almost derailed by the assassination of President Lincoln. The presentation is titled Sherman's Last Campaign—The Astounding end of the Civil War, Durham Station, NC, April 26, 1865.

February Chapter Meeting - Our featured speaker was Rear Admiral Larry Chambers USN 9ret). Larry was Commander of the USS Midway in April 1975 and was ordered to the waters off Saigon as part of Operation "Frequent Wind". Helicopters flew numerous sorties into Saigon to evacuate American military and civilian personnel as well as South Vietnamese military allies as North Vietnamese troops entered the city. The iconic photos of the day showed sailors onboard the Midway shoving fuel-depleted Huey helicopters off the flight deck to allow a South Vietnamese Major and his family to land a small, private airplane on the carrier's deck. In 2004, Chambers reunited with Major Buang-Ly and members of his family at the museum when the Major's daughter was 37 years old. She was 8 years old in 1975, when the safe landing took place. In March 2018, Rear Admiral Lawrence Chambers, class of 1952, received the U.S. Naval Academy Distinguished Graduate Award.

March Chapter Meeting – Our March meeting was huge, with more than 40 members and guests in attendance. Featured speaker LTC Benny Blackshire, US Army (ret), packed the house with his tales of clandestine work in Viet Nam, Cambodia, and Laos along the Ho Chi Minh Trail. His Top Secret work was only recently declassified, allowing him to share his incredible story.

April Chapter Meeting – Another large turnout for our April featured speaker Mike Deeb, a noted Civil War novelist and retired professor of American History. While much of Mike's published work is historical fiction following a Michigan boy through various major scenes during the Civil War, he has also published books on the assassinations of both Robert and John Kennedy. His topic to us, "Causes of the American Revolution" was timely and informative, and Mike offered to send our members a monthly newsletter centering on the Revolution.

Jefferson did not get along with Alexander Hamilton, forcing Washington to mediate. Washington ultimately sided with Hamilton and the Federalists, causing a rift between Jefferson and Washington that lasted several years until Washington's death.

He and other chapter members are attempting to raise awareness of the Revolutionary War and our founding fathers among students, who no longer are taught American history in high school. Additional details on his meeting will be included in the chapter newsletter.

At April 30, 2018, the Florida Society had \$165,000 combined in its checking and money market accounts. The annual dues from the Florida Society have been paid to and reconciled by the National Society. See the Finance Committee Report for a detail report on the cash receipts and disbursements for 2018.

Since the Winter BOM, your Treasurer has:

- Filed the required IRS 1099 Forms for the three FLSSAR Officers receiving a stipend and to the Youth Contest Award winners who received at least \$600 from FLSSAR during 2017.
- Attended the Winter Leadership Conference and Trustee Meeting in Louisville on March 2-3. I took the opportunity to sit in on the Insurance & Risk Management Committee meeting. More on insurance below.
- Participated in the Commemoration of the Battle of Thomas Creek in Jacksonville on April 7, in Colonial Militia attire.
- Participated in the Welcome Home for Honor Flight of West Central Florida Mission #33 at the St. Petersburg/Clearwater Airport on April 24, in Colonial Militia attire.
- Represented the Tampa Chapter in presenting JROTC Medals and Certificates at two high schools.

## Liability Insurance

At the Fall BOM the Executive Committee and/or the BOM asked me to, again, investigate a liability policy for the Florida Society, and to include NSSAR in my search. I contacted the NSSAR Insurance & Risk Management Committee Chairman. He sent me the advance draft of an article being submitted to the SAR Magazine on the need for each State Society to obtain liability insurance. My attendance at the I&RM Committee Meeting in Louisville on March 2 confirmed that the National Society general liability policy does not extend to the state societies or local chapters. There is some sentiment on this Committee to pursue that possibility on the next renewal date.

Shortly after the Leadership Conference and Trustee Meeting, I contacted two different brokers in the Tampa area, that I have worked with in the past, and one California based insurance carrier that works exclusively with non-profit organizations. The insurance carrier referred me to a local broker, who after a short discussion, advised that the carrier did not cover any organization that used fire arms, even if only in a "salute" without ammunition. The other two brokers continue to work with their own contacts but acknowledge that the few occasions that we do a black powder salute at state and local events has caused some carriers to decline to provide a quote. Both brokers tell me they are working with carriers that seem interested and hope to have quotes to me shortly.

## IRS Form 990

Your Treasurer is aware that IRS Form 990 EZ must be filed for the Florida Society on or before May 15 and intends to do so.

## **Recommended Application Submission Improvement Areas:**

- There has been sufficient previous notification by GG and others which have been forwarded to all FLSSAR Chapter Registrars regarding the change in NSSAR policy regarding unproven information contained on submitted applications. Unproven information can no longer be submitted on applications. Likewise any applicable information contained on document submitted with an application must be annotated on the application in the appropriate places when applicable. Failure to comply with these requirements will result in a pended application.
- NSSAR is identifying and will reject photocopied applications being received on SAR archival paper. A
  printer does a better job of injecting ink into paper if the copy prints from a computer command. If you
  take a printed application and simply photocopy it onto SAR watermarked paper it is insufficient for
  NSSAR requirements.
- Enclose 1 application copy on SAR watermarked archive paper and 1 application on plain paper for all applications submitted.
- Ensure all required signatures and dates are present as required for type of applications being submitted.

- Do not submit NSDAR web site printouts from the "Descendants Database Search" or NSDAR "Patriot Index" information. This information is not acceptable for either lineage or service and NSSAR does not want this unacceptable information included with any application.
- Ensure <u>ALL</u> applicable information contained on all submitted proof documents is recorded in the applicable sections of the application. Do not list references that are not being submitted and list all documents that have been submitted.
- Ensure all known spouse information is included when known for each generation even when the spouse is not in direct lineal descent. This will prevent applications from being pended when two person of the same name are living in a given area and this information would assist in identification of the correct person used on the application.
- Only one set of proof documents are required to be submitted with each application. This also applies when submitting more than one application under the family plan criteria. One set of proofs only for the common documents used by all the applications in the group. His does not apply to multiple supplemental applications submitted at the same time. Supplemental applications are always considered separately and require complete sets of documentation.
- Use a red pencil to underline applicable data on all proof documents and DO NOT USE any type of highlighter.
- Copy of entire legible original census page must be submitted when using a census as a proof document.
   Ancestry.com census transcription pages cannot be used in lieu of the original census page, but may be used in addition to the original page.
- Never use nick names on an application unless there is a required proof document has been submitted that validates the nickname.

## New NSSAR Application/Genealogy Policy and Prep Manuals

This new versions of these manuals are available for download from the NSSAR website.

- NSDAR/NSCAR Record Copy Acceptance Criteria Change 2011-06, Applications from other lineage organizations. SAR will now accept an official record or chapter copy of a DAR or C.A.R. application approved after 1 January 1985 as evidence of lineage and related fact except where DAR, C.A.R. or SAR has determined that the facts have been determined to be incorrect. In other words, center checks on applications approved after 1 January 1985 no longer prevent a DAR application from being accepted in lieu of other documents. Applications approved before this date are acceptable for corresponding facts marked as individually-verified on DAR and C.A.R. applications. The subcommittee acknowledged that there were arguments on both sides of the issue and what it proposed was a middle ground that it deemed in the overall interest of the organization. No review process is perfect, but the overall DAR review process is an excellent one that includes a number of checks and balances. The old policy was clearly confusing to many applicants, chapter registrars, and state registrars, and the genealogy staff was spending a great deal of time requesting further information relating to DAR applications. Compatriot Peterman made a point in discussion I think all of us share: we do prefer copies of the documents themselves. Acceptance date for NSSAR record copies is 01 Jan 1074 and after.

- Pursuant to Florida Society SAR Governing Documents, Bylaws, Article V, Section 2, Financial Review Committee (revision date: 10/16/2016), the Financial Review Committee has requested and received from the Treasurer sufficient financial records and specifically requested documents to perform the annual noncertified financial review for fiscal year January 1, 2017.
- Check balance of \$ 90,265.00 on the Wells Fargo Bank statement dated December 31, 2017, accurately represents the cash assets of the Society on that date at that institution. The Registrar, Secretary, and the Treasurer are authorized depositors for the checking account with confirmation of deposits by the Treasurer. The Treasurer has the only checkbook and has signed all checks during fiscal year 2017. There are other authorized check signers. There are no authorized co-signers. There are no other checking accounts. There is one Money Market Account at Wells Fargo valued at \$57,358.72 on December 31, 2017.
- There is no "petty cash," account. However, there are two Wells Fargo credit card accounts [\$9,000.00 limit on one designated for the Treasurer and \$1,000.00 limit on the card designated for the Secretary] which are reconciled by the Treasurer.
- There have been no additions or deletions of individuals authorized for financial transactions on the Florida Society accounts at Well Fargo since the Financial Review of 2016.

## 120 - Executive Administrator Position

A. The position has a term lasting until the Board of Management meeting closest to the FLSSAR Annual Meeting when

a. The FLSSAR Executive Committee can vote to renew the applicant's term for another year,

- b. Advertise for another candidate,
- c. Or to eliminate the position.
- B. The Executive Administrator should answer directly to the FLSSAR Executive Committee with requests by the committee members for administrative assistance routed through the FLSSAR President.
- C. The primary duties of the Executive Administrator shall be:
  - a. Assist the FLSSAR President with scheduling of meetings.
  - b. Tutoring a new President with the consistency of administrative functions specific to the FLSSAR.

  - d. Establishing scheduling blocks for BOM meetings.

Update to the FLSSAR Governing Documents which adds the stipend for the Secretary, Registrar and Executive Administrator that was previously approved at the BOM May 13-15, 2016.:

Section 2 Expenses of the Secretary, Registrar and Executive Administrator

#### **Commemorative Historic Sites**

- The Charter of the Commemorative Historic Sites Committee includes development of the history and background of such sites and to document such sites. Annually the Florida Society holds celebrations to commemorate each of three Revolutionary War Battlefields in Florida. The Last Naval Battle celebration is held at Merritt Island in March, and the Battle of Pensacola and the Battle of Thomas Creek are held during May in Pensacola and Jacksonville respectively.
- The Last Naval Battle Celebration took place as scheduled on March 10, 2018 at the Merritt Island site. This commemorates a battle which took place south of Cape Canaveral on March 10, 1783. Continental Navy ships Alliance commanded by Captain John Barry and Duc de Luzun were en route from Cuba to Philadelphia with a cargo of silver when they encountered three British ships including the Sybil commanded by Captain James Vashon. Through the daring strategy of Captain Barry, the Alliance was able to disable the Sybil which then withdrew. The program included a wreath laying on the shores of Sykes Creek and is hosted by Brevard County Sons and Daughters of the American Revolution.
- The Thomas Creek 241st Anniversary celebration was held on April 7, 2018. Over 100 attended this celebration, with greetings brought from the City of Jacksonville by Ms. Susan Grandin, past local Director of the Trust for Public Land. Greetings were also brought by Florida and Georgia SAR Chapters, and DAR and C.A.R. Chapters. Dr. Roger Smith taught attendees that the Battle of Thomas Creek was not just another border

skirmish, but another attempt to make N.E. Florida the 14th Colony. An SAR Musket Salute brought the program to an impressive closing.

As information, our very good FLSSAR entries for the Poster and the Brochure did not make the finals at Congress in Knoxville as a NSSAR winner but they were well recognized for their talent. This year at Congress in Houston, we are again looking forward to winners. After serving many years on this important

youth committee, I am passing the Chairmanship to Compatriot Larry Sturgeon of the Withlacoochee Chapter, who has some great ideas for growing this program. Thanks go to all who helped make this a viable educational program for our youth.

#### **Poster Contest:**

Accordingly, for FLSSAR 2017-18 the Poster Contest Revolutionary War theme will be the "Battle of Pensacola". As before, I would suggest the Chapter winner deadline date of April 2018. For the FLSSAR contest the chapter winning posters (22 X 28 inches) will need to be brought to the Annual FLSSAR meeting Friday May 18th before 3:30 P.M. in the

Cypress I meeting Room for Judging. Make sure Chairman Ramseur receives an original plus two copies of the entry form for the winning chapter poster. Attach the original to the back of the poster and Mr. Ramseur will mail one copy to the National Chairman and the other copy to NSSAR HQ before June 1. **Brochure Contest:** (The Sgt. Moses Adams Memorial Middle School Contest)

Again the theme for the Brochure contest is different than the poster contest and centers around the 8th grade curriculum where American History is normally taught in middle school. Submission is on an 8 ½ X 11 piece of paper that is created into a tri-fold brochure. The brochure will be judged on student art and student authored theme text. Material cut and pasted from books, magazines and the internet will be accepted but will receive a lower grade than student produced the art work. Our FLSSAR submission deadline from individual chapter winners will need to be mailed or emailed to me by the end of April 2018. I will then email all chapter entries to our FLSSAR judges for their review and scoring. Hopefully, by the middle of May, I will be able to forward by email our FLSSAR State Brochure winner to our National Brochure Chairman Tom Adams. Chairman Adams will then repeat the process for all the state winners to all the NSSAR judges in order to have a winner for final evaluation at Congress in Houston in July 2018. "The permanent Middle School Brochure Contest theme that began with the 2016-2017 academic term will again be "The Foundational Documents of the United States". The theme for the Brochure Contest is structured to match up with the Government curricula found in the majority of states during the middle school years. The students will be encouraged to pick a particular founding document and produce a brochure within the established criteria. This will eliminate the need to revisit the theme on an annual basis while providing a large amount of flexibility to adapt to the established curricula."

The Eagle Scout Committee performs and supports several very important activities:

Eagle Scout Recognition Certificates - Throughout each year, new Eagle Scouts are recognized by local SAR members for their outstanding achievement at their Eagle Court of Honor, and presented with SAR Eagle Scout Certificates of Achievement. IF possible, our Compatriots should be dressed in Colonial Uniforms or similar period dress. Packets of Eagle Scout Recognition Certificates can be purchased through the NSSAR Merchandise Website at www.sar.org.

Arthur M. and Berdena King Eagle Scout Award Contest – SAR invites all Eagle Scouts (under 19 years of age) interested in the American Revolution to participate in the Arthur M. & Berdena King Eagle Scout Award. The contest is open to all Eagle Scouts who are currently registered in an active unit and have not reached their nineteenth birthday during the year of application. While the preliminary rounds of the contest begin at the local level, Scouts may eventually advance to the state or national levels, eventually held in June during the annual SAR Congress, and awarded up to \$10,000.

- College plans do not have to be completed in order to receive the cash award. Three cash awards are given: the National First Place Winner receives \$10,000; the Runner-up receives \$6,000; and the 2nd Runner-up receives \$4,000. Scouts may apply more than one year if he meets the age requirements, but no more than \$10,000 total may be granted to any one Eagle Scout. Prizes and recognition may also be awarded at the SAR chapter and society level our Florida Society currently awards \$1,000 to the first-place winner, with an additional \$300 provided by the FLSSAR Auxiliary.
- Each Eagle Scout must complete an application form, a four-generation ancestor chart, and a 500-word patriotic themed essay.
- The competition is conducted in three phases: the local chapter, state-level society, and national phases. The competition is entered at the Chapter level. Applicants may not enter at the national level. Contest entrants need complete only one application for the SAR chapter-level competition. The application of each Chapter-level winner is forwarded to be used in the society- and national-level competitions by the SAR as appropriate. - The JROTC Committee is pleased to report that awards of medals and certificates have been presented to the outstanding cadets throughout the State of Florida and Puerto Rico in high school JROTC units and college ROTC units. Chapters have responded promptly to requests from the JROTC/ROTC unit officers for these awards. Good Job!
  - This years Enhanced JROTC Program contest winner for the FLSSAR Outstanding Cadet is Cadet Samanta Marlene Pomier Jofre from Naples High School. She was nominated by the Naples SAR Chapter. Cadet Pomier Jofre has a 4.76 GPA and is an outstanding student, leader and accomplished member of her community as demonstrated by her leadership and contributions to her school, unit and community. She as outstanding potential.

It is critical that the Chapters and the units bear this in mind for the nominated cadet to be competitive at the NSSAR level. In 2016, 21 states submitted nominees; in 2017 there were 24, and this year there are 29 nominees. The competition is increasing. The winner at NSSAR receives \$4,000, second place receives \$1,500 and third place \$1,000. The NSSAR judging is currently underway, and the winners are expected to be announced by the middle of May.

Over the past year OAS has continued to serve at two Florida Veterans Medical Centers:

James A. Haley Polytrauma Unit (Tampa)

Bay Pines Community Living Center (St. Petersburg)

We have scheduled one visit each month at each facility. We serve up to six patients each visit at both locations for approximately two plus hours. Our three to six volunteers are primarily from the Clearwater Chapter with occasional help from volunteers from two local DAR chapters and the Pinellas County Genealogical Society. Our efforts take a break from June-September due to volunteer availability.

At these two facilities OAS is warmly received. Patient acceptance and enthusiasm is high. Often, the patient's benefits are seen as profound. Our volunteers also receive psychic benefits from performing the service.

Regrettably, efforts by other state SAR chapters have not been successful in gaining cooperation at other VA centers.

This year, 2018, marks the thirtieth anniversary of the establishment of the USS Stark Memorial Award event. It was initiated in 1988 to memorialize the brave men and women who have and who continue to stand up and to protect and preserve the freedom our patriotic ancestors fought so long and hard to achieve.

The purpose of this memorial award is to recognize all chapters and award outstanding chapters and state societies for their work with and for veterans. Some of these activities include making contributions to veterans hospitals, nursing homes and medical centers; hospital, nursing home and home visitations; outings; volunteer service; participation in veterans' funerals; flag placement on graves; working with veterans in ancestor search to mention just a few of the activities. Participation with Veteran and other organizations at memorials and other sites is also import and and should be recognized and reported.

The highlights and accomplishments by the chapters in the state is covered in their respective chapter reports. At the state society level, the USS Stark Memorial Award contest ended at year end. Total points earned in 2017 was lower by 30% from 2016. Only four chapters participated in 2017 versus six in 2016. On the plus side, points earned in 2017 were higher than in the five years prior to 2016. Part of the decline in the 2017 points earned may have been due to construction at the James Haley Veterans Hospital in Tampa, and volunteers were unable to contribute their time and talent.

The 2018 contest is underway and will end on December 31, 2018. It is important to realize that the NSSAR state society winner is determined by the total points earned by all the chapters in the state divided by the total membership in the FLSSAR Even if a chapter reports only a few points - not enough to win even the small chapter award or compete in the state, it helps the FLSSAR in the NSSAR contest.

Lastly, I would like to thank the eight members of this committee for their work this year. Your contributions have been greatly appreciated. Many thanks.
