

President Robert J. Folk Sr. opened the meeting at 10:00 AM Saturday, 19 May 2018, and a quorum was certified by Secretary Hall Riediger. The Invocation was given by Chaplain Rev. Dwight D. Elam. Miami Chapter President Bernard W. Wolff led the Pledge of Allegiance, and Compatriot RVP Scott Bushnell led the SAR Pledge. President Folk recognized and Introduced and received Greetings from President General Larry T. Guzy; Secretary-General Warren M. Alter; and, South Atlantic District Vice President General James Wood. Past President Generals Carl K. Hoffmann (1997-1998); Lindsey Cook Brock (2014-2015); Immediate Past Chaplain General Rev. Randy Moody; and Immediate Past Vice President General South Atlantic District Lawrence G. Fehrenbaker were also introduced and recognized. Seven first-time attendees were also recognized and welcomed.

The Reading of the Minutes for the 3 February 2018 Board of Management (BOM) was corrected from the floor, with a Motion offered by David Kelsey to substitute the guest Speaker's Certificate of Appreciation with a gift of equal value from the SAR Merchandise Store. The Motion was APPROVED.

President Bob Folk summarized the actions and decisions of the Executive Committee meeting that took place on Friday, 18 May 2018:

- Recommendation to the BOM MOTION: Disband the Treasure Coast Chapter (Vero Beach).
 - Members will become "At Large" Members until they transfer to another Chapter. PASSED.
- RECOMMENDATION: Pay \$90 pro-rata fee to Southeast Atlantic District for District website annual maintenance. (No vote; included in Budget.)
- Referral to Meetings and Arrangements Committee that consideration be given to the purchase of a portable audio speaker system with wireless microphones, at a cost not to exceed \$400.

Finance – Page 35 plus Page 49

Compatriot Young declared that a Budget shortfall of \$(2,000+) for the current year. We have the resources to cover it, but 2019 Budget will reflect increases to cover continuing anticipated shortfalls.

Two immediate recommendations were proposed for:

- 1. Address the Florida Patriot Magazine increased printing costs by seeking competitive bids for future publication expenditures. (Printing Company was sold, and new Owners have raised prices substantially.)
- 2. Ralph Nelson's collections from book sales in 2017 carry over as collections in 2018. Many thanks for his contributions, and recommended continued support by all Compatriots.

MOTION to accept Finance Committee Recommendations. PASSED.

Editor, <u>The Florida Patriot</u> Magazine Printing and distribution costs have increased substantially, and are now up to \$2.75 per printed copy (28 pages, 510 printed). 700 copies are currently printed, and 1,700 are distributed by email. The consensus of the (lengthy) discussions was in favor of digital publication and distribution, with the option of purchasing hard copies for any Compatriot who wishes to do so.

Ralph Nelson/Don Lanman - MOTION: Discontinue hard copy publication of The Florida Patriot Magazine, and go 100% digital for all future distribution. vLarry Sturgeon(Withlacoochee) – AMENDMENT: Allow the option to offer printed copies, by adding \$15 per year per subscription. AMENDMENT PASSED.

(1) in the Annual Congress Host City, immediately after the Annual Congress adjourns,

(2) in Louisville as part of the Fall Leadership Conference, (3) in Louisville as part of the Winter Leadership Conference, (4) in the Annual Congress Host City immediately prior to convening the Annual Congress.

At April 30, 2018, the Florida Society had \$165,000 combined in its checking and money market accounts. The annual dues from the Florida Society have been paid to and reconciled by the National Society. See the Finance Committee Report for a detail report on the cash receipts and disbursements for 2018.

Since the Winter BOM, your Treasurer has:

Filed the required IRS 1099 Forms for the three FLSSAR Officers receiving a stipend and to the Youth Contest Award winners who received at least \$600 from FLSSAR during 2017.

- Attended the Winter Leadership Conference and Trustee Meeting in Louisville on March 2-3. I took the opportunity to sit in on the Insurance & Risk Management Committee meeting. More on insurance below.
- Participated in the Commemoration of the Battle of Thomas Creek in Jacksonville on April 7, in Colonial Militia attire.
- Participated in the Welcome Home for Honor Flight of West Central Florida Mission #33 at the St. Petersburg/Clearwater Airport on April 24, in Colonial Militia attire.
- Represented the Tampa Chapter in presenting JROTC Medals and Certificates at two high schools.

Liability Insurance

At the Fall BOM the Executive Committee and/or the BOM asked me to, again, investigate a liability policy for the Florida Society, and to include NSSAR in my search. I contacted the NSSAR Insurance & Risk Management Committee Chairman. He sent me the advance draft of an article being submitted to the SAR Magazine on the need for each State Society to obtain liability insurance. My attendance at the I&RM Committee Meeting in Louisville on March 2 confirmed that the National Society general liability policy does not extend to the state societies or local chapters. There is some sentiment on this Committee to pursue that possibility on the next renewal date.

Shortly after the Leadership Conference and Trustee Meeting, I contacted two different brokers in the Tampa area, that I have worked with in the past, and one California based insurance carrier that works exclusively with non-profit organizations. The insurance carrier referred me to a local broker, who after a short discussion, advised that the carrier did not cover any organization that used fire arms, even if only in a "salute" without ammunition. The other two brokers continue to work with their own contacts but acknowledge that the few occasions that we do a black powder salute at state and local events has caused some carriers to decline to provide a quote. Both brokers tell me they are working with carriers that seem interested and hope to have quotes to me shortly.

Authorized Check Signers

At the Spring BOM it was decided that the Treasurer should approach Wells Fargo about deleting all the currently authorized checks signers on the Florida SAR checking and money market accounts, except for those that are current members of the Finance Committee. I visited a branch in Spring Hill and worked with a surprisingly helpful customer service representative who removed all authorized check signers except for the current Treasurer, Hall Riediger and Kevin Yarnell, all members of the Finance Committee.

IRS Form 990

Your Treasurer is aware that IRS Form 990 EZ must be filed for the Florida Society on or before May 15 and intends to do so.

I want to remind each chapter to file its own IRS Form 990N or 990EZ and file it on time.

- Proof document title page and copyright page not submitted for one or more documents.
- No proof submitted for one or more generations to connect lineage from one generation to the next.
- Incorrect check amount required for NSSAR and/or FLSSAR fees and dues.
- Lineage names do not match the submitted proof documents such as middle name or initial missing or given names shorted such as "Frank" instead of "Franklin."
- Word(s) miss spelled in all areas of application.
- Application form used is not the current authorized form.
- Lineage section locations do not conform to required format which is "City/County/State" such as commas used instead of "/" or "/" not used even if city and/or county not known.
- Lineage section dates not properly formatted full known date should be 2 digit numeric day (i.e. 02), 3 character month (i.e. Sep) and 4 digit year (i.e. 2001). (i.e. 02 Sep 2001)
- Proof document missing, listed on application but not sent with the application.
- Unproven/unaccepted information used on application from a previous SAR, DAR and/or CAR application record copy.
- Service reference section left blank on application form.
- Chapter Name and State section left blank on application form.
- Lineage not correct for one or more generations.
- One or more required application signatures are missing on the application.

Recommended Application Submission Improvement Areas:

• The SAR embraces and has approved four membership application forms: MS/Word version; PDF version; SARApAid by Cox Software; and My Applications, the online application system. Links to the current updated version of each of these four forms is available from the SAR website by clicking on https://sar.org/application. Revised versions of the four forms have been acceptable since they were first approved by the Trustees in March 2017 but outdated versions of these forms, in particular the MS Word, the PDF, and the SARApAid forms, continue to be received at Headquarters. Now, the Trustees have set an effective date after which outdated versions of the forms cannot be used. At the 2018 NSSAR Fall

Leadership Meeting, the Trustees approved October 31, 2018, as the effective date for use of only the current versions of these application forms. The new application forms have several important changes: removal of the spaces for listing of the applicant's children, a revision to the applicant's signed certification, and addition of a space for signature of the Genealogist General. The current version date for each form type is:

- o MS Word version: "adopted Feb 2017 SAR Application Form 2017" found on the bottom of the application form.
- PDF version: "Rev. Mar 2017" found on the bottom of the application form.
- SARApAid by Cox Software: "Appaid Ver. 5.03... Feb 21 2018" found on the bottom of the application form.
- o My Applications (the online application system): This format does not have a revision date but any application printed after May 7, 2018 will automatically contain the required changes.

Only application forms with these, or more recent revision dates, will be accepted as of October 31, 2018. While leeway is certainly due those whose applications were in process at the time we reach the deadline, we need for this deadline to be respected and we request those who assist with application process – sponsors, genealogists, registrars, secretaries, and others – to assist our applicants in using the right application form and in avoiding the disappointment of having their form returned because of use of the wrong form. Bob Fish, Chairman NSSAR Genealogy Committee Jim Faulkinbury, Genealogist General

- There has been sufficient previous notification by GG and others which have been forwarded to all FLSSAR Chapter Registrars regarding the change in NSSAR policy regarding unproven information contained on submitted applications. Unproven information can no longer be submitted on applications. Likewise any applicable information contained on document submitted with an application must be annotated on the application in the appropriate places when applicable. Failure to comply with these requirements will result in a pended application.
- NSSAR is identifying and will reject photocopied applications being received on SAR archival paper. A
 printer does a better job of injecting ink into paper if the copy prints from a computer command. If you
 take a printed application and simply photocopy it onto SAR watermarked paper it is insufficient for
 NSSAR requirements.
- Enclose 1 application copy on SAR watermarked archive paper and 1 application on plain paper for all applications submitted.
- Ensure all required signatures and dates are present as required for type of applications being submitted.
- Do not submit NSDAR web site printouts from the "Descendants Database Search" or NSDAR "Patriot Index" information. This information is not acceptable for either lineage or service and NSSAR does not want this unacceptable information included with any application.
- Ensure <u>ALL</u> applicable information contained on all submitted proof documents is recorded in the applicable sections of the application. Do not list references that are not being submitted and list all documents that have been submitted.
- Ensure all known spouse information is included when known for each generation even when the spouse is not in direct lineal descent. This will prevent applications from being pended when two person of the same name are living in a given area and this information would assist in identification of the correct person used on the application.
- Only one set of proof documents are required to be submitted with each application. This also applies when submitting more than one application under the family plan criteria. One set of proofs only for the common documents used by all the applications in the group. His does not apply to multiple supplemental applications submitted at the same time. Supplemental applications are always considered separately and require complete sets of documentation.
- Use a red pencil to underline applicable data on all proof documents and DO NOT USE any type of highlighter.
- Copy of entire legible original census page must be submitted when using a census as a proof document. Ancestry.com census transcription pages cannot be used in lieu of the original census page, but may be used in addition to the original page.
- Never use nick names on an application unless there is a required proof document has been submitted that validates the nickname.

Notes of Interest:

• New NSSAR Application/Genealogy Policy and Prep Manuals
This new versions of these manuals are available for download from the NSSAR website.

- NSDAR/NSCAR Record Copy Acceptance Criteria Change 2011-06, Applications from other lineage organizations. SAR will now accept an official record or chapter copy of a DAR or C.A.R. application approved after 1 January 1985 as evidence of lineage and related fact except where DAR, C.A.R. or SAR has determined that the facts have been determined to be incorrect. In other words, **center checks on applications approved after 1 January 1985 no longer prevent a DAR application from being accepted in lieu of other documents.** Applications approved before this date are acceptable for corresponding facts marked as individually-verified on DAR and C.A.R. applications. The subcommittee acknowledged that there were arguments on both sides of the issue and what it proposed was a middle ground that it deemed in the overall interest of the organization. No review process is perfect, but the overall DAR review process is an excellent one that includes a number of checks and balances. The old policy was clearly confusing to many applicants, chapter registrars, and state registrars, and the genealogy staff was spending a great deal of time requesting further information relating to DAR applications. Compatriot Peterman made a point in discussion I think all of us share: we do prefer copies of the documents themselves. Acceptance date for NSSAR record copies is 01 Jan 1074 and after.

The Charter of the Commemorative Historic Sites Committee includes development of the history and background of such sites and to document such sites. Annually the Florida Society holds celebrations to commemorate each of three Revolutionary War Battlefields in Florida. The Last Naval Battle celebration is held at Merritt Island in March, and the Battle of Pensacola and the Battle of Thomas Creek are held during May in Pensacola and Jacksonville respectively. The Charter, as recently amended, includes celebration of Liberty Tree Dedications.

A proposal was submitted to the Chairman of the NSSAR Historic Sites and Celebrations Committee to recognize Liberty Tree Dedications as National Events. The proposal was circulated to members of the committee for preliminary review, and was placed on the agenda for the Leadership Meeting in Louisville on September 28th. There were three proposals reviewed at this meeting, two were approved. I had the opportunity to discuss the proposal and answer questions from committee members before a favorable vote was taken. - The accountings for month-end August 31, 2018 reflect the new format since the conversion of the trust accounts from Charles Schwab to Regions Bank. The conversion occurred in the month of February and the responsibility for the investment selections has been transferred to Regions. All the assets were sold and new assets purchased. Those transactions are shown on Schedule D, as well as any Gain (Loss). Regions Bank charges a monthly fee based on Market Value which is reflected on Schedule B.
- The new accounting format reflects the "Unrealized Gain (Loss) on the Summary page to better communicate the progress of the accounts at a simple glance.
- The Endowment Trust Fund accounting does not indicate to whom the chapter distributions were made on Schedule C. This is a one-time issue caused by the information not being available at the time that the accountings were to be submitted for publication in the Blue Book. The check numbers were known and are reflected and the chapter information will be on the annual accounting for December 31, 2018.
- This will be my last submission as my term is expiring as of December 31st and I have chosen not to run again. I thank all of the Trustees for their support and knowledge throughout the last three years.
- [John Stewart] So far, 16 chapters have been approved for \$8,956.21. In accordance with the Trust document and the policies and procedures of the ETF Distribution Committee. Half of that has been distributed and the balance will be sent out in December. Applications for proper reimbursement for expenses incurred during the fiscal year ending October 31, 2018 will be accepted through November 15th.
- Elsewhere in these proceedings, there should be an interim accounting. The required accounting for the full year will be presented for approval after the end of the calendar year.
