FLSSAR STATE OFFICER'S REPORT President

Lindsey Brock October 22, 2006

Since our August 2006 BOM meeting, I have communicated with many of our FLSSAR officers, chapters, committee chairman and members. Contact has also been made with various NSSAR and FSCAR officers and staff on various topics. Additionally, Compatriot Greg Ohanesian, VPG of the South Atlantic District and I have communicated via phone on various topics including plans for the upcoming November 4, 2006 South Atlantic District meeting in Charleston, SC.

It was my pleasure to meet with the Executive Committee of the Gainesville Chapter on September 5th to discuss and explore many aspects of local chapter activities. Our primary focus was the task many of our chapters are experiencing in the enlistment of members to serve in official capacities within their local chapters. Other topics discussed at the meeting included membership promotion and retention. We also discuss the topic of associate membership. I explained the Jacksonville Chapter's experience in the establishment of associate members. On September 9th, Ben DuBose and I meet at the new facility of the Cape Canaveral Port Authority, 445 Challenger Road, which is currently under renovation. The purpose of the visiting the site was to check on the progress of the renovation and to insure that the new facility has adequate parking and coordinate the specific area which the State of Florida Historical Marker and the cannon would be placed to commemorate the first celebration of "The Last Naval Battle of the American Revolution, which will be held on March 10, 2007. FLSSAR Committee Report Joseph P. Rumbaugh Orations Contest

The following information was sent out to all local Chapter Presidents by e-mail. If others need the information, we can easily send it out to them. The critical first step in participating in the Rumbaugh Oration Contest is for the local chapter to choose a contest chairman and send his information (name, address, phone no., & e-mail address) to Gordon Greenwood at 352-378-8764 or gordonegreenwood@aol.com or 4117 NW 33 Place, Gainesville, FL 32606 so we can begin the process of communicating with one another about the local and FLSSAR contest and the procedures to be followed. FLSSAR hasn't had a national winner since 1997 and there were only two participants in last January's FLSSAR contest. Let's work together to change that!

The Rumbaugh Oration Contest: Some Questions & Answers

1. What is an oration?

An oration is a carefully prepared formal speech written in advance (and given to the contest judges in advance), committed to memory, and delivered without notes. In this case, a speech of at least five minutes in length but not more than six.

2. What topics can the oration be about?

Oration topics should be about a Revolutionary War event (e.g.: The Battle of King's Mountain or the Boston Tea Party), a document (e.g.: Declaration of Independence or the Bill of Rights), or a personality (e.g.: Benjamin Franklin or Sir William Howe), showing the relationship it bears to America today. For example, the 2005 winning oration was about the separation of church and state as provided in the Bill of Rights and its implications for religious activities in schools and other public places.

3. Who can participate in the Rumbaugh Oration Contest?

Any high school student, public, private, or home-schooled, in grades 10-12 at the time of the contest.

4. When and where is the contest?

The state (FLSSAR) competition will be held at the winter Board of Management meeting on January 19, 2007. Therefore, local chapter level competitions should be held before that time. Probably most local chapters hold their contest in the November-December time frame. The national (NSSAR) competition will be held at the 117th Annual Congress in Williamsburg, Virginia, July 6-11, 2007. All state organizations will send at state expense one winner and a companion (e.g.: parent, coach) to the national contest. The last Florida winner was in 1997. There were only two participants in last year's state FLSSAR contest.

5. What are the prizes for the contest?

a. Local chapter level prizes will be determined by each local chapter. Many local chapters provide a first prize of \$50, a second prize of \$25, and a third prize of \$15, since they may be reimbursed for those amounts. The local chapter will also need to make reservations and provide for transportation and expenses (hotel room, dinner) for the winner and a companion (parent, coach) to the Winter Board of Management meeting. Such expenses may be reimbursable. The contest usually takes place in the late morning or early afternoon of the first meeting day and the results announced at the Friday evening banquet.

b. State level (FLSSAR) prizes are as follows:

First Place: \$1000. Second Place: \$500. Third Place: \$250 All Others: \$100

In addition the first place FLSSAR winner will receive a medal and certificate as well as transportation and expenses to the national contest. c. National level prizes are:

First Place: \$3000. Second Place: \$2000. Third Place: \$1000. All other finalists: \$300. All other contestants: \$200.

6. How will the competition be judged?

At the state level the three judges, who must be given a copy of the oration in advance, will use the following criteria:

- a. Composition (organization, vocabulary, logic) 20 points
- b. Delivery (voice, body movement, gestures) 40 points
- c. History (research, accuracy, American Revolution based) 20 points
- d. Significance (relation to current issues) 20 points

In addition, penalty points will be deducted for orations violating the at least 5 minutes but not more than 6 minutes time limits for delivery.

7. How can the local chapter recruit students to enter the contest?

Designate at least one person in the chapter to contact local public and private schools as well as home-schooled students. Who to contact will vary locally, of course, but many public school systems have English or Language Arts Coordinators or Supervisors who are in charge of providing curriculum materials and textbook adoptions. These professionals are in an excellent position to advise you as to how to proceed or who to contact.

Otherwise, the next best course would be to contact the Superintendent's office and/or building Principals for guidance as to what English teachers to contact. The Superintendent's office should also be able to provide the names of students being home schooled.

Additionally, it's good to keep in mind that most senior high schools are divided into departments and the Chair of the English Department may turn out to be the most helpful person of all. Often one or two English teachers will be most interested in speech and/or debate and may even supervise extra-curricular activities such as a Debate Club.

FLSSAR Committee Report Membership Promotion & Retention

This committee was contacted and met electronically to discuss ways of promotion more membership and retaining the members that we have. Many chapters contributed the following list of suggestions and we thank them for their participation in this most important chapter activity.. Not all of these suggestions are right for all chapters, but in the list are items that may help your chapter encourage more eligible men to seek membership and more of your members to renew annually.

SOME SUGGESTIONS FOR CHAPTERS TO INCREASE MEMBERSHIP

Following are some suggestions which chapters might use to help recruit and retain chapter membership. Many chapters contributed to this list and we thank them for their contribution. If anyone has other suggestions on how this life blood of our Society can be increased, please pass this information on to the Membership Promotion & Retention Committee. The following are not listed in any order of importance. All are considered good and all came from various chapters in our Florida Society.

- 1. Contact the National Society and give them the Postal ZIP Codes for the counties served by your chapter. Ask National for a list of any SAR members who have moved into those Zip Code areas. Then make a personal contact with the individual about joining your chapter.
- 2. In your chapter newsletter, ask you chapter membership to "talk-up" SAR at every opportunity. Don't hide you membership. Make SAR a matter for public discussion.
- 3. In your chapter, help make SAR, DAR and CAR function as one. If your chapter recruits a new SAR member, ask if he has any children or grandchildren who might become CAR members and a wife who might be interested in DAR
- 4. Anytime the Color Guard participates in an event, it is an excellent opportunity to give out brochures about membership in SAR.
- 5. Chapters should participate in Genealogy Seminars by having a recruiting desk complete with members in Colonial Uniform and plenty of SAR literature. Advertise the fact that the chapter will assist prospective members in the application process.
- 6. History Fairs are an excellent place to talk about SAR membership and to distribute SAR literature.
- 7. Members of other lineage societies (i.e. The Society of Colonial Wars, Mayflower, Founders and Patriots, etc.) are excellent candidates for membership in SAR.
- 8. It has been stated that the entire question of attracting members rests on the focus of the chapter. Is the chapter a viable and working chapter in the state society, or is the chapter simply a "meet and eat" chapter? These are the real benchmarks. If there is nothing going on to interest a new member who has just paid hundreds to join and be recognized for his patriot, then that member will drop within one or at the most two years if not given a reason to stay.
- 9. Initiating new programs, especially programs involving the youth, can involve grass-roots participation of the membership with little or no cost other than the time involved.
- 10. Request a list of the "dropped" members of your chapter from the State Secretary. A personal call, asking them to renew their membership, might prove successful.
- 11. Suggested Bylaw if the chapter adopts the idea of Associate Membership. A suggested Bylaw for the Chapter Constitution os available upon request from the Senior Vice President.

- 12. Contact the dropped members and encourage them to renew their membership.
- 13. Ask a new member what program he would like the chapter to participate in.
- 14. Ask the new member what he is interested in doing to promote the SAR objectives.
- 15. Use provisional membership in case of a natural disaster (hurricane, flood, tornado, etc.).
- 16. If the member is confined to a nursing home or assisted living facility, forgive State and Chapter dues. Note: This would require State and Chapter agreement.
- 17. Create a "Helping Hand" Fund in the chapter to take care of dues needs for confined members.
- 18. On the chapter dues notice, ask for extra dollars to be used to pay the dues for members who for whatever reason can not afford the dues.
- 19. Hold a retreat of officers and committee chairs to brainstorm ideas on how to retain and attract new members.
- 20. Work closely with the DAR. Many of the DAR husbands are eligible for SAR membership, but have not been invited or encouraged by their DAR wife.
- 21. Be sure to recognize the DAR for any prospects they supply who become members of SAR. Remember, there is a medal available for DAR members who provide three SAR members.
- 22. By sending in the appropriate Zip Codes to National, request a list of any SAR members who have moved into those areas from other State Societies.
- 23. Use the email to communicate with members between chapter meetings. Keep them informed.
- 24. Improve communications between the officers and members of the chapter.
- 25. Provide a written job description for every chapter position, both officer and committeeman.
- 26. Ask other organizations what they are doing to attract new members. Talk to them about SAR and see if you can recruit from that organization to SAR.
- 27. Create a membership brochure. Put the brochure in libraries and distribute copies to other organizations.
- 28. Pay the Life Membership fee for older members who can not afford it.
- 29. Have joint "business" meetings with DAR chapters to discuss membership recruitment.
- 30. Advertise SAR! Put the chapter meeting information in as many local newspapers as possible each month.
- 31. Schedule table set-ups where the chapter ;can promote the society and the chapter.
- 32. Make a serious attempt to get the local news media to attend as many of the chapter events as possible.
- 33. Be sure to "cash in" on the Keynotes to History discs which are available for your local radio stations.
- 34. Have a chapter color guard and provide it to some other organizations in addition to participating in Veterans Day parades, Christmas parades, etc. Show the colors!
- 35. Many members will not, or can not, purchase or make a colonial uniform for the color guard. Encourage all of the chapter members to purchase a tricorn hat and wear it with your blazer. It attracts attention and it advertises the SAR.
- 36. The Daytona-Ormond chapter has a website which advertises "Researching Data for SAR Applications." They state that this can be used by any chapter, but it does have local references that may or may not be available in other locations. Look it up. It may give your chapter some ideas on how your chapter can create its own website.

Many thanks to the many chapter who contributed to the above list of ideas. There are certainly many other innovative ways to promote and retain membership in our chapters and those listed above are only a few. The Committee received a quarterly statistical report for the period 7/31/06 through 9/30/06 from Michael Jones, NSSAR Librarian-General. The report summarized membership data for members of the Friends of the SAR Library (FOL) for all state societies. FLSSAR remained in first place with a total of 52 personal and chapter

members (down from 56 on 1/1/06). The FOL funds are used to supplement the regular library operational budget, providing new services such as database subscriptions, books, and other materials for the library collection. This is quite separate from fund-raising efforts for the proposed **Center for Advancing America's Heritage**, the new building that will house the NSSAR Library.

Vice-President Grant Wallin, a member of the national library committee as well as this committee, returned from the Fall Leadership Meeting in Louisville with a somber message: "The main item that came out of the library situation is that National seems to think that we as members and state societies should get on board or the balance will be very difficult to raise. One-half of the dollars are raised. They have enough money to build the building, but they desperately need the remaining three-million to put in trust to staff and maintain the building. In other words, to make the building self-sufficient, the remaining part of the goal MUST be raised or they cannot go ahead with it. With a national membership as small as ours, the dollars that come in from dues and merchandise sales is not sufficient to carry the extra load of a library. I feel that in our Florida Society, we need to try to get our members to send in their dollars through their chapters to FLSSAR and then have the FLSSAR add to that total and present one check to National."

Website Review Committee (Ad Hoc) Report

Background

Phase One - To develop any recommendations, we realized that we needed to look at the current website, get an idea of what the future website might be – its purpose and intended use. The concept that the FLSSAR website should in some fashion be a marketing tool for potential members, an information tool for our membership, and a tool used to recognize individuals and chapters developed from this initial phase. This mirrored the language in the NSSAR Vance Award in describing what a winning website should have and will be judged on: overall appearance, and usefulness to the members, usefulness to the public, promotion of the SAR, creativity, clarity, functionality, and speed loading. Also, we determined that the website should be easily navigated, uncluttered, targeted to our audience, have an attractive and professional look, with current & timely information. Discussion developed specific ideas for web elements: SAR appropriate graphics; textual content to be right-sized in size and quantity; website navigation via a menu system; and use of sound files either eliminated or used only for special, unique requirements; and a color scheme that is fitting for FLSSAR. Further, discussion offered the following as minimum website navigation elements:

- *Officer's Page
- *Member's section
- *Committee section
- *Calendar of events
- *Online Newsletter
- *Chapter or State Society Activities/Photos
- *Meeting Information/Facts

*Application Worksheet

*Links to NSSAR/NSDAR/NSCAR

While our study focused mainly on the FLSSAR website, we also recognized the need for specific guidelines for those chapters within the Florida Society who have (or will have in the future) their own sites. Therefore, many of our observations, suggestions, recommendations and comments refer to websites operated and maintained at the chapter level.

Group Consensus during discussions: 4 agreed on major points, 1 dissented on some points.

Phase Two discussions were centered on the need for Web Standards for both the state and chapter sites and what shape those standards might take. The result is Recommendation 1.

Group Consensus during discussions: 5 agreed on the general idea with differences on scope of concept.

Phase Three discussions were based on the need, if any, for any addition or changes to the FLSSAR Bylaws. The result is Recommendation 2. It is presumed that if recommended by the Executive Committee and approved by BOM this recommendation would affect either a committee charter change or Bylaw addition that would fall into Article III Section 14.

Group Consensus during discussions: 3 agreed on initial Recommendation, 2 abstentions; further discussions led to unanimity for subsequent recommendation.

Recommendation 1: Web Standards

WEB SITE POLICY AND PROCEDURES

General Rules

The FLSSAR webmaster is not the sole owner of the FLSSAR website or the material contained on it. This means that no copyright is allowed unless it is specifying original articles, poems, graphics or materials. In addition to the FLSSAR webmaster, at least one other member of the Florida Society should have the information and codes necessary to access the FLSSAR website in the case of emergency.

The FLSSAR website should, at a minimum, contain the following elements:

- *Officer's Page
- *Member's section
- *Committee section
- *Calendar of events
- *Online Newsletter
- *Chapter or State Society Activities/Photos
- *Meeting Information/Facts
- *Application Worksheet
- *Links to NSSAR/NSDAR/NSCAR

The FLSSAR website should be easily navigated, uncluttered, targeted to its audience, have an attractive and professional look, and provide current and timely information.

The FLSSAR website should promote the SAR in a positive manner. The following things should be avoided at all times:

- *Anything that could potentially violate the Society's 501(c)3 tax-exempt status. These kinds of activities would include endorsing a specific political candidate for office, endorsing a specific political party, or promoting commercial activities or linking to commercial websites.
- *Displaying any personal information about a Compatriot that could potentially lead to identity theft.
 - *Displaying the names, photographs, or addresses of anyone under the age of 18 without the specific written consent of the parent or legal guardian.
 - *Criticizing SAR, allied organizations, or individuals.
 - *Doing anything that violates the standards of good taste.

Any Chapters may continue to have their web presence within FLSSAR website. If they desire to create their own website, they will be assisted as needed by the Electronic Technology Committee.

Recommendation 2: FLSSAR Webmaster Duties

The following language options are recommended to define the duties of webmaster.

<u>Option 1:</u> The following language is recommended as an addition to the Committee Charter, Electronic Technology Committee.

ELECTRONIC TECHNOLOGY COMMITTEE

Purpose: To develop, design, implement, and maintain the usage of Electronic Technology and the FLSSAR web site as methods of information dissemination furthering the purposes of the Society.

Authority: Florida Society Bylaws, Article V, Section 6. b.

Members: A Chairman and Members who shall be appointed by the President, Florida Society, and whose terms shall be concurrent with that of the appointing officer.

Functions:

- 1. To maintain the domain name "flssar.org" with interNIC, its successors or assigns, for the purposes of implementing and maintain its use as a method of disseminating information to compatriots and third parties, furthering the purposes of the Society.
- 2. To maintain information regarding the Society, its objectives, programs and members, and methods of dissemination thereof, balancing available technology and budgetary constraints of the Society.
- 3. To reduce the cost of both intra- and inter-Society communications by:
 - Maintaining public awareness of the Society and its programs to increase membership,
 - b) Increasing the timeliness of inter-Society communication,
 - c) Creating electronic archives of the Society.
- 4. Unless otherwise directed by the FLSSAR Board of Management, it shall be the duty of the Webmaster to establish, operate and maintain the FLSSAR website in such manner and style as to accomplish the following objectives:
 - a. To provide current and applicable membership recruitment information to the general public;
 - b. To disseminate official information;
 - c. To provide a vehicle for the officers of the FLSSAR to share and exchange views and information with the membership.

The Webmaster shall determine the format and content of the website, and shall arrange for its design, operation and maintenance, and will insure that the website URL is at all times available to all members of the Florida Society. All content shall conform to the objects, charter, bylaws, and policies of the FLSSAR and to the rules, directives, and limitations enacted by the Board of Management.

The Webmaster shall be appointed by the FLSSAR President and shall have the power and duty to act as agent of the FLSSAR to execute and administer contracts with firms or individuals acting as independent contractors to provide services and materials for the hosting of the FLSSAR website, subject to the limitation that the aggregate amount of such contracts shall not exceed the funding authorized by the Board of Management or the current approved budget.

Option 2: Requires FLSSAR Bylaws and Committee Charter Changes

"Section xx Webmaster

Unless otherwise directed by the FLSSAR Board of Management, it shall be the duty of the Webmaster to establish, operate, and maintain the FLSSAR website in such manner and style as to accomplish the following objectives:

- 1. To provide current and applicable membership recruitment information to the general public;
- 2. To disseminate official information;
- 3. To provide a vehicle for the officers of the FLSSAR to share and exchange views and information with the membership.

The Webmaster shall determine the format and content of the website, and shall arrange for its design, operation, maintenance, and will insure that the website URL is at all times available to all members of the Florida Society. All content shall conform to the objects, charter, bylaws, and policies of the FLSSAR and to the rules, directives, and limitations enacted by the Board of Management.

The Webmaster shall have the power and duty to act as agent of the FLSSAR to execute and administer contracts with firms or individuals acting as independent contractors to provide services and materials for the hosting of the FLSSAR website, subject to the limitation that the

aggregate amount of such contracts shall not exceed the funding authorized by the Board of Management or the current approved budget."
