## FLSSAR STATE OFFICER'S REPORT National Trustee

Incumbent: Frank X. Hodaiski October 9, 2003

For this quarter, my activities have included: Attendance at the Fall meeting of the Trustees, 25-28 September 2003, at the national headquarters in Louisville. A summary of the most important items taken up is as follows:

FUNDRAISING: A good deal of the discussion centered around the remaining fundraising necessary to begin construction on the Center for Advancing American Heritage. Currently \$910K of the \$1.1 to 1.2 million in hard money has been raised. A target date of November 1<sup>st</sup> has been set for seeking bids with a 60 day ad with bid opening in early spring and construction phase to follow. A push to raise the last \$100K is ongoing as is the drive to fund equipping the facility and the \$3 million endowment for the maintenance of the building. Bottom line: The Center for Advancing American Heritage will be much more than a library; it will house a museum and a genealogical center to advance education and research serving visitors from all over the United States.

NEW LIBRARY: Trustees were informed that in the library area of the new facility, all existing microfilm will be put in storage and replaced by Internet connection, CDs and other electronic sources. Oversight will be provided by the Information Technology Committee. The IT will articulate with the Genealogy Committee to establish criteria. There was some comment from states which had invested heavily in donations of microfilm rolls. These trustees were told that microfilm would still be available on demand and readers available for those who wish to view the films.

POSSIBLE LIAISON WITH AMERICAN LEGION: NSSAR may soon partner with the American Legion in efforts to promote suitable programs. A joint committee of both organizations will be named and will meet to explore areas of possible cooperative effort. The president general spoke of the potential for good and the increased national exposure and effectiveness for both groups.

RUMBAUGH CONTEST: As directed by the BOM, I presented a letter to Rumbaugh Committee Chairman Rod Hildreth expressing FLSSAR opinion on criteria for judging and the advantage held by repeat contestants to the national contest. He asked if he could reproduce the letter for distribution and I agreed. We spoke for nearly an hour.

#### IN ADDITION:

- 1. The Chicago Congress lost about \$20K due to failure to meet guarantees.
- 2. A professional fund management firm has been employed to grow our investments. FLSSAR SrVP Miller is a member of the NSSAR Finance Committee and attended the committee meeting.
- 3. Budget for next year was approved.

ELECTIONS 2004: There will be a contested election for president general at the Pittsburgh Congress. Secretary General Henry McCarl will be opposed by Charles Bragg. The office of Genealogist General will also be contested as Incumbent GG William Neal will be opposed by Edward Butler of Texas.

## **Current Financial Status-NSSAR**

Harold F. Miller Jr.-Member Financial Comm. NSSAR

At the Fall Trustees Meeting in Louisville, The Finance Committee met at 9AM, Friday, Sept. 26, 2003, at the NSSAR Headquarters and was chaired by Charles W. Grissett. The first meeting I attended as a new member was at a combined meeting of the Budget, Finance, and Investment Committees held at the 113 Congress in Chicago on Tuesday, July 8, 2003. On 8/25/03 I received by mail the Statement of Activities for the General Operating Fund which covered the current month of July and year-to-date. I received the following month of August figures and year-to-date figures at this Trustees Meeting. The negative variance, **actual verses budget**, expanded from \$5705.in July to \$16,884 in August. The monthly negative variance from July 31<sup>st</sup> to August 31<sup>st</sup> went from \$9629 to \$26,513. As of August 31<sup>st</sup> this 8 months year-to-date negative variance figure (\$26,513.) occurred as the positive budget figure of \$231,304 exceeded the actual year-to-date positive figure of \$204,791 by this amount.

These slightly negative figures are a reflection of our drop in new members as well as the number of compatriots not renewing their memberships. This has reduced our society's anticipated revenue by \$53,000. Over the past five years about 25% of first year members have dropped from the membership rolls.

Much has recently occurred to improve our cash flow in the future with the increases in regular application (+\$25.) and supplemental (+\$20.) fees effective November 1, 2003. There has not been an increase in these fees in the past ten

Membership, net of Nat'l Life & French Society members, at the end of August was 25,507. With the net full dues paying members at 24,368 as of 9/1/03 and the net full paying members projected for 9/1 through 12/31/03 to be 949, the total net member projection is 25,317. The total dollar projection for this year is, therefore, 25,317 x \$25.00= \$632,925. With the State Life Membership at 2014, the cash projection is further increased by \$40,280 (2014 x \$20.00.) to a grand total of \$673,205.00.

Two years ago at our 112<sup>th</sup> Congress NSSAR established the SAR Foundation which is a "supporting organization", directly controlled by the NSSAR, the "parent". NSSAR operates as a 501c3 not-for-profit entity while the Foundation operates as a 509c3 not-for profit. The "supporting organization" operates quite differently than the "private corporation".

Two months ago the Finance Committee concurred with the executive committees' approval of BB&T as the temporary investment custodian successor to PNC who had received some bad publicity due to an attempt to cover up bad loan transactions. A decision was expected to have been made last Friday to appoint The Fifth Third Bank as the investment advisor to replace PNC. Through out the coming year the society will slowly move 85% of the restricted net assets to this new investment manager in the SAR Foundation. The balance of the assets, the George Washington Endowment Fund, a permanently restricted asset class, with its own board of managers, will move its assets to BB&T as soon as practicable. In essence all that will remain is the operating account with the investment account disappearing.

## FLSSAR Committee Report Advancing America's Heritaage

On August 8-9 at our Summer BOM meeting in Winter Haven Charles "Chuck" F. Bragg, NSSAR Committee Chairman as well as the current Registrar General of our National Society made a presentation about the ongoing effort to build our Center for advancing America's Heritage. At the conclusion, "Campaign Leadership Briefing Handbooks" were distributed to our seven Regional Vice Presidents. Your Florida Society President and Senior Vice President have led the way by making contributions worthy of a Campaign Lapel Pin and Medal. I respectfully ask all Florida Society members to help out with this deserving effort. The summer edition of the SAR magazine on pages 26 and 27 has pictures and a list of those that contributed. The new building will be 9700 square feet on the land just south of our 12000 square foot headquarters building. Half of the six million to be raised will be placed in an endowment to maintain its operations. Analysis indicates a need of \$1,350,000. cash balance before construction can begin. Past President General Larry McClanahan said at the Fall Trustee Meeting that he expects to request bids in December and award contracts in January. Our world wide SAR annual dues paying members are projected to be 26456 by year end. If all of them make a one time gift of \$50.00, this would almost cover the \$1,350,000.needed to commence construction.

#### About the new Library and Museum

Will more than double existing square footage for library and can be expanded in future.

Will allow tours for American school children to be expanded.

Will enable the SAR to provide better access for students, scholars, writers, and interested Americans to our Museum artifacts, newspaper collections, and the papers of George Washington, George Clark. And the Marquis De Lafayette, and will allow for the acquiring and displaying of new artifacts, documents, and books about the early history of our country.

Will have expanded areas for education that can accommodate computers and technology for students, scholars, writers, and interested Americans.

Will allow SAR to promote its use for historical and scholarly research.

Will allow for museum expansion into old library space.

Will enable the SAR to develop on-line facilities for the teaching of the history and heritage of the Revolutionary era.

Will enable the SAR to develop programs for the instruction of immigrants and "newly minted" Americans,

in our common civic culture, including our history, heritage, and the English language, that is essential for the successful integration into American culture and civic life. The Center for Advancing America's Heritage will make it possible to develop and distribute orientation materials for legal immigrants upon naturalization, including a brief discussion of U.S. history, law, & principles of democracy.

Will enable the SAR to expand existing youth programs, and implement new ones.

I am still receiving reports that some of our chapters are still having difficulty securing the names of Eagle Scouts because the local Scout Executive claims that this is privileged information. Previously I presented a plan to avoid this problem, and I will repeat it here. First, it is absolutely necessary to have a good working relationship and understanding established with the local District Scout executive (the professional serving the District) and the local District Eagle Scout Board of Review Chair (a volunteer). After thoroughly explaining our program to them, and reviewing our materials, ask if you can prepare a SAR Eagle Scout Scholarship "kit" to be given by the Board to each new Eagle Scout immediately upon his successful passing of the Board of Review. The "kit" should have a congratulatory letter from the chapter which explains that the Application and the Four-Generation Ancestor Chart complete with a 500 word (or less) theme on some subject that concerns the Revolutionary War must be in the chapter's hands no later than December 1st of this year. This allows time for the chapter to judge the entries and to pick a chapter winner. The winning entry must be forwarded to me to arrive no later than January 2nd, 2004 so the State Committee will have time to select a winner at the January BOM. The "kit" should also include an Application Form, a Four-Generation Ancestor Chart and an Eagle Brochure which explains the National Program.

The letter included in the "kit" should also include an invitation to present a SAR Eagle Scout Certificate of Recognition at the new Eagle Scout's Court of Honor. It is a wonderful opportunity to put the SAR in public view.

Both the West Central Florida Council and the Central Florida Council provide the names and addresses of ALL Scouts who earn the Eagle Rank during the year. This certainly makes our job a little easier, but the method outlined above will provide the names of Eagle Scouts who are actually interested in our scholarship program.

This communication has been forwarded to all EdComA members requesting their advice. Accordingly, I hope to be able to provide the BOM with a verbal report of our decision on Oct. 17th.

2. Jack Bovee, one of the two EdComA consultants and Director of the Social Studies Programs for Collier County has agreed to break away from the State Social Studies conference (Orlando) and meet with the BOM on Saturday morning, October 18th at 9AM (Larry Bradley has graciously agreed to allow us a short period so he (Jack) can brief us). Jack will bring relevant materials for us to use (info, pre-written letters, etc.). He will brief us on three areas: 1) the need for passing bills, already in the Legislature, (and the role we play) that would require Florida students to take and pass courses in American History, Government and Economics if they are to graduate from High School, 2) the inclusion of relevant questions on (lower grade) promotion tests and 3) the inclusion of similar questions on the FCAT. 3. Jack has been sent a copy of the NSSAR Heritage Foundation CD entitled: "America's Heritage — An Adventure in Liberty." He intends to burn 70-100 copies and provide them to all of the relevant Supervisors/Directors at the Orlando meetings.

4.
