### FLSSAR STATE OFFICER'S REPORT

#### **National Trustee**

Harold (Hal) F. Miller, Jr. October 22, 2005

I wish to thank President Harry Hollien for starting the process of organizing a caucus of those of us that attended the Fall Trustee Meeting. Because of an important last minute conflict, Harry could not attend. However, SVP Lindsey Brock stepped up to the plate and offered his suite as a place to meet and decide where we should concentrate our time. Every effort was made to attend those committee meetings that directly affected our interests. The following 23 Committees were covered by our members: Bylaw, CAR, Color Guard, Congress Planning, Congress Site Selection, Council of VPG's, DAR Liaison, Finance, GWEF/Distribution, GWEF/Fund Raising, Historic Sites & Celebrations; Hospitality & Music, Investment, Knight Essay Contest, Law Enforcement, Fire Safety & Heroism, Patriotic Education, Protocol, Special Projects, Strategic Planning, ROTC/JROTC/Service Academy, Veterans, &War Graves.

It was good to have such a fine turnout from Florida. The eight members in attendance were: Lindsey Brock, Phil Carr, Dick Friberg, Fred Gaines, Ron Hamilton, Frank Hodalski, Hal Miller, and Bill "Steve" Stevenson.

I am today as upbeat as I was when I first reported as National Trustee at our Summer BOM. Our Constitutional Protocol success at the Congress in July, which restored the ranking of the VPG's to their proper positions following the PG, has put FLSSAR on the map. I must admit, however, that since that report much anxiety has occurred in the minds of many of Florida's SAR's. This came about with the rules of Protocol being rewritten by the new Protocol Chairman, former PG Howard Horn. His proposed rules were unacceptable to us, especially since the Trustees would have had no say as to the approval or disapproval of these rules. Our Florida State Chancellor, Carl K. Hoffmann, who is a member of the NSSAR Protocol Committee expressed our objections and submitted suggestions to Chairman Horn which helped bring about the necessary changes. At the Fall Trustee meeting our Florida Delegation received by hand from the Protocol Chairman a copy of the first page of the revised rules (Paragraph 2) which stated that "These rules of Protocol are subject to the approval of the annual Congress..." At the formal banquet that night these new rules of protocol were explained by PG Roland Downing and then executed.

That fact that news about these Constitutional and Bylaw actions taken at Congress failed to appear in the Summer SAR Magazine, which was mailed in early September, further added to our anxiety. It was not until I saw former PG Carl Hoffmann's attachment of September13th's email from former PG Hank McCarl that I discovered the reason for this omission. It seems that "Charles Britton (*Bylaw Chairman*) went to work after the Congress to incorporate all the changes in the Bylaws and we just received his rewrite in digital format about two weeks ago (*October 1?*) so we did not have the exact wording of the revisions until after the deadline for the Summer issue of the SAR Magazine..."

Subsequently, I was much relieved to see in the <u>Headquarter Dispatch</u> that the minutes of the 115<sup>th</sup> Annual Congress were included. On page 13, the 7 Bylaw proposals were discussed as was the action taken on each by the Trustees. The 7<sup>th</sup> proposal was our amendments to Article IV, Section 1, of the Constitution concerning the precedence of the VPG's in the Society, placing them after the PG and ahead of the other general officers. It was adopted 165-38 or by 77%. By the way, this last <u>Headquarter Dispatch</u> was the final issue to be printed. In summary, as to Protocol, I hope we can now put all our anxiety behind us.

One of the first actions taken by PG Roland Downing was his establishment of a new ad hoc Bylaw Task Force that will function during 2005-6 and submit its work product to the NSSAR after the Dallas Congress and before the Fall Trustees meeting in 2006. The Task Force's goal is to create a self-consistent document having less ambiguous language and improved format. They must consult with the Bylaw's and Legal Advisory Committees whenever they think their new language may change the meaning of a provision as opposed to clarifying or removing conflicts. Proposing changes in law is not the function of this effort. The members of the Task Force are: Howard Horn, David Appleby, Peter Keltch, Carl Hoffmann, and Nathan White. In any case, we must continue to be vigilant.

At our Fall Trustee meeting a motion was made by Frank Hodalski, Alternate Trustee, laying out a road map for establishing an SAR Memorial Membership for the late USMC Corporal Timothy Creager, a true American hero, recently killed in Iraq. On October 10<sup>th</sup> a thank you letter from David John Kelsey, Sr., President of the Flagler Chapter, SAR, was received by President Harry Hollien, FLSSAR. It expressed a special thank you to compatriot Hodalski who guided the unanimously passed procedure as set forth in the FLSSAR proposal through the NSSAR. All fees were waived and a decision was made to look at any similar requests in the future on an individual basis.

Adding icing to the cake, we responded to Joe Harris, Chairman of the ROTC/JROTC/Service Academy Committee, who had expressed a need for an additional \$1000 to cover the Committee's 2005-6 operating expenses. Our response was immediate. At the beginning of the Trustee meeting, during the gifting period,

FLSSAR gave \$1050 to satisfy this need. The following Florida members, as well as our State and one chapter made this happen: Doug Bridges, Lindsey Brock, Alvie Davidson, Dick Fowler, Ron Hamilton, Carl Hoffmann, Hal Miller, John A. Williams, FLSSAR, and Deland Chapter SAR. A challenge was made to the other State Societies, Trustees, and members to help out, with some success. Joe Harris was also very pleased that his expenditure of \$787.97 for the printing/handling of ROTC pamphlets was approved for reimbursement (\$788.00) by the George Washington Endowment Fund Distribution Committee from 2005 money.

What is really needed here are large donations to the ROTC/JROTC/Service Academy Committee Endowment Fund so that their annual needs of \$3000 to \$4000 could be met without having to ask for help every year.

We will continue to structure this report in two parts.

#### A. American Heritage (Hollien)

The group responsible for this part of the program has not been as active this quarter as it has been in most others. The reasons are three: 1) the chair is involved in a number of other FLSSAR program upgrades, 2) we have only a few American Heritage (History) CD's available for the schools and 3) the Summer and early Fall are not the most opportune times to interact with the various facets of school systems. However, one of the committee members currently is organizing the distribution of the History CD's to the Home Schoolers. While still not the largest in number, this group probably is the most important of the three K-12 cohorts. Finally, there are still requests for CD's from Compatriots who are interacting with the public and private school sectors and these programs will be upgraded once additional teaching aids become available.

#### B. Legislative (Toops)

The following is a summary of my views related to Social Studies (American History, et. al) legislation. It is based on my attendance at a meeting with the association of Florida Social Studies Supervisors (FCSS/FCSSS):

- 1) The FCSS members attending recognize that there is still a need to pursue legislative remedies, but they need to better understand their own objectives and how to communicate them. They need to have more effective lobbyists and they recognize that they need to pay them appropriately. The FCSS members planned to devote their entire October meeting to defining a legislative strategy for the future.
- 2) I found that many individuals within the Social Studies community are trying to develop plans and programs within their school systems which present American History fully and in a good light. There were many examples of these plans, which included assessments. I believe they represent material consistent with our purposes.
- 3) There are undercurrents of opposition to taking action to increase Florida's focus on Social Studies (Am. History, Civics, Geography, Economics...) within some local school administrations, within the DOE and with some of our legislators. Again, it is my view that (some) school administrators in many Florida schools are purposely not providing support for the teaching of Social Studies. Not only do they do not support teaching or measuring our Florida students' knowledge of Social Studies, they actively oppose these efforts!
- 4) It is obvious to me that the SS teachers and supervisors are at a disadvantage, since their jobs and performance ratings depend on these same administrators... therefore it is difficult for them to push too hard against the system.
- 5) There is some fear that the new DOE Chancellor will not be friendly to the cause of Social Studies. Hearsay implies that this is the reason she was rejected in Minnesota, but then recommended for the position in Florida.
- 6) Some of the FCSS group suggested that, since they know the content of the Social Studies topics that they teach (i.e., American History), they could not only assess students' knowledge but also report this performance data to their own organization (FCSS). They might also share it with the media, the public and their supporters (not likely, however). It will be interesting to see if the FCSS members can agree on this strategy. I believe the Social Studies community (teachers, supervisors...) is performing a fine job, one consistent with our (FLSSAR) ideas, but is receiving little support from the State of Florida, the DOE and, even, some of their school administrators!

Finally, I have requested that Jack Bovee provide us feedback on the October FCSS meeting.
