### FLSSAR STATE OFFICER'S REPORT National Trustee

As a member of the NSSAR Medals and Awards Committee I attended the committee meeting on September 26th , 2008. One of the agenda items for discussion was the Battle of Pensacola Medal proposed by the Pensacola Chapter. When I reviewed this proposal earlier I advised President Toops that only State Societies and NSSAR Committee Chairmen are permitted to submit proposals for medals. President Toops sent e-mail to Chairman Jacks noting that the FLSSAR Executive Committee and BOM members had approved the proposal. Chairman Jacks acknowledged the e-mail. When the item was brought up for discussion Chairman Jacks stated the proposal had to be reviewed by the NSSAR Historic Sites Committee prior to Medals and Awards approval. I advised Chairman Jacks that the FLSSAR had been assured by members of the Historic Sites Committee that the proposed medal would be approved and the Historic Sites Committee was meeting at same time as Medals and Awards. Chairman Jacks said medal would not be considered prior to Historic Sites Approval. There is a long standing precedent in Medals and Awards Committee of only considering medals proposed by a State Society or NSSAR Committee. It is my opinion, with a (99.99%) certainty, that the medal will not be approved unless it is presented as a Florida Society medal.

On September 27 I attended the Trustee Meeting. Sam Powell, Capital Campaign Manager, CAAH, briefed on the 5 year effort to raise funds for the CAAH. The President General's Report indicated the William C. Dunhard Charitable Foundation gave a one million dollar gift to the CAAH this past summer. Compatriot Powell estimated it would cost 8 to 10 million dollars to complete the CAAH. He emphasized, that in securing corporate donations, it is necessary to prove that the SAR membership also supports CAAH. The program to accomplish this is the State Recognition Challenge Campaign. All donations, by state, from 1999 to date are included in the totals. When state donations average \$250 per member, and at least 20% of the state's members have donated, the state's name will placed on a plaque displayed at the CAAH. The report for June 30, 2008 showed only two, (Delaware and DC), have achieved that goal. Florida had 8% of its members donating with average per member of \$49. Compatriot Powell showed architectural drawings of the CAAH. President Toops asked if it would be possible for the states to get copies of the drawings. He believed it would be of great help when soliciting donations. PG Appleby stated he thought this could be arranged.

\* This implies that each individual has given some amount to the SAR Foundation.

It is important that the chapter record and give credit to <u>each individual</u>, if the chapter decides to collect the funds and then send them directly to the SAR Foundation.

I have provided an example form to the above chapters for this purpose ...very important!

\*\* This growth rate (7%) will result in the Florida Society returning to a count of 2000 members in about four (4) years.

**Note**: I have asked Hall Reidiger and William (Steve) Stevenson to collect the results from the chapters over what is termed the Silent Phase, i.e. July thru Dec 31, 2008 and thereafter for Dec 31, 2009. This data, i.e. 30% of membership participation, will be used to leverage the participation of corporate and local community donors.

I have selected the above named chapters because they are the ones that I have visited or will visit prior to the Fall BOM. The Sr. Vice President and his team of Regional Vice Presidents are encouraged to spread the word and assist Hall Reidiger and Steve Stevenson in collecting the data over the next 18 months. I will make a brief presentation on this material at the Fall BOM.

I certainly appreciate the hospitality of the all of the chapters who have allowed me to visit their locations. I have really enjoyed their company and I appreciate their allowing me to present and answer questions about the business of the Florida Society.

### FLSSAR STATE OFFICER'S REPORT Senior Vice President

William Stevenson

At the Summer BOM, the SVP Committee discussed: 1. CAAH Program; 2. Membership; 3. VP Award; 4. Youth Programs

1. CAAH (now "The Center": The committee took up the proposal Pres Toops made at the Executive Committee Meeting. His view (the second phase of fund raising) was that the whole Society must show support for "The Center" so it can proceed. Pres. Toops proposed that each Chapter donate \$25 and each FLSSAR member donate \$5 toward "The Center" project. A reporting sheet has been proposed to record donations. At the September NSSAR Leadership Meeting, Pres. Toops and I learned some other most welcome news regarding the subject. NSSAR reported it had received the bequest from the Drinkard estate -\$1 million which made available funds for construction in the Fulton-Conway Bui1ing at \$2.1 million. Unfortunately, inflation has had its way with the estimated sum needed to complete the remodeling. It is now estimated at \$8 million, some \$2 million more than the original \$6 million estimated. Additional expenses are: property taxes \$7,000; Gen. Ins. \$8,240; Flood Ins. \$2,312; and Liability Ins. \$751. NSSAR also believes it may at some future date sell \$300 Thousand tax credit.

With the money on hand, NSSAR has hired an Architectural Firm and have obtained preliminary floor plandrawings of "The Center" layout. They were on display. Pres. Toops talked of obtaining copies for display here in FLSSAR.

Once the Second Phase of Fund Raising has been completed, which in FLSSAR the proposal was updated to 30% of membership (based on a 7% membership growth) rather than \$5 from each member, NSSAR will begin its "Capital Campaign" In that NSSAR will approach the major Foundations, etc., soliciting donations.

2. Membership: Sources -family members in both SAR and DAR in additional to "outside" sources. NSSAR has a prize for the DAR Chapter which has the largest of its recommendations approved as SAR members. My over-realistic goal is to reach 2000 members in the next two years. We reached that figure in 1996 in our centennial year, but also lost over 400 by the end of the year. After discussing it with Pres. Toops, he proposed a more realistic goal, to which I agree. The more realistic goal is based on four years. That figure is a yearly growth of 7 percent. To reach that goal, each chapter must eliminate loses by NPD (non payment of dues). While that can not be achieved completely, in cases of hardship, the chapter can carry the individual until the crises passes, thereby reducing NPD losses. Finally, each member is encouraged to recruit one member each year. If each member did, FLSSAR membership would double in just one year -that would be nearly 3,000 members. Lets hope.

3. VP Award: At the Summer BOM meeting the members of the SVP Committee approved the following motion: "Starting the 2009 calendar year, one chapter in each of the three chapter-size categories that produces the greatest increase in new chapter membership based primarily on the information reported on Item 16 of the Chapter Challenge will be honored at the Annual Meeting each year. The honor will take the form of a chapter prize (to be determined) and one representative from each of the three Chapter groups will be invited to attend the awards Banquet, dinner and registration fee expenses paid, where they will be introduced and asked to give a brief explanation as to how their chapter went about recruiting new members. They will also be asked to meet with the RVPs for the same purpose. In the event there was a tie in any of the three Chapter categories, other criteria than "greatest increase" would be used.

4. Youth Programs: I explained that the youth programs -NJROTC, Essay Contest, Oration Contest, and Eagle Scout Scholarship Contest -should also be promoted, especially the funding of same. Eagle Scout Scholarship program is in best financial position since it was originally established by a large donation, but the others need much help as they were not so funded. Ways to raise funds need to be found. I suggest a one way is to place a jar labeled for one of the programs, be at every Chapter meeting, to collect donations for that project. Jars could be rotated at meetings.

## FLSSAR STATE OFFICER'S REPORT

### Secretary

The quarter was busy in a number of ways. The work was routine for this time of the year but of greater volume than in previous years.

The annual reports and 2009 dues will be compiled and submitted soon. Chapter secretaries will receive the current roster from the state database and instructions for submitting their annual reports in early November. The reports are due around December 10<sup>th</sup>. Chapter Presidents are encouraged to verify that the report is filed in a timely manner.

With regard to the annual report two items need approval from the BOM.

- 1. Motion: State dues for 2009 be forgiven for any member that is an active member of the military. This action has been adopted by the BOM for the past 2 years. This motion would continue this practice. Six members qualified for this exemption in 2008.
- 2. Motion: Chapters submitting required 2009 membership reports and dues to the FLSSAR Secretary in a timely manner will be eligible to receive a rebate in the amount of \$2 per qualifying paid-up member. This would continue a long standing practice of the Florida Society. Note that I am proposing a decrease of \$1. Last year rebates totaled \$3,858. A change of \$1 would add roughly \$1,200 to the state budget. Several new initiatives including the Battle of Pensacola commemoration will tax the current state budget. Reducing the rebate would alleviate some of this pressure.

At this meeting I am submitting four changes to the FLSSAR By-Laws. Each of these is relatively minor. Cumulatively they are an attempt to have the By-Laws conform to our current practices. Copies of these changes are available from the secretary if requested.

I'm also looking to improve the production of this BOM report booklet. Currently we are expending a significant amount of resources producing 80-100 copies of a nearly 50 page document. I'm proposing that on the Sunday prior to the meeting the secretary email the reports to all chapter and state officers, all BOM members, and any other member that wishes to receive the reports. The secretary would also run 20-25 paper copies to be available for those BOM attendees without email access. Members receiving the report via email would have the time to read and review all the reports and could, at their preference, print a copy for their use.

There are 3 significant advances:

- 1. We'd save considerable resources
- 2. The reports would have a wider circulation resulting in increased communication
- 3. BOM attendees would have sufficient time to review the reports. Currently, unless the member devotes a block of time to reading the reports upon arrival at the hotel they are not fully prepared to participate in the meeting and any discussion. This secretary's report is a case in point. The discussion of the proposals in this report would most likely be more productive if members had time to read and consider the ideas prior to their arrival at the meeting. Further, chapter delegates could, as they see fit, seek the advice of their chapter as to voting for or against any proposals.

I would like to propose that this idea be tried for the Winter 2009 BOM.

### Dear Compatriots:

There has been quite a bit of confusion over the new NSSAR policy regarding DAR Record Copies. In several recent postings on SAR-Talk, Joe Dooley, our Genealogist General, has mentioned a supposedly "new" DAR verification procedure involving "a single large check mark down the middle of the page or on the margin." I am writing this message to clarify the issue and to provide examples of DAR Record Copies to substantiate my points.

1) The issue is not about a "single large check mark." As I pointed out in my original posting on this new NSSAR policy, DAR uses three different methods to indicate verification of information on a DAR Record Copy.

"Center checks" indicate that the information was taken from a previously verified NSDAR application.

"Individual checks" indicate that new information has been proven with documentation. Brackets or parentheses indicate that the information has not been proven.

When "center checks" are used, each name, date, and place verified from a previous DAR application is checked above or next to the words "born," "on," and "married."

When "individual checks" are used, each name, date, and place verified from new documentation is checked above the name, date, and place.

When a name, date, or place has not been verified using either new documentation or a previous DAR application, the name, date, or place is enclosed in brackets or parentheses.

2) This DAR verification is NOT new. DAR has been using this procedure since at least 1995.

Thus, this new NSSAR policy is NOT about a "new" DAR verification procedure. Rather, this NSSAR policy is about no longer allowing DAR Record Copies that were verified from previously accepted DAR applications. The following examples of DAR Record Copies illustrate this point.

The first example (#853XXX) is a 2007 DAR Record Copy. For generation 1 (the applicant), the DAR used "individual checks" to show that the information was verified through documentation. (The applicant submitted her birth certificate, marriage certificate, etc.) For generations 2 through 8, the DAR used "center checks" to show that the information was verified from a previous DAR application. The staff genealogist also wrote the number of the previous application that he/she used in the verification process (# 852291) in the empty space between each generation. Example #853XXX is the DAR Record Copy of the DAUGHTER of a Florida SAR prospective member. It was

PENDED just a few days after the Fall Leadership Meeting as a result of this new NSSAR policy.

Example #769XXX is a DAR Record Copy from 1995. Generations 1 through 5 contain "individual checks" indicating that the information was verified through new documentation. Generations 6 through 8 contain "center checks" indicating that the information was verified from a previous DAR application (#765809).

Example #797XXX is a DAR Record Copy from 2000. "Individual checks" are used in generations 1 through 4. "Center checks" are used in generations 5 through 8 (# 499413 A468 & # 714184).

According to what I read on SAR-Talk, this new policy/interpretation, as it relates to the acceptability of NSDAR Record Copies, was adopted by the Genealogy Committee at the last NSSAR Leadership Conference. As a member of that committee, I received NO communication from anyone that this issue was going to be discussed, let alone voted on. I have requested the minutes of the said meeting where this issue was supposedly discussed and voted on, and have not yet received the requested minutes or any acknowledgement of my request for said minutes. My personal belief is that this new rule/interpretation was adopted without sufficient explanation, discussion, or voting by the Genealogy Committee.

I will be discussing this issue at the upcoming FLSSAR BOM. I would encourage all of you to express your thoughts about this new rule/interpretation directly to Joe Dooley, Genealogist General or Richard Fetzer, Chairman on the NSSAR Genealogy Committee. Their contact information is as follows:

# FLSSAR Committee Report DAR Liaison

The DAR Fall Forum was attended by committee members George Lockhart and Steve Williams and was assisted by John Camillo of the Withlacoochee Chapter. The coverage was for Saturday from 8 am to 4:15 pm for the purpose of passing out SAR informational material and to encourage DAR members to participate in membership referrals. At this forum a display was used to present the current standing of the Florida DAR Society's standing in the competition for the \$500 prize (Referral program) with the intention of generating a sense of competition within the DAR community with other states, most notably Georgia, and to act as a springboard for the recruiting of SAR applications.

Some information pertaining to the weekend:

1.39 of the 106 Florida DAR chapters (37%) visited our table.

2.79 DAR ladies signed the guest sheet ~ 26% of Forum attendees.

3. 21 of these stated they had male prospects and took the SAR Worksheet and DAR Referral Form to support those male prospect applications.

Observations and Recommendations

Observations:

1. While most of the Forum attendees passed by the SAR table, only ~26% could be induced to approach and/or sign the guest log.

2. The DAR Referral status board mentioned above did generate interest in the \$500 prize and offered an opening into handing out worksheets/DAR Referral forms.

3. The participation of 7 SAR compatriots in the Color Guard at the Saturday Banquet created positive goodwill and publicity in the Florida DAR community as judged by the large number of personal comments I received.

4. Outside of the stated purpose for the SAR table, our presence affords the compatriots an opportunity to socialize and establish contacts and friendships with individual DAR ladies and, by extension, their chapters.

Recommendations

1. Some form of expanded 'Outreach' should be considered to increase the percentage of coverage of SAR information to the number of DAR chapters and Forum attendees. This might include, but not be limited to, a Forum workshop session centered around SAR/DAR liaison, activity participation, and cooperation in like interests. These interests include youth activities, education, and other patriotic events/activities.

This Outreach could also include providing a information packageto each Forum attendee. The package might include:

DAR Referral form SAR Worksheet SAR Application requirements brochure

Brochures for SAR Youth activities, e.g., Rumbaugh, Knight, Eagle Scout.

Ticket for surprise gift drawing\*

\* The 'surprise gift' would be something of nominal value and the ticket would have be turned into the SAR table - thus, the DAR attendee would have to stop by our table and would, thereby, increase our exposure.

2. Continue to use a means of visibly showing status of DAR referrals and the progress towards the FSSDAR 'winning' the \$500.

3. Continue to offer our Color Guard to the FSSDAR at their Spring and Fall Forums. This would be a recognized state Color Guard event and could be used to receive the Bronze Color Guard medal.

4. As a further attractant, a second table might be used for the placement of interesting memorabilia and artifacts, e.g., a musket and bayonet, cartridge container, wooden 'canteen', quill & ink pot, wax and stamp seal, pewter mugs & flatware, replica coinage. Other items of historical or educational interest might be included - anything to draw visitors to the tables.

The Camporee adventures of Phil Wright and Steve Stevenson, Brevard Chapter, have received fairly widespread acknowledgement. I think they are worth repeating here (with the Author's permission). There are a number of good ideas presented. Most Boy Scout Councils/Districts have two Camporees a year.

"Compatriot Phil Wright and myself (Steve Stevenson) participated in the Central Florida Boy Scout Camporee at Camp La-No-Che in Paisley on September 27<sup>th</sup>. We set up a display table with handouts of Declaration of Independence & US Constitution provided by the Heritage Foundation, Eagle Scout Scholarship information, and flyers for the Last Naval Battle of the American Revolution. We also were dressed in our period costumes with 2 muskets and other display materials.

During the time period from 9 a.m. to 3 p.m. we interacted with between 400 and 500 scouts and 50 to 75 scouting leaders. We discussed the muskets and materials – the muskets and Phil's routine explaining the loading/firing steps were a big hit and attracted the most interest of the younger scouts (and most adults, too). The Eagle Scout Scholarship program was explained to all Life and Eagle scouts present with our (business) cards handed out to many for further contact.

Several adult leaders expressed interest in the application process for both the SAR and DAR and were also given cards for follow-up information.

## FLSSAR Committee Report Joseph P. Rumbaugh Orations Contest

The following information has been sent out to all local chapter presidents regarding the FLSSAR Rumbaugh Contest to be held at the Winter BOM Meeting.

The Rumbaugh Oration Contest: Some Questions & Answers

1. What is an oration?

An oration is a carefully prepared formal speech written in advance (and given to the contest judges in advance), committed to memory, and delivered word for word without notes. In this case, a speech of at least five minutes in length but not more than six.

#### 2. What topics can the oration be about?

Oration topics should be about a Revolutionary War event (e.g.: The Battle of King's Mountain or the Boston Tea Party), a document (e.g.: Declaration of Independence or the Bill of Rights), or a personality (e.g.: Benjamin Franklin or Sir William Howe), showing the relationship it bears to America today. For example, the 2005 winning oration was about the separation of church and state as provided in the Bill of Rights and its implications for religious activities in schools and other public places.

#### 3. Who can participate in the Rumbaugh Oration Contest?

Any high school student, public, private, or home-schooled, in grades 9-12 at the time of the contest.

#### 4. When and where is the contest?

The state (FLSSAR)competition will be held at the winter Board of Management meeting on January 30, 2009. Therefore, local chapter level competitions should be held before that time. Probably most local chapters hold their contest in the November-December time frame. The national (NSSAR) competition will be held at the 119th Annual NSSAR Congress in Marietta, Georgia, on July 4-8. All state organizations will send at state expense one winner and a companion (e.g.: parent, coach) to the national contest. The last Florida winner was in 1997.

#### 5. What are the prizes for the contest?

a. Local chapter level prizes will be determined by each local chapter. Many local chapters provide a first prize of \$50, a second prize of \$25, and a third prize of \$15, since they may be reimbursed by the ETF for those amounts. The local chapter will also need to make reservations and provide for transportation and expenses (hotel room, dinner) for the winner and a companion( parent, coach) to the Winter Board of Management meeting. Such expenses may be reimbursable. The contest usually takes place in the late morning or early afternoon of the first meeting day and the results announced at the Friday evening banquet.

b. State level (FLSSAR) prizes are as follows:

First Place: \$1000. Second Place: \$500. Third Place: \$250 All Others: \$100

- c. National level prizes are: First Place: \$3000. Second Place: \$2000. Third Place: \$1000. All other finalists: \$300. All other contestants: \$200.
- 6. How will the competition be judged?

At the state level the three judges, who must be given a copy of the oration in advance, will use the following criteria:

- a. Composition (organization, vocabulary, logic) 20 points
- b. Delivery (voice, body movement, gestures) 40 points
- c. History (research, accuracy, American Revolution based) 20 points
- d. Significance (relation to current issues) 20 points

In addition, penalty points will be deducted for orations violating the at least 5 minutes but not more than 6 minutes time limits for delivery, and for deviations from the copy of the oration given to the judges.

7. How can the local chapter recruit students to enter the contest?

Designate at least one person in the chapter to contact local public and private schools as well as home-schooled students. Who to contact will vary locally, of course, but many public school systems have English or Language Arts Coordinators or Supervisors who are in charge of providing curriculum materials and textbook adoptions. These professionals are in an excellent position to advise you as to how to proceed or who to contact.

Otherwise, the next best course would be to contact the Superintendent's office and/or building Principals for guidance as to what English teachers to contact. The Superintendent's office should also be able to provide the names of students being home schooled.

Additionally, it's good to keep in mind that most senior high schools are divided into departments and the Chair of the English Department may turn out to be the most helpful person of all. Often one or two English teachers will be most interested in speech and/or debate and may even supervise extra-curricular activities such as a Debate Club.

8. How does the local chapter enter its winner in the FLSSAR contest?

First, go to the NSSAR website (<u>www.sar.org</u>), click on Rumbaugh Oration under Education/Youth at the top, and print out: (1) Procedures, (2) Contest Rules, (3) Chapter Entry Form, (4) Judging Sheet, (5) State and National Entry Forms, A&B. Send in the Chapter Entry Form and State and National Entry Forms (Forms A&B) along with a picture of the orator and 4 copies of the oration to: Dr. Gordon Greenwood, 4117 NW 33rd Place, Gainesville, FL 32606, by not later than January 12, 2009.

FLSSAR recognition awards for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place will be presented at the 2009 Spring/Annual Meeting, based on newsletters received by December 31, 2008.

Information about the national Newsletter and Periodicals Committee, including Guidelines for Judging, and the various awards in different categories, appear on the website at <u>www.sar.org</u>. A synopsis of the guidelines are: 1. To be eligible for competition, there should be a minimum of two issues per year submitted to the national committee chairman by December 15, 2008. However, editors are encouraged to place the committee chairman on their normal distribution list.

2. Judging will include editorial content (writing, style, content, punctuation, spelling, typo's, appropriateness of content, helpfulness to readers, general interest of articles, clarity of production and overall quality) and appearance (general layout, use of photographs, use of art/graphics and verall appearance). The address to submit state and chapter newsletters is:

- 3. The minimum number of pages should be four pages each issue or twelve pages total per year.
- 4. The method of printing, whether Xerox, print, or mimeograph, is not to be of primary concern.
- 5. Quality of production will be judged looking at mistakes and errors.
- 6. Is there an identifiable masthead with the state or chapter name and SAR logo prominent?
- 7. Are the officers' or editor's name given or a contact number/address?
- 8. Has color been used?
- 9. Do pictures make up part of the coverage?

10. Does the content include: state activities, calendar of events, a welcoming of new members, deceased members remembered, special observances announced and reported, chapter events given coverage in state newsletters, special stories, national SAR events?

11. Cost of production should not be the major factor in determining the "best all-round newsletter. It is true with more money to spend, the quality of the print, pictures, and design will be high, but content, but making do with available resources should be considered.

The national award that will be of interest to most FLSSAR chapters will be the Carl F. Bessent Award. This award has two categories: single sheet, up to 8 ½ by 11 inches, with print on both sides; and multiple sheet, 8 ½ by 11 inches, with print on both sides. The award is presented to chapter editors for best multiple and single sheet periodicals. A certificate is presented during the annual congress to both first place and honorable mentions in each category.

Chapters should pay particular attention to SAR's Newsletter and Periodicals Handbook. There newsletter workshops at BOM meetings from time to time, and we hope to benefit from the national workshop that the Florida Patriot editor attended at the last national congress.

### FLSSAR Committee Report Patriotic Activities

Since my last Committee report of August 5, 2008, through the date of this report (about 2<sup>1</sup>/<sub>2</sub> months), currently 164 (average) e-mails <u>at a time</u> were sent out on 27 occasions, a total of about 4428 e-mails. Therefore, during the first six months of the 2008-2009 program year which began on May 4, 2008, my report of April 20, 2008 through the date of this report, October 24, 2008, (about six months), reveals that 164 emails at a time were sent out on 79 occasions to 164 recipients resulting in about 12956 e-mails.

If we do as well in the last six months of this program year, our mailings could almost double last vear's results when emails were sent out on 82 occasions to 168 (average) recipients at a time resulting in about 13812 emails. My thanks go out to the members of this committee, all SAR's, friends, and recipients who have sent me great patriotic material to work with and forward on. Please keep it coming.

SINCE NO ADDITIONAL CHAPTERS HAVE MADE A FLAG AWARD PRESENTATION SINCE OUR LAST REPORT, WE RESPECTFULLY MAKE ANOTHER APPEAL THAT THEY DO SO. THERE ARE ONLY TWO MONTHS REMAINING, NOVEMBER & DECEMBER, DURING THIS 2008 CALENDAR YEAR. PLEASE NOTE BELOW THE 7 CHAPTERS THAT HAVE REPORTED TO DATE. WE ARE 9 CHAPTERS SHORT OF THE 16 NECESSARY. As you know, our Committee Charter includes as one of its functions the administration of the Flag Program for the Florida Society. This includes competition for the NSSAR Rear Admiral William R. Furlong Award to the State Society with the best Flag Program. It awards and presents the NSSAR Flag Certificate to individuals and activities in the name of the FLSSAR, encourages FLSSAR chapters to participate in Flag Day, June 14, ceremonies, and promotes respect and honor to the Flag of the United States. In order for our State Society to earn the Admiral Furlong Ribbon Award from the NSSAR Flag Committee, at least 50% of its chapters (16 chapters) must present at least one or more Flag Certificates during the calendar year. ## FLSSAR Committee Report NSSAR Constitution & ByLaws Review

Chairman: Frank Hodalski 29 October 2008

**<u>Report and Recommendations</u>**: Contrary to previous information indicating that the project to rewrite the NSSAR bylaws would be discontinued, the committee meetings scheduled for the Fall meeting included a meeting of PPG Horne's sub-committee. The Florida Society attendees included our national trustee, and outnumbered the committee members present for the meeting.

PPG Horne reviewed a previous presentation of rewritten bylaws outlining the duties of the general officers. In general, they added language to flesh out the rather sparse descriptions that are currently in the bylaws. We were informed that PPG Horne collaborated with Bylaw Committee member Charles Britton in improving the proposed language. In general, they are not contentious, the one exception being the office of Inspector General. In brief, the IG's areas of responsibility would include:

- Providing leadership in self governance and compliance with governmental regulations, NSSAR bylaws, and internal controls at all levels of the organization.
- Responsibility for compliance with NSSAR code of conduct, and Human Resources practices and procedures.
- Ensure that financial controls are in compliance with highest possible standards
- Oversee audits of NSSAR and the SAR Foundation through utilization of outside independent auditor.
- Oversee an annual audit of NSSAR finances by the Independent Audit Committee.
- Have access to legal counsel, as necessary.
- Report to the Board of Trustees and the Congress
- Serve as a member of the Executive Committee and deliver findings and reports, copies of which will be archived for future reference.

This office was created by appointment of the President General shortly after the Sacramento Congress. The IG is currently serving, and delivered reports to the Executive Committee at the fall meeting in Louisville. There are serious parliamentary questions as to the validity of the appointment.

The Florida Society must develop a basic position on the issue of the bylaw revision itself, which FPG Horne now admits far exceeds the original housekeeping and grammatical charge given the committee. In the future, issues that will be contentious will be introduced. These involve the committee structure and responsibility, and include the executive, finance, investment, nominating, ethics, and foundation committees. Substantive changes will be introduced, contrary to the limitations placed on the original charge to the committee. Some possible courses of action:

- Advise PG and Sec. General of Florida Society position
- Inform PPG Horne and committee members of FLSSAR position
- Advise other state societies of issues
- Develop legislative strategy including position statements and appropriate motions
- Assign speakers and topics
- Write "white papers" on issues and how passage would affect NSSAR for handouts

This ad hoc committee has committed to working on a number of issues related to the society's website, Patriot magazine, historical and archival records, and other technology items. In the Summer we outlined several initiatives. At this meeting we wish to focus on the positions of webmaster and Patriot Editor.

As we indicated at the last BOM, we feel that the positions of webmaster and editor of the Patriot magazine are equal in importance and so should be treated equally in how these positions are filled. Currently the webmaster is appointed and the editor is elected. We are recommending that both be appointed positions.

We did not receive much feedback regarding this recommendation. All the responses agreed that both positions should be treated equally however not everyone agreed that the positions should both be appointed. Instead, some preferred that both should be elected.

While we still hold to our view that both be appointed, we thought it best to submit to the Charter and By-Laws committee two different, competing By-Law changes. In the first, the changes would make both positions appointed. The second proposal would make both elected. By doing this, the membership will have a chance to decide the best way to organize the society and fill these important positions.

One additional comment is needed. In our deliberations the committee specifically and intentionally, at the request of the chairman, did not discuss any of the issues under our consideration with respect to any individuals now holding or having held the offices of webmaster and editor. We did this so that our approach and decisions might reflect what we thought would be best for the society both now and into the future without regard to personalities. Our recommendation that the webmaster and editor positions be appointed should not be construed as an attempt to remove either of the gentlemen now in office from continuing to do so in the future.
