Mile Marker Two and all seems to be OK. The CAAH program during the summer has been in a holding position; too many chapters have been inactive. Now that summer is over expect it will pick up. At the Leadership Meeting in Louisville at the end of September I learned that of Florida's 1523 regular members, 174 had contributed. As of 31 March, Florida had contributed \$94,706. From 1 April to 23 June contributions totaled \$1,960 for a total of \$96,666 or an average of \$62 per member.

Membership – As of 6 September 2009, total Florida membership was 1,732 of which regular membership numbered 1,563. Since 1 January 2009, there has been inducted 116 new members, 80 reinstated, and 27 deaths.

Before the Summer BOM I visited two chapters and attended the Battle of Pensacola. Since the Summer BOM I have attended the Consitution Day Ceremonies (St. Lucie River Chapter/DAR's) in Palm City, the Fall Leadership Meeting in Louisville, KY, the Withlacooche Chapter (10 Oct), and the Lakeland chapter (17 Oct).

At the Leadership Meeting, the Blue Ribbon Committee submitted it's report. Simply put, it addressed the question "was the Genealogy Dept. complying with regulations and the Constitution (Art. III), the By-Laws (No. 9), as well as Form 0912 (original purpose of the committee?). The committee's decision was the Genealogy Dept. was complying, so the Blue Ribbon Committee recommended "no change in procedures."

In the Genealogy Committee meeting the members approved two motions. The first was to extend the "grandfathering clause" to the 2nd generation not only for SAR applications, but to DAR applications as well. The second motion that was approved was to "fast track" applications of sons and grandsons of both SAR and DAR members (fathers and mothers applications).

At the request of the last BOM, I put together a listing of deadlines and other important dates appropriate for local chapters. The feedback received was minimal but that which came in was positive.

We're gearing up for the collection of 2010 dues and the annual reports. To this end, the BOM will need to consider two motions voted upon annually.

- For the last few years the Florida Society has not charged dues for members who are on active military duty. Last year, 14 members met this criterion. This waiver of dues applies only to Florida dues. National dues still must be paid by either the member of their chapter. Chapter dues are at the discretion of the chapter. The BOM will need to decide if it would like to extend this program into 2010.
- 2. Each year the Florida Society rebates a portion of the state dues back to the chapter. This practice began in the late 1990's (1997 I believe). The rebate has in the past been \$3 per member paying Florida Society dues. In the current year the society is operating on a budget with a deficit and the first draft of the 2010 budget has a similar shortfall of funds. To help alleviate this situation, I propose that the rebate for 2010 be reduced. A \$1 reduction would generate between \$1,400 and \$1,500 for the work of the society. The Finance committee will speak to this matter.

Information regarding the annual report will be sent out during the second week of November.

Other work has been primarily routine however we took on a project to correct some of the omissions and errors in the online National database. As of this writing nearly all the missing state numbers have been entered and all the chapter designations have been corrected. There are limitations to working on the database and as a result no easy way to double check things. To this end, local chapter officers with access to the database are encouraged to send any corrections to the secretary. [Note: I am permitted to change only items found on the main page for each member. Corrections dealing with ancestors, membership chronology, and similar matters must be submitted to National.]

Recommended Application Submission Improvement Areas:

- Ensure all required signatures and dates are present as required for type of applications being submitted.
- Enclose 2 application copies on SAR watermarked archive paper and 1 application on plain paper for all applications submitted.
- Use a red pencil to underline applicable data on all proof documents and DO NOT USE any type of highlighter.
- Copy of entire legible original census page must be submitted when using a census as a proof document. Ancestry.com census transcription pages cannot be used in lieu of the original census page, but may be used in addition to the original page.
- Recommend using pager clips instead of staples.
- Never use nick names on an application unless there is a required proof document has been submitted that validates the nickname.
- Any name, date or location used in the application generation requires a document to prove that information. Do not enter names, dates or locations in this section a proof document has been provided that exactly matches that information.

Notes of Interest:

• The current SAR grandfather policy, as articulated in Bylaw No. 1, Section 5, and on SAR Form No. 0912, provides that male relatives of former or current SAR members within two degrees of kinship may be permitted to join the SAR, even if the former or current member's application is not sufficiently documented according to current SAR genealogy standards, provided that the lineage and/or patriotic service has not been questioned by either the SAR or the DAR. When such applications are accepted, the line is "grandfathered," and subsequent applicants will be required to document the lineage and/or patriotic service fully in accordance with current SAR genealogy standards. The policy accepted by the NSSAR Genealogy Committee on 25 September 2009, will extend this grandfather policy to DAR applications, so that male relatives of former or current DAR members within two degrees of kinship may be permitted to join the SAR, even if the DAR member's application is not sufficiently documented according to current SAR genealogy standards, provided that the lineage and/or patriotic service has not been questioned by

either the SAR or the DAR. Some compatriots are referring to this as the SAR's "grandmother" policy. This new policy will provide a resolution to many DAR application center check mark issues. The details of this new policy are still being developed, and will be posted on the SAR Genealogy webpage (http://www.sar.org/committee/genealogy/policies.html) as soon as possible.

- "Fast Tracking" of SAR applications which meet certain criteria was approved by the NSSAR Genealogy Committee on 25 September 2009. In general, SAR applications that are based in large part on recently-approved SAR applications may be processed more quickly than applications that are based on older applications, or that are based on a new lineage. Per the proposal, the Staff has been charged to devise the specific details of "fast tracking" procedures, and will report back to the Committee at its meeting in the Spring of 2010. As soon as specific details have been established they will be posted on the SAR Genealogy webpage (http://www.sar.org/committee/genealogy/policies.html) as soon as possible.
- Policy on Correspondence Pertaining to Pended Applications has been revised by the NSSAR Genealogy Committee on 25 September 2009. Previously, if an application was pended due to a minor deficiency, the Headquarters policy provided that the Staff could act on it as soon as the minor deficiency was corrected (such as a missing signature, or a single document). If the application was pended due to more than a minor deficiency, the additional material was placed in queue with other correspondence received on the same day. The current procedure has been changed to provide, if an applicant addresses all of the concerns raised by the Genealogy Staff within 60 days, his application may be re-reviewed by Staff upon receipt of the additional material. If the applicant does not respond within 60 days, his additional materials will be placed in queue with other correspondence received on the same day. This revised procedure will greatly reduce the lengthy processing delays many applicants have experienced previously.
- The NSSAR Genealogy Committee has formed a Sub-Committee to review the current SAR Genealogy policy pertaining to soldiers who appear to have deserted or gone AWOL.
- National Dues & Application Fees Increase: Effective dues year 2010, Regular Membership dues increase to \$30. Junior Membership dues increase to \$10. The collection of dues runs parallel or concurrent with the 2010 increase. (The collection period for this increase begins now for 2010) November 1 to December 31, 2009. New Member Applications received during this period must include \$30 for 2010 dues plus \$60 for the application fee. Junior Membership Applications received during this period must include \$10 for 2010 dues plus \$30 for the application fee. These new rates are currently available in PDF file form from the FLSSAR web site. On the home page look on the left for a link labeled "Documentation". Clicking on that link will bring up a menu where you'll see the "Applications Fees & Dues Schedule" link.

GENEALOGIST REPORT

Dear Compatriots:

In my previous reports, I have provided you with updates on the ongoing saga of the DAR center check issue, and will continue to do so as long as I am able. As I have stated before, I believe it is my duty as FLSSAR Genealogist to keep you informed of these types of matters.

As you are probably aware, PG Appleby formed a Blue Ribbon Panel at the Annual Congress in Atlanta to investigate the DAR center check issue. PG Nathan White was appointed as chairman and HG Lindsey Brock and others were appointed as members of this committee.

Even though I was one of the first to question GG Joe Dooley's ruling in September 2008 that prohibited the use of DAR record copies with center checks as proof for SAR applications and despite the numerous reports that I wrote on this topic and distributed to compatriots around the country, the Blue Ribbon Panel **never** officially asked me for any input on this issue; however, HG Lindsey Brock did ask me to forward information to him which he said he would pass on to Blue Ribbon Panel committee members. Instead, PG Butler personally removed me from all national committees on which I served, including the Genealogy Committee.

At the request of Panel Chair PG Nathan White, President-Elect Rick Hollis of the Tennessee Society did present an eight page report on his findings regarding this issue that contained almost one hundred pages of exhibits. I present the text of his report as Exhibit 1. If you are interested in his excellent exhibits, please let me know, and I will be more than pleased to send them to you in their entirety in electronic format.

The crux of Mr. Hollis' report discusses SAR Genealogical Policy GR040704-A ("The 1986 Rule") that states "The NSSAR will accept record copies of applications (dated 1986 or later) from the NSDAR, General Society of Mayflower Descendants, Society of the Cincinnati, Founders and Patriots of America, (and) The Society of Colonial Wars with respect to related sections of the SAR application that require proof of service and/or proof of the applicant's lineage". This policy appeared on the NSSAR Genealogy Committee Home Page for years and the heading on the top of the page where it appeared stated "Policy Approved by the 2004 Annual Congress." I presented a copy of this policy at the March 2009 Genealogy Committee Meeting in Louisville where it was disregarded by most of the compatriots in the room, who chose to uphold GG Dooley's September 2008 ruling that prohibited the use of DAR record copies with center checks as proof for SAR applications – even DAR record copies dated 1986 and after. I could not understand this clear violation of The 1986 Rule.

Not long after Mr. Hollis presented his comprehensive report on this topic to the Blue Ribbon Panel, PG Butler replaced PG White as chairman of the Blue Ribbon Panel and appointed PG Howard Horne as the new chairman. PG Horne dramatically reduced the scope of what the Blue Ribbon Panel was originally tasked to consider. I present as Exhibit 2 a series of e-mails between Mr. Hollis and PG Horne where Mr. Hollis flatly refuses to redo his report that was previously submitted to Chairman White who thanked him for his "comprehensive response" and stated that "This will be helpful to the committee." Unlike PG Horne, PG White did not limit the scope or length of what could be submitted to the Blue Ribbon Panel for its consideration. Even HG Lindsey Brock communicated with individuals in at least two state societies and encouraged them not to attend the Blue Ribbon Panel hearing, so as not to lend any credence or validity to it.

Similarly, in an e-mail dated September 15, 2009 that I have included as Exhibit 3, PG Butler also limited the scope of deliberations on this issue. He states "There shall be no discussion about how the matter came to be reviewed by the Genealogy Committee, or the fairness of the hearing. I am ruling in advance that the committee process and hearing were conducted fairly...There shall be no discussion about any NSSAR General Officer, staff member, or Committee Members, or how they conducted themselves in the performance of their duties." In the various reports that I did, one of the most important aspects of each related to how this new genealogical policy came to be and whether the Society's rules were followed. As you can see, PG Butler is not permitting this type of discussion and further states that "...there have already been calls for referral of some members conduct to the Ethics Committee." I would be most curious to know of which specific actions PG Butler is speaking that would justify such a referral to the Ethics Committee.

The 1986 Rule was adopted unanimously by the SAR Genealogy Committee on September 26, 2003 (Exhibit 4). Some of the Genealogy Committee members present and voting at this meeting where this policy was unanimously adopted included Edward Butler, Jessie Hagan, and William Marrs.

At the 2004 Annual Congress, The 1986 Rule that had been unanimously adopted by the Genealogy Committee was presented for ratification by the Annual Congress (Exhibit 5). The motion for the ratification of The 1986 Rule by the Annual Congress was tabled as there were concerns that The 1986 Rule was not broad enough (some wanted to include Sons of the Revolution record copies as acceptable proofs) and to avoid lengthy discussion. Since the Annual Congress did not ratify The 1986 Rule, the members of the Blue Ribbon Panel including PG Horne and HG Brock voted unanimously to leave in place the policy promulgated by GG Dooley that prohibits the use of DAR record copies with center check marks as proof of lineage and service for SAR applications.

Now, it is important to note the Annual Congress did not revoke The 1986 Rule; consideration was simply tabled to provide time to gather information related to SR record copies. This means that The 1986 Rule unanimously adopted by the Genealogy Committee in 2003 was SAR genealogical policy until changed by GG Dooley in September 2008.

This brings up another interesting point. How can it be that the SAR website stated for years that The 1986 Rule was approved by the 2004 Annual Congress when indeed it was not? Well, that is a topic for another discussion.

One thing that I learned this week was that the Blue Ribbon Panel did more than just reaffirm GG Dooley's ruling prohibiting the use of DAR record copies with center checks. PG Howard Horne and HG Lindsey Brock voted in the Blue Ribbon Panel meeting for the Panel to file an ethics complaint against Tennessee SAR President-elect Rick Hollis for something he said or wrote. I find it most curious that Mr. Hollis, who has been one of the most vocal advocates for revoking the policy promulgated by GG Dooley that prohibits the use of DAR center check record copies, is now facing an ethics complaint. I find it even more curious that HG Lindsey Brock would vote to bring such charges, when he was privately assuring compatriots that he agreed that the policy change promulgated by GG Dooley should be undone. As a matter of fact, HG Lindsey Brock spoke to me on more than one occasion about how highly he regarded Mr. Hollis and that I should get to know him! If anyone would like to know what Mr. Hollis looks like, he appears in a photo on the cover of The Florida Patriot, Fall 2009 issue. HG Lindsey Brock also appears in the same photo.

On Saturday, October 17, 2009, the Tennessee Society SAR Board of Governors unanimously approved the following proposed amendment to the NSSAR Bylaws, to be considered at the Annual Congress in Cleveland in June 2010. The proposal was sponsored by Tennessee State Registrar Richard T. Spencer, Jr. I highly encourage the Florida Society to support this amendment, as it resolves the genealogical issues that both the Executive Committee and Board of Management of the Florida Society asked me to resolve at the October 2008 Board of Management meeting.

By-law No. 1 – Membership Add the following at the end of Section 5:

The National Society of the Sons of the American Revolution affirms its respect for the policies and procedures of the National Society of the Daughters of the American Revolution (DAR) relating to approval of its membership applications. Accordingly, NSSAR will accept as proof of service and/or proof of lineage any DAR application

approved in 1986 or thereafter, except, (1) those involving lineage subsequently closed by DAR, (2) those on the DAR short form, and (3) DAR "legacy" applications.

The type of markings employed by DAR to signify verification of facts shall be immaterial to the acceptability of a cited DAR application, if the application bears (1) the dated signatures of the appropriate DAR officer or officers confirming approval of the application, and (2) the new DAR member's national number. Any SAR application pended or "grand fathered" pursuant to the change in genealogy policy promulgated on September 29, 2008, shall be unconditionally approved forthwith.

The resolution of the Genealogy Committee adopted September 25, 2009, regarding "grand mothering" of SAR applications is rescinded. Any application approved pursuant to that resolution shall forthwith be deemed unconditionally approved, and limitations on future use of so-called "grand mothered" applications shall be removed.

Compatriots,

When I posted a message on SAR-TALK on June 16, 2009 asking the question, "Am I the only one who is disgusted over the DAR center checkmark issue???" I was amazed at the response I received. Most people complied with my request to send responses privately. I quickly learned that I was not the only one who was concerned about the DAR center checkmark issue. Like many others, I attended the March 2009 Spring Leadership Genealogy Committee meeting and sat on the front row. I listened to the evidence presented by Compatriot Ted Duay and Genealogist General Joe Dooley, and left the meeting devoid of confidence that our policies were being administered properly.

Professionally, I manage non-profit associations, including a special emphasis on operational compliance with by-laws and policies established as guidelines for operations. Since March 2009, I have performed a very informal compliance review and based upon the information that is publicly posted and available, it is my finding that the Genealogist General did not honor a policy adopted by the 2004 Annual Congress when posting a policy change on SAR-TALK on September 29, 2008. [Exhibit A] Staff Genealogist Susan Acree confirmed the change with her email of February 18, 2009, that stated, "So, your recollection is accurate. October 2008 is probably very close to the date that we began pending SAR apps. based on centrally marked DAR applications." [Exhibit B]

Compatriots,

This past weekend, the Genealogy Committee met during the Leadership Conference, and several items were approved that I'd like to bring to your attention.

Spanish Patriots: [deleted - not germane]

Pended Applications: [deleted - not germane]

Approved DAR Applications:

The Genealogy Department and the Genealogy Committee also want to make compatriots aware of recent procedural changes in the DAR's use of verification marks. Whenever the DAR is reviewing a new application which refers to one of their previously approved applications, the DAR staff genealogist now places a single large check mark down the middle of the page or on the margin, rather than marking each genealogical fact as verified.

The SAR needs to verify specific facts, and the current DAR practice does not convey which facts are verifiable. If you cite an approved DAR application on a new or supplemental SAR application, be sure that the facts you need to prove on your application are verified on the DAR application, as evidenced by a discreet check mark after each genealogical fact. If the needed facts are not individually check-marked, please find another approved DAR application, or try to find the documents the DAR relied on to verify the genealogical facts in question.

Almost immediately, members of the Genealogy Committee began to respond to the Genealogist General and to SAR-TALK expressing their concern that the issue, indeed, was not discussed at the Genealogy Committee meeting, as suggested in his SAR-TALK posting September 29, 2008.

[EMPHASIS] When referring to a policy change that the Genealogist General posted on SARTALK, by definition, it is a revision of existing policy. The act of changing the old policy confirms that DAR center checkmarks were accepted until that time. The GG claimed that the change was due to "recent procedural changes in the DAR's use of verification marks." Yet, a letter from Terry D. Ward, Director of the Office of the Registrar General – Genealogy Division, [Exhibit C] states emphatically, "First, let us dispel the notion that this is a new practice on our part. Quite the contrary, it has been a part of our verification procedure for at least 15 years." She continues to say that DAR does not care whether SAR uses these applications or not – and that is true. It is not their concern whether we ever obtain members. This is not their job.

Moreover, DAR applications have the following information: Date "Application Verified;" Date "Accepted by the National Board; signature of the "Registrar General" and signature of the "Recording Secretary General." Some applications say, "Verified and Approved." How can SAR possibly claim that DAR applications are not verified when it is signed by the Registrar General and authenticated by the Recording Secretary General? We should exhibit professional courtesy.

POLICY DOCUMENTATION for GR040704-A

I reiterate that I believe that the implementation of policies established by the 2004 Annual Congress have been violated by the Genealogist General and other present or former General Officers who are complicit with his administration of policy.

GR040704-A states, "The NSSAR will accept record copies of applications (dated 1986 or later) from the:

- NSDAR
- General Society of Mayflower Descendants
- Society of the Cincinnati
- Founders and Patriots of America
- The Society of Colonial Wars

with respect to related sections of the SAR application that require proof of service and/or proof of the applicant's lineage."

I made a copy of this policy on June 7 and June 25, 2009 from the Internet. However, between June 25 and July 2, these policies were disconnected from the website. Interestingly, and it is worth noting, that on June 24, I received two requests for a copy of policy GR040704-A, identified on the Genealogy web page as having been "Approved by Congress July 2004." Peter Keltch requested a copy at 5:15 p.m. and a while later Larry Cornwell made the second request. My reply to Compatriot Keltch was visible at the bottom of Compatriot Cornwell's request, so it was obvious that they were communicating. Then, within a few days, sometime before I checked the website again on July 2, the polices were disconnected from the website.

More importantly, with whom did Compatriots Keltch and Cornwell share this information? Who, with authority to access our website, tried to sanitize the web page of these policy links?

Then, after giving a copy of the specific web address to Compatriot Bill Marrs on July 7, while at Congress, I returned home to find that these links have been replaced with a page that states, "The statements previously posted on this page were uploaded without authorization, and are currently being reviewed by the President General's Blue Ribbon Panel." [Exhibit D] However, how can this statement be correct when Genealogist General Judge Edward F. Butler, Sr. authorized the establishment of the web page and its contents? In an email dated January 3, 2006, found in the SAR-OFFICER-L Archives [Exhibit E-1], he announced his excitement for the new genealogy web page and asked officers to "pass this email on to all chapter registrars, genealogists, and those who might be working with a prospective new member. Of particular help should be the sections on Frequently asked Questions, Policies on Acceptable Documentation and Policies on Acceptable Patriotic Service." The URL given is identical to the ones cited that include GR040704-A, and that are submitted as evidence. GG Butler reminded officers about this again in a SAR-OFFICER-L posting dated March 10, 2006 [Exhibit E-2], as well as SAR-TALK-L Archives on January 3, 2006 [Exhibit E-3] and again on March 10, 2006 [Exhibit E-4].

In order to complete this report, requested by Blue Ribbon Panel Chair Nathan E. White, I have used a publicly available archive website, to examine our website on 14 separate dates ranging from February 10, 2006 until August 19, 2007, in addition to the four additional dates examined on June 7, June 25, July 2, and July 11, 2009. These dates are:

February 10, 2006; June 14, 2006; August 22, 2006; October 4, 2006; November 24, 2006; December 6, 2006; January 10, 2007; January 15, 2007; January 16, 2007; January 20, 2007; January 26, 2007; March 6, 2007; May 13, 2007; August 19, 2007.

The Internet Archive Wayback Machine index for the SAR Genealogy Committee's web page is included. [Exhibit F]. According to available information, Genealogist General Judge Edward F. Butler, Sr. and Ralph D. Nelson, Jr., VPG International [Exhibit G] created a genealogy website that began in June 2005, with the final product introduced in January 2006. [Exhibit E1].

Printed copies of each of these "Policies on Acceptable Documentation" and "Policies on Acceptable Patriotic Service" as well as "General Articles on Genealogy" are presented as Exhibit H (February 10, 2006), Exhibit I (August 22, 2006), Exhibit J (August 19, 2007). The policies begin in 2002 and continue until 2006, and are provided as evidence that these policies were posted on the website, unchanged, under the direction of Genealogist Generals Judge Edward F. Butler, Sr. (2004-06) and Dr. Charles F. Bragg (2006-08). The germane policy is GR040704-A, and copies of the policy from several dates in 2009 are included as Exhibit K to demonstrate that the policy was also publicly available during the administration of Genealogist General Joseph W. Dooley, 2008-10. A comparison of the pertinent policy in Exhibits H, I, J and K will illustrate that the policy was "Adopted at Congress July 2004" is unaltered in 2006, 2007, and 2009.

Because links to SAR Genealogy web pages are being disconnected with such frequency, it should be noted that we have printed hard copies of the relevant pages and the contents of their links, and have also saved the archived pages to hardware for safekeeping.

The policy GR040704-A is clearly stated and was not amended by a subsequent Annual Congress. Congress is the superceding authority in our organization and neither its by-laws nor policies (approved by Congress) can be amended without the vote of another Congress. Committee member Ted Duay first presented this to the Genealogy Committee in March 2009.

Additionally, the mindset of acceptability of all DAR applications, including center check marked applications can be established by a document published and copyrighted by Judge Butler in 2004, and posted to the website. Posted under "General Articles on Genealogy" it is entitled, "Evidence, Proof and Burden of Proof in Genealogy: a Judicial Perspective, by Judge Edward F. Butler, St., Genealogist General 2004-6." [Exhibit L] To describe the handling of "Old DAR Applications, Judge Butler states on page 8, "Applications with one set of tick marks, usually down the middle of the page, will be presumed to have been completely verified, and no further information about that information will be required." In other words, center marked DAR record copies are acceptable. He used the same language in the next paragraph to describe "Old SAR Applications."

At Congress, people pulled me aside to discuss their recollections of the 2004 Congress. Some remember that this is when the 20-year rule was abandoned in favor of a date certain, for accepting DAR applications. GR040704-A includes the language parenthetically, "(dated 1986 or later)." This assessment seems to be confirmed by a February 17, 2009 email from Staff Genealogist Susan Acree who stated, "The '20 year' statement was removed about 3 or 4 years ago, as the time-line for the 20 years is, basically, a moving target." Her memory approximates 2004. [Exhibit M]

My conclusion - GR040704-A is valid.

THE QUESTION

By what authority does a Genealogist General change policy adopted by an Annual Congress?

To examine this question, I consulted the Constitution and By-laws for SAR, the Handbook, and an interesting document posted on the web page entitled, "<u>Duties of the Genealogist General</u>," by Judge Edward F. Butler, Sr., Genealogist General 2004-6 [Exhibit N]. Neither in the Constitution and By-laws, the Handbook, nor even in Judge Butler's chronicle of duties did I find a claim that the Genealogist General can make policy. It states, as follows:

Duties of the NSSAR Genealogist General by Judge Edward F. Butler, Sr., Genealogist General, 2004-2006

The duties of the NSSAR Genealogist General are not spelled out in the Constitution or By-Laws of the society. The following duties should be assumed by anyone elected to that office:

- Define existing problems in the NSSAR application process, and communicate those problems to the NSSAR Genealogy Committee for action. Report the actions of the NSSAR Genealogy Committee to the Executive Committee.
- Make recommendations to the NSSAR Genealogy Committee, Executive Committee, and the Trustees about proposed changes in policy regarding the application process, including the use of various types of evidence and the degree of proof required.
- 3. Act as liaison with any state society that is seeking to amend the NSSAR By-Laws relating to the application process.
- 4. Propose policy relating to membership requirements.
- Serve as an ex-officio member of the NSSAR Genealogy Committee and the NSSAR Lineage Workshop Committee.
- Participate with the chairman of the above committees in setting the agenda for meetings, and work toward the established goals of each committee.
- 7. Rule on ambiguities and conflicts in the NSSAR application process or policy affecting the acceptability of evidence, or the weight and credibility of evidence submitted in SAR applications. Then report to the NSSAR Genealogy Committee on those rulings. If the committee agrees with the rulings, the committee should adopt same. If the committee does not agree in full, the committee should issue a written statement of policy, otherwise the Rulings of the Genealogist General shall become final. If dissatisfied with the ruling of the committee, the Genealogist General may submit a proposed policy interpretation change to the trustees.
- 8. Maintain a binder containing at a minimum the stated policies of the NSSAR regarding the application process; copies of all Rulings of the Genealogist General; Minutes of the meetings of the Genealogy Committee and the Lineage Workshop Committee, and copies of all publications of both committees; and copies of all Rulings of the

- Chancellor General relating to the NSSAR application process or the duties of the Genealogist General. A copy of this binder shall be maintained by the membership department at headquarters.
- At the pleasure of the current President General, serve as a non-voting member of the NSSAR executive committee, and serve as official liaison with the NSSAR Genealogy Committee and Lineage Workshop Committee.
- 10. Promote Genealogical Research and Writing in the NSSAR, including the submission of timely articles for publication to both The SAR Magazine and the Headquarters Dispatch, as well as state society newsletters and national genealogical magazines.
- 11. Promote and/or supervise genealogical seminars and lineage workshops at the NSSAR Annual Congress and in conjunction with meetings of the various state societies and/or district meetings.
- 12. Maintain an e-mail list of SAR state Registrars and Genealogists, and periodically communicate with them about problem areas and/or changes in the application process with suggestions as how they might improve the quality of applications submitted by them. Inform them about new developments in the NSSAR application process and about genealogical information which might be beneficial or interesting to them. It is important to give them feedback.
- 13. Communicate to the membership periodically about the status of applications and current events in the field of genealogy that might be of interest to the members. SAR-Talk and the SAR Officers and Chairman's e-mail list should be utilized for this communication together with the e-mail list of SAR state Registrars and Genealogists.
- 14. Prepare and submit written reports for each of the two annual meeting of the Trustees and for the Annual Congress.
- 15. Attend the two annual meeting of the Trustees and for the Annual Congress, including the meetings of the NSSAR Executive Committee at each.
- 16. Respond to queries of the NSSAR membership staff and Executive Director and provide guidance to them.
- 17. Review problem applications and those submitted to the President General in the appeal process, either approving same or pending them for additional proof.
- 18. Respond to individual queries of the various state Registrars and Genealogists.
- 19. Keep abreast of the latest developments in the field of genealogy and genealogy software. This can be accomplished by reviewing online genealogy sites and by subscribing to publications such as Heritage Quest, Family Tree, Genealogy Bulletin and the Magazine of the National Genealogical Society.

Furthermore, as found in the Handbook (2008), the Constitution and By-laws defines the duties of the Genealogist General [Exhibit O] as follows:

Bylaw No. 9 - Genealogist General

The Genealogist General shall examine all applications for membership and approve the applications of those found to be eligible, which eligibility shall be based on the policies, criteria and procedures as set forth by the Genealogy Committee and in accordance with this Constitution and Bylaws. Any appeal from his decision, which shall be submitted to him, shall be examined and he shall report his decision, with supporting evidence, to the President General within thirty days of such appeal. The President General, in making his decision, may seek the advice of the Genealogy Committee, such advice to be rendered within 30 days.

Nowhere do I find that the Genealogist General, Genealogy Committee, Trustees, or Executive Committee can make policy that preempts the vote of an Annual Congress.

Compatriots, I am neither now nor at any time seeking the removal of anyone from office. That has never been an objective throughout this process. However, evidence suggests that certain national officers have been careless in administering their fiduciary responsibilities of maintaining internal controls over the integrity of the Society's policies and procedures on genealogical matters, including care and control of how these policies are presented and interpreted on the SAR website. Specifically, the Genealogist General, whose duty it is to know and abide by the genealogical policies of the organization, based upon the evidence, failed to do so.

I do believe that our rules are our foundation and that when you start destabilizing the foundation, you put our entire organizational structure at risk.

Many applicants have filed their application in good faith and in accordance with rules that have been in use for many years. Fairness dictates that applications pended or grandfathered because of the use of a center checkmark should be approved without qualification immediately and their membership certificates issued at once.

NSSAR Genealogy Committee Minutes September 26, 2003

The Chairman Marston Watson opened the meeting at 9:00 a.m. The Committee members present were: Compatriots Rod Hildreth, Vice-Chairman, Richard Anderson, Larry Bradley, Charles Bragg, Edward Butler, Robert French, Jessie Hagan, William Lees, Stephen Leishman, William Marrs, Gene Patterson, Richard Steele and Billy Wallis. Chairman Emeritus Richard Locke, Genealogist General William Neal and staff members Susan Acree and Betty Graham were also present. The Committee members excused were Fisher Craft, Billy Lyle and John Shugrue. Also attending the meeting were Presidents General Raymond Musgrave and Larry McClanahan, Chancellor General David Appleby and Compatriots Miles Dechant, Stanley Henderson, Will Carr, Jack Moore, Daniel McMurray, Joseph Thomas, Gerald Burkland and Gerald McCoy.

Motion: Vice Chairman Hildreth moved, seconded by Ed Butler, that: Richard Steele shall be elected as Secretary of the Committee. The motion passed unanimously.

President General Raymond Musgrave made some remarks pertinent to Genealogy Committee's mission and the need to have our organization become more user friendly. He recommended the need to accelerate membership application approvals, in addition to encourage and promote father and son memberships. He urged the Society to maintain a positive and constructive attitude in assisting applicants in obtaining application approval.

Vice Chairman Rod Hildreth indicated that the NSSAR needs to (1) implement a user-friendly process for application approvals, (2) implement programs to increase membership and (3) implement a positive and constructive attitude toward future membership.

Chairman Watson introduced a need for the creation of a NSSAR National Registry of Genealogists and Researchers among the state societies who are willing to assist, upon request, in an occasional search of a vital record or other source on behalf of a member society.

Motion: Compatriot Butler moved, seconded by Compatriot Leishman, that: The Genealogy Committee recommends the creation and implementation of a National Registry of Genealogists and Researchers program. The motion carried unanimously, with the sub-committee being formed with Compatriots Butler, Marrs and Hagan as members and chaired by Compatriot Butler.

Chairman Watson proposed that the Genealogy Committee charge be revised for better clarification of its duties and responsibilities.

Motion: Vice Chairman Hildreth moved, seconded by Compatriot Marrs, that the following charge be adopted: The Genealogy Committee shall establish policies and procedures regarding the conditions under which new member and supplemental applications are accepted, to ensure that there is reasonable evidence which eligible applicants or members must provide; recommends methods of search for an applicant to follow where proof is missing on any essential fact; reviews all pending new member applications over six months old or any pending applications not accepted by the Genealogist General that has been appealed to the President General, and recommends a course of action for each application reviewed; and conducts a workshop on genealogical sources and procedures at the Annual Congress. The motion passed unanimously.

Chairman Watson asked the Committee for a restatement of the existing policy to accept record copies of applications from the following four lineage societies.

Motion: Compatriot Hildreth, seconded by Compatriot Steele, that: The NSSAR will accept record copies of applications (dated 1986 or later) from the NSDAR, General Society of Mayflower Descendants, Society of the Cincinnati, Founders and Patriots of America and The Society of Colonial

Wars, with respect to related sections of the SAR application that require proof of service and/or proof of the applicant's lineage. The motion carried unanimously.

[It is important to note that the NSDAR regards a "record copy" of its application as one which has the words RECORD COPY on it, regardless of whether or not all of the events on the application have a check mark or every signature from the NSDAR general officers appears on the record copy.]

Compatriot Watson raised the issue of how the use of vital records found on the Internet could be accepted as proof for birth, marriage and death events on NSSAR applications.

Motion: Compatriot French moved, seconded by Compatriot Leishman, that the following motion be adopted: The NSSAR will accept certain vital record data that is available on the Internet or sold on a CD-Rom, that have been compiled from reputable sources and would otherwise be acceptable to the NSSAR as documentation. In all cases of Internet documentation, a hard copy that identifies the URL and/or source of the document shall accompany the submission so its authenticity can be verified if necessary. The motion carried unanimously. A copy of Guidelines of Acceptability for Internet Transcripts and Documentation is attached.

Listed below are the upcoming dates for our 2010 BOM meetings at the Ramada Plaza Hotel & Inn Gateway in Kissimmee, FL:

January 15-16, 2010 May 7-9, 2010

For the contract year 2009 and 2010 the room rates will remain at (\$65.00 + taxes). **Plaza tower** rooms will likewise remain at (\$75.00 + taxes). **Plaza tower one-bedroom suites** will also remain the same (\$99.00 + taxes) during 2009 and 2010.

The BOM Registration form was sent electronically to the attendees of the Spring BOM for use in electronic registration. Such early delivery of the BOM registration forms will continue to be utilized to make it easier for attendees from the previous BOM to register for the next BOM. For the last 3 BOMs (Spring, Summer and this Fall), the predominate method of filling out the registration form has been by electronic means – using the Web based PDF form or the e-mailed PDF form. Between 75% and 82% have chosen this method. Six per cent (Spring BOM) have used an e-mail message or a phone call to register while 10 & 11% have used the Florida Patriot form, and 9% & 7% have printed the PDF form and hand-filled it out.

Once again BOM attendees were asked for their input. The results are:

- For Name Tags 75% use their own badges/tags
- For Proceedings 50% want a hard copy of the proceedings
- Spring/Annual Mtg 50% would prefer the Committee meetings/BOM on 1st day with the Annual Meeting on 2nd day.
- For Meetings/sessions 100% attend or try to attend the Executive Meeting; 75% attend committee or workshop meetings; 75% visit the hospitality room. For Summer, Fall, & Winter BOM meetings, 75% want the Friday meeting schedule to begin earlier so that the Hospitality room can be visited after the banquet.
- For possible BOM session topics 75% want officer training, 50% want Publicity workshop, 50% want ROTC workshop, 50% a Rumbaugh workshop, and 50% want a Genealogy workshop. Other sessions at lower levels include Americanism poster, History Fair, Patriotic Activities, Knight Contest, Education Committee, Middle School outreach, Eagle Scout, Newsletter/periodicals, and Website sessions.
- For hotel comments 50% felt that the food quality stayed the same, 75% felt that the check-in process stayed the same.
- When asked about a new venue (hotel), 50% want to move; 75% stay at the hotel for the BOM and 2/3s of these stay in the tower. The price range that the respondents would pay for a room is equally split between the given range selections: \$80-90, \$91-100, \$101-110, and \$111-120.
- Of all respondents, 75% would prefer the Radisson Hotel on SR192 over the Hotel in the Mall (Florida Mall hotel).

Since my last Committee report of <u>August 20, 2009</u>, e-mails to another 165 (average) recipients at a time were sent out on 8 occasions over almost two months, resulting in a total of about 1320 e-mails through <u>October 13, 2009</u>, the date of this report. <u>My knee replacement operation on Sept. 15th impaired my production.</u> This is lower than the number of e-mails sent last year over the similar reporting period (2 ½ months) <u>August 5, 2008 through October 24,2008</u>, when e-mails to 164 (average) recipients at a time were sent out on 27 occasions (abnormally high), a total of <u>4428</u> e-mails.

Adding the above 2 months results of <u>1320</u> e-mails to my 8-20-09 report of <u>6270</u> emails when another 165 (average) recipients at a time were sent out on 38 occasions over about a 4 month period, resulting in a total of about <u>7590</u> e-mails. Therefore, during the first six months of the 2009-2010 program year which began on April 24, 2009, my report through the date of this report, October 13, 2009, (about six months), reveals that emails were sent out on 46 occasions to 165 recipients at a time resulting in about <u>7590</u> e-mails. During last year's program year, 2008-2009 which began on 5/4/08 and ending on 4/24/09, e-mails totaled 20295. I need to do a better job in the second half. <u>Please Committee Members, keep those PATRIOTIC e-mails coming to me.</u>

By-law No. 1 - Membership

Add the following at the end of **Section 5**:

The National Society of the Sons of the American Revolution affirms its respect for the policies and procedures of the National Society of the Daughters of the American Revolution (DAR) relating to approval of its membership applications. Accordingly, NSSAR will accept as proof of service and/or proof of lineage any DAR application approved in 1986 or thereafter, except, (1) those involving lineage subsequently closed by DAR, (2) those on the DAR short form, and (3) DAR "legacy" applications.

The type of markings employed by DAR to signify verification of facts shall be immaterial to the acceptability of a cited DAR application, if the application bears (1) the dated signatures of the appropriate DAR officer or officers confirming approval of the application, and (2) the new DAR member's national number. Any SAR application pended or "grand fathered" pursuant to the change in genealogy policy promulgated on September 29, 2008, shall be unconditionally approved forthwith.

The resolution of the Genealogy Committee adopted September 25, 2009, regarding "grand mothering" of SAR applications is rescinded.. Any application approved pursuant to that resolution shall forthwith be deemed unconditionally approved, and limitations on future use of so-called "grand mothered" applications shall be removed.
