Bob Allen of the Florida House of Representatives, Florida Senator Mike Haridopolos, Chuck Nelson of the Brevard County Board of Commissioners and Mayor Rocky Randels of the City of Cape Canaveral presented the Florida Society with a Key to the City. Stan Payne, CEO of the Canaveral Port Authority was also in attendance. The United States Coast Guard presented and posted the colors and Captain James A. Watson IV, USCG was our guest speaker.

This was truly a historic occasion for the Florida Society and deserving tribute to Captain John Barry and the crew that served aboard the Alliance on March 10, 1783. We were honored to have in attendance two members of the St. Lucie River Chapter, John E. Moore, Sr. and John E. Moore, Jr. whose patriot ancestor, Robert McKnight served aboard the Alliance with Captain Barry. We are already making plans for the 225<sup>th</sup> commemoration which will be held on Saturday, March 8, 2008.

George Lockhart and I along with several other Florida Society SAR members attended the DAR State Conference in Orlando, FL on March 22-25, 2007. The DAR, as they have in previous years, graciously provided the Florida Society with a table for displaying SAR Membership data.

I wish to express my sincere appreciation to all of my Florida Society compatriots that sent flowers, emails, cards, letters and those who made phone calls during my recent health episode which occurred on March 26, 2007. I also deeply appreciate the prayers that were lifted up on my behalf.

# FLSSAR STATE OFFICER'S REPORT Senior Vice President

Since our Winter BOM, your Senior Vice President has been on the road. A short synopsis of my journeys started with a rather quiet two weeks when on February 8th, I drove to Jacksonville to meet with President Brock, spent the night at his house and early the next morning, we left for the dedication ceremony of the Battle of Kettle Creek near Washington, Georgia. We arrived in Washington, Georgia at 3:00 p.m. on February 9th and checked into the Bed & Breakfast. At 5:00 p.m., the Georgia Society held a reception at the place where we were staying after which we walked downtown to a restaurant where the Society had arranged for a meal for the SAR participants and their wives. On February 10th, after a nice breakfast, we proceeded to the Washington Library where they had a very well documented video concerning the Battle of Kettle Creek. Immediately after the video, the parade of the color guard and camp followers formed for a parade around the town square where we halted and a series of short speeches concerning the battle were presented. A Bar-B-Que lunch was served to those who purchased tickets, after which we traveled about eight miles out of town to the site of the Battle of Kettle Creek. It was a well organized ceremony complete with the posting of the colors by the color guard, the presentation of wreaths by the various State Societies and other patriotic organizations, and a series of greetings brought by the many dignitaries who were in attendance. Immediately after the ceremonies were concluded, we headed back to the bed and breakfast location, changed out of our colonial uniforms, packed up and headed back to Jacksonville. On the 11th, after spending the night at Lindsey's house, I proceeded to drive back to my home in Seminole.

From the 10th to the 21st, I had a busy time catching up on my emails (173 of them) which had piled up in my absence. My Clearwater chapter meeting was held on February 21st where I had lunch with them and then proceeded to drive back to Jacksonville for another night's stay with the Brocks. Very early on the 22nd. Lindsey and I left for a twelve-hour drive to Louisville to attend the Spring Leadership Conference. We had left Jacksonville at 5:00 a.m. and arrived in Louisville at 5:00 p.m., a distance of 784 miles. Tired, but undaunted, we had dinner with the large Florida Society contingent at Cunningham's restaurant in Louisville. February 23rd marked the beginning of the conference with a scheduled breakfast followed by various committee meetings. I met with the Eagle Scout Committee and helped in the grading of the Eagle Scout Scholarship and Recognition State winners from 9:00 a.m. until 11:00 a.m. when I had to leave to attend the National Library Committee meeting of which I am a member. That afternoon was dedicated to a Trustees meeting which was followed by a Dinner Theater show that evening to which we were all bussed out to the site of the theater in Indiana. The next day Lindsey and I had the opportunity to visit the National Headquarters after which there were more committee meetings. I attended the one on the formation of new chapters which was well presented and offered many good suggestions. That night, participating with the color guard, the final banguet was held with all of its pomp and ceremony. The next morning. Lindsey and I left at approximately 7:00 a.m. for Jacksonville, arriving there around 7:00 p.m. that evening. The next day, I drove back to Seminole, tired, but pleased that I had the chance to participate in the conference.

Things remained fairly quiet after that until March 9th when Pat and I picked up Charles Schafer and his wife Beth to trek over to Cape Canaveral for the dedication of the State of Florida Marker honoring the Last Naval Battle of the Revolutionary War. The space here does not allow me to spend the time I would like regarding this event. Lindsey Brock, Ben DuBose and Fred Gaines put on what may have been the biggest and best dedication ceremonies ever held by the SAR. A reception was held at 5:00 p.m. on March 9th which was followed by a supper for over ninety people at the Radisson Hotel. On Saturday morning, we had almost four hundred people in attendance at the dedication. Approximately 200 of these were in the color guard. Proclamations from the City, County and State House and Senate were read and accepted. Thirty-four wreaths were presented and the keynote speech was given by a USCG Captain. It was a grand show with five other state societies having representatives at the event. Two descendants of a crew member of the USS Alliance were also recognized at this event. This ceremony will be conducted every year on the Saturday closest to the 10th of March and we sincerely hope that the crowds will grow even larger as the event becomes better know around the country. Next year will be the 225th Anniversary of the battle and should generate a large crowd on March 8, 2008. Every one should plan now to attend. You will be glad you did.

It has been a good year and I have enjoyed my year as your Senior Vice President. But, I am the first to acknowledge that without the help of all of our Compatriot brothers, the many things that our Society does would not get done. Let's all dedicate ourselves to encourage more of our Compatriots to become active in the many activities that are included, not only in the Florida Society but in our twenty-nine chapters as well.

I will in the near future, induct the newly elected Withlacoochee Chapter Officers.

It has been a very satisfying experience to serve the four chapters in the North Central Region, for the last two years. As in most regions, we faced some challenges, but I believe we all made a positive effort to address them. Mr. Gordon Greenwood had been nominated to the NC-Regional Vice President position for the 2007-2008 period. I am sure that with his focus on details, he will be a successful RVP for the region.

**Gainesville Chapter:** This chapter has now successfully defined and inducted a new chapter officer line up. - 1. It has pleased me in recent months that members and prospective members of FLSSAR have been inquiring about documents and application preparation. Most of these inquiries have come from north central Florida and south east Florida. I am open anytime anyone needs questions answered or help with the "brick wall". My email address is: <a href="mailto:floridasearch@tampabay.rr.com">floridasearch@tampabay.rr.com</a>.
- I belong to an organization which is an arm of the Association of Professional Genealogists and the Federation of Genealogical Societies named Records Preservation and Access Committee (RPAC). We concern ourselves with closure of records and limiting access to records. The need to access government records by prospective SAR members brings RPAC into play. Recently we have learned that the National Archives & Records Administration has published in the National Register on 26 Feb 2007 that NARA is going to drastically increase the fees charged to make copies of records such as Civil War military pension files, bounty land warrants, and old military service files. This National Register number is: 36 CFR Part 1258. It is necessary to respond to this increase by April 27, 2007. I know this seems a bit late but I just got information about this. You can do it electronically by visiting the following web site: <a href="http://regulations.gov">http://regulations.gov</a> and follow the way to a reply screen.
- There is a new web site available to find documents from Colonial American, Revolutionary era, and some 17<sup>th</sup> 18<sup>th</sup> century material. These are all digitized original documents.

   It is necessary to register (no cost) and then you can view any record from the Pennsylvania Archives Series at no cost. All other information is on a varied fee basis.
- 4. For those FLSSAR members who are still actively researching their family history I strongly advise you keep an eye on the web site Ancestry.com. It is available free of charge at most public libraries. At this time Ancestry has just gained access to Scottish census records from 1841-1901, Ellis Island Records from 1892-1957, and all Canadian border crossing records from 1895-1956. These all have accompanying digital imaging as well as a full index.

However at this time last year we had 4,234 records in the database. The number currently stands at 7,191 or a 41% increase. We hope to commit time to this project during the summer months.

# FLSSAR Committee Report Chapter Challenge

Chairman: George Lockhart

Recommended changes to the Chapter Challenge report for 2007 were sent to the committee members. Those responding agreed with the recommended changes. The new criteria have been printed and will be distributed to the Regional Vice Presidents at the Regional VP Meeting to be held at the Spring BOM and Annual Meeting for further distribution to the Chapters. The 2007 report should be completed by the chapters and to the RVP's by 3 March 2008.

Ribbons were ordered by this Chairman in sufficient quantity to handle this year and next. The ribbons were purchased at AAA Trophy Mart, in Jacksonville, FL at a cost of \$1.85 each. Extra ribbons, 2006 Chapter Challenge reports and other information will be turned over to the new Chairman at the Spring BOM.

I wish to thank the committee members and regional vice presidents for their support during the past year. My congratulations to the red, white and blue ribbon recipients whose reports showed that the chapters are active and supporting the objectives of the society.

Of the 29 chapters, 22 completed and returned the form. Some of the activities cited by chapters for 2006 "Other" points include:

Central Florida members attended some National events such as Cow Pens, Kings Mountain, and Fort Fredericka. They also attended in colonial uniform a flag retirement ceremony for the disposal of 5,000 worn/damaged American Flags.

Brevard Chapter distributed the Keyhole to History CD and two radio stations are playing the CD on a daily basis. They also spent much time and energy in preparing for the March 10<sup>th</sup>, 2007, celebration of the Last Naval

Battle of the American Revolution. Their activities included raising \$6,000 (\$2,000 from the chapter) for a cannon monument and designed and funded a commemorative medal for the occasion.

St. Lucie River Chapter had four members who served as judges for the St. Lucie Co. History Fair.

Gainesville Chapter distributed the "Keyhole to History" CD to the Alachua County School Board for use in all classrooms.

Flagler Chapter had 4 members that spent a total of 750 volunteer hours to organizations such as Meals on Wheels, Flagler Cities Council, COP of Flagler County and Florida Trail Association.

Deland Chapter distributed 2 Keyholes to History CDs to two radio stations, one in Deland and the other in Ormond.

Palm Beach Chapter actively participated in an Armed Forces Memorial Day Program involving 1500 service personnel and Patriotic Organizations. The chapter had 6 men in SAR uniform and they presented a 36-inch memorial wreath in memory of our fallen service personnel. In addition they had 4 men assisting the program activities.

Miami Chapter – While at the NSSAR Congress in Dallas, Texas, in July 2006, the chapter made a donation of \$10,000 to the Center for Advancing America's Heritage. The money was to be matched with a like amount by an anonymous donor.

Lakeland Chapter held it first memorial service at its September 2005 meeting to honor members that have died in the past year. This service generated enough favorable comment that another service was conducted in September 2006. The surviving family members were invited to attend the service and be a guest for lunch. The chapter honored seven deceased members at this service which was the best attended with 27 members and 19 guests.

Withlacoochee Chapter delivered in excess of \$6,500 in gifts and hosted a pizza party for 115 veterans in Balderomo Lopez Veterans Home.

Lake/Sumter Chapter furnished three Keyholes to History CDs to three radio stations for their use in the Lake-Sumter area. They also donated American Flag stars and cash to the "Shoebox" program in The Villages. Tallahassee Chapter presented an FLSSAR Award to the State History Fair.

Emerald Coast Chapter presented an SAR wreath during local Memorial Day services, with 2 chapter members in period uniform. They also presented an SAR wreath during a local Veterans Day service with one chapter member in period uniform.

Pensacola Chapter distributed 100 American Heritage CDs to the Escambia County Home Schooling Association. They also had two members that served as judges at the Escambia and Santa Rosa County History Fairs.

Saramana Chapter has donated a large amount of time and incurred a good amount of expense in promoting and distributing the Keyhole to History CD and meeting with members of the press to encourage coverage.

### FLSSAR Committee Report Education Committee

In late February and early March we received information that Past Governor Robert Graham and Past Representative Lou Frey were working with Governor Crist and the Florida Senate and House on a bill which would require that Civics be placed into the Sunshine Standards and also the FCAT. Their effort also included the creation of a "Center for Citizenship", which would meet at the Lou Frey or the Robert Graham institutes. This bill became ultimately SB1234 and was sponsored by Senator Don Gaetz.

Members of the FLSSAR Education Committee began discussion this legislation. The basis of this legislation was from Jason Caros and Jack Bovee of the FASSS (Florida Association Social Studies Supervisors), who has hired a new lobbyist and has kept us aware of the progress of the bill. We recently launched an effort to get members to write to their local senators and to the Senate Education Committee to express support.

Since that time, the Florida House has created HB7151, which is much more comprehensive and in principle, meets our objectives. Our objective over the last several years has been to get American History and Government back into importance within our Florida Public School systems. The house legislation has several key items: 1) Replace the title, "Sunshine Standards" to "World Class Education Standards", 2) Create an Advisory Council made up of outstanding teachers, 3) provide in the standards, a 'complete' education program, which includes social studies, with an emphasis on history, government and civics, 4) require addition of tests (FCAT) to measure student's knowledge of social studies, with an emphasis on history, government and civics. There is much more to this bill, including the addition of requirements for a plan for articulated world-language curriculum. Recently, after some discussion within the committee, we again asked Florida Society leaders and members to write to their senators and representatives, expressing their support for SB1234 and HB7151. We are pleased to have evidence that already a number of members have written, emailed and talked to their representatives. The feedback from these legislators has been supportive.

At the time of this report, it appears that HB7151 has moved successfully through all house committees and is awaiting to be scheduled on the house floor for a vote. SB1234, it

is believed, is being held up <u>as expected</u>, with an evaluation of the appropriateness of the "Center for Citizenship". I have personally expressed to FASSS personnel and some legislators that we should not allow this bill to die because of this item!

It has been stated by several contacts, that these bills, are strongly supported by Governor Crist and both the Senate and House leadership. The view is that they should easily come to the floor (s) for a vote and will pass.

In anticipation of passing joint legislation, which resembles HB7151, we are attempting to achieve membership on the Sunshine/World Class Education Revision Committee.

We have also requested participation in the Lou Frey and Robert Graham, "Center for Citizenship", if it is incorporated into the legislation. We will be meeting in the near future with the FASSS organization in Orlando. If anyone wishes to join our effort, let us know.

#### Report on Survey of Membership

#### Introduction

A survey of the wishes/needs of the FLSSAR membership was proposed in 2005; it was subsequently approved and funded by the BOM. A further purpose was to address a number of grievances that had surfaced during the previous 2-3 years and discover if they simply were isolated complaints or should be of serious concern to our Society. The survey was designed also to assess the efficiency of our programs and provide a conduit for constructive suggestions. The vehicle employed was of the positive type; one that would tap into the percepts and desires of our constituency.

A suggested version of the survey was submitted to the Executive Committee and the BOM. After two revisions it was approved and included in the Spring 2006 edition of The Patriot. Other copies were delivered directly to members attending chapter meetings when the undersigned visited them. Unfortunately, however, the announcement of, and explanations about, this program were omitted from The Patriot; hence only modest participation resulted. Accordingly, a second distribution of the 2-page survey was made (e-mailed) to chapters. Unfortunately, the explanations of this program's nature and purpose were *again* omitted from The Patriot. These two omissions led to the receipt of a large number of letters, e-mails and telephone calls wherein Compatriots asked what the survey was all about and why it was sent out with no explanations. In all, these unfortunate problems led to a response by only a little over 200 members (actually 12.2% of our membership). Since the survey was designed for a 20% or better response (which undoubtedly would have occurred if proper explanations had been permitted), the intended statistical analysis of the obtained data had to be discarded. Nevertheless, a great deal of useful information accrued. Included was intelligence that should provide future FLSSAR leaders with useful insights into ways to upgrade/improve our Society.

#### The Responses

A number of the communications/responses received were ones that could not be employed in the analyses that follow (they were **not** counted in this review, of course). First, several Compatriots commented -- sometimes at length -- about the critical need for a program of this type. Several others were not so kind. One compatriot simply printed "This is just another attempt to get more money out of me". Three responses contained nothing but a negative statement about the BOM ("an exclusive club" for example), three only complained about the food and its cost at chapter meetings and one did not like the form of the survey. Finally, three of the responses contained an attack on individual Compatriots. This type of response was not judged legitimate and, hence, they were discarded. Indeed, the undersigned would not have liked to have had comments of this type directed at him (had they occurred), hence, he declined to let them be published about others. In short, this report is based only on the responses from 197 Compatriots and does not include the 24 (inappropriate ones) cited above.

#### **The BOM- General Member Contrast**

In addition to the overall analysis, certain data breakdowns could be (and some were) carried out. For one thing, a contrasting of the responses made by the BOM members to those submitted by "general membership" Compatriots proved useful. Of the total, 35 respondees were clearly BOM members, 158 were not and 4 were in question. The BOM-nonBOM contrast was between the 35 and 158 with the remaining four members used only in the overall computations. It should be noted that, while there are roughly about 100 BOM members, only 38-50 regularly attend meetings; hence, a representation by 35 individuals from this group reasonably parallels the "active" BOM group. The demographics of the two segments are as follow.

Note that the BOM members exhibit greater experience with the SAR; they also show better attendance and (by implication) are of a more advanced age. A surprising feature: 11% of the BOM members and a full 30% of the general members chose not to provide their names. Moreover, the fact that 58% of the latter group had held chapter level leadership positions showed that this group was generally more committed than the bulk of the Florida SAR population.

#### **Group Goals**

Overall, the two groups listed pretty much the same reasons for being SAR members: patriotism (love of country and need to put it into action), pride in ancestors, fellowship, service to country and community, program support, and need to learn were the primary reasons. So too were the groups similar when rating the "positives" with respect to chapter meetings and the BOM/annual meetings. The SAR programs (especially the youth programs) rated high, as did Speakers and Fellowship. No statistically significant differences between the groups were found regarding these factors.

On the other hand, the desire/need for more and better communication was clearly apparent even before the meetings data were subjected to grading with 76% of the BOM Compatriots aware of the effort to upgrade our society but only 44% of the general members "in the know". This problem became even more apparent when the grading of meetings was conducted. The **lack of good communication** was rated as the top problem by a majority of *all* FLSSAR members. Of course, only a portion of the general membership group rated the FLSSAR meetings at any level as over half of them have never gone to even a single one of them. Yet, overall, many general members scored poor information and *lack* of welcome as the most serious of problems.

#### Structure of the SAR

One of the surprising findings was that both 17% of the BOM and 17% of the general members indicated that they believed the SAR to be a **social** organization; in turn, 22% and 40% (respectively) of our respondees suggest that the SAR was a **service** organization only. It is clear that some confusion exists in the minds of a substantial number of our members as to what we are and what we should be. This issue is of great importance and should be addressed in the near future.

#### The Patriot

It should be remembered that, since this survey was conducted *before* the present editor was elected to that position, it tends to reflect prior issues -- just as some of the cited concerns about our state society would be mitigated as a result of the programs carried out during the past two years. In any event, both groups judged The Patriot to be more of a journal than a newsletter and rated it better in the first role (i.e., journal) even though they *preferred* it to be more of a newsletter. In general, there was some unhappiness with this publication with the BOM members somewhat harsher in their judgments than the other group. That is, the general membership rated The Patriot a little higher than did the BOM members. Moreover, it did not seem to matter whether an arithmetic or geometric scale was applied, all mean ratings scored it above the *inadequate* level (by 11-26 points) but well below the very good level (with scores ranging 10-25 or 4-17 points below it). Thus, the best overall rating that could be mustered for The Patriot (at that time anyway) was between average and a weak good. Further, it was in the actual assessment of The Patriot where its problems were revealed. A majority of the general Compatriot group indicated that it did not include anywhere near enough news about the chapters and their programs nor carry enough general

information or news about individual members. The BOM group concurred adding that the magazine should also be carrying more news about the Ladies Auxiliary. Some of these problems have already been corrected, but a few linger. Nonetheless, it seems that our members desire a publication that leans toward the Newsletter side of the equation.

#### **Electronic Communication**

It appears that most members are aware of the FLSSAR website (BOM: 97%; Non-BOM: 67%). Surprisingly, however, over half of all respondees did not know its address (BOM: 40%; Non-BOM: 58%).

The problem with FLATALK proved very much more serious. Surprisingly only 49% of the BOM group indicated that they were aware of FLATALK and, in turn, only 37% indicated that they had signed up for it. The lack of awareness here was even more striking with respect to our general membership where less than 20% even knew FLATALK existed. "Never heard of it" was the most common response. It appears that a great deal of effort will be required to upgrade the effectiveness of our attempts to reach out to our membership electronically. Moreover, this effort will be hampered to some extent by the lack of computers, and/or their use, by the FLSSAR Compatriots. Indeed, 20% of all respondees volunteered that they either did not have a computer or did not use one. This finding would project to the realization that around a quarter of *all* Florida Compatriots cannot be contacted via the internet.

#### **Comments by Members**

Many of the problems we face as a Society have been demonstrated and/or implied by the reports/discussions above. As it turns out, the suggestions by our members are proving to be even more important. A few currently are being addressed but others are not and need to be. While many good suggestions were received, only those which have not been considered above and for which there was some *group* concern are included below.

- 1. As might be expected (especially from the above), the BOM itself took the most severe hit. A substantial number of the non-BOM members judged it to be a "closed" group which is not interested in the chapters or members. Some respondees hoped that a reduction of the "seeming endless" disputes among the "too few different" officers would lead to a more positive effort toward members and chapters; one of the long-term members indicated that he could not remember when "power-plays" weren't taking place. In any case, these perceptions exist and while they are inaccurate to some extent, they all should be addressed.
- 2. One of the greatest of our members concerns was with the critical need for both 1) better public relations and 2) a much greater thrust in this area. Of course, most of the questionnaires were completed before The History Fairs program was established and Public Affairs was split off from the Publicity committee. These efforts obviously are steps in the right direction. Nonetheless, calls for more publicity-worthy speakers, and a greater effort to portray our nature, goals, and programs, at both the state and community levels, were numerous. In short, many members felt that the appropriate effort in public relations was lacking.
- 3. Without a doubt, the desire for better organized links between the BOM (plus its officers) and the chapters/members was a prevailing concern. As a matter-of-fact, many of the concerns/suggestions found below reflect this particular need. Some recommendations about continuing the effort to upgrade the role of the Regional Vice Presidents (that has been going on for the past 2-3 years) were received. However, even more of the nonBOM members requested that a greater number of the FLSSAR officers interface with the membership and that the BOM be generally less insular.
- 4. A general call for the recruiting of new members -- especially *younger* new members -- rippled through the responses. This was to be expected. Yet many of those respondees who could be identified as being in this (younger) category seemed put off by the lack of welcome they had received (they felt like "outsiders" they said). Several indicated that one of the major reasons they had joined the SAR was to learn about Colonial History (two humorously listed some of the programs they actually had heard instead) but had been disappointed; some may not be attending meetings because of a lack in *history* programs at all levels.
- 5. Expressions of concern about the lack of a useful Procedures Manual were scattered among a number of the respondees. The bulk of their suggestions were for an approach where a hard copy would be sent to the chapters (as well as electronically placed on our website). It was suggested that a package of annual updates (new officers, new deadlines, etc.) be sent in a form wherein it would **not** be necessary to reprint the entire manual.
- 6. Fiscal responsibility at the state level also took a hit. Three problems were identified as major: 1) the lack of effort to increase the Endowment Trust Fund (ETF), 2) the lack of a reasonable *return* on the money held by the fund and 3) its inability to meet the needs of the chapters. A number of suggestions relative to reorganization and reinvestment were made. Some already have been accomplished during the past two years but more appear needed.

7. Finally, a number of other suggestions (some rather good) were scattered among the respondees. Prominent were ways 1) to speed up applications, 2) to make the BOM meetings more efficient, 3) to improve communication with the chapters (one was that the Executive Committee should prepare **brief** monthly reports and send them to the chapters), 4) to enhance attendance at meetings (one of these was to establish associate membership and/or broadening of the "76'ers" program where it exists), 5) to keep the website up-to-date, 6) to provide stories and information for chapter newsletters. There were others. As would be expected, the survey provided a vehicle for a number of Compatriots to express their

frustrations and disappointments even though most of their suggestions were positive in nature. Anyway, some complaints were trivial, others were only too real -- and important. On the other hand, some of the expressed opinions were simply not fair. Nonetheless, the information provided is useful in a number of ways. Two are of special importance. First, a number of the "hot spots" are identified. While some of them already are known to the BOM and the FLSSAR officers, others were not. Happily, some can be mitigated quite easily (or already are in the process of being addressed). Others will require some effort. The second of the two is almost as important as the first. Specifically, some of the impressions about the activities at the "state level" appear to be distorted. If not corrected, they could become "the reality". In any event, the mechanisms used to improve communication and upgrade the exchanges between the BOM and our members/chapters should contain a healthy public relations component.

It also can be said that most of the over 200 individuals who responded in various and sundry ways showed that they care a great deal about our great country and this fine organization. The best way to thank them for their effort -- and their other accomplishments -- is to make our Society as great a one as we possibly can.

The FLSSAR web site no longer uses much information that had been available in the past to attract viewers to the Florida Society web pages. Many articles and other information has been removed, resulting in a likely reduction of over seventy-five percent of the hits that we were getting in the past on our web site.

Chapter information remains sketchy, and there are only nine of the twenty-nine chapters listed that have been linked to. Five of these nine state sites have officer listings that conflict with the flssar.org listing of chapter officers.

Netscape viewers still do not get the control bars on the top of the <a href="www.flssar.org">www.flssar.org</a> home page and are not likely to know that information is available. As a result, many of them probably quickly move on to other web sites.

Since the necessary script has been removed from all <a href="www.flssar.org">www.flssar.org</a> web pages, we are no longer able to track activity through our Website Traffic Report; so it has not been possible to offer any statistics in this area.

The new format of the contest worked well. On the plus side, we received positive feedback concerning the website and the ease of entry for the contest. There was significantly less confusion for the students from when they had to find a local contest to enter. The students who signed up for our email reminders seemed to like the material we sent and we were able to do a much better job of promoting the SAR to these students. The stability of the website and entry information should be a benefit going forward.

We must report two negative aspects of the new format. The committee intentionally reported to the BOM their consideration to change the contest from local to state level at the Fall 2005 and Winter 2006 BOM's. While we knew the idea had significant merit we thought the change might adversely affect local chapters and solicited input months before proceeding. No chapter responded with any complaints or concerns about the idea. At the Spring 2006 BOM, we asked for a discussion and vote. No opposition was shown so we proceeded with the new plan.

Once put into place however, 3 chapters voiced complaints to the change. Saramana was particularly outspoken in their opposition. Their concerns had merit but we were already committed, by BOM mandate, to proceed. We can only offer our regrets that the objections were not voiced at some point during our 7 month deliberation on the topic. They would have been greatly appreciated at that time.

For the 2007-2008 contest we have slightly altered things to allow chapters to conduct local contests if they choose. There are some drawbacks to this approach but we are hoping that the compromise will assist those chapters who value a local contest.

The second negative for the 2006-2007 contest was the number of entries. We had hoped the new format would work to improve the number of essays submitted. We saw no improvement from prior years. It is difficult to pinpoint a specific cause for the low number of entries for this year's contest as well as contests in past years. We are hoping that ground work laid this year might payoff in next year's contest. If not, we will suggest that the BOM re-examine our commitment to this and the other youth contests to determine if these efforts continue to be the best use of our resources to further our mission.

# FLSSAR Committee Report Good Citizenship

# **FLSSAR Committee Report Membership Promotion & Retention**

This committee has met electronically and membership promotion and retention ideas came in from all over the State. Many chapters contributed the following list of suggestions and we thank them for their participation in this most important chapter activity. Not all of these suggestions are right for all chapters, but in the list are items that may help your chapter encourage more eligible men to seek membership and more of your members to renew annually. Please save this list as it is not in print any place else. Remember, a chapter which is not actively recruiting every month will soon be a dying chapter.

#### SOME SUGGESTIONS FOR CHAPTERS TO INCREASE MEMBERSHIP

Following are some suggestions which chapters might use to help recruit and retain chapter membership. Many chapters contributed to this list and we thank them for their contribution. If anyone has other suggestions on how this life blood of our Society can be increased, please pass this information on to the Membership Promotion & Retention Committee. The following are not listed in any order of importance. All are considered good and all came from various chapters and Compatriots in our Florida Society.

- 1. Contact the National Society and give them the Postal ZIP Codes for the counties served by your chapter. Ask National for a list of any SAR members who have moved into those Zip Code areas. Then make a personal contact with the individual about joining your chapter.
- 2. In your chapter newsletter, ask you chapter membership to "talk-up" SAR at every opportunity. Don't hide you membership. Make SAR a matter for public discussion.
- 3. In your chapter, help make SAR, DAR and CAR function as one. If your chapter recruits a new SAR member, ask if he has any children or grandchildren who might become CAR members and a wife who might be interested in DAR
- 4. Anytime the Color Guard participates in an event, it is an excellent opportunity to give out brochures about membership in SAR.
- 5. Chapters should participate in Genealogy Seminars by having a recruiting desk complete with members in Colonial Uniform and plenty of SAR literature. Advertise the fact that the chapter will assist prospective members in the application process.

- 6. History Fairs are an excellent place to talk about SAR membership and to distribute SAR literature.
- 7. Members of other lineage societies (i.e. The Society of Colonial Wars, Mayflower, Founders and Patriots, etc.) are excellent candidates for membership in SAR.
- 8. It has been stated that the entire question of attracting members rests on the focus of the chapter. Is the chapter a viable and working chapter in the state society, or is the chapter simply a "meet and eat" chapter? These are the real benchmarks. If there is nothing going on to interest a new member who has just paid hundreds to join and be recognized for his patriot, then that member will drop within one or at the most two years if not given a reason to stay.
- 9. Initiating new programs, especially programs involving the youth, can involve grass-roots participation of the membership with little or no cost other than the time involved.
- 10. Request a list of the "dropped" members of your chapter from the State Secretary. A personal call, asking them to renew their membership, might prove successful.
- 11. Suggested Bylaw if the chapter adopts the idea of Associate Membership. A suggested Bylaw for the Chapter Constitution is available upon request from the Senior Vice President.
- 12. Contact the dropped members and encourage them to renew their membership.
- 13. Ask a new member what program he would like the chapter to participate in.
- 14. Ask the new member what he is interested in doing to promote the SAR objectives.
- 15. Use provisional membership in case of a natural disaster (hurricane, flood, tornado, etc.).
- 16. If the member is confined to a nursing home or assisted living facility, forgive State and Chapter dues. Note: This would require State and Chapter agreement.
- 17. Create a "Helping Hand" Fund in the chapter to take care of dues needs for confined members.
- 18. On the chapter dues notice, ask for extra dollars to be used to pay the dues for members who for whatever reason can not afford the dues.
- 19. Hold a retreat of officers and committee chairs to brainstorm ideas on how to retain and attract new members.
- 20. Work closely with the DAR. Many of the DAR husbands are eligible for SAR membership, but have not been invited or encouraged by their DAR wife.
- 21. Be sure to recognize the DAR for any prospects they supply who become members of SAR. Remember, there is a medal available for DAR members who provide three SAR members.
- 22. By sending in the appropriate Zip Codes to National, request a list of any SAR members who have moved into those areas from other State Societies.
- 23. Use the email to communicate with members between chapter meetings. Keep them informed.
- 24. Improve communications between the officers and members of the chapter.
- 25. Provide a written job description for every chapter position, both officer and committeeman.
- 26. Ask other organizations what they are doing to attract new members. Talk to them about SAR and see if you can recruit from that organization to SAR.
- 27. Create a membership brochure. Put the brochure in libraries and distribute copies to other organizations.
- 28. Pay the Life Membership fee for older members who can not afford it.
- 29. Have joint "business" meetings with DAR chapters to discuss membership recruitment.
- 30. Advertise SAR! Put the chapter meeting information in as many local newspapers as possible each month.
- 31. Schedule table set-ups where the chapter can promote the society and the chapter.
- 32. Make a serious attempt to get the local news media to attend as many of the chapter events as possible.
- 33. Be sure to "cash in" on the Keynotes to History discs which are available for your local radio stations.
- 34. Have a chapter color guard and provide it to some other organizations in addition to participating in Veterans Day parades, Christmas parades, etc. Show the colors!
- 35. Many members will not, or can not, purchase or make a colonial uniform for the color guard. Encourage all of the chapter members to purchase a tricorn hat and wear it with your blazer. It attracts attention and it advertises the SAR.
- 36. The Daytona-Ormond chapter has a website which advertises "Researching Data for SAR Applications." They state that this can be used by any chapter, but it does have local references that may or may not be available in other locations. Look it up. It may give your chapter some ideas on how your chapter can create its own website.

Many thanks to the many chapters who contributed to the above list of ideas. There are certainly many other innovative ways to promote and retain membership in our chanters and those listed above are only a few. Keep sharing your ideas with your fellow Compatriots. They will thank you!

# **FLSSAR Committee Report NSSAR Library**

The Committee received a quarterly statistical report for the period 1/1/07 through 03/3/07 from Michael Jones, NSSAR Librarian-General. The report summarized membership data for members of the Friends of the SAR Library (FOL) for all state societies. FLSSAR remained in first place with a total of 51 personal and chapter members (down from 53 on 10/31/06), 23% of the national total.

FOL funds are used to supplement the regular library operational budget, providing new services such as database subscriptions, books, and other materials for the library collection. This is quite separate from fund-raising efforts for the proposed **Center for Advancing America's Heritage**, the new building that will house the NSSAR Library. The Committee urges all FLSSAR members and chapters to actively support this crucial building program. More information can be obtained on the NSSAR website (**CAAH**).

During the 1<sup>st</sup> quarter of 2007, the SAR Library added 87 new books, served 380 in-house users, assisted with 561 in-house research requests, acknowledged 160 letters, responded to 211 research requests by mail, and answered 138 research requests by phone (data reported by Michael Christian, NSSAR Librarian).

The committee wishes Michael Jones, NSSAR Librarian-General, a speedy recovery from his recent illness.

# **FLSSAR Committee Report American History Teacher Award**

Chairman: Kevin Yarnell

In our last report we articulated several ways by which we might proceed with a program to recognize outstanding history teachers in our schools. There has not been much feedback but that which we received has been highly useful. It has also left us without a single way by which to proceed. Each idea offered in our report and several other alternatives have been found to have flaws that would significantly compromise their usefulness.

As an example, we pursued the possibility of running a contest in some similar manner to the way we conduct the youth contests each year. Discussions revealed that our winner might not represent the best or even a quality history teacher. One instructor observed that while they'd be grateful for the honor they would prefer to devote their time to their teaching rather than to filling out forms and writing essays to gain recognition. In fact, they suggested that the type of teacher that would enter such a contest would be one that likely was more interested in the award than their students. We confirmed this thought with other instructors and quickly saw the significance of the observation.

Further, based on the National rules as they stand, there was no way to guarantee the accuracy of any statement made by a teacher regarding their instruction. In other words, they could write of their commitment to teaching the colonial period but we'd have no way of determining if this was in fact done each year.

We then have two core problems. The first is finding the right history teachers to recognize. The second is to determine the best way to accomplish this recognition.

The latter problem is fairly easy to solve. A cash prize, recognition at a dinner, or a continuing education seminar are just some of the possibilities. The former however is the real dilemma and we currently don't have a workable solution.

At this point we are working on a plan by which we would encourage local chapters to do something to recognize outstanding history teaching in their area. This committee would send to the chapters detailed

suggestions of things they might do during the school year and then ask for feedback on the results of their efforts. Our hope is that practical experience on a local level might guide us as we enlarge this program.

Finally, we realize that many chapters do not have the financial resources to take on this program. Yet it is not clear whether the state society views this project as having sufficient priority to warrant offering assistance to the chapters. Perhaps in the future it could be added to the list of items eligible for reimbursement from the Endowment Trust Fund but we think it is premature to do that at this time. Instead we plan to discuss with the Executive Committee the possibility and advisability of creating a budget line item of \$1000 in the 2007-2008 budget for this committee. Our intent would be to divide this money between interested chapters for them to use to finance a history teacher recognition program. If the membership thinks this is an appropriate approach we will develop and provide administrative details for the Summer BOM to approve.

In the interest of full disclosure, the Tampa chapter of which I am an officer will be asking for a portion of these funds to offset the cost of a recognition banquet currently in the planning stages should the state society offer such assistance.

### Minutes of the Annual Meeting, April 2006

The Annual Meeting convened following the Youth Awards Luncheon. Chaplain Schafer gave the Invocation. Pledge of Allegiance was led by Senior Vice President Brock. Carl Hoffmann led the SAR Pledge. Newell Kellogg requested the floor. He said that we had received a bill for the accounting work done on the Operating Budget Trust Fund and the Endowment Trust Fund. The bill covers the years from 2002-2005. The total bill was \$1161.55 with \$702.85 for the Endowment Trust Fund and \$458.70 for the Operating Budget Trust Fund. Newell moved and Alvie Davidson seconded that the bill be paid. Discussion followed. President General Roland Downing arrived. Senior VP Brock spoke to the issue recommending that the bill not be paid until the work is completed. Jack Coleman asked if the Society had a bill on letterhead that explained the charges. The answer was yes, the fee was for work performed regarding an accounting preparation through 4/27/06 for both funds. The bill contained the note: "Payments not received within 30 days of the date of this invoice are subject to 1.5% late fee per month". Newell withdrew the motion and Alvie withdrew his second. Carl Hoffmann moved that the action be deferred to the Executive Committee for resolution. Gerald Meeks seconded the motion. Motion passed.

President Hollien presented the President General Roland Downing who addressed the group. He talked about fund raising for the Center for Advancing America's Heritage. He provided a handout which discussed the progress toward educational outreach at SAR and showed a graph which showed a \$300,000 donation made in 1999 which started the fund raising activity. They need \$3 million to build the building and \$3 million for operation and maintenance of the building. Given the rate of fundraising it is possible with the cooperation of all members that construction could start in 18 months. Every member needs to contribute \$200. That would mean that the Florida Society's share would be \$320,000. He encouraged each chapter to make a donation. President Hollien distributed the post cards showing support of the National Society and its programs. He asked that the cards be signed and given to President General Downing. President Hollien asked for State Officer Reports and Statutory Committee Reports. Gerald Meeks, Chairman of the Medals & Awards Committee advised that Lonnie Jones had replace Al Snapp on the committee. Dick Fowler, Chairman of the Nominating Committee presented his report on page 21 of the Quarterly Reports. President Hollien read the list of candidates and the office for which nominated:

President, Lindsey Brock; Senior Vice President, Grant Wallin, Jr.; Secretary, Kevin Yarnell; Treasurer, James Holyfield; Registrar, William Stevenson; Regional VP NW, Edward Young; Regional VP NC, Ronald Toops; Regional VP NE, Tom Beauchamp; Regional VP EC, Ben DuBose; Regional VP WC, Nelson Jantzen; Regional VP SE, Gerald Meeks; Regional VP SW, Donald Cahill; Chancellor, Carl Hoffmann; Chaplain, Charles Schafer; Recording Secretary, Joseph Motes; Genealogist, Alvie Davidson; Sergeant-at-Arms, Lonnie Jones; Member of the Executive Committee At Large, John Cahoon, Jr.; Historian, John Little; Parliamentarian to be appointed by the incoming President; "The Florida Patriot" Editor, Richard Fowler. He then asked for nominations from the floor. Carl Hoffmann nominated Philip Carr for the office of Trustee. Alvie Davidson seconded the nomination. Since there was no opposition a voice vote was taken. Motion passed unanimously. Phil Carr accepted the nomination. President Hollien then asked if there were any other nominations from the floor. John Tinney nominated Saul Montes-Bradley for the position of Senior Vice President. John did have a letter from Saul agreeing to serve in the position if elected. Motion seconded by Terry Walton. President Hollien asked if there were further nominations. Dick Friberg nominated Hal Miller as an Alternate Trustee. Hal Miller accepted the nomination. Alvie Davidson seconded the motion.. President Hollien asked for any further nominations from the floor. John Cahoon nominated Saul Montes-Bradley for "The Florida Patriot" editor. John explained that Saul had expressed a desire to continue to serve as editor. Phil Carr moved that the members vote on all offices that were uncontested and then take up those offices that were contested. Motion was seconded by Carl Hoffmann. The guestion was called on Phil Carr's motion and all voted in favor of the question. Then a voice vote was taken on Phil Carr's motion to vote on the uncontested offices. Motion passed unanimously. President Hollien pointed out that he thought that any officer except President could dually serve as editor of "The Florida Patriot". Carl Hoffman moved that a vote be taken on the most senior position of Senior Vice President first. The motion was seconded by William Stevenson. Kevin Yarnell confirmed that the bylaws do allow any officer other than the President to hold more than one office. Based on this Carl Hoffmann withdrew the motion and William Stevenson withdrew his second. Prior to the vote. President Hollien opened the floor to anyone who wanted to speak on behalf of either candidate for the contested offices. He limited it to three speakers for each candidate. No one spoke. President Hollien then appointed Lonnie Jones to hand out the ballots and Frank Hodalski, Gerald Meeks and PG Roland Downing as tellers. The first vote was taken on the office of Senior VP, Grant Wallin and Saul Montes-Bradley. PG Downing reported the results of the ballot vote for the position of Sr. VP. Saul Montes-Bradley received 19 votes and Grant Wallin received 41 votes. The tellers remained the same. President Hollien announced that the voting will be for the position of Editor of "The Florida Patriot", Saul Montes-Bradley and Dick Fowler, candidates. The tellers returned with the vote count for Editor. Saul Montes-Bradley received 24 votes and Dick Fowler received 34 votes. Jack Coleman moved that the ballots be destroyed. Motion seconded by William Stevenson. Motion passed.

President Elect, Lindsey Brock, Chairman of the Charter & By Laws Committee introduced the committee members and presented the propose by law changes. Those changes and committee recommendations are shown on page 23 of the Quarterly Report. Lindsey read each proposed change and the committee recommendations. Frank Hodalski advised that the Committee Chairman should make a motion in the affirmative so that a Yes is for passage and a No vote would be for no passage. The motion does not require a second. It was moved and seconded that a vote be taken on each proposed amendment with a yes vote being in favor of the proposed amendment and a no vote being opposed to the proposed amendment. Considerable discussion followed. The first amendment was voted on and was rejected. Discussion followed on the second amendment. President Elect Brock pointed out that the BOM Program Committee has already negotiated a contract with the hotel for four meetings in 2006-2007 and the Society would probably lose its negotiating position if we tried to change from 4 to 3 meetings. Kevin Yarnell invoked a point of order that the By Laws require that the proposed amendments be voted on by ballot at the Annual Meeting. He said that ballots were prepared and that all three proposed amendments were on the ballot. Discussion continued on the third proposed amendment. Regarding the second proposed amendment Ben DuBose moved that the proposal be modified to take effect following the April 2007 Annual Meeting. Motion was seconded by Jack Coleman and passed by voice vote. A ballot vote was taken on each proposed amendment. While the ballots were being tabulated President Hollien announced that there is a resolution being considered under Senate Resolution 89 and House Resolution 367 recognizing the centennial celebration of SAR receiving its congressional charter, on 9 June 1906. Members were asked to contact their representatives and encourage support of these resolutions. President Elect Lindsey Brock announced the appointment of Frank Hodalski as the Parliamentarian. Ballots were returned with the following results: First amendment regarding tenure of officers and committee chairman the vote was Yes=6, No=47, proposal rejected; second amendment regarding changing the number of meetings from four to three as amended by previous vote to take effect following the April 2007 Annual Meeting was Yes =17, No =34, proposal rejected; third amendment regarding the requirement for Assistants for selected offices was Yes=2, No=49, proposal rejected. President Hollien directed that the ballots be destroyed. There being no further business it was moved by Gerald Meeks to adjourn. Motion was seconded and passed. Meeting adjourned at 4:43 pm.
