On July 25th, I wrote an apology to the six members of this committee indicating that, during the past quarter, I encountered an overwhelming series of tasks and the most dreaded of challenges: DEADLINES-- deadlines for my new book, deadlines for chapter revisions, deadlines for "Forensic Files", deadlines for cases, deadlines for presentations and on, and on. Money was/is involved in most instances (and hey, baby needs shoes), personal friendships re: the rest. As of this date, nearly all of the deadlines have been met and the rest are under control. But, once I could attack the Educational Committee issues, it was too late to get closure in time for this meeting. No chance to realize any real progress.

However, the fact that I was not doing my job properly did not mean that the other committee members were following suit.

First off, Saul Montes-Bradley has agreed to a request by the University of Miami to teach a course sponsored by its Institute of Retired Professionals entitled "Founding Fathers". Saul will hit the academic deck on Sept. 12th and we will need to assist him in any way he requests. In any case, our Fall BOM undoubtedly will be spiced by his report.

David Ramseur has had a running (e-mail) dialog with Ralph Ricardo, (State) Social Studies Curriculum Specialist, about the committee which will be formed to evaluate and select the next generation of History textbooks (K-12). Ricardo has promised to keep David current relative to the formation of these History textbook adoption groups. He also has started evaluating several relevant texts and has informed Ricardo about the SAR (Heritage Foundation) history CD's — and offered to provide him with copies.

Compatriot Ed Lake has weighed in with some excellent ideas and very real help to the committee. He has been working particularly with David Ramseur but I and other members of the committee plan to extend this interface during the next quarter. Ed also has organized a communicative link with Dr. James Witt of the University of West Florida (whose philosophy is consistent with ours), with

Pensacola Christian Academy and with A. Beka Books (publisher). He has gotten together with David and has provided him with one of the Beka history texts that he and Dr. Witt found reasonable. As with Ed and David, we will want to take a hard look at A. Beka Books. While this firm may not be one of the "giants" in the textbook arena, it appears worthy of our attention and, perhaps, mutual support.

Phil Ballou has been providing the interface with Jack Bovee who has exploded all over our committee. This gentleman is a long-term educator from Collier County, a past principal and now its K-12 Social Studies Coordinator. He asks for our help re: the history texts as well as getting SB2272 and HR1367 reintroduced during the next legislative session. These bills, which died in the last session, would have required Florida students to be tested (for promotion) on their knowledge of history, civics, economics and geography (as well as the present assessment of mathematics, reading, writing and science). It appears clear that Mr. Bovee will be a great resource for this committee and it is just as clear that we will want to assist him with some of his programs. Thankfully, Phil Ballou has opened a good dialog with him.

Other activities — less dramatic ones — have been carried out also. Included has been the review of the Heritage/NSSAR CD's and a history CD-- a conglomerate-- entitled "The American Revolution and Early Republic as Witnessed by Mercy Warren and Others".

THE FLORIDA SAR ENDOWMENT TRUST FUND

The Endowment Trust Fund was established by the Florida Society of the Sons of the American Revolution, Inc. in 1972. Its purpose is to provide from its annual income, exclusive of capital gains, money to be distributed in support of patriotic, historical, and charitable projects in the year following the year in which the income was earned.

GUIDELINES FOR ENDOWMENT TRUST FUND DISBURSEMENTS AUTHORIZED REIMBURSEMENTS

- 1. Cost of bronze and silver medals to ROTC students and one luncheon expense per recipient.
- 2. Joseph S. Rumbaugh Oration Contest expenses as follows:
 - a. Prize Money \$50.00 1st prize; \$25.00 2nd prize; \$15.00 3rd prize
 - b. Oration Medal One @ \$35.00
 - c. One hotel room for contestant and family member for night preceding FLSSAR contest
 - d. Luncheon for one contestant and one family member at annual award.
 - e. Round trip mileage allowance \$.20/mile if more than 100 miles from contest. Two travel lunches may be added to this allowance.
- 3. Eagle Scout medal and other materials including luncheon for the recipient.
- 4. Florida Society, C.A.R.
- 5. Genealogical and Historical Materials presented to public libraries.
- 6. Expenses incurred honoring veterans' graves and cemeteries.
- 7. Copies of historic documents presented to Public Schools.
- 8. Restoration of historic and patriotic monuments.
- 9. Awards (medals) Law Enforcement, Fire Safety, Heroism, ROTC, Good Citizenship, Eagle Scouts, etc. and one lunch per recipient.
- 10. Knight Essay Contest. Same as for Rumbaugh Oration Contest.
- 11. History Fairs: Limit of \$100.00
- 12. Flag Certificates and presentation folders.
- 13. Engraving Expenses not to exceed \$5.00 per award.
- 14. Liberty Tree not to exceed \$250.00 on a one time only basis.
- 15. Genealogical Workshop limit of \$200.00.

INSTRUCTIONS FOR CHAPTERS SUBMITTING APPLICATIONS FOR REIMBURSEMENT

- 1. Applications MUST be submitted on the approved form with seven copies.
- 2. Chapter should absorb 25% of eligible expenses except for medals.
- 3. Applications shall include expenses incurred for the same calendar year of project or award.
- 4. Any application for eligible reimbursement in excess of \$350.00 shall be submitted by the Disbursement Committee to the next FLSSAR BOM meeting for disposition.

THE FOLLOWING ARE NOT REIMBURSABLE EXPENSES

- 1. Any administrative expenses: postage, telephone, correspondence, etc.
- 2. Frames or framing other than SAR presentation folders.
- 3. Any award or medal to SAR members.
- 4. Any expenses for awards in previous or future calendar years.
- 5. Cost of meals for other than award recipients, except as in Rumbaugh and Knight contests.
- 6. Any awards to animals.

THE FOLLOWING MUST BE APPROVED BY THE BOARD OF MANAGEMENT

- 1. Reimbursement expenses in excess of \$350.00.
- 2. Reimbursement for requests by one Chapter in excess of six in any calendar year.
- 3. Requests for projects other than those listed above under AUTHORIZED REIMBURSEMENTS.

Report of Activities to the Board of Management (date) I 4Ju1y2003

For this quarter, my activities have included: Attendance at the 113th National Congress of the National Society of the Sons of the American Revolution, held in Chicago, Illinois, 05-l0July2003. Activities there:

The turnaround time required remains a serious public relations problem and if there is no improvement in handling, there will be even more justifiable complaints about the genealogy section. These thoughts were passed on by me to the TG elect and the new executive director. Both indicated awareness of the problem and an intention to provide more help for genealogy in order to improve performance and timeliness of handling both new and supplemental applications. NOTE: DAR fees were just raised to \$75 for each and \$10 for a record copy.

Using "Page Maker" publishing software and giving all twenty files to the printer on a CD, makes it easier on everyone. The printer likes it and it seems to have sped up his processing time. Unfortunately, due to backups at the printer, we had to wait until the very last hour of June before the Summer edition was put in the mail.

For the fourth consecutive issue of "The Patriot" activities in every chapter have been included. While this has to be limited to each chapter, the overview of the thirty chapters gives a very comprehensive view of what the Florida Society is doing.

The period of this report is from 4 May through 9 August 2003. Camps were busy during this time with ceremonies and activities during Memorial Day, Flag Day, Independence Day and Allegiance Sunday. In addition, Camps participated in other patriotic and civic events in their localities, and presented patriotic/historical/educational programs to organizations and activities. The Fourth Massing of the Brigade Colors on the evening of the FLSSAR Annual Meeting Banquet on 3 May was very successful. Twenty members of the Brigade participated in the event. The Colors from six of the Camps were presented. Four musket escorts, a drummer, a bagpiper, the Brigade Commander and the Deputy Brigade Commander participated. After the meeting, past FLSSAR President Hodalski informed the Brigade Commander that NSSAR President Aston commented that the performance by the Brigade was as good as any by the NSSAR Color Guard. Those Brigade members participating were from Jacksonville, Clearwater, St.Lucie River, Gainsville, Pensacola, Saramana, Miami, Treasure Coast, and Naples. The Brigade Quartermaster has been busy getting the latest information on where to get uniforms and equipment at the best prices. More information on uniforms will be in the Summer issue of THE FLORIDA PATRIOT newsletter. The venders listings should be ready to send to the Chapters by the end of August. The Brigade procedures page for the FLSSAR Procedures Manual has been completed and distributed to all Camp Commanders. It is requested that all Camp Commanders pass this information on to members of their Camps. Specific activities of the Brigade Camps during this period were as follow:

a. George Washington Camp #1 (Jacksonville), Dick Cardell Commander. On 26 May, five members of the Camp, three in colonial uniform one in Bravo and one in Charlie, participated at Memorial Day ceremonies at the Veterans Memorial Wall in downtown Jacksonville. A memorial wreath was placed by the Chapter President's wife. On 7 June, a Camp member in colonial uniform, representing the Brigade and the FLSSAR, laid a wreath and participated in ceremonies held by the NSSAR commemorating the Battle of Ramsour's Mill at Lincolnton, NC. On 13 June, the three man presentation team in colonial uniform presented THE HISTORY OF THE STARS AND STRIPES program to the residents of Cypress Village in Jacksonville. Over 125 attended the presentation. The program was well received, and the presentation team complemented on its program.

- b. Francis Marion Camp #2 (Ocala), Owen Malcolm Acting Commander. On 26 May, seven members of the Camp, three in colonial uniform displayed the "Avenue of Flags" at Highland Memorial Park Cemetery in Ocala. Assisting the Camp members during the event were two DAR members. Also assisting the Camp members were cadets from the Air Force JROTC unit at Forest High School in Ocala. Over 50 cadets came about 08:00 AM and attached the casket flags on the poles. The sight of over 140 large burial flags flying in the breeze is not easily forgotten. Then at 4:00 PM, the cadets returned, took the flags off the poles, and folded the flags for safekeeping until next year. Over 300 people entering the park during the day were given a small American flag, and donated over \$200 to help defray the costs of the event. Information was available about the SAR, and two men indicated interest in becoming members. For their assistance in setting up the event, the Chapter donated \$100 to the Air Force JROTC unit. The Ocala Chapter has over 200 burial flags that have been donated to the Chapter by the spouses of veterans.
- c. Cape Canaveral Camp #3 (Bravard), Ben DuBose Commander. In April, a bronze medal was minted by the Chapter dedicated to those who lost their lives on the COLUMBIA shuttlecraft. By June, proceeds from the medal sale were enough to pay for the first "Liberty Tree" and a \$1,000 granite marker. Dedication to take place on the 4th of July at the Bravard Veterans Center on Merritt Island. One Camp member in uniform gave two talks concerning the American Revolution, and recruited for new members at interested groups. In May, a member in uniform gave a talk on the American Revolution to an interested group. In June a 5 man color guard in colonial uniform presented the colors at a joint DAR/SAR luncheon. By the end of June 15 JROTC medals were presented eight of which were presented by Camp members in colonial uniform. On the 4th of July, a six member color guard in colonial uniform participated in the Liberty Tree and Marker dedication at the Bravard Veterans Center.
- d. Samuel Adams Camp # 4 (Clearwater), Nelson Jantzen Commander. On 26 May, at the Memorial Day ceremony four members in colonial uniform presented the colors and placed a wreath on the memorial plaque at the Dunstan Church in Seminole, FL. The Camp will post the colors at the BOM on 8 August 2003. Other Brigade members are invited to participate in colonial uniform in the event.
- e. Yorktown Camp # 5 (St. Lucie River), Doug North Commander. On 25 May, during the Memorial Day Program at the First Congregation Church in Port St. Lucie, a Camp member in colonial uniform led the reading at both services. Also on 25 May, at 1:00 PM, two members in colonial uniform acted as the color guard at the Fernhill Cemetery "Parade of Flags Ceremony". On 26 May, two members in colonial uniform acted as the color guard for the United Veterans Program at the Veterans Memorial Park in Port St. Lucie. At the same time, three additional members in colonial were participating in the Veterans Parade in Stuart. On 7 June, two members in colonial uniform participated in the Jensen Beach Elk's Flag Day parade. On 8 June, two members in colonial uniform participated in the St. Lucie Elks West Flag Day Ceremony. On 14 June, two members in colonial uniform participated in the Vietnam Memorial Dedication. An additional five members were in attendance in Bravo uniform. On 6 July, one member in colonial uniform attended the Ft. Pierce Commission Meeting and received the Proclamation for the Constitution Week celebration in September.
- f. Marquis de Lafayette \$6 (Gainesville), Harry Hollien Commander. Five camp members have full colonial uniforms, and five "Ranger" type uniforms are available for other members of the camp. One Camp member and his two children, all in colonial uniform, marched in the 4 July parade in Micanopy. The two children, members of the CAR, rang the town's "Liberty Bell" at the 02:00 PM ceremony.
- g. Nathen Hale Camp # 7 (Pensacola), Ed Young Commander. On 14 June, the Camp color guard consisting of five Camp members, two in colonial uniform and three in Bravo uniform participated in Flag Day ceremonies sponsored by the Scottish Rite in Pensacola. The Camp's participation in the Pensacola 4th of July parade was "rained out".
- h. Nathanael Green Camp # 8 (Saramana), Hal Miller, Jr. Co-Commander. On 9 May, nine members of the Camp color Guard in colonial uniform participated in a two county Massing of the Colors sponsored by the Sarasota and Manatee County's Korean War Commemoration Committees. The ceremony was held in the Faith Alliance Church in Sarasota. The keynote address was given by Eugene Chin Ye who concluded by presenting Freedom Medallions to all Korean War veterans present. On 26 May, the Camp participated in two Memorial Day events. First, a four man color guard in colonial uniform marched in a Memorial Day parade in the heat of the day to J.D. Hamel Memorial Park on the Bay. In the evening a four man color guard in colonial uniform paraded the Colors with four other color guards at the annual Sarasota Concert Band Memorial Day Concert held in Philippi Estates Park. On 14 June, five Camp members in colonial uniform paraded the Colors at the Flag Day Celebration Luncheon sponsored by the Manasota Regents Council FSSDAR.
