FLSSAR STATE OFFICER'S REPORT

National Trustee

Harold (Hal) F. Miller, Jr. August 19, 2005

I know that President Dr. Harry Hollien and Alternate Trustee Frank Hodalski will cover much about our 115th Annual Congress that took place on July 2-6 at the Hyatt Regency Hotel in Louisville. I'll try to cover some points that they might not. Since stepping down as President on April 30th, my only major SAR activity has been my duties as Chairman of the NSSAR Investment Committee, which entailed the preparation and submission of my Investment Committee report.

Before I continue, however, I would like to thank all that participated and /or attended our Annual Spring BOM Meeting for 4/29-30 in Sarasota. Your dedication to SAR made it a success and I'll never forget "Charley's Angels" over a year ago.

At the Congress I was officially elected National Trustee. 225 delegates heard letters of Greetings from Vice President Dick Cheney, First Lady Laura Bush, and Speaker of the House Dennis Hastert. Christine Miller, representing the Mayor of Louisville, proclaimed July 4, 2005, as "SAR Day".

Thank you Frank Hodalski for leading us to a bylaws victory by restoring the ranking of the Vice President Generals to their proper position following the President General.

Three resolutions were passed: **the first one**, recommended by the Maryland Society members, "...support the recommendation that birth certificates of deceased members be made available to the public by stamping them as deceased or otherwise indicating only for genealogical purposes and not usable in any manner to obtain false I.D. while continuing to allow organizations such as ours, genealogists, and the public in general; access to this vital information (congressional public law 108-458). **The second resolution** was recommended by VPG International Ralph Nelson which gives congratulations to the voters and candidates in Iraq. **The third resolution** was a courtesy one from our NSSAR for the hospitality of the city of Louisville and the State of Kentucky who worked long and hard to insure the success of our 115th Congress.

President General Roland Downing appointed a new task force chaired by Ralph Nelson to develop outreach support from our membership by making use of a new educational web site. This will hopefully increase membership as well as financial support for our "Center for Advancing America's Heritage".

During the time period since our last BOM meeting I have communicated with various officers within FLSSAR and with several of our chapters relating to upcoming ceremonial events, new members and other communication relating to FLSSAR committee assignments. President Hollien presented a slide presentation entitled "America's First Captain" and afterward he conducted the installation ceremony for the newly elect 2005-2006 officers of the Jacksonville Chapter.

On Saturday 25 June 2005 I attended the South Florida Packet Workshop of the Florida Society C.A.R., which was hosted by the Swamp Fox Society in Pompano Beach, FL. Robyn Carroll is the newly elected President of the Florida Society CAR and her State Theme/Project is "Making Manatees Count". The project will focus on protecting Florida's manatees by educating the public about the dangers manatees face, and what can be done to keep them from becoming extinct. At our Spring/Annual BOM meeting Patriot Frank Hodalski collected monies

for the purchase of pins that depicts President Carroll's state project. The money raised from the sale of the pins will be donated to the emergency fund at Florida's Homosassa Springs Wildlife State Park.

During the month of July I attended the 115th National Congress of the National Society of SAR. The Florida Society's endeavor to restore (amend Section 2 of NSSAR's Bylaw 14) the office of Vice President General to its previous ranking within the NSSAR was overwhelmingly passed by the delegates in attendance. General: It is clear, as I visited the small chapters in my region, that it is a real challenge for the officers of these chapters, to not only maintain their own chapter business, but to attempt to participate in as many of the FLSSAR and NSSAR defined programs as possible. I personally recognize these hard working individuals, who if they didn't do it, the chapters would probably disintegrate. The four chapters in the NC region, each have on the order of about 40 members, of which usually up to ten (10) assist in the accomplishment of the chapter's business. Attendance during the period just prior to the summer months for these chapters is about 8 - 12! It sure is a pleasure to have the ladies join us with their husbands.

In an attempt to highlight the importance of communications, I have encouraged our chapters to insure that chapter newsletters are sent to the FLSSAR web site and that site information, i.e. chapter officer information is kept current. This is a key activity, which allows potential members to be able to contact the SAR chapter in their region of interest.

Gainesville Chapter

The Gainesville chapter honored a number of JROTC cadets with awards (9), just before the end of the last meeting period. They also make an effort to thank their speakers with speaker recognition certificates. They have recently initiated a Flag recognition program for their community. I have continued to work on archiving our records in a manner that would both safeguard them and make more of the information accessible. At the last BOM, I was granted permission to purchase a scanner to aid in this project. However, prior to that purchase it was necessary to do some ground work with the paper records. The task involved a complete reorganization of the stored applications. Previously they were filed by last name and one drawer of the cabinet was full of applications of members who, at some point, had been dropped from the roles. Thus, it wasn't possible to actually find a member by looking in one place. With some help from students at my high school, every application we have is now filed by state number. The work uncovered many discrepancies in membership numbers that required research to resolve.

The other, related, project has been to enter past members into the database. Compatriot Stevenson graciously sent me all the names and numbers for the FL members #1-500. I've also been plowing through the old 'card' file and entering that data. As of this writing I have 3,063 members entered. That's still a far cry from the 8,679 that

should be there, but it is nearly 900 more than what I reported in May. Compatriot Stevenson has promised to send me additional lists and between those, the card file, and the applications, I've got a chance to recover probably about 90% of our members.

These tasks took much longer than expected and I opted to delay the purchase of the scanner until I was ready to begin the actual scanning. I hope to complete the 'card file' task before the fall BOM and be able to report on the progress of the scanning at that time.

I very much appreciate the suggestions, advice, and encouragement offered by the committee members, the state leadership, and FLSSAR members.

As with the last report, this one also will be structured into two parts. The first will be written by the Chair (Hollien) and will review the Heritage American History program, the distribution of CD's plus related matters. The second part of the report will be written by the Vice Chair (Toops); he will cover our interaction with the Florida Legislature and other relevant groups (such as FASSS). He also will initiate discussion designed to structure a more cohesive organization of our current program.

A. American History (Hollien)

The subgroup responsible for the distribution of the American History teaching aids (i.e., the CD's) continues to be active. For example, as a result of the efforts of Compatriots Grant Wallin and Gene Brown, these materials are now available to every public school teacher in both Pinellas and Pasco counties. In all, 1400 of the 1430 CD's Grant and Gene managed to cobble together have been distributed; 900 to the Pinellas school district plus 500 to the one in Pasco Co. A remarkable feat by two outstanding Compatriots.

We also have requests from other chapters/counties/organizations throughout Florida. An example: Jack Bovee, our consultant from Collier Co. is arranging distribution there. Moreover, we are attempting to obtain at least 1000 more units from NSSAR. In this regard, we are seeking the services of a Compatriot who would kindly be willing to approach Wal-Mart (or some other corporation) for a grant to make additional copies of the CD for our use in the program. NSSAR is having some difficulty raising the funds to make the thousands of CD's necessary and we have no budget to make them either.

Finally, Compatriot Ed Young has provided names and addresses of several Home School organizations. We now are commencing a thrust to provide these groups, and the individual parents, with our American History teaching aids. We believe that this particular effort will garner substantial rewards for both FLSSAR and the home schoolers.

B. Legislative (Toops)

I have held discussions with several key contacts throughout Florida. These have included officials at FASSS and the League of Women Voters (LWV). They both have predicted that there probably will be a delay of a year or two before it will be possible to reintroduce more "Social Studies" legislative bills. For one thing, all of these groups are waiting for the results and recommendations of the relevant FASSS committee meeting(s). However, this conference will not take place until September. Hopefully, the FASSS membership will finalize their position and plans at that time.

I have contacted the appropriate FASSS chairman and have requested that I be placed on their September agenda. I intend to focus my remarks on strategies related to measuring the results from forthcoming legislative sessions. The reason for doing so is because a considerable amount of the "information" we receive is based only on "hearsay" rather than on solid facts. Finally, I have just received an e-mail from the FASSS chair inviting me to attend the September meeting; it also states that I will be given time to address this meeting. I plan to attend.

The first quarterly meeting of the new year provides an opportune time to take a fresh look at our charge as a committee, and to look at some of the ways we can realistically support our national library resource.

The National Society is in the midst of a capital campaign to fund the library and museum expansion. This is certainly one area in which we can encourage FLSSAR and the local chapters to assume a more direct responsibility for fund-raising. We may want to discuss possible formula approaches such as so much per member for one time or ongoing contributions. Individual members should be reminded that contributions are tax-deductible, and that there are a variety of permanent memorial options available to donors.

We are very fortunate in having an outstanding, professionally managed library collection in Louisville. The library has been online since 1999, thanks to dedicated staff and an outside contractor, the Library Corporation, located in West Virginia.

Although the NSSAR Library has only a fraction of the resources of its' sister genealogical resource centers, the DAR Library and the Library of Congress, it is a vital part of our national genealogical heritage, along with other genealogical resources throughout the country

A major activity that we could undertake this year would be to initiate a cooperative NSSAR Library effort with other State Societies, in association with the National Society Library Committee. The objective would be to enable the NSSAR Library to join OCLC, the largest library consortium in the world. Funding could be shared by the National Society, the State Societies, and our international chapters.

OCLC is a consortium of almost 54,000 libraries in 96 countries and territories. Located in Columbus, Ohio, it provides a variety of library products and services, not least of which would be **local, user-friendly access to worldwide information resources for our members.** Cost-effective benefits would include full-service online cataloging, collection development and management tools, assistance with digitization and preservation, enhanced electronic collections and access to full-text materials, and reference partnerships with other special collection libraries, including the Library of Congress. OCLC promotional literature will be available at the BOM meeting on August26th.

Appendix A

Pensacola Chapter Spearheads Effort to Mark Historic Washington Family Grave

Colonel (USA Ret) George Willis Tate

Odd as it seems, a member of the esteemed family of George Washington has lain in anonymity in Pensacola for over 170 years. Mary W. Willis (nee Lewis) was the granddaughter of George Washington's only sister Betty, and died of yellow fever in Pensacola October 7, 1834.

Chapter member Colonel George Willis Tate is her great great great grandson and heads a committee of the Pensacola Chapter to memorialize this most historic American. It was his research for a forthcoming book which identified this long-lost grave.

Tate reports that "Byrd Charles Willis and his family were wealthy landowners with strong political leanings in Virginia, but financial reversals led him to look southward to the Florida territory for new opportunities. Having helped Andrew Jackson gain the presidency, Jackson reciprocated by appointing Willis as his agent at the newly established Pensacola Navy Yard. Willis himself was the great grandson of George Washington's father Augustine, while his wife was the granddaughter of Betty Washington, George Washington's only sister."

"Mary Willis' father was Major George W. Lewis and had the distinction of commanding George Washington's Lifeguard during the Revolution. But for his actions, the great Washington might not have lived to become our first President." said Tate.

Mary W. Willis was originally buried in a private Pensacola cemetery, but in 1899 was re-interred, along with several of her children, in the city's historic Saint John's Cemetery in Lot 23, Section 19, Block 2 North. Mary Willis's stone at that site was made of sandstone and has weathered away into illegibility, but the Pensacola Chapter plans to remedy that when they re-dedicate a new memorial to this historic figure on All Saints Day, Nov 1, 2005, at 1030 AM. Governor Jeb Bush and other VIP's have been invited.

"In addition to these ties to the family of George Washington, this lady was the mother of another famous Floridian, Princess Catherine Willis Murat of Tallahassee. Emperor Napoleon III brought her to France and made her a member of his court. And her mother in law was none other than Napoleon I's sister, Caroline, wief of King Joachim Murat" "It doesn't get any more historic than that" said Tate.

Pensacola Chapter's former president Lonnie Jones frets that they are several hundred dollars short of their fundraising goal for the historic marker for this Washington Family grave. "Compatriots throughout Florida are urged to give us a hand if they're able so we can properly honor this lady who was so closely affiliated with the Washingtons and with the American Revolution." Summer Board of Management Meeting

August 26 – 27, 2005, in Lakeland, Florida

The meeting was called to order by President Harry Hollien at 910 p.m., Friday, 26 August 2005. Chaplain Charles Schafer gave the Invocation. The Pledge of Allegiance was led by Senior Vice President Lindsey Brock followed by the SAR Pledge led by Recording Secretary George Lockhart. The American's Creed was led by Secretary Kevin Yarnell. There were no National Officers present. President Hollien introduced former Vice President General, South Atlantic District, Ron Hamilton. First time attendees were introduced and included Alvin Bellamy (Pensacola) and Jack Bolen (Tampa). Secretary Kevin Yarnell certified a quorum was present. It was then moved by Ed Young and seconded by Grant Wallin that the minutes of the last meeting be approved as printed in the last issue of "The Florida Patriot". The motion passed. Reports of National Officers were called. There being none, reports of National Committee Chairmen were called. Ron Hamilton, Vice Chairman of the National ROTC and JROTC Committee thanked the membership for supporting the unfunded JROTC program. Reports of the National Trustee, State Officers and State Committees were called. Those reports are found in the Quarterly Reports which are made a part of these minutes, along with additional remarks and reports. Ron Toops, North Central Regional Vice President commented that his region has many small chapters (less than 40 members) of which 8 to 10 are able to run the affairs of the chapters. This makes it difficult for them to support many of the State and National Programs. Sergeant-at-Arms, Lonnie Jones reported that the State Flags had been carried to Alabama to participate with other state societies in the Armed Forces Day Blue Star Salute. The Editor, "Florida Patriot" Saul Montes-Bradley reported that it takes about 6 weeks to get the "Patriot" prepared, printed and distributed. He set September 5th as a deadline for materials to be submitted to him in order for the "Florida Patriot" to be in the hands of the membership prior to the Fall Board of Management meeting on October 28th and 29th. President Hollien took issue with the 6 week period and indicated that he would talk to Saul following the meeting. President Hollien then reported on the Executive Committee meeting. The President of the Flagler Chapter, D. J. Kelsey, suggested a change in the National bylaws to allow a membership category that would handle eligible members who have been killed while serving on active duty. William Stevenson moved that the Flagler chapter be allowed to proceed with a possible National bylaw change to allow a membership category that would handle eligible members who have been killed while serving on active duty. Motion was seconded by Ed Young and approved by the membership. President Hollien brought from the Executive Committee a motion concerning funding of overseas JROTC awards. Currently the National Society has no funding to provide medals to the units overseas. A plan was announced whereby state societies would adopt two overseas units. Compatriot Stevenson moved to support two overseas units at a cost of approximately \$32.00 with the understanding that if the George Washington Trust Fund opted to fund these units, this motion would be void. Motion seconded by Grant Wallin. Motion passed. President Hollien reaffirmed that the Planning Board had been reinstated. He plans to initiate a Program Committee to focus on speakers and kinds of programs for the Board of Management meetings. Will be looking for state and nationally recognized speakers. Discussion followed on kinds of speakers and having the media in attendance. Ben DuBose stated objection to asking people running for office as speakers. Secretary Yarnell reported that he had certificates for the chapters to pick up. He also stated that he had the new state stationary available for those who

may need some. National Trustee Hal Miller mentioned that the Chapter Challenge requirements had been revised to better account for the wide range of chapter sizes. Smaller chapters will be better able to compete. Dick Fowler commended Kevin Yarnell for his outstanding work in getting together the credentials for delegates to National Congress. President Hollien, Chairman of the Education Committee discussed the highlights of the committee activities as presented in the Quarterly Reports. Secretary Yarnell asked one of the National Delegates about where we could find the name of the winner of the Knight Essay Contest. Compatriot Hodalski stated that it should be in the National Program Booklet. Doug North updated the Good Citizenship report with additional activities by Pensacola, Escambia, Pinellas and Pasco counties schools. He announced that he would be bringing 1500 certificates to the next morning Board of Management meeting. Frank Hodalski, Chairman of the History Fair Committee, reported that he had discussed the program with the Regional Vice Presidents at their meeting during the morning. At that meeting it was discussed that the Chapters need a "How-to-do-it" booklet. Compatriot Hodalski reported that the State's Rumbaugh Orations contest winner did an outstanding job of presenting his oration at the National Congress. He felt that the orator's subject matter may have impacted on his winning. Ted Duay, Chairman of the Rumbaugh Orations Contest Committee reported that he is in the process of putting a committee together. Senior Vice President Brock reported that the Law Enforcement, Fire Safety and Heroism committee has added a fourth category. He said that new forms were available. He also reported that National is looking at changing the name of the committee to something like Community Service Awards Committee. More information will be forthcoming. Gene Brown, Chairman of the Liberty Tree Committee added to his report that the Miami Chapter will be planting a liberty tree on 9/11 at Coral Gables. He also added that a number of chapters have planted a 2nd or 3rd liberty tree but may not have notified the committee. He will be putting out a letter asking all the chapters to update the committee on their liberty tree plantings so the committee will have a better record of plantings that have taken place. Al Snapp, Chairman, Meeting Arrangements – BOM Committee reported that a date and host chapter for the next BOM meeting were needed. President Hollien indicated that Palm Beach Chapter would host the Winter meeting but he was still looking for a volunteer for the Fall meeting. Compatriot Snapp suggested that some chapter take all the hospitality provisions as Lakeland Chapter did not have any storage room. Ed Buckley from the Palm Beach Chapter will take all the hospitality provisions. Bud Casey, Chairman, Newsletters and Periodicals Committee requested that an Ad Hoc Committee be established to judge the newsletters. The following were appointed: Carl Hoffmann, Frank Hodalski, and Lindsey Brock. President Hollien reported that the Public Relations part of the Publicity Committee had been moved to the Public Relations Committee with the Publicity Committee retaining the Earl Marlin portion. He also reported that the Chairman of the Veterans Affairs committee Lani Wingate had resigned due to his wife's illness. President Hollien will be appointing a new chairman. The meeting recessed at 10:35 p.m. with a poem titled "Just a Common Soldier, A Soldier Died Today" read by Compatriot Stevenson. The meeting will reconvene at 9:00 a.m. Saturday morning.

The Summer Board of Management meeting reopened at 9:05 a.m., Saturday, 27 August 2005. President Hollien asked if there were any first time attendees. Raymond Davis (Gainesville) stood to be recognized. President Hollien stated that the Board was still on Committee Reports. Blue Star Salute – Chairman Dick Cardell was not present so President Hollien announced that the State had received a citation from National. In addition, three chapters received certificates.

They were Pensacola, St. Lucie River and Jacksonville Chapters. Commemorative Historic Sites Chairman, Fred Gaines, Jr. reported that we do have some activities with our members going to other states to participate in their events. Working with Senior Vice President Lindsey Brock they are hoping to get a celebration somewhere in Florida and are working on it. He did mention the grave marking in Yulee on 1 October 2005. Ben DuBose mentioned that Cape Canaveral was the site of the last naval battle of the Revolutionary War. He said there is already a marker there probably placed by the county. He suggested that we may want to consider placing an SAR marker there as well. He will work with Fred Gaines on this. President Hollien, Chairman of the Honors Council stressed that this is a very important to recognize very important members who can no longer be active in the affairs of the state and chapters. Frank Hodalski has come up with a plaque for each member. Nomination forms have been given to the Regional Vice Presidents for further distribution to the chapters. This form must be back to the chairman by the Fall BOM meeting. Recommendations for 5 Honor Council Fellows will be made at the Winter BOM meeting. Those Fellows will then be recognized at the Spring BOM/Annual Meeting. President Hollien announced that the Planning Board has been reformed. It has committee members, but no chairman at this time. By the Winter BOM meeting it should be fully functional. Dick Fowler, Chairman of the Procedures Manual Committee reported that hard copies of the manual had been handed out at the Spring BOM meeting. Kevin Yarnell has marked up a hard copy. Dick solicited comments or changes from the Board. President Hollien strongly recommendation to the Procedures Manual committee that they set up rules to send to the committee chairs as to how they are to establish their sections/instructions in the manual. Ben DuBose, Chairman of the Public Relations Committee gave his report. The focus of the committee will be to create and package various programs that will become available to all state chapters for distribution to the local mass media, with the aim of getting the SAR some statewide attention. He proposed to do this by creating daily 60 second Public Service spots that a local radio station could present. He played a tape recording of some Public Service spots titled "KEYHOLE TO HISTORY". Each spot presents a historical event to coincide with the day the spot is being played. The committee will create weekly spots based on the Revolutionary period. They will be produced at a local college with music and possibly sound effects. Tapes will be packaged with fifty-two spots, one for each week of the year, and made available to local chapters to distribute to their home town radio stations. His plan is to hit the airways by the summer of 2006. They are looking for volunteers to help with this effort. Newell Kellogg, Chairman of the Operating Budget Trust Fund Trustees and Chairman of the Endowment Trust Fund Trustees handed out the Treasurer's report. He commented to the President that minutes of the last BOM meeting had stated that only one half of disbursements authorized by the Endowment Trust Fund Disbursements Committee would be made. He stated that this was not happening. As of June 31, 2005 the Fund had \$3,555.23 for disbursement. As of July 31 that figure is down to \$742.00 which means that there will be a shortfall as we experienced in 2004. He stated that the trustees will comply with the statutory requirements of the State of Florida relating to accounting of trust funds. The State requirements are very specific. Sam Boone indicated that he and the ETF Review Committee would have the accounting report (with recommendations) ready for Fall BOM. Compatriot Kellogg then asked if there were any questions. There followed a short discussion of the \$13,328.89 Cash in Escrow Account and the distribution of investments. The issue of payment of only half of the amounts approved by the Disbursements Committee was raised with considerable discussion. The result was a motion by Frank Hodalski that a letter from the President to the Trustees and the chairman of the

Disbursement Committee clarifying the policy adopted at the 2005 Annual Meeting to pay 50% of approved requests from the Endowment Trust Fund. Specifically, this would mean that the Disbursement Committee would approve the application and then instruct the treasurer of the trustees to pay 50% of the approved amount. Motion was seconded by William Stevenson. Discussion followed. Question was moved by Carl Hoffmann, seconded by William Stevenson. Motion on the question passed. Then the motion by Frank Hodalski was voted on and passed. Sam Boone reported that he had received the audit report from Michaelson & Co., P.A. Based on their review, they were not aware of any material modifications that should be made to the financial statements in order for them to be in conformity with generally accepted accounting principles. President Hollien called for any unfinished business. Carl Hoffman elaborated on the process of getting a tax exempt certificate. If chapters have any questions they can talk to him or the Regional VP's who have the information. He also reminded the group of the grant money available through Wal-Mart. Bud Casey initiated a round of applause for the efforts of Compatriot Hoffmann. Frank Hodalski mentioned that the Saramana Chapter got a \$2000 grant from the National Rifle Association to purchase replica muskets. Under new business Compatriot Hodalski reminded the President that appointments for the Nominating Committee were needed before the end of the BOM meeting. Hal Miller, Jr., Ed Young, William Stevenson, John Little and Dick Fowler were appointed by President Hollien. Other new business – Carl Hoffmann commented that the Florida Society should be proud of the actions of their representatives at National Congress. He discussed what actions took place and stated that President General McCarl thanked Florida for pushing actions through Congress. President Hollien recognized past Vice President General Ron Hamilton for the excellent job he did in that postion. Ron received a round of applause. Frank Hodalski thanked Kevin Yarnell for putting the chapter officer information in the Quarterly Reports booklet. Al Snapp reminded the group that Jim Randall will be with us in October. Following the Compatriot Fund distribution, Sam Boone led the SAR Recessional and Chaplain Charlie Schafer gave the Benediction. Meeting closed at 10:45 a.m.
