My activities since my last report of 23 April 2006:

28 April 2006- Appointed Chairman Patriotic Activities Committee + 9 members - Many emails

12 May 2006- Saramana Chapter SAR luncheon meeting

24 May 2006- Saramana Chapter SAR Board of Governors Meeting

29 May 2006-At 10:00AM, I participated as one of five compatriots in our Nathanael Greene Camp # 8 Color Guard in the Sarasota Memorial Day parade, about a mile and a half to J. D. Hamil Memorial Park. The summer heat was too hot for that distance. The other four marchers were: Bradley, Hodalski, Tarpley, & Riegle Later on at 6:00PM, I again participated in this same color guard as one of four compatriots. The crowd at the Phillippi Estate Park was a little smaller than usual due to the heat, about 700. The program began with the Presentation of the Colors. Our Color Guard, which was recognized as a participant in the program, consisted of 4 members; Bradley, Crandall, Miller & Riegle. We were joined by three other Color Guards: the Sarasota Military Academy, the Sarasota Fire Dept. representing the DAV Post 97, and Glen Peters American Legion Post 266. The Memorial Day Address was given by Captain Robert O'Neill, USN Ret., followed by the Sarasota Concert Band presentation of "An American Salute".

31 May 2006- After email correspondence with Florida Governor Jeb Bush on March 9<sup>th</sup> requesting the State to commemorate the 100<sup>th</sup> Anniversary of the signing by Compatriot President Theodore Roosevelt on June 9, 1906, of the Congressional Charter of the SAR, I received on May 31<sup>st</sup>. the formal Proclamation which extended his greetings and best wishes to all observing June 9, 1906, as "Sons of the American Revolution Day in Florida". . I was allowed to read it at the public meeting of the Sarasota Board of the County Commissioners on June 6th. It was then presented personally to Lindsey C. Brock, President of the Florida Society, SAR. This was accomplished after the Sarasota Board of County Commissioners presented a similar Proclamation to the acting President, VP Phillip H. Tarpley, of the Saramana Chapter SAR who accepted it on behalf of all its members. Other members present were Donald H. Bailey Sr., Eugene L. Bradley, and Hal Miller. All SAR participants were dressed in their colonial alpha uniforms at the Sarasota Board of County Commissioners semi-monthly meeting.

17 June 2006- I was one of two Color Guard members that paraded and posted The Colors at the Flag Day Celebration Luncheon sponsored by the Manasota Regents Council NSDAR and hosted by the Myakka Chapter NSDAR, held at the Venice Yacht Club.

8-12 July -116<sup>th</sup> Annual Congress –Dallas, Texas, @ Intercontinental Hotel-Attendance 466-which included guests of 182. During the Presentation of Gifts at our 2<sup>nd</sup> Session our delegation of 14 donated \$700.00 which together with our State's carry over of \$300.00 from our last BOM Meeting totaled \$1000.00. This allowed us to again add to the Endowment Fund of the NSSAR JROTC COMMITTEE. Considering that we are and have been involved for some time in "World War III", we need to increase this amount and make every effort to have all other State Societies follow our lead.

As Chairman of the NSSAR Investment Committee, my annual report was submitted and can be found on page 66 of the NSSAR "Officers & Committee Chairmen Reports" Booklet. Correspondence regarding the report was by email to my two members. Also as a member, I attended the National Finance Committee and the George Washington Endowment Fund Distribution Committee. Emails sent to both Chairmen.

### FLSSAR STATE OFFICER'S REPORT President

It has been an exciting and rewarding experience serving as President of the Florida Society and I look forward to the remaining months of my tenure. My first official duty as President was installing the newly elected officers of the Pensacola Chapter on May 13, 2006. While in Pensacola, Ed Young, Commander of the Sons of Liberty Florida Brigade and I visited the site of the Revolutionary War "Battle of Pensacola". Preliminary plans are under way for the Florida Society to place a State of Florida Historical Marker at that Revolutionary War site. The highlight of my visit to the Pensacola Chapter was participation in presenting, posting and retiring the colors at the USS Oriskany's retirement ceremony on Saturday evening May 13<sup>th</sup>. Participation in this ceremony was very likely a first for the Florida Society or any other organization to be given the sole honor of presenting, posting and retiring the colors at a U. S. Military ceremony. According to many active duty and retired military personnel this honor is usually given to only active duty military units. A future article written by Mark Kilgore of the Pensacola Chapter will be in a forthcoming issue of the SAR Magazine which will provide details relating to the ceremony and the intentional sinking of the USS Oriskany which became the world's largest artificial reef off the coast of Pensacola.

Ray Osborne a Florida Historian extended me an invitation to attend and speak to those attending a local history and arts seminar at the Eau Gallie Library in Melbourne, FL on May 20<sup>th</sup>. This forum provided the opportunity to talk about the Florida Society and the National Society of SAR. However, my primary presentation focused on Captain John Barry and the last naval action of the American Revolutionary War that occurred south of Cape Canaveral, FL on March 10, 1783. There were approximately 65 in attendance at the meeting and all were pleased to hear that the Florida Society will be conducting a ceremony on March 10, 2007 to commemorate this last Revolutionary War naval battle and that the Florida Society will also be placing a State of Florida Historical Marker at Cape Canaveral. Attached to this report is a local newspaper article written by Tom Breen of Florida Today which was published after a phone interview between Tom and I prior to the meeting on May 20<sup>th</sup>.

Hal Miller, VP Phillip Tarpley, Donald Bailey, Eugene Bradley of the Sarasota Chapter and I attended the public meeting of the Sarasota Board of County Commissioners on June 6<sup>th</sup>. The Commissioners allowed Hal Miller to read the Proclamation from Florida's Governor Jeb Bush in which he extended greetings and best wishes to SAR in celebration of our 100<sup>th</sup> anniversary on June 9, 2006. The Sarasota Board of County Commissioners also presented the Florida Society a similar Proclamation at this meeting. Hal and I extended our appreciation to the Board for allowing us to speak before the Commissioners and be a part of its June 6<sup>th</sup> meeting. The meeting was televised on a local TV station so FLSSAR received some positive PR in the Sarasota area.

My wife Billie and I along with our two grandchildren, Connor and Caitlin, participated in the wreath laying ceremony at the Battle of Ramseour Mill in Lincolnton, NC on June 10th. Connor and Caitlin laid a wreath on behalf of the Florida Society C.A.R, Billie's wreath was for the Florida Society DAR and my wreath was on behalf of the Florida Society SAR. At this ceremony I was given the opportunity to announce the upcoming March 10, 2007 ceremony at which the Florida Society will commemorate the Last Naval Battle of the American Revolutionary War at Cape Canaveral.

On June 21<sup>st</sup> it was my privilege to attend the monthly meeting of the Ocala Chapter. At that meeting I was given the opportunity to bring greetings and tell the membership about current events happening at the FLSSAR and NSSAR level. I am pleased to report that the Ocala Chapter, under the leadership of President Warren Page, continues its tradition of carrying forth the goals and objectives of FLSSAR. The Ocala Chapter was successful in obtaining four resolutions commemorating the SAR upon celebration of its 100<sup>th</sup> anniversary on June 9, 2006.

The Florida Society had fourteen members in attendance at the 116<sup>th</sup> Annual Congress of the National Society which was held in Dallas, Texas July 8 -12, 2006. In addition, seven members of the Florida Society's Ladies Auxiliary were also in attendance. The Texas Society received many accolades for the great job in hosting the 116<sup>th</sup> Annual Congress in Dallas.

The Florida Society received the following awards at the 116<sup>th</sup> Annual Congress:

**C.A.R. Activities Award**. This award is presented to the State Society which has documented their work with the Children of the American Revolution over the past year.

**Col. Theodore Roosevelt, Jr. Certificate of Recognition.** This award is presented to the State Society for their participation in the 2006 Partners in Patriotism Program of the Sons of the American Revolution and the American Legion to honor the men and women who served at home and on the battlefields during World War II.

**Officers Attendance Award.** This award is presented to the State Societies whose President and National Trustee have attended both preceding Trustees meetings and the last Annual Congress.

**The Certificate of Distinguished Service** was present to Billie and Lindsey Brock for assisting the President General during his travels during the past year.

The Liberty Medal Award was awarded to nine members of the Florida Society.

#### **Other Activities Of The President**

The Princess Malee Society held its annual installation of new officers at the home of Mrs. Molly Knight on Sunday May 7<sup>th</sup>. At this meeting it was announced that the Princess Malee Society, which is the local Jacksonville Society of the C.AR., was honored as the Most Outstanding Society in the nation at the April 2006 National Convention held in Arlington, VA. The N.S.C.A.R currently has over 10,000 members and approximately 529 local societies throughout the nation and being named the **Number One** society in the nation was a great accomplishment by the Princess Malee Society.

Four Jacksonville Chapter color guard members, Commander Dick Cardell, Loyd Puckett, Steve Owens and I attended the annual Memorial Day ceremony at the Memorial Wall in downtown Jacksonville on May 29<sup>th</sup>. Special wreaths were laid in honor of those who gave the ultimate sacrifice while serving our country in Afghanistan and Iraq. Two additional names were added to the memorial wall who also gave the ultimate sacrifice while serving our country in the Korean War. When additional names are discovered their names are added to the wall, hence the reason for the addition of the two Korean War names being added at this years' Memorial Day Service. Other patriotic organizations such as the American Legion and numerous veterans groups, such as the Northeast Florida Veterans Council, of which the Jacksonville Chapter is a member, were also in attendance.

Three Jacksonville Chapter color guard members, Commander Dick Cardell, George Lockhart and I attended the annual Memorial Day Parade and celebration at Jacksonville Beach, FL on July 4<sup>th</sup> to pay tribute to our active duty and retired military men and women. The Jacksonville Beach Color Guard members and other patriotic organizations were also in attendance. The Jacksonville Chapter's color guard was given the honor of being the lead color guard unit in the parade.

David Ramseur and I along with two members, Sara Benzel and Alice LeGrand, of the Amelia Island Chapter of DAR, attended the Naturalization Ceremony at the Federal Courthouse in downtown Jacksonville, FL on July 20th.

On August 12<sup>th</sup> I attended the Florida Society C.A.R.'s Northeast Florida Packet meeting at the home of Caitlin and Connor Brock. The state theme, "The Wild Wild East" features Florida's Frontier Heritage and studies all aspects of Florida's frontier heritage from the first contact by the Spanish to the closing of the open range in 1949, as well as modern day cattle ranching in Florida. Funds raised for this project will be given to the Florida Cracker Cattle Association to produce a new brochure to inform the public about the Cracker Cattle Breeding Program and encourage cattle-raising families to continue their involvement with this program.

Lastly, on Saturday August 19<sup>th</sup> the Jacksonville Chapter SAR and the Princess Malee Society C.A.R. held a joint flag retirement ceremony at the Brock's home on Little Marsh Island. There were approximately 35 flags that were retired at the ceremony.

One of the frustrating things about being the Editor and Webmaster of the Florida Society has been the minimal amount of feedback. I always have mixed feelings about the lack of feedback. It is good NOT to have feedback from the standpoint that this is a sign that not too much is wrong. It is BAD not to get feedback because you are not telling me what you would like to have improved in the format or content of the website or the *Patriot*.

Recently I developed a new way of gathering survey information electronically, and I plan to use that method in the future to canvas the membership to get their feelings on specifics. For example, one of the things I would like to know is whether members like having the pictures of the BOM meeting in the magazine. (Incidentally, the BOM pictures in the Summer edition were supposed to have been in color. I will make that clear to the publisher so that in the next edition the center fold will ALWAYS be in color, and color used on some other pages will be in black and white).

I will soon initiate a survey of those members with email addresses to gather this information electronically. That is another reason why it is important to have as many members' email addresses as possible. It may not be a scientifically accurate survey, but it should give a pretty good indication of how members feel. The survey will utilize the Website Traffic report. As questions appear on the report, individuals will click on their answer to questions. Each answer will be on a separate web page. The website traffic report will show the number of times each page was "hit." It will also be possible to limit the number of hits per respondent to ONE only answer to each question.

Communication is important in every organization, and we want to do everything possible to use the best means available of exchanging ideas. One of these tools is *FLATALK*, which is a list-server that allows for the free exchange of ideas between members of our society. Sam Boone (Gainesville) is working to revitalize *FLATALK* and bring it back to its former level of excellence

### FLSSAR Committee Report Education Committee

Summer, 2006

This report will be in three parts. The first will cover the American Heritage History CD's and the reporting problems being faced. The second will address the need to establish communication links with Home School Societies and the third, the questionnaire sent all FLSSAR members in the Spring issue.

1. The American History CD's. As can be seen from a review of Appendix A, 5,541 units have been obtained and, all but 241 have been distributed to the Regional Vice Presidents. As far as can be determined, about 3,984 have been placed into the hands of Public School Administrators, Social Studies Supervisors, History teachers and other relevant individuals. Accordingly, over 1,557 appear to be unaccounted for. The best performance has been by the West Central Region where Grant Wallin and Gene Brown have placed 1,500 CD's with teachers in two counties. The best reporting has been by the North East Region where all the chapters reported either in 2005, 2006 or both. The poorest were the South East Region (where only one chapter -- Palm Beach -- responded to requests and/or distributed any CD's) and the East Central Region (where it appears only 10 CD's have been distributed). In any case, and as can be seen from the Appendix A schedule, less than half of the FLSSAR chapters are participating at any level and indeed, over one-third of the chapters (N=11) did not respond at all. The Regional Vice Presidents will need to address this problem as at least another 5,000 will have to be distributed if each of Florida's History teachers is to receive one. Moreover, while responses from the recipients are greatly desired by NSSAR, TSSAR and the Heritage Foundation few have been received.

- **2. Home Schools.** Attempts are being made to set up a link between FLSSAR and the Home Schools. Since it would be financially impossible to mail a CD and pamphlet to each Home School teacher we identify, attempts are being made to develop a conduit to them via their societies. Of course, any chapter willing to do so could distribute them locally -- as have the Pensacola chapter which has delivered over 100 and the Emerald Coast chapter where members have delivered a whopping 575 CD's to home schoolers. However, this type of effort probably is unrealistic for most chapters. In any event, the letter being sent to the Home School Societies can be found in Appendix B.
- **3. Survey.** The BOM approved funding for a questionnaire to be sent to *all* members last January. The purpose of the survey was to query the 1,500 or so FLSSAR members who are not active at the State level in an attempt to assess their concerns and felt needs about our Society. The questionnaire went out in the Spring issue but the short announcement about the reason for the project, its description, instructions and so on was not published by the 2005-6 Editor. Unbelievably, neither were these instructions, nor related materials, published by the current Editor in the Summer issue. The undersigned finds it difficult to believe that he has received 134 responses *anyway*. However, a number of communications (a couple rather pointed) have been received asking questions about the questionnaire and/or complaining that no justification or explanations were provided. Hence, the money appropriated by the BOM has been pretty much wasted as those Compatriots that we most need to contact (and have respond) are the very ones that, *again*, are least likely to participate. Accordingly, the undersigned requests that the BOM permit him to include the explanations/instructions found in Appendix C in the next issue of the Patriot.

#### Appendix B. FLSSAR letter to Home School Societies

Dear:

Enclosed you will find a copy of the American Heritage teacher's aid to Colonial History (a CD plus a pamphlet) being produced by the Florida Society of the Sons of the American Revolution (FLSSAR). There is no charge for this or for any subsequent copies.

These materials were developed by the National Society of the Sons of the American Revolution (NSSAR) and the American Heritage Educational Foundation, Houston Texas. They are organized (individually) into sections for elementary, middle and high school students. As would be expected, the focus is on American History -- especially on the formation of our country, the Declaration of Independence, the U.S. Constitution, our Founding Fathers and similar events/issues. Included are lesson plans, references, games and related materials. The themes involve Freedom, Unity, Progress and Responsibility.

Our Society (FLSSAR) is attempting to place one of these CDs in the hands of every Floridian responsible for teaching American History, Civics or Economics. So far we have provided nearly 5000 of them to teachers in the public schools and several hundred to others in private schools. On the other hand, only a few have gone to homeschool teachers -- primarily because we have not yet been able to establish links with Home-School Societies such as yours. It is in this regard that we are contacting you.

May I reiterate. There is no charge for these teaching aids -- i.e., either the CDs or the pamphlets. Our only problem is physically getting them to the individual teachers. As you can imagine, mailing a unit to each teacher (even if we had their addresses) would be quite costly, and, while there are 1700 SAR members in Florida, it is a cost greater than we can handle (we are all volunteers). What we wonder is, if we ship you an appropriate number of these CDs, could you include one in each of your routine mailings to your members. An alternative would be to give you and/or the teacher/parents permission to burn copies for your/their use. The only restrictions here would be that they could not be sold and their source -- the SAR -- would have to be referenced. Note also the questionnaire on the last page of the xeroxed pamphlet. We also would request, that any parent or teacher who uses these materials complete one and send it to me.

The pamphlet and the CDs themselves provide additional information about this program. We believe it to be an important one relative to enhancing an awareness about our heritage and the bases upon which this great country was founded. Further, we believe that the materials contained in the CDs can be of particular aid to homeschoolers. Hence, we hope to work with you on this significant project. A new publication, *Four Battleflags of the Revolution*, is a very high-quality catalog of the Sotheby Auction on June 14, 2006, of the four battleflags captured by Lt.-Col. Bonastre Tarleton in 1779 and 1780. They were sold to an anonymous bidder for more than \$17 million. The catalog itself contains outstanding color plates of the battleflags and related documents, as well as a recounting of four major actions: Pound Ridge and Bedford, NY (2 July 1779), Waxhaws, SC (29 May 1780), Camden, SC (August 1780), and the Battle of Cowpens (17 January 1781).

Many FLSSAR chapters were successful in obtaining Charter Centennial Proclamations from their local counties and municipalities. **Report and Recommendations:** The NSSAR Executive Committee, by motion, approved an FLSSAR pilot program of 52 weekly public service announcements dealing with Revolutionary War period history. The FLSSAR Public Relations Committee began work immediately, with a target date of 01July2006 for completion of production. The Broadcaster's Club of Sarasota, a group of current and retired broadcast and media professionals living in the Sarasota/Manatee county area, agreed to join with the Florida Society in producing the PSAs. An outline presentation of the proposed Public Service Announcement project was made in January and, after review and editing by Bill Stevenson, a complete set of 52 scripts was given to the president and program chairman of the Broadcaster's Club. Further editing was necessary, due to the length of the story-line portion of the scripts. Each ran between 55 and 58 seconds, leaving little or no time for intro and tag. A standard introduction and two tag versions were used, allowing each segment to finish under the one-minute limit with minimal alteration of the script. Further editing, other than pacing of the delivery, was done as necessary by the narrators to maintain the one-minute time limit. The project was discussed informally before and after the April meeting of the Broadcaster's Club. Mr. Don Blair, Broadcaster's Club program chairman, put together a team of three broadcast professionals, including him, to do the recording. Mr. Blair persuaded Michael Moody and Clear Channel radio of Port Charlotte to join the project. Mr. Moody donated the studio time that allowed us to record, edit, and produce a series of vignettes which satisfied the professionals. A Fife and drum corps cut was selected and added under the narration as an authentic background for the production. To date, four radio stations have verbally agreed to run the spots, and they are already being heard several times a day in the Sarasota/Bradenton market on 1220 AM. We plan to offer them to public and private schools for use as announcements, and/or in the classroom. Home schooling organizations may also be included.

The recording and engineering phase of the project was completed ahead of schedule. We have 250 CDs in jewel cases ready for distribution to FLSSAR chapters at the August Board of Management meeting. The graphics on the CD and jewel case labels, depicting Washington's crossing of the Delaware, were designed by Compatriot Francis X. Hodalski, and read as follows:

# **FLSSAR Report Sons of Liberty Florida Brigade**

The period of this report is from 30 April 2006 through 26 August 2006. # Proposed Pilot Program For FLSSAR Middle School Youth Outreach

With the exception of the Good Citizenship Certificate awards, which are unique to the Florida Society, neither the national society, nor any other state society that we know, offers any program aimed at the middle-school or junior high school grade level. We propose to develop and promote a youth outreach program emphasizing scholarly research and original writing by the student. It would feature an essay of 500 to 750 words on a specified colonial or revolutionary war topic, utilizing the same primary and secondary research methodology used in history fair entries. The program could easily be funded and put in place.

- Funding: 20 of 29 chapters donating \$30 each for a prize pool of \$600 or by an FLSSAR grant of \$600 from the operating budget. This would provide an award structure of \$300, 200 and 100, for blue, red and white awards, respectively.
- Ask Ladies Auxiliary to consider joining in awarding prizes.
- Selection of ad-hoc committee appointed by the president. Possibly a blueribbon committee selected from committee chairs of Knight Essay, Education, Publicity, Electronic Tech, History Fair and Public Relations committees.
- Selection of topic by committee. Topic would emphasize a colonial or revolutionary person or event designed to provoke and hold the interest of a 12 – 14 year-old student.
- Develop promotional literature and application, including scholastic and research protocols and mailing information. Help provided by the FLSSAR Knight Essay, Publicity and Public Relations committees.
- Make inquiries as to the best time frame to announce the program and allow maximum coordination with the teaching of Colonial and Revolutionary history in the curriculum. Set dates with the help of the FLSSAR Education committee.
- Promotion of the program utilizing the same list of county coordinators we work
  with for Florida History Fair. In addition, individual chapter promotion through
  first-person contact with local school boards, school administrators, curriculum
  coordinators and social studies lead teachers. Critical is the involvement of the
  Senior VP and Regional VPs to personally work with chapters and lead them into
  participation.
- Promotion on FLSSAR website with the help of the Electronic Tech Committee.
- Receipt and judging of entries. Selection of award winners.
- Red and White awards by local chapter presidents, and/or FLSSAR officers. If this is not doable, then by mail with congratulatory letter signed by FLSSAR president and committee chairman.
- Blue ribbon award at Spring BOM along with other youth awards, or, if preferable, by Regional VP and Chapter President in the winning region.

Please note that at no time have I used the term "contest". I would suggest that we use a new approach e.g.: The Florida Society, Sons of the American Revolution

### A. Instructions for chapters submitting applications for reimbursement:

- 1. Applications must be submitted on official FLSSAR forms, nine copies are required.
- 2. All requests for reimbursement MUST be itemized and include explanations.
- 3. The chapter must absorb 25 % of expenses cited below except for medals.
- 4. Applications should be for expenses incurred during the calendar year of the project or award (for example: medals purchased earlier can be reimbursed only in the year awarded).
- 5. Applications for eligible reimbursement will be limited to \$350.00
- 6. Chapters are limited to five requests per year.
- 7. Chapters may include a code if they wish to have the awards matched to the applications.
- 8. Half of all awards will be paid when approved, the other half at the end of the calendar year.

### B. Authorized reimbursement to chapters:

- 1. Full reimbursement for all ROTC (bronze and silver) medals; also one medal per year for the Rumbaugh, Knight, and Eagle Scout contests.
- 2. Prize money for the Rumbaugh and Knight contests. Limits: \$50 (1st), \$25 (2nd), \$15 (3rd).

- 5. Medals for Law Enforcement, Fire-Safety, Heroism, Good Citizenship awards and one lunch per recipient.
- 6. Support for the Florida Society CAR.
- 7. Genealogical and Historical materials presented to public libraries.
- 8. Expenses incurred when honoring Veterans' graves and cemeteries.
- 9. Copies of historical documents presented to the Public Schools.
- 10. Restoration of historic and patriotic monuments.
- 11. History Fairs (Limit: \$100.00); Genealogical workshop (Limit: \$200.00).
- 12. Flag Certificates and presentation folders.
- 13. Engraving expenses not to exceed \$5.00 per award.
- 14. Liberty Tree Dedication not to exceed \$250.00 on a one-time basis only.

### C. Items NOT eligible for reimbursement:

- 1. Any administrative expense: postage, telephone, correspondence, etc.
- 2. Frames or framing, other than SAR presentation folders.
- 3. Any award to SAR members. Any award to animals.
- 4. Cost of meals for other than award recipients, except for Rumbaugh and Knight Contests.
- 5. Expenses for awards made in previous calendar years or projected for future years.

1. Requests for projects other than those listed above under authorized reimbursements.

### HISTORY OF THE TRUST FUNDS

## **Endowment Trust Fund**

The Florida SAR Endowment Trust Fund was created July 10, 1972. "This Trust Fund is created and shall be administered and operated exclusively for the benefit of, and the income of the Trust Estate shall be distributed by the Trustees exclusively in aid of patriotic, historical, educational and charitable uses and purposes...only within the United States or any of its possessions..."

"The Trustees shall from time to time on the written directions of the FLORIDA SOCIETY SAR or its Board of Management make payment out of the Trust Fund, from interest or cash dividends only, to such persons, corporations or associations, in such manner, in such amounts and for such purposes as my be specified in the written directions of said society. Under no circumstances shall the Trustees invade the principal of the Trust Fund hereby established, or pay out any portion thereof."

The Florida Society SAR has established the Endowment Trust Fund Disbursements Committee to administer and request payments from the Endowment Trust Fund.

### **Operating Trust Fund**

The Florida SAR Operating Budget Trust Fund was created May 18, 1991. It is to be administered and operated exclusively for the benefit of the operating budget of the Florida Society SAR. Only income amounts can be paid to the Florida Society SAR. "Under no circumstances shall the TRUSTEES invade the principal of the Trust Fund hereby established, or pay out any portion thereof."

### **FLORIDA STATUTES**

Florida Statute 737 governs trust funds in Florida. This statute requires a trust fund accounting for any accounting period starting January 1, 2003. The trust fund accountings must include the following elements:

- (1) Must be reasonably understandable.
- (2) Must show all cash and property transactions.
- (3) Must show all gains and losses realized and all receipts and disbursements.
- (4) Must show the market value and carrying value (cost) of all assets at the end of the accounting period.
- (5) Must allocate all receipts and disbursements between income and principal.

Since the beneficiary of both trust funds is the Florida Society, any accountings should be presented to the Florida Society. The Treasurer's Reports previously issued by the Trustees of these funds contained some of the required elements but not all of them.

### ACTIVITIES OF THE ENDOWMENT TRUST FUND REVIEW COMMITTEE

### 2002 - 2004 Trust Fund Accountings

The prior ETF Review Committee hired the firm of Faster Systems to prepare the trust fund accountings for both the Endowment Trust Fund and Operating Budget Trust Fund for the years ended December 31, 2002, 2003, and 2004. These accountings were prepared in accordance with the requirements of Florida Statutes.

The current ETF Review Committee reviewed the accountings performed by Faster Systems for accuracy by performing the following procedures:

- (1) Reviewed all bank statements for the disbursement account maintained at Citrus and Chemical Bank for the period from January 1, 2002 through December 31, 2004. It was noted that all cleared checks appeared to be for authorized purposes. No unusual disbursements were noted.
- (2) All receipts of income per the accountings were agreed to the underlying brokerage or account statements.
- (3) The accountings were checked for mathematical accuracy.
- (4) The assets on hand at the end of each year per the accountings were agreed to the underlying brokerage or account statements. The carrying value of assets was agreed to past Treasurer Reports or current account statements.
- (5) All brokerage account statements from January 1, 2002 through December 31, 2004 were reviewed. No unusual transactions were noted.
- (6) All chapter contributions per the accountings were agreed to related month's bank statements.
- (7) Distributions to chapters were sampled and agreed to the underlying bank statements.
- (8) All sales of securities and the resulting gain or loss per the accountings were agreed to the underlying brokerage statements.

Based on its review, the 2002 –2004 trust fund accountings prepared by Faster Systems appear substantially correct except for the allocation between income and principal at the end of each accounting period. The 2002 – 2004 accountings have been presented to the Treasurer of the Florida Society as beneficiary of the funds.

## 2005 Trust Fund Accounting

The ETF Review Committee obtained all the 2005 brokerage and bank statements for both the Endowment Trust Fund and the Operating Budget Trust Fund and prepared the required accounting for 2005 using the same statutory format as Faster Systems. Based on the review of documents and transactions for 2002 – 2005, the ending income amount

available at 12/31/05 for both funds was adjusted to reflect the estimated amounts available to spend for 2006. In its preparation of the 2005 accountings, no unusual transactions were noted.

### Recommendations


- (1) The books and records of both trust funds should be maintained in the required statutory format so as to avoid any future confusion on income amounts available to spend.
- (2) The assets of both trust funds are invested almost exclusively in common stocks and common stock mutual funds, which only generate a small amount of income. The portfolio of both funds should be adjusted to include income-generating assets such as bonds, certificates of deposit, and money market instruments, which would provide more yearly income to be spent on charitable activities.




# **Endowment Trust Fund** Ending Market Value






# Operating Budget Trust Ending Market Value
