Since our May, 2008 Annual BOM meeting, I have communicated via phone and email with various state and chapter officers, committee chairman and members at both the FLSSAR and NSSAR level. Contact has also been made with various C.A.R. societies, state officers of the Florida Society C.A.R. and National Society C.A.R covering many topics and upcoming events.

Sunday, May 4<sup>th</sup> I attended the installation of the officers of the Princess Malee Society at the Fort Caroline National Park, Jacksonville, FL. The Senior State President, Billie Brock, conducted the installation ceremony.

FLSSAR President Ron Toops was the guest of honor at the Jacksonville Chapter on May 8, 2008 and he conducted the installation ceremony of the newly elected officers of our Chapter. President Toops also gave us a report on some of upcoming activities and goals of the Florida Society that he will be implementing during his term as President of FLSSAR.

On May 29<sup>th</sup> approximately seven members of the Jacksonville Chapter participated in the Annual Memorial Day tribute our fallen military personnel at the Jacksonville Memorial Wall. Several members of the Princess Malee Society of the C.A.R of Jacksonville also joined us on this occasion.

Billie and I, along with our two grandchildren, Connor and Caitlin Brock, of the Princess Malee Society participated in the wreath laying ceremony at the Battle of Ramsour's Mill on Saturday, June 7<sup>th</sup>. David and Marjorie Ramseur of the Jacksonville Chapter also attended this event.

On Saturday, June 7<sup>th</sup> the Jacksonville Chapter along with members of the C.A.R. and DAR attended a traveling exhibit which featured a rare painting of President George Washington at the Cummer Museum and Gallery in Jacksonville.

It was my pleasure to attend a meeting of the Center for Advancing American's Heritage "CAAH" at Louisville, KY on Friday, June 13<sup>th</sup>. The meeting consisted primarily of discussing the different areas (Education, Exhibits/Gallery, Library and Merchandise Sales) of the new CAAH facility which will be the new Headquarters/CAAH facility for SAR on Main Street in Louisville, KY. The next morning, Saturday, June 14<sup>th</sup>, Billie and I attended a Flag Retirement Ceremony at the headquarters of the NSSAR in Louisville, which was conducted by the Kentucky Society and Executive Director Joe Harris.

The Florida Society had six members in attendance at the 118<sup>th</sup> Annual Congress in Sacramento, CA on July 4<sup>th</sup> – July 9<sup>th</sup>. There were several proposed revisions to Article III (4) of the NSSAR Constitution, Bylaw No. 19 of the NSSAR Bylaws and Bylaw No. 30 of the NSSAR Bylaws. Article III and the proposed revision to Bylaw No. 19 both passed. However, the proposed change relating to Bylaw No. 30, which dealt with the Ladies' Auxiliaries did not pass. A motion was made from the floor "that all work be held up on the Fulton Conway CAAH/Headquarters project until ... the Fall 2008 Leadership meeting in Louisville." This motion was soundly defeated by those in attendance. There were only three votes in favor of the motion.

It recently became evident to me, that we must get on board as a Society and as members of this Society and again provide, I repeat personal and financial support. It was made clear to me, that we need to make an effort to achieve participation, if only in a small financial way, by all of our members. The evidence supports the conclusion, that if a corporate organization, finds that the membership of an organization is supporting the task in great numbers, then they are willing to give **substantial financial support**. It will be the task of this President to develop a strategy which yields a **significant participation** in giving to this fund raising endeavor. Even the small sum of \$20 from a member is appropriate. In the near term, we plan to better understand the participation goals of the NSSAR organization and begin a process which utilizes the time of the President, Sr. V.P, Regional VPs, and others to make this effort a success.

The <u>Second Objective is to increase Florida Society Membership</u>. The Florida Society has basically had a flat membership position for at least eight (8) years. Our Senior Vice President and the President would like to return to a 2000 membership level in 4-6 yrs. The Regional Vice Presidents are now in the process of developing one strategy for encouraging membership growth. Many of our chapters are increasing their individual chapter memberships and I am sure that many of their techniques can be used to assist the other chapters. I personally have experienced, that if you achieve increased membership growth, you in fact achieve expanded program participation and new fresh ideas for being successful, as it relates to our many programs.

We have a number of other goals and objectives which are important as well, however I will itemize them at another time. Let us see if we can work as a team and make the two listed a success.

**Session Florida House & Senate2008-2009**: To Summarize the 2007-2008 Session, the Florida House of Representatives again supported the effort related to re-emphasizing Social Studies in our Public Schools. Although it was clear that the House was aggressive in this important effort, the Senate and it's leadership refused to act on the House Legislation which was presented to them. As usual, our legislators are frequently not open as to the reasons for their inaction, but the main obstacle may have been the poor state budget position. The Florida House's text appeared to indicate that there was no net increase in spending required, however this had no effect on the adverse outcome.

I will be in contact soon with the Coordinators of the Florida Social Studies Supervisor leadership and' will be defining our strategy for the coming year. In their legislative updates, it is clear that a large number of our local representatives will be up for election. This indicates an opportunity for our our members to contact their local representative candidates and encourage them to support our efforts associated with Social Studies, i.e. American History, Civics, Geography, Economics, etc.. I will keep you informed. We will probably be asked again to go to Tallahassee to advocate our position to the Florida House and Senate leadership. I am hoping that some of you will assist me in all of these efforts.

**Florida Sunshine State Standards**: The process is about finished on this revision process. The writers had completed an earlier version of the revisions with the associated benchmark. Each element of the Social Studies Program, i.e. American History, World History, Geography, Civics, and Economics, had their own criteria and associated benchmarks. This earlier version was review in a "Town Hall" format at several locations. There were about 123,000 individuals who accessed the text and there were over 7800 comments submitted. When I talked to one of the revision process coordinators, they assured me that my comments had been passed onto the writers. There were also nineteen experts who reviewed the approach. The document now is made up of about 265 pages and is in the process of editing, based on the feedback and comments. It should soon be submitted to the Commissioner. The target for implementation is for the 2012/2013 school year.

**Middle School Essay Pilot Contest**: The Lake-Sumter Chapter did present awards to the two middle schools in our area, one a public school and the other a private academy. The award approach for this Middle School Pilot Essay effort, included a FLSSAR provided plaque along with a financial award to the participating middle school. The selected chapter winners received a cashier's check, a certificate and in one case each student received a copy of the Declaration of Independence. The presentations were made in American Revolutionary Uniform. We also will recognized the participating teachers with an Outstanding Good Citizenship Pin and Certificate. The development of this pilot a partnership effort with the teachers at three local middles school, one public, one charter and one private.

It is the intention of the FLSSAR Middle School Outreach Committee to initiate additional state oriented Middle School Essay Pilots this fall for the 2008-2009 period. The Lake Sumter Chapter will also kick off their second effort at the end of August. The participating schools and teachers were pleased with the program and intend to participate again. The chapter is hoping to include four schools during this time frame.

**Education/Program Review**: It is my intention to open up for discussion a general reorganization of the various Youth Education Programs and Committees. My intention is to recognize the difficulty that chapters have in deciding what programs they want to participate in; I am hoping that the Florida Society can assist in these decisions.

Since my last Committee report of <u>April 20, 2008</u>, e-mails to another 165 (average) recipients at a time were sent out on 52 occasions over about a 3 ½ month period, resulting in a total of about <u>8580</u> e-mails through <u>August 5, 2008</u>, This is <u>almost triple</u> the number of e-mails sent last year over the similar reporting period April 22, 2007 through July 19, 2007, when e-mails to 175 recipients at a time were sent out on 17 occasions, a total of <u>2975</u>

For last year's program year, 2007-2008 which began on 4/29/2007, ending May 4, 2008, e-mails were sent out on 82 occasions to 175 recipients at a time resulting in about a total of 13812 e-mails for the year.

Most important, our Committee Charter includes as one of its functions the administration of <u>the</u> <u>Flag Program for the Florida Society</u>. This includes competition for the NSSAR Rear Admiral William R. Furlong Award to the State Society with the best Flag Program. It awards and presents the NSSAR Flag Certificate to individuals and activities in the name of the FLSSAR, encourages FLSSAR chapters to participate in Flag Day, June 14, ceremonies, and promotes respect and honor to the Flag of the United States.

This ad hoc committee has committed to working on a number of issues related to the society's website, Patriot magazine, historical and archival records, and other technology items. The group had a very productive meeting in May and worked out a preliminary outline of the work to come.

The following is a summary of this work. We very much welcome feedback from the membership.

- 1. We feel that the positions of webmaster and editor of the Patriot magazine are equal in importance and so should be treated equally in how these positions are filled. Currently the webmaster is appointed and the editor is elected. We are recommending that both be appointed positions and will draft the appropriate by-law changes for presentation to the Charter and Bylaws committee in October.
- 2. While the production of both the magazine and website require the expertise of a single individual we see the need for each area to have an advisory committee. The editor would be a member of the Patriot Advisory Committee but not the chair. The same would be true for the webmaster in his role on the Website Advisory Committee. Each of these committees would be charged with setting policy for their publication and would act as a vehicle to air concerns by the membership. There are many advantages to this approach and we'd be glad to discuss these with interested members.
- 3. With regard to the above, we will recommend that the current Electronic Technology Committee be disbanded and reformed as the Website Advisory Committee. We feel this would be a better use of the talent that generally serves on the current Electronic Technology Committee. The Patriot Advisory Committee would be a new, standing committee.
- 4. We are working to clarify the roles of the Archive Committee and Historian so as to eliminate any overlap of effort. This work is on-going.
- 5. In our discussion we realized that the society has a need for a privacy policy. A <u>first draft</u> of this is given on the next page. Please feel free to offer suggestions for improvement.
