# FLSSAR STATE OFFICER'S REPORT National Trustee

Note: Ron Toops became the FLSSAR Trustee following the 2009 Congress. This report is provided by Ron Hamilton who was the Trustee during the Congress.

I attended Atlanta congress 4 - 8 July. On July 5th the Trustees reaffirmed proceeding with the building of the SAR Library and Genealogical Facility at the Society's Main Street property. The construction is to be accomplished without third party debt. This was approved by the Delegates. At an August Executive Meeting in Rochester, NY the Committee voted to proceed with construction of the Library. There will be a contract signing ceremony at Headquarters at 10:00 AM on Tuesday August 25th. Construction will start immediately. It is hoped NSSAR will be able to move into the new facility in July or August 2010.

The following was also approved at Congress:

- National dues will increase from \$25 to \$30 effective January 1, 2010 for Regular Members. National dues will be increased from \$5 to \$10 effective January 1, 2010 for Junior Members.
- New Member Application (processing fee) will increase from \$60 to \$80 effective January 1, 2010.

Good Evening to all. Mile Marker ONE -well the year began running, but first let me again thank the members for granting me the honor of temporary stewardship of the Florida Society. It is my great honor.

Now to business. As you can see in Commander Young's I have been quite active as Commander of my outpost representing the FLSSAR at numerous activities in the Treasure Coast Area. Also on 8-9 May I represented the FLSSAR at the Battle of Pensacola Ceremonies. What a show. Event was well researched and presented. The Pensacola Chapter is to be well commended for a job well done.

It was one of the best yet. Location was very nice, but one needed skates or a go-cart to get around the hotel it was so big. Congress generally good and productive. Only one major bit of unpleasantness that caused the session to over-run 2 hours. That was on the subject of the application fee. NSSAR at the last Leadership Conference had proposed to double it from \$60 to \$120. I recommended it be increased \$10-15, but it was approved at an increase of \$20, from \$60 to \$80; making the total amount (fee and dues) to NSSAR, effective 1 January next, at \$110. The other sad event was the Eagle Scout Committee felt it necessary and voted to discontinue making the big Eagle Trophy and the medal available to the States at no cost until the economy improves.

Future events are Official visits, in October to Lakeland Chapter on the 17th and to Withlacoochee Chapter (date to be set), in December Clearwater Chapter for installation of Officers on the 16th, and in January 2010 to Palm Beach Chapter on the 19th and the Daytona/Ormond Chapter on the 21st.

### **GENEALOGIST REPORT**

### Dear Compatriots:

At the Spring 2009 FLSSAR Board of Management Meeting, I presented my final Registrar Report which summarized the events that transpired during the March 2009 NSSAR Genealogy Committee Meeting in Louisville. As you are probably aware, I was unsuccessful in overturning the ruling by Genealogist General Joe Dooley in September 2008 that prohibited the use of DAR Record Copies with center check marks as proof of lineage and service for SAR applications.

One of the exhibits that I presented at the NSSAR Genealogy Committee Meeting was SAR Genealogical Policy GR040704-A (copy attached) that I downloaded from the NSSAR national website. As you will note, this policy reads "The NSSAR will accept record copies (dated 1986 or later) from the NSDAR...with respect to related sections of the SAR application that require proof of service and/or proof of the applicant's lineage." At the top of the page on which this policy is listed, it states "Policy Approved by the 2004 Annual Congress."

When I presented this exhibit at the March 2009 NSSAR Genealogy Committee Meeting, it was disregarded by most of the compatriots in the room, including Genealogist General Joe Dooley and Secretary General now President General Ed Butler. Paul Hays, National Trustee of the DC Society and a member of the NSSAR Genealogy Committee, stood up and stated that any SAR Genealogical Policy approved by an Annual Congress could not be undone by any committee and could only be rescinded by a future Annual Congress. His statements and concerns were disregarded by most of the compatriots in the room, including Messrs. Dooley and Butler.

In June 2009, President-elect Rick Hollis of the Tennessee Society, who attended the March 2009 NSSAR Genealogy Committee Meeting, posed the question on SAR-Talk regarding SAR Genealogical Policy GR040704-A, and questioned the authority by which the Genealogist General or any committee could rescind an SAR Genealogical Policy seemingly approved by an Annual Congress. His question generated numerous responses.

Even though I did not attend the Annual Congress in Atlanta, several compatriots provided details to me of what occurred. When Compatriot Jim Faulkinbury of California and others attempted to bring up the subject of DAR Center Check Marks and SAR Genealogical Policy GR040704-A during the business meeting on Wednesday, President General Appleby refused to permit any discussion of the subject because he had created a Blue Ribbon Panel to research the issue. He appointed the members of the Panel and they were tasked with presenting a report at the September 2009 NSSAR Leadership Meeting.

I mention all of this to you, because as you can see, it is of concern to people in all sections of our country, and still remains the most significant outstanding genealogical

policy issue affecting the SAR and the preparation, processing, and approval of applications. I believe it is my duty as FLSSAR Genealogist to keep you informed of these types of matters.

In conclusion, I thought I should mention that when the 2009-2010 NSSAR Committee Assignments were posted on the NSSAR website, my name was removed from the NSSAR Genealogy Committee and all others national committees to which I had previously belonged. ### Policy Approved by the 2004 Annual Congress

The Genealogy Committee shall establish policies and procedures regarding the conditions under which new member and supplemental applications are accepted, to ensure that there is reasonable evidence which eligible applicants or members must provide; recommends methods of search for an applicant to follow where proof is missing on any essential fact; reviews all pending new member applications over six months old or any pending applications not accepted by the Genealogist General that has been appealed to the President General, and recommends a course of action for each application reviewed; and conducts a workshop on genealogical sources and procedures at the Annual Congress.



We had a very productive few months in working on the membership database and increased the amount of data by a significant margin. You may recall that our goal is to have all our current and historical membership information stored electronically. This will allow us to find information with much greater ease and is also an effective backup for our paper records should those be lost in some disaster.

As of this writing, we have at least some information on 8,861 present and former members of the FLSSAR. We recently assigned state number 9380 indicating that we have accounted for all but 519 members. Work this summer also revealed that a block of 100 state numbers and another of 20 may have never been used. If this turns out to be correct that will leave only 299 members or just over 4% of the membership that is still lost.

Currently, we're working on several items. The main focus is entering data from annual reports in the 1970's into the database. This data is giving us a membership history of our members and also helping to locate those still missing. The annual reports are also occasionally yielding chapter officers lists and other similar data that is entered as well.

We continue to scan any newly approved application or supplemental. Currently we have just over 200 applications scanned. The immediate goal is to scan applications of the current membership and then work on the historical copies. The scanning is a fairly slow process as is this entire project, but we're confident that our patience will pay off in the end.

As was reported at the Spring BOM meeting we received 15 essays at the state level and spent \$1,750 in prize money and approximately \$50 for the trophy to conduct this contest. Thus we spent \$120 per entry.

Many of us like this contest and have fond memories of past winners at both the local and state level. But the facts clearly point out the ineffectiveness of this program as a means of furthering the objectives of our society. Were we to have unlimited funds at our disposal there would be reason to continue offering this contest. As this is not the case, the committee offers the following:

- 1. We conduct the essay contest this year and offer a single prize of \$500 for first place.
- 2. We offer a second contest for a short instructional video as outlined below offering prize money totaling \$1250. This 2<sup>nd</sup> contest would also be run by this committee.
- 3. Based on the results, the committee would recommend to the Spring BOM a course of action to retain or eliminate one of both of these contests.

### Brief outline of the Instructional Video Contest

- Eligibility would be the same of the Knight Essay. Group projects would also be accepted
- Task: to create an original instructional video on a person, place, or event, associated with the American Revolution
- The video would be posted to the commercial You-Tube website by the student
- A short entry form providing basic information on the student(s) and the link to the video would be sent to the contest chairman
- Judging criteria would include accuracy, effectiveness in conveying the information, and technical merit. In addition, consideration would be given to the number of "hits" received by the video on the You-Tube site.
- Prizes: 1<sup>st</sup>: \$700, 2<sup>nd</sup> \$350, 3<sup>rd</sup> \$200 [Note the total prize money for this and the adjusted Knight Essay contest will total \$1750, equal to the prize money normally given to the Knight contest.]

### Advantages include:

- We would be allowing students to use a medium more in tune to their technological world
- The results of their work would be available to a world wide audience via the You-Tube website. [Note that the Knight essays are seen only by a very small group.] Thus we dramatically increase our potential impact toward our goal of educating our fellow citizens on the founding of our country.
- The administration of the contest will be fairly simple. Only the publicity will require significant effort.

Since my last Committee report of April 18, 2009, e-mails to another 165 (average) recipients at a time were sent out on 38 occasions over about a 4 month period, resulting in a total of about 6270 e-mails through August 20, 2009, This is lower than the number of e-mails sent last year over a similar reporting period April 20, 2008 through August 5, 2008, when e-mails to 165 (average) recipients at a time were sent out on 52 occasions (abnormally high), a total of 8580 e-mails. .

For last year's program year, 2008-2009 which began on 5/4/08, ending on 4/24/09, e-mails were sent out on 123 occasions to about 165 recipients at a time resulting in about a total of 20295 e-mails for the year...

Most important, our Committee Charter includes as one of its functions the administration of the Flag Program for the Florida Society. This includes competition for the NSSAR Rear Admiral William R. Furlong Award to the State Society with the best Flag Program. It awards and presents the NSSAR Flag Certificate to individuals and activities in the name of the FLSSAR, encourages FLSSAR chapters to participate in Flag Day, June 14, ceremonies, and promotes

and honor to the Flag of the United States.

Fortunately during the program year we came a long way in the last six months due to the last minute efforts by President Grant Wallin, SVP Ron Toops, Secretary Kevin Yarnell and our 7 Regional VPs to find enough chapters that may have presented flag awards during the calendar year. 2008, and not reported them to us.

In order for our State Society to earn the Admiral Furlong Ribbon Award from the NSSAR Flag Committee, at least 50% of our chapters (16 chapters) must present at least one or more Flag Certificates during the calendar year. Since Walter Baker, Chairman of the NSSAR Flag Committee, has asked that all State Patriotic Committees forward their chapter report to him by April 1st., we respectfully ask all chapters to respond to us or your Regional VP whenever you make a presentation, but never after March 15, 2010.
