### FLSSAR STATE OFFICER'S REPORT President

Harold (Hal) F. Miller Jr. 4 January 2005 Activities for this past quarter:

On Oct 7<sup>th</sup> I was asked to lay our State's wreath at the 224<sup>th</sup> anniversary of the Battle of Kings Mountain which was very well attended with at least 40 wreaths laid at the base of the Monument to pay tribute to the 28 patriots who died there. PG Hank McCarl played an active role in the ceremony. Compatriots from 6 southern states were in attendance. Florida was represented by VPG Ron Hamilton, and RVPs Lindsey Brock, and Fred Gaines, along with their wives.

On Oct 16<sup>th</sup> I didn't have to travel very far to join the monthly luncheon meeting of the Lakeland Chapter after the BOM meeting ended at the Holiday Inn. The proximity was one of the many incentives of that expert of persuasion, Al Snapp, who graciously asked that I be their speaker. I brushed up my speech, "Why John Adams Deserves More". By the way, the food served at their regular Country Club meeting place is great.

On Oct 20<sup>th</sup> I traveled to another Country Club, this one in Dunedin where the Clearwater Chapter meets for their monthly meetings. Pru-Ann joined me, as did our Alternate State Trustee, Frank Hodalski and his wife, Barbara. I was very pleased to have been asked to honor a young lady, Miss Jessica Porter of Hudson, Florida. As a 19 year old in 2003, she started "Operation Homefront Quilts" which is an ongoing project to send a handmade quilt to the immediate families of each U.S. service person killed during the conflict in Afghanistan and Iraq. Jessica and her team obtain the photograph of the deceased from military websites and send it along with the military unit name on the back of each quilt adding the following words: "In Remembrance and Gratitude-American Hero 2003 or 2004". As of last summer, the operation had made about 700 quilts, many not finished. Publicity began in February, 2003, with coverage by the Readers Digest when more than 450 had died. Since then she has been interviewed and featured in the New York Times, and St. Petersburg Times, with special stories by 10 News and Newsweek. As of the date of this meeting, about 900 + had died and 530 quilts had been delivered. On one of the many board displays she presented was a congratulatory letter from Governor Jeb Bush. It was indeed an honor to present her with the NSSAR Silver Good Citizenship Award. It was not surprising that she was able to raise over \$300 in contributions to help cover her mailing costs, etc.

On Nov.11<sup>th</sup> I joined our Saramana Color Guard, Nathanael Greene Camp # 8, and carried the United States Flag for 2 miles in Sarasota County's Veterans Day Parade. It weighed more when we reached the J.D. Hamel Memorial Park. Strangely enough, Pru-Ann received, from 2 DAR friends, a copy of a picture of me carrying that flag from the Nov. 12<sup>th</sup> edition of the "Tallahassee Democrat". (Hard to believe, isn't it?). They mentioned my name and the SAR. Seven compatriots participated in the Sarasota parade while four marched in the Bradenton parade.

On Nov. 16<sup>th</sup> & 17<sup>th</sup> I participated as a judge at the Manatee County History Fair held at the Manatee County Convention Center (8:30 AM) and the next evening joined PG Carl Hoffman in Colonial Uniform as he presented our 3 Eagle Plaque Awards for the American Revolutionary History Prize to the winners.

On Dec. 9<sup>th</sup> Pru-Ann and I took another trip to Clearwater to install their Officers and Board of Governors. Gene Brown will begin his second year as President.

On Dec. 10<sup>th</sup>, at our Rumbaugh Oration Contest Luncheon, I was pleased to install our new Officers and Board of Governors. Don Bailey Sr. begins his third year as President, and John A. Williams, Jr. has stepped up to the plate as Vice President. More new blood arrived in the form of two members of the Board of Governors.

On Dec 13<sup>th</sup>, dressed in my "alpha" uniform, I joined two others also in "alpha", and one more in his "bravo" uniform, former PG Carl Hoffmann. We had a color guard of 4. We were asked to participate in the "Wall Of Honor" Ceremony organized by the Manatee County School Board behind their building to honor former Manatee students who made the ultimate sacrifice as well as those who have served or are now serving their country in Afghanistan and/or Iraq. SAR & our Color Guard was recognized as participating along with other veteran groups. A 33 minute video was made of the one hour program and aired many times on METV Channel 21 as well as on Comcast Channel 19.

#### **Daytona-Ormond Chapter**

On 18 November 2004 I attended the Daytona-Ormond Chapter's monthly meeting where President Tom McNally was the speaker. Compatriot McNally's speech was entitled "Surviving Post Traumatic Storm Disorder". His presentation was sprinkled with a combination of humor and helpful information on how to take control of your emotions when confronted with everyday events over which we have no, or only limited control, such as the four hurricanes that impacted virtually every Florida County in 2004.

You will recall at our Fall BOM meeting it was reported that the Daytona-Ormond Chapter presented a check to the principals of Atlantic High and Osceola Elementary schools to purchase United States Flags for 141 classrooms in those two schools. The generosity of the Daytona-Ormond was reported in the local media, which resulted in other organizations taking part in the initiative to furnish U. S. Flags to the public schools in Volusia County. The Gemini Springs and Sugar Mill Chapters of the DAR in Volusia County are emulating the generosity of the Daytona-Ormond Chapter by providing U. S. Flags to three other schools in Volusia County; and other FLSSAR chapters have or are planning to furnish U. S. Flags to schools in their respective counties.

His rendition of those songs and the accompanying music was enjoyed by everyone.

The following is the quarterly report for October, November and December of 2004 Because of the hurricanes, some activities were limited. We had to cancel our DAR/SAR Constitution Week luncheon in Stuart; however, we have rescheduled it to a President's Day luncheon on February 12, 2005 at Johnny's restaurant in Port St. Lucie. A local paper, "The Hometown News," did a feature article on our awarding of a medal to a firefighter at our October meeting. The chapter met in October at the Plaza in Jensen beach and again at Johnny's Restaurant in November and December.

On Veterans Day two compatriots in uniform were part of a color guard at Veterans Memorial Park in Port St. Lucie. On the same day, and at the same time, three compatriots in uniform marched in the Stuart, Florida Veterans Day parade. After the parade, we met and talked to General Paul Tibbets, the pilot of the Enola Gay, which dropped the atomic bomb on Hiroshima. I personally thanked him for what he did because I could have been one of a million casualties predicted if we had to invade Japan. Later that day, past Chapter President, Jay Wise and I went to honor the gravesite of a Medal of Honor Recipient, Reidar Waaler, at Forest Hills cemetery in Palm City. This is the only Medal of Honor gravesite in a wide area of Central Florida that encompasses over three million people. The focus of this committee has been to initiate and carry out the placing of American Heritage teaching aids (CD's/booklets) in the hands of all Florida teachers of History -- first in the public schools and then in private and home schools. Most of the three thousand available units were divided into lots and provided our seven Regional Vice Presidents. It was requested that they transfer appropriate numbers of them to the Chapters so their members, in turn, could place them with relevant Social Studies Supervisors (and in some cases teachers) for consideration. In turn, they were to forward these aids to the History teachers they supervise. A few were sent directly to teachers, or other individuals, who requested them. Further exceptions were those given to committee or BOM members who brought them directly to the schools in their district. Reports are trickling in from participants at all levels and a substantive report will soon be sent to NSSAR. So far there has been only praise for our American History teaching aids. Incidentally, the approach we are using has saved our state and chapter treasuries a great deal of money. We get the CD's/booklets free from NSSAR and transfer them (by hand) to the teachers.

This program is considered only partly successful as it appears that some of our Chapters and/or Compatriots have not become interested enough it to participate at a reasonable level. It would appear that we, the members of FLSSAR, can make a significant contribution to the upgrading of the knowledge about our great Country by Florida's young people— and do so with only minimal effort on our part. The program is a wonderful way to get good information to our children and youth! Will you, our members, provide just a little more assistance?

Contacts with NSSAR Executive Director Jim Randall have resulted in a promise to send 1500 more units to us for the next stage of our distribution. He, in turn, requests that we seek corporate sponsors to better support this program.

Second, EdComA Co-Chair Ronald Toops has been in touch with both past and present legislators in an effort to find out about relevant bills that will be presented for consideration during the upcoming legislative session. Our primary consultant with FASSS (Jack Bovee) has also been contacted.

Third, some information has trickled in about the experiences a number of our Compatriots have had with district-level History textbook selection committees. Moreover, the reports of our two (Florida-level) state-wide History textbook selection committee members (Dick Fowler and Richard Cardell) can be found at our website.

The FLSSAR website continues to be the focal point for communications within the Florida Society.

The Hurricane predominated all activity in the early part of the quarter. Some pictures of Hurricanes Charley, Frances and Jeanne were included in the photo gallery page.

Use of a digital/SLR camera has improved the quality of pictures and more "slide shows" are being posted in the photo gallery page. This camera also allows almost instant shooting of simultaneous pictures. A case of this was on the National Congress photos at <a href="http://lccpsl.org/slide/nc04cg/nc04cg.htm">http://lccpsl.org/slide/nc04cg/nc04cg.htm</a>. Pictures were taken at approximately five second intervals and thirty-six pictures were taken in two minutes. Most digital cameras require a considerably longer time interval between shots.

Slide shows are easy to use, and a viewer is more likely to scan this type of presentation than to view the static displays. Usually both are offered, and if something is seen in the slide show, it is easy to switch over to the static display to see more details of any picture desired.

Activity on the website was down for the month of October but has come back stronger than ever. One additional newsletter for the C.A.R. was added to the newsletter pages. Some chapters are now doing their newsletters in PDF format, which makes it very easy to be incorporated into our website. When the newsletter editor sends in such a .pdf newsletter, all that has to be done is copy it, input it to the web and all articles, graphics and photographs automatically appear. The only other thing is to make a link to that newsletter from the newsletter index page.

The website and e-mails have become the main communication tools for the BOM meeting information and reservations are being copied from our web page and sent in to the person responsible for reservations.

The focus during this period has been on the six programs outlined in the last report. While some activity occurred within all six, the best progress was made with respect to the first two. They are as follows:

Efforts have been made to establish a FLSSAR Speaker's Bureau. One was organized and a Bureau Coordinator selected. He is Compatriot William Piper of the Lake-Sumter chapter. He also has joined this committee and agreed to establish a Roster of speakers (an announcement requesting volunteers has been sent to all Chapter Presidents). Individual volunteers are urged to register with Compatriot Piper and provide him with information about how they may be contacted, the geographical area they are willing to serve (examples, "within 100 miles of my home", "the entire State of Florida") and the topics upon which they can lecture. Subsequently, members of the Speaker's Bureau can be contacted in two ways: 1) through Coordinator Piper or 2) directly (they would simply log their speaking engagements with him). The purpose of this thrust is to: 1) provide the Chapters with a greater, and more varied, pool of programs, 2) provide additional visibility regarding our Society, 3) permit an SAR presence with other groups (especially with heritage organizations such as the DAR, OFPA, etc), and 4) identify potential members. It is hoped that a large number of our talented Compatriots will volunteer to provide at least an occasional lecture for this program.

The second thrust has been (and is continuing to be) focused on increasing the number of Brigade Camps supported by our chapters. At present only about a third of them have Color Guards. If active, these units provide excellent visibility for our Society; they also constitute good tools for recruiting. During this period, we have worked with two chapters in forming Camps. They are in the process of applying to Brigade Headquarters for commissioning and their chance of success appears favorable. These two chapters are Lake-Sumter and Withlacoochee.

#### CURRENT STATUS OF ROTC AND JROTC UNITS IN THE STATE OF FLORIDA.

#### ROTC UNITS.

There has been no change in the assignments of ROTC units to institutions of higher learning in the State of Florida for the year 2004.

#### JROTC UNITS.

With the rapid building on new high schools in the State of Florida, there has been a surge of JROTC units where Federal law permits. As a new high school opens, where requested, a JROTC unit may be identified and actions is started to obtain qualified Military Instructors. The administrative arrangements of the start of the JROTC unit may start taken place even prior to the opening of the new high school.

Each of the Services manages their JROTC units in a different manner with the lead command having overall responsibility. For example, the Navy is at the Naval Education and Training Command, NAS Pensacola, Florida. The Marine Corps is at the Training and Education Command, Quantico, Virginia.

The below is a comparison in the growth of JROTC units within the State of Florida for 2001 and 2004.

The period of this report is from 17 October 2004 through 15 January 2005. Most of the Camp activities during this period centered around events during the 11 November Veterans Day celebrations, providing Color Guards for civic and fraternal organizations, and participation in holiday and celebration parades. The WITHLACOOCHEE Chapter has sponsored a new Camp, and Thomas Jefferson Camp # 11 is now a part of the Brigade. At the time of this writing, members from Jacksonville, Pensacola and Central Florida plan to participate in ceremonies at St. Simon Island, GA with the GASSAR Color Guard on 19 April 2005. Lake Sumpter Chapter is in the process of forming a new Camp. Specific activities of the various Brigade Camps during this period were as follows:

- a. George Washington Camp # 1., (Jacksonville) Dick Cardell Commander. On 11 November, six Camp members, five in colonial uniform and one in "Bravo", participated in the Jacksonville Veterans Day parade. # AN HONORS COUNCIL A Proposal

Many of our FLSSAR long-time leaders are now growing older and/or are limited in the contributions they currently can make because of physical limitations. At present there are few ways that their long-term leadership and outstanding contributions can be rewarded – or even recognized. Moreover, as they "retire," we are denied both their wisdom and knowledge about SAR in general and our State Society in specific. Therefore, it is proposed that we establish an Honors Council. This organization would serve as a combination Hall-of-Fame and a Senior Advisory Board.

To be eligible for election to the Honors Council, a Compatriot would have to have served our Society over time, held a number of positions as a FLSSAR officer and/or committee chair and made signal contributions to our Society. They also would have to be functionally retired even though they might still be attending meetings and serving on committees.

Up to five members could be elected Honors Fellow (by the BOM; secret ballot) the year the Council is formed and up to three members can be elected each year subsequently.

Honors Fellows would receive a plaque and be placed in a permanent advisory status. They would be kept appraised of FLSSAR activities by the systematic forwarding of information about FLSSAR activities (the minutes of all meetings, special updates, etc) and would be afforded a voice at each BOM (in person or electronically). Once a year they would be honored at a luncheon hosted by FLSSAR. In turn, they would be asked to provide counsel and advice to the FLSSAR Executive committee and Board of Management.

- 10. Knight Essay Contest. Same as for Rumbaugh Oration Contest.
- 11. History Fairs: Limit of \$100.00
- 12. Flag Certificates and presentation folders.
- 13. Engraving Expenses not to exceed \$5.00 per award.
- 14. Liberty Tree not to exceed \$250.00 on a one time only basis.
- 15. Genealogical Workshop limit of \$200.00.

#### INSTRUCTIONS FOR CHAPTERS SUBMITTING APPLICATIONS FOR REIMBURSEMENT

- 1. Applications MUST be submitted on the approved form with seven copies.

- 1. Any administrative expenses: postage, telephone, correspondence, etc.
- 2. Frames or framing other than SAR presentation folders.
- 3. Any award or medal to SAR members.
- 4. Any expenses for awards in previous or future calendar years.
- 5. Cost of meals for other than award recipients, except as in Rumbaugh and Knight contests.
- 6. Any awards to animals.

#### THE FOLLOWING MUST BE APPROVED BY THE BOARD OF MANAGEMENT

- 1. Reimbursement expenses in excess of \$350.00.
- 2. Reimbursement for requests by one Chapter in excess of six in any calendar year.
- 3. Requests for projects other than those listed above under AUTHORIZED REIMBURSEMENTS.

# FLORIDA SOCIETY OF THE SONS OF THE AMERICAN REVOLUTION MINUTES WINTER BOARD OX MANAGEMENT MEETING JANUARY 14-15.2005, LAKELAND FLORIDA

The meeting was called to order by President Harold F. Miller, Jr., at 9:15 P.M. The Invocation was given by Chaplain Charles Schafer. The Pledge to the Flag was led by Senior Vice President Harry Hollien; the American Creed was led by Secretary Kevin Yamell.

National officer were introduced by President Miller. Included was President General Carl Hoffman: Vice President General David Sympson dual member; Vice President General Phil Carr, Registrar General Richard Friberg; Boy Scout Committeeman Bob Burk; and Vice President General Jack Coleman. First time attendees were asked for and John Williams, Jr., and Frank McWilliam were introduced.

Secretary Kevin Yarnell certified that a quorum was present. President Miller asked for the approval of the minutes of the last meeting Parliamentarian Rollin L. Bauchspies, Jr., offered the following corrections for the Fall BOM Minutes: that the word elected should read, nominated, pertaining of the National Trustee referred to in paragraph 8; and that the word nominated be used in place of the word appointed in reference to the Nominating Committee in paragraph 9. The corrections were accepted and the minutes were than passed as corrected.

Reports from National Officers were called. President General Carl Hoffman asked to give all of his reports at this time. He reported that changes in by-law #21 has a error in regards to monies and handed out the corrected by-law changes, to be made part of these minutes. He reported the results of the Nominating Committee and those nominated. They will be published in the Spring issue of THE FLORIDA PATRIOT and are made a part of these minutes. He thanked his committee. He reported that only two Florida chapters have tax exemptions, Saramana and Jacksonville, and suggested that other chapters check into the process of tax exemption with Comp .George Lockhart. He reported that in the offering of associate membership by our chapters, those so elected can not serve in leadership roles. He also reported that he went to his local Wal-Mart and solicited funds for the Florida SAR Youth Programs and was given a check in the amount of \$1000.00. He suggested that we all could go to our local stores.

Vice President General Sympson suggested that the chapters obtain a manual for the Color Guards from the Louisville Chapter for \$10.

Vice President General Phil Carr reported on the EMS awards, and Comp. Lindsey Brock showed us a proposed drawing of it, if approved by the National Congress.

Registrar General Richard Friberg reported on the up coming CAR meeting in Tampa.

Boy Scout Committeeman Bob Burk reported that about 40 applications for the National Scout award will be judged in Louisville at the Fall Trustee

Meeting. That the Scout Committee is soliciting funds for the cash awards that are given each year.

Alternate Trustee Frank Hodalaski's report was lost in transcribing.

Reports of the Florida State Officers were called; they and those of the Committee Chairman are found in the Quarterly Reports which are part of these minutes, along with additional comments and reports.

State Secretary Kevin Yarnell added to his report his thanks to the chapters for their timely reporting.

State Treasurer James R Holyfleld reported that our State Society was in good financial shape with an excess in the bank.

State Registrar William R. Stevenson reported that approval of applications was now much harder at the national level

President Miller adjourned this section of the BOM until 8:45 A.M. Saturday. Chaplain Schafer gave a benediction at 10:10 P.M...

The BOM reconvened 8:35 A.M.

Vice President General David Sympson reported that he had a call from National Headquarters and that the wife on Executive Director Jim Randall was mauled by a dog on Friday and has had over 900 stitches and has nearly lost an arm. Comp Coleman asked that the Florida Society convey its concern and that we all pray for a speedy recovery.

The State Officers Reposts continue with Secretary Kevin Yarnell distributing a corrected copy of all committee members to the BOM.

President Harold F. Miller, Jr., Chairman of the Executive Committee reported that the Committee met at 3 P.M. Friday. There was a discussion of the short fall in the monies of the Endowment Trust Fund and how to over come this in the future. As it turns out the short fall in much less at the time of this report then originally thought to be. \$185.00 is the correct figure. He assured the BOM that all requests for reimbursement filed in 2004 will be paid in full to the amount allowed. He reminded the BOM that requests for reimbursements before the event will not be considered. The Executive Committee requested that their be a moratorium on all disbursements for the first quarter in 2005 and that an Ad Hoc Committee be convened to look into the long term problems and to find a solution. Appointed were, Compatriots Harry Hollien,, Frank Hodalaski and Rollin Bauchspies, Jr. Comp. Jack Coleman spoke at this point as to our obligation to the state society to furnish the necessary capitol. He suggested that he will make a contribution to the trust fund on each of his birthdays, and he challenged us to do the same.

Senior Vice President Harry Hollien presented to the Executive Committee a discourse and paper on the formation of an "Honors Council" The purpose of this is to recognize and use the talents of our senior members, some of which can not attend our meetings. A motion was made by Frank Hodalaski and seconded by Comp. Steve Stevenson that this Honors Council should be formed in principal as presented by Senior Vice President Harry Hollien This motion

passed. The President formed an Ad Hoc committee of the following compatriots, Carl Hoffman, Harry Hollien, Phil Carr and Jerry Meeks for the purpose of working out the details of implementation. A copy of the Sr. Vice President's proposal is made a part of these minutes.

Standing Committee Reports are printed with the following additions.

Archives Committee Chair Comp. Kevin Yarnell elaborated on his report with much discussion from the members Comp Genealogist Alvie L. Davidson offered to help into looking for a cost affected way to enter our records in an electronic format. A repot will be presented at the Spring BOM
