On November 3, 2005, two days before the deadline for the Fall issue of the Patriot, I received a submission from President Hollien titled "Challenge II." Dismayed after reading it, and to insure that my actions were not biased by the erratic behavior of President Hollien in the last two BOMs, I requested the assistance of a number of well respected members of this Board, all with impeccable credentials, stellar service in the Society and well loved by all, to whom I did not disclose my opinion, but with whom I shared the article. I could not agree more with the comments received in reply to my request for assistance and that are made a part of this report (see Annex A). Had I not found the objections below, these would have sufficed. But the decision not to publish the President's article was ultimately mine and, *noblesse oblige*, I must make my reasons known. I believe that as an elected officer who answers solely to the Board of Management, the only appropriate forum for this action is through this Editor's Report.

The "Challenge II" is, as many have noticed, a poorly written harangue more than an article (see Annex B). However, it would not have been the first nor last time that someone's face was saved by editorial privilege and creative rewriting. However, I do not believe that that privilege extends to changing the meaning and overall thrust of an article and it is that meaning and that thrust that I have found beyond improvement in President Hollien's submission.

It is not just that this article is long in fear-mongering, non-sequiturs, and inconsistencies, completely devoid of facts and, as one of the members consulted defined it, just boring. For were it to be redone in a lively prose and well-though argument, the essential bigotry of the libel and its inconformity with our purpose and objectives would still remain

Let's be clear. Like many members of this society I, too, agree that illegal immigration is a problem. I fought it in business to the extent of my abilities and will continue to do so. That said, and in spite of its sub-titles and leads, the tract does not refer to "illegal immigration" at all, but rather to *ALL* immigration: legal or otherwise. In fact, President Hollien makes it crystal clear: "both legal and \*especially\* illegal," in case one missed the point. He then goes on to recommend that we all: "Listen to Americans for Immigration Control."

Just who are these folk we are told to listen to?

Americans for Immigration Control is a nativist and ethnocentric organization that sponsors a slew of anti-immigration propaganda that not always stops short of hard-core racism. It is run by an assortment of "biological determinists" and "white nationalists" like Brent Nelson, who sits on the board of AICF and in the Advisory Board of the "Citizens Informer," (flagship publication of the white-nationalist Council of Conservative Citizens); or John Vinson, AICF President and editor of "Immigration Watch;" or Robert H. Goldsborough, executive Director of AIC and a self-styled "conspiracy scholar" who rants against Jews, Masons, the Trilateral, Skull & Bones, the Clintons, the Bushes, the Bildenbergers, The Council of Foreign Relations and all that "conspiracy theory" nonsense. Goldsborough tells us: "The economic problem of America and the world is ultimately a Jewish question" and that-paraphrasing Henry Ford (whose Nazi sympathies were never a secret)-- "The money question, properly solved, is the end of the Jewish Question."

There are many members of this society who 60 years ago sacrificed their all fighting against this kind of fanaticism. But President Hollien says in his "Challenge II" that we should *listen* to this!

There are too many who sacrificed too much the last time a bigot spoke of the "Jewish Question" to tolerate such abhorrent propaganda among us.

But President Hollien says we should *listen* to one such propagandist.

This fellow Goldsborough also claims in numerous tracts that Masons (allied with Jews) are bent on establishing a "New World Order," and that they (the Masons) worship the devil. There are many members of this society who would be amused if not offended to know of their heretofore unsuspected "nefarious activities."

And President Hollien tells us to *listen* to the author of this diatribe!

One of the principal financial backers of the AIC is the Pioneer Fund, a foundation linked to eugenics and other "racial" research. According to the Study of Academic Racism, since its founding in 1996 this latter day Mengueles have contributed nearly 200,000 dollars to AIC because "the two organizations share essentially the same goal: to stop immigrants from the Third World from settling in the US."

And President Hollien would have The Patriot record the support of this society to these people, by telling our members to *listen* to them!

In another part of this *Magnus Opus*, President Hollien refers to what he terms "*runaway immigration*" (again, not just illegal, but *ALL* immigration) which he singles out as a culprit for crime, terrorism and what have you. In a tirade long on emotion and--as should by now be expected--merrily unburdened by any facts, President Hollien attempts to raise our level of suspicion towards all immigrants.

If the association with the AIC were not enough to run for cover, the wholesale condemnation of "runaway immigration" as the root cause of every evil with what we may safely call unsubstantiated fear-mongering surely should be. Consider these statements: "*Terrorists arriving as illegal aliens in order to develop cells dedicated to the destruction of our homeland*" or "*the big corporations invest large amounts of money in supporting ethnic identity (especially for the illegals).*" The fact that not a single illegal alien has been linked to terrorism and that, in point of fact, all that were so identified were either born here or entered the country legally seems not to bother the writer. Nor is he bothered by the fact that not a single corporation, big or small, has spent a single dollar supporting the "ethnic identity" of a single illegal alien. Facts seem to have a way to completely escaping his grasp. As another member of this society has so eloquently put it to me, if the previous statements were the case, then the following would necessarily follow:

"...anyone who hires an illegal immigrant is potentially supporting terrorists in this country and abroad. Such acts are treason of the highest order and indeed can be likened to giving the enemy safe harbor. High treason deserves high punishment and that can only mean death. If we were to simply arrest, try, convict, and execute all of those who hire illegal immigrants, including the corporate officers and board of directors of those companies who have indirectly supported such policies within their companies, then I suggest that the influx of illegal immigrants would be reduced to a trickle within a matter of months after the first execution. When swift and stern justice enters the lives of those who reap the real monetary benefit of illegal immigration, then we will see results. After all, anything less would be un-American."

Sometimes, there is nothing like an old-fashioned reductio ad absurdum to prove the fallacy of an argument!

In "Challenge II," reality is never allowed to interfere with prejudice, so why let facts interfere with the President's harangue? After all, "immigrants" pollute our culture and our way of life. As Mussolini's minions decried in "La Difesa della Razza" (In Defense of Our Race) in 1938, "The Italian race has remained pure for 2000 years." The Italian fascists seemed to be as undisturbed by the long history of Goths, Visigoths, Greeks, Saracens, Longobards, Franks, Norse and every other race in the known world mixing it up in the Italian peninsula as the author that occupies us today seems to be undisturbed by the many immigrant influences that gave us bagels, corned beef & cabbage, spaghetti al pomodoro, bratwurst, fish & chips and every other dish, religion, language and culture known to man from the very beginning of this Great Republic. And in the process of so doing, these very immigrant currents contributed to our nation some of the greatest men and women ever spawned by the human race.

Somehow, I think there is nothing more American than a Senegalese having a kosher diet-coke at a Chinese restaurant in Little Italy. And I find myself in good company:

"If there is a country in the world where concord, according to common calculation, would be least expected, it is America. Made up as it is of people from different nations, accustomed to different forms and habits of government, speaking different languages, and more different in their modes of worship, it would appear that the union of such a people was impracticable; but by the simple operation of constructing government on the principles of society and the rights of man, every difficulty retires, and all the parts are brought into cordial unison."

And, certainly, AIC and its proponents are not without ignominious precedents, tough I will mention but one:

"If some means are not adopted to prevent the indiscriminate admission of wild Irishmen and others to the right of suffrage, there will soon be an end to liberty & property." Harrison Gray

Much of the rest of the libel is dedicated to promoting "Mexifornia," a blurb so preposterous as to deserve no serious argument and, like President Hollien's libel, a work unencumbered by any reference, footnote, fact or figure. The only thing that becomes apparent in "Mexifornia" is Victor Davis Hanson's absolute ignorance of anything Mexican, his bigotry and his resentment. In full knowledge of his own prejudice, he resorts to the racist's old copout: He loves Mexicans. In fact, he has Mexican friends! Paraphrasing Dr. Walter A. Ewing, a Research Associate with the Immigration Policy Center, "Mexifornia" is but a confused diatribe by one angry and very frightened man who persists in undermining his own arguments in a context of intellectual vacuity, devoid of any pretense of scholarship, objectivity or even a shadow of academic professionalism.

But President Hollien thinks we should all read and *believe* it, and base our own actions on its ill-natured stereotypes!

President Hollien would do well to listen to our President in this subject:

"The long term solution, however, for immigration is for Mexico to be prosperous enough to grow a middle class where people will be able to find work at home. And I remind people all across our country, family values do not stop at the Rio Bravo. There are people in Mexico who have got children who are worried about where they are going to get their next meal from. And they are going to come to the United States, if they think they can make money here. That's a simple fact. And they're willing to walk across miles of desert to do work that some Americans won't do. And we've got to respect that, it seems like to me, and treat those people with respect."

There is one last point that I found neither inane nor revolting as most of the others, and yet oddly illuminating: It has to do with a piece of tax legislation under consideration by Congress. President Hollien writes: "And, just wait until Social Security collapses, as it will if the proposed law extending it to Mexicans is passed (i.e. the so-called "Totalization Treaty")!!"

How will Social Security collapse by adding Mexico to the 23 other countries that are part of this interesting and useful program, President Hollien does not say.

Alarmist remarks aside, a *Totalization Agreement* (not a *treaty*, mind you), serves to remedy an inequity in the taxing of non-immigrant foreign nationals working in the United States, who often find themselves liable for US taxes as well as those in their country of permanent residence. In fact, once the agreement is resolved it tends to result in more taxes paid in the US, as these are generally lower than that of other countries, especially since by virtue of the agreement, payments to the US system qualify for benefit eligibility in the home country. Since an individual does not qualify for Social Security unless he or she completes a minimum number of "quarters" (essentially 10 years of contributions), most of these temporary residents would never qualify for benefits in the US and thus end up making non-refundable contributions in exchange for nothing at all, a fact that has led many foreign nationals temporarily in the US to avoid paying any US contributions altogether. With a Totalization Agreement, these contributions count in determining home country benefits and hence tax evasion is significantly

reduced. There are currently Totalization Agreements in place with Australia, Germany, Portugal, Austria, Greece, South Korea, Belgium, Ireland, Spain, Canada, Italy, Sweden, Chile, Luxembourg, Switzerland, Finland, The Netherlands, France, Norway and the United Kingdom.

What is President Hollien's point, then?

Frankly, I doubt he has one. Scaring the audience into a knee-jerk reaction to his hate-filled speech seems to be all of what we might call purpose in his ill-natured tract.

I believe it is not my prerogative but my *obligation* to exercise my best judgment in fulfilling my editorial duties under Section 13 of our bylaws, as mandated by the BOM. President Hollien's crude and often ungentlemanly attempts to impose his will, usurp the editor's authority and prevent the performance of his duties in order to visit upon the membership articles that have nothing to do with the purpose of our organization in detriment of those who do have something relevant to say have been a nuisance, to be sure, but one that I will continue to endure as heretofore while endeavoring to produce the best publication I possibly can within the parameters of our bylaws and the NSSAR guidelines (see annex C). I am grateful to all the members who have shown their unqualified support in this work and who have provided valuable knowledge, time and effort in making our award winning publication one of the best in the country.

In short, I believe illegal immigration is a big problem just as much as I believe that there are laws in the books to deal with it. Further, I don't believe now nor do I think I can be persuaded to believe that immigration as a whole is any kind of scourge or danger. Much to the contrary, I believe it is and has always been an essential part of our very nature as Americans. But that is irrelevant. What is relevant is that President Hollien's article **is not in conformance with the bylaws of the FLSSAR** and rather than representing the Society in its best light, it is a borderline hate-mongering piece that places the Society in the middle of a political issue in which it has no business and that bears no relationship to the Chartered purposes of the Society. I also believe that biological determinists and other bigots are as dangerous as they are revolting, and that by linking our publications to their disgraceful arguments we would be doing ourselves and the FLSSAR a great disservice, just as great as the one we would do were we to follow President Hollien's advise and thrust our programs, including our youth programs, in the midst of that partisan political battle. And it would not only be a disservice, it would be an egregious violation of our Constitution and bylaws.

Our purpose is clear and clearly stated in the NSSAR's Constitution and bylaws:

"The SAR is a historical, educational, and patriotic non-profit, United States 501(c) 3, corporation that seeks to maintain and extend

- \* the institutions of American freedom
- \* an appreciation for true patriotism
- \* a respect for our national symbols
- \* the value of American citizenship
- \* the unifying force of e pluribus unum that has created, from the people of many nations, one nation and one people.

We do this by perpetuating the stories of patriotism, courage, sacrifice, tragedy, and triumph of the men who achieved the independence of the American people in the belief that these stories are universal ones of man's eternal struggle against tyranny, relevant to all time, and will inspire and strengthen each succeeding generation as it too is called upon to defend our freedoms on the battlefield and in our public institutions."

Any departure from this clear purpose in the pursuit of partisan political objectives is worse than folly. It is a betrayal to the principles of our beloved institution and the very nature of our organization. May all our members shun any such efforts with unyielding conviction!

### Annex A (Editor's Report)

The following are excerpts from members of the FLSSAR regarding the President's "Challenge II." As I have not requested their authorization to quote them, I am not revealing their identity in this presentation. Most are frequent attendees at the BOMs and have had a distinguished career in the FLSSAR and NSSAR. All responded to my request for assistance and, while some agreed with the opinions of President Hollien on immigration and others did not, all but one opposed printing the article in the Patriot, and that one not without misgivings.

- "...it was so long it began to border on a harangue ...are his views of a political nature and does he have the right to use, as a sounding board, a magazine that is sponsored by an organization that must, for obvious reasons, remain apolitical?"
- "True patriots differ in their views on some of the concerns the President lifts up. Even many very conservative persons, such as me, would have difficulty with his thoughts we eschew bigotry and the America First movement, which have plagued us in past generations. We draw different conclusions than the President with respect to the issues he raises. I once resigned from my SAR chapter...because the President of the chapter insisted on expressing views in our meetings and newsletter which might be expected of a spokesperson for the John Birch Society, and in some cases even the KKK."
- "I have always believed that the Florida Patriot should serve two primary purposes...the first and foremost being to inform the members of the Florida Society of what our society is doing and secondly to recognize those Compatriots who are making those things happen. In my opinion, the "President's Message" should be sufficiently short to allow it to fit on one page."
- "...the magazine is no place for political rhetoric."
- "...this piece should have no place in the pages of The Patriot. While the sentiments expressed may be shared by many others, the author should pursue more appropriate vehicles of expression-there are plenty of them out there. He should not exploit his position in this organization by using it as a bully pulpit."
- "Even my wife...objected to the tone and blatantly biased hostility of the piece."
- "[I] question whether you should publish the article."
- "...it may well be offensive to a number of other members of the society and does not appear to take an apolitical position if the SAR is to remain as a 501(c) 3 non-profit organization"
- "...submitting an article of four and a half pages, as the President's Challenge appears to be, is out of order since it is not submitting timely and pertinent information respecting the affairs of the Florida Society to the membership. In fact, the length of the article is denying the membership from obtaining information of the affairs of the Society since the President's article takes over one fourth of the PATRIOT magazine"
- "Although this is not the first instance of a president attempting to use FLSSAR as a means of distributing his personal political position it is still not appropriate. Attempting to do so will, in no way, effect our 501 (c) 3 status, in my opinion, but it is an affront to every member of the organization."
- "I could go on and on but that is the problem with Challenge II: It is too long, verbose, and badly written. Will there be a "Challenge III and IV"? Installments would leak into the next administration... Instead of being alarming it is boring. Instead of a "call to arms," a "Challenge", it is, well...boring."
- "President Hollien would be better advised to concentrate his efforts privately in that arena and not risk alienating members."
- "Your work in producing an extremely fine "Patriot" is to be commended."
- "the editor [is] doing his usual good job. There is no debate about who has control of the content and publication of the "Patriot". Our bylaws are very specific. The editor is in charge!"
- "If that harangue were to be published I would immediately resign from the SAR."
- "As editor of the Patriot, you are charged with making decisions affecting the content of the magazine. Until that authorization/responsibility is properly rescinded by the FLSSAR Board of Management, you are allowed (and obligated) to continue exercising your own good judgment regarding content and format."
- "The Editor must have final say. The magazine should provide space for committee reports and news from FLSSAR and chapters. The material in the President's submission is very political and biased, and does not deserve a place in The Patriot."

"Who wrote this, Goebels?"

"It is important to me to not have that article published under the auspices of the Society. If he wants to publish it somewhere else, that's fine--the Constitution protects that. But the Society has the right to not have words forced upon it that have nothing to do with the purposes for which it was founded."

One of the members forwarded the following, published in 1945, which he has kept in his files since returning from WWII to remind himself of the idiocy of fascism's notions of racial and cultural "purity:"

### **Annex B (Editor's Report)**

The following is the unedited text of the so-called "Challenge II" as it was presented for publication on November 3, 2005, two days before the deadline

\*CHALLENGE II: CONTRIBUTING TO OUR SURVIVAL\*

\* \*

We all know that SAR is \*NOT\* a political outfit. It is a patriotic, historical and educational Society. Note especially the words "patriotic" and "educational." However, we also should realize that we are fully within our mandate and missions to work to defend our great country and teach other Americans how to do so. And, if by doing so, we help

preserve our Society, it is all to the good. As a matter of fact, the survival of our great society -- and our good works -- should be a primary goal of ours.

#### \*THE THREAT\*

As I stressed in my first "Challenge" article (see the Summer issue of this journal), one of the top threats to our Society – and, indeed, to America itself – is our rapidly shifting culture. While this great "blob" (remember that old movie?) which is descending on us has many facets, its core is formed by multiculturism [SIC]. "This threat is pretty vague," you say, "I don't see it as a real problem." Well, if that's the way you see it, you are wrong. This crisis is real; it is here right now. Moreover, as well as having many dimensions, it has many causes which are complex and can be difficult to understand. Certainly, to review them all would take many essays such as this one. Worse yet, it is much too great a challenge for any one of us to try to fight them all. Nevertheless, there is one major element (or source) about which we all should be able to agree no matter how we feel about some of multiculturism's [SIC] other parts. It involves a reform that will both aid in maintaining much of what is worthy in these United States and also a reform which will assist the SAR in surviving as an entity.

#### \*A SPECIFIC\*

What is this "force" that needs to be reformed? It is one of the most powerful engines which drives the rise of multiculturalism. Specifically, it is runaway immigration. Not concerned? Let's take a look at this problem.

#### \*THE CASE AGAINST ILLEGAL IMMIGRATION\*

First off, let's look at illegal immigration and how it operates to drive multiculturism [SIC]. For perspective, you might do well to read Victor Hansen's "Mexifornia". In it, he shows just how immigration – both legal and \*especially\* illegal -- has a profound effect on the growth of multiculturism [SIC]. He describes how it is systematically destroying California. With inroads in Arizona, New Mexico and even Florida, uncontrolled immigration appears to be marching both up and across our nation. He demonstrated that, if not stopped, it alone could rob us of our Culture and, with it, the American Dream. As a primary root of multiculturism [SIC], it is even more destructive.

\*Still\* not worried? Listen to Americans for Immigration Control which is one of the societies that document this threat. It does so by describing the effect/nature of the wide open Mexican border \*plus\* the many other serious "leaks" that exist in our own ports and with Canada.

For example, they point out that, in the year 2000, census-takers counted over 8.7 million illegal aliens living in our country -- and how many are here today? Eleven million, 12 million (one outfit claims that there are 20 million illegals in the U.S.)? Worse yet, as U.S. Border Control tells us, if the amnesty planned by the White House and Congress

occurs (it is shamefully called "the Secure American and Orderly Immigration Act"), each of those millions of criminals will be rewarded for breaking our laws both by being given U.S. citizenship and also by being allowed to bring in endless members of their families (i.e., under the Family Reunification Laws). Amnesty proponents argue that even

though illegal, these "undocumented workers" contribute to our Society. This claim is patently false! Actually, in the year 2004 (alone), they cost us (the taxpayers) over \*\$68 billion\* for "services", \*\$7 billion \*for welfare\*, \$28 billion\* for billingual and other education programs and over \*\$133 billion \*in job losses (see also G. Borjas). And, just wait until Social Security collapses, as it will if the proposed law extending it to Mexicans is passed (i.e. the so-called "Totalization Treaty")!!

This threat goes on and on. 1) From Terrorists arriving as illegal aliens in order to develop cells dedicated to the destruction of our homeland to that great mass of individuals just as dedicated to the destruction of our language (the Department of Justice alone spent \$27 million last year helping to set up U.S. election ballots, U.S. drivers' licenses, etc. in foreign languages); 2) from the EEOC actually suing companies for requiring "the use of English in the workplace" (M.E. Mujica, U.S. English) to the many business firms that give the illegal aliens jobs (also illegally) thereby taking them away from our unemployed (which still is over 5%); 3) from the 34% of all auto thefts committed by illegals [SIC]to the over 400,000 of them who draw Social Security "without having worked one day in America" (AFIC). And so, on and on and on! Pretty grim, what? You betcha! [SIC]

And how do all these illegal aliens add to -- and even accelerate -- the devastating cultural changes that are occurring? They do so in many ways. An example: many of them are blatantly using us, while openly hostile to our way of life. What appears to be a majority of them refuse to assimilate (unlike virtually all of our past immigrants). Moreover, the "politically correct" crowd exploits them in an effort to destroy our culture. Indeed, they are now trying

to make it a crime for Americans to combat this horde of invaders by even criticizing them.

In his a brilliant article on "Nine Ways to Destroy America," former Governor Richard Lamm (Colorado) puts it all together. He stresses that all one has to do to destroy the U.S. is to use these millions of illegal aliens (along with other forces, of course) to "turn American into a multilingual and multicultural society." In turn, he cites Lipset in pointing out that such "celebrations of diversity" have almost universally led to conditions of "turmoil, tension and tragedy" and done so in \*any\* country where they have been allowed to exist. Look at the grim problems which exist in Yugoslavia; those in the "two" Canada's, those found in India and Pakistan (even though they are now separate countries), those in Malaysia, in Lebanon – even in Belgium.

Gov. Lamm further argues that one of the best ways to destroy our Culture – and along with it, the most unique country that has existed in all of human history – is to force diversity on our population. By this, he does not mean that we should not learn to understand and appreciate other cultures but rather to actually diversify ours. To do so, all that needs to be done is to establish that "all cultures are equal," then have the big corporations invest large amounts of money in supporting ethnic identity (especially for the illegals [SIC]) and establishing the cult of "victimology" [SIC] (by ensuring that all minorities understand that their lack of success is due to the nastiness of the majority for, after all, "America is evil"). It will be necessary, further, to prevent appropriate discussion and debate by making it taboo or illegal to talk or write anything detrimental about the cult of diversity, illegal aliens, or any minority, to prevent immigration laws from being enforced and so on. Does all this sound familiar to you? That is what is happening in America today. If you don't think so, just spend a few days at any one of our universities.

#### \*A RESPONSE\*

Is it really possible that we are going to let this great "blob" of multiculturalism sweep over us and destroy our great country – and with it, the SAR – and do so without any response at all? Can we really buy into those slogans found in Orwell's "1984" – ones like: "freedom is slavery, ignorance is strength"? Not me -- that is, if I can help it. How about you? But, as I've said, we cannot at once reform all of the many things that have gone wrong. However, along with the many Americans who are beginning to realize the magnitude of these threats and are trying to do something about them, we can first help by joining one or more of the many "grass roots" organizations which are countering this threat, ones that are springing up all over the U.S. We can support them, add to their leadership and, by doing so, help resist the advance of the "blob" -- we can enhance the status and continuance of our Society as well. If each of us does a little and we all work together, the total output there should be productive. But, what can we do specifically?

#### \*REFORM\*

As I suggested above, we should first make our position about multiculturism [SIC] known (well-known) and aid in the grass roots efforts against it. We then can focus our efforts on a single but important primary cause -- that of countering illegal immigration and reforming its out-of-control elements. Note, however, that we should not be seen as "going back" to the "old, tired ways". Rather, we should make it clear that our goals actually are to reform and upgrade multiculturalism and multilingualism in such a way that they become consistent with \*our\* basic Culture rather than compete against it.

Our efforts to help eliminate illegal immigration can be a powerful weapon in this cultural battle -- and, they should be popular also. But how do we accomplish these worthy objectives? Happily, we already have a number of programs in place which provide immediate vehicles for stressing that "new" culture based on the "unum" in "epluribus unum".

Our five youth programs, our History Fairs, the Education program, our Speakers' Bureau and especially our new Public Relations thrust all exist right now. They can become an immediate platform for what we are trying to do. That is, we can use them to take a stand for reformation.

This approach should be based on the tenants articulated by our Founding Fathers; we should unabashedly work to reduce diversity by replacing it with a single language and American Culture as it should continue to exist. These overall goals can be specifically furthered by our efforts to reform the status of illegal immigration.

The nine committees named above can immediately initiate both useful shifts in their overall philosophy and practical thrusts which can serve to support our efforts. For example, the next topic for the relevant youth programs could be "How Illegal Immigration is Degrading American Society". Secondly, a number of Compatriots could volunteer for the FLSSAR Speakers' Bureau and provide speeches with the same type of message. Yet another example -- once our "Keyhole to History" spots are up and running, we could develop

another set entitled something like "Highlights of American Culture". There are many things that we can do with only small changes in the programs we presently are conducting.

It is time to end this section of my challenge to you. So, what are your ideas? Are we really ready to take a stand for\* \*our Society, for our "way of life", for our Country? Will we help by developing a cohesive program to reform the present chaos in the country's immigration policies? Is illegal immigration an effective focus? If you agree, let us try to develop some innovative programs which will supplement those suggested above.

### Annex C (Editor's Report)

FLSSAR bylaws - Section 13. Editor

It shall be the duty of the Editor to prepare, to publish quarterly unless otherwise ordered by the Board of Management, and to distribute to all members of the FLSSAR, THE FLORIDA PATRIOT magazine, in such manner and style as to accomplish the following objectives:

a. to inform the members about recent happenings and present or planned activities and programs of the FLSSAR and NSSAR, of the Chapters, and of the members;

b. to disseminate official information, such as minutes of meetings, notices and agenda for future meetings, financial and other reports, proposed bylaw amendments, announcements, and the like;

# FLSSAR Committee Report Charter & By Laws

Chairman: Lindsey Brock 29 December 2005

Committee Members: Lauren Bradley, Vice Chairman, Clearwater Chapter, John Cahoon, Emerald Coast Chapter, Dr. Robert Danneman, Ocala Chapter, Albert Snapp, Lakeland Chapter and John Tinny, St. Augustine Chapter.

The first two bylaws amendments were submitted by Sam Boone of the Gainesville Chapter and both propose to add a new Section to Article III Officers and Article V Committees.

### Article III Officers – proposes to add the following new section:

Section 7 Tenure

"The president and senior vice president are each elected for one-year terms and may not be again elected to either of these offices until a period of two years has elapsed. All other officers, except the secretary and treasurer, shall hold office for no more than three consecutive one-year terms. The secretary and treasurer may be elected for up to five one-year terms."

### Article V Committees - proposes to add the following new section:

Section 7 Tenure of Chairmen

"Since the chairmen of all committees (statutory, standing and ad hoc) are appointed by the president, the term-of-office of all committee chairmen will be co-terminal with that of the president who appointed them. The chairman of all committees can be re-appointed by the succeeding president; provided, however, no compatriot shall serve as chairman of any given committee for more than three consecutive one-year terms."

**Recommendation** by the Charter and Bylaws Committee: The committee recommends that the BOM not adopt the addition of Section 7 Tenure and likewise the committee recommends that the BOM not adopt the addition of Section 7 Tenure of Chairmen.

The second proposed bylaws amendment was submitted by Jack Coleman of Jacksonville Chapter and he proposes that our BOM meetings be changed from four meetings a year to three.

#### Article II The Board of Management, Section 3 Meetings.

Section 3 Meetings of FLSSAR's Bylaws are currently as follows:

- "The Board of Management shall hold at least four regular meetings each year, as follows:
- a. a meeting in either June, July, or August, to be known as the Summer Meeting;
- b. a meeting in September or October, to be known as the Fall Meeting;
- c. a meeting in either January or February, to be known as the Winter Meeting; and
- d. a meeting on the day before the date fixed for the opening of the Annual Meeting of the State Society, to be known as the Spring Meeting."

**Recommendation** by the Charter and Bylaws Committee: The committee recommends that the BOM not adopt the proposal to reduce our BOM meeting from four to three.

The third proposed bylaws amendment was submitted by President Harry Hollien of the Gainesville Chapter. This proposed would add a **Section 7 to Article III** Officers of FLSSAR's Bylaws.

President Hollien's proposed amendment states:

- "That the following officers shall be required to arrange for the appointment of an Assistant. The appointment process would involve nomination of the Assistant by either the Officer or the BOM, with the approval of the other. The role of the Assistant would be to assist and understudy the Officer in his duties for the purpose of improved efficiency and continuity of office. The Officers included in this group are:"
- 1. Secretary, 2. Treasurer, 3. Registrar, 4. Chancellor, 5. Chaplain, 6. Genealogist, 7. Historian, 8. Sergeant-at-Arms, 9. Editor.

**Recommendation** by the Charter and Bylaws Committee: The committee recommends that the BOM not adopt the proposal to appoint an Assistant to the nine (9) Officers included in this proposed amendment.

We will continue to structure this report in two parts.

### A. American Heritage (Hollien)

Efforts are still underway to identify a committee member who will lead our Home School CD distribution program. Second, we now have but few (CD) units available and will either attempt to procure a supply from NSSAR or seek funding in order to burn our own copies (NSSAR has indicated that it would provide us with the labels). We have been approached recently by one of our consultants (Jack Boove). He is interested in placing a copy of the CD in the hands of each History teacher in the county he supervises. Also, a county in our SE district also has shown interest.

#### B. Legislative (Toops)

Recently, I met with the Senior Legislative Assistant to Florida State Senator, Cary Baker, and shared with her information received from the Social Studies Supervisors' meeting held earlier in the year. I communicated that it was my opinion that most of the Social Studies teachers in Florida have a good understanding of what should be taught in that area—which, as you know, includes American History and American Government. However, it also is apparent that a serious problem within the state is that some school administrators, some DOE personnel and some legislators do not support putting any emphasis at all on the teaching of Social Studies. These same individuals certainly do not want to measure the performance of our students, nor do they want their particular school's performance measured for those subjects which are within the realm of the Social Studies. It is also evident that it is difficult for a teacher to object strongly to these adversarial efforts as his/her performance reviews, pay and job depends on those same individuals.

In this regard, I suggested that one approach would be to interview, anonymously, teachers and social studies personnel to determine the truth. The Senior Legislative Assistant stated that she would share our conversation with Senator Baker. It was her thought, however, that Senator Baker would have to request that a committee be formed within the Florida Senate, one that would be chartered to evaluate the issues associated with the teaching and measuring performance of Social Studies to our Florida students.

At this time, it is my belief that the Education Committee should regroup and define a state-wide strategy for assisting our legislators and Social Studies teachers with this problem.

# Winter Board of Management Meeting

January 6<sup>th</sup> – 7<sup>th</sup>, 2006, Lakeland By George A. Lockhart, Recording Secretary

The meeting was called to order by Senior Vice President, Lindsey Brock at 9:52 PM, Friday, January 6<sup>th</sup>, 2006. Chaplain Charles Schafer gave the Invocation. Compatriot Brock announced that President Hollien was attending the meeting of the Ladies Auxiliary. He then proceeded with receiving reports from State Officers. Those reports are found in the Quarterly Reports which are made a part of these minutes, along with additional remarks and reports. Secretary Yarnell encouraged all chapter officers to communicate chapter events to the state promptly; particularly death notices and address changes. Treasurer Jim Holyfield handed out the Treasurer's report. He reported that the state had an excess of receipts over expenditures of \$6,651. He also stated that the state has total assets (cash, certificates of deposit and investments) of \$65,649 and no liabilities. He thanked everyone for getting their dues in on time. The question was asked as to how many paid members there are. Secretary Yarnell replied that as of the meeting there were 1,511. That means that more than 200 compatriots have not renewed their dues thus far. Registrar William Stevenson reported that the state had received 31 membership applications, 61 were carried over from last year, 81 were pending at National and 11 had been received from National. He reported that 24 supplemental applications had been received by the state, 83 carried over from last year, 95 pending at National and 12 had been received from National. In this group there was one memorial application, 1 Junior application and 2 Youth applications. Chancellor Carl Hoffmann reported that there was no litigation pending. He reiterated the potential for donations from Wal-Mart. The Sergeant at Arms, Lonnie Jones reported that the state had received a new streamer for the flag for our participation at the Kings Mountain event. The Editor of the Florida Patriot, Saul Montes-Bradley reminded the BOM that the deadline for submission of item for publication was 20 January 2006. John Cahoon, Chairman, Patriot Medal Committee reminded the BOM that nominations for the Patriot Medal need to be made by close of business Saturday, 7 January 2006. It was reported that the Chapter Challenge criteria was being sent to the Regional Vice Presidents for further distribution to the chapters. Lindsey Brock, Chairman of the Charter and By Laws Committee presented the proposed by law changes and recommendations of the committee for consideration, comments or recommendations by the BOM. Voting on the amendments will be done at the annual meeting in Gainesville. Compatriot Brock introduced the members of the committee and then discussed each proposed by law change.

The meeting was turned over to President Hollien who received the report of the nominating committee. Dick Fowler, Chairman of the Nominating committee reported a correction to their report in the that the National Trustee and National Trustee (Alternate) are not nominated by the committee but rather are selected by the Board of Management at its annual meeting. Nominations from the floor will be received at the annual meeting. Having finished the report of the nominating committee the Board of Management returned to the report of the Charter and By Laws committee. Carl Hoffmann recommended a vote against the proposed revisions to the tenure limitations on the Secretary and Treasurer. John Cahoon asked if the Board is required to act on the committee report so actions can be taken to present the proposed by law changes to the membership for action at the annual meeting. Jack Coleman moved and Carl Hoffman seconded a motion to accept the recommendations of the Charter & By Laws Committee regarding four by law changes submitted at the Fall BOM. Specifically, the Charter & By Laws Committee has recommended against the adoption of each of the four changes. After discussion, the motion passed. The proposed by law changes and recommendations of the committee and Board of Management will be published in the next edition of the Florida Patriot. The Chairman of the CAR Liaison Committee, Richard Friberg in giving his report moved on behalf of the CAR Liaison Committee that the FLSSAR award the C.A.R.-SAR medal to the C.A.R. state president Miss Robyn Carroll for the excellent work she has done this year leading the F.S.C.A.R and that the FLSSAR award the senior state president of the F.S.C.A.R. the Martha Washington medal in appreciation for all the work she has done for the Florida C.A.R. He also moved that the BOM approve a \$1,000 donation to the F.S.C.A.R. to be presented at the state C.A.R. annual meeting in Altamonte Springs during the weekend of March 30th – April

1st. Frank Hodalski advised the BOM that in the past monies donated to the Boy Scouts and C.A.R. came from excess funds in the Endowment Trust Fund, if there were any, and that there was a standing order that we must earmark these funds and there must be funds available and that we know where these funds will come from before we disburse them. President Hollien asked if there were funds budgeted for this item. Answer, no that funds would need to be reprogrammed from the \$6,651 of excess reported by the Treasurer to cover the donation since there are no funds available from the Endowment Trust Fund. Carl Hoffmann moved to table the motion to approve a \$1,000 donation to the C.A.R. Phil Carr seconded the motion. Motion appeared to pass. Jack Coleman requested a hand count on the motion to table. There were 35 in favor and 11 opposed. Motion passed. Then the motion to make the awards was voted on and passed. Ted Duay, Chairman of the Joseph P. Rumbaugh Orations Contest reported that they only had two contestants this year from 29 chapters which was disappointing since the prize money is substantial. Due to the limited participation this year, the Florida Society may want to re-think its continuing participation in this contest and expend the resources in programs of more interest. There seemed to be a general consensus that part of the problem was the demands placed on the students by the school curriculum during the fall and winter school terms. Between school demands and extracurricular activities the potential contestants feel that do not have the time to expend to the Raumbaugh Orations Contest. President Hollien reported on the Ladies Auxiliary meeting. They have raised their awards to \$300 for first place, \$200 for second place and \$100 for third place. The meeting recessed at 11:00 PM. The meeting was scheduled to reconvene at 8:00 AM Saturday morning.

The Winter Board of Management reconvened at 8:00 AM, Saturday, January 7, 2006. President Hollien introduced one of our National Officers, Ed Butler. Compatriot Butler gave a presentation on Developing Outreach Support. Following the presentation President Hollien introduced Dr. Ralph Nelson who gave a slide presentation on the Real Story of the American Revolution, RSAR He headed up the efforts to establish a web site, www.rsar.org, which provides a public resource for discovering, acquiring, and maintaining liberty. President Hollien asked Bud Bauchspies to move to the head table and act a Parliamentarian in the absence of Sam Boone. President Hollien then presented the report of the Executive Committee. He explained the Honors Council and advised the BOM that they needed to approve the nominees. Frank Hodalski presented two general styles of plaques considered. One was a plaque that could be wall or desktop mounted the other a desktop eagle. John Cahoon asked who authorized the Honors Council. President Hollien stated that the Honors Council was approved by the BOM and a committee was appointed by the President to review nominations. Compatriot Cahoon then asked if the BOM understood at the time they approved the Honors Council that once Compatriot becomes a member of the Council that they can no longer hold an elected office or serve as a committee chairman. President Hollien responded that it was not an attempt to put people out to pasture but rather a way to honor their many years of faithful and dedicated service. Prior to presenting the names for this years class of the Honors Council, Ben DuBose asked if the BOM was going to select the plaque. Some discussion on the plaques followed. Dick Fowler moved that the BOM decide on the appropriate award to be given. The motion was seconded and passed. Dan Shepherd then moved that the plaque with the addition of the frame be selected. Motion seconded by Gerald Meeks. Motion passed with some dissent. President Hollien then presented the nominees for the first class. Each one would have to be voted on separately. The first nominee was Bud Bauchspies. Bud objected of the provision that an Honor Council member could not hold office or chair a committee. He declined the nomination at the Executive Committee because of his objections. There was some discussion about removing those restrictions from the Honors Council rules. Dan Shepherd moved to modify the rules governing the Honors Council that members may be allowed to hold state office or state committee chairmanship after election. Motion was seconded by William Stevenson and passed without dissent. The Honors Council Committee recommended Bud Bauchspies, Jr., George Avant and Howard R. Ford. Each was voted on by the BOM in turn and each was agreed to without dissent. There was a brief discussion regarding a member who was not recommended by the committee. Jack Coleman moved and William Stevenson seconded to strike that discussion from the minutes. Motion passed. Frank Hodalski moved and Phil Carr seconded that the report of the committee be accepted which includes their decision to reject the nomination of one compatriot. Motion passed. Discussion followed about a memorial fund in honor of Al Snapp. Richard Friberg moved and Dan Shepherd seconded a motion to donate \$500 to Al Snapp's memorial

fund at the Asbury United Methodist Church. A motion was made by Phil Carr and seconded to table the motion until the spring BOM meeting. Motion to table passed. Jack Coleman moved and Brett Brown seconded that an email notice be sent to the chapters providing information on Al Snapp's memorial fund and asking chapters and members to send donations directly to the church. Carl Hoffmann offered an amendment that the checks be sent to the state treasurer and then one check be sent to the church. Amendment seconded by William Stevenson and accepted by Jack Coleman. A deadline of January 31st was suggested. Motion passed as amended. Frank Hodalski moved and Hal Miller seconded a motion that the state's portion of this meeting's 50/50 drawing be allocated to the Al Snapp memorial fund. Motion passed. President Hollien moved on to briefing the BOM on a proposed two page questionnaire to be sent to all members to seek input on their vision of FLSSAR. A copy of the questionnaire was handed out and discussed. The Executive Committee recommended that the questionnaire be distributed to the membership as an insert in the next Florida Patriot. The responses to the questionnaire would be analyzed and the results would be presented to the BOM and specifically the Planning Committee. The cost for 1700 inserted copies would be \$445.00. Frank Hodalski moved and William Stevenson seconded a motion to allocate the necessary money. The motion passed. It was reported that the President General, Roland G. Downing had expressed interest in attending the FLSSAR annual meeting. William Stevenson made a motion which was seconded to accept the request of the President General to attend our annual meeting. Motion passed. President Hollien announced that he had received a letter from Jim Randall, Executive Director NSSAR, about supporting an effort to place flags in schools in the Hurricane Katrina impact area. A motion was made and seconded to instruct the president to gather the specific details of this program and report back at a future meeting. Motion passed. President Hollien presented a proposal by Ben DuBose that for those members of our Florida Society who are on active duty be forgiven their state dues and that chapters be encouraged to forgive their chapter dues. William Stevenson moved and Ben DuBose seconded that we forgive the 2007 state dues only for all compatriots on active duty in 2006 and encourage chapters to forgive chapter dues. Subsequent years would have to be acted on by the BOM. Motion passed. President Hollien then discussed a proposal received from Hall Riediger, President/Registrar, St. Lucie River Chapter requesting that the BOM join him in encouraging the State of Florida to declare the 19<sup>th</sup> of April as Patriot's Day. John Cahoon moved and William Stevenson seconded that no action be taken at this time and to instruct the president to gather the specific details of this idea and report back at a future meeting. Motion passed. Dick Fowler suggested that Hall Riediger prepare a resolution for the BOM to act on at its next meeting. President Hollien said he would pass that information on to Compatriot Riediger. President Hollien announced that the annual meeting will be held in Gainesville on 28-30 April 2006, Holiday Inn at the I-75 Newberry Exit. Senior VP Brock briefed the BOM on meeting places for the next term. The contract we have with the Lakeland Holiday Inn expires after the present meeting. We can renegotiate with them or try to select another hotel along the I-4 corridor. Senior VP Brock offered to chair the committee. Frank Hodalski moved and Dan Shepherd seconded a motion that the Meeting and Arrangements Committee be empowered to make inquires, do the negotiations and come up with a recommendation for a site in central Florida. Motion passed. During discussions on the motion it was suggested that the Summer BOM be held in July rather that August. That would potentially avoid a hurricane and give more time between the Summer and Fall BOM. Compatriot Brock said he would take that under advisement. Carl Hoffmann, Chairman, National Officer Development reported that there had been very little activity. He has talked to some about it, but that the interest must come from the individual. Individuals interested in pursuing a national office must commit to attending the national meetings. Frank Hodalski reported for the Veterans Affairs committee that they had partnered with DAR, Colonial Dames of the 17<sup>th</sup> Century, Military Order of Retired Officers and the Ladies Auxiliary. Due to the generosity of these groups and the last BOM they were able to mail 30 boxes to troops overseas. St Lucie River Chapter sent 5 boxes, Ben DuBose sent 2 boxes. In addition to those, two boxes were sent by President Hollien, a box was sent by Sam Boone and William Stevenson. Compatriot Hodalski also reported that they had put together 80 "ditty" bags with toiletries etc. for veterans at Bay Pines Veteran's Hospital in Tampa. Dick Cardell, Chairman of the Blue Star Salute Committee reported that at the National level the American Legion had dropped out of the program. Nonetheless he encouraged the chapters to participate with local veterans groups in local activities. He asked to be advised of any chapter activities. Fred Gaines, Jr., Chairman of the Commemorative Historic Sites Committee amended his report by advising that in December the committee had

received a definitive answer from the Department of the Navy regarding the Naval battle and they stated it would be appropriate to place a plaque at Cape Canaveral providing historical data on the last battle of the Revolutionary War. They will be coordinating further with George Thurmond, Chairman of the National Commemorative Historic Site Committee. They hope to have the ceremony in 2007. Ben DuBose, Chairman, Public Relations Committee amended his report by announcing they would not be going to the Florida Institute of Technology (FIT) but instead will be going to an organization called Broadcast Pioneers, a group of people influential in early broadcasting. Hopefully they will be partnering with us. If that does not work, they will go back to FIT. President Hollien reported for the Endowment Trust Fund Review Committee. He said that every time Sam Boone thinks he is just about finished that something else comes up. Every thing appears to be OK but Sam is still trying to find all the records. Several members of the BOM expressed concern about records not being readily available. President Hollien reported that there currently is a shortfall of about \$800 in reimbursing chapters. He expects that it will take about two years before we have enough in the fund to totally reimburse the chapters. Before any further reimbursements are made we must resolve the funds available. Newell Kellogg has not received the end of the year statement from AG Edwards so he does not have a report on the year ending in December. Compatriot Kellogg did report that as of the end of the year \$5,398.94 of \$5,409.38 in the Endowment Trust Fund had been disbursed leaving a balance of \$10.44 which will not cover the unpaid requests nor the remaining unpaid 50% amount of \$818.00. Frank Hodalski moved and Dan Shepherd seconded a motion that the Executive Committee be authorized to deal with the 2005 ETF shortfall of approximately \$800 after the required reports and data become available. Motion passed. During the discussion an additional request from the Palm Beach Chapter for \$1,204 came to light that was not part of the \$818 previously reported. It was pointed out to the Palm Beach Chapter that a request cannot exceed \$350. The chair assured the chapter that they would be permitted to split the request and resubmit multiple requests for consideration with the other unpaid 2005 requests. The ETF Committee did not review the request from Palm Beach due to the resignation of the committee chairman, Fred Curtis.

Having completed the committee reports the BOM moved to unfinished business. Several members had requested reconsideration of the motion to contribute to the C.A.R. The motion to donate had been previously tabled. It was pointed out that since the C.A.R. state conference occurred prior to the next BOM that it would be too late to consider. Hal Miller moved that the previous motion be taken off the table. Lindsey Brock seconded the motion. Motion passed. Richard Friberg pointed out that contributions for the boy scouts and C.A.R. should come from any overage in the Endowment Trust Fund. When there were no funds left over in the ETF monies were obtained from the FLSSAR General Fund. Lindsey Brock moved and Dan Shepherd seconded a motion that a donation of \$500 be made to the C.A.R. and that the money come from the excess money in the general fund as earlier reported by Jim Holyfield. The motion was amended to include the fact that this action was not to be considered as precedent setting for future years. The amendment passed as did the motion. Kevin Yarnell requested a clarification on the proposed by law changing the frequency of meetings from 4 to 3. He said the by laws were very specific on the months for the meetings but the proposed by laws did not state the months. Lindsey Brock responded that the three meetings proposed would be in January, May and September. Hal Miller asked that the first time attendees be recognized. They were: Brett Brown (Palm Beach), Sam Cahill (Naples), and Steve Williams (Brevard Chapter).

The BOM then proceeded to new business. Frank Hodalski reported that elections for National Officers are coming up and the office of Genealogist General is being contested. Compatriot Hodalski gave his personal support to Dr. Ralph Nelson who is a dual member with Florida and asked if it was proper for the BOM to endorse his candidacy for Genealogist General. Bud Bauchspies advised the BOM that in the event of a contested candidacy the Florida Society would support the candidate that is a member of the Florida Society. Since both candidates are members of the Florida Society, the BOM can endorse either candidate. Hal Miller moved and Dick Fowler seconded that the Florida Society endorse Dr. Ralph Nelson for Genealogist General. Motion passed.

The Secretary moved that, as in prior years, the BOM authorize a \$3.00/member dues rebate based on the number of paid members as of December 31, 2005. The rebate would be paid to the chapters who submitted their annual report in a timely manner. The motion was seconded and passed.

Lonnie Jones conducted the 50/50 distribution. Grant Wallin, Jr. received the distribution and donated his proceedings toward the donation to the C.A.R. Jack Coleman gave his report on gift giving to the Endowment Trust Fund under the 365 program. This was followed by the SAR Recessional by Lindsey Brock and the benediction given by President Hollien. Meeting adjourned at 12:10 PM.
