<u>Charters</u>: I have recently (December) downloaded and reviewed several of the Committee Charters and find opportunities for improvement. I will continue this review and with this committee define appropriate actions.

<u>Chairman's comment</u>: It was a very satisfying experience to find that these gentlemen very responsive to their responsibilities. Their responses were thoughtful and to the point. There were three amendments to the 2007 Bylaws, as follows:

FLSSAR Bylaw Amendment #1, Author - Bud Bauchspies:

ARTICLE V COMMITTEES, Section 1 – Executive Committee, para. 2, pg 11, line 4

Underlined text were the words which were inserted.

... During intervals between meetings of the BOM, the members of the Committee shall have the duty to meet on call of the Chairman and to act <u>for the Board of Management</u>, <u>including utilizing the powers of the Board of Management delineated in Article II Section 2. of these Bylaws</u>, on any matter that the Chairman deems to be of such urgency and importance that the action must be taken before the next regularly-scheduled meeting of the BOM. ...

... Go to: Article II - THE BOARD OF MANAGEMENT, Section 2 - Powers

The BOM shall have the following powers and duties:

- a. to exercise management and control over the affairs of the FLSSAR;
- b. to create and staff additional offices and committees as needed:
- c. to approve, and authorize adjustments in, the FLSSAR budget;
- d. to admit new chapters;
- e. to fix fees from applicants, dues from members, and raise funds by other means to meet the financial needs of the FLSSAR;
- to fill vacancies which may occur in any office, to serve until the next Annual Meeting of the FLSSAR except as otherwise provided in Article IV, Section 2, of these bylaws;
- g. to sign contracts for the purchase of services and materials, and to establish policies and procedures regarding reimbursement for expenses incurred in carrying on the business of the FLSSAR; and
- h. to adopt and enforce rules and procedures which shall not be inconsistent with the Bylaws of the NSSAR.

... Go to: ARTICLE IV - DUTIES OF OFFICERS, Section 2 - Senior Vice President

If the President is absent, the Senior Vice-President shall preside at meetings of the FLSSAR and of the BOM. He shall succeed to the President's office in the case of resignation, death or disability of the President, and he shall perform such duties as ordinarily pertain to that office and are assigned to him by the President or by the BOM.

Recommendation: The Charters & Bylaws Committee recommends that the BOM adopt this amendment.

FLSSAR Bylaw Amendment #2, Author Jack Coleman:

Text of Amendment - Indicates Some Affected Articles, Sections ...

ARTICLE IV - DUTIES OF OFFICERS, Section 1 - President ...

Insert the following text:

Section 2 President-Elect

President-Elect, Florida Society Presidency Training Oriented; Will join the FLSSAR President in the implementation of all Society activities that are expected of a sitting Florida Society President. He will attend all chapter, state, district and national meetings which the President attends. This position is intended to allow an incumbent President to begin his term with a thorough knowledge of the operation of the Office of Florida Society President. The sitting President may also assign appropriate committee chairmanships to the President-Elect which will enhance the President-Elect's ability to perform his duties when he does take office.

If the President is absent, the President-Elect shall preside at meetings of the FLSSAR and of the BOM. He shall succeed to the President's office in the case of resignation, death, or disability of the President and he shall perform such duties as ordinarily pertain to that office.

... Modify ... Additional Bylaw Changes Necessary ...

Section 3 Senior Vice President

Shall be the Chairman of the Regional Vice President's Committee. He shall perform such duties that are assigned to him by the President. Additional descriptions need to be defined!

...

Recommendation: The Charters & Bylaws Committee recommends that the BOM not adopt this amendment.

Insert the following "new" section:

ARTICLE III - OFFICERS

Add New Section:

Section 7. Endorsement of Candidates for National Office

Candidates who have declared for election to General Offices in the National Society may appear before the Board of Management for the purpose of seeking the endorsement of the Florida Society. Formal endorsements will not be made by the Florida Society before the Fall Meeting of the Board of Management.

The Eagle Scout Committee is currently reviewing seven Eagle Scout Scholarship Applications for our Calendar Year 2007 Awards. FLSSAR Committee Report Education Committee

Legislation/Florida: Although the next sessions for the Florida House and Senate do not begin until March, there is some activity in the Florida House. Representative Charles Burney of District 16, Jacksonville, has created a bill, HB393. This bill is similar to the one submitted initially last year and focuses on an **emphasis on "civics (Civics & Government)** education" at all grade levels. At this time,

I do not believe that any effort includes the other Social Studies topics, such as American History, Geography, Economics, World History! At this time, there does not appear to be any legislative activity on this in the Senate.

Since the representative listed is located in the Jacksonville area, we hope to make personal contact with him and the senator that also lives in this area. This senator was involved with the Florida Senate Education Committees last year. I will remind you, that although the Florida House passed a positive Social Studies last year, the Senate refused to act!

Jason Caros, will communicate the status of Florida legislation at our January BOM. He is a Social Studies Specialist and leader of the Florida Social Studies Supervisor organization. This organization has been the driving force behind our legislation in the past. They provided the lobbyist, who makes contact with and encourages Florida Legislators to perform, based on our expectations.

Florida Sunshine State Standards: It has been reported that the approval for the Social Studies Standards has been pushed back to September 2008!

Middle School Essay Contest Proposal: It was interesting to find that all three of the schools, that I originally mentioned, are still intending to provide middle school essays. However, each was not able to meet the original target dates! They all delayed them to mid-January for various reasons, including conflicts with the Florida FCAT. Some were delayed because of other conflicts, which did not allow the teaching of the American History period of interest, at the appropriate time for the topics selected. Since this is a pilot, our chapter is being flexible and is hoping that the essays will come in January.

This result highlights the difficulty that the FLSSAR will have with any of our educational programs. We need to be aware of what and at what time in the school year the various American History topics are taught and if they are taught at all!

FLSSAR Committee Report Electronic Technology Committee

Our FLATALK list server is working and is serving as a good communication tool for members of the Florida Society. Steve Williams, FLATALK Administrator, has been able to get everything working well.

One problem that we have been having with NSSAR SAR-TALK is that when replying to a SAR-TALK message it automatically is sent to the SAR-TALK list. This has caused considerable problems, and many members have

dropped off of SAR-TALK because they have been deluged with superfluous messages that are usually only intended for the person who was the originator of the message responded to.

We had that problem briefly with FLATALK, but Steve has been able to correct it so FLATALK replies are automatically sent to the sender, rather than the list.

If you dropped off of FLATALK because you received a lot of "junk" message that you were not interested in when it was recently re-activated, please give it another try, since that problem has been solved. It is a very effective way of sending a message to hundreds of fellow Florida Society members, and the more members that use it the more effective it will be.

The Committee received the Friends statistical report for the period 1/1/07 through 12/31/07 from the NSSAR Library. The report summarized membership data for members of the Friends of the SAR Library (FOL) for all state societies.

At the Fall BOM the JROTC Seminar was attended by 5 interested compatriots. It was a successful meeting and several issues were addressed including;

- 1. Using a challenge to compete letter with the Program Instructions.
- 2. Include a pre stamped and addressed return post card.
- 3. Distribution of packages to schools.
- 4. Expanded Program packages due State Chairman before 1 April 2008
- 5. Essay requirements, word count, Nomination form, recommendations.
- 6. Presentation of medals.
- 7. Recommendation of awarding Good Citizenship Medals to retiring Instructors.

Complete packages were prepared, one for each of the <u>29 Chapters</u> and one for each State Committee member and one for each Regional Vice President. Inside were pre-addressed and stamped envelopes and a request for each Chapter JROTC Chairman's information. I appreciate the <u>6 Chapters</u> that returned the information as requested.

After discussing the issues with the National JROTC Committee Chairman It appears that we are to consider the Bronze JROTC Medal Program and the Enhanced program as two separate programs. Yes, you may end up presenting a Bronze JROTC Medal and a JROTC Medallion to two different Cadets at one of the Schools. There is no National or State program to recognize any competitor at the Chapter level except the 1st place winner.

1. The "JROTC Bronze Medal Program" Recipient is selected by the Senior Instructor and can be from any class year. But it is strongly felt that a freshman should not receive this award as he has not had enough time in the program to prove our requirements. The Bronze JROTC Medal Program does not require a nomination form to be submitted. The Senior Instructor will notify the Chapter JROTC Committee Chairman of the Time, Place, of the ceremony and Name and Rank of the Chosen Cadet. The ROTC Silver Medal program for the College/University level programs is the same. Cadet chosen by the Instructor. Instructor notifies the Committee Chairman of the Date, Time, Name and Rank for the presentation ceremony. Chapter responds accordingly.

- 2. The "Enhanced Program" Cadet chosen by the Senior Instructor must be in his next to last year(junior year of a four year school Program) of JROTC.. This can, but does not have to, be the same cadet receiving the Bronze Medal. He must submit the Nomination Form, Essay, and recommendation letters from both the Senior Instructor and the Principal of the school. The Instructor and Principal certifies that he meets the requirements of Class standing and GPA by submitting their recommendations.
- 3. The Essay shall be between 500 and 700 total words. If it is less that 500 total words it is disqualified and shall not be forwarded to State. If it is over 700 words contact the state chairman for instructions. The Essay shall have a title and it shall be "How the JROTC has prepared me to be a better citizen of the United States"
- 4. Just a friendly reminder, all chapter JROTC Enhanced Program Packages are due to the Chairman Before April 1, 2008. Please ensure that packages are complete. For more information see the Updates JROTC Page at the National and FLSSAR ROTC/JROTC Website.











This report covers the period January 1, 2007 through December 31, 2007 and is the final report for 2007. During this period, forty-one applications for reimbursement grants were received and processed by the committee. All applications were approved for reimbursement and sent to the Trust Fund Treasurer for payment of 50% of the authorized amounts. These payments amounted to \$3516.16. There remained \$2792.52 in the Endowment Trust Fund to be distributed to the chapters towards the \$3516.09 that the chapters were owed. The final distribution of \$2792.52 to the chapters brought their reimbursements to a total of \$6308.68 or 89.71% of the \$7032.25 they were authorized to receive. Thus, \$723.57 or 10.29% of their authorized reimbursements could not be paid.

Winter Board of Management Meeting January 18-19, 2008, Kissimmee By Terry Walton, Recording Secretary

The meeting was called to order by President Grant Wallin at 8:56 p.m., 18 October 2008. The invocation was given by Jack Coleman, substituting for Chaplain Randy Moody, who was otherwise engaged in Rumbaugh oration contest matters, who later made a belated entrance. Grant Wallin then led the Pledge of Allegiance, the Pledge to the SAR, and the American Creed. Secretary Yarnell circulated an attendance sheet, with the following chapters constituting a quorum: Brevard, Caloosa, Central Florida, Clearwater, Emerald Coast, Flagler, Fort Lauderdale, Gainesville, Jacksonville, Lakeland, Lake—Sumter, Miami, Naples, Palm Beach, Pensacola, Saramana, St. Lucie River, Tampa, Treasure Coast, and Withlacoochee (20 of 30). President Wallin requested reports, if any, from national officers and committee chairs; there were none.

The report of the national trustee, Lindsey Brock, appears on p.7 of the **Quarterly Reports of the Florida Officers and Committee Chairmen, Winter Board of Management Meeting, Kissimmee, January 18-19, 2008** (BLUE BOOK), a publication that is an integral part of the official minutes. Page numbers cited in these minutes refer to the Blue Book. **A copy of the BLUE BOOK is available through all local chapters.** State officers were then asked for reports. The seven RVP reports appear in the Blue Book (pp.9-14), with the exception of the Southwestern RVP, Don Cahill, who gave his report orally. Other state officer reports appear on pp.14-18 of the Blue Book; Frank Hodalski, Parliamentarian, requested permission to give his Support the Troops report, summarizing recent activity (33 boxes sent), and various correspondence and photos, as well as a detailed financial report. Other members offered various ideas for contributing to the Support the Troops effort. Alvie Davidson announced that he would be stepping down as Genealogist after ten years of service, offering high praise for the nomination of Gerald Meeks as his successor.

After receiving three responses from printers, Grant Wallin reported that the Executive Committee decided to stay with the current *Florida Patriot* printer, but recommended that submission deadlines be moved up two weeks beyond the present requirement to prevent future publication delays. The publication submission deadlines will be available on the website.

The Finance Committee report, given by Treasurer Leon Hammock, appears on pp.19-20. Ted Duay requested a clarification of several accounts: 503, Donations Received, should be changed to Operating Budget Trust Fund to distinguish it from other gifts; 604, Secretary's Expense, is for the rental of a room to house Society records and other items; 608, Editor's Expense, is for *Florida Patriot* printing and mailing expenses; 857, Support the Troops, is for mailing expenses. Ben Dubose asked that account 847 be changed to Patriotic Education Committee. President Wallin made a motion to approve the two account name changes; it was seconded and passed unanimously.

Members attending BOM for the first time introduced themselves: Carl Brown, Jacksonville; Daniel Hans, Withlacoochee; and Weymouth Reed, Jacksonville. Lindsey Brock, Chairman of the Nominating Committee (Lindsey Brock, John Cahoon, Alvie Davidson, Fred Gaines, and Frank Hodalski), reported the following nominations for 2008-2009 officers: President: Ron Toops; Sr. Vice President: William Stevenson;

Northwest Regional Vice President: Ed Young, North Central Regional Vice President: Gordon Greenwood; West Central Regional Vice President: Nelson Jantzen; North East Regional Vice President: David Ramseur; East Central Regional Vice President: Hall Reidiger, South East Regional Vice President: Gerald Meeks; Southwest Regional Vice President: Don Cahill; Secretary: Kevin Yarnell; Treasurer: Leon Hammock; Registrar: Ted Duay, III; Genealogist: Gerald Meeks; Chaplain: Randy Moody; Recording Secretary: Terry Walton; Chancellor: Carl Hoffmann; Sergeant-at-Arms: Phil Tarpley; Historian: Bob Murray, Editor: Dick Fowler; Executive Committee Member-at-Large: John Cahoon, Jr. The election will be held May 3, 2008, at the annual meeting, which coincides with the Spring BOM meeting, May 2-4, 2008. All eligible FLSSAR members can vote and additional nominations may be made from the floor.

President Wallin discussed the bylaws pertaining to BOM voting eligibility, pointing out the need and difficulty of making changes to the bylaws. He requested the Secretary to determine the voting eligibility of BOM registrants and to verify them later in the meeting. Chairman Nelson Jantzen, Chapter Challenge Committee, reported that the 2007 forms must be in the hands of the RVP's by March 1st, and that the Executive Committee had approved revisions to the 2008 form to be submitted in 2009. Both forms will be on the website. There was discussion of the Marlin awards, and the cash incentives associated with them. Ron Toops, Chairman of the Charter and Bylaws Committee, reported on the three proposed amendments (pp.22-23) submitted at the Fall BOM. The Committee voted to adopt amendment 1, to not adopt amendment 2, and to adopt amendment 3. The amendments will be formally put to a membership vote at the annual meeting on May 3rd.

President Wallin reported that John Little has resigned as chair of the Commemorative Historic Sites Committee, and requested Lindsey Brock to report. Lindsey recapped recent developments relating to the Last Naval Battle (related in recent SARTALK/FLATALK communications, and the *Florida Patriot*. The highlights include the presence of the USS Barry and the US Naval Band, as well as the approval of large and small medals.

Ben Dubose reported that he and Lindsey Brock are willing to assume responsibility for the Commemorative Historic Sites Committee, under the aegis of the Last Naval Battle Committee, until such time as a chairman is appointed.

President Wallin received the voting eligibility verification from SecretaryYarnell, indicating that all members present were eligible to vote (57). He then explained that nominations for the position of Vice President General South Atlantic District, NSSAR, would be requested.

Ron Hamilton nominated Frank Hodalski and described his background and qualifications for the specified three minutes.

Jack Coleman then nominated Lindsey C. Brock and described his background and qualifications for the position. Both candidates spoke for the stipulated three minutes. Tellers were then appointed: David Kelsey for Lindsey Brock, Ron Hamilton for Frank Hodalski, and John Cahoon as Head Teller. Ballots were then distributed. Reports for the Credentials and DAR Liaison Committees appear on p. 24. Chairman David Ramseur updated his Eagle Scout Scholarship Committee report which appears on p.25. Eight applications were received, with three scholarships awarded: 1st place went to Tampa (\$1,000), 2nd place to Brevard (\$500), and 3rd place to Clearwater (\$250).

The Ladies Auxiliary will also be awarding additional scholarship funds to the three outstanding scouts. The 1st place winner and his parents will be recognized and awarded at the Spring BOM meeting on May 2nd.

Ted Duay, III reported that the Genealogy Committee workshop held on 18 January 2008 had 30 participants, and that another workshop will be hosted at the Spring meeting. The Joseph P. Rumbaugh Orations Contest Committee chairman, Randy Moody, reported that the three entrants were judged on 18 January 2008, and the winners were: 1st Place: Jinan Martiuk, Saramana Chapter; 2nd Place, Matthew Berning; 3rd Place: Arash Nasajpour. Cash awards were \$500, \$250, and \$100 respectively, plus additional awards from the Ladies Auxiliary. The 1st Place contestant, Jinan Martiuk, will be going to national. Judges were Dick Cardell, Gordon Greenwood, and Terry Walton. Doorkeeper was Lonnie Jones.

President Wallin announced that the ballots had been counted and the next Vice President General, South Atlantic District, will be Lindsey C. Brock. Since Florida is next in rotation for the position, his actual election will be a formality.

The meeting recessed at 10:12 p.m., 18 January 2008.

The BOM reconvened at 8:30 a.m., 19 January 2008.

Education Committee Chairman Ron Toops's report is on p.25. He added that our dinner speaker, Jason Caros, was right on target with his assessment of the lack of current legislation promoting Social Studies, Civics & Government, American History, and History in general.

President Wallin reported for the Executive Committee. He noted that the combined federal campaign reports were due on December 31, and that the information gathered should benefit the SAR at all levels. The Treasurer will keep chapters informed of IRS reporting requirements as they are updated. There was a discussion of the possible move to a new location for NSSAR HQ, which will be discussed here at a later point. There was a discussion of ETF distribution of funds. The rules will remain the same (25% contribution by chapters, 50% initial distribution of the reimbursement amount), and that there will be adequate funds to cover the year-end shortfall. A motion to leave the rules in place and to approve payment of the final installment to chapters was made. It was seconded and passed.

The Last Naval Battle Committee chairman, Ben Dubose, reported on arrangements made so far for the March 8th event. He requested that chapters email him with the number of attendees they expect to have. Registration & reservation details are available on the website.

Ben Dubose also went on to make the Liberty Tree Committee report. The Committee is proposing that Liberty Tree reimbursement requests be increased by \$100 to a total of \$350 per chapter. They will formally submit this proposal to the Executive Committee for approval.

Lindsey Brock confirmed that a contract will be signed with the Ramada Plaza Hotel & Inn Gateway for the 2008-2009 period. His report appears on p.28.

The NSSAR Library Committee report appears on p.29. Chairman Terry Walton urged all FLSSAR members and chapters to show their commitment and involvement by becoming a Friend of the SAR Library by sending a \$25 check to SAR Library, 1000 South Fourth Street, Louisville, KY 40203, Att'n: Friends of the Library. Grant

Wallin noted that there is a national contest for societies with the greatest percentage of membership increase that we can win if we can increase our membership this year. Terry Walton added that although we remain first in the nation in FOL membership, we are rapidly being overtaken by the Georgia Society which will be our major competitor. Patriotic Activities Chairman Hal Miller's report appears on pp.29-30. He urged all chapters to become involved in the Flag Program, and to report their chapter flag activities by email to Frank Hodalski (fhodalski@msn.com) by April 1st, the date set by the NSSAR Flag Committee. The Florida Society will compete for the Rear Admiral William R. Furlong Award based on their statewide Flag Program activities.

The ROTC Committee report appears on pp.32-33. Chairman Lonnie Jones clarified the distinction between Bronze JROTC Program and the Enhanced Program. JROTC Enhanced Program packages (includes Nomination Form, 500-700 word essay, recommendation letters from both the senior instructor and school principal stating that the candidate meets the requirements of class standing and GPA) are due to the chairman before April 1, 2008.

Chairman Ron Toops's Advancing America's Heritage Committee report appears on p.33 and focuses exclusively on the issue of relocation options for the national headquarters, which was discussed at the Executive Committee meeting.

The Americanism Elementary Poster Contest report appears on p.34. Ed Young noted that the chapters should be in contact with their schools, presenting the requirements of the contest, and establishing the guidelines/procedures for judging any submissions. The chapter's winning poster should be brought (not mailed) to BOM on May 2nd where there will be displayed.

NSSAR Constitution & Bylaws Review Committee Chairman Carl Hoffmann noted that the only development that came out of the last Leadership meeting was the suggestion that a new national officer be created: "Inspector General." The reaction of BOM members present was uniformly jocular.

The New Chapter Development Committee, chaired by Steve Williams (not to be confused with William Stevenson), is reported on pp.33-34. Both Steve and Grant Wallin were happy to report that the Florida Society now has 30 chapters, the latest being the William Dunaway Chapter (Marianna/Greenwood) which was chartered at a January 5th meeting.

FLSSAR Endowment & Operating Budget Trust Funds, including the ETF and OTF Trust Funds status, was reported by Chairman Ted Duay. Ted asked if members would prefer an abbreviated report at the quarterly meetings with a detailed summarization at the annual meeting; member response was affirmative. Ted was once again complimented on the terrific job he and his committee are doing.

Trust Fund Development Committee Chairman Jack Coleman delivered an unusually restrained but inspiring appeal to the collective consciences (and wallets) of those present. Commander Ed Young's report for the Sons of Liberty Florida Brigade appears on pp.56-58. It was also noted by a BOM member that the new Dunaway Chapter may qualify as an Outpost. With the transfer of two Brigade members to the Caloosa Chapter (Moody father and son), Caloosa Chapter has been approved as Outpost D.

UNFINISHED BUSINESS: A lengthy dialog ensued between a dozen members on ideas and techniques for recruiting and retaining members. 192 members failed to renew this year, of which, Kevin Yarnell estimates, probably half will return.

NEW BUSINESS: Chancellor Carl Hoffmann requested time to discuss the proposed relocation of national headquarters to Main Street. He recounted the recent history of the NSSAR and the backstory for the move from Washington to Louisville some 30 years ago. His analysis and observations were not supportive of the proposed move. He feels that at this stage the process has not been subjected to sufficient due diligence, and the proposed relocation should not be approved until due diligence has been assured. Dick Cardell, Dan Shepherd, Don Cahill, and Frank Hodalski raised a number of pointed questions and observations that provided an added dimension with differing viewpoints to the discussion. Frank Hodalski, a member of NSSAR's Strategic Planning Committee, observed that he sat in on a 5 1/2 hour meeting of a subcommittee that addressed this issue at the last Leadership meeting. He left the meeting with the realization that after 8-10 years of fundraising if nothing is done now it would never be done. He noted that the present building is in a red-lined district, that some teachers will not bring their students into the neighborhood, that the building is subject to flooding, and that the proposed expansion across the street would have the same location deficits. His bottom line was that nothing be done without due diligence and everything be done to maximize our position.

Carl Hoffmann introduced a motion that would instruct the national trustee to "withhold his vote to purchase this building until he is satisfied that due diligence has been done." The motion was seconded, and passed by a majority vote of members present.

A question was raised about the changes to the national bylaws that would affect the Vice Presidents General. Frank Hodalski feels the measure should be tabled until the subcommittee studying the issue makes its report.

The 50/50 drawing was exactly \$200 and was won by David Ramseur, who donated \$100 to the general fund and \$100 to support the troops.

Chaplain Moody gave the benediction, the recessional was recited, and the meeting adjourned at 10:10 a.m., 19 January 2008.
