FLSSAR STATE OFFICER'S REPORT President

Great "First Step" for "The Center" ! ... Our CAAH Campaign Chairman, Hall Riediger has reported our preliminary fund raising data, as of January 16, 2009. Ten (10) chapters have reported member giving to the fund raising effort for "The Center". So far, one-hundred and fifteen (115) members have given something to the SAR Foundation Inc. Campaign, approximately 7% of the Florida Society membership (1545, Dec 31, 2007. It is 25% of our Florida Society objective of 30% (464) participation, for the period, September 15 thru Dec 31, 2008. Please note, there are a number of chapters and chapter members, who have sent their financial gifts directly to the SAR Foundation. Together with these chapters, the members, the SAR Foundation and CAAH Campaign Chairmen, along with the Florida Society Senior Vice President and his team of RVPs, we will compile these additional participants.

At this moment several chapters are taking the giant steps and exceeding the 30% objective. They include the St. Lucie River and the Lake-Sumter Chapters. I am sure that there will be additional chapters reaching this goal in the future. We are in a learning phase and as we proceed we will better communicate the best approaches for insuring that all chapters and their members are counted. One effective approach has been associated with the forms provided during the several chapter visits, performed by this President. If there are any questions about the method for enumerating your chapter's data, please contact Compatriot Riediger, SrVP Stevenson or myself.

Also, Compatriot Hall has reported that the <u>amount of giving reported is \$4475</u>. As noted earlier, this doesn't account for the mailing directly to the Foundation, the \$10,000 which was to be given by Everett Ballard/Caloosa Chapter or other similar gifts. It also does not include at this time, the much appreciated giving that had occurred prior to September 2008.

We will make the effort to ensure that the members are credited for all giving since the beginning (of time) about 10-12 years ago.

The SAR Foundation leadership, should be issuing a report this month as well. As we receive this information we will try to share it by way of our Regional Vice Presidents.

FLSSAR STATE OFFICER'S REPORT Senior Vice President

Compatriots the third quarter is over; only one to go. My hope is that each of you having lent your entire support to Pres. Toops' programs, i.e. CAAH and membership.

- 1. At the mid-year BOM two programs were discussed in terms of a. the sum to 'be raised by member and by amount -Pres. Toops hopes \$5 per member (30% of membership) and membership. Pres. Toops encourages, as noted above, a growth of 30% of the final membership figure for the last year. Understandable, this is truly not the time to go begging for monies, but it must be done. I have, I believe, possibly found a solution. It is one I finally remembered from my grandfather's talk with me. This is at Chapter level. At the next three Chapter Meetings (that ends the year), try to collect fifty cents from each attending member (maybe the Chapter can cover those absent members). Consider: if the Chapter had 50 members that would equate to \$75. Thus, with 31 chapters, that equates to \$2,325. Just think', Just \$1.50 from each member.
- 2. Membership: Pres. Toops' proposal discussed. (See Membership Committee Report)
- 3. Youth Programs -the 4 youth programs I,,-ere The Essay, The Oration, the Eagle Scout Scholarship, and the JROTC -were discussed. This included the funding and how to improve same.

Additions made at the meeting follow:

A summary of SVP activities for the first 6-months of 2009, appears in report published on back cover of Winter 2009 (No 4 Vol XXXVIII) issue of THE FLORIDA PATRIOT. These objectives continue as priorities, with limited to moderate success.

As advised by telephone, Pres. Toops, in early January 2009 indicated over 150 members had contributed to THE CENTER (over \$1,500). Good start, but surely the FLSSAR can do better! Personally, I understand the general feeling is that contributions remain "low" (my term) because, as I interpret feelings in my own chapter, individuals do not relate personally, to NSSAR "gains"; i.e. "what is in it for me?"

As reported in this afternoon's SVP meeting, the RVP's report of the by-laws committee 3 members want to keep 4 BOM's, one member wants to reduce to 3 meetings.

Youth Programs: In my own chapter – limited success. Members appear to relate to these programs more readily than to THE CENTER. [Compatriot Stevenson presented the Eagle Scout and ROTC committee chairs with money collected from the Treasure Coast Chapter.]

Finally on January 15, 2009 (evening) I attended the Jacksonville Chapter SAR meeting. REGISTRAR'S REPORT January 22, 2009

On June 2, 1897, the *New York Journal* reported one of the more famous quotes of U.S. humorist and novelist, Mark Twain, who wrote, "The report of my death was an exaggeration." After reading the Winter 2009 issue of *The Florida Patriot*, I must say that I feel a bit like that great American. For the second issue in a row, the magazine erroneously fails to list me as Registrar and instead lists William R. Stevenson, despite the Editor being notified of this error the first time. Rest assured, despite the repeated lack of recognition in *The Florida Patriot*, I am still honored to be your Registrar and continue to serve to the best of my ability.

At the request of the BOM and the Executive Committee at the Fall 2008 meeting, I sent a letter and materials to all members of the NSSAR Genealogy Committee, as well as the President General and Secretary General explaining Florida's position as it relates to SAR's recent prohibition on the use of DAR Record Copies with center check marks as proof of lineage for SAR applications. In total, approximately fifty-seven letters were sent. In addition, I forwarded the letter and materials to forty-seven compatriots around the country who serve as the genealogical contacts for their respective state societies. A copy of the letter and materials follow this report.

On January 9, 2009, I spoke with Richard Fetzer, Chairman of the NSSAR Genealogy Committee, who acknowledged receiving my letter and materials sent on November 16, 2008. He assured me that I would have an official response from him in a week's time, as well as a copy of the minutes of the last NSSAR Genealogy Committee Meeting that I requested twice in October 2008. As of the writing of this report, I have yet to receive anything from Chairman Fetzer.

Despite a lack of response from Chairman Fetzer, I have received many messages of support from SAR State Registrars, Genealogists, and Presidents from around the country who overwhelmingly support Florida's position and agree that the SAR's new ruling as it relates to the prohibition of DAR Record Copies with center check marks is foolish, ill advised, and should be rescinded. Some of the more interesting comments are below:

"Much to do about nothing. One would think that they had better use of their time. The DAR has always been very attentive to accepting applications and whether they use a center check or the check in front of the information, just does not seem any reason to reject that information. I only wish that they would be more [concerned] about helping us recruit new members." SAR State Registrar

"...this policy of not accepting center checked DAR apps as proof is causing significant problems and is causing us to lose applicants. I am having to return almost all of the applications I see that rely upon DAR apps for proof since they are center checked for having relied upon older DAR apps. This is a significant number since I process over 200 apps a year... The result is ill will on the part of the applicant, particularly if a DAR

member is involved in preparing the application, and anger and confusion on the part of the first line sponsor." SAR State Registrar

"I am already having problems with applications using DAR record copies. I will be speaking with Compatriot Fetzer at our upcoming BOM in Feb. I will express my frustrations along with yours to him in person." SAR State Registrar

"We lost two good applicants this past week because of this problem. One was the son of an active DAR lady who was doing his papers, and her DAR app which was only three years old was center checked for several generations. When I informed her that she would have to obtain the older DAR app, or other documentation, she went through the roof and promptly withdrew her son's SAR application." SAR State Registrar

"I agree with many of your points... As you so appropriately pointed out, nothing in genealogy is 100% certain. I do see instances where these center checked record copies could be of value." SAR State Registrar

"I received your message in a round about way and it's the first I had heard of this ruling. At a time when we should be trying to increase our membership it seems like there are those who are constantly putting up "roadblocks" to stop this action..." SAR State President

"...I support the Florida Society position. I think the DAR does an excellent job verifying proof of lineage and fail to understand Chairman Fetzer's ruling. My wife is a certified genealogist with DAR and has gone to Washington D.C. on numerous occasions to assist in verifying new DAR applications. I personally think our Society is way out of line if we no longer accept DAR Record Copy proofs!" SAR State Registrar

"This whole thing sounds like a petty fight with the DAR. Although they (SAR) don't want to admit it, the SAR doesn't want to accept DAR Applications because the DAR doesn't accept ours as reference proofs...Sounds like we have certain SAR members still a little vindictive, when we should be combining forces and having two great organizations. Afterall, we both (SAR & DAR) have Patriot Ancestors who fought for this great Country." SAR State President

"As state genealogist, I have received NO communication from Genealogist General Joseph W. Dooley or the genealogical committee about this or any other genealogical matter in the nine months I have been state genealogist..." SAR State Genealogist

"I will add that in asking questions about potential applications, the genealogy staff at the National Office has referenced this change but did not specify why or to what extent this would impact the approval of applications beyond the previously stated policy of having to reprove the genealogy of any record copy older than approximately 1985." SAR State Secretary

I have made arrangements to attend the next NSSAR Leadership Meeting in Louisville in hopes of having SAR's ruling rescinded. I would encourage as many of you to attend as possible and voice your concerns. If you are unable to attend, I would encourage you to contact both Genealogist General Joe Dooley and Genealogy Chairman Fetzer and voice your concerns directly to them. Re: New SAR Policy Interpretation Concerning Acceptability of DAR Record Copies with Center Check Marks as Proof of Lineage for SAR Applications

Dear Compatriot Fetzer:

I am writing this letter to you at the request of and by the authority of both the Executive Committee and Board of Managers of the Florida Society Sons of the American Revolution. I was also asked to send copies of this letter to all members of the NSSAR Genealogy Committee and to the President General and Secretary General.

As I am sure you are aware, Genealogist General Dooley reported on SAR-Talk on September 29, 2008 that "The (NSSAR) Genealogy Department and the (NSSAR) Genealogy Committee also want to make compatriots aware of recent procedural changes in the DAR's use of verification marks. Whenever the DAR is reviewing a new application which refers to one of their previously approved applications, the DAR staff Genealogist now places a single large check mark down the middle of the page or on the margin, rather than marking each genealogical fact as verified." He reported that the NSSAR Genealogy Committee met during the previous Leadership Meeting and approved the decision to no longer accept DAR Record Copies with center check marks as proof of lineage for SAR applications. In essence, this disallows any DAR Record Copy that references a prior one.

I have attached as Exhibit I copies of two DAR Record Copies that I have in my possession. One was approved in 1995 and the other in 2000. For both of these applications, the DAR Staff Genealogist used center check marks to verify information on these applications to prior ones. In the case of my examples, the center check marks are next to the words "born," "on," and "married." In other cases, the center check mark is next to the number of the prior DAR Record Copy used to verify the information. The relevant information is circled for your convenience. This is hardly a "...recent procedural change..." as reported by the Genealogist General on SAR-Talk.

I have attached as Exhibit II handout materials produced by the DAR and distributed at its Genealogy Consultant Course held in August 2008. The handout is useful because it defines the symbols used by the DAR Staff Genealogist when an application is verified. Center checks are used to indicate that the information was taken from a previously verified application. Individual checks are used to indicate that new information was proven on the application. Brackets or parentheses are used to indicate information that has not been proven.

The new rationale for not accepting DAR Record Copies with center check marks is because the SAR Staff Genealogist cannot "divine" what information has been verified or not by the DAR Staff Genealogist. As mentioned above, center check marks mean that all the information in a specific generation has been verified to a previous application unless brackets or parentheses are used to indicate that the information has not been verified. We, in Florida, fail to understand what is so confusing about this and why SAR will no longer accept DAR Record Copies that use center check marks, particularly since DAR has been using center check marks to verify its applications for many years.

The Florida Society strongly disagrees with the NSSAR Genealogy Committee's recent decision to no longer allow the use of DAR Record Copies with center check marks as proof of lineage and respectfully requests that this new policy interpretation be rescinded as soon as possible, retroactive to its date of inception. We believe that this new policy interpretation will have a detrimental negative impact on new member recruitment and demonstrates a lack of trust in the skills of DAR Staff Genealogists.

In addition, the Florida Society officially requests a copy of the minutes of the NSSAR Genealogy Committee from the last Leadership Meeting where the decision was made to implement this new policy interpretation, as Florida would like to know who brought up the issue, the nature of the discussions, and who voted for and against this. I have requested these

minutes twice, once on October 4, 2008 and once on October 19, 2008. As of the writing of this letter, I have yet to receive them.

I appreciate any assistance that you can provide.

Six years ago, the state database contained only the current members. Currently we have information on 8,028 of the 9,268 men who were at one time members of the society. That is 86.6%. Further, we have begun the process of scanning applications. At present we are only scanning the applications of new members and newly approved supplementals. We currently have 184 applications in electronic form.

The work of getting our archival information in useable form is far from over, but we continue to make steady progress.

Session Florida House & Senate 2009: Just off the Press, January 13, 2009: The Florida House of Representatives again entered legislation (HB0013) which "Requires Sunshine Standards for Social Studies to include emphasis on Civics Education*; requires Social Study standards to be included in assessments; requires FCAT to measure student content knowledge & skills in Social Studies; provides requirements for administration (on) Effective Date: upon becoming law"; On Tuesday, January 12th, Jason Caros of the Florida Social Studies Supervisor's (FSSS) organization, along with our Lobbyist, met with Florida House Representative, Charles McBurney * and Senator Stephen Wise in Tallahassee. They discussed the content of HB0013 and other topics related to similar Social Studies Legislation in the Florida Senate. It appears that they were very successful. Early feedback from Jack Bovee, also of the FSSS, indicates the following (My interpretation): 1) The Senate will probably create Senate Legislation which is identical to HB0013; 2) An individual has been assigned to develop the expected cost impact study and present it to these leaders; 3) It is anticipated that since the objectives for implementation

are not until 2014-2015, that there will be no immediate financial impact ... important in the current (2009) poor economic period. Shortly, there will be an effort to meet with Governor Crist, in order to obtain his support as well. Similar efforts will be made with the leaders of the Florida DOE.

* House Representative Charles McBurney resides in the Jacksonville Chapter area.. Representative McBurney supported this legislation in 2007-2008 and was successful in getting it passed in the House. Our Compatriots in Jacksonville, including David Ramseur and Lindsey Brock were active in communicating to Repr. McBurney on several occasions and we appreciate their extra effort.

I have discussed with Jack Bovee, the strategy that should be taken for the Florida Society during this 2009 legislative season and I will recommend it at this time, as follows: 1) Write to Repr. McBurney and Senator Stephen Wise and express your support; 2) Communicate with your local Florida representatives and senators, letting them know that you encourage them to support this Social Studies Legislation. We were very effective last year, as both houses were filled to the brim w/email messages.

Again, it appears to me we are again making progress. We may not yet have "Early American History" emphasis, but we certainly can support the Civics orientation, which emphasizes the Constitution, the Bill of Rights, Functions of the Three Branches of Government, and many topics based on the work of our Founding Fathers. Thank you for communicating this encouragement to your representatives.

Florida Sunshine State Standards: I am not aware of the progress of this effort at this time.

<u>Middle School Essay Pilot Contest</u>: The Lake-Sumter Chapter again, kicked off their version of the Middle School Essay "Pilot" Program. They currently have fourteen (essays), which appear even better than those for last year. This year the students were asked to define what event best set the stage for Declaring Independence. The Topics included Paul Revere's Ride, Boston Massacre, Boston Tea Party, Battle of Lexington & Concord and the Olive Branch Petition. The Judges have already provide some feedback.

As was done last year, there will be individual certificates and financial rewards for those who were most persuasive on their topic choice. There will be certificates and some other awards given to all students who participated and there will be certificates and gifts for the teacher and the school.

The Lake-Sumter Chapter hopes that the Florida Society will consider this new program for implementation at some later date.

Current FLATALK list membership is 211 compatriots. It is desirable that chapter officers sign up for this communications tool.

Statistics:

Since November 2007 there have been 111 messages sent via FLATALK in 423 days of usage, or 1 message every 3.8 days; there have been 21 submitters.

The top 2 submitters have sent 33 and 26 messages, respectively - 53% of total.

The top 5 submitters have sent 33, 26, 13, 8, and 6 messages, respectively - 77.5% of total. The remainder of the submitters have sent either 1 or 2 messages.

The content of the messages have concerned the BOM meetings, National Congress, various FLSSAR events and contests, the Florida Patriot magazine, and Florida Society endeavors. So one can see that these are not trivial messages or anything that can justifiably be considered SPAM. The frequency of the messages - one every 3.8 days - also cannot be described as excessive e-mail traffic.

FLSSAR Website

Change in the top menu system of tabs now includes a separate tab for Chapter information which contains links for Chapter Officers, Newsletters, and Websites.

The Google AdWords initiative begun in 2008 has the statistics listed below. The program uses 40 keywords that when one of these words is typed in a Google Search will bring up a link for FLSSAR. The cost associated (\$.05/per click) with this depends on our link being clicked when it is displayed - if not clicked (accessed), then there is no charge.

Total number of times our 'ad' has been shown = 7,628

Most linked Keyword = Genealogy (1, 354)

Cost to date = \$5.59

Other keywords (and times our 'ad' has been shown): American Legion (132), Geo Washington (120), Patriotic (91), Revolutionary War(74), American Revolution(46), ROTC (34), SAR (20), and Thomas Jefferson (42).

Since our last BOM, a total of 50 SOT care packages have been sent. Twenty-six SOT boxes were sent to our Army units just before Thanksgiving and should have arrived before Christmas. The boxes were sent in increments of 15 boxes on 22November, and 11 boxes on 24 November. Purchases of goods from Dollar General and Dollar

Tree mostly included personal items and totaled \$265.07. Postage of the 26 boxes at \$10.95 each totaled \$284.70. The total expense of \$549.77 exhausted the \$1000 allocated by FLSSAR for 2008 and left us \$19.63 over budget.

Individual donations left us with a total of \$452.60 cash on hand. Your generosity allowed us to begin 2009 by posting an additional 24 boxes, 12 boxes at \$10.95 on 14January, and an additional 12 boxes at \$11.95 on 21January. The Dollar Stores received a total of \$146.50 in purchases; Office Depot received \$18.00 for a typewriter ribbon cartridge and eraser tapes. Postage of the 24 boxes amounted to \$274.90. The total expenditure of \$439.40 leaves us with \$13.20 cash on hand to continue this year.

Redeployments and the closing of Camp Fallujah resulted in changes in our geographic area of support. We are now sending boxes to five Army units in Afghanistan. With your help, we will continue to box and send care packages until our troops come home.
